**Section I. Issues**

The station identified the following topics as significant issues facing our community in this quarter:

- A. **New Microsoft Data Center Coming to Malaga – Jobs, Economic Development.**  
The Chelan Douglas Regional Port Authority is moving forward with the purchase of 23 acres on Malaga Alcoa Highway, with the purpose of selling it to Microsoft. Microsoft plans to build a three data center campus with an assessed value of \$500 million
  
- B. **Wenatchee Schools New Superintendent – Education** The school board went through the arduous process of selectin a of a new superintendent. There were dozens of applicants. The process was narrowed down to three finalists, who all visited the district. The chosen candidate already worked in the district, and is a now an interim director who will start work on July
  
- C. **MegaKittrick" Project - Wenatchee City Infrastructure Upgrades** The city of Wenatchee bundled several projects into one which has a total cost of \$6 million. When finished, one roadway will connect to Confluence Parkway. The Confluence Parkway itself is a \$177 million project to connect North Wenatchee with a new bridge over the Wenatchee River.
  
- D. **Confluence Parkway Project – Wenatchee Infrastructure Upgrades** The Confluence Parkway project includes a 2.5-mile bypass on the north end of Wenatchee, along with a new vehicle bridge that connects US 2 and US 97 over the Wenatchee River. The bypass would be located between Hawley Street and SR 97A, alongside the Apple Capital Loop Recreation Trail. Funding was close to finalized from state and federal sources as of the end of March.
  
- E. **Confluence Health – Issues and policies surrounding the only major hospital in the Region** Confluence Health is updating their employment vaccination policy, going into effect on March 1. Confluence Health is now going to allow unvaccinated staff to work on hospital grounds, after meeting certain requirements. A lawsuit claiming the employee requirement for COVID-19 shots at Confluence Health to be unconstitutional is officially dead.
