## Political Public File Checklist

- NAB Form (or equivalent) – forms must be fully filled out for each request for political broadcast time
- Agreement form - must be fully filled out for each candidate (part of the NAB Form)
- Candidate certification (BCRA, McCain-Feingold) for federal candidates (U.S. President, U.S. Senate, U.S. House of Representatives) This is also part of the NAB Form.
- Order
- Invoice - place in file as soon as it's available. Since this is not always available in a timely fashion, a statement has been placed in the file directing the viewer to the business dept. where airtime information may be obtained.

### Notes:

You should have a copy of your current Political Disclosure Statement in the file. Also, provide the disclosure to every requestor of political broadcast time

Do not place copies of checks or credit card receipts etc. in the file
