On 30 December 2023, the Federal Communications Commission received a complaint regarding broadcast radio station KSCV, 90.1 FM. The Complainant reported: "On Saturday, December 30, 2023, at approximately 1300 CST, KSCV's broadcast signal was observed to be occupying the entire bandwidth from 89.85 MHz to 90.35 MHz".

I request that you please provide me KSCV's equipment performance measurements (a requirement of CFR Title 47 § 73.1590). I also welcome anything else that you may care to provide regarding the issue presented in the subject complaint.
