News/Talk 750 WSB Ascertainment Statement

News/Talk WSB develops on-air programming to address issues of significant concern to Atlanta and its surrounding communities.

Our news/talk format allows the radio station to address issues of concern in our city of license on a daily basis. Issues oriented programming aired daily includes the Neal Boortz Show, the Clark Howard Show, and the Erick Erickson Show.

News/Talk WSB airs 4 hours of news and information Monday through Friday morning. In addition, WSB-AM & WSBB-FM airs eleven minutes of news per hour from 9am until 12 midnight Monday through Saturday. WSB-AM & WSBB-FM carries 5 minutes of news per hour in the remaining hours.

On a quarterly basis, News/Talk WSB produces long-form special assignment reports on issues of community concern. Recent topics have included gangs, same-sex marriage, and eating disorders.

News/Talk WSB broadcasts four community affairs programs. "Perspectives" addresses multicultural issues. "Business in the Black" addresses minority issues. "21st Century Parenting Solutions" discusses parenting issues. "The Heart of Atlanta" addresses issues of interest in the city of Atlanta. "Health Talk Atlanta" addresses health issues.

Issues on these programs are ascertained through interviews with community leaders, representatives of charitable and civic organizations, and those individuals making a difference in our listening area. News/Talk WSB also solicits community input during its public affairs programming and via the radio station's website.

Producers for news/talk programs and for the community/public affairs programs are required to provide, in writing, details about each program topic, guests, and how listeners may obtain additional information about the issue.

The WSB-AM & WSBB-FM programming specialist compiles all data for the station's quarterly reports under the supervision of the assistant program director for WSB-AM & WSBB-FM who is responsible for the ascertainment process.

Seventh, Congress authorized no funds for federal "fallback" exchanges. So Washington may not be able to impose Exchanges on states at all. Eighth, the Obama administration has yet to provide crucial information that states need before they can make an informed decision. Ninth, creating an exchange sets state officials up to take the blame when Obamacare increases insurance premiums and denies care to the sick. State officials won't want their names on this disastrous mess. Tenth, creating an exchange would be assisting in the creation of a "public option" that would drive domestic health-insurance carriers out of business through unfair competition. Finally, rejecting an exchange reduces the federal deficit. Obamacare offers its deficit-financed subsidies to private health insurers only through state-created exchanges. If all states declined, federal deficits would fall by roughly \$700 billion over ten years.

What constitutes such a “critical mass” has not been defined, and the validity of the metric has come under fire from conservative judges, such as Chief Justice John Roberts. In questioning Roberts said, “... you won’t tell me what the critical mass is. How am I supposed to do the job that our precedents say I should do?”

For better or worse, Americans smoke pot. Roughly 100 million Americans admit to trying marijuana at least once and 11.5% of Americans have smoked marijuana in the last year. Usage seems especially high when considered in light of the controlled substance schedule marijuana is classified under. Marijuana is a Schedule 1 substance, the most restrictive classification. Substances in this schedule have no currently accepted medical use in the United States, a lack of accepted safety for use under medical supervision, and a high potential for abuse. Others included in this schedule are heroin and LSD. Comparatively, oxycodone, cocaine, methamphetamine and methadone are all under Schedule 2. Prohibition of any good comes at a high price. Taxpayers must fund law enforcement, judicial proceedings, and incarceration. One report from Harvard University estimates that legalizing marijuana would save \$7.7 billion per year in government expenditure on enforcement of prohibition. They also forgo any potential tax revenue. Legalization would yield tax revenue of \$2.4 billion annually if taxed at normal rates and \$6.2 billion annually if taxed at rates comparable to those on alcohol and tobacco, according to the report. On the other hand, legalization may come with hidden costs, such as increased healthcare costs if usage increases and leads to ill health effects.

The change to more creative names seemed to start with one such inside joke. One of the first creative names might be the Racketeer Influenced and Corrupt Organizations Act (RICO), which may have referred to Johnny Rico in the 1931 gangster film “Little Caesar.”

THE CLARK HOWARD SHOW: Kodak is exiting the printer business after their attempt to subvert the industry's typical business model failed. Printers are the kind of purchase that people make based on price sensitivity. Few understand that the real cost of a printer is not its upfront expense, but rather the cost of replacement ink over its lifetime. Most printer manufacturers have adopted the Gillette shaver business model. Gillette takes a loss on every handset and makes it profit on replacement blades. Hewlett-Packard -- the dominant printer company -- exemplifies this approach. They lose on every HP printer they sell just to make a handsome profit on ink cartridges. Kodak tried to do the opposite: Make money on its printers by selling them for around \$150 and then sell ink at rock-bottom prices. That unique approach only won Kodak about two percent market share in the printer business. Fortunately, Kodak's loss can be your gain. Now that the company is in bankruptcy, they've decided to exit the printer selling business yet continue selling ink at reasonable prices. So look for the Kodak printers themselves to go on discount. They should now be offered at comparable prices like you'd find from Brother, HP, and Samsung. Think of it as a twofor of savings for your home and office -- savings on the printer and on the inki!

THE CLARK HOWARD SHOW: What you pay for your water bill is rising in many places around the country, but you don't just have to take it. The real problem is you're paying for upgrades to older water systems that may date back to the early 1900s. USA Today reports many metro areas have seen water bills triple in the last many years. It's not unusual to have a water bill than can exceed your power bill in some municipalities. Many places are under court order to improve their water and sewer systems, while others have to do it simply because the delivery system is so old there's no other choice. But there are ways to reduce your water bill even at a time when the cost of service is going up. I had a low-flow toilet put into my house. I went from using 3.5 gallons/flush to 1.1 gallons/flush. Some toilets even have two buttons -- one that delivers a 1.1 gallon/flush and another for 1.6 gallons/flush. You can also install low-flow showerheads that use a blast of air to simulate a strong stream of water. And in some places, you can get a government rebate if you outfit your home with water-efficient devices. Check with your municipality to see if they participate.
