Louisiana put together a group to save the military base in Algiers, but once the land was handed over there was a dispute on who would sign the lease with the United States Navy. Mayor Mitch Landrieu is running for reelection, and he is and always has been the overwhelming favorite. There was a new twist this week as retired Civil Court judge Michael Bagneris announced he was running. In the past, he was Executive Council to Mayor Dutch Morial. Most recently, he's been in the news for fighting with Mitch Landrieu because he's one of the leaders in the Civil Court judges group that wants to build their own courthouse. But the mayor wants the Civil Court judges to go with the rest of government and move into the Charity complex that they're hoping to renovate. There's been a lot of tension between these two, but Bagneris said he is not running out of spite. He thinks the Mayor has done a poor job on dealing with the issues of crime and jobs. There's also been some excitement in the New Orleans City Council race with the news of Jackie Clarkson running in District C. She was going to retire, but with the news of Kristin Palmer not seeking reelection she will run. If Clarkson wins this would be her third stint representing District C. There was a very interesting press conference where Mayor Mitch Landrieu announced that he had called Clarkson and asked her to run. The governor's race is also getting started even though it's two years away. David Vitter hasn't formally announced he's running, but it seems that he will. Louisiana has an open primary system, and the state Democratic Party has been weakened greatly. The leaders of the party want to rebuild and get some good candidates and put up a fight. But, there's an argument that the Democratic voters might be better off supporting a Republican who is less conservative. In the past this has worked. The idea is if a Democrat state-wide or away from New Orleans gets in a runoff with a Republican, the Democrat will automatically lose. But if there's no Democratic candidate, and there are two Republicans that means that the Democratic voters are up for

grabs. And there are enough of them to where they can really swing the election. This is something that we may see as the race for Governor unfolds.
