



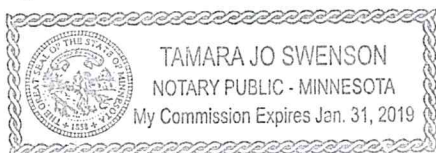

Dear Anna:

With the filing of the KQPR, Albert Lea, Minnesota Assignment Application, it will be necessary to give notice to the public of the filing of that application. With respect to the assignment of Station KQPR, it will be necessary to provide both broadcast and newspaper publication. The station must provide broadcast publication at least once daily on four days following the acceptance for filing of the application. The announcements should be broadcast between 7 a.m. and 9 a.m. and/or 4 p.m. and 6 p.m. Please keep a record of the dates and times of each broadcast announcement. I recommend starting the announcements immediately.

I have attached a sample text of the notice for you to review and use. Once broadcast publication has been completed, either you or someone at the station should complete the attached proof of publication, stating when the announcements were broadcast on KQPR. That will demonstrate the station's compliance with the Commission's publication rules. A copy of the proof of publication should be filed in the KQPR online station public inspection file along with a copy of the Assignment Application.

It also will be necessary to provide public notice of the filing of the KQPR assignment application in a local Albert Lea newspaper. The same text which I provided for the broadcast notice should be used for the newspaper publication as well.

If there is a daily newspaper published in the community of Albert Lea, the notice will need to be published in that local newspaper twice per week for two consecutive weeks. If there is no daily newspaper published in Albert Lea, but there is a weekly newspaper published in



Albert Lea, the notice should be published once per week for three consecutive weeks in that local weekly newspaper. Please also keep a written record of the dates of the newspaper publication.

There is no requirement that the local public notice appear in any particular section of the newspaper. However, most stations use the legal or classified sections. The newspaper will send the station a proof showing the dates the notice was published. I have enclosed not only the text of the notice to be used, but certifications to be completed after the broadcast and newspaper publications have been completed. Please place the notices, proofs and/or certifications in the KQPR online station public inspection file. There is no need to file the notice and certifications with the FCC itself.

Please contact me should you have questions with respect to the KQPR Assignment Application or the Commission's broadcast and newspaper publication requirements.

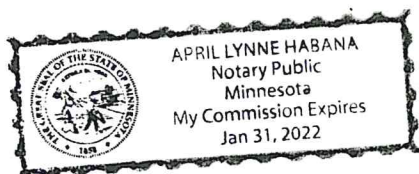
