This Exhibit summarizes the past, silent status of KHLY-AM (the “Station”) under the ownership of Sun Valley Media Group, LLC (“SVMG”) pursuant to Special Temporary Authority (“STA”) issued by the FCC.

Note: On March 27, 2017; the consummation of the acquisition and assignment of the Station’s License to SVMG occurred (File No. BAL-20170203AAI). Since that transaction, the Station has been silent under STA during the following dates:

1. On May 1, 2017, due to malfunctions of its transmitter, the Station remained silent pursuant to STA (File No. BLSTA-20170601AAK) and, as extended (File No. BLESTA-20171020AAW) until it resumed broadcasting on March 25, 2018.
2. On August 6, 2018, while local zoning, permitting and construction began of a new tower site near Hailey, Idaho, the Station remained silent pursuant to STA (File No. BLSTA-20180816AAW) until it resumed broadcasting on March 17, 2019 in Pocatello, Idaho.<sup>1</sup>
3. On May 17, 2019, while new transmitting facilities continued to be built, the Station remained silent pursuant to STA (File No. BLSTA-20190617AAO) until it resumed broadcasting on January 1, 2020 in Hailey, Idaho.<sup>2</sup>

Upon the Station’s relocation from Pocatello to Hailey, the Station has been consistently on-the-air. Further, operations of the Station have been in full compliance with FCC rules and regulations, while serving the cities of Hailey and Sun Valley as well as other communities in Blaine County, Idaho.

<sup>1</sup> Pursuant to Construction Permit, File No. BP-20170531ABF, the Station was in the process of changing: (i) transmitter sites, (ii) class of license, (iii) antenna system and (iv) city of license (from Pocatello to Hailey, ID).

<sup>2</sup> Under the Commission’s AM Revitalization, SVMG applied for a Construction Permit (File No. BNPFT-20180418AFY) for a new FM translator station to relay KHLY-AM and, upon grant, built those facilities on February 12, 2020, operating per license, K279DA at Sun Valley, ID.
