Issue: Drive Sober or Be Pulled Over

Issue: Judge to Decide How Much Time State Police Need to Release Accident Reports

A Little Rock law firm accuses State Police of violating open-records law by delaying the release of the reports. The issue is going before the Arkansas Supreme Court to settle

Issue: "My Social Security" Online Accounts Need Texting Capabilities

Social Security recipients who hold online "My Social Security" accounts will no longer be able to access those accounts unless they have a cellphone with text messaging capabilities under a new agency directive. The newly mandated policy will tighten security and protect user data.

Issue: Zika Virus Vaccine Looks Promising

Three experimental Zika vaccines protected mondys against infection from the virus, an encouraging sign s research moves into studies in people.

Issue: Casino Amendment Gets More Signatures

A group hoping to develop casinos in three Arkansas counties turned in another 50,000 signatures in its effort to place a constitutional amendment on the Nov. 8 ballot. Arkansas Wins would build casinos in Boone, Miller and Washington counties.

Issue: Broadband in all school districts making progress

Arkansas is in the midst of a project to provide high-speed Internet to each of the state's 276 districts. When complete, every school in the state will have the same broadband speed per student.

Issue: Federal Lawsuit Filed Over Planned Electric Transmission Line

Two groups representing landowners are suing to block an electric transmission line planned for delivering wind-generated power across Arkansas from Oklahome to Tennessee.

Issue: Arkansans Applying for Expanded Medicaid Program Exceed Expectations.

The number of Arkansans who had completed enrollment in the expanded Medicaid program, exceed by 50,000 state official's initial estimate.

Issue: Deadline for Paying County Real Estate and Personal Property Taxes Approaches

Deadline is October 17 for paying 2015 Real Estate and Personal Property Taxes is October 17. After that date, a 10% penalty will be charged.

Issue: Arkansas Wins Makes General Election Ballot

Arkansas Wins announces that it had received enough signatures to make general election ballot. The casino amendment will be listed on the ballot as Issue 5.

Issue: Governor Proposes Using Tobacco Settlement Money to help developmentally disabled

Gov. Hutchinson proposes tapping into \$8.5 million in unused money from the state's 1999 settlement with tobacco companies to provide more services to the developmentally disabled. Hutchinson will ask the Legislature to redirect the money.

Issue: President Obama Pushes New Plan to Combat Heroine and Opiod Abuse

The President is pushing a new plan to fight the deadly heroin and opioid addiction affecting so many families. The Justice Department plan will call for law enforcment to identify links between over-prescribing doctors and distribution networks across the country and prosecutors to share information across state lines.
