

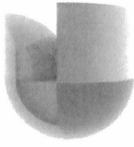
Except as otherwise indicated, the Station certifies that, with respect to each Network carried on each program stream, over the previous calendar quarter:

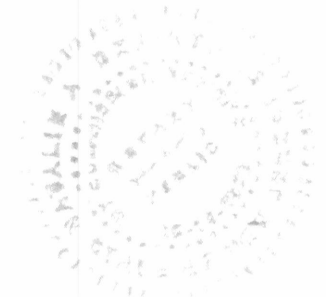

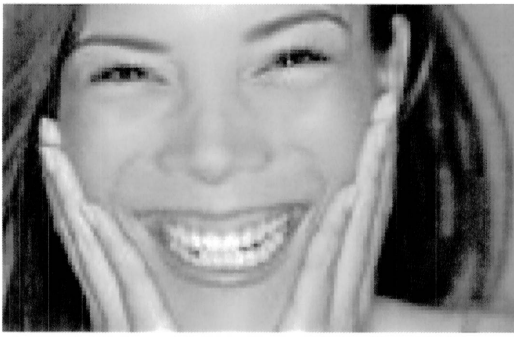
