**RADIOTHON FOR UNITED WAY OF MORROW COUNTY by 95X WVXG**

On February 26th, 2015, The First "Live United Radiothon" for the benefit of the United Way of Morrow County was held in Mt. Gilead. The Staff of 95.1 FM worked for several months on the planning and coordination of the event with the staff of the United Way and its Board members/volunteers, and eight hours of on-air time were donated.

The station developed and ran an event promo for several months and provided in-depth support to the United Way organization as a public service. Station staff also made a presentation to the Board on how they could effectively maximize results.

During the Radiothon, staff were on-air the entire 8 hours interviewing community members, businesses, United Way agency staff and recipients, and directing appeals. The staff also provided advertising incentives for businesses making donations to United Way and did contests during the radiothon that generated additional funds.

When the end concluded, a total of \$12,000 had been realized. The amount more than doubled the original goal of \$5,000.
