Dear Sir or Madam:

Pursuant to the Cable Television Consumer Protection and Competition Act of 1992 and Section 76.64 of the rules of the Federal Communications Commission, Station WPVI-TV, Philadelphia, located in the Philadelphia, PA designated market area (the "Station"), hereby elects to continue retransmission consent with respect to carriage of the digital signal of the Station on all systems, headends, and franchises owned by, controlled by, or affiliated with the above-referenced entity, in all communities and franchise areas served by such systems, headends, and franchises, for the three-year period commencing January 1, 2012 and ending December 31, 2014 and for any period thereafter to the extent covered by your existing retransmission consent agreements with ABC, on the terms specified in such agreements.
