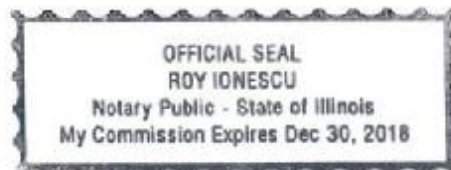

A candidate for whom nomination papers have been filed as a partisan candidate for the March 15, 2016 Primary Election, and is defeated for his or her nomination at the primary election, is ineligible to file a Declaration of Intent to be a Write-In Candidate for the November 8, 2016 General Election.
