Notice of ATSC 1.0 Signal Relocation in Connection with Next Gen TV Transition WCCT-TV, Waterbury, Connecticut (Facility ID 14050)

This instrument is to certify that notifications of the change in operations to WCCT-TV were sent on July 13, 2021 to 41 Multichannel Video Programming Distributors (“MVPD”) located within its service area via Certified mail with electronic return receipt.

TEGNA Broadcast Holdings, LLC (“Licensee”), licensee of television station WCCT-TV, Waterbury, Connecticut (“WCCT”), has notified, pursuant to Section 73.3801(h) of the rules of the Federal Communications Commission (“FCC”), that WCCT intends to relocate its ATSC 1.0 signals to temporary host station facilities in order to facilitate WCCT’s commencement of broadcasting in the ATSC 3.0 (Next Gen TV) broadcast standard (the “WCCT Next Gen Transition”).

WCCT currently broadcasts in ATSC 1.0 on RF Channel 33 at 220 kW ERP. The WCCT Next Gen Transition will occur at 10 a.m. Eastern Time on October 12, 2021 (the “Transition Time”). As of the Transition Time, WCCT’s ATSC 1.0 broadcast of (a) its primary program stream will be relocated to the facilities of WTIC-TV, Hartford, Connecticut (Facility ID 147) (“WTIC” or “Primary Host”), and (b) its multicast program streams will be relocated to the facilities of WFSB, Hartford, Connecticut (Facility ID 53115) (“WFSB”) and WTNH, New Haven, Connecticut (Facility ID 74109) (“WTNH,” and together with WFSB, the “Multicast Hosts”). Copies of the current broadcast licenses of WTIC, WFSB, and WTNH were provided in the notification and set forth for each host’s antenna position, location and power level, as well as the

table below to provide post-transition stream identification information for each WCCT program stream.
