**WKOW Reduced Power Operations from Licensed Aux Antenna**

This filing is to notify the Commission that WKOW has commenced use of its licensed aux antenna (CDBS File No. BXLCDT-20061106ABC) for an as-yet undetermined period of time.

WKOW, which is not a reassigned station as part of the nationwide post-Auction transition, shares a tower site with reassigned stations that are currently in the midst of their repack construction projects. In furtherance of the execution of these repack projects, WKOW has moved its operations to its licensed aux antenna. As of the date of this filing, it is unclear how long WKOW will need to broadcast from its aux antenna.
