Money Tips

The Internal Revenue Service has plenty of ways to penalize you for mistakes on your tax return. Some of these potential penalties are so convoluted and complex that there may well be disagreement within the IRS on when they apply. However, most people accrue tax penalties for very simple mistakes. Here are some of the more common yet easily avoidable mistakes.

Failing to File – Do you really think the IRS will forget about the fact that you did not file your tax return? It may take some time, but the IRS will eventually catch up with you. Expect little sympathy if you do not file. The IRS is willing to work with people to make payments, but if you make no effort at all, you are subject to the non-filing penalties of 5% per month of the due taxes, up to 25% of your unpaid tax bill.

Many people simply put off filing until it is too late, and think that doing nothing is better than attempting to file a potentially wrong return. You can deal with that problem by filing an extension with Form 4868_to buy time. Note that 4868 does not buy you time to pay, just time to file. You still have to make a reasonable estimate of your expected tax payments.

Of course, the best solution to the problem is to keep your records organized throughout the year to make the April filing easier.

• **Not Making Payments** – If you do not pay the taxes that you owe by April 18th (normally April 15th), another penalty applies, just not as large of a penalty as for non-filing. The monthly penalty is 0.5% of your unpaid taxes, up to 25% total. That applies even with an extension, since Form 4868 requires you to estimate your taxes and send in your payment with the form.

The IRS does allow installment programs and other provisions in some cases that can reduce or eliminate penalties and interest, so it really is in your best interest to explore options rather than to send in partial payments on your own (or avoid payment altogether).

- Forgetting Signatures If you fail to sign your paper form, it is as if it was never submitted. That is even true with e-forms, where you "sign" via a PIN number. Double-check to make sure that you sign your form. Otherwise, you will be subject to the non-filing penalties unless you send in a properly signed form as well but you risk IRS confusion with two submitted forms.
- Not Making Quarterly Payments Self-employed individuals must make quarterly estimated tax payments throughout the year so the government can receive regular cash flow from estimated taxes in the same way that employers take out monthly deductions for taxes. Filing in a lump sum at the end of the year can result in an "underpayment" penalty even if you paid the full amount of taxes due. You did not pay it at the right time.

You can avoid this penalty by making sure estimated taxes are regularly paid. For independent contracting jobs where the income varies greatly, you can use the "safe harbor" provision by paying 100% of last year's tax liability or 90% of this year's estimate, whichever is less. If you also have a salaried job or your spouse has one and you file jointly, you can cover the taxes by having extra monthly taxes withheld on the salaried position. That spreads the taxes out in roughly the right time period.

• No Apparent Health Insurance – The Affordable Care Act requires that you have health insurance or you must pay a penalty (for 2017) of the greater of 2.5% of your income, or \$695 per each adult not covered, plus \$347.50 per child not covered. Each 1040-style form has a box to check for "Health care: individual responsibility." Fail to check this box and the IRS has no way to know that you have health insurance; thus, you will be assessed a penalty.

With a little attention and vigilance, you can reduce your chances of simple errors that could result in tax penalties and/or audits. Why give the IRS any more of your money than you have to?

Topic: Taxes: When Married Couples Need to File Separately

With April 18 just around the corner, chances are you and your spouse are knee-deep in tax work. Most couples file jointly to take advantage of various benefits but depending on your situation, you may want to file separately. We tapped Kelly Phillips Erb, a Philadelphia tax attorney who blogs at Forbes, for some pointers on when to do this. (Sadly, love doesn't conquer all when it comes to the tax man.)

1. When a Spouse Has a Tax Liability

Though your spouse's liability won't carry over to you, it could throw a wrench in your taxes if you file jointly, Erb says. "It can make filing taxes complicated because you have to file an injured spouse claim" if something goes wrong. For example, if your husband owed back taxes but as a couple you got a refund and the IRS decided to take it, you'd be prompted to file an injured spouse claim. This may help get part of your refund back.

Your spouse's back taxes could also impact their credit score if the problem gets bad enough. The government could make a claim on your property until the debt is repaid, which is known as a tax lien. This will show up on your spouse's credit report and could make it harder for them to borrow money in the future. (You can see how a tax lien and other factors may be hurting your credit by reviewing two of your free credit scores on Credit.com, which are updated every two weeks.)

2. When a Spouse Can't Be Trusted

"When you file a return, you sign under penalty of perjury," Erb explains, noting taxpayers vow to report everything to the letter. "If you sign the return knowing they tend not to be forthcoming, you're putting yourself at risk."

Erb recalls a client who dealt with this issue for 15 years and "ended up with a liability in the millions she couldn't pay." However, she had signed a return with her husband claiming things were just fine. The IRS eventually chased both of them down for the money, even after they separated. "When you get married, you like to think everything's rainbows and unicorns," Erb says, but "don't file if you think they're not being truthful. Ignorance is not an excuse."

3. When a Spouse Lives Abroad

"There are some tax reasons why you might file separately, but as a rule, most people file separately for non-tax reasons," Erb says. However, if one spouse has a different residency — not just between states but in another country entirely — it "might be advantageous to file separately, because depending on the situation, you could possibly lose credits or other tax breaks that you might not want to."

Driverless vehicles could be on our roads sooner than you think. That's if a \$500,000 appropriation is approved by the state legislature.

District 16 Rep. Jason Fischer filed House Bill 3831 requesting the money to help fund the Driverless Tra According to the appropriations project request, "the funds will be spent to invest in the transportation technology and to bring two Olli shuttles to Jacksonville and Baptist Health complex as the first working example of this technology anywhere in Florida."

The autonomous electric minibus was designed by Local Motors. It's already on the roads in Washington, D.C., and will soon be used in Miami-Dade County and Las Vegas.

According to an IBM press release, Olli's passengers will get to interact with it as they travel. They'll be able to ask the vehicle questions, like where are it's going and why it's making specific turns.

Olli will also be able to study transportation data and will be equipped with 30 sensors throughout the vehicle.

ONGOING MAINTENANCE ON DAMES POINT BRIDGE BEHIND SCHEDULE

Jacksonville, Fl. - The ongoing maintenance started in January and was originally planned to end mid-March.

Hampton Ray with the Florida Department of Transportation says the contractor has a 200-day contract which expires in May.

The Dames Point Bridge currently has one lane blocked in each direction during the day and multiple lanes blocked at night.

Ray says the reason drivers do not see actual construction crews while traveling over the Dames Point Bridge is because the work is being conducted on the side and below the bridge. Lane closures are necessary because cars traveling over the bridge are going highway speeds and it's the best way to ensure the safety of the construction crews.

"It's a temporary inconvenience for a permanent solution. This will definitely add life to the bridge," Ray says.

FDOT says the contractors are working as quickly as possible to make the bridge stronger and safer as they work on the joints where the bridge connects.

During the night, crews are also working to install a permanent catwalk on the north and south towers which is the reason behind the multiple lanes being shut down.

Authors of Florida's voter-approved constitutional amendment that broadly legalized medical marijuana are blasting proposed rules to regulate the cannabis industry.

The proposed rules, released Tuesday by state health officials, would essentially maintain current vendors' stranglehold on the medical marijuana industry --- poised to become one of the nation's top money-makers --- by applying current Florida laws and rules to the constitutional amendment approved in November.

"It looks like the Department of Health is protecting the existing monopolies. I hope the Legislature chooses to act in creating a free market system. The Legislature has a chance to change that," said Ron Watson, a lobbyist who represents AltMed, a Sarasota-based company founded by former pharmaceutical industry executives who have obtained a medical marijuana license in Arizona and are seeking one in Florida.

Guadalupe Osteen said she was diagnosed with post-traumatic stress disorder (PTSD) and bipolar disorder years ago, and said the medication prescribed to help her has made her feel worse.

"Knowing you have to wake up and not be normal, and you have to depend on a medication to live your life," Osteen said. "You can't just get up and go. It gets depressing." She wanted to know if she'd be eligible for medical marijuana under the state's new law. Osteen soon learned about Liberate Physician Center through Facebook."They made me feel welcome," she said. "They were very professional, and I would recommend it to anyone."Liberate has seen about 15 local patients since it opened its doors in Mandarin last month.Liberate's Melissa Blake said a patient can come in for a consultation, which is a medical review to see if they have an eligible condition. Qualifying medical conditions include cancer, epilepsy, HIV and PTSD. "Once we have received all of their records, then we are going to review all of them," said Blake, managing director of the company in Jacksonville. "The doctor is going to review them." The company says the cost of the first visit is \$169.A follow-up visit may include a physical exam with a doctor who is on the state's qualified list to treat patients using medical marijuana. Amendment 2 was passed by voters in November, making medical marijuana legal in Florida. However, Florida's leaders are still working on the final rules for implementation. The amendment left most of the details up to the state Legislature and state health department. Under the new law, doctors must treat patients for at least three months before entering orders for marijuana treatment. One of Liberate's main goals is to get a jump start on this doctor-patient relationship."Once the rules are actually out. we figure there's going to be a mass frenzy of everybody just trying to get into different doctor's offices," Blake said. This way, Blake said patients with debilitating illnesses can have access to treatment the day the rules are set.

Jacksonville continues to have one of the highest HIV infection rates in the state. Action News Anchor Tenikka Hughes Lutheran Social Services and Community Aids Network will open a clinic to assist those who have been diagnosed with HIV. pharmacy. The clinic is due to open the southside of Jacksonville in the spring of 2017 according to Heather Vaughan with Lutheran Social Services. The American prison system costs taxpayers an estimated \$75 billion dollars per year; Tenikka Hughes speaks with Dr. Michael Hallett a published author and a professor at the University of North Florida. In 1994 the federal government revoked pell-grant eligibility of convicted felons. Dr. Hallett goes on to discuss his study of Angola State Penitentiary who installed a seminary to assist with the rehabilitation of prisoners. Based on his study, a faith based rehabilitation program seems to have a positive impact on inmates, thus reducing the prison population and the overall financial impact on taxpayers.
