NEW YORK - A new report shows Zika birth defects were about the same in Puerto Rico and other U.S. territories as in other places hit by the epidemic.

About 1 in 20 women infected with Zika had babies with birth defects in U.S. territories. That's similar to what was seen in the rest of the United States and countries in Latin America and the Caribbean. The report was released Thursday.

The island territories — particularly Puerto Rico — are the U.S. locations hardest hit by the Zika epidemic. The tropical mosquitoes that spread Zika are more widespread there.

Most people infected with Zika don't get sick. It can cause a mild illness, with fever, rash and joint pain. But infection during pregnancy can lead to severe brain-related birth defects.

St. Johns County woman says she was scammed by Chihuahua puppy website

A 19-year-old St. Johns County woman called police and told them she was scammed out of thousands of dollars when she attempted a purchase a Chihuahua puppy online.

The woman said that on June 25, she found a Chihuahua puppy on the website Classy ChihuahuaPuppies.com. She sent the company, located in Texas, \$500 via Western Union, she told the St. Johns County Sheriffs Department.

She said a man named "Devin Chase" told her the puppy would be flown to her.

On day later, on June 26, a representative from Domestic Pet Movers called her and said the puppy required a special crate, which required an additional \$799.

The woman went to Publix and sent the money. After she sent the money, another person called and said the dog needed medical shots before he could be flown.

The woman went to back to Publix and sent an additional \$1,373, police said.

When the woman called Domestic Pet Movers, she was told to send another \$1,028 or the police would "show up at her door."

The woman then hung up. She told polcie she thought the website looked legitimate but that the callers on the phone sounded deceptive.

The St. Johns County Sheriffs Department closed the case and advised her to contact her credit monitoring service and the Better Business Bureau.

A recent survey from the National Association of Realtors found that 71% of student loan borrowers cited their student loan burden as a reason to delay buying a home.

The student loan plight may be a major factor in the housing market struggling to gain momentum, and these loans certainly affect the debtors directly. Jocelyn Paonita, Founder of The Scholarship System, describes the issue this way: "College debt has such a crippling impact for the rest of someone's life because you're not able to take advantage of opportunities right from the beginning."

Home mortgage backer Fannie Mae recently announced new rules that may help relieve that impact. Fannie Mae introduced three changes to its underwriting rules that may help those struggling with student loan debt to enter the housing market. The change will also allow the estimated 8.5 million student loan debtors that already have homes to reduce their overall debt burden.

Two of the changes relate to the calculation of the debt-to-income ratio (DTI), an important threshold in establishing loan qualification. To qualify for a mortgage loan, your monthly DTI ratio should generally be at or below the 43% to 50% range. Fannie Mae has altered two common sticking points for student loan debtors that lowers the DTI and makes it more likely that debtors can reach the loan qualification threshold.

The first change involves income-driven repayment plans – programs that allow reduced payments on student loans in proportion to the debtor's income. Because the payment can vary as part of the plan renewal, lenders were instructed to use a set 1% of the student loan balance instead of the lower payment amount when calculating DTI – a difference that can easily push calculated debt levels above the DTI threshold given significant student loan balances.

Under the new rules, the existing lower payment amount may now be used for calculating DTI values as long as the payments show up on the borrower's credit report and are above zero. It may take a month or two after a payment plan is established for that plan to show up on a credit report, so make sure that you can verify your lower payment before attempting to take advantage of this new rule. You can check your credit score and read your credit report for free within minutes using Credit Manager by MoneyTips.

The second change regards third-party payment of student loans. Whenever a third party (such as an employer or a parent) is regularly making the student loan payments on behalf of the student, the student loan debt has been historically included in the borrower's debt-to-income ratio even though the debt is being regularly paid by others. Fannie Mae now allows mortgage lenders to exclude those debts from the DTI as long as there is documentation that the third party has made adequate payments for at least one year.

For those who have the combined burden of homeownership and student debt, Fannie Mae has changed the rules to make cash-out refinancing a more economical option. If you have enough equity in your home to pull out extra cash and apply it toward paying off your student loan debt, Fannie Mae has eliminated fees associated with the cash amount above the mortgage value and ensured that the excess is not assessed at a higher interest rate than the mortgage. Not all student loans must be paid, but at least one student loan must be paid off in full as part of the transaction.

It's not obvious that a cash-out refinancing would be preferable, because it depends on the terms and type of your student loan. The interest rate on your refinancing may not be preferable to the rate of your student loan, especially federal Perkins or Stafford loans. You will also lose the potential advantages associated with a federal loan, such as deferment options. Use online calculators to run numbers and verify whether a cash-out refinance makes sense for you. MoneyTips is happy to help you get free refinance quotes from top lenders.

RICHMOND, Va. - William Morva showed signs of mental illness long before he killed two men during an escape from custody in 2006, friends and family say. In the years leading up to the killings, Morva began sleeping in the woods, showed up barefoot at his father's funeral and was banned from a school campus after being found half naked on a bathroom floor.

Now Morva is days from being executed in Virginia for crimes his attorneys say were spawned by delusions that made him fear for his life. The case of the inmate, now 35, has pushed to the forefront the debate over whether people with mental illness should be shielded from the death penalty.

"He has never understood completely exactly what he did, the ramifications of what he did, the lives he has upset," Morva's mother said in a video, urging Virginia Gov. Terry McAuliffe to halt the planned lethal injection Thursday and commute his sentence to life without parole.

Jailed in 2005 on accusations that he tried to rob a convenience store, Morva was then taken to a hospital to treat an injury. There, he attacked a sheriff's deputy with a metal toilet paper holder, stole the deputy's gun, and shot an unarmed security guard, Derrick McFarland, before fleeing.

Morva's escape set off a police manhunt that shut down Virginia Tech's campus the first day of the school year. A day later, Morva fatally shot another deputy, Eric Sutphin, before Morva was found in a ditch with the deputy's gun nearby.

Jurors were told Morva suffered from a personality disorder that resulted in "odd beliefs," but not delusions. He has since been diagnosed with delusional disorder, a more severe mental illness akin to schizophrenia that makes it impossible for him to distinguish between delusions and reality, his attorneys say.

His lawyers say Morva escaped and shot the two men because he believed he was going to die in jail.

"Look, don't you understand that they are trying to keep me in here? Somebody wants me to die, and I don't know who it is," Morva told his mother in a call from jail, before his escape.

A prosecutor in Morva's case called it "highly inaccurate" that jurors didn't have a full picture of Morva's mental health, noting that several experts who examined him agreed he had a "superior IQ" and suffered from a variety of personality disorders. Montgomery County Commonwealth's Attorney Mary Pettitt said in a letter to McAuliffe that to "assert some 10 years later that all three of the original experts were wrong is absurd."

"With enough time and motivation one can always find an expert to say what you want to hear but that doesn't mean it's true or accurate," Pettitt told the governor. She declined to be interviewed by The Associated Press.

Relatives of Morva's victims either didn't return phone messages or couldn't be reached.

While the U.S. Supreme Court has said people who have intellectual disabilities and commit crimes when they are juveniles cannot be executed, the justices haven't extended that exemption to adults who were mentally ill when they committed their crime. The court has said only that states cannot execute people who are "insane" and don't understand why they are about to be put to death.

Proposals to ban the death penalty for people with severe mental illnesses have recently been considered in several capital punishment states, including Virginia. None have passed in part because critics fear it will result in every defendant alleging a mental illness, said Ronald Honberg, a senior policy adviser with the National Alliance on Mental Illness. The group is urging McAuliffe to grant Morva clemency.

At trial, Morva told jurors his name was Nemo, calling that a "slave name." He smiled, snapped his fingers and nodded at jurors when the verdict of death was read as if he "won the lottery," Derrick McFarland's father commented at the time. Morva also has expressed belief that a former presidential administration conspired with police to imprison him and that his own attorneys were working against him, but has never received treatment for his mental illness, his lawyers say.

"If he had gotten treatment, could all of this have been prevented? Hindsight is 20/20 but one can't help but wonder," Honberg said.

McAuliffe, a Catholic who says he personally opposes the death penalty but has an obligation to uphold the law as governor, has called off one execution since taking office. In April, he granted clemency to Ivan Teleguz, saying jurors in the murder-for-hire case were given false information that may have swayed sentencing.

Virginia governors have halted executions for mental health concerns before. In 2008, Gov. Tim Kaine commuted a man's death sentence amid concerns about his competence. A decade earlier, Gov. Jim Gilmore spared a man with schizophrenia.
