Also, in the news recently, Attorney General Conway’s scrutiny of for profit colleges which he says often make promises they don’t keep. One of those colleges called it false and has been organizing support for his Conway’s opponent. Attorney General Conway faces Republican nominee Hopkins County Attorney Todd P-Pool on November 8th.

TOPIC: Republican nominee for Attorney General Todd P’Pool is keeping himself in the news lately as he tries to unseat incumbent Democrat Jack Conway. He also says Kentucky should take an aggressive stand toward what he considers over-reaching by Washington. P’Pool is the Hopkins County Attorney, he’s a UK Law graduate and

Williams finds himself trailing in the polls, but he says voters are only now focusing and this week his campaign rolled out spots that criticize Beshear for job losses in the state during the last four years. Williams represents a string of counties in Southern Kentucky, but he's hoping to capture the state's highest office.

TOPIC: Kentucky's statewide elections are now just over six weeks away. The Commonwealth will elect a Governor and Lt. Governor, as well as Attorney General and other offices. Governor Steve Beshear is seeking re-election and has a big lead in the polls and fundraising. But Republicans insist there is still time for their nominee Senate President David Williams to pull off an upset. While that is going on – candidates in next year's Presidential race are already fighting it out especially on the Republican side. In Kentucky – Legislative and Congressional candidates are lining up for next year, even though they don't know how or if district lines will be drawn up. Two players on the Kentucky Political landscape – Terry McBrayer is a former Chairman of the State Democratic Party – now a powerful lobbyist and lawyer with a worldwide list of clients. He was once a serious candidate for Governor himself and a member of the Legislature. Republican State Senator Damon Thayer of Georgetown – who has been involved in politics at every level in Kentucky. He's been elected and re-elected by wide margins in a district with a Democratic Majority – he also runs a Georgetown based communications firm.

GUEST: Paul Patton, Former Kentucky Governor, President of University of Pikeville

TOPIC: Former Kentucky Governor Paul Patton led the commonwealth from 1995 to 2003 and always considered one of his crowning achievements the passage of a 1997 Higher Education Reform Act. After that, he also assumed the Presidency of what is now the University of Pikeville, which now has a remarkable story of growth and new programs to share.

TOPIC: Morehead State University is boasting an all time record enrollment, topping 10,000 students for the first time ever. What's driving students to college and specifically to MSU? Morehead State's President is among a group of exceptionally strong regional University President's serving in Kentucky right now. - August 9 Could the Fed increase interest rates to help give the economy a boost, and a fast food giant says sales are booming!
- August 10 Wall Street is hoping to build on Tuesday's big rally. The Dow gained almost 430 points – its best day in more than two years – the Nasdaq finished nearly 125 points higher
- August 11 Wall Street is hoping for a turn-around after the Dow tumbled another 519 points, losing 4% of its value – the Nasdaq fell more than 100 points – the President is looking for ways to help the economy and focusing on the housing market
- August 12 Investors are hoping to build on yesterday's huge gains in the market – the Dow closed up more than 400 points – a better than expected jobs report fueled Thursday's rebound
- August 15 Traders hope the markets can stabilize this week after last week's huge swings. The Dow finished up or down 400 points or more – four days in a row.
- August 16 The buyers were back on Wall Street after a string of merger announcements boosted investor confidence. Stocks have now erased all of their losses since Standard and Poors cut America's credit rating on August 5th
- August 17 The stock market's three day rally came to an end. Investors sold stocks on continued worries about Europe's economic and debt problems
- August 18 Nervous investors pulled more than \$40 billion out of stock and bond funds in a single week. That's the largest amount removed from mutual funds in one week (in nearly 3 years).
- August 19 The calm didn't last for long on Wall Street – stocks were pummeled once again following a few quiet days for world markets. Traders are becoming increasingly worried that the U.S. will fall back into a recession
- August 22 Wall Street will try to find its footing after a four week losing streak – investors continue worrying about a potential global recession and the health of the European banking system
- August 23 Investors are trying to put a four-week losing streak behind them – but the housing market still appears to be in trouble
- August 24 The earthquake that hit parts of the east coast did not disrupt the stock market's rally, stocks made it two winning days in a row after some encouraging economic news from Asia and Europe

August 25	The stock market is on track for its first winning week – stocks rose for the third straight day – encouraged by some better than expected news on manufacturing
August 26	Wall Street is waiting for a speech later today by the Federal Reserve Chairman, Ben Bernanke will speak at the Fed's annual retreat in Jackson Hole Wyoming. Some investors hope he'll announce more government support for the economy.
August 29	Investors are getting ready for what could be a big week on Wall Street. Several major economic reports come out this week including new data on the housing market, auto sales, the unemployment rate and consumer spending
August 30	Stocks extended last week's rally on news that consumers spent more money last month. Investors were also relieved that hurricane Irene appears to not be as costly as first feared.
August 31	Some Federal Reserve officials pushed this month for a more aggressive response to the weak economy. Notes from their August meeting show Fed officials discussed a range of options, including buying more treasury bonds
September 1	The stock market closed the book on a wild month with modest gains. Stocks made it four winning days in a row. The Dow rose 53 ½ points.
September 2	There are new estimates about what will happen with unemployment, and gas prices are in uncomfortable territory
September 5	The stock and bond markets are closed for Labor Day. Stocks plunged after a weaker than expected unemployment report renewed fears that the economy can slip back into a recession
September 6	Wall Street is open for business after the long holiday weekend. We'll see if stocks can bounce back from last week's selloff, when the market plunged following a dismal August unemployment report.
September 7	It was a bumpy day on Wall Street with nervous investors responding to increased concerns over the European debt crisis and stalled U.S. economic recovery
September 8	Investors are gearing up for President Obama's highly anticipated jobs speech tonight. Jobs are a top priority for both Main Street and Wall Street, especially after last week's dismal report that showed zero job growth last month.
September 9	The New York Stock Exchange is remembering the 10 th Anniversary of 9/11 today. Once trading gets underway, investors will have the chance to react to last night's speech by President Obama on jobs

September 12	We are now seeing how Hurricane Irene affected business at one of the major tourism cities on the East coast and trouble in Europe has investors on Wall Street paying close attention to the markets
September 13	Another wave of layoffs is coming to Wall Street. Bank of America is cutting 30,000 jobs over the next five years, the struggling bank says the move will save it \$5 billion a year
September 14	Large U.S. Banks will soon have to show the government how they would break up and sell off their assets in the event they fail. The rules – are designed to reduce the chances of another government bailout of Wall Street banks if there is another financial crisis
September 15	Investors pushed stocks higher Wednesday after the leaders of Germany and France promised to help Greece avoid defaulting on its debts.
September 16	Mortgage rates are at their lowest level in six decades, but few Americans can take advantage of the historically low rates because banks are now much stricter about lending after the financial crisis
September 19	Fed policy makers meet this week to decide whether the economy needs another helping hand. They are expected to discuss a third round of bond buying that would push more cash into the financial system and help keep interest rates low
September 20	Growing fears about a Greek default put an end to a week-long rally on Wall Street. Financial and energy stocks led the sell off
September 21	Wall Street expects the Central Bank to announce a new plan to help stimulate the weak economy.
September 22	The Fed will sell billions in short term bonds to buy longer term treasuries. The move is designed to reduce rates on mortgages and other consumer and business loans.
September 23	The stock market will try to recover from its biggest two day slide since the financial crisis three years ago. Stock plunged after a gloomy outlook by the Federal Reserve renewed fears of a global recession.
September 26	The recent safe haven investments fell out of favor as investors dumped the gold and silver to raise cash. They're worried the global economy is headed for a recession and could cut demand for the commodities. Gold fell nearly 10% last week, silver plunged 25% - those same fears sent crude oil lower to close at around \$80 a barrel.
September 27	Investors are hopeful that European leaders will act soon to contain the region's debt crisis. Stocks rose despite news that new home sales fell to a six month

low in August.

September 28

Stocks soared on renewed hopes for a resolution to Europe's debt crisis, but they pared some gains later after the financial times reported that European leaders are split on the terms of Greece's second bailout package

September 29

Investors are still waiting for European leaders to take concrete action to address their region's debt crisis. GM factory workers have approved a new four-year contract with the automaker – it provides profit sharing instead of pay raises for most workers and also promises at least 5,100 new jobs.

September 30

Investors are concerned Europe's debt crisis will trigger a global recession. Investors unloaded shares of luxury retailers on concern about slower economic growth in China.

It is a one-minute segment outlining a crime, how it occurred, the location of the crime, clues, and any hidden-camera footage of the suspect. A reward is offered to anyone who has information that will lead to the arrest and conviction of a suspect.

July 5

He racked up thousands of dollars in charges on a stolen credit card. Now police hope you'll recognize the man who went on the illegal shopping spree. They say he's made more than \$5,000 dollars worth of charges on a stolen Home Depot Credit card. Now police are hoping you'll know who this man is. Officers say between April 28th and May 3rd of this year, the suspect went to several Home Depot stores to rack up \$5,224 in purchases on one woman's stolen card. Det. Robert Sarrantonio says what this person did was go in and buy metal; spools of metal; and what that person did was take them to a scrap metal shop. Police say the man probably got hundreds in cash from selling the stolen goods – and now they say they need your help putting this man behind bars. Crime Stoppers is offering a \$1,000 cash reward for information leading to an arrest in this case.

July 19

He was caught on tape carrying out his crimes. Police say the same man broke into stores in a strip mall over the course of several days, but it was where he went after the burglaries that could give police new clues in the case. Police are hoping you know who this man is! They say between April 23rd and May 3rd, this man broke into stores four times at a strip mall on Versailles Road near Red Mile. Same suspect doing the burglaries – have been taking rocks and throwing them through the glass. When they're going in – they are mostly taking cash out of the register. The stores were leaving cash in registers overnight; something we've instructed them not to do. With the stolen cash, police say the suspect would often walk to the Thornton's on Versailles Road. Police are hoping the store's video will give you a better look at the suspect and his jacket – a black hooded with flames on the sides and back upper shoulder. Crime Stoppers is offering a \$1,000 cash reward for information leading to an arrest in this case.

July 26

Surveillance cameras captured two men robbing a Lexington gas station. Now police say these two may be responsible for similar crimes in the area, and they are offering a reward for information that helps lead to an arrest. Two men burst into the Speedway at Man O War and Liberty Roads – robbing the overnight clerk who was working at 1:40 am on April 28. Police say both had handguns, both were wearing all black and one spoke with a Spanish accent. Officers say they made the clerk empty the register, a safe, and stole cigarettes on their way out. But police say their crime spree wouldn't end there. A short time later, Paris Police Department dispatch had a call with a commercial robbery to a Thornton's station with their same description. Officers need your help identifying these two men before they strike again. We believe they are in Lexington or in the surrounding counties. Police say they were spotted taking off from one crime scene in a newer model white two door pickup with a white bed cover. Crime Stoppers is offering a \$1,000 cash reward for information

leading to an arrest in this case.

August 2

It is a hard loss for one family. Two brothers shot and killed – just more than two years apart. Now that family is pleading to the public to come forward with information to help solve the murders of these brothers. Two brothers and two cold cases – police are hoping you’ll know who’s responsible for gunning down Quinn and Micole Dent. It’s hard to console someone who’s lost two children, especially in this tragic manner. Three months ago, police say Micole had just left a nightclub on Fortune Drive when two men wearing bandanas over their faces came from the side of the building shooting him dozens of times. Making matters worse for Dent’s family, it forced them to re-live the murder of Micole’s brother, Quinn, who was gunned down on September 28th in 2008 near a nightclub at the corner of East Second and Spruce Streets. We couldn’t believe it – there are no words – feeling like we just lost, surely this can’t be happening again. Crime Stoppers is offering a \$1,000 cash reward for information leading to an arrest in this case.

August 9

They say she stole wallets from purses in Lexington restaurants and used folks credit cards to go on a shopping spree. Police want you to take a close look at this woman. They say on July 1st and 2nd, she stole wallets at two Hamburg restaurants – Johnny Carinos and Cracker Barrel and used the credit cards inside to rack up thousands of dollars in purchases minutes later. The victims say one moment they got up and they were gone. These criminals know to go out immediately and go to a store and use them before a credit card is stopped. Police say after stealing the credit cards at Johnny Carinos, the woman shopped in Brannon Crossing. The next day, they say she stole a wallet at the Cracker Barrel on Winchester Road and spent more than \$3500 at an area Wal-Mart and Walgreens. Officers say she may be connected to more cases. Crime Stoppers is offering a \$1,000 cash reward for information leading to an arrest in this case.

August 23

Police are looking into two different gas station robberies that happened about an hour apart. A man held up the Swiftly Oil in Frankfort last night. The robber used a pipe or wrench to attack the clerk before taking off with the money. About an hour later, someone held up the Speedy Mart on Main Street with a silver handgun. The description of the robber in both cases is the same. Anyone with information on the robberies is asked to contact Frankfort Crime Stoppers.

Police say they’ll check with neighboring businesses for surveillance of a robbery. The crime happened around 6PM at Emperor’s Cleaners in the Idle Hour Shopping Center in Lexington. A man held an employee at knife point while he robbed the store. That clerk says he then told her he had a drug problem and apologized for robbing her. That robber is still on the run.

August 30

Police need help finding a man who attacked a woman as she was walking through a Lexington neighborhood. The woman was able to help investigators

come up with a sketch of the man and now they're offering a reward for information that helps put the suspect behind bars. Police are searching for a man – who looks like this. They say on the morning of June 25th, he attacked and robbed a woman as she was walking down Alexandria Drive. Det. Robert Sarrantonio says she was walking to her boyfriend's house. While she was walking, she noticed there was a male subject with a hood following her. Police say as the woman continued, she lost track of the man following her. He then all of a sudden appeared at the front door of the apartment building. Police say the man grabbed the victim from behind and assaulted her. She helped investigators make this composite sketch from her hospital bed. Police say he's a black man in his late teens or early 20's...about 5'7" with short wavy black hair and gold inlays on his upper teeth. Crime Stoppers is offering a \$1,000 cash reward for information leading to an arrest in this case.

September 6

Police say they need help finding a bank robber who struck almost two months ago. They still haven't been able to find the man who took money from a Lexington Bank. Police hope you know who this man is. They say on July 8, he robbed the Chase Bank on Clays Mill Road at 2:00 pm. He presented a note to the teller demanding cash and no dye packs. Police say the man is believed to be in his 50's, outfitted in a UK ball cap, had the teller load the money into a bag he'd brought with him. Police say after the robbery, he headed out the door, down Clays Mill towards Lafayette High School. Officers say it's especially important to find suspects committing crimes like these. Lots of times these bank robbers have committed robberies in multiple states – maybe someone can pick this up and solve multiple cases. Crime Stoppers is offering a \$1000 cash reward for information leading to an arrest in this case.

September 13

Lexington Police are looking for the people behind an early morning shooting this winter near a popular downtown restaurant. They still haven't been able to find the men who fired shots near Tolly Ho sending three people to the hospital. Shots rang out early in the morning of February 4th along South Limestone – sending three people to the hospital. Now, police want to know if you know who the gunmen are. Officers say four men were heading to Tolly Ho when they were approached by two men in the McDonald's parking lot. After the confrontation there, police say the four moved on. A short time later, they realized they were being followed. Police say the two men stopped the group on the sidewalk. In this location, the shorter of the two suspects produced a firearm and started shooting. Police say two of the four were hit directly; a third passerby got struck in the foot by a stray bullet. The two victims who were shot were seriously injured as a result. The gunman got away in a green Camero or Monte Carlo. Crime Stoppers is offering a \$1,000 cash reward for information leading to an arrest in this case.

September 20

Police in two counties want to find a woman who they say is shopping on credit cards she stole from someone else's home. Now detectives are offering a reward for information in the case that leads to an arrest. Police are hoping you know who this woman is. They say on June 24th she used credit cards stolen in

a burglary in Jessamine County at a department store on Tiverton Way in Lexington. Now, officers in Jessamine County and in Lexington have partnered trying to find out who she is and how she got the cards. Det. Rob Sarantonio says, "We're not sure if the person using the cars is actually the person who committed the burglary; we do believe there is a connection." He says the burglary happened a week before the cards were used and the homeowner didn't realize the card had been stolen until a big bill arrived. He says sometimes people have credit cards in places around the house they don't carry with them; that's something we always do following a burglary – stress taking an inventory. Crime Stoppers is offering a \$1000 cash reward for information leading to an arrest in this case.

September 27

Police say they started a fire to cover their crime. Two men stole from a business on National Avenue in Lexington and then torched the evidence. Now police are offering a reward to help catch the suspects. On July 29th, police say these two shadowy figures were captured on this surveillance moments after torching a car on National Avenue near Winchester Road in Lexington. Investigators say the two stole a car at an auto repair shop on National Avenue, drove it to the dead end of the street and doused it with lighter fluid. Fire Investigator John Blanton said a passerby in the area called to report a fire in the area. The car was a total loss and now police hope you can make out who these people are. They could be residents or known to residents in the National Avenue or Richmond Avenue area. Police say the victim likely has no connection to the suspects wanted in this case. Crime Stoppers is offering a \$1,000 cash reward for information leading to an arrest in this case.

July 15

The Deep Springs Pump Station is a new project being constructed on the East side of Lexington. The design will make it blend right in with the neighborhood. The Pump Station will keep the water flowing toward treatment plants and will avoid raw or partially treated sewage from backing up after heavy rainfall or snow events. The green impact is going to be that the Lexington environment, especially water quality is going to be improved by all of the sanitary sewer projects that we've got going on.

July 22

Bluegrass Pride is offering a passport program to celebrate their 10 year anniversary. The passport program is something where people can go on our website bgpride.org and look up a list of 25 options for them to do from now through October 1st and if you participate in 10 of those options then you can be eligible to win prizes. You can win a \$500 gift certificate to petal power or a \$500 local food basket. The idea is to get people to go out and see things in the community and see the partnerships that we've made and also make a difference in their own life. The Kentucky Department of Environmental Protection is hosting the 10-10-10 challenge for individuals and businesses in the commonwealth. The program is to encourage Kentucky to take steps toward living green. All you need to do is register at dca.ky.gov and begin reducing your environmental impact.

September 2

Central Kentucky leaders will be on hand today to recognize an elementary school for its efforts to go green. According to school officials, last year, students and staff at Rosa Parks Elementary School in Lexington reduced the school's energy consumption by 47% simply by changing their habits and paying more attention to the use of electricity in the building.

BUSINESS LEXINGTON

Hosted by Tom Martin, Editor of Business Lexington Magazine – on a weekly basis highlights the business community in Lexington during THIRD QUARTER of 2011

July 2

Foreclosure and mortgage delinquency rates in the Lexington-Fayette metro area rose in April – the most recent month analyzed over April of 2010. According to new data from Core-Logic, local foreclosures remain below the national rate.

Home sales were up sharply in May, according to the National Association of Realtors. The numbers are drawn from contract signings, a strong indicator of where the market is heading. Sales rose by over 8% in May to a reading of 88.8. Economists look for that reading to hit 100 before declaring a healthy scenario.

The Wild Turkey Distillery in Lawrenceburg was announced the state's first major distillery expansion in decades. The new \$50 million distillery will double production of the brand's bourbon and rye whiskies to 11 million gallons annually. The new distillery features improved anti-pollution controls, water recycling and a renewable fuel system.

July 9

Should downtown Lexington welcome more street food vendors? The Urban County Council has set up a task force to look into the question. Council member Peggy Henson is chairing. Issues include whether the city should encourage competition with permanent restaurants; safety; staying out of the way of pedestrians. A proposal on the table would set up a "mobile food and beverage vending" pilot program, designating six "vending zones" in and around downtown. Vendors would be required to rotate throughout these zones with a limit of three at each location. Much more on this in the new business Lexington "Restaurant" edition...you can check it out online at Bizlex.com

Lexington is moving up in the world...literally. Forbes "Best Places for Business and Careers" ranks Lexington #4 – up from #9 last year, and Lexington beat all six of the most recent cities the annual Commerce Lexington "Leadership Visits" have traveled to, topping #7, Austin #28, Oklahoma City – Boulder in 44th place, Greenville #60, Madison #63, and Pittsburgh #69. Forbes notes that Lexington is characterized for its surrounding horse farms that give the region its identity – but also for its rapidly developing urban center.

July 16

It may be possible to create a replacement for oil and coal shale deposits as energy resources from Algae. Research led by Professor Joe Chappell in the University of Kentucky College of Agriculture focuses on a colony forming green Alga that accumulates large amounts of high-value petrochemical replacement oils. It's the first example of recreating a true direct replacement for oil and coal. Still the challenge: capturing the genetic blueprints of the algae that could be used to generate alternative production platforms.

Data Geeks – listen up! Some great sites have come to our attention. Go to “New Geography.com to get the latest information on industrial growth or decline in any given area across the United States – including Kentucky. You’ll find that since 2001, Kentucky has seen jobs in mining and oil exploration increase 38% - management up 42%, there has been a 23% jump in jobs related to arts and entertainment, while the information industry has seen a 17% employment decline, with agriculture and forestry down 21% and manufacturing off by 26% for the decade.

Commerce Lexington developed “Locate in Lexington.com” as an aid to site location specialists and companies looking to bring their business and people into the Bluegrass region. It’s a very rich resource for anyone doing research on the area, offering data, facts and figures – a listing of local business services, education, and business connections, and a collection of information about what it’s like to live in Lexington.

July 23

Downtown Lexington has drawn another high-tech business – in this case, a new headquarters office for a firm with offices in seven other cities. Software information systems SIS has snipped the ribbon on its new address on Martin Luther King Blvd. and Barr Street – the former Triple A offices. In the process SIS is expanding to create 15 new high-tech jobs averaging \$80,000 in annual salary. SIS has been a Lexington presence for more than 25 years.

The Lexington Downtown Development Authority has launched a regional search for a new executive to succeed Harold Tate, who retired in April. The DDA oversees the ongoing physical and economic development of downtown Lexington.

Lexington based Fazolis gets a write-up in Nation’s Restaurant News as one to watch for what results from a chain-wide makeover. The company has refurbished 99 company owned and 15 franchised restaurants in the past 18 months. Its part of a brand repositioning plan that began with menu upgrades in 2009 – which alone stopped years of sales and traffic declines for the quick service Italian chain. Beginning in early 2010, Fazolis started updating unit décor and rolling out its enhanced service program with fast-casual touches like food runners and real plates. Once the remodeling phase is completed, plans call for a franchise push and locations in non-traditional venues to help reignite growth.

State law now requires a dental screening for admittance to public schools. The aim is to reduce Kentucky’s high incidence of dental health issues. But it can also pose a barrier to education for kids from households that can’t afford the screening. One local industry is stepping up to make sure all of its future generation gets and education. The children of Horse Industry employees will receive free dental screenings. It’s made possible by a partnership between the Keeneland Association, UK’s College of Dentistry and Blue Grass Farms

Charities. One of the University's Mobile Dental Units will be on hand at Keeneland on July 30th to provide screenings for kids between 4 and 10 who have a parent or guardian affiliated with the Thoroughbred Industry. Those found in need will be referred to the school's Twilight Clinic for more extensive care at significantly reduced or no cost for the children of families who cannot otherwise afford it. In the process, the clinic provides training for dental students – preparing them to work with children as they move into dental practices.

July 30

The proposed merger of St. Joseph Health System with the University of Louisville Hospital, Jewish Hospital and St. Mary's Healthcare is getting some attention. In the offices of the Kentucky Attorney General, as well as Governor Steve Beshear, the Governor cites growing concerns about how the merger will impact access to medical services. Beshear calls for a deliberate and thoughtful review of the merger. St. Joseph is part of Catholic Health Initiative and CHI would hold 70% of the merged entity. That has raised concerns over how Catholic Church doctrine would impact such matters as end of life care and women's reproductive issues. These concerns recently went public with health care executives and opponents of the proposed merger taking out dueling ads in the Louisville Courier-Journal. Meantime, Attorney General Jack Conway has told the Federal Trade Commission that the merger can't proceed without the state's approval.

Two of our area institutions of higher learning have won some valuable attention. A survey conducted by the chronicle of higher education ranks Eastern Kentucky University as one of three in the nation earning an "A" plus for career development. ECU lands on the chronicles "Honor Roll" of great colleges to work for. Also among the 111 colleges and universities ranked as "outstanding workplaces" was Somerset Community Colleges.

August 6

Good News – Bad News on economic recovery from an important resource in the commercial real estate sector – the NAI Isaac Firm is out with its midyear Lexington commercial real estate report. The good news is the numbers indicate recovery is happening. The bad news is there is still a long way to go. The report notes that the key indicator for real estate recovery is job growth – that jobs fill buildings. Going by that measure, the vacancy rates for retail and suburban office spaces have dropped over the most recent six months. There have been increasing vacancies, however in downtown and industrial spaces. At 7.6 %, Fayette County's jobless rate is among the lowest in the state. For perspective, Jackson and Magoffin Counties are at the far end of the unemployment spectrum with rates topping 16%.

On the national level, while weakness in growth in the services and manufacturing sectors in the early month of the year were tied to temporary factors such as a jump in oil prices and the impact from Japan's massive earthquake in March, signals of a pickup have so far been elusive. In fact, growth in the services sector dropped in July to its lowest level since February

2010.

August 13

Ask a random group of ten Americans how they would rate their country's direction these days and seven will tell you the United States is off on the wrong track. It's in a Reuter/IPSOS poll that finds the level of discontent in this country at its highest since Reuters/IPSOS began polling American public opinion in the winter of 2009. As you might imagine, the poll finds most pointing a finger of blame to political dysfunction in the nation's capitol.

For all we hear about unemployment, there are jobs available – good ones. American manufacturers including many in Kentucky are having trouble attracting workers with the skills needed to innovate and cultivate growth in their businesses. Some believe this 'skills gap' threatens not only the future success of the U.S. Industrial sector, but the overall competitiveness of the U.S. Economy as well. The Kentucky Association of Manufacturers is trying to get the word out to its members to complete a survey that is key to a study now underway, looking into the impact of the shortage of qualified workers who have the skills manufacturers need to compete. This is especially critical in advanced manufacturing, and advanced manufacturing has been identified by Mayors Jim Gray of Lexington and Greg Fischer of Louisville as a key to future prosperity for Kentucky. In fact, they're cooperating to join Louisville and Lexington in an economic development super region that would revolve around improving both cities competitiveness in advance manufacturing, Fischer and Gray spoke about it last week in Louisville.

August 20

General Electric has chosen Lexington as its site to develop new "next generation" energy efficient lamps. GE Lighting is investing about \$10 million at its Lexington Lamp Plant to produce the new "silver halogen" line. The expansion is expected to create 38 new jobs.

It's been a big week for grants – money you get to keep! UK landed a couple of major grants to continue Alzheimer's Research, and another for research into ways to capture CO2 Emissions. \$7 million for Alzheimer's Disease research and clinical initiatives goes to the Sanders-Brown Center on Aging – that comes from the National Institute of Health. The other, weighing in at \$14.5 million, comes from the Department of Energy to UK's Center for Applied Energy Research. The aim of that work is to make carbon-capture systems at coal-fired power plants more effective and cost-efficient.

Grants ranging from \$5,000 to \$65,000 are available from the Kentucky Workforce Investment Board. The Board is now accepting proposals for grants support the creation of industry partnerships that would encourage employers to build a talent pipeline in support of five targeted industry sectors: Automotive and Aircraft Manufacturing – Transportation, Distribution and Logistics – Business Services and Research & Development – Health Care/Social Assistance – and Energy Creation and Transmission. Important: Information gleaned from these industry partnerships will be used to adjust

education and training investments to meet the needs of growth industries in Kentucky.

August 27

More homeowners are showing a preference for paying off their loans sooner. Looking into why, Freddie Mac, the Mortgage Finance Agency, found that people are reacting to interest rates, which have stayed at near rock-bottom, and weak labor conditions. It's translating into a trend in refinancing into shorter-term loans. Of those who refinanced a 30-year fixed-rate mortgage during the second quarter, 37% went down to 15 or 20 year fixed rate loans. That's the highest rate of change seen since late 2003.

Automotive innovation is at the heart of the advanced manufacturing being targeted for growth in Kentucky as Lexington and Louisville leaders work to form a new "super region." And with some leading economists predicting another round of rising gasoline prices, Hybrids and total-electrics are looking better all the time. This is not lost on General Motors. GM sources telling Reuters that the carmaker will build an electric Cadillac, to be based on the technology used in its Chevy Volt plug-in Hybrid. They say to look for it in showrooms in a couple of years.

September 3

Business and organizations can now apply for grant money to pay for projects – infrastructure, educational – that are designed specifically to improve water quality, reduce storm water runoff or help us better understand storm water issues. The incentive is funded by Lexington's water quality management fee. It offers up to \$150,000 for approved infrastructure projects and as much as 35,000 for educational initiatives. Last year's grant winners included the installation of rainwater harvesting tanks to capture and re-use roof runoff – the use of pervious pavement that rainwater runs through and into the ground – workshops on rain gardens and storm water pollution – and the creation of an outdoor learning space for environmental education. Those and other projects added up to 1.2 million dollars in grants. You can download an application from the division of water quality website Lexingtonky.gov/incentives

Look for the Obama Administration to roll out a plan next week to revive the housing market and cut down on foreclosures. One report says the plan includes an effort to help troubled borrowers refinance their mortgages. The administration's home affordable refinance program introduced in the spring of 2009 was intended to help up to 5 million homeowners avoid foreclosure, but according to the Federal Housing Finance Agency, as of May it had assisted only about 810,000 homeowners in refinancing into loans with lower rates. The average rate on a 30 year fixed loan was 4.2% last week – close to the lowest seen in half a century.

For a second month in a row, private sector job growth slowed in August. Manufacturing activity is advancing but advancing unevenly across regions.

Want to support the arts, bring more color and imagination into your

community – your life? Lex Arts has come up with an added incentive to support its “Fund for the Arts.” Donors giving \$52 or more anytime during the year are eligible for a Lex Arts card that entitles you to a 10% discount at many area arts venues and restaurants, as well. September 10

Foreclosure rates in Lexington and Fayette County increased in June. Over the same period last year, according to research firm “Core-Logic” this new data shows the rate of foreclosures among outstanding mortgage loans was about 2 ½ percent for June – up by about a ½ percentage from a year ago. Important to note: Foreclosure activity in Lexington – Fayette is lower than the national rate which was up by well over 1%.

September 17

Indiana Governor Mitch Daniels decision to shut down the I-64 “Sherman Minton Bridge has called attention to the condition of bridges closer to home. Inspectors had discovered disturbing cracks in the steel structure of the Sherman-Minton which spans the Ohio between New Albany, Indiana and Louisville. So it’s closed for the foreseeable future – who can forget what happened in Minneapolis just a few years ago when an interstate bridge collapsed – killing 13?

Close to home: 11 bridges in Fayette County are deemed “structurally deficient” according to Transportation for America – a coalition of business, transportation and environmental groups. TOA’s James Corliss says that doesn’t necessarily mean they’re in imminent danger of failure, but he says, it does serve as an important warning sign. The bridges include the busy 47-year-old Newtown Pike span over New Circle Road. Most bridges in the U.S. were designed to have a 50-year lifespan before needing to be reconstructed or replaced.

Business is concerned about it, Fed-Ex Freight President Bill Logue, telling a U.S. Chamber of Commerce gathering that the lack of investment in infrastructure is hitting his business every day. Logue said delays caused by infrastructure failures like the Sherman-Minton Bridge mean condensed delivery windows, more facilities, extra trucks and planes, more employees – all adding up to increase Fed-Ex costs and rates. According to a study conducted for the U.S. Chamber, every one point increase in transportation effectiveness results in a \$42-billion dollar increase in the gross domestic product. The closure of the I-64 Bridge is something of a poster-child for investment in infrastructure. The Chamber called for it in 2010, and now President Obama is pressing Congress to put people back to work, in part by funding infrastructure projects.

September 24

Another example that direct connection between a University and its hometown economy: Co-Plex Therapeutics – a University of Kentucky spinoff – has signed an exclusive global license agreement with Hawthorn Pharmaceuticals to develop and commercialize HAW-A-D-14 a treatment for Alzheimer's. The treatment is said to significantly decrease the production of the major ingredient in 'senile plaques' – while also altering proteins associated with characteristics of an Alzheimer's brain. The development of HAW-A-D-14 is the outcome of work by UK researchers Bert Lynn, Mark Lovell and Co-Plex CEO John Beran.

A \$10,000 'Carrot' is being dangled to lure Lexington, companies participating in the Federal "Small Business Innovation Research" and "Small Business Technology Transfer Research Programs." The one-time subsidy is being offered to relocating companies by the Bluegrass Business Development Partnership. Seven companies taking advantage of such incentives have recently relocated to Lexington – coming from Virginia, West Virginia, Utah, Michigan, Georgia, Texas, and Pennsylvania

Could this be the start of something big? Drugstore giant Wal-Greens is installing solar systems in 90 of its stores in Ohio. The first 53 installations will be finished by mid-November and that will bring Walgreens' total number of solar stores to 136 – one of the largest solar rollouts to date for an American retailer
