1. ISSUE: Baker City Water and Sewer late fees GUEST: Baker City

On August 8, 2021 at about 4:24 PM, near the 1700 block of Valley Avenue; Baker City Police attempted to take James Reedy into custody for multiple arrest warrants. James fled on foot and ran, uninvited, into a residence at 1783 ½ Valley Avenue.

Officers learned the tenants of 1783 ½ Valley knew James but did not want him inside their house.

James barricaded himself inside a bathroom of this house and refused to come out, arming himself with a knife and threating self-harm. Baker City Police, Baker County Sheriff's Deputies and Mental Health Crisis all attempted to negotiate with James. James destroyed a police phone given to him through the door while attempting to talk to him and he refused to peacefully come out of the bathroom.

After exhausting all efforts to get James out of the house that James did not belong in, police forced open the door that James was hiding behind. With the assistance of Baker County Sheriff's Office and Oregon State Police, James taken into custody without injury to James or the responding officers.

5. ISSUE: BCPD received car seat grant GUEST: Phoebe Wachtel

DESCRIPTION: The Baker City Police Department recently received a \$1,200 grant from Oregon Department of Transportation for the purchase of child safety seats for distribution to low-income families.

According to the Oregon Department of Transportation, "Child passengers must be restrained in child safety seats until they weigh forty pounds or reach the upper weight limit for the car seat in use. Infants must ride rear-facing until they reach two years of age unless the child turned age one prior to May 26, 2017"

6. ISSUE: James Reedy sentenced GUEST: Baker County DA

DESCRIPTION: On September 16, 2021, James Reedy, 55, was sentenced by Judge Matthew Shirtcliff to the custody of the Oregon Department of Corrections for a period of 55 months. Mr. Reedy pleaded guilty to three counts of Identity Theft and one count of Failure to Appear. The financial crimes occurred when Reedy used other individual's credit cards at several different businesses in Baker City. Chief Deputy District Attorney Michael Spaulding represented the District Attorney's Office. The cases were investigated by officers from the Baker City Police Department.
