I represent Legal Missouri 2022, the campaign committee supporting Amendment 3, the adult use marijuana measure on the November ballot.

On information and belief, KWIX, KTCM, & KRES aired one or more ads opposing Amendment 3 that claim Amendment 3 places "critical race theory" into the Missouri Constitution. The ad script is attached.

Unlike candidate ads, stations can be legally liable for running false issue ads, particularly after being advised of the falsehood.

<u>Legal Missouri 2022 demands that this false advertising be immediately pulled from broadcast on these and any affiliated stations.</u>
