

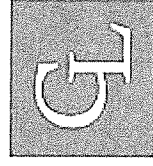

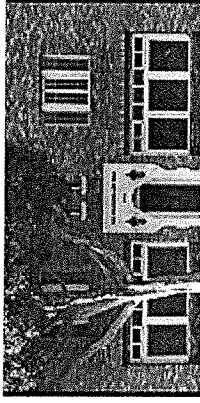

The California Supreme Court's decision in the *Dynamex* case in 2018 created a restrictive "ABC" test to determine which workers could be properly classified as independent contractors. Last year, the Legislature enacted AB5 which set forth numerous exceptions to the ABC test but left a lot of questions unanswered. AB2257 is a further attempt to clarify who may be classified as an independent contractor.
