Rocky Mountain Cable is in foreclosure

On April 1, the assets of ICE Cable Holdings, dba Rocky Mountain Cable, were foreclosed on and a foreclosure sale was held. A recording at the 800 number for Rocky Mountain Cable states "proceeds from the sale have gone to the foreclosing entity, the secured creditor.

There are no remaining assets to service the unsecured creditors and all employees have been terminated."

While the recording asks those wanting more information to leave their name and number and someone will call back, the DCI has not received a return call. The voice mail service will no longer be in operation as of April 30.

Many customers of Rocky Mountain Cable are now being serviced by USA Communications, but not the franchises in Hotchkiss and Olathe. As of April 13, no other cable company has come forward to service Hotchkiss according to Marlene Searle, town clerk. Customers in Hotchkiss and in the surrounding mesas are continuing to have cable channels for the time being.

USA Communications did not bill any of the former Rocky Mountain Cable customers in Hotchkiss and Olathe for April. Cable customers who were on an automatic payment plan with Rocky Mountain Cable should contact their bank and cancel those payments.




