

WSAW reports that John Hall is charged with leaving a firearm in an area accessible to an unsupervised minor, contributing to the delinquency of a minor, and possession of a firearm by a felon after his 8-year old son took it to the "For Kids We Care Center" Daycare in Maryland and accidentally shot a 7-year old girl wounding her in the arm.

WSAW reports that attorneys for Zacarias Moussaoui, the man charged in the 911 attacks, are asking for the death penalty to be thrown out because some key witnesses for the prosecution are in violation of the judge's court order prohibiting them from following trial proceedings.

Federal Economic Report

WSAW reports that in the Federal Reserve's latest Beige Book, retail sales in late November and December continued to rise during the year-end holiday period amid generally stable prices, spending on travel and tourism spending "was generally strong," increases in manufacturing activity "were widely reported," both wholesale and retail prices were widely reported as "rising only moderately or remaining stable," most districts reported "moderate" growth in employment and labor cost pressures, and there were reports of "strong demand for both skilled and unskilled labor in part boosted by storm recovery efforts in many hurricane damaged regions.

Date

Crime

- John Hall is charged with leaving a firearm in an area accessible to an unsupervised minor, contributing to the delinquency of a minor, and possession of a firearm by a felon after his 8-year old son took it to the "For Kids We Care Center" Daycare in Maryland and accidentally shot a 7-year old girl wounding her in the arm.
- Former Enron CEO's Ken Lay and Jeffrey Skilling are in court as the Enron fraud and conspiracy trial begin.
- Attorneys for Zacarias Moussaoui, the man charged in the 911 attacks, are asking for the death penalty to be thrown out because some key witnesses for the prosecution are in violation of the judge's court order prohibiting them from following trial proceedings.
- A federal judge eliminates the testimony from four witnesses who are considered key in making the government's case in the Zacarias Moussaoui trial after they received e-mails containing trial summaries and advice on how to shape their testimony from Carla Martin who is a lawyer for the Transportation Security Administration.
- Authorities in the United States, Canada, Britain, and Australia arrest 27 people involved in an international child pornography ring.
- The Saddam trial was put on hold due to Hussein's refusal to answer questioned asked of him.
- Zacarias Moussaoui confessed he was suppose to fly a fifth plane into the White House but he was arrested by the United States a month before the attacks took place.

Economy

- In the Federal Reserve's latest Beige Book, retail sales in late November and December continued to rise during the year-end holiday period amid generally stable prices, spending on travel and tourism spending "was generally strong," increases in manufacturing activity "were widely reported," both wholesale and retail prices were widely reported as "rising only moderately or remaining stable," most districts reported "moderate" growth in employment and labor cost pressures, and there were reports of "strong demand for both skilled and unskilled labor in part boosted by storm recovery efforts in many hurricane damaged regions.
- Ford, the nation's second largest auto maker, announces it is shutting down 14 factories and slashing 20 percent from its workforce, which is up to 30,000 jobs by 2012.
- Federal Reserve has increased the benchmark interest rate to 4.75%.

Environment

- Only two of the seven snowy owls taken in by the Raptor Education Group in Antigo this winter have survived.
- The Department of Natural Resources is looking for deer infected with chronic wasting disease that may have escaped from the Buckhorn Flats Hunting Preserve in Almond after the owner discovered a hole in a fence.
- Scientists have found the prion that causes chronic wasting disease in the skeletal muscle of deer, but there is no evidence that the disease can be transferred to humans.
- The Lac Du Flambeau Chippewa Tribe wants to take charge of water quality on its reservation and is asking the Environmental Protection Agency for power to regulate point sources of pollution.
- The Department of Natural Resources votes unanimously to keep the 2006 deer hunt rules and season options the same as in 2005.
- The United States Department of Agriculture is issuing a quarantine on products made from pine trees in hopes of controlling the spread of the destructive pine shoot beetle.
- State officials say 60 of 76 deer killed at the Buckhorn Flats Game Farm tested positive for chronic wasting disease.
- DNR has made electronic decoys for turkey hunting illegal in Wisconsin because of the danger to other hunters.
- Wisconsin deer hunters will have to kill an antlerless deer before they can shoot a buck to help reduce the deer population.

Education

- As an alternative to traditional high school, more than 500 students are enrolled in "IQ" Academies, a virtual high school run by the Waukesha School District.
- Political cartoons depicting the prophet Muhammed as a terrorist and published in the UW-Oshkosh and UW-Madison newspapers spark violence in the Muslim world.
- The Wisconsin Technical College System votes to increase tuition 8 percent for the 2006-2007 school year.

Health

- UW-Madison Hospital celebrates a milestone with their Heart and Lung Transplant Program performing its one-thousandth heart and lung transplant.
- The American Lung Association releases its "State of Tobacco Control" report giving Wisconsin an "F" grade in smoke-free air and tobacco prevention and

control spending and a "D" grade in cigarette taxes and youth access to tobacco products.

- The FDA approves an inhalable form of insulin called Exubera for people 18 years and older.
- Turkey confirms 18 cases of people contracting the H5N1 bird flu virus, and the World Health Organization has not confirmed all the cases, but says the victims apparently caught the virus from infected chickens with no indication of human-to-human transmission.
- Canadian officials say they have found "Mad Cow" disease in a six-year old cross-bred cow in Alberta, and the Canadian Food Inspection Agency says the animal has been euthanized.
- A Federal Immunization Committee is recommending infants should get a three-dose vaccine called Rotateq for rotavirus by the time they are six months of age.
- A drug prescription program that allows Wisconsin residents to use a state web site to order their drugs from three approved Canadian pharmacies is extended for two more years.
- The Lincoln County Health Department says there have been 12 reported cases of blastomycosis this year including a 16-year old who died last month.
- Health officials are holding a meeting in Merrill to discuss the 18 confirmed cases of blastomycosis.

Local

- Seven counties including Marathon, Portage, and Wood are among seven counties taking part in a new program known as the "Farm Fresh Atlas."
- Wausau School Board President Jeffrey Lamont says he will not seek a third term.

- Governor Doyle holds a state of the state town meeting at the TB Scott Library in Merrill.
- A&B Process Systems in Stratford, which makes ethanol equipment, is expanding and adding 60 new jobs.
- The Department of Revenue's "Website of Shame" lists Waupaca County Sheriff Steve Liebe and his business Liebe Auction Service as owing more than \$145,000 dollars in back taxes.
- The Village of Kronnenwetter officials nix their ambulance service contract with the City of Mosinee and have now turned to the City of Schofield for their service.
- Marine Lance Corporal Stephen Holt from Marshfield is headed to Iraq as a combat correspondent for a television station at Camp Pendelton in California.
- Aspirus Wausau Hospital's 51-room wing addition with state-of-the-art technology is the first step in their renovation.

- Zachariah Barrett of Wausau turns himself into the Everest Metro Police and charged with food tampering after police say he put mercury into a pepper shaker at the Wendy's Restaurant in Weston.
- Rob Collins of Vesper is sentenced to ten years in prison after pleading guilty last November to five counts of recklessly endangering safety and fleeing an officer.
- Richard and Jimmy Klenz of Green County are sentenced each to one in jail with work release privileges and ordered to pay \$1,000 dollars a month to the co-op members along with paying fines and community service for selling watered down milk in 2004.
- Wausau West High School teacher, Jeff Murray, faces disciplinary action after being accused of making sexually harassing comments to two female students regarding their clothing.
- The Wausau City Council approves the re-zoning of the Wright House so it can house both a restaurant and residence.
- Cory Borgwardt who escaped from Lincoln Hills School last summer surrenders to authorities and is now in the Lincoln County Jail.
- Liquor Store owners in Stevens Point are now required by law to keep track of who is buying kegs.
- The Clark County Board votes down a comprehensive land and zoning project that includes a \$200,000 dollar Department of Administration state grant pending a final referendum vote in April 2006.
- Rebecca Ramm, the Wausau woman who murdered her husband, David Ramm, and hid his body in their home for months, strikes a plea deal and will not be going to trial.
- Village of Kronenwetter Administrator Henry Luxem says the new Municipal Center will cost \$3.5 million dollars, which is a boost of \$40 dollars on a \$100,000 dollar home spread over 20 years.
- Keith Chaffey, who escaped from Lincoln Hills in 2005 and later surrendered to authorities, is sentenced to six years in prison and three years extended supervision.

- A seventh teenager is now charged in the mob beating of 50-year old Samuel McClain last month in Milwaukee.
- Walmart agrees to pay \$25,000 dollars to settle aggregations by State Consumer Protection Specialists who say they overcharged customers for bulk items at five Wisconsin stores.
- A bi-partisan senate committee is holding hearings around the state to hear testimony on encounters with the Department of Natural Resources.
- Senator Russ Feingold's campaign is returning contributions associated with lobbyist Jack Abramoff who pleaded guilty to corruption and tax evasion.

- Both legislative houses convened in a special session, but quickly adjourned without taking action on Governor Doyle's Energy Assistance proposal.
- Steven Avery agrees to a \$400,000 dollar settlement in the \$36 million dollar federal lawsuit against Manitowoc County for the wrongful conviction of rape where he spent 18 years in prison, and now wants to use the money for bail where he is being held in the Calumet County jail on homicide charges in the death of Teresa Halbach.
- Former Illinois police officer, Newton Tench, now working at a Kenosha school for the past two years as a computer tech, is facing felony charges accused of downloading a million images of child pornography onto his computer.
- Governor Doyle signs a bill into law making it illegal to protest at funerals in Wisconsin.
- President Bush stops in Milwaukee to promote his energy program including promoting technologies designed to reduce America's dependence on imported oil.
- Members of the Army Reserve 890th Transportation Company out of Ashwaubenon return from serving in Iraq.
- An Arizona man, Denys Hughes, was arrested in July 2005 in Kansas for possessing bomb making materials while in Vilas County investigators seized 42 biological and chemical samples and dozens of guns from his cabin in Manitowish Waters which now leads to a grand jury indictment for possession of those items and for attempting to make a deadly biological toxin for use as a weapon.

- Steven Avery's lawyers are trying to get statements made by his nephew, Dassey dismissed because the documents were released to the public.
- The Dept. of Justice along with the Coalition of Wisconsin Aging Groups to aid against scams and coverage problems with the Federal government's new prescription plan.
- State Representative Scott Jensen will resign next week after being convicted of felony misconduct for using state employees as secret campaign operatives.
- 21-year-old Lance Corporal Nicholas Anderson of Sauk Ciry was killed in Afghanistan while on patrol.
- Libertarian Roy Leyendecker has filed papers to run for Governor this fall.
- Wisconsin has passed a new law which requires citizens statewide to register to vote.

- Governor Jim Doyle is launching a new power initiative and grant which will help Wisconsin businesses and residents to take advantage of renewable energy technologies.

- California's governor declares seven counties are in an official state of emergency after flooding causes an estimated \$100 million dollars in damage in addition to three deaths.
- Searchers find one of thirteen missing miners dead after an explosion at a West Virginia mine.
- Officials in Texas say a fire covering 40,000 acres is now contained and the second covering 90,000 acres is about 70 percent contained.
- Washington D.C. lobbyist, Jack Abramoff, pleads guilty to federal charges of conspiracy, tax evasion, and mail fraud as part of a plea deal to agree to cooperate in a corruption probe of lawmakers at the nation's capital.
- President Bush signs a bill extending the Violence Against Women Act.
- Randy McCloy is the sole survivor of the mine explosion in West Virginia that killed 12 of his co-workers.
- Pilgrim Baptist Church, a landmark built in 1890 in Chicago, is destroyed by fire.

- Vice President Dick Cheney is hospitalized for nearly four hours after suffering from shortness of breath.
- President Bush meets with German Chancellor Angela Merkel at the White House to try to put an end to Iran's nuclear ambitions.
- The United States military confirms the deaths of two Army pilots whose helicopter went down in Iraq.
- President Bush urges the renewal of the expiring portions of the 1965 Voting Rights Act at a ceremony at the Kennedy Center honoring the late Dr. Martin Luther King.
- The United States Supreme Court rules in a 6-to-3 vote to uphold Oregon's doctor assisted suicide law.
- New Orleans's Mayor Ray Nagin apologizes after he said New Orleans will be a "chocolate city" again during a speech at a Martin Luther King holiday event.
- Nearly five months after Hurricane Katrina, more than 3,200 people are still officially unaccounted for by the National Call Center.
- The CIA believes the voice on a newly released audio tape aired on an Arabic language network is that of Osama Bin Laden saying that attacks like those in London and Madrid are planned for America.
- Abductors of American journalist, Jill Carroll, who was kidnapped in Baghdad January 7, 2006, say they will kill her unless the United States meets their demand of releasing all female Iraqi prisoners.
- The Senate Judiciary Committee approves the nomination of Samuel Alito to the United States Supreme Court in a 10-to-8 vote.
- President Bush speaks about terrorism and the situation in Iraq on a visit to Kansas State University.
- Iraqi officials say joint United States and Iraqi operations were carried out to free kidnapped American journalist, Jill Carroll, but provided no details.
- Officials from the Federal Mine Safety and Health Administration and Sago Mine Operators among others are questioned at a United States Senate Hearing on Mining Safety following two deadly mining accidents in West Virginia.
- A report commissioned by the United States Pentagon argues the Army is overstretched and undersized and a second report released by democrats on Capitol Hill note every available army combat brigade has served in Iraq or Afghanistan for at least a one-year tour and many are on their second or third deployments.
- The United States Justice Department files a lawsuit in a U.S. District Court in California demanding the world's biggest search engine, Google, turn over data it says will help the government ultimately keep children from accessing web pornography.
- In a press conference, President Bush gives a warning to the newly elected majority of the Palestinian Parliament, Hamas, insisting the prospect of Mideast peace is not dead if the group renounces violence.
- Federal Transportation Security Administration officers find a real but inactive grenade in a Northwest Airlines flight attendant's luggage at Mitchell International Airport in Milwaukee, Wisconsin.

- Al Qaeda's number two leader, Ayman Al Zawahiri appears on a videotape airing on an Arabic language network
- Anchorman Bob Woodruff and his cameraman, Doug Vogt, lie in a United States Army hospital in Germany after being hit by a roadside bomb in Iraq.
- Coretta Scott-King, the widow of civil rights leader, Reverend Martin Luther King Jr., dies at the age of 78.
- Judge Samuel Alito is sworn in as the 110th United States Supreme Court Justice.
- President Bush delivers his "State of the Union" Address in Washington, D.C.
- West Virginia Governor Joe Manchin calls for an immediate shut down of the state's coal mines until safety checks are conducted after two more miners are killed in two more on the job accidents.
- Authorities are investigating the arson fires of five churches about 25 miles south of Birmingham, Alabama.
- The budget plan President Bush sends to congress boosts military and homeland security spending while also trying to rein in the budget deficit.
- At a hearing in Washington, D.C., senators from both political parties are raising doubts about the Bush administration's legal basis for a domestic eavesdropping program.
- President Bush along with former Presidents Clinton, Carter, Bush Sr., and 14 United States senators attend the funeral for Coretta Scott King in Atlanta, Georgia.
- President Bush gives details of a 2002 plan of a terrorist plot to slam a hijacked plane into the US Bank Tower in Los Angeles just weeks after the World Trade Center attack, and the White House releases a fact sheet listing nine additional Al Qaida plots that have been disrupted in the last four years.
- Former FEMA Director Michael Brown testifies at a senate hearing regarding the response to Hurricane Katrina.
- White House spokesman Scott McClellan explains the information delay regarding Vice President Dick Cheney's hunting accident.
- Homeland Security Chief Michael Chertoff testifies at a senate hearing regarding the response to Hurricane Katrina.
- Doctors for Harry Whittington, the man accidentally shot by his hunting partner Vice President Dick Cheney, say he is back in intensive care after suffering a minor heart attack caused by some of the birdshot moving and lodging into a part of his heart causing the atrial fibrillation.
- New details from a congressional report regarding Hurricane Katrina say nobody at the federal, state, or local levels did enough to protect the people of the Gulf Coast despite warnings an unusually powerful hurricane was on its way.
- Homeland Security Secretary Michael Chertoff testifies before a congressional committee.
- Vice President Dick Cheney speaks publicly for the first time since the accidental shooting of his hunting partner, Harry Whittington.
- Harry Whittington, the man Vice President Dick Cheney accidentally shot while they were hunting, is released from a Corpus Christi, Texas, hospital.

- Vice President Dick Cheney makes his first public appearance since the accidental shooting of his hunting partner, Harry Whittington, addressing a joint session of the legislature in Wyoming.
- Rescuers are digging through debris trying to reach 65 miners trapped underground by a gas explosion at a coal mine in northern Mexico.
- The White House getting resistance from both democrats and republicans including the republican chairman of the House Homeland Security Panel over a deal that would allow a Middle East based company to manage several large United States ports.
- Federal lawmakers from both parties are threatening a bill to block the running of six American ports to the United Arab Emirates.
- The sale of six American ports will be delayed because of growing concern over the security if the United Arab Emirates takes over.
- The Centers for Medicare and Medicaid are proposing a limitation on the number of prescription plans that a company can offer to lessen confusion among citizens.
- South Dakota is just one signature away from banning abortions after the state's legislature gave its final approval for the bill. The Governor has indicated he will sign the bill.
- Citizens across the county are protesting and rallying against the sale of six American ports to the United Arab Emirates.
- US Senate, has ended Russ Feingold's filibuster against the renewal of the patriot act. Feingold says today's actions assure the final passage of the reauthorization bill.
- There are new questions concerning hurricane Katrina and what the White House knew ahead of time after the release of some videotapes showing Bush and his Homeland Security Chief being briefed before the storm hit.
- The Patriot Act is another stop closer to be renewed after the senate voted to extend the anti-terror law.
- Northwest Airlines has a tentative pay-cut deal with its pilots which is a major step in ending another problem that threatened the future of the bankrupt airline.
- President Bush in continuing his trip to South Asia and has now arrived in Pakistan to talk about US relations.
- Governor Mike Rounds signed a bill banning nearly all abortions, except when it would save the mother's life. The bill is scheduled to go into effect on July first of this year.
- 17 jurors will decide whether Zacarias Moussaoui will spend life in prison or be executed for conspiring with Al Qaeda; they will hear from over 200 witnesses including Moussaoui.
- The House of Representatives has approved the renewal of the Patriot Act and says President Bush looks forward to signing the bill into law.
- The deal to sell six American ports fell apart after huge controversy in Washington when both parties opposed the deal to United Arab Emirates.
- President Bush and Ireland's leaders are vowing to keep the Emerald Island peaceful after decades of Protestant-Catholic strife.

- The Senate Judiciary Committee approves a bill that would strengthen the Border Patrol and let millions of undocumented workers seek United States citizenship without first having to leave the country.
- President Bush's White House Chief of Staff Andrew Card announces his resignation.
- American hostage, Jill Carroll is free after being held in Iraq for three months.

World

- Israel's Prime Minister Ariel Sharon undergoes emergency surgery at a Jerusalem hospital after suffering a significant stroke with massive bleeding.
- Police say 63 people die after an attacker strikes at a shrine 50 miles south of Baghdad, and in central Iraq a suicide bomber attacks a line of about 1,000 police recruits with 56 people dying and another 60 injured.
- Doctors say Israel's Prime Minister Ariel Sharon is breathing on his own and slightly moving his right arm and leg after suffering a massive stroke.
- After Israel's Prime Minister Ariel Sharon suffered a massive stroke, temporary governmental control is in the hands of his deputy, Ehud Olmert.
- Osama Bin Laden's number two man in the Al Qaeda terrorist network, Al Zawahiri, is targeted in a CIA strike on a remote village in Pakistan near the Afghan border and may have been killed according to United States sources.
- With insurgents in Iraq planting roadside bombs that are bigger and harder to detect, United States troops are not waiting for the government and are making their own modifications to their vehicles for better protection.
- Two American pilots are dead after a helicopter crash in Iraq where two extremist groups are claiming responsibility.
- Pakistan officials say a United States air strike kills three senior Al Qaeda operators including a chemical and biological specialist, chief of operations for Afghanistan and Pakistan, and chief of operations for Afghanistan's Konar Province.
- Kidnapped American journalist, Jill Carroll's captors release a video tape of her and threaten to kill her in two days if the United States military does not release all female Iraqi prisoners.
- Almost 140 survivors are brought to shore at an Egyptian Red Sea port after an Egyptian ferry carrying 1,400 people sinks in the Red Sea.
- Another video tape surfaces of kidnapped American journalist, Jill Carroll, asking for United States cooperation along with a letter written by Carroll.
- The United Nations wants the United States to close Guantanamo Bay releasing a report that calls it a torture camp.
- Nine people are killed and many wounded in protests that include setting fire to the Italian Consulate.
- The death toll could reach as high as 2,000 from a mudslide in the Philippines.
- A bomb destroys the Golden Dome on one of Shiite Islam's holiest shrines in Baghdad

- Acting Prime Minister Ehud Olmert is declaring victory for his Kadima Centrist party in Israel's elections.
- An earthquake in Iran registers a 5.1 on the Richter Scale and the death toll is now at 70.
