Accordingly, Stations hereby notify Operator that, pursuant to Section 325(b)(3)(B) of the Communications Act of 1934, as amended (the “Act”), and Section 76.64(f)(2) of the Rules and Regulations of the Federal Communications Commission (the “Rules”), Stations elect to assert their rights under Section 325(b)(1)(A) of the Act and Section 76.64(a) of the Rules to require that Operator obtain Stations’ express consent before retransmitting its signals. This election of retransmission consent is for the period January 1, 2015 through December 31, 2017.

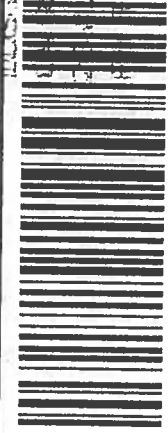
