Issue: Mail Scam

We ran the following program to address it: Morning Show/Kansas News Date: April 4, 2023 Time of Day: 7:30 am Duration: 2-3 minutes Brief description of program (format, participants, contents, etc.):

The KPRD Morning Show hosts reported on a mail scam that was circulating in multiple Kansas counties. These were letters claiming to be from an attorney with law firms located in Canada and said there were millions of dollars in an unclaimed life insurance policy available. The sender asked the recipient of the letter to partner with them to claim these monies. Insurance Commissioner Vicki Schmidt and Treasurer Steven Johnson advised Kansans that these letters were a scam and to not contact the sender.

Issue: A Desperate Need for Local Childcare

We ran the following program to address it: Morning Show/Kansas News Date: April 19, 2023 Time of Day: 7:30 am Duration: 2-3 minutes Brief description of program (format, participants, contents, etc.):

KPRD informed the listening audience of a new childcare facility that would soon be up and running in a local community. At last report, Ellis County, Kansas still needed 542 new childcare slots to meet demand.

Issue: The Need for a Change in Probate Law

We ran the following program to address it: Morning Show/Kansas News Date: April 20, 2023 Time of Day: 7:30 am Duration: 2-3 minutes Brief description of program (format, participants, contents, etc.):

KPRD shared the announcement that "Karen's Law" (HB 2027) was signed by the Governor of Kansas. This legislation created a procedure to prevent the distribution of a person's assets to someone charged with killing that person. Prior to passage of this law, a person charged with killing someone could collect from their estate until found guilty of the crime.

Issue: Low-Income Kansas Seniors Receive Help in Purchasing Fresh Fruit & Vegetables We ran the following program to address it: Morning Show/Kansas News **Date:** May 11, 2023 **Time of Day:** 7:30 am **Duration:** 2-3 minutes Brief description of program (format, participants, contents, etc.): KPRD informed listeners of the Kansas Senior Farmers Market Nutrition Program that was providing low-income seniors with coupons to purchase fresh fruits, vegetables, herbs and honey from authorized farmers at local farmer's markets. **Issue:** Child Nutrition We ran the following program to address it: Morning Show/Kansas News **Date:** June 1, 2023 **Time of Day:** 7:30am **Duration:** 3-5 minutes Brief description of program (format, participants, contents, etc.): KPRD on-air staff shared information about the free lunches and breakfasts that were available free of charge over the summer months. The local school district was providing the summer meals free. KPRD shared the locations of distribution and the dates and times the free meals were available for their children or grandchildren.
