Dear Administrator or Biomedical Engineer,

WFGX has retained RF Notifications, a broadcast TV consultant, to notify you that on January 17, 2020, WFGX commenced broadcasting using its newly assigned UHF channel 14.

Certain biomedical telemetry devices have been allowed to use unoccupied TV channels in their area on a **secondary basis**, according to the rules of the Federal Communications Commission (codified at 47 CFR 15.242 (a)(1)). If interference to or from these devices arises with regard to the TV broadcast service, the devices must cease operation on that channel. It is the responsibility of the medical facility or operator of the device to identify and retune its equipment to an alternative non-interfering channel.

The contact information for the broadcast executive in charge of the TV station, along with the commencement date, TV channel and frequency band for each station are listed on the attached page(s). Please contact the individual listed on the attached page who is associated with the specific channel, if you wish for more information or want to report interference problems.
