Re: Election of Retransmission Consent Status for KTNL

Ladies and Gentlemen:

Denali Media Juneau, Corp. ("Licensee"), licensee of television station KTNL, Sitka, AK (the "Station"), located in the Juneau, AK DMA, hereby gives notice to GCI Cable, Inc. that, pursuant to Section 325(b)(3)(B) of the Communications Act and Section 76.64(f)(2) of the FCC's Rules, Licensee elects retransmission consent status for the Station. Accordingly, pursuant to Section 325(b)(1)(A) of the Communications Act and Section 76.64(a) of the FCC's rules, the Station's broadcast signal may not be carried on your cable systems or other distribution systems that you own, operate, or manage without Licensee's express written consent pursuant to a retransmission consent agreement. This election of retransmission consent is for the period January 1, 2018 through December 31, 2020.
