KTOM-FM provides its listeners with programming and public service announcements that address issues of concern to our local community. Among the issues determined to be of most concern to the community during the preceding calendar guarter were:

- Affordable Care Act: an interview w/Dr. Gary Gray, chief medical officer, Natividad Medical Center who discussed how the Affordable Care Act (ACA) is impacting public hospitals like Natividad. He talked about the establishment of the new trauma center designation at the hospital and how that will improve health care for Monterey County residents
- CITY FINANCES AND TAX: Discussed City Finances and how monies from new sales tax (\$20 million dollars annually) will be spent by city council. Improvements to police department, libraries, and debt services highlighted.
- Counseling: Marta Martinez of Monterey County Rape Crisis Center on advocacy training program for rape counseling
- Earthquake Preparedness: CA EARTHQUAKE AUTHORITY discussed the EBB (Earthquake Brace & Bolt Program)
- Food Bank Assistance: Melissa Kendrick with the Monterey Co Food Bank discussed the fire/arson that destroyed food banks delivary fleet & how the community can help rebuild it
