- 1. The undersigned agree to become a corporation by the name of Seven Ranges Radio Company, Inc.
- The address of the principal office of said corporation will be located at Greens Rum Road, St. Marys, Pleasants County, West Virginia 26170.
 - 3. The purposes for which this corporation is formed are as follows:

To engage in the general business of radio broadcasting, including, but not limited to, AM, FM and FM multiplex transmissions.

To engage in the leasing, buying, owning, selling, holding, equipping, maintaining and operating of broadcasting and receiving stations and any connections between such stations; and to transmit, send and broadcast over the radio, news, talks, speeches, lectures, musical concerts, recorded music, plays, theatricals, recitals, programs, revues, readings, reports, signals, and all matter and things of any kind, nature and description whatsoever that may be transmitted by radio; and the doing of any and every act or thing, proper, necessary and incidental to the general purpose of this company.

To buy, acquire, own, lease, sell, retain, deal in, or otherwise dispose of absolutely or contingently, real or personal properties and interests therein (whether like or different), pursuant to the purposes of the corporation and to do all other acts and things required to be done in connection therewith, either within or without the State of West Virginia.
