UTICA PARENTS CAN EXPECT MORE THAN THE USUAL CHAOS IN THIS MORNING'S SCHOOL BUS RUN. THAT'S ACCORDING TO FORMER DRIVERS AT DURHAM SCHOOL SERVICES. THEY SAY THEY WERE FIRED ON FRIDAY, LEAVING THE COMPANY SHORT STAFFED BY AT LEAST A DOZEN DRIVERS FOR TODAY'S RETURN TO SCHOOL. DURHAM SAYS THEY WERE LET GO FOR MAKING UNREASONABLE DEMANDS. THE DRIVERS CLAIM THE COMPANY REFUSED TO PAY OUT HALF OF A 3-THOUSAND DOLLAR SIGN-ON BONUS DUE ON OCTOBER FIFTEENTH.

UTICA SCHOOLS COULD BE IN LINE FOR TENS OF MILLIONS OF DOLLARS IN ADDITIONAL FUNDING. GOVERNOR HOCHUL HAS REPORTEDLY SETTLED THE LONG RUNNING CAMPAIGN FOR FISCAL EQUITY SCHOOL FUNDING CASE.
