

PUBLIC NOTICE

On September 26, 2005, KEYY was granted a license by the Federal Communications Commission to serve the public interest as a public trustee until October 1, 2013. Our license will expire on October 1, 2013. On October 3, 2011, KEYV was granted a license by the Federal Communications Commission to serve the public interest as a public trustee until October 1, 2013. Our license will expire on October 1, 2013. On January 25, 2011, KEYR was granted a license by the Federal Communications Commission to serve the public interest as a public trustee until October 1, 2013. On January 25, 2011, KEYP was granted a license by the Federal Communications Commission to serve the public interest as a public trustee until October 1, 2013. We have filed applications for license renewal with the FCC. A copy of these applications are available for public inspection during our regular business hours. It contains information concerning these stations' performance during the last eight years or lesser license period. Individuals who wish to advise the FCC of facts relating to our renewal applications and to whether these stations have operated in the public interest should file comments and petitions with the Commission by September 1, 2013. The announcements (there are a minimum of six of them) should be broadcast

June 1st and 16th , July 1st and 16th , and August 1st and 16th as follows:

- o The others can be broadcast whenever you choose.

Once the announcements have been broadcast, fill out an affidavit that recites the dates and times the pre-filing announcements were broadcast over the air. The affidavit should look like this:
