Section I. Issues

The station has identified the following issues as significant issues facing our community this quarter:

A. Housing:

"Me+3 ASCSU"- Broadcast on 3/10 reported on ASCSU's attempts at creating a petition to revoke the U+2 law

"Me+3 Response by the City of Fort Collins"- 3/17 reported on the follow up to the city of Fort Collins and whether or not they actually started reinforcing U+2 actively in Avery Park.

B. Government:

"Iowa Caucus Update"- 2/3 Reported on the Iowa caucus results with analysis from a CSU political science professor along with a roundtable discussion of what this could mean for the rest of the primary/caucus process.

"Primary update"- 2/10 An update of the campaign process so far as well as discussion and education about what a superdelegate is in preparation for Super Tuesday.

"Super Tuesday" - 2/17 An update and analysis of Super Tuesday and the debates from the past week. The team speculates on what this could mean for the rest of the campaigns.

C. Campus Instruction and Improvements:

"Construction Update" -2/3 as school starts for the spring semester we report on what construction will be happening around campus and how much it costs.

D. Education:
