Discussion of issue: Red flags to be on the look out for someone contemplating suicide: Talking about feeling hopeless or having no purpose, death of a loved one or pet, divorce or break-up of a relationship, diagnosis of a major illness, loss of a job, or serious financial problems, talking about feeling trapped or being in unbearable pain, increasing the use of alcohol or drugs, withdrawing or feeling isolated, talking about wanting to die or to kill oneself, loss of interest or pleasure in activities the person previously enjoyed, giving away personal possessions, making a will, and cleaning up his or her room or home.
