By accepting this agreement, the advertiser understands that WMBS (Fayette Broadcasting Corp.), will bill advertiser on a monthly/broadcast basis and that payment for advertising is due within ten days of receipt of bill. Advertising may be terminated if payment is not received within thirty days of receipt of bill. In such case, advertising rate is determined by advertisements actually broadcast. There is a finance charge of 1-1/2% per month on any outstanding balance over thirty days past due. This periodic rate on outstanding balances corresponds to an annual rate of 18%.

In addition to other remedies, advertiser authorizes the Prothonotary, Clerk or any attorney of any court to appear for advertiser and confess judgement in favor of WMBS (Fayette Broadcasting Corp.) or in favor of any holder of this contract. Judgement by confession may be entered either prior to or after an event of default, as often as necessary, for such sums as are or may become due under this contract with cost of suit and \$750 added as reasonable attorney's fees. Advertiser agrees to waive, to the extent permitted by law, all rights of appeal, appraisal, stay of execution, now or later in force. Judgement may be confessed as often as necessary, and a photocopy of this agreement shall be sufficient warrant. The advertiser assumes responsibility for compliance of broadcast material with all federal, state and local advertising rules and regulations. All commercials become the property of the radio station.

The parties to this advertising agreement affirm that nothing in this agreement, or any of the actions, benefits and obligations relating to it, discriminate in any way on the basis of race or ethnicity. Fayette Broadcasting Corporation does not discriminate in the sale of advertising time, and will not accept advertising which is placed with the intent to discriminate on the basis of race or ethnicity. Any provision in any order or agreement for advertising that purports to discriminate, or has the effect of discriminating, on the basis of race or ethnicity, is hereby declared null and void.
