Retransmission Consent Election

Dear Mr. Boullion:

Pursuant to the Communications Act and the FCC rules, this is to notify you that Station WJRT-TV, Flint, Michigan (the "Station"), assigned to the Flint –Saginaw-Bay City DMA, hereby elects retransmission consent with respect to carriage of the Station's signal, including any multicast channels on all systems, headends, and franchises owned by, controlled by, or affiliated with the above-referenced entity. This election of retransmission consent is for the period from January 1, 2012 through December 31, 2014. The election includes, but is not limited to, all systems, headends, and franchise areas referenced on Exhibit A. Please notify us immediately if you have any additional systems that carry the Station which are not included on Exhibit A, or if you have divested any systems included on Exhibit A.

This election will not affect the continued carriage of the Station's signal by your system as to any part of the relevant period for which an existing retransmission agreement is in effect, which such agreement shall govern the carriage of the Station's signal by your system. If there is no existing agreement in place, or the existing agreement is scheduled to expire prior to December 31, 2014, then it will be necessary for your system to obtain our express approval in order to retransmit the Station's signal after 12:01 AM on January 1, 2012 or after the expiration date of the existing agreement, as applicable. For the avoidance of any doubt, any existing retransmission agreement currently in effect shall not extend beyond the current term of such agreement, and, with this letter, the Station hereby provides notice of termination to the extent necessary to reject exercise of any renewal provision.

Please also be advised that the Station recently underwent a change in ownership on April 1, 2011. In anticipation of the change of ownership, ABC, Inc. assigned its interest in any existing retransmission agreement with respect to the Station to WJRT, Inc.
