- 1 The permittee/licensee in coordination with other users of the site must reduce power or cease operation as necessary to protect persons having access to the site, tower or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.
  
- 2 Ground system consists of 120 equally, spaced, buried, copper wire radials about the base of daytime tower 54.6 meters in length except where they intersect radials from the old nighttime elements, at which point they are shortened and bonded to transverse strap. In addition, a 9.8 meters by 9.8 meters square copper ground screen is installed about the base of the tower.
