The Pennsylvania Senate Environmental Resources and Energy Committee today approved legislation to establish an Independent Energy Office (IEO) within the Commonwealth, according to Chairman Gene Yaw (R-23), sponsor of the measure.

Over half of Pennsylvania households use natural gas as their primary home heating fuel, and the state's 48 underground gas storage sites-the most for any state-help meet regional heating demand in winter.

Those in Pennsylvania who heat with natural gas provided by UGI will be seeing their utility bills go down this winter. UGI has announced its purchased gas cost rates will decrease on December 1, and as a result the average residential heating customer receiving gas supply from UGI will see a bill decrease of 20.2%, lowering the average monthly bill from \$116.76 per month to \$93.17 per month. UGI Utilities serves more than 740,000 natural gas and electric customers in 45 counties in Pennsylvania.

A year after pleading no contest to criminal charges, one of Pennsylvania's leading natural gas companies is poised to drill and frack in the rural community where it was banned for a dozen years for polluting the water supply.

Coterra Energy Inc. has won permission from state environmental regulators to drill 11 gas wells underneath Dimock Township - the sweet spot of the largest natural gas field in the United States, according to well permit records reviewed by The Associated Press. Billions of dollars worth of natural gas, now locked in shale rock deep underground, await Coterra's drilling rigs.

Some landowners, long shut out of royalties because of the state's lengthy moratorium, can't wait for the Houston-based drilling giant to resume production in Dimock. Other residents dread the industry's return.

Pennsylvania's Department of State is working to reduce voter errors and confusion by instituting more uniformity across Pennsylvania's 67 counties with a redesigned mail ballot for the 2024 primary election. The redesigned envelopes and instruction sheets have revised language to better inform voters how to properly fill out and return their mail-in ballots, with the goal of decreasing voter confusion that can lead to completed ballots being rejected and assisting county election workers in efficiently processing mail-in ballots.

New York's highest court on Tuesday ordered the state to draw new congressional districts ahead of the 2024 elections, giving Democrats a potential advantage in what is expected to be a battleground for control of the U.S. House.

The 4-3 decision from the New York Court of Appeals could have major ramifications as Democrats angle for more favorable district lines in the state next year. Republicans, who won control of the House after flipping seats in New York, sought to keep the map in place. The state's bipartisan Independent Redistricting Commission will now be tasked with coming up with new districts, which will then go before the Democrat-controlled Legislature for approval. The court ordered the commission to file a map no later than Feb. 28, 2024.
