SHE ALSO PROVIDED AN OVERVIEW OF THE VARIOUS PROGRAMS THE TRANSITIONAL HOUSING ORGANIZATION IS INVOLVED WITH.
- 7-19 ROGER FRITSCHENMEYER FROM PRAIRIE INDEPENDENT LIVING RESOURCE CENTER DISCUSSED THE 25TH ANNIVERSARY OF THE PASSAGE OF THE AMERICANS WITH DISABILITIES ACT AND AN ANNUAL CELEBRATION AND RALLY PILR HOLDS TO INCREASE AWARENESS OF THE ADA AND ISSUES INVOLVING THOSE WITH DISABILITIES.
