The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.

Unknown DC Serial Bank Robbers, Suspects #1, #2 and #3 (Bank Robbery) -- George County Police and the FBI are looking for a gang of serial bank robbers who have struck at least six times in the Washington DC Metropolitan area since January 2004. Agents say that the method of operation is very similar in all robberies. Somewhere between three and six robbers enter the bank dressed in coats, pants, ski masks, and gloves. They enter the banks armed with what appear to be assault-style rifles and in three of the robberies they fired their weapons. In one robbery, they fired shots at a police officer who arrived at the scene. The heists are executed with an almost military-like precision and usually last no more than five minutes. The gunmen shout demands to the employees and patrons, take money from the tellers' drawers, and usually flee in a stolen van. In four of the robberies, police have recovered the getaway vehicle abandoned and set ablaze. Witnesses have reported seeing black suspects, but some of the surveillance stills show suspects that appear to be white, Hispanic or light-skinned black men. George County Police and FBI agents are considering the men extremely dangerous. Suspect #1 served as a lookout and did not enter the bank. The age, height, sex, and race of the suspects are undetermined.

Joel Vidal (as) Urena (Murder, Assault with a Firearm, Robbery, False Imprisonment) -- On October 5, 1996, Steve Kerston was awakened at 5 a.m. by flashlights in his eyes. Four masked men had broken into his family's Cotati, California home. Police say it was Joel Urena and three accomplices. Steve says the men attacked him and then went into his parents' bedroom. The men demanded money, jewels and guns from Mark and Mary Kerston. When the couple insisted that they had none, one of the men went out to the living room and shot Steve in the leg. When the couple still insisted they had no valuables, the men threatened to shoot Steve in the head. Mercifully, they didn't follow through on the threat. Instead, they grabbed whatever

they could get their hands on and took off. Urena has scars on his face from a car accident and another scar on his right hand. Although of Hawaiian heritage, he may appear Hispanic. He may be wearing a moustache. Urena may be driving a 80's-90's silver or blue metallic Chevrolet Blazer or an 80's black Chevrolet Astro van. He is 33, 6'0" and 260 pounds. Richard Steve Goldberg (Child Molestation) --- Goldberg molested six young girls under the age of ten. He reportedly gained the trust of the neighborhood parents, then became a babysitter and "friend" to kids in the area. The single man set his home up in a way that would attract children. His backyard had swings and a cage with rabbits and ducks. Inside the house, Goldberg had children's computer games that he would allow them to use, kid's music, art supplies, and even children's soap. He would also take them to Disneyland, parks, lakes, etc. Goldberg was found out after two young girls playing on his computer saw an image of two of their young friends naked, including the next door neighbor. A full investigation was launched and six neighborhood kids reported being assaulted by Goldberg. Child pornography was found on his computer, including a photo of him having sex with children. After cops came in to search his house and took his computer away, Goldberg fled the area in late June. In early July, after finding evidence on the computer, police issued an arrest warrant for him. Authorities know he visited his parents in Rumson, New Jersey, shortly after running. There is evidence he was also in Las Vegas, and Bullhead City, Arizona. Goldberg's hair is jet black but would be gray if he didn't dye it. He has a receding hairline. He used to work at Boeing before being laid off. He likes outdoor activities and was the president of a gun and revolver club in Long Beach, California. Goldberg is 58, 6'0" and 160 pounds. (See Shows #665, #680, #707 and #725, OADs 2/16/02, 6/15/02, 2/22/03 and 6/28/03) Police know Goldberg fled home to his parents in Rumson, New Jersey after leaving Long Beach. However, his trail ends there. Since he has been on the run, police say Goldberg has been linked to Las Vegas, NV; Bullhead City, AZ; CO and GA. Goldberg's ex-wife and two adult children live in Atlanta, GA.

Chaunson McKibbins (Murder, Kidnapping, Aggravated Assault) -- Chaunson McKibbins is wanted for the kidnapping, torture and murder of Demitrios Robbins on November 18, 2001. McKibbins, along with some of his buddies, kidnapped Robbins and brought him to an apartment in Atlanta, GA. Robbins was physically assaulted, and even attempted to escape from an open window at one point, only to be chased down and shot at by his abductors. Robbins was thrown into the back of a vehicle and was transported to a house in the Atlanta Metro area, where he was beaten and tortured. Robbins was later murdered by an undetermined means in the house basement, his body then cut into ten pieces with a chainsaw. Police were led to the location by a police informant. Nine of the Robbins' body parts were discovered months later in a shallow grave in a heavily wooded area. His head was later found buried separately, some 20 miles away. McKibbins' accomplices' were arrested, but authorities are still seeking the ring-leader, McKibbins, and are anxious to bring him to justice. McKibbins is a convicted drug dealer who has used the aliases C-Bo and Chauncy. McKibbins is 33, 6'0" and 170 pounds. (See Show #743, OAD 12/06/03) Police believe he may have grown his hair out, possibly wearing it in dreadlocks. He had a slight goatee at time of murder, but may have shaved it off.

Anthony Stephen Kuchta (Drug Charges) -- Kuchta is accused of being a Class I narcotics trafficker. He is wanted by the Michigan State Police for conspiring to deliver over 650 grams of cocaine - an offense punishable by life without parole in the state of Michigan. Kuchta and four associates were arrested April 23, 1990 in a reverse drug transaction in which they purchased two kilos of cocaine in an undercover sting operation. This was to be the first parcel of a two-hundred kilo deal in which Kuchta was the moneymen. Arrested along with Kuchta were Pedro Molla and Giovanni Mereu. Molla and Mereu were deported after their cases were dismissed. The two Molla sisters failed to appear for trial March 16, 1991 and are also fugitives. Kuchta failed to appear the previous December. Kuchta, who has used the aliases Dave Taylor and Dade Taylor, has a scar on his left wrist. He grew up wealthy, dresses well, wears a Rolex watch, likes manicures and facials, and likes expensive American cars. He is divorced but very close to his young son. He is very intelligent. He fishes and boats, and prefers warm climates. Kuchta is 52, 5'10" and 170 pounds. (See Shows #268, #347 and #683, OADs 5/14/93, 1/7/95 and 7/15/02)

Brad Bergeron Feature (Teen Suicide) – On September 10, 2003, Brenda Robichaux discovered her 18-year-old son Brad Bergeron lying still on his bed in their trailer in rural Louisiana. He had been shot in the head with the family's shotgun, which lay near his body. Plaquemines Parish Sheriff's detectives determined the scene a possible suicide, but left open the possibility of foul play. According to Brenda, Brad had been threatened two days earlier by the town bully, Patrick Pleas, for being involved with his estranged wife, Leddy Jo. Detectives felt that there were too many unanswered questions to rule Brad's death a suicide or a murder. Brenda contacted AMW to find out what happened to her son. AMW investigator Ron Antoci, a retired NYPD detective and Don Francipani, a top forensic investigator, traveled to Louisiana's bayou to see what they could uncover. Through exhaustive interviews and forensic testing, AMW investigators determined Brad Bergeron, unfortunately, had committed suicide. Brad Bergeron is part of the startling statistic – every 100 minutes a teenager commits suicide – which is equal to 14 a day. What can parents do? Tereso "Blanco" Navarrette Pacheco (Murder) -- Tippecanoe County (IN) Sheriff's deputies are looking for Tereso Navarrette Pacheco. They say he shot and killed his ex-girlfriend Juanita Santa Rosa on September 15, 2002. Police found Juanita's dead body lying in a ditch along Lilly Road in their county. Detectives say that Pacheco shot Juanita and then dumped her body there before he fled in her car. The vehicle was recovered later in Cedar City, Utah. Police recovered evidence in the car linking Pacheco to the murder, but Pacheco has not been found. Pacheco, who uses the alias "El Blanco" has a skin problem on his hands and face that lightens his skin. He is known to wear a wide-brimmed hat, likes to play soccer, and may be working in housing construction. Pacheco is a Mexican national who has relatives in California. He is described as a man with a violent temper and is considered armed and dangerous. Pacheco is 40, 5'06" and 155 pounds.

Timothy James Marino (Rape) -- Police in Newport Beach, California say that Timothy James Marino is wanted for the rape of a female friend after she was rendered incapacitated after a night of drinking. On September 14th, 2003 a woman went to the apartment of Timothy Marino, where the two planned to have dinner and then go out bar-hopping. Before they headed out, Marino allegedly handed her a glass of beer. But she didn't want it, so she poured it out. According to the woman, Marino then became angry and poured her another glass of beer, insisting that she drink it. Police say that beer was a key part of Marino's plan for the evening. They believe it contained a date rape drug. The woman says that she and Marino took a cab to the Newport Beach Pier where they met up with Allen Crocker, a friend of Marino's. But because the bars in the popular area all were crowded, they decided to head back to Marino's place. That's when the woman says she began feeling drowsy. By the time they got to the apartment, she was struggling to stay awake. It was a struggle she'd quickly lose. "I went to Tim's room and sat on a chair," she recalls, "and I fell asleep." Police say it was the moment Marino and Crocker had waited for. With their victim unconscious and helpless, cops say the two men took turns violently raping her. And apparently, it was a moment they wanted to remember, because police say that earlier in the day, a video camera had been set up in the bedroom, and Marino and Crocker recorded everything they did that night. On the tape, says Detective John Hougan of the Newport Beach Police Department, Marino can be seen "playing to the camera. He's giving a thumbs up, he's smiling at the camera." Police say the camera was still rolling when the woman began to wake up, noticed the camera, and asked Marino what was going on. "This conversation is recorded, with Tim telling her that the camera was not recording anything, when in fact it was," says Detective Hougan. "The victim is obviously confused. Her speech is slurred. Her movements are slowed." After she left the apartment, the woman says, she couldn't remember anything about what had happened the previous night. This, too, is typical of people exposed to date rape drugs. But from her condition, the woman realized that she had been assaulted, and went to the police. Cops made an appointment with Marino to come in for questioning, but he never showed up. Instead, police say he called the technology firm where he'd worked as an IT consultant for eleven years and abruptly quit. His boss says Marino asked him to prepare his last paycheck, telling him: "I've got myself in a situation here where I just can't come back." Then, Timothy Marino vanished. But police got a major break when the second suspect, Allen Crocker, turned himself in. They say Crocker had possession of the videotape shot in Marino's apartment. They say that he believed it might somehow prove his innocence. It was a gamble, and Crocker lost. After viewing the tape, a jury convicted him. Timothy Marino is still on the run and believed to be in California or Canada. Marino has worked as an IT consultant for a technology company and has a pilot's license that he may have used to flee to Canada. He likes to stay in shape and may hang out at health clubs. He fancies himself an expert bartender -- his favorite drink to make and consume is a margarita. When he smokes he usually uses clove cigarettes. People who know him say that he is obsessed with cleanliness and especially insists on having a spotless bathroom. Marino is also known to shave his arms, legs, and chest. Timothy James Marino is 42, 5'10" and 190 pounds.

CAPTURED:

Martha Ann Gomez (Sexual Assault of a Child) -- Gomez is wanted for sexually assaulting three girls between the ages of 13 and 15 from 1996 to 1998. Gomez posed as a

teenage boy and usually met her victims through phone chat/sex lines. She preyed upon girls with low self-esteem, touting herself as someone who would listen to their problems. The conversations eventually escalated to actual meetings where Gomez sexually assaulted the girls. When the girls, who still believed Gomez was a man, tried to break out of the relationship, Gomez threatened their lives and their families' lives. In at least one case, police say Gomez used a gun. Police figured Gomez out and arrested her in the fall of 1998 on one count of aggravated sexual assault of a child. She bonded out. On November 24, when she was supposed to appear in court, and as police were filing three additional charges against her, Gomez disappeared. Gomez may have cut her hair and dyed it blonde. She has acne scars on both cheeks, "Gomez" tattooed on her lower left arm near her wrist and "ACE" on her upper left arm near the biceps. She has a very masculine walk, and hunches down as she walks. She claims she injured her back years ago when working in a candle factory, and used to receive disability checks for a dislocated disc in her back. She usually does factory work. Gomez has used several aliases, including Emilio Garrison, Eric Garrison, and Eric Barragan. Gomez is 38, 4'9" and 115-125 pounds. (See Shows #544, #563, #586, #670 and #686, OADs 5/29/99, 10/23/99, 4/29/00, 3/30/02 and 8/10/02) Martha Ann Gomez was arrested on Monday, October 6, 2003, in Reynosa, Mexico by Mexican authorities thanks to an AMW tipster and the help and direction of the Houston Police Department and the U.S. Marshals.

The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.

Timothy William Berner (Murder, Bank Robbery) -- Police in Sterling Heights, Michigan are on the hunt for the man who they say killed one of their own. On Friday, June 4, 2004 Sterling Heights police officer Mark Anthony Sawyers was filling out a report in his patrol car when a red Chevy Camaro pulled along the passenger side. The driver of the Camaro, Timothy Berner, fired one shot from a shotgun into the back of officer Sawyer's head. Berner then stole Sawyer's handgun and fled the scene. A surveillance camera from a nearby bank recorded Berner's vehicle fleeing the scene. They believe he may still be driving his 1994 red Chevy Camaro with license plate number YSR497. There have been no confirmed sightings since immediately after Mark's murder. Police believe that Berner's motivation for acquiring Sawyer's handgun would be that it would be a more practical weapon for committing bank robberies. Officer Sawyers joined the Sterling Heights Police Department seven months ago. Prior to joining the force, he was a police officer in Detroit for three years. Officer Sawyers leaves behind a wife and an eleven-month-old daughter. Timothy Berner uses the aliases Tim Smith, Don Jones and Vic (Vengeance). He has several tattoos including USMC on his upper arm, a dragon on his left shoulder, a tribal image on his left forearm, daggers on his inner forearms on both sides and a band around his left wrist. Berner is a large man who is a former semi-pro wrestler and a Dessert Storm veteran. He likes to frequent strip clubs and is a heavy drinker who prefers Jack and Coke. He has piercing blue eyes and may have either died his hair or shaved it off. Berner is considered armed and dangerous. Police believe that he may have lost weight dropping from 250 to 220 pounds and was last seen at the 299 North Tavern in Mount Clemens, Michigan with an unidentified woman. She is in her late 20's to early 30's, 5'9" 150 pounds with dirty blonde hair. He may still be driving his red Camaro. Berner is 33, 6'4" and 210-220 pounds. (See Shows # 768, #769 and #770, OADs 6/12/04, 6/19/04 and 6/26/04)

Edward Raifsnider (Fraud) – Agents in several states are hunting for Edward Raifsnider for defrauding people in more than 30 states. Agents say that Raifsnider has a scam he has carried out dozens of times in many locations over that past couple of years. They say that his victims are usually people who sell their vehicles in the classifieds. Once he finds a seller, he impersonates a law enforcement officer or an FBI agent and then tells them that he is interested in buying the car for the asking price. When the seller agrees to the sale, agents say Raifsnider purchases the vehicle with a cashier's check. By the time the seller finds out the check is a counterfeit, Raifsnider is long gone. Raifsnider is known to use the seller's name from the title to create a fake I.D. and later sells the vehicle and title to a dealership or another buyer for cash. Raifsnider has scammed over 50 people out of 1.5 million dollars. Raifsnider is also wanted for questioning in the unsolved murder of Ali Kemp in Leawood, Kansas, because of his resemblance to a sketch of the murderer in that case. Raifsnider is balding and has been known to wear a toupee and may be hiding somewhere in the Midwest. Raifsnider is 45, 5'11" and 220 pounds.

Unknown Armen Gyulbudagyan Killer (Murder) – The LAPD's Cold Case Squad is looking for the unknown killer or killers of Armen Gyulbudagyan. Police say that around 11 pm on June 30, 1996, Armen went to move his car to allow for street cleaning. Family members told police they saw Armen leave his apartment in Van Nuys in his slippers, suggesting he planned to be right back. Moving the car for the street sweepers was part of Armen's routine and something he did every Sunday night. But this Sunday night was not routine. Police say that Armen was likely abducted shortly after leaving the apartment and struck on his head at the right temple with a blunt object. They think he was then thrown into the trunk of his own car and driven away. Cops say someone sitting in the driver's seat repeatedly shot a large caliber handgun at the trunk through the rear passenger seats, striking Armen's body several times. Next, they say, someone seated in the passenger seat took the same gun and fired several more rounds into the rear seats. Armen died in the trunk. Police believe there may have been more than one killer, but only one weapon. Police believe that after killing Armen, the killer or killers drove a few blocks away and abandoned the car in an alley. At around midnight, a resident found Armen's car illegally parked and blocking his driveway in the rear alley of Woodman Avenue. The neighbor called police to have the car removed. But, when cops arrived in the early morning hours, they quickly determined it was not just an illegally parked car. They found a very suspicious scene--a wallet in plain view with money and credit cards still in it and the keys still in the car. A short time later, police popped the trunk and discovered Armen's lifeless body. Los Angeles homicide detectives worked the case for several years. About two years ago, the case was assigned to the Cold Case Squad. Investigators have uncovered lots of information, but still have never recovered the gun used to kill Armen Gyulbudagyan. Also, detectives feel there are some eyewitnesses that have never come forward. They are interested in any new information on the case and are working with America's Most Wanted to find those answers for Kristine and her family.

Juan Jimenez (Murder, Robbery, Burglary, Larceny, Conspiracy) – Juan Jimenez is charged with the murder of a homeowner named Bob Rooney during a burglary in Glastonbury, Connecticut on June 29th, 1991. Police say that Jimenez, Deddy DeLeon, Joaquin Santiago and Paul Eilerman crept into Mr. Rooney's home while he was asleep, then woke him up demanding

to know where he had hidden large sums of cash they believed was in the house. After a brief struggle in the kitchen, police say Jiminez shot Rooney in the chest, fatally wounding him. DeLeon, Santiago and Eilerman were captured and convicted. Jiminez is the only suspect who evaded arrest and has not been seen since the night of the crime. Jiminez, who uses the alias John Jimenez, has a scar on his left eyebrow, an appendix scar on his abdomen and a bullet wound hole on his left forearm. He is described as an extremely vain man who is clean cut and neat. He's known to party and drink and speaks fluid Spanish and English. Jiminez is 36, 5'7" and 170 pounds.

John Armand Ounigian (Probation Violation) – John Armand Ounigian has a long history of committing financial crimes involving real estate and other business ventures. Since 1991, authorities say Ounigian has committed financial crimes which defrauded his customers of over 2.5 million dollars. Federal authorities say that he victimized mainly the elderly, involving them in real estate and financial schemes, and then stealing their money. Many of his victims depended on the money Ounigian allegedly stole. This wasn't the first time that Ounigian committed financial crimes. In 1996, Ounigian was arrested and convicted of bank fraud. He was sentenced to seven years, given a fifty thousand dollar fine and was required to pay restitution to his victims. On October 12, 2001, Ounigian was released from federal prison and placed on federal probation. Among several conditions of probation, he was ordered to refrain from participating in any financial or real estate based employment. He is now charged with violating the conditions of his probation as well as fraud. Ounigian's whereabouts are unknown as he continues to evade authorities. Ounigian uses the aliases John Kimble, Armand Ounigina, and John Weston. He is described as charismatic and is able to adapt to his surroundings while gaining the trust of his victims. He likes to live a lavish lifestyle, including lavish diners, chauffeured limousines and luxurious hotels. Ounigian is 59, 6'1" and 230 pounds.

CAPTURED:

Richard Emile Newman (Murder) -- Police in Toronto, Canada are looking for Richard Newman in connection with the murder of Rhoan Gooden. Rhoan Gooden was a security guard at the Tropical Nights Club in Toronto, Canada. On August 4, 2002, Richard Newman entered the club with several of his friends. Gooden approached Newman and told him to remove his headband and stop smoking his cigarette. Although Newman argued with the bouncer, he did take the headband off, but a few minutes later, he was seen putting it back on. About a half an hour later, Newman approached Gooden and fired a single fatal gunshot into the man's stomach. Gooden died two days later. Gooden was a 32-year-old married man with two young children. Police say that he could still be in Canada or may have crossed into the United States. Newman is from Jamaica and speaks with an accent. He wears his hair in a ponytail or cornrows and may have nerve damage in one of his hands. Newman may seek work in construction or as a short order cook. Newman is 32, 5'10" and 170-200 pounds. (See Show #768, OAD 6/12/04) On the morning of July 2, 2004, Marshals arrested Newman in Brooklyn, New York.

The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.

James T. Moran (Murder) -- Police in Kennewick, Washington are on a hunt for James Moran. Moran allegedly went to the home of his in-laws, Glenn and Debbie Carr and shot the two of them. He then left with his daughter, 7 year old Jaime. Neighbors say they saw him and the girl drive away. Moran's other children were staying elsewhere, but were picked up by their father. Police say he took all four of them on the run with him. An AMBER Alert was immediately issued for the Moran children, and a description of Moran, and the car in which they fled was circulated. The next morning, police in Moses Lake, Washington got a call from Moran's mother, saying the children were safely in her custody. Police say Moran had been driving back from Arkansas with his wife Mandy. At some point, Moran allegedly attacked his wife and abandoned her. He then returned to the Northwest to get his kids. Mandy is now in protective custody, fearing for her life. Neighbors of Moran in Kennewick reported seeing a car that may have belonged to Moran near his house. Police immediately swarmed the area, evacuated the neighbors and surrounded Moran's house. They tried to contact Moran inside, but when that failed, tossed in tear gas to try and get him to come out. When that also had no effect, a SWAT team entered the house, but found no one inside. Police now do not know whether Moran was ever in the house. Moran has a tattoo of the letters "MJM" on his left wrist and has scars on his abdomen and right hand. He uses thyroid and diabetes medication and may try to obtain a prescription for the medication. Police believe Moran may still be in the Tri-City area of Kennewick, Paco or Richland and may possibly be driving a Pontiac Grand Am with Wyoming plates. Moran is considered armed and dangerous. Moran is 32, 5'8" and 220 pounds.

Unknown Child Molester/Internet John Doe #4 (Child Pornography) -- The FBI are on the hunt for an accused child predator who uses the Internet to distribute disgusting photos showing himself molesting young children. Agents say they found online images of the man

abusing at least two children – a boy and a girl. One of the images portrays sadistic and violent acts. Based on the images authorities found, they obtained a “John Doe” warrant charging the unidentified man with transporting child pornography images over the internet. The FBI had released images of his face, cropped from the online photos. John Doe #4 is white, has brown hair and is 180-190 pounds. He has a long scar on his upper right arm and has a tattoo of a face on his upper left arm.

Anthony Smith (Murder, Aggravated Assault) -- On March 30, 1993 Anthony Smith, Kenyatta Warney and two young ladies were walking to Smith’s apartment when they passed by Christopher Holmes, his brother and several friends who were moving furniture. Holmes spoke to the girl walking with Smith. Smith became angry and allegedly stabbed Chris Holmes in the chest. In the ensuing melee, Smith and Warney stabbed Holmes brother David and two of his friends. After the initial round of violence, smith and Warney fled to their apartment, but quickly returned with pistols and opened fire on the Holmes group as David and his sister Sandy were attempting to give medical aid to their dying brother. Sandy and Chris were hit by gunfire. Chris Holmes, a Desert Storm veteran, died from a stab wound to the heart. He was also struck in the flank by a bullet. Warney plead guilty to assault and weapons charges and is serving a fifteen year sentence. Smith jumped bond and fled. A bench warrant was issued on June 24, 1993. Smith has a slender but strong build, and may work in construction. He is considered a ladies man, but is known to be very jealous. Smith, who uses the nickname “Sniper,” has a thick Jamaican accent and although he’s thin, he very strong. Smith is 37, 6’2” and 180 pounds. (See Shows #355, #477, #581 and #639, OADs 3/4/95, 4/19/97, 3/25/00 and 7/07/01)

David Benjamin Creamer (Child Pornography, Money Laundering, Weapons Charges) -- David Creamer is wanted on numerous child pornography charges stemming from a business he ran out of his home in Tucson, Arizona which distributed CD-ROMs involving, among other subjects, child pornography, adult obscenity and bestiality. On June 5, 1997, a 23-count indictment was handed down, charging Creamer and his businesses, Profit Group, CD-Disc Inc., and CD Disc Direct Inc., with distribution of child pornography, transportation of obscene materials and money laundering. Between 1992 and 1995, Creamer’s business produced more than 100,000 CD-ROMs in the United States and Denmark for world-wide distribution. A trial date was set for March 10, 1998. On December 17, 1997 he was due to appear for a pre-trial urinalysis test. He never showed and hasn’t been seen since. In March of 2000 Creamer was added to the Customs’ Services Top Ten List. He is also on the US Marshals’ Top 15 List. Creamer has scars on his face, right knee, left knee, left leg, a circular discoloration on the left side of his ribcage and a scar shaped like a plus sign on his neck. He wears glasses, often wears a full mustache, beard and ponytail, and likes to wear one-piece jumpsuits and Mexican wedding shirts. He is diabetic and may be taking medication. He has a fascination with Harley-Davidson motorcycles and has previously owned them. He is interested in weapons and often carries a .38 in a shoulder holster under his jumpsuit. He has worked as a handyman. Creamer is 58, 5’10” and 250 pounds. (See Show #729, OAD 8/02/03)

Artur Martirosyan (Murder) – Artur Martirosyan is wanted in connection with the murder of two men in Aurara, Colorado. On September 7, 1998, Martirosyan drove Michael Martinez and Alex Pogosyan and an unnamed friend to the home of Edgardo Morales. Martinez

was seeking revenge on the people he believed "snitched on him." Edgardo Morales and Zach Olbert were sleeping in the basement of the house when Pogosyan and Martinez entered carrying 12 gauge shotguns. Pogosyan and Martinez open fired killing Obert and Morales. After the killings the Martinez and Pogosyan split from the group, went to the home of Penny Bowman-Medla and shot her to death along with her 16-year-old son, Greg Medla and his 16-year-old girlfriend Marissa Avalos. Later that day, police responded to tips that unexpectedly led them to the discovery of the body of Michael Martinez - who had been shot to death. Martirosyan and Pogosyan were later arrested but due to lack of evidence, they were forced to release Martirosyan. Pogosyan was convicted for his involvement in the crime and now police have the evidence they need to arrest Artur Martirosyan. Martirosyan enjoys getting tattoos which include the word "Armenia" on his right elbow; "Armenian Pride" on his front right bicep; "A4I" on his back right bicep; "A.M." and a series of Armenian letters or numerals; and a panther on his left arm. Martirosyan is 24, 5'5" and 125 pounds.

Raul Ortiz Gonzales (Battery Causing Death) -- Franklin City, IN, police are searching for Raul Ortiz Gonzalez, who police say is a 26-year-old illegal alien, wanted for the death of his girlfriend's two year old daughter. On March 21, 2003, the child's mother, Sylvia Sanchez, left little Mariella Deluna in Gonzalez's care. Police say Gonzalez had been living with Sanchez for several months, and was accustomed to watching the child on occasion. This time, however, an afternoon of babysitting turned deadly. Cops say that while Sanchez was at work, she received a phone call from Gonzalez, saying that Mariella was content and playing. Only a few minutes later, cops say Gonzalez called back and told Sanchez that Mariella was vomiting and losing consciousness. Gonzalez then took Mariella to Sanchez, who brought her immediately to the hospital. Autopsy results show that Mariella died from a severe blow to the head or from being shaken. Doctors say she became unconscious immediately after sustaining her injuries. Gonzalez was interviewed through a Spanish translator and denied harming the child. After agreeing to return to the police station to take a polygraph test, Gonzalez fled and has not been seen since. Gonzalez is an illegal alien, speaks very little English and may be seeking work in restaurants. Gonzalez is 27, 5'6" and 160 pounds.

FEATURED CASE:

Rock star Dave Navarro-- a former member of Jane's Addiction and The Red Hot Chili Peppers - lives the dream life in Hollywood with his wife, Carmen Electra. But he carries the scars of the most traumatic experience of his life -- the murder of his mother, Connie Navarro. Connie's killer was one of the first cases AMW ever took on. Navarro's mother was murdered by a man named John Riccardi in March of 1983. John Riccardi had been on the run for eight years, when AMW ran the story, but he couldn't hide from AMW viewers. AMW Hotline tips led FBI agents to his hiding place in Houston, Texas on January 4, 1991. Dave Navarro says he'll never forget the day John Riccardi was captured. In 1994 Riccardi stood trial for the murder of Connie Navarro and Susan Jory. Dave Navarro had to relive his mother's murder all over again as he testified at Riccardi's trial. But it was worth the wait - Riccardi was found guilty. The jury considered the crime so heinous they sentenced him to death. He is now in San Quentin Prison on death row. Dave has a special thanks for the viewers of America's Most Wanted. He says, "they really do make a difference in the lives of the victims. The difference is that America's

Most Wanted offers a solution." "That's what makes it so important and why he is so grateful to it."

MISSING:

Lori Kay Hacking

Age: 27

Height: 5'3"

Weight: 115 pounds

Salt Lake City Police and more than 1,200 volunteers are scouring the terrain surrounding Memory Grove Park and City Creek Canyon in search of Lori Kay Hacking, a 27-year-old pregnant woman who reportedly vanished while jogging. Lori left her home around daybreak on Monday, July 19, 2004 to run in the Memory Grove park and City Creek Canyon area. After she failed to show up at work later, her husband, Mark Hacking, called 911. Police officials report that search teams have scoured the canyon and surrounding hills and it appeared Hacking, who is five weeks pregnant, is probably no longer in the area. Detectives consider the case to be a missing persons investigation, but the possibility she was kidnapped is not being ruled out. Authorities say that two days after Lori's disappearance, her family and in-laws were stunned to learn that her husband, Mark, had not graduated from college nor had he been accepted at medical school in North Carolina, as he'd stated. Lori's mother believes her daughter was also deceived. The University of North Carolina said that Hacking had never applied to the medical school. Also, the University of Utah said he was enrolled from 1999 to 2002, majoring in psychology, but never graduated. Police say the confusion about Mark's background is just a piece to the puzzle and he is considered a "person of interest." Lori is a little reserved around strangers but is describes to be a fun person with a strong will. She loves to run, read and scrapbook. Her favorite foods are Mexican and Sushi. She recently found out that she was pregnant and was very excited about having a baby.

CAPTURED:

John Evan Mizic (Escape, Fraud, Counterfeiting, Robbery)

Karen Mizic (Accessory After The Fact to Escape) -- John Mizic has a long criminal history involving scams, robberies, and cocaine and heroine abuse. He was serving time for a 1998 scam in a Harrisburg, Pennsylvania jail when he met Karen, a mother of three children. She had a boyfriend in the same jail and got to know Mizic. Karen eventually dumped the boyfriend and got involved with Mizic. She married him in jail. From his cell, he was able to control Karen and her children, forcing them to wait for his call before they went out of the house. In March 2001 Mizic was transferred from jail to a halfway house in Harrisburg to complete his sentence. Mizic was a week away from being released when he escaped from the halfway house. On May 7, 2001 he received a weekend social pass from the halfway house to visit his wife, who was undergoing shoulder surgery. When he didn't return on May 9, 2001, Mizic was placed on escape status. The United States Marshals Service learned that Mizic packed up his wife's house and three children, along with computer equipment and one or two

dogs, on the morning of May 9. The family took off and has been on the run ever since. USMS have traced the Mizic family to areas of Pennsylvania, Massachusetts, Florida and Virginia. Mizic is back to his old tricks: pulling a counterfeiting check scam. He steals checks in the mail, makes phony ones on his computer and cashes them in banks around the town he happens to be in. In one month he made off with nearly \$70,000. This is how he is able to stay on the run, take his family to Disney World, buy Thomas Kinkaid prints, jewelry and an SUV. His take is well over \$500,000. Authorities are concerned about his step-children's welfare. It doesn't appear they've lived in one town long enough for the children to attend school. Mizic, who has used the aliases Jon, Daryl and David Mizic, Jon Misic, Jeffrey Hoffman, Otis Jackson, Victor Gallo, Anthony Eugene Jones and Edward Buchanan, has scars on both eyes and his right arm, a rose tattoo or an eagle on his forearm and an unknown tattoo on his left thigh. He is known to wear pinky rings. He appears to have gained a considerable amount of weight. Mizic is 47, 6'0" and 275-310 pounds. Karen Mizic, who has used the aliases Karen Sheeler and Karen Barnhart, has an unidentified tattoo on her chest. She is 37, 5'3" and 130 pounds. The pair may be traveling with the children in a 1994 Ford Bronco with Florida plates F83-LSU or a 1999 Burgundy Dodge conversion van. (See Shows #692, #720, #750 and #757, OADs 9/28/02, 5/24/03, 1/24/04 and 3/20/04) Mizic's good luck came to an end when on May 20, 2004, police arrested him and his wife Karen after U.S. Marshals tracked the family to a hotel in Independence, Missouri.

The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.

Noe Miranda-Valez (Sexual Battery and Interference with Child Custody)

Jose Macedo-Avellaneda (Sexual Battery and Interference with Child Custody) -- Police in Lakeland, Florida are looking for Noe Miranda-Valez and Jose Macedo-Avellaneda for the kidnapping and rape of a mentally handicapped girl. On July 12, 2004, Miranda and Macedo and two other men went to a Lakeland shopping mall and approached a 17-year-old female who is mentally handicapped. The men lured the victim out of the shopping mall. This was caught on surveillance cameras in the mall. They held her captive for more than 12 hours and during that time the men raped her. The following day, the victim was found walking near a gas station. She was dropped off on the side of the road near a gas station in Bowling Green, Florida more than 50 miles away from where she was taken. Police have arrested and charged two of the men, but Noe Miranda-Valez and Jose Macedo-Avellaneda have not been seen since. Noe Miranda-Valez wears small hoops earrings and goes by the name Noel. Miranda is 21, 5'7" and 160 pounds. Jose Macedo-Avellaneda, who is also known as "Chewy," has a goatee and a ponytail and wears hoop earrings. Macedo is 23, 5'7" and 170 pounds.

Jordan Allgood Killer (Murder) -- Everyone who knew Jordan Allgood says his name was truly fitting, that he was a good man in every sense of the word. A well-respected coin dealer in the small community of St. George, Utah, the 43-year old Allgood was known for his honesty and integrity. He was a devoted husband and father of three. Jordan was a former locksmith who had turned his love of coin collecting into a lucrative business, a rare coin shop. Two days before Thanksgiving, 2003, Jordan opened the doors to Allgood Coin at around 10 a.m., just as he had done almost every day for the previous seven years. For the next two hours it was business as usual. But then, just after noon, a man who appeared to be a customer entered the shop. Police doubt whether Jordan even had a chance to see him. But the store's

security cameras saw everything. The cameras watched as the man, wearing a disguise, pulled out a handgun immediately after stepping foot into Allgood Coin. He quickly walked toward Jordan, who was standing behind the counter. Then, without any warning, the robber opened fire, hitting Jordan in the chest. As Jordan dropped to the floor, seriously wounded, the gunman moved behind the counter and handcuffed him. Then, the thief cleaned out the safe, stepped over his bleeding victim, and headed for the door. In the videotape from the store's security camera, the gunman can be seen opening the shop door and stepping forward to leave. But then, he catches himself in the doorway and seems to get flustered. While still standing in the open doorway, he removes a gray wig and fake beard. Because he removed his disguise, the camera was able to capture an image of his face. But the videotape is so grainy that it's hard to make out many details. After removing the disguise, the killer can be seen putting on what appears to be a baseball cap and sunglasses. Then, he steps back into the shop, closes the door and rummages through his bag of loot. With everything finally in order, he finally slips out the door. All the while, Jordan Allgood lay dying. Despite being handcuffed and seriously wounded, somehow Jordan managed to call 911. He was able to give the dispatcher a brief description of the man who attacked him. But within minutes, while he was still on the phone with the dispatch operator, Jordan died. Police hope someone can identify the killer from the grainy surveillance video image. But they're also asking coin collectors and coin dealers to be on the lookout for the coins stolen from Allgood Coin. Jordan, like most coin dealers, was a "creature of habit" and packaged his coins in a particular way. On coins that were stapled in cardboard 2 X 2 holders, he would load the coins so that the holder's hinge was at the top of the coin. He then stapled the three open sides parallel to the edge of the holder. On all of his U. S. coins in 2 X 2 holders, Jordan would put the date in the upper left corner, the condition in the upper right and the price on the bottom right corner. On foreign coins, Jordan would put the country in the upper left, the date in the upper right and the price in the bottom right of the 2 X 2 cardboard holder. Jordan always capitalized, and never used the dollar sign (\$) on the 2X2 cardboard holders. He never used a decimal point on his price listings, but would put a line under the "cents" part of the price marked on the holder. On items not in a 2 X 2 holder, he did use a dollar sign (\$) on the price sticker. Some of them are very rare -- and if they turn up, they could lead to the killer.

Lori Lepper Killer (Murder) – Police are searching for the murderer of 32-year-old Lori Lepper. On Friday November 29, 2002, Lori Lepper was found brutally beaten and stabbed to death in her apartment. Lori Lepper was well-known around the LA rock scene as a die-hard fan. It was rock and roll that had lured the native of Bologna, Italy to the US, 11 years before her death. Lori made LA her home. She held down a day job with a payroll company, but she was crazy for rock and roll, spent her evenings at concerts and clubs, and eventually became the webmaster for several fan websites; including an official one devoted to the band “Loaded,” a group formed by Guns’n Roses bassist Duff McKagan. Police determined that Lori had been killed around 6pm on Tuesday, November 26th. On that Tuesday, Lori had the day off from her full time job and was working at home. At 3:50 on the day of the murder, police believe Lori spoke to an acquaintance on the phone. At 6pm the “Loaded” website was pulled up on her computer. Police believe it could have been either Lori or her killer. One of Lori’s two missing wallets was found at 6:30 that same Tuesday night about two miles away from her home at the corner of 6th and La Brea Avenue. A second wallet was found two blocks from her home at the

intersection of Orlando and Whitworth Drive on Thanksgiving evening. Police have determined that Lori Lepper's killer may be a white male who has an extremely violent temper and may have a history of assault arrests. (See Show #770, OAD 6/26/04)

ALL POINTS BULLETIN:

Kevin Louis Vermette (Second Degree Murder (3), Attempted Murder) -- Folks around Kitimat, British Columbia always thought Kevin Vermette was a curious man. A quiet loner with a passion for restoring old cars, he lived and worked at the Kitimat Hotel. Some in town called him a "silent psycho." On July 12, 1997, police say Vermette exploded. Four young men - 20-year-old Mark Teves, 20-year-old Michael Mauro, 21-year-old David Nunes, and 20-year-old Donny Oliveira stopped at Kitimat's Hirsch-Creek Park that evening. At 9:30, fishermen heard eight gunshots. When police arrived, they found all four young men lying on the ground in a pool of blood. Only Donny Oliveira was still alive - he was rushed to a hospital by helicopter. Witness accounts and evidence left at the scene led investigators to suspect Vermette. When Mounties went to Vermette's hotel room to question him, they discovered he had cleared out. Armed and dangerous, he's taken to the woods, but police say he could resurface anywhere. Vermette never drinks or smokes and is a health food and fitness enthusiast. He has a tattoo of a cartoon cat with "Lucky" written under in on his right upper arm and a coyote and dagger through a red rose on his upper left arm. He may be wearing wire-rimmed glasses. Vermette is 49, 5'8" and 165 pounds. (See Shows #458, #489 and #507, OADs 7/19/97, 4/11/98 and 8/15/98)

Adolfo S. Sanchez (Murder) -- Sanchez shot and killed his ex-girlfriend, Jennifer Wiedemann, on July 20, 2001. Wiedemann was shot three times in the upper chest and throat. She had broken up with Sanchez about a week before her murder. Sanchez had made several unsuccessful attempts to get Jennifer to take him back. After the murder, Sanchez fled to Milwaukee where he has relatives. Police recovered his car and gun in the Milwaukee area, but Sanchez was nowhere to be found. Sanchez has numerous tattoos including, the Virgin of Guadalupe on the right side of his chest, the name Adolfo on his left forearm, an angel on his right bicep and an eagle with a dagger through it on his left bicep. Sanchez was employed as a factory worker and may be working in the fast food/restaurant industry. Sanchez is 31, 5'7" and 135 pounds. (See Show #648 and #680, OADs 9/8/01 and 6/15/02)

Frederick Styles Wanamaker (Aggravated Sexual Battery) -- Wanamaker is wanted for sexually abusing several young boys over the course of twelve years. Wanamaker used his status as a family friend and Boy Scout leader to take advantage of three brothers and two of their friends. Because of the youngest of the boys was molested on federal parkland, federal charges are also pending. Wanamaker was a neighbor of the three brothers in Yogaville -- a new-age community in Buckingham County, Virginia. Wanamaker befriended the family and became a father figure to the children. Wanamaker, a sailor by trade, eventually became a Boy Scout leader, taught neighborhood kids special courses on navigation and took them on camping trips. Wanamaker started molesting the oldest of the brothers when the child was about 10 and continued until the boy was about 13. At that time, he shifted his sexual attention to the second oldest child for a few years. When the youngest brother turned 10 and started going on camping

trips with Wanamaker, the oldest brother, then an adult, felt he had to tell his mother what had happened to him, lest it happen to his brother as well. He was too late. All three brothers and two of their friends from the Boy Scout troop had been sexually assaulted. Wanamaker's abuse spanned from 1985 to 1997. Wanamaker has worked as a Merchant Marine and ship's captain. He has training and credentials which qualify him to pilot virtually any seagoing vessel anywhere in the world. Investigators fear he may still be molesting children in a foreign nation. He is described as professional, quiet, with an intellectual demeanor. Wanamaker is 57, 5'8" and 180 pounds. (See Show #634, OAD 5/26/01)

Terray D. Appling (Armed Kidnapping w/Sexual Assault, Home Evasion, Indecent Assault and Battery) – In the middle of the night on September 19, 2003, Terray Appling and an accomplice broke into a residence in Westfield, MA, and assaulted the female occupant. The woman who happened to be house sitting for a friend was awakened by the front door being kicked in. Appling, who was armed with a knife, cut the phone lines from the walls and tied the victim up. Police claim that while Appling's partner ransacked the house, Appling stood guard over their hostage. They say Appling began to molest the woman and stopped only because he and his partner thought they had enough loot and wanted to get out of the apartment. Appling's partner has been arrested, but he continues to evade police. Appling is 28, 6'0" and 320 pounds.

MISSING:

Lori Kay Hacking

Age: 27

Height: 5'3"

Weight: 115 pounds

Salt Lake City Police and more than 1,200 volunteers are scouring the terrain surrounding Memory Grove Park and City Creek Canyon in search of Lori Kay Hacking, a 27-year-old pregnant woman who reportedly vanished while jogging. Lori left her home around daybreak on Monday, July 19, 2004 to run in the Memory Grove park and City Creek Canyon area. After she failed to show up at work later, her husband, Mark Hacking, called 911. Police officials report that search teams have scoured the canyon and surrounding hills and it appeared Hacking, who is five weeks pregnant, is probably no longer in the area. Detectives consider the case to be a missing persons investigation, but the possibility she was kidnapped is not being ruled out. Authorities say that two days after Lori's disappearance, her family and in-laws were stunned to learn that her husband, Mark, had not graduated from college nor had he been accepted at medical school in North Carolina, as he'd stated. Lori's mother believes her daughter was also deceived. The University of North Carolina said that Hacking had never applied to the medical school. Also, the University of Utah said he was enrolled from 1999 to 2002, majoring in psychology, but never graduated. Police say the confusion about Mark's background is just a piece to the puzzle and he is considered a "person of interest." Lori is a little reserved around strangers but is describes to be a fun person with a strong will. She loves to run, read and scrapbook. Her favorite foods are Mexican and Sushi. She recently found out that she was pregnant and was very excited about having a baby. (See Show #773, OAD 7/24/04)

CAPTURED:

Manuel Tarango, Jr. (Attempted Murder, Armed Robbery) – It was 1:22am on the morning of December 5, 1999 when Manuel Tarango, Jr., Emilio Rodriguez and a third suspect burst into Mr. D's Sports Bar & Grill. Brandishing pistols, the gunmen began firing as soon as they entered the bar, but the gunmen had picked a bar that was full of off-duty police officers that night who'd come to see a band of cop-musicians, "Pigs In A Blanket", perform. All three gunmen were wearing masks. When Tarango tried to jump over the bar to get to the ash register, several patrons grabbed him and slammed him to the floor. The third suspect began firing wildly into the crowd. At that same moment, on the other side of the bar Rodriguez engaged in a toe-to-toe shootout with off-duty cop Dennis Devitte. Devitte was shot seven times, but managed to fatally wound Rodriguez with eight bullets. Rodriguez died at the scene. Five other patrons were wounded during the attempted robbery. The entire event was over in less than twenty seconds. Police believe Tarango fled to Mexico after the robbery. The third suspect, who was wearing a white t-shirt over his head, has not been identified by authorities. Officer Devitte recovered from his wounds and returned to normal patrol duty five months after the shooting. He has been honored as one of America's "Top Cops" for the year 2000 for his heroic actions that night at Mr. D's. Tarango, who has gang affiliations, uses the street name "Demon". He may have a thin mustache and a shaved head or very close-cropped hair. He is known to smoke both marijuana and PCP. Tarango is 21, 5'10" and 185 pounds. (See Shows #600, #618, #670, and #686, OADs 8/19/00, 1/27/01, 3/30/02 and 8/10/02) After searching for Tarango for more than four years, Las Vegas Police finally tracked him to Mexico. When six officers of the Chihuahua State Judicial Police surrounded Tarango with guns drawn outside The Habana Club bar, he was stunned. Neither of the other two suspects who participated in the robbery at Mr. D's on the night of December 5th, 1999 has been identified to date and Tarango has refused to cooperate with investigators since he's been in custody. Manuel Tarango sits in the Clark County jail in Las Vegas awaiting trial.

Timothy William Berner (Murder, Bank Robbery) -- Police in Sterling Heights, Michigan are on the hunt for the man who they say killed one of their own. On Friday, June 4, 2004 Sterling Heights police officer Mark Anthony Sawyers was filling out a report in his patrol car when a red Chevy Camaro pulled along the passenger side. The driver of the Camaro, Timothy Berner, fired one shot from a shotgun into the back of officer Sawyer's head. Berner then stole Sawyer's handgun and fled the scene. A surveillance camera from a nearby bank recorded Berner's vehicle fleeing the scene. They believe he may still be driving his 1994 red Chevy Camaro with license plate number YSR497. There have been no confirmed sightings since immediately after Mark's murder. Police believe that Berner's motivation for acquiring Sawyer's handgun would be that it would be a more practical weapon for committing bank robberies. Officer Sawyers joined the Sterling Heights Police Department seven months ago. Prior to joining the force, he was a police officer in Detroit for three years. Officer Sawyers leaves behind a wife and an eleven-month-old daughter. Timothy Berner uses the aliases Tim Smith, Don Jones and Vic (Vengeance). He has several tattoos including USMC on his upper

arm, a dragon on his left shoulder, a tribal image on his left forearm, daggers on his inner forearms on both sides and a band around his left wrist. Berner is a large man who is a former semi-pro wrestler and a Dessert Storm veteran. He likes to frequent strip clubs and is a heavy drinker who prefers Jack and Coke. He has piercing blue eyes and may have either died his hair or shaved it off. Berner is considered armed and dangerous. Police believe that he may have lost weight dropping from 250 to 220 pounds and was last seen at the 299 North Tavern in Mount Clemens, Michigan with an unidentified woman. She is in her late 20's to early 30's, 5'9" 150 pounds with dirty blonde hair. He may still be driving his red Camaro. Berner is 33, 6'4" and 210-220 pounds. (See Shows # 768, #769, #770 and #772, OADs 6/12/04, 6/19/04, 6/26/04 and 7/17/04) A tip to the AMW Hotline on Saturday, July 24, 2004, placed Berner in Jacksonville, Florida. The caller said Berner was still driving the red Camaro he was seen fleeing in after the ambush murder of Officer Mark Sawyers on June 4th. When police went to check the Jacksonville location, they immediately spotted Berner's Camaro, and knew the tip was good. As they moved in on the house, cops say they heard a gunshot from inside. When they entered, they discovered Timothy Berner, dead from a self-inflicted gunshot wound.

The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.

Patty Carrion (Attempted Murder, Criminal Use and Possession of a Firearms) -- FBI agents in Connecticut are looking for Patty Carrion for attempted murder. On September 20, 1995, agents say, Carrion walked up to a man who was sitting in a park and began to yell at him. Then Carrion pulled a .32 caliber gun from her pants and shot him in the chest. When the man got up to run, Carrion shot the man again in the back. A witness saw Carrion leave and go to a car parked near the park. The witness saw Carrion slam the trunk of the car and then flee to a house. Police impounded the car that evening, but Carrion was gone. When agents searched the car, they found the .32 caliber gun and 82 packets of cocaine. Carrion has not been seen since. Carrion has used numerous aliases and nicknames including Patricia E. Carrion, Patti Carrion, Patti Carrion, Patty Watson, Patti Watson, and Patricia Watson. She is a small woman who has a discoloration on her right cheek. Carrion has been known to alter her appearance by changing the color of her hair, dressing as a young boy by wearing baggy clothes, hats, wigs and theatrical makeup. She is a known drug user and dealer who is associated with the Latin King Street Gang and the Ching-Ling Motorcycle Gang. Authorities believe that Carrion had twin daughters since on the run and may be seeking medical attention for one of them. Carrion is 34, 5'0 and 115 pounds. (See Show #748, OAD 1/10/04)

Leonard Ray Harper (Murder) -- Leonard Ray Harper is wanted for murdering his friend, Jerry Permenter, in August 1997. Harper was seeking revenge when he killed Permenter. Permenter struck Harper's pregnant girlfriend, Francesca. After the incident, Francesca decided to abort her baby. About a month and a half after the incident Harper picked Permenter up in his car, drove him to a deserted field, put a gun to Permenter and shot him. Harper and Francesca hopped on a bus and traveled across the country. Francesca continued to work as a dancer to support their life on the run. Francesca says Harper became more and more possessive. He

wouldn't let her out of his sight, and she began to fear for her own life and she was pregnant again. At one point Francesca convinced Harper to let her go to the restroom of a Pizza Hut in Shamrock, Texas. While in the bathroom she used a napkin to scribble a note asking for help. She left the note behind with a manager. He called the police and they pulled over Harper's car a short time later. Harper was arrested and brought back to San Antonio. Harper was officially charged with murder, but bonded out of jail and took off. Before leaving, he threatened Francesca and promised that he would be back for his daughter someday. Harper, who goes by the nickname "Hap", has a scar on his right cheek. He is a Jekyll and Hyde personality who drinks heavily and is often high. He bites his fingernails. Harper may have a trust fund, and his grandmother may be supporting him on the run. He likes sushi and likes to cook. He is a scuba diver. Harper is 33, 5'9" and 160 pounds. (See Show #698, OAD 11/23/02)

Heather Catherine Tallchief (Bank Larceny)

Roberto Solis (Bank Larceny) -- The Nevada FBI and Las Vegas police are looking for an armored car driver and her male roommate who disappeared on October 1, 1993 along with a Loomis Armored Inc. van filled with \$3.15 million dollars. Heather Tallchief, a native of Buffalo, New York, was hired by Loomis in Las Vegas as an armed guard/driver. On October 1, 1993 Tallchief drove a Loomis armored van to Circus Circus Hotel and Casino, where she dropped off two co-workers to make a delivery. The co-workers went inside to fill ATM machines, while Tallchief waited for them outside in the van. When they came back out of the casino, the van, Tallchief and the money had disappeared. The van was found abandoned in Las Vegas on the morning of October 13. Investigation of Tallchief's residence, which had been vacated the day before the robbery, indicated that she was living with her boyfriend, Julius Gabriel Sauve. The FBI positively identified Sauve through fingerprints as Roberto Solis. Agents traced Tallchief and Solis to Denver, Colorado the day of the heist. Approximately one week later, they were traced to Miami, Florida where authorities intercepted two passports in the mail on their way to Tallchief and Solis. The FBI believes the couple may be in the Caribbean. Tallchief, who also uses the names Heather Sonny Tallchief-franco and Heather Franco, is a Native American of the Seneca Tribe. She has long hair which she sometimes wears in a ponytail, multiple piercings in her left ear and she also wears a nose ring. She wears clear glasses. Tallchief is 32, 5'8" and 140 pounds. Solis' aliases include Julio Garrett Sauve, Roberto Ignacio Zelaya, Pancho Aguilila, Pancho Agila, Pancho Aguilar, Miguel Angel Dominguez and Joseph Anthony Panura. He has tattoos on his right forearm of the Spanish words "esta vida loca". He has curly hair, but his most noticeable feature is his eyes. He has an eye disease called "exophthalmos", which renders his eyes very sensitive to light. He sometimes looks "bug-eyed", sometimes wears a patch over one eye, and may wear glasses or blue contact lenses over his naturally brown eyes. He enjoys writing poetry and fancies himself an art collector. Solis is 58, 5'10" and 152 pounds. Authorities warn that both Tallchief and Solis should be considered armed and dangerous. (See Shows #594, #698 and #748, OADs 7/8/00, 11/23/02 and 1/10/04)

Jenny Liang (Murder) -- Liang and her boyfriend Patrick Sheen were together over a year when they bought their home in Las Vegas, Nevada. Patrick owned his own insurance company, and Jenny worked as a dealer at the Mirage Casino. Jenny's 14-year-old son lived at their home and attended school in the area. Patrick's sister Ruby was close with the family. She

visited her brother often and they had a very close relationship. On October 2, 2000 Jenny called Dennis Lam at the insurance company to tell him that Patrick would not be at work that day. Later that evening Jenny called Dennis again and said Patrick would be out of town for a meeting and would not return until Friday, October 6, 2000. The same day Jenny called Dennis, she also called her work and spoke to a scheduler at the Mirage. Jenny called out sick from work on October 2 and 3. Then on October 4, Jenny called the Mirage again and said she was hospitalized and would not be able to return to work. Shortly after that phone call, Jenny picked up her 14-year-old son and dropped him off at her ex-husband's house. She also gave her ex-husband and her son the 1999 Mercedes-Benz she owned with Patrick. She told her son he would have to take care of himself and that she had to go. Within this week Ruby, Patrick's sister, told cops she was trying to contact him and his family, but no one could be reached. On October 11, 2000, Ruby was getting nervous and she called the police station to file a missing person report on her brother. It wasn't like him not to call or stop by her house. The police, Ruby and a locksmith went to Patrick's home. As soon as they entered they knew there was a problem because of the smell that was coming from the bedroom. The cops found Patrick's body in his bed. He had been shot multiple times in his head with a .357. Patrick's fingers were starting to mummify, the home was not ransacked, there was no forced entry, and there was \$925 in his pocket. The only thing missing was Patrick's girlfriend, her son, and their Mercedes. An investigation tracked Jenny to Los Angeles where she made a withdrawal from an ATM and purchased a plane ticket to Hong Kong. She may be in China, and may be using the names Zhen Yu Liang or Yu Zhen Liang as aliases. She almost always wears white clothing. Jenny Liang is 42, 5'2 and 110 pounds. (See Shows #671, #698 and #748, OADs 4/6/02, 11/23/02 and 1/10/04)

Paul Xavier Stone (Sexual Abuse of a Child) -- Paul "Rocky" Stone has a history of molesting young boys in the Madison, Wisconsin area which dates back to the mid-1960's. His M.O. is to target 12- to 15-year-old boys, usually from single parent homes. Stone befriends them and takes them fishing, skiing and snowboarding. Stone takes Polaroid photos of the boys, clothed at first, claiming he is recording their growth. By the third or fourth meeting with the boys, Stone gives the children LSD and sexually assaults them. Stone has photographed the boys engaged in various sexual acts. Investigations led authorities to Stone's residence in June 1996. Inside they found a box full of Polaroid photos of young boys, semi and fully nude. Police have identified three boys at this point. They believe there are at least 25 unidentified victims in those seized photographs. Stone was charged with two counts of sexual assault and one count of possession with intent to deliver LSD. He was released from custody after a family member posted \$8,000 cash bail. Stone failed to show up for his jury trial on November 18, 1996. He has been a fugitive ever since. Marshals believe he may be molesting other young boys. Stone, who has used the alias Terrill J. Schuette, has a rose tattoo on his upper right arm. He hangs out at parks, and is usually in the company of young boys. Stone is 56, 5'8" and 150 pounds. (See Show #702, OAD 12/28/02)

Joe East (Murder, Weapons Violations, UFAP) -- Tamara Parrish saw college as a chance at a new life - and that meant leaving her old life behind. But one figure from that world, her ex-boyfriend Joe West, allegedly came back to haunt her. Tamara's family says that East started stalking Parrish after she broke up with him. Finally convinced that he would never have

her back, police say, East broke into her home and killed her with three shots - right in front of her family. Police say East is a Jamaican national who was in this country illegally. Wherever he is, they want him caught right now. East, who has used the aliases Delroy Smith, Roy Wilson and Leroy Russel, has a medium complexion and a stocky build. He has no known occupation. East is 40, 5'7" and 200 pounds. (See Shows #430 and #509, OADs 11/23/96 and 8/29/98)

Jennifer Servo Killer (Homicide) -- 22-year-old Jennifer Servo was less than three months into her first full-time job as a TV reporter for the Abilene, Texas NBC station when her colleagues noticed that she was not responding to phone messages at her home. They asked her apartment manager to check on her and that's when she was found dead. Servo had been strangled and had suffered a head trauma. Jennifer was found fully clothes, but an autopsy turned up bruises on her body that indicate she had been sexually assaulted before she was killed. Missing from her apartment was a "Guess" purse with a photo of Anna Nicole Smith on it, three seasons of "Sex In The City" and "Saving Private Ryan" on DVD, and a Kyocera brand cell phone. (See Shows #697 and #723, OADs 11/16/02 and 6/14/03)

CAPTURED:

Kayla Marie LaSala (Murder) -- Cops described 14-year-old murder suspect Kayla Marie LaSala as "cunning" when she escaped from home confinement in Mercer County, West Virginia by cutting off an electronic monitoring device and gluing it onto a cat. But an AMW viewer proved to be smarter. Thanks to a tip to the AMW Hotline, LaSala is back in custody. LaSala is accused of murdering her father in February by stabbing him more than 100 times. Police say they do not know the motive for the vicious attack. She was allowed to stay with an uncle in the area while she awaited her trial, scheduled for September. But police say that on Saturday, July 3rd, she escaped. Kayla's cousin, Derek Metz, originally told detectives that he saw her getting into a dark-colored car with an unidentified African-American man. Derek knew more than he told the police, but he swore to his cousin that he wouldn't rat her out. Several days later, Derek became worried for Kayla when he couldn't reach her by phone. He then learned that AMW had joined the hunt for his cousin and called our hotline. He told the operators that Kayla was with a man from Florida named Troy Gilmore. According to Derek, she was going by the name Tyragha McCala and met Gilmore in an adult chatroom on the internet. Mercer County detectives discovered that Gilmore lived in Altomonte Springs, Florida, just outside Orlando. Officers there tracked him down at his job on Tuesday, July 13th. They say he admitted that LaSala was at his house. When police arrived at the location, they found LaSala playing on a computer. She was arrested without incident.

The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.

Chuan “Charley” Cai (Murder) – Charley Cai is wanted for allegedly killing his girlfriend Xiaoyan “Shirley” Liu in Toronto, Canada. Shirley Liu was last seen at a New Year’s Eve party in the early morning hours of January 1, 2000. A few days later, after failing to reach her, Shirley’s sister became concerned and contacted police. On January 6, 2000 police found Shirley’s body stuffed into a suitcase in the apartment she shared with her boyfriend Charley Cai. Shirley had been suffocated and Cai was nowhere to be found. Cai is a millionaire and he and Liu lived together for six years before coming to Canada last year. Police say Liu was in the process of breaking up with Cai. Cai is originally from China, where he made his money in a computer firm. He may be driving a white 1990 four-door Toyota Camry with Ontario license plate AEDC 129. Cai is 31, 5'10" and 140 pounds. (See Shows #575, #687 and #722, OADs 2/5/00, 8/17/02 and 6/07/03)

Scott Alan Hornick (Escape, Burglary) – Hornick is wanted for a number of con games, burglaries and escape. In 2001 Hornick was locked up at the Warren County Correctional Center in northwest New Jersey for burglary, theft and fraud. On August 6, 2001, Hornick and another inmate, John Strubel, devised a plan to escape from the jail through a hatch in the day area of their cell block. Corrections officials say they pulled it off by picking the lock using a pair of eyeglasses as a tool. They then climbed into a crawl space and knocked out a drainpipe, which led to the second story roof of the jail. Hornick and his accomplice climbed down a ladder and over the perimeter fence where they fled on foot. On August 8, 2002 Hornick and two other men were trying to burglarize a Circuit City in Wayne, New Jersey. Cops responded to the call and the burglars fled in an SUV, leading patrol cars on a high speed chase through northern New Jersey. The SUV crashed and officers caught up with Hornick and his accomplices. Hornick cooperated and gave a statement, but used the alias Jerry Todisco and fled before police could

make a fingerprint match. Police later caught up to Hornick in Mount Laurel, New Jersey, at an extended stay hotel. When cops arrived, Hornick jumped out his second story window and fled in his car. Since then, police have received confirmed sightings of Hornick at bars with gambling in the Easton, Pennsylvania area and in a mall in northern New Jersey. Hornick, whose other aliases include Scott Allen and Charles Hall, dates women to get access to their credit cards, then leaves them. Hornick is 32, 5'11" and 260 pounds. (See Shows #719 and #739, OADs 5/17/03 and 11/01/03)

Anatoliy Valenko (Murder)

Vladimir Balachov (Murder) -- Valenko and Balachov are wanted by the New York City Police Department for the 1995 dismemberment murder of their roommates in a Brooklyn apartment. Police say that on November 12, 1995 the two murdered Fakhat Askarov and Fakhat's girlfriend, Larisa Jakovleva during an argument. Then detectives say Valenko and Balachov purchased a circular saw with the victim's credit card and dismembered the bodies. Police located Fakhat Askarov's head and leg and Jakovleva's leg on Plum Beach in Brooklyn. The torsos were located in a mountain reservation in Essex County, New Jersey. Both men are from the Ukraine and speak very little English. They may be hiding out in a Russian community, possibly in California or New York. Both men place personal ads in Russian newspapers to meet women. Both men have worked as carpenters in construction jobs, as a gas station attendant and as a cashier. Valenko is 32, 5'8" and 150 pounds. Balachov is 33, 5'10" and 150 pounds. Following the initial broadcast, AMW received over 80 tips on the pair. (See Shows #529, #530, #641 and #722, OADs 2/13/99, 2/20/99, 7/21/01 and 6/07/03)

John Patrick Addis (Murder, Kidnapping) -- Addis is wanted for the 1995 kidnapping and murder of his girlfriend in the Nevada desert. On August 19, 1995, police say Joann Albanese disappeared from her residence in Las Vegas along with her boyfriend, John Edwards. Police later determined that Edwards was in fact, John Patrick Addis, a former Alaskan state police homicide investigator. Police say Addis was working as a personal trainer in Las Vegas, when he became involved in a romantic relationship with Joann. On the day she disappeared, Joann, a single mother of two, was scheduled to have dinner with Addis to inform him that the relationship was over. Joann's car was discovered several days later, abandoned in Little Hell's Canyon near Prescott, Arizona. Police say Addis strangled Joann in a fit of rage and hid her body. Police say Addis has a history of traveling around the country finding work in fitness clubs, so he can meet women, romance them, and live off their money. On July 31, 1998, three years after Joann disappeared, a grand jury in Clark County, Nevada charged Addis with her murder and kidnapping. On October 9, 1998, hunters discovered Joann's body. Police determined she had been murdered. Addis, who has used the aliases John H. Edwards and John Elliott, is an avid body-builder who works in gyms as a personal trainer. He is a small plane pilot, outdoorsman and marksman, and is skilled in forensics and criminal investigation. He believes in UFO's and the god RAH, and often claims he's a science fiction writer who writes screenplays on UFO's. His ex-wives say he has a history of domestic violence and fraud, and he has served time in jail for custodial interference. He is adept at manufacturing false identification and Social Security cards. Addis is 53, 6'0"-6'1" and 200 pounds. Harry Carrasquillo (first Degree Murder) – Harry Carrasquillo is on the run from two murder charges. Milwaukee police say he's a drug dealer who settled a territorial dispute by gunning down his rivals on September 1, 1988. Police say Carrasquillo accused another dealer, Carlos Mata, of cutting into his sales. His response was to set up an ambush. On the night of September 1, Mata and another man, Julio Fabian, visited a cellular phone and pager store. As they exited into the parking lot, witnesses saw a burgundy-colored car approach. Three men jumped out of the vehicle and immediately opened fire, killing Mata and Fabian. One witness who later identified Harry Carrasquillo from a photo line up told police that he gazed directly at her as he fired shots into the men. Police rounded up Carrasquillo's accomplices, and they've been convicted. But Carrasquillo has vanished. Carrasquillo uses the alias Harry Garcia and police believe he may be sporting a mustache and goatee. Carrasquillo is 34, 5'8" and 175 pounds.

Shane Matthew Magan (Attempted Murder of a Peace Officer, Armed Robbery) -- Magan is wanted by Riverside and San Bernardino, California authorities for attempted murder of a peace officer and a string of supermarket and convenience store robberies in Southern California. On February 25, 1993 during a suspicious vehicle traffic stop, Magan, who was high on speed, opened fire on a Riverside sheriff's deputy. The officer returned fire, but Magan and his friend, Justin Flint, managed to escape. Minutes later, in nearby San Bernardino County, the two youths robbed a gas station convenience store at gunpoint. Flint surrendered to authorities shortly after the robbery, but Magan remains at large. Magan was spotted in a gang round-up, but authorities at that time did not know Magan was a fugitive from justice. Magan has a noticeable hare lip. He shaves his head, wears black hooded sweatshirts and black caps and fancies himself a Hispanic gangster. He may associate with Pomona's local 12th Street Sharks gang, and may run with a gang of armed graffiti Taggers. He uses amphetamines and speed, and should be considered armed and extremely dangerous. Magan is 27, 5'7" and 145 pounds. The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.

Jason Allen and Lindsay Cutshall Unknown Killer (Murder) -- Jason Allen, 26, and Lindsay Cutshall, 23, were planning a September 11th wedding. The couple met while attending an Appalachian Bible college in West Virginia. After the couple graduated, they returned to Lindsay's hometown of Frenso, Ohio. Lindsay's mother said Jason bought a farmhouse in Frenso in order to be close to her daughter. By all accounts, the young couple had an ideal life. The two were devout Christians, church-going, who spent a lot of their time with Christian youth groups. Family members say the couple wanted to open up an outdoor adventure camp for youths. In the meantime, they spent their summers working as camp counselors. This summer the Jason and Lindsay traveled to the Sierra foothills of California, about 40 miles east of Sacramento, to work as camp counselors at Rock-n-Water, a Christian adventure camp. The couple spent their days with young kids, canoeing, camping, and whitewater rafting. They were scheduled to return home on August 22, but decided to take one more trip along the coast before heading back home. Mysteriously, the couple never made it home or back to work the following Monday. Camp directors at Rock-n-Water reported the two missing when they failed to show up for work on Monday, August 16, 2004. On Wednesday, August 18, Jason and Lindsay were found. Local deputies in helicopters were rescuing a hiker near Fish Head Beach when they spotted two bodies on the beach below. Once investigators made their way down the steep cliffs overlooking the beach, they confirmed that they were the bodies of Jason and Lindsay. Police say both of them had been shot once in the head and were still in their sleeping bags. Investigators canvassed the area and interviewed local citizens, but turned up nothing. Jason and Lindsay's Ford Tempo was found Wednesday parked alongside Highway 1 above the beach. It appears the couple parked their car and made their way down the narrow path to the beach below. Police say Jason and Lindsay camped on the beach in their sleeping bags under the stars, as did many tourists passing through the scenic area. But unlike the hundreds of people that stop

to enjoy the view, Jason and Lindsey became victims of an unknown killer. Sonoma County police continue to investigate the baffling murders. On Tuesday, August 24, a man named Nicholas Edward Scarseth, of Chippewa Falls, Wisconsin, turned himself into authorities. Police had issued an alert that Scarseth was wanted for questioning because he was seen in the area where the murders took place. Police released him on Thursday, August 25, but they did not say if Scarseth provided them with any new information. Scarseth is not considered a suspect at this time.

Lisa Gurrieri and Brandon Rumbaugh Unknown Killer (Murder) -- Lisa Gurrieri, 19, and Brandon Rumbaugh, 20, had been dating a year and, according to family members, were planning on getting married. They had met in a local nightclub and had been together ever since. Family members say they had been living together for about two months. On Friday, October 18, Lisa and Brandon decided to celebrate their one-year anniversary by going camping near Bumble Bee, an area one hour north of Scottsdale, Arizona. Locals say the area is known as Sunset Point and is a popular place for campers to visit. Lisa's mother, Paula, said it was more than just a popular place for her daughter and Brandon - it was where they went on their first date. Friends say the couple planned to park overnight near Bumble Bee road and reminisce about when they first met. It all sounded wonderful. No one thought such an innocent date would turn into a nightmare. But deputies from Yavapai County Sheriff's office say when the couple didn't return to the valley on Saturday, as planned, their friends went to look for them. Police say on Sunday, October 19, 2003, around 3:30 p.m., the couple's friends found them in the back of their truck. Deputies say the couple had been shot several times in the head and were still lying in their sleeping bags. Autopsy reports revealed that there were no drugs or alcohol involved in the murders and there was no sign of a struggle. Police questioned other campers who were less than one hundred yards from where the couple was camping, but police still haven't made any arrests. Lisa was working as a secretary at Salt River Project. She was described by co-workers as someone that would light up a room. Brandon was a student at Mesa Community college and was working as a personal trainer. The night before the murders, two men were seen arguing in the doorway of the apartment building where the couple lives in Scottsdale. Now police are searching for one of the men, described as white, in his 40's and, on Oct 16, 2003, wearing jeans and a white t-shirt. Sonoma County Sheriffs are looking for a car seen in the area where Jason Allen and Lindsay Cutshall were found murdered. The vehicle is described as a dark-colored sedan, 1980's or early 90's model, dirty with a distinctive decal on the back. The windows may have tinting which may be peeling off.

Victor Hugo Nava-Franco (Escape) -- In the early afternoon hours of August 6, 2004, five inmates escaped from the Frio County Jail in Pearsall, Texas. The men crawled underneath two perimeter fences during an hour-long recreational period. Investigators are unsure whether an accomplice met the men outside of the facility, or if they just blended into the neighborhood. Helicopters and search dogs were called in to try to track down the escapees, but had no luck locating them. The escapees include: Victor Nava-Franco, who was originally

arrested for entering the country illegally; Luis Garcia-Esparza, who was awaiting trial on conspiracy to distribute marijuana; Manuel De La Fuente, who was awaiting trial on possession of marijuana and probation violation; Reymundo Flores Alaniz, a convicted murderer, who was awaiting trial for charges of conspiracy to distribute heroin and Jorge Arturo Castaneda-Silva, who was awaiting trial on charges of possession of marijuana. Luis Angel Garcia-Esparza uses the aliases Luis Angel Garcia and Luis Angel Esparza. He is 23, 5'7" and 180 pounds. Reymundo Flores Alaniz uses the aliases Artano Alaniz, Reymaundo F. Alanis and El Artano. He has graying hair and has tattoos on his abdomen, upper left arm, left arm and right arm. Reymundo Flores Alaniz is 47, 5'8" and 190 pounds. Jorge Arturo Castaneda-Silva is 22, 5'6" and 155 pounds. Manuel De La Fuente is also known as Manuel Delafunete. He has tattoos on his on upper right arm and on his chest. Manuel Delafunete is 35, 5'11" and 230 pounds. Victor Hugo Nava-Franco, who is also known as Victor Hugo, Victor Franco and Franco-Nava, has a scar/tattoo on his left hand. Victor Hugo Nava-Franco is 28, 5'6" and 155 pounds.

Sarkis Peltekian (Vehicular Manslaughter, DUI) -- On July 2, 1993 police say Peltekian, driving drunk, lost control of his car and smashed into a pickup truck carrying nine teenagers on their way home from the beach. The truck careened off a concrete overpass, fell 50 feet, and landed in a railroad yard. Seven teenagers died. Two survived with serious injuries. Peltekian was arrested, but released on bail within 48 hours. He immediately moved out of his apartment and disappeared. Sarkis has a scar on his back. He was born in Lebanon and speaks fluent Arabic. He wears fancy clothes, and has worked as an auto mechanic and tire and paint salesman. Investigators initially thought Peltekian might have returned to Lebanon, but they now suspect he is still in the U.S. because his daughter is now living with Peltekian's parents in Corona, California. Peltekian is 42, 5'8" and 200 pounds. (See Shows #455, #603 and #691, OADs 6/21/97, 9/9/00 and 9/14/02)

James "Rick" Johnson (Robbery) -- Johnson was the mastermind behind an attempted robbery at Lamco Jewelers in Alameda, California in April 1997. The attempt failed but the owners, Richard and Wanda Cook, were almost beaten to death in the process. Johnson needed his way into the back rooms of a pool hall in San Francisco, making friends with pool hustler and jeweler Richard Cook. When Johnson found out that Cook kept a safe in his store which allegedly had millions of dollars in cash and jewels. Johnson plotted to rob Cook of his money. Johnson recruited a team of six men. Each man had a specific role in the job. Two men scouted out the store. Posing as customers, they visited the store several times checking out security and the Cooks' routine. Two other men were recruited to subdue the Cooks and secure the location. Another man was lookout and the sixth man was recruited to create an accident with the Cooks' only employee so he would not get to work to interrupt the robbery. Planning for the robbery took over a year. Johnson knew Cook would never give up the safe combination, so he created a scheme to take the entire safe. The team of men retrofitted a U-Haul truck with a heavy-duty winch and enough iron to handle the move. When the time was right, the team went into action, equipped with walkie talkies and a police scanner. Each member of the team meticulously did their part. Halfway through the plan something went wrong. The police scanner said there was a disturbance at the location and they were dispatching a car. The team thought they had been had and called off the heist. But they were wrong; the call was for a dispute next door. The team fled and all but Johnson was captured. Johnson's car was found at the San Francisco airport. He

is known to have an active passport and connections in Europe. Johnson, who has used the nicknames Rick and Romeo, has a small unknown tattoo on his left shoulder. He very healthy and body conscious, likes the beach, and is reputedly a ladies' man. He does not do drugs, but has made money importing and selling drugs. He tends to be quiet and introspective, philosophical about life, feels that he doesn't "fit", and has suicidal tendencies. He likes to take risks, and at one time was a high rise window washer. His father left when he was young, and he may be seeking a father figure or older male mentor. Johnson is 35, 6'2" and 170 pounds. (See Shows #663, #715 and #749, OADs 2/2/02, 4/19/03 and 1/17/04)

UPDATE:

Unknown Jill Behrman Killer (Murder) -- 19-year-old Indiana University freshman Jill Behrman went out on a bike ride on May 31, 2000 at a little after 9:30am. The bike ride was a part of her normal workout routine. She never returned. Jill's classmate saw her about 10 minutes after she left her parents' home. Jill never showed up for work at her campus job that day. When she failed to show up for lunch with her family, the search began. Two days later, Jill's bike was discovered in a farmer's field, miles away from her regular route. Jill's father immediately went to the scene. "It was really strange because that was in an area that was in the opposite part of the county from where she had been riding," Eric Behrman said. "We felt certain that whatever happened her bike would have been hauled up to that area and either pitched or dumped in that spot." The police developed a theory: Jill was riding along, then stopped for a drink of water. At that point, a truck hit Jill. The driver then threw Jill and her bike in the back of the truck, and later discarded the bike in the farmer's field. But there was no sign of Jill, and the search continued without any new developments for nearly two years. Then, investigators suddenly got what seemed to be a huge break in the case. Cops had arrested a woman in another case. But when the subject of Jill's disappearance came up during their questioning, the woman told police an amazing story. She said that she and two other people were driving in a truck, when they hit Jill, killing her. She claims they then threw her body into Salt Creek. Her story followed almost exactly the theory police had developed. Divers were sent into the creek, but the water was so murky they were unable to find anything. The decision was made to drain Salt Creek. It was a tremendous effort, with more than a million gallons of water pumped out. But police found no remains, no clues -- nothing. That's when the suspect who made the confession admitted she was lying. The cops and the Behrman family were back at Square One. Another year passed without any new details. Then, in March, 2003, a hunter was out scouting locations for the upcoming turkey season when he stumbled over some bones in a remote wooded area. He realized to his horror that they were human remains. Dental records soon identified the remains as those of Jill Behrman. After 34 long months, she had at last been found. Police believe a man named Kerry Silvers may have some answers. Silvers is not a suspect in the case, but police believe that while serving time in a county jail, he may have gotten information about Jill's death from another inmate. But Silvers escaped from jail, and hasn't been seen since. Although police want to talk with Silvers, Jill's family believes he's not the only person who could help solve the case.

Kerry Silvers (Wanted for Questioning) -- Police in Indiana are on the hunt for Kerry Silvers, and not just because he escaped from a county jail. Although he is not a suspect in the case, police believe Silvers might hold the key to solve the murder of Jill Behrman, an Indiana

University student. Silvers was serving 61 years in the Orange County Jail on forgery and theft charges. While Silvers was incarcerated, police believe he received information from another inmate that might be important to the Behrman investigation. In April, 2002, jail officials say Silvers overpowered a guard and secured his weapon. He has been on the run ever since. Authorities say he should be considered armed and dangerous. Police believe he has been surviving for the past two years by creating fake checks on the computer, and having an accomplice cash them. He then splits the profits with his accomplice. A story about the murder of Jill Behrman, and the possibility that Kerry Silvers may have information that could help solve the case, has spurred the U.S. Marshals into action. After watching the segment on TV, Jason Wojdylo, the U.S. Marshal's Supervisory Deputy for southern Indiana, pledged to make finding Silvers a top priority. Silvers has a tattoo on his right shoulder of a heart with the name "Marsha," his ex-wife, in it. Has been known to dress like a woman and is computer proficient. Silvers is 30, 6'0" and 210 pounds.

Rigoberto Ramos (Rape) -- Police in Alexandria, Virginia say Rigoberto Ramos and his crony Jose Bonilla went to a local park on Friday, July 2, 2004 and began hunting for a victim. When they spotted a 22-year-old woman walking along a bike path, they went on the attack. According to detectives, Ramos and Bonilla forced the woman at gunpoint into a brushy area, and then raped her. The assault occurred in broad daylight. With the help of the victim, police were able to quickly identify the suspects. A week later, Bonilla was in handcuffs. But Ramos remains at large. Police suspect he has fled the area. Ramos is known on the streets as "Barbita," for his style of beard. But detectives say he may have shaved it off to alter his appearance. He's got a history of weapons violations, and is considered armed and extremely dangerous. Ramos uses the alias Ismael Alberto Murcia and the goes by the nickname "Barbita." He has a tattoo of Jesus on right side of his back, crying eyes and Spanish writing on his chest and praying hands on left side of back Ramos is a native of El Salvador who considers himself a "ladies' man." He is a street hustler who often brokers services from car repairs to prostitutes in Latino neighborhoods. Ramos is 23, 5'8" and 180 pounds.

Chaka Raysor (Murder, Racketeering, Conspiracy, Drug Charges) -- Chaka Raysor is wanted by the Bureau of Alcohol, Tobacco and Firearms and the United States Attorney's Office in the Eastern District of New York for murder, racketeering, and conspiracy to distribute crack cocaine. In 1985, investigators say Raysor and his brother Umeme formed a ruthless drug gang in their Bedford-Stuyvesant neighborhood of Brooklyn. At its peak, agents say the organization raked in over \$90,000 a week dealing crack cocaine in Brooklyn, Maryland, Delaware, and Norfolk, Virginia. The federal indictment also charges Chaka Raysor with a total of nine murders. But agents believe the Raysor organization committed more than forty homicides during their ten-year reign of terror. On the streets of Brooklyn, the gang was known as "The Killers". Agents say Raysor mesmerized his gang members with fiery, Black Panther-style rhetoric, and maintained their loyalty with an iron fist. they say during their reign of terror the ruthless Raysor gang murdered innocent local residents, rival drug dealers, landlords, and a homeless man. On April 27, 1998 Umeme Raysor was convicted of federal racketeering, narcotics conspiracy and murder charges, but his brother Chaka remains at large. Chaka Raysor has used the aliases Charles Herbert Raysor, and the nicknames "Chik", "Chak", and "C". He is usually heavily armed, and is skilled in martial arts. Raysor has a stocky, powerful build, close-

cropped hair and a beard, and a glass left eye with a scar underneath. He is described as ruthless, manipulative, charismatic, and extremely violent. Raysor is 33, 5'10" and 200 pounds. Viewer tips placed Raysor in Williamstown, South Carolina, but authorities were unable to locate him. (See Shows #517, #535, #559, #560, #561, #562, #571, #573, #582, #613 and #725, OADs 11/7/98, 3/27/99, 9/25/99, 10/2/99, 10/9/99, 10/16/99, 1/8/00, 1/22/00, 4/1/00, 12/16/00 and 6/28/03)

Shango Raysor (Wanted for Questioning) -- Shango Raysor is wanted for questioning in a series of armed taxi cab robberies in New York City. Detectives believe that Shango may be traveling with his brother Chaka Raysor, the reputed head of a drug organization who was charged in a federal indictment with crack cocaine distribution in Brooklyn, Maryland, Delaware and Virginia. Agents believe the Raysor organization may have committed more than forty homicides during their ten-year reign of terror. Another Raysor brother, Umeme, was convicted of federal racketeering, narcotics conspiracy and murder charges. Chaka Raysor has been profiled on AMW 11 times since November 1998. Finding Shango may lead to the arrest of his infamous big brother Chaka. Shango Raysor sometimes wears his hair in cornrows. He is 26, 6'1" and 170-180 pounds. (See Shows #613 and #725, OADs 12/16/00 and 6/28/03)

Gregory Allen Moyer (Taking Indecent Liberties with a child, Failure to Appear) -- In 1994, Gregory Allen Moyer was working as a teacher at a private boys' school in Fluvanna County, Virginia. Students at the school began to come forward with allegations of sexual abuse involving him. Moyer was arrested and subsequently convicted on fourteen felony charges of Taking Indecent Liberties with a child. Moyer was sentenced to twenty eight years in prison with twenty four years and six months suspended. He appealed, but was unsuccessful. A court ordered Moyer to appear for sentencing on May 10, 2001, but he never showed. Moyer is an outdoorsman and an avid camper. He is 48, 5'9 and 130 pounds. (See Show #748, OAD 1/10/04) After several years running from the law - it turns out Moyer ran to Mexico. In August 2001, he took a teaching job at Instituto Tecnologico y de Estudios Superiores de Monterrey Campus in Aguascalientes, Mexico. During the school year in 2004, Moyer suggested to his students they look up on the Internet a book he had written, called DISCOVERING THE SPIRIT. It was a non-fiction travel book about a trip he took to the Dakotas with a buddy.

Several students took him up on his suggestion, but when the kids did an Internet search on Moyer, it wasn't his book they found - it was his profile on the America's Most Wanted website, AMW.com. The students did the right thing and contacted both America's Most Wanted and the FBI. On Saturday, April 17, Mexican agents picked him up, and FBI agents brought Moyer back to Houston, Texas. Moyer awaits a hearing on new charges related to his unlawful flight while he serves his original sentence for indecent liberties with a child.

Nashville, Tennessee...TOP COP ROBERT BUTLER...AMW spotlights hero cop Sgt. Robert Butler as he goes on a high-speed chase after a fugitive who uses his hostages as human shields in Nashville, Tennessee. In an action-packed re-enactment, Sgt. Butler is able to subdue the fugitive and rescue the hostages.

Nashville, Tennessee...MARTHA PATLAN AND GENERO DORANTES ... Police say Martha Patlan and her boyfriend, Genero Dorantes are wanted for the murder of Patlan's 4-year-old son, Luis Cisneros. On Sunday, February 23, 2003, police say Luis' body was discovered in a park in Nashville, Tennessee. Doctors and detectives determined that Luis died of blunt force trauma to the head, and had infected burn marks on his body. Police believe Luis was killed Thursday or Friday and dumped in the park on Saturday or Sunday. Police believe Patlan's 8-year-old daughter, Mariana Patlan, and the couple's 15-month-old son, Edgardo Espinosa are traveling with them.

Bloomington, Indiana...JILL BEHRMAN UPDATE... After the recent discovery of Jill Behrman's remains in a remote part of Morgan County, police are now searching for Kerry Silvers who they say is someone that they'd like to talk to. Silvers has served time in the Laurence and Orange County jails. Most recently, he escaped from the Orange County jail in April, 2002 after overpowering a guard and has not been seen since.

Independence, Missouri...SAM AND LINDSEY PORTER MISSING... Police say on June 4th, 2004, Daniel Porter quit his job of twenty years at a plastics factory. He then went to pick up his children, Sam and Lindsey, for a scheduled weekend visit. But police say that when it came time to return the children to their mother, Daniel refused. According to Tina, the children's mother, Daniel began calling her, threatening to kill himself and the children. She immediately reported his violent calls to the Independence Police Department. Familiar with Porter's violent history, investigators did not take these calls lightly. One of the places where police began searching for Porter was Trenton, Missouri, where he grew up. When he was spotted in the area changing a tire, deputies quickly made their arrest. But the children were nowhere in sight.

Riverside, California and Dallas, Texas...RIVERSIDE ARMORED CAR KILLER... The FBI and police departments in Riverside, California and Dallas, Texas are looking for the suspects in three armed robberies, one of which resulted in the murder of an armored car employee. On January 8, 2004, Corey Medlock, a Brink's armored car driver, was shot and killed while delivering cash to a Food-4-Less supermarket in Riverside. The FBI believes the Riverside killer is the same man they are looking for in connection with a caught-on-tape robbery

of another armored car employee in Dallas. On December 8, 2003, a suspect armed with a semi-automatic pistol is clearly seen on video surveillance tape entering the Fiesta grocery store in Dallas. The suspect ordered the driver to remove his glasses, then sprayed him in the face with pepper spray, grabbed the driver's satchel containing an undisclosed amount of cash and exited the rear of the store. On the afternoon of April 19, 2004, police believe the same suspect from Dallas and Riverside struck again in San Antonio, Texas.

Long Beach, California...BORBON BROTHERS...Jaimie Manuel Felix Borbon and Javier Francisco Felix Borbon are wanted by the FBI for the kidnapping and hostage taking of 17-year-old Jorge Osuna Ayon. On June 30, 1993, in Paramount, California, Jorge was abducted at gunpoint by the Borbon brothers and possibly two others. According to the FBI, the Borbon brothers drove Jorge to Tijuana, Mexico, holding him captive for about a month. The kidnapers demanded \$800,000 ransom from Jose Ayon, the victim's father. On July 26, 1993, the kidnapers demanded that a woman bring the money by 5:00pm sharp to the Caliente racetrack in Tijuana. Unfortunately the woman was late and the men shot and killed Jorge.

Sikeston, Missouri...RICHARD YANG...On July 4, 1998, police say Louise Yang left work and headed for home. She unlocked the back door to find her husband, Richard Yang just inside the door with a chef's knife. Police say Yang chased her around the house, eventually into the living room, where she was stabbed to death. Yang waited about 45 minutes before he picked up the phone and called police saying, "I killed my wife."

Central City, Pennsylvania...CENTRAL CITY KIDNAPPER...Police say on September 19, 1999, an unknown suspect abducted a ten-year-old girl off a street in Central City in broad daylight and assaulted her.

Burbank, California...SHARON ANNE SANTOS MISSING...When 30-year-old financial analyst Sharon Anne Santos didn't show up for work on Wednesday, August 18th, her coworkers at Warner Brothers studios knew there was reason for concern. Sharon had not called in, and also failed to show up the next day. Burbank Police were dispatched to her home on Thursday only to find the doors locked and no signs of foul play. However, Sharon had not been seen in more than 48 hours, and her family says she left behind several items that she would normally have taken with her. In fact, the only thing missing was her two-door black 1999 Honda Accord.

Brooklyn, New York...ALFONSO FOWLE AND JAHBIR FOWLE...New York City police are looking for Alfonso Fowle and Jahbir Fowle after police say the two were involved in a drug turf war where eight-year-old Daesean Hill was killed by a stray bullet. The shootout also claimed the life of Michael Warner and occurred only two weeks after the brothers were released from prison. Police describe the Fowle brothers as career criminals whose biggest enterprise is drug distribution and believe they are hiding out in Georgia or Florida.

Branson, Missouri...ED RAIFSNIDER CAPTURE...U.S. Marshals took Ed Raifsnider into custody on August 12, 2004 in Branson, Missouri. The con artist, who stole over \$1.5 million from people across the country, is behind bars thanks in part to a tip from an AMERICA'S MOST WANTED viewer. After purchasing a motorcycle with a counterfeit cashier's check, he re-titled it using an alias. U.S. Marshals used the alias to track Raifsnider to a residence in Branson. Upon leaving his home, agents followed him to a gas station where he was taken into custody along with computers, credit cards, fake IDs, firearms, and cash that were found inside of his car.

Branson, Missouri...LARRY RAIFSNIDER...Police say on October 20, 2003, Larry Raifsnider and an accomplice lured a couple to a local flea market in Branson. Police say Raifsnider told the couple he was interested in buying their fifth wheel trailer that they had advertised in the paper. But when the couple arrived, police say Raifsnider wasn't interested in the trailer, he wanted their cash. According to the couple, Raifsnider and another man shoved guns in their faces, tied them up, and demanded money. Police say the couple had roughly \$100 on them and handed it over. Raifsnider kept pressing them for information about their bank accounts, but came up empty handed. The couple told police that Raifsnider got spooked for some reason and split. The couple managed to break free and called 911. But it wasn't in time to catch Raifsnider or to stop him from tormenting another couple. Police say on December 5, 2003, LJ Dart and his wife were woken up at 2:22 a.m. by a flash of light. When the couple looked up, there were two armed men standing over their bed. Police say one of those men was Raifsnider.

Tempe, Arizona...PAUL EISCHEID...Cops say Paul Eischeid and other members of the Hell's Angels Mesa chapter violently beat and stabbed a woman as punishment for refusing to follow the gang's orders to remain quiet. According to authorities, the Hells Angels gang members viciously attacked the woman, beating and stabbing her to death. Then, after dumping her body in the desert, they continued their fury by taking turns stabbing her, nearly decapitating her. A

passing motorist discovered the corpse and alerted authorities. Cops are looking for Eischeid who was arrested, but bonded out and then disappeared.

Phoenix, Arizona...DOUGLAS WISTROM...The USMS in Phoenix have a current FEDERAL WARRANT out on Douglas Wistrom for his illegal possession of unregistered firearms. Police also say that he's part of the Phoenix Hell's Angel Chapter.

New York, New Jersey, & Washington, D. C....ADNAN EL SHUKRIJUMAH... After naming El Shukrijumah an accomplice in the 9/11 and "dirty bomb" plots, the FBI reveals that they believe that he is involved with the new plot against financial organizations in New York, New Jersey, and Washington, D.C. Not charged with any crime, agents believe he may have pertinent information to the ongoing terror investigation. They believe he knows how to build and detonate a "dirty bomb" and provided terrorist groups with detailed plans of the New York Stock Exchange, which he may have been planning to attack.

Decatur, Illinois...KEVIN NOLEN... While searching the Internet for child pornography, the U.S. Immigration and Customs Enforcement agency started getting hundreds of hits from the same source. The investigators were able to identify the source as Kevin Nolen. Authorities say he's a computer expert who also has a sick fascination with children. When I.C.E. officials searched Nolen's home in July of 2003, they confiscated his computer. That's where they hit the jackpot. They discovered 26,000 pornographic images of children and also traced over 200 postings back to his computer. That was all they needed to obtain a warrant charging Nolen with ten counts of possession and another ten for distribution of child pornography.

Upper Darby, Pennsylvania...DARRYL WILLIAMS...Police are searching for Darryl Williams who they say murdered Jamie Durham and Jawuan Ellis after attempting to rob the two.
