The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.

David Lee Kemp (Murder) – On August 5, 1998 Tina Cremer Kemp divorced her husband of five years, David Kemp. Six days later she was dead, along with her new boyfriend, Robert Miller. The couple was shot in Rob Miller's apartment. Rob was in the kitchen; Tina was in the shower. All evidence pointed towards David Kemp, but before cops could question him he skipped town. Thirteen days later cops found him in Bishop, California. Kemp engaged them in a two-hour stand-off and demanded to talk to his mother. After cops lowered a cell phone behind a fence, Kemp talked to his mother for a bit before he was taken down with non-lethal beanbag shots. He was taken into custody and flown back to Lawton, Oklahoma to face the music in the Comanche County Jail. On March 11, 1999 a jail trustee stole a barbecue fork from the kitchen and pulled it on the one guard on duty that night. He locked the guard in a cell and unlocked several other inmates. Nine inmates escaped. Eight were recovered. The only one still missing is David Kemp. The last official sighting of David Kemp was in June of 1999. He was checked into the Vista Motel and, by all accounts, he was an ideal tenant. He kept to himself and always paid his rent on time. But one day he didn't pay his rent and the night manager came calling. He found Kemp had barricaded himself into the bathroom. The manager knocked down the door and Kemp was lying in the bathtub with a knife on his stomach and covered with blood. It looked like Kemp had tried to kill himself, but when the doctors examined his wounds, they found they were only superficial cuts. He did get out of paying his rent, however. He was last seen getting into his brother's black Firebird at a gas station on the outskirts of Las Vegas. Kemp should be considered armed, dangerous, and extremely unstable. Kemp has used the aliases Ian Melancon and David Glover. He has scars on his wrists from a failed suicide attempt. He always wears a baseball cap, and likes hot rod and matchbox cars. He has been known to work as a janitor, carpenter, and oil rigger. Kemp is 33, 6'3" and 200 pounds. (See Shows #557, #568, #599 and #616, OADs 9/11/99, 12/4/99, 8/12/00 and 1/13/01)

Unknown Ronald Bridges Killer Accomplice (Murder) – On September 16, 2002 at approximately 12:20pm, an unknown black man attempted to rob the Game Proz video game store in Houston, Texas. The robbery had a getaway driver waiting outside the store. The robber

entered the store and disabled the surveillance cameras by spray painting them. The robber then had the clerk fill a bag with money and video games. When police arrived at the scene, the getaway driver fled leaving the robber inside the store. The robber quickly took off on foot, leaving the money and games behind. Police chased the suspect into a nearby residential area but could not find him. The suspect gained access to a home in that community through an open porch door then climbed into the attic to hide. The house belonged to 53-year-old Ronald Bridges, who was home at the time. Ronald was relaxing on his couch when he heard a loud crash coming from a back bedroom sometime between 3:30 and 4:00pm. The man who had been hiding in Ronald's attic fell through the ceiling. When Ronald entered the room to investigate the noise, the intruder attacked and killed him during the subsequent struggle. The killer then took Ronald's truck and fled the area. The truck was found several hours later. The vehicle had been set on fire and destroyed. A composite sketch was created of the killer from witnesses at the robbery. A sketch was also done of the getaway driver from the failed robbery. The suspect has a slim, muscular build, and is described as very athletic. The suspect is in his mid 20's to mid 30's and 6'3"-6'5". The accomplice is described as having a dark complexion and a medium or heavy build. The pair may be traveling in a white 1995 Chevy Caprice with chrome rims and a chrome grille. Richard Lynn Bare (Murder) -- Bare is wanted for the January 15, 1984 murder of Sherry Hart, 24, of West Jefferson, North Carolina. Bare and a friend, Jeffery Burgess, drove Hart to an area known as the Jumping Off Place, a 1,200-foot rock cliff outside of town. There, Bare became enraged when Hart refused his sexual advances. According to Burgess, who is cooperating with investigators, Bare followed Hart into the woods, and when she ran from him, Bare hit her over the head with a gun he was carrying. Bare then threw Hart over the Jumping Off Place to her death. Bare and Burgess were arrested in March 1985 and charged with Hart's murder. But in July 1985, Bare escaped from the Wilkes County, North Carolina jail where he was awaiting trial. Burgess remains free on bond pending his trial. Bare probably has dyed his hair blond and shaved his beard. He is a heavy drinker who prefers Jim Beam whisky. He is a non-skilled, general laborer who hates working, but has had a job as a chicken factory packer. He does not smoke or like being around people who do. He is a hard-rock music fan and considers himself a ladies' man. Bare is 39, 5'7" and 145 pounds. (See Shows #113, #139, #167, #212, #355 and #599, OADs 5/6/90, 11/16/90, 6/14/91, 5/1/92, 3/4/95 and 8/12/00)

Scott Allen Woodring (Murder, Criminal Sexual Content) – Woodring is wanted for the July 7, 2003 murder of Michigan State Trooper Kevin Marshall. On Sunday, July 6, 2003, at around 10:00pm Woodring barricaded himself and his wife in their home when police attempted to serve him with a warrant for soliciting a minor for sex. Michigan state police surrounded the house and a 40-hour standoff began. Several hours into the stalemate Woodring's wife was able to escape the home unharmed. On Monday afternoon, Woodring fired two shots from within the home towards officers outside while they tried to negotiate with him. When those attempted negotiations failed, they entered the house. Once inside, Woodring shot at the SWAT team, killing Marshall and wounding another officer. Police left the house with Woodring still inside. On Tuesday, around 3:45pm, police fired a distractor device into Woodring's house. A short time later Woodring's house caught fire. Once the fire was extinguished, police searched the burnt-out home for any sign of Woodring. There was no one found within the home. A couple of hours later they found a backpack about ¾ of a mile away from Woodring's home, which his

wife identified as his. The backpack contained ammunition and food. Woodring, a self-proclaimed former "Michigan Militia" member and a member of the "Christian Identity Movement", is a white-supremacist and anti-Semite with sexist and homophobic views. He is an avid survivalist who stockpiles weapons and ammunitions. He has been known to travel by hopping freight trains. Woodring is 40, 6'1" and 170 pounds.

Malaika Tamu Griffin (Murder) – Malaika Tamu Griffin is wanted for the murder of 25-year-old Jason Horsely. In the winter/spring of 1999, Griffin was renting a room in a house next door to Jason and his girlfriend, Deborah Loiselle. On April 20, 1999, Deborah had her first encounter with Griffin as the two women were standing in their front yards separated by a fence. Deborah says Griffin, whom she'd never seen nor met before that day, immediately threatened to kill her dogs and began cursing and hurling racial slurs. Jason and Deborah are Caucasian; Griffin is African-American. Over the next 28 days, Griffin had several other run-ins with Jason and Deborah that they say she initiated over parking on the public street and Jason unloading his tools on the public sidewalk in front of her house. None of the arguments made any sense to Jason and Deborah because they insist they never trespassed on her property and the parking spaces should have never been a matter of dispute because Griffin didn't even own a car. Hers had been repossessed. On the evening of May 18, 1999, Jason was organizing his carpentry tools on the sidewalk in front of Griffin's house when she came outside and began screaming at him. Deborah heard the commotion and came out of her house to stick up for Jason. After a brief but intense argument, both women stormed back into their respective homes and Jason continued organizing his tools. Griffin came back outside minutes later armed with a laser-sighted 9mm pistol and shot Jason in the back at point-blank range. He never saw her coming. The bullet pierced Jason's heart and killed him almost instantly. Then, Griffin ran to the home of an acquaintance, Monique Thomas, and carjacked her at gunpoint. Griffin abandoned the car in Iowa and hopped a bus to Chicago where her trail went cold. When police searched Griffin's room in Denver, they were shocked to find a stockpile of ammunition, diffused hand grenades, a 9mm assault rifle and books commonly associated with terrorists, *The Anarchists' Cookbook* and *The Poor Man's James Bond*. They also found spiral notebooks full of Griffin's secret writings about a coming race war and the killing of white people. None of her colleagues or close friends ever heard her express the types of racist rhetoric she wrote about in her notebooks. Griffin is a world-traveled lady with a Magna Cum Laude degree in chemistry. She has worked in laboratories and a pharmacy in the past. Griffin is an avid outdoorswoman and survivalist who buys top of the line camping gear and firearms. She has bad credit and declared bankruptcy in 1999. She doesn't smoke, but may drink occasionally. She prefers going to museums to clubs or other nightlife. She usually carries a backpack wherever she goes. Griffin is 32, 5'4" and 145 pounds. (See Shows #575, #599 and #646, OADs 2/5/00, 8/12/00 and 8/25/01)

William Peter Fischer (Murder) -- Billy Fischer met Nancy Hyer on a Manhattan-bound train and opened up his life to her. Nancy soon found that the polite young man sitting next to her suffered from cystic fibrosis - he had been sick most of his life. During this time, he was abandoned by uncaring parents and left to drift from one foster home and group home to the next. The only caring family Billy had was his brother Jayson, who lived in separate foster homes while they grew up. The brothers saw each other as often as they could, and Jayson would fill Billy in on their absent and unpredictable father, William Peter Fischer. Ten years after he abandoned his two sons to foster homes, Fischer remarried and suddenly took a renewed

interest in the boys. Jayson maintains that this surge of fatherly love was hollow and motivated by a desire to look better in the eyes of his new wife's family. But the Fischer family reunion was short-lived. Jayson says that his father was deep in the throes of a crack habit and that made his behavior erratic and hot-tempered. The boys decided they would be better off on their own. For four years, Billy refused to talk to his father, but on a trip to New York to see Jayson, he learned that Fischer was willing to see him. Billy's health had taken a turn for the worse, and when he arrived at his father's home in Southampton he found a suddenly supportive father. Billy now found a father ready to pay for his medical bills - which had already piled up on Fischer's doorstep - and even ready to buy him a car. But, police say, this was all just a ruse to put Billy off his guard. Nancy, the woman Billy met on the train, was moved by Billy's story and wanted to see him again. She called him at Fischer's Southampton home and arranged to meet him at 8:00 p.m. on December 11, 1986. It turned out to be her date with destiny. Nine days later, police found her body and Billy's in her abandoned car at the Southampton Elks Club. Billy had been shot 18 times, and Nancy had been stripped of her clothing and stabbed in the chest and abdomen. Serving a search warrant on Fischer's home, police say they discovered three bullets lodged in the wall that matched those that had killed Billy. And with the blood-detecting chemical Luminal, they discovered blood traces throughout the house - even in the vacuum cleaner. Fischer, meanwhile, was in the process of getting a second mortgage on his house. When a grand jury indicted him for murder, he had already left with \$60,000 in his pocket. His car was discovered at New York's Kennedy Airport on February 27, 1987. Fischer has a tracheotomy scar on his throat and a receding hairline. He is a fancy dresser and very flirtatious - he reportedly engages in "kinky" sex with multiple partners. He is a heavy drinker, a suspected crack cocaine user, and a smoker. He is a heavy antacid user and may have stomach problems. He has worked as an auto dealer. Fischer is 58, 5'11" and 180-200 pounds. (See Shows #218, #408, #497, #577 and #646, OADs 6/19/92, 5/4/96, 5/30/98, 2/26/00 and 8/25/01)

Dominique Alexander Wright (Murder, Robbery) – On Monday, December 16, 2002, the California Department of Forestry extinguished a burning Nissan Maxima in which the bodies of Christal Langston, 30, and Jared Pulliam, 23, were found bound, naked, and partially burned. Pulliam was involved in a crystal-meth drug transaction with Leron Leon Morris. Police are unsure why, but believe Pulliam was going to Morris to get the drugs from this transaction back. Pulliam asked Langston to accompany him on a ride to a friend's house to "pick up his back pack". Once at that house the victims were held at gunpoint and forced to undress by Morris and Wright. The victims were both bound and beaten before being forced into the trunk of Pulliam's car. The car was then driven out to a remote area where Wright shot each in the head execution-style. The car was subsequently set ablaze. Morris has been arrested for the murders, but Wright continues to elude authorities. Wright is 18, 6'3" and 165 pounds.

Vuthy Woodward Sok (Grand Theft) – On June 7, 2000, Javier Saucedo was working his usual schedule with Vuthy Woodward Sok for an armored truck company. After making twelve stops, Sok told Saucedo he had left a key at an earlier location. The suspect insisted on going back right away and offered to drive the armored truck back to the location. Sok asked Saucedo to go inside and get the key while he caught up on his paperwork. Inside, an employee told Saucedo they had not left the key there. When Saucedo got back into view of the truck, he noticed the messenger door was open and that Sok was outside, which is against company policy. Saucedo then saw that moneybags were thrown on the ground outside the truck, and asked what

Sok was doing. Sok said that he needed money and asked if Saucedo wanted to be a part of it. Fearing for his safety, Saucedo said yes. Then Sok suggested that they shoot up the truck. Saucedo made the excuse that he wanted to go back inside and get the key before they took the money. Sok exited the truck, closing the door behind him, and was dragging off a large plastic bag of money containing \$744,628. Saucedo pulled his weapon and ordered Sok to halt and put his hands up. Sok looked over his shoulder and kept going. Saucedo yelled for someone to call 911, and report that he was being robbed. Sok then got away in a car with two unidentified individuals. Sok is a former LAPD officer who is described as a compulsive gambler. He is very flirtatious with women. Sok is 30, 5'8" and 160 pounds. (See Shows #599 and #646, OADs 8/12/00 and 8/25/01)

The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.

Brian Michael Jones (Rape, Sexual Assault, Kidnapping) – Jones is wanted for the rape and kidnapping of a Las Vegas woman, “Mary”. On August 28, 1999 “Mary’s” car got stuck in the desert sand. She began walking for help when Jones stopped and offered to help her pull her car out. He told her that he had a truck at his house and it would be able to pull her car out of the sand. “Mary” got into Jones’ car and went to his house. Instead of just getting his truck, Jones held “Mary” hostage for 18 hours while he raped and performed sexual acts on her. After 18 hours of abuse, “Mary” was able to escape and run to safety. Jones was arrested on September 2, 1999. He was released on bail in November 1999. Jones checked in weekly with a parole officer while he was awaiting trial. In September 2000, Jones failed to report to his parole officer and hasn’t been seen since. Jones worked in the real estate business. He likes to work in landscaping, is a handyman, collects guns and makes his own bullets. He is known to have driven a 1979 orange/red Stingray Corvette and a 1980’s white Chevy pickup truck. Jones is 46, 5’11” and 180 pounds. (See Show #633, OAD 5/19/01)

Denise Mansfield Killers (Murder) – In June 2002, police found 45-year-old Denise Mansfield dead in the living room of her home in the upscale neighborhood of Lake Arbor in Prince George’s County, Maryland. She had been strangled to death. Mansfield was a former accountant for Arthur Anderson who ran a business from her home refurbishing and selling desktop computers to a select list of customers. She had recently placed classified ads to sell some furniture. Someone posing as a buyer for the computers or for the furniture for sale may have killed Mansfield. On June 22, 2002, the day Denise was murdered, a credit card bill showed that Denise’s card was used at a SunTrust Bank drive-through ATM near her home in Prince George’s County. Investigators looked at the bank’s list of transactions and compared it to the bank’s surveillance video – both have a time stamp. The video appeared to show three women using the ATM machine at the time Denise’s card was used. In March 2003 detectives released their photos to local media and America’s Most Wanted, along with a video still of a possible male witness who was in line behind the women. Hotline operators received a tip from a friend of the three women, indicating their whereabouts. Cops located them in Tucson,

Arizona and quickly arrested them. Upon further study of the surveillance video and the bank's ATM transaction log, investigators noticed a discrepancy. They discovered that there was a three minute difference between the timecode on the videotape and the timecode on the bank's transaction log. When cops accounted for the difference, they realized that the three women could not possibly have used Denise's card. They released the women from custody and re-focused their investigation on the unidentified man in the surveillance video who used the ATM after the women were finished. The man cops originally thought was a witness quickly became their main suspect. Lilly has "Slick" tattooed on his upper right arm. He is slender, with a receding hairline. He is articulate, polite and soft-spoken, a loner who likes to read. He trained at a trade school as a carpenter. He and Mary are rumored to have had a new baby in New York. Lilly is 61, 5'11" and 170 pounds. Dennis LaMonte Hargrove (Murder) – On June 25, 2003, Hargrove, his cousin, and two unidentified men showed up at the apartment of an associate. The associate owed Hargrove thousands of dollars, an alleged drug debt, but the man was not there. Instead, the man's girlfriend, Colette Moss, 23, was there. Hargrove shot and killed her. Another woman, a 14-year-old girl and a 2-year-old toddler were in the apartment. Hargrove fired at all three of them. The other woman was shot at five times, and the toddler was shot in the face. All are hospitalized and recovering. On July 9, 2003, police arrested Brian Hargrove, Dennis' cousin, in Norfolk, Virginia. However, Dennis Hargrove remains on the run. Hargrove, who has used the aliases Chuck Hargrove, Dennis Venable, and Chuckie Venable, has two gold-plated front teeth (a bridge or plate that is removable). He always carries a gun, wears a bulletproof vest, and has associates who help him to change cars. Hargrove is 27, 6'0" and 180 pounds.

Jan Jablonski (Burglary) -- Jablonski is wanted in connection with dozens of robberies that yielded millions of dollars. Because of his association with the self-proclaimed gypsy burglars, Tamara and Barbara Dolinska, police are seeking him in Florida, Missouri, Maryland, Pennsylvania and Tennessee. Jablonski is part of, and may be the head of, a group of traveling burglars who move from city to city. In the past, Jablonski drove the Dolinska sisters in rental cars to the wealthiest neighborhoods. The women would knock on the doors of homes where they believed the residents were no on the premises, and if the owner would answer they would

pose as potential home buyers. Another story that they would often try involved the loss of a family pet. When the owners were not home, Tamara and Barbara Dolinska went to work. The bandits slipped around to the back of the house, broke a window, and climbed inside. The women would then steal cash, jewelry, silver and other small valuable items. They would carry the stolen goods in pillow cases or in an apron hidden beneath their clothes. Jablonski would wait patiently in front of the house in the getaway rental car. After 10 to 15 minutes, the sisters would stroll calmly out of the house, goods in hand. The Dolinska sisters have both been arrested and are currently facing charges related to several dozen of these crimes. Jablonski was seen as recently as 2001 in a wealthy Palm Beach Gardens, Florida community. Once again, he was driving a rental car and trying to sneak in behind a resident's car. This time, however, the passenger was a young woman. Authorities fear he may be up to his old tricks but with a new partner in crime. Jablonski has countless aliases, including John Ottem and Jan Jablowski. He has an olive complexion, tans easily and is often mistaken for a Hispanic male. He speaks with a Polish accent, may have bad hygiene, and may have a mustache. He is balding, likes to drink vodka, and is described as loud and boisterous. Jesse James Hollywood (Murder, Kidnapping) – On August 6, 2000 at approximately 2:30pm 15-year-old Nicholas Sam Markowitz was kidnapped from West Hills, California. He was taken because his brother owed Hollywood and his companions money from a drug deal. Markowitz was taken to the Santa Barbara area where he was held until late in the evening on August 8, 2000. Hollywood and his companions, Ryan Hoyt and Jesse Ruge, walked Markowitz up a trail while a third suspect, Graham Pressley, remained behind at the vehicle. Pressley and Hoyt had been there earlier in the day to dig a grave. Ruge and Hoyt duct-taped Markowitz's hands behind his back and taped his mouth, then put the boy into the grave and shot him in the torso and head. The grave was filled and covered with branches. Hikers found the body on August 12, 2000 and notified officials. Hollywood remains at large. Hollywood, who is known to like guns and expensive cars, may have very short hair. Unknown O.S.U. Arsonist – Fire investigators have ruled that arson was the cause of a fire at 64 East 17th Avenue in Columbus, Ohio on April 13, 2003, near Ohio State University. The house fire killed five college undergrads: OSU students Alan Schlessman, 21, and Kyle Rawlin, 20, and visiting Ohio University students Andrea K. Dennis, 20, Erin m. Demarco, 19, and Christine Wilson, 19. It injured three others. More than fifteen students were inside the three-story brick home when the fire broke out just after 4:00am. The students were residents of the home and several left-over guests from a party the previous night. Firefighters battled the blaze and eventually pulled several students to safety, but were unable to save the five victims. Fire investigators say the blaze was intentionally set with accelerants somewhere on the front porch of the home. Police detectives are investigating the five deaths as homicides.

Jerry Otis Robinson (Aggravated Malicious Wounding, Firearms Charges) – On January 29, 1999 Jerry Robinson invited girlfriend Stacie Breaker over to his apartment in Sandston, Virginia for dinner but as the night progressed they began arguing. When Stacie

attempted to leave, Jerry pulled out a gun and pointed it at her. As she picked up the phone to call police he shot her repeatedly, hitting her in the hand, wrist, and behind her ear. After Jerry stopped shooting he climbed on top of her and began to strangle her. However, Stacie was able to roll away. At that point Jerry ran into his bedroom. When he returned he told Stacie he called 911. Then he grabbed his gun and left the apartment, and has been on the run ever since. Stacie was rushed to the hospital and survived her injuries. Robinson is described as having an obsessive/compulsive personality. He is 30, 5'2" and 130 pounds.

Evelyn Hernandez Killer – On May 1, 2002, Evelyn Hernandez, who was nine months pregnant, took a bus to her bank to make a deposit, then went to a store to buy a new wallet. She spoke with her sister at 9:00pm that evening. It was the last time anyone would talk with her. Her 5-year-old son, Alex, has not been seen since that day as well. Evelyn was reported missing six days later by her ex-boyfriend, Herman Aguilera. Aguilera was the father of Evelyn's unborn child. The two reportedly had argued in the past about support for the baby and their relationship. Aguilera was married and refused to leave his present wife. Police have questioned Aguilera, and while they have not cleared him, they do not call him a suspect in her murder. A week after her disappearance, Evelyn's wallet was found in South San Francisco. Then, on June 24, her badly decomposed body was found near the Bay Bridge. Despite an exhaustive search, police found no trace of Evelyn's unborn baby. There has also been no sign of Alex.

Ann Kibalo (Child Abduction)

Samantha Kibalo (Missing Child) – Three-year-old Samantha Kibalo vanished last February while in the care of her non-custodial mother, Ann Kibalo. Samantha's father, Mike, was granted full custody of Samantha after splitting from Ann. After their split, Mike would take Samantha to Long Island, where Ann lived, whenever Ann requested a visit with her daughter. At the end of their week-long visits, Ann always brought Samantha back home to Rockland County. After the most recent visitation, Ann failed to appear at the designated meeting place, the Ramapo police station in Suffern, New York. This is not Ann's first attempt to kidnap Samantha. Ann also abducted her ten days after her birth, before she and Mike had split up. Ann was permitted to keep Samantha throughout the custody battle, which took almost a year. After that year Mike was given custody of Samantha and Ann was allowed unsupervised visitation. There is currently a felony warrant out for Ann Kibalo for custodial interference. Police recovered Ann's car after Samantha was reported missing, but there was no sign of Ann or Samantha. Police are concerned for Samantha's safety because of Ann's unstable mental condition. While the Rockland police have searched as far as New Hampshire and Illinois, they have received the most credible sightings from Florida. They are specifically focusing on the Boynton Beach area and Palm Beach County. Ann may wear eyeglasses while driving. She is also thought to have a rare red-haired Tibetan Spaniel named Vodka with her. Mike Kibalo says Vodka would be due for immunizations about this time. Evelyn was reported missing six days later by her ex-boyfriend, Herman Aguilera. Aguilera was the father of Evelyn's unborn child. The two reportedly had argued in the past about support for the baby and their relationship. Aguilera was married and refused to leave his present wife. Police have questioned Aguilera, and while they have not cleared him, they do not call him a suspect in her murder. A week after her disappearance, Evelyn's wallet was found in South San Francisco. Then, on June 24, her badly decomposed body was found near the Bay Bridge. Despite an exhaustive search, police found no trace of Evelyn's unborn baby. There has also been no sign of Alex. (See Show #728, OAD 7/26/03)

Stanley Obas (Criminal Homicide, Aggravated Assault, Kidnapping) – In March 1996, 13-year-old Richezza Williams ran away from her home in Long Island, New York. Five months later, her badly decomposed body was found in a cemetery in Easton, Pennsylvania. On July 28, 1996, about two weeks prior to the discovery of the body, three young men tortured and murdered Richezza in the basement of a house three blocks from the cemetery. After the murder, the men placed Richezza's body in a box, carried it to the cemetery and hid the body in a storage vault. Two of the men involved in the murder have been arrested and convicted, but the third man, Stanley Obas, is still on the loose. Obas, who has used the aliases Neil Stevenson and Troy Smith and the nickname "Wildman", has scars on his left arm, left leg and face. He is a member of the Cash Money Boys gang, a known drug user, and considered armed and dangerous. He often wears three rings on his hand. Obas is originally from Haiti. He is 25, 5'10" and 130-180 pounds. (See Shows #631 and #670, OADs 5/5/01 and 3/30/02)

Richard Robert Sanchez (Kidnapping, Rape, Custodial Interference, Tampering With Evidence, Assault, Child Abuse) – Sanchez physically and sexually assaulted his sister-in-law as retribution against his estranged wife. When he realized he would go to jail for his actions, Sanchez abducted his three non-custodial sons and is on the run with them. On August 21, 2000 Sanchez pushed his way into the home of his estranged wife's sister, using a stun gun repeated on her in front of her five-year-old son. He then spent several hours stunning, raping and prodding the victim with a cooking fork in several rooms of the house, all while the child was present. Because of the brutal and repeated nature, Sanchez is charged with eight different counts of criminal sexual penetration. The crime was committed in front of her child, so he is also charged with child abuse, and add that because he confined his sister-in-law with her child, he is also charged with kidnapping. In November 2000, Sanchez turned himself into police. He was indicted and released on a \$200,000 bond. While he waited for trial, he was on release and had to wear an electronic bracelet. On August 12, 2001, Sanchez cut off his bracelet and fled with his three non-custodial sons, Christopher, now 4, Daniel, now 10, and Richard, now 14. There has been no sign of Robert, his sons or his vehicle since that day. Cops fear that he is armed and has been endangering his sons while on the run. Sanchez, who has the letter R tattooed on his left and a little Grim Reaper on his lower left leg, is losing his hair and may now be bald. He always wears a baseball cap, and has a stocky build. He likes to go fishing and play games with his sons, and telephones frequently when he is apart from his children. He has previously worked as a glass installer and may be looking for similar work. He may be driving a white four-door 1991 Ford Taurus with New Mexico plates 270 DMC. He is very persuasive, but cops say he is very dangerous and may be armed. Sanchez is 37, 6'1" and 221 pounds.

David Benjamin Creamer (Child Pornography, Money Laundering, Weapons Charges) – David Creamer is wanted on numerous child pornography charges stemming from a business he ran out of his home in Tucson, Arizona which distributed CD-ROMs involving, among other subjects, child pornography, adult obscenity and bestiality. On June 5, 1997, a 23-count indictment was handed down, charging Creamer and his businesses, Profit Group, CD-Disc Inc., and CD Disc Direct Inc., with distribution of child pornography, transportation of obscene materials and money laundering. Between 1992 and 1995, Creamer's business produced more than 100,000 CD-ROMs in the United States and Denmark for world-wide distribution. A trial date was set for March 10, 1998. On December 17, 1997 he was due to appear for a pre-trial urinalysis test. He never showed and hasn't been seen since. In March of 2000 Creamer was

CAPTURED:

Edward Santana (Murder) – Guiselle Rojas, 39, was returning home from a dance club shortly after 12:00am on June 13, 2002, when she was ambushed on the way into her house by Santana, who dragged her into the grass and stabbed her more than fifty times with a screwdriver. Guiselle met Santana when they were paired up at a salsa class, and often went to clubs to dance with a group of friends. Santana persistently and openly courted Guiselle at these classes and gatherings until she finally decided to go on a date at the encouragement of friends. While on a trip to Las Vegas, Santana and Guiselle got into a physical altercation. Guiselle decided to end the relationship and Santana violently threatened her. Guiselle was very afraid of this new side of Santana and had a restraining order put on him. It was soon after this that Santana lay in wait and killed her. A tipster located Santana at a Los Angeles homeless shelter...where he was giving salsa lessons. People at the shelter told authorities he might be at a local bar; bar patrons knew where Santana lived, and he was picked up less than five minutes after police began surveillance. He gave authorities a full confession. (See Show #723, OAD 6/14/03)

The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.

Pinkney “Chip” Carter (Murder) – On July 24, 2002, Carter entered his ex-girlfriend Elizabeth Reed’s house where she lived with her four children. Reed’s current boyfriend, Glenn Pafford, was also at her house. Carter, who was disgruntled about the breakup of the relationship, fired shots at Glenn, then at Elizabeth. He then turned the gun at Courtney Smith, Elizabeth’s 16-year-old daughter. Elizabeth and Glenn died on the spot, but Courtney was taken to the emergency room where she died two days later. Reed’s 14-year-old son Rick was in a back room and came forward after hearing screams and gunshots, then called 911. On August 5, 2002, border patrol agents in Texas located Carter’s truck in Escobares, Texas. Carter abandoned the vehicle, jumped into the Rio Grande, and swam to Mexico. Mexican soldiers patrolling the border arrested Carter when he arrived on the other side. When the soldiers searched Carter, they found two handguns. Carter was charged with the illegal importation of firearms and was facing up to eight years in prison. Mexican authorities refused to release Carter to Jacksonville detectives, but told them that they would call when Carter was going to be released. Police thought it would be several years before Carter could be brought back to the US. However, just four months later Jacksonville authorities learned that Carter had been released from jail after paying a fine. Carter’s brother traveled to Mexico and gave Carter a motorcycle. Carter drove off on the bike and hasn’t been seen since. Carter may still be riding the motorcycle, a blue and silver 1983 Suzuki. He likes to hunt, enjoys country line dancing and shooting pool. He has worked as a grocery store clerk and may be working as a bartender. Carter is 48, 6’0” and 165 pounds. (See Show #716, OAD 4/26/03)

Donald Charles Kueck (Murder) – Los Angeles County sheriff’s deputy Stephen D. Sorenson, 52, had a beat that covered a sparsely populated, 150-square-mile area on the western fringes of the Mojave Desert, and basically ran a sheriff’s substation out of his home. Many say he operated much like the old-fashioned town sheriff and was on duty 24/7/365, working whenever and wherever needed. Sorenson was working on his day off when he went to check on

a reported trespassing at a property in Llano, California, which is an unincorporated area of Los Angeles County about 40 miles northeast of downtown. A witness reported hearing about a half dozen gunshots and called authorities. Sheriff's deputies responded to the scene near 165th Street East and Avenue T-I and found Sorenson's unoccupied patrol car. They also found bloodstains and other signs of a struggle in and around the patrol car. Sorenson's body was discovered less than a quarter mile away. He was shot in the upper torso, but it was unclear whether he had been able to return fire. Sorenson's 9mm Beretta handgun is missing. Kueck is a resident of Llano who lived near the scene and has a history of resisting arrest. Kueck was originally wanted for questioning as a potential witness but authorities now believe that it was Kueck who shot and killed Deputy Sorenson. Kueck's 1973 yellow and black Dodge Dart was found about 2 ½ miles from the trailer near where Deputy Sorenson's body was discovered. The incident occurred near an old trailer where investigators found chemicals "consistent with manufacturing methamphetamine." Kueck is 52, 6'2" and 180 pounds.

Hector Perez Killers (Murder) – On October 9, 2001, Hector Perez and about eight neighborhood kids, including his brother and sister, met at nearby Maslow Park, a common hang-out for the kids. The group of kids was sitting on the grass when a 1997-1999 purple or black Dodge Neon with tinted windows and chrome wheels slowly rolled into the parking lot, slowed down, then drove away. Suspect #1 was driving. Approximately 20 minutes later, after the group had moved to the bleachers of the nearby baseball diamond, the same car returned. This time, the passenger window was down. Witnesses heard a voice from the car yell "Hey!", then, without any further warning, three shots were fired. Everyone fled, but little Hector was shot in the chest. One of the neighborhood kids tried to administer CPR, but it was too late. Perez died shortly thereafter. Possible motives for this shooting include gang initiation, mistaken identity, or perhaps one of Hector's friends was the intended target. In fact, the neighborhood boy who administered CPR reportedly had a single bullet shot into his home a few weeks after the Perez murder. Police do not know if the two incidents are related. Suspect #1 has long wavy hair. Suspects #2, #3 and #4 are bald. (See Show #662 , OAD 1/26/02)

Unknown New Orleans Armed Robbers – On April 19, 2002 at 3:00am, three masked men robbed the Diamond Jubilee Casino on the eastern side of New Orleans. Their crime was caught on surveillance tape. They were carrying high powered weapons including an AK-47 and a 9 .mm. The backpack one of the men was carrying probably contained extra weapons and ammunition. The three were also wearing body armor. Once inside, they ordered the customers to get on the floor and then they went back to the money room. The suspect toting the AK-47 seems to be the ringleader and was wearing a rubber Bill Clinton mask and camouflage. The suspects saw an armed security guard near the money room and said "Unarm her". When neither of the suspects moved to take her gun, the security guard went to give it to them, but instead of waiting, the suspect with the AK-47 immediately shot her in the stomach. She fell to the ground and they took her gun. They moved her aside to get into the money room and then shot her again in the thigh. Amazingly she survived. Once inside, they demanded the cashier open the safe. They got away with thousands of dollars and took off. On their way out the front door, the suspect with the AK-47 fired several rounds at the floor, just missing a customer. On April 29, 2002 they struck again. They walked into an Auto Zone located several miles from the casino. It was around 8:00am when the three masked men entered, toting a bag of guns and wearing body

armor. Again, their crime was caught on surveillance tape. One customer inside was wearing a two-way radio on his belt. One of the suspects thought he was a cop. The suspect dragged the customer down the aisle to the back of the counter and held a gun to his head until he was convinced the man was not a cop. The suspect with the AK-47 forced the manager at gunpoint into the back office and tried shooting open the safe. They could not open it so they grabbed the store's petty cash and took off again. This time no one was seriously injured. The first suspect used a 9 .mm rifle, wore a white hooded sweatshirt, light pants, a black mask partially covering his face, and white gloves. He is 20-30, 5'8"-6'0" with a heavy build. The second suspect, the probable ringleader, was wearing camouflage pants and shirt. He is 20-30, 5'8"-6'0" with a medium build. The third suspect was wearing a long-sleeved light colored shirt and dark pants, a fishing-type hat, a dark mask covering his face and white gloves. He is 20-30, 5'8"-6'0" with a medium build. (See Show #683, OAD 7/13/02)

Edward Mathis (Murder, Narcotics Violations) -- Four days before Christmas in 1994, 12-year-old Chris Valdez made a discovery that will stay with him for the rest of his life. While he was away at school, someone broke into his home and murdered his mother and stepfather. He couldn't get inside, but he didn't have to. He could already see the blood. It was everywhere. Chris' mother, Millie Espinal, was found in the bedroom belonging to Chris' 4-year-old brother. Millie had been shot in the face nine times while the child cowered in his closet. In the basement was another body - Chris' stepfather, Ari Espinal. He was lying in a pool of blood from 16 gunshot wounds. Police and federal agents soon had a motive and a suspect for the horrific killings. They say that Ari Espinal had been dealing drugs, and had a large store of cash in his home. Word of his riches had fallen on the ears of a man US Marshals call one of the most ruthless outlaws they have ever put on their 15 Most Wanted List: Eddie "Lucky" Mathis. Marshals say that Mathis made a career out of violence as a drug enforcer. Even his associates in the ruthless narcotics underworld, agents claim, were shaken by his stories of pistol-whippings, robberies, and getaways. Mathis is alleged to routinely carry as many as five handguns at once, and he never leaves home without his bulletproof vest. Law enforcement thought they had Mathis when they stormed an apartment in Atlanta, Georgia, but he made his getaway through the back. Now that he has gotten used to life on the run, officials fear that his next victim may be an unsuspecting police officer who stops him for a traffic violation. "Lucky," they say, is unlikely to ever believe his luck has run out. Mathis, who has used the aliases Eddie Whitson and John Whitson, has a chain tattoo around his left biceps. He may have a mustache or goatee. Mathis is an alleged co-leader and enforcer of a crack ring in Long Island, NY. He is believed to have a Tech 9 machine gun with silencer. He is also known to be a cross-dresser. Mathis is 3, 5'9" and 190 pounds. (See Shows #488, #506 and #672, OADs 4/4/98, 8/8/98 and 4/13/02)

Jana Eyster Mystery (Murder) – On the morning of April 26, 1999, firefighters in Columbus, Ohio discovered the body of 25-year-old Jana Eyster. An autopsy later determined that she died after being shot in the head. The fire had been set to cover up the murder. Her car was discovered a block away from her apartment building and had traces of her blood in the trunk. Jane had just moved into the apartment after graduating from Ohio State University. She had recently begun working as a correction's officer at Ohio Medical Corrections Center. A surveillance videotape shot one hour before the fire at a local gas station less than a mile from

Jana's apartment shows a man buying a gas can similar to the one found in the dumpster behind her building. The man in the surveillance photo is a person of interest in the investigation.

Sheldon Alton Daniel (Attempted Murder, Robbery, Kidnapping) – On September 6, 2001, four robbers entered an Office Max store in Plymouth Meeting, Pennsylvania. Sheldon Daniel and Naru Salahudding walked into the store at 8:06pm; Keith Williams and Shameek "Blue" Mayes entered the store at 8:32pm. All four men hid out in the restroom until the store was supposed to be closed. At 9:15pm, the men came out of the restroom yelling and screaming. Two were wearing Halloween masks and two were wearing black shrouds. The store was full of customers because it was "back to school" time and the store's hours had been extended. The fifth member of the gang, a store employee who was their "inside man", was a no show, but the men proceeded with the robbery anyway. They forced the customers, including children, to the front of the store at gunpoint, and had one of them in a headlock. They also tied an employee to a chair with duct tape and left him in an aisle. They forced a second employee to stay in the restroom. Two of the men stayed with the group of customers while the other two escorted the managers to the office. They asked the managers to open the drop safe in the cash room, which held a large quantity of cash. When manager Matt Finch couldn't get the safe open, they made him beg for his life, then shot him in the arm. Manager Paul Rossi couldn't get the safe open either, so they beat him repeatedly with a gun, wounding him in the head. After about eight minutes, the two robbers left with about \$1,600, rejoining their accomplices at the front of the store, then fled. Daniel, who uses the alias Shaheed, is Muslim. He may have facial hair and may be working in a department store. Daniel is 24, 6'2" and 200 pounds. (See Show #665, OAD 2/16/02)

Eugene Anthony Linder (Murder) -- When Eugene "Geno" Linder first came to Las Vegas, he decided it was the town for him. After years of seeking the limelight in Detroit and Los Angeles, he had finally discovered a city where the party never stopped. Police say Linder rented a house he couldn't afford, bought a BMW, and attempted to go into business designing clothes. When that didn't pan out, police say he targeted high-end exotic dancers, more for their money than their physique. But the long Las Vegas nights took their toll on Linder's body, mind, and wallet. Police say he became increasingly violent, and came to their attention in 1996, when he allegedly tried to choke his girlfriend during an argument in front of her house. The charges were dropped. One morning in 1997, Linder woke up, hung-over and burnt-out, and decided to take a long look at himself. He turned on his video camera and began creating his own 12-step program with the ambitious title "My 30 Day Plan for Perfection." He thought that by taping his transformation, he could help others. But police say he stumbled along the way. As the downward spiral of Linder's life grew tighter, he met Devi Ives under unusual circumstances. Linder was visiting a beauty salon to enhance his appearance with inch-long acrylic fingernails, and overheard Devi talking about problems with her Mercedes. He offered to help, and gradually worked his way into this attractive 34-year-old divorced mother's life. Weeks after she started dating Linder, Devi disappeared. Five days later, her body was discovered in the desert. After that, police say they received a tip from a former girlfriend of Linder's who claimed he had confessed the murder to her. Police found signs of a struggle in Devi's bedroom, and concluded that after a fight, Linder had strangled her. "Perfection is inside you," Linder claimed on the tape. "You must let it grow. You must cultivate it and let it spring forth. Believe me, it's growing as we speak."

Police say Linder has missed his chance at becoming a perfect person, but would love to see him become a model prisoner. Linder has used the aliases Geno and Mario. He wears a perfectly-trimmed beard and moustache. He is a flashy, meticulous dresser who wears inch-long acrylic fingernail extensions and makeup. He may work as an exotic male dancer or escort, and used to work for professional boxer Thomas "Hitman" Hearns. He is a flamboyant talker who claims to be in the entertainment business, and has worked in retail and clothing design. Linder is 46, 6'0" and 175 pounds. (See Shows #505, #524 and #583, OADs 8/1/98, 1/9/99 and 4/8/00)

David Zuccolotto (Sexual Assault of a Child, False Imprisonment) – On Wednesday, August 15, 2001, a 13-year-old female victim reported a rape to police. She told detectives that her attacker lived in her neighborhood. They quickly linked Zuccolotto to the crime. The girl told police that she and a friend went to visit a neighbor to play with his new laser toy. After playing with the gadget for a while, the neighbor, Cesar Zuccolotto, and his brother David insisted they go inside the building's basement to play with the toy some more. It was all a ruse to get the girls inside. David Zuccolotto sexually assaulted the 13-year-old girl in the basement. The girl told detectives that when it was over, David threw a \$20 bill at her and told her that if she told anyone, he would kill her. Officers quickly found David and Cesar in Apartment 8 of the building. They were both charged and released on bail. David disappeared and did not return for a scheduled court hearing on August 29, 2001. Cesar showed up for his hearings and has since reached a plea agreement with the District Attorney's office. David Zuccolotto, who has used the alias Sergio Rodriguez, has a scar on his right leg. He is a Mexican national in the US illegally, and speaks fluent Spanish. He was previously employed at McDonalds and at Interlaken Resort, and may be seeking work in fast food restaurants or in maintenance and housekeeping at hotels. Zuccolotto is 22, 5'5" and 150 pounds.

Unknown (murder) -- Mickey Thompson made his name through race cars, both on and off the track. Whether he was drag racing, off-road racing, or smashing another land speed record, Mickey pulled the crowds, eager to see what he would do next. Even with almost five hundred speed records broken, Thompson didn't stop there. His inventions and innovations not only made cars faster, but safer and better protected. With his business moving along smoothly, and his love for his wife Trudy deeper than ever, in 1988 Thompson seemed to be on easy street. But just past six o' clock in the evening on March 16, 1988, Trudy and Mickey were brutally murdered by two gunmen in the driveway of their Bradbury, California home. Two witnesses say that Mickey was shot first, injured, and forced to watch his wife being murdered before his eyes, knowing he was next. The Los Angeles County Sheriff's Detective on the case, Mike Robinson, said that they "were there to do one thing and that was to kill them...." The killers even had bicycles ready to make their escape--a shrewd move in Mickey's gated community, where a car could easily have been boxed in. The ruthlessness of the killers and their apparent deliberate planning both suggest a contract killing, but who would want Mickey dead? Many signs point to Michael Goodwin, Mickey's former business partner, who attempted to swindle the Thompsons, but was stopped in court by Mickey. After a half-million dollar award was made to Mickey, the couple began receiving numerous death threats. Goodwin, who is serving time in federal prison for bank fraud, denies any connection to the murders. Police believe their only hope is to track down the gunmen, and find out who put them onto the Thompsons. Both suspects are described as having a thin muscular build and wearing dark hooded sweatshirts

during the murders. They approximately 32-45, 6'0", and approximately 175 pounds. The killers possibly were seen in the area before the murders in a then-new maroon Volvo station wagon. Following the initial broadcast, a tipster recalled having seen two men loading bicycles into a Ryder truck in a nearby parking lot. Thompson's sister has offered a \$1 million reward for information leading to the capture and conviction of those responsible for the deaths of her brother and sister-in-law. (See Shows #476, #535 and #621, OADs 12/6/97, 3/27/99 and 2/17/01)

The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.

Brigitte Hartwig (DUI Manslaughter & Vehicular Homicide) – On May 8, 2000, Brigitte Hartwig spent the evening eating and drinking with friends. After leaving a restaurant, Hartwig proceeded through an intersection on a red light striking a minivan driven by Gail Schroeder. Schroeder's nine-year-old daughter, Engel Grace, (a passenger in the minivan) was taken to the hospital where she later died as a result of her injuries. Hartwig had a .059 alcohol level and was subsequently arrested and charged with DUI manslaughter and Vehicular Homicide. Hartwig's attorney made arrangements for her to surrender herself but she failed to do so. Hartwig sold her house and fled the area. Several tips have indicated that Hartwig fled to New York and then possibly to Germany or Switzerland. Hartwig is 59, 5'8" and 125 pounds. (See Show #637, OAD 6/16/01)

Craig Michael Pritchert (Armed Bank Robbery) – FBI agents describe Pritchert as a high-living day trader who covers his stock market losses by robbing banks. Pritchert and his long-time girlfriend Nova Esther Guthrie have traveled around the United States like a high-tech version of "Bonnie and Clyde". Pritchert was released from federal prison in Arizona on June 11, 1996 after serving time for a Las Vegas, Nevada bank robbery. After his release, Pritchert lived in Phoenix until August 13, 1997 when agents say he robbed the Norwest Bank in nearby Scottsdale. On August 13, 1999 Pritchert and Guthrie held up the Wells Fargo Bank in Mesa, Arizona. Pritchert plans his robberies meticulously, employing scanners, handcuffs, guns, two-way radios, masks, and well-timed precision to gain access to the bank vault where the large amounts of currency are stored. Pritchert, Guthrie and an unnamed associate are also charged with the armed robbery of the Bank of Southwest in Durango, Colorado on October 31, 1997 in which they allegedly made off with \$50,000 in cash. Pritchert has numerous aliases, including Josh Riggs, Garrett W. Guthrite, John Guthrite, Wil Hicks, Brent Wilson Hicks, Matthew Ryan Pritchard, Michael Craig Pritchert, Michael Craig Pritchard, Michael Craig Pitcher, and Craig Pritchard. He is described as handsome, outgoing, charismatic and intelligent. Like Guthrie, he loves to ski and snowboard and may be hanging around ski resorts. He likes "yuppie-type"

upscale cars such as BMWs, Mercedes, Saabs and Subarus. Pritchert is 40, 6'0", and 185 pounds. (See Shows #565, #581 and #639, OADs 11/13/99, 3/25/00 and 7/7/01)

Nova Esther Guthrie (Armed Bank Robbery) – Guthrie and her boyfriend, Craig Pritchert, robbed the Bank of Southwest in Durango, Colorado on October 31, 1997 and the Wells Fargo Bank in Mesa, Arizona on August 13, 1999. The FBI believes Guthrie and Pritchert have also held up banks throughout the Pacific Northwest and Texas. In March 1999, Guthrie surrendered to the FBI in Denver, Colorado and was released on bond. She moved to Cheyenne, Wyoming to live with relatives and got a job as a waitress. Pritchert remained at large. Agents believe the love-struck couple reunited on the internet. On April 4, 1999 Guthrie drove out of Cheyenne to meet Pritchert and resumed her life on the run with him. Pritchert is an active day trader on the internet. He covers his stock losses by robbing banks. The robberies have all been meticulously planned, employing scanners, handcuffs, guns, two-way radios, masks, and well-timed precision to gain access to the bank vault where the large amounts of currency are stored. Guthrie is believed to have been the getaway driver in the Durango robbery. Guthrie has used several aliases including Nova Hicks, Nova Thomas, and Alex Santini. She is from a white supremacist-religious fundamentalist family background. She studied to be a mortician, and has worked in sales and as a waitress. She loves to ski and snowboard, and may be hanging around ski resorts. Guthrie is 30, 5'4", and 130 pounds. (See Shows #565, #581 and #639, OADs 11/13/99, 3/25/00 and 7/7/01)

Vernon Ray Henry (murder) -- On the outside, Vernon Ray Henry, his wife Connie, and their five children looked like one big happy family. But on the inside, there was something very wrong. Police say Henry is an angry jealous man who's paranoid about outsiders. He worked at home in Athol, Idaho, refused to use banks or credit cards and didn't trust the government. On August 26, 1996, police say Henry exploded. On that day, Vernon Henry's daughter, 18-year-old Heather, went out on a date without her father's consent. Apparently Connie Henry stood up for her daughter, and she and Vernon argued for hours. After Heather returned from her date, around midnight, police say the argument escalated. From his bedroom, 12-year-old Casey Henry heard his mother exclaim, "Don't point that gun at me." Then police say Casey heard three shots. He called 911. When police arrived, Heather and Connie both lay dead. The surviving Henry children were cowering in a back bedroom. Vernon Henry had jumped into the family's maroon Toyota Camry and disappeared. The car is still missing and Henry is charged with two counts of murder. Vernon Henry usually wears a beard. He is a skilled car upholsterer and enjoys tinkering with cars. He is a survivalist who holds anti-government beliefs and doesn't trust banks. Henry is 51, 5'10" and 145 pounds. (See Shows #475, #581 and #639, OADs 11/22/9, 3/25/00 and 7/7/01)

Unknown Amy Quinton Killer (Murder) – Authorities are looking for the man responsible for killing 22-year-old Amy Quinton, a senior at the University of Utah. On August 3, 1999, Amy was at home in her Salt Lake City apartment with her roommate and a friend. Amy was studying for final exams. Just after midnight a black male entered the ground-floor dwelling through an unlocked sliding-glass door. Amy's roommate was the first to spot the intruder when she went to the kitchen to get a soda. A struggle ensued, and when she cried out for help, Amy reached for the phone and dialed 911. Just as the connection was made, the intruder grabbed the phone from Amy and hung it up. Moments later when 911 called back,

police believe the intruder himself answered the phone and told them everything was OK. As part of routine procedure, police dispatched an officer out to the apartment to check on the situation. As the officer was on the way, the intruder demanded the girls' wallets and money. Before leaving the apartment, the man stabbed Amy's roommate in the stomach, then stabbed Amy once, fatally, in the heart. Less than an hour after the murder, the killer used one of the girls' debit cards to buy gas at a station outside Salt Lake City. Hours later, the killer used the card again to buy gas at a station in Steamboat Springs, Colorado. That's where his trail goes cold. The suspect has short hair and may have a mustache. He has a lean, muscular build and was wearing a dark shirt and dark slacks. He is described as well-dressed and well-spoken. He may also have cuts on his hands from the crime. The suspect is in his mid-20's, 5'8", and 160-170 pounds. (See Show #581, OAD 3/25/00)

Phokham Keomenivong (murder) -- Midvale, Utah is a quiet Mormon suburb on the outskirts of Salt Lake City. Unexpectedly, it's home to a violent street gang called the Oriental Posse. Police say it's made of Laotian teenagers who emulate the notorious and brutal street gangs of South Central Los Angeles. Officers say 17-year-old Nick Dirkson didn't know how deadly serious the gang was. When he believed that Oriental Posse members had stolen a CD player from his car, he confronted them. On November 18, 1995 gang members showed up at the fast food restaurant where Nick and his wife Nichole both worked. They called Nick out to the parking lot. Police say 18-year-old Phokham Keomenivong thought Nick would back down, but Nick stood his ground: he wanted his CD player back. From inside the restaurant, Nichole watched in horror as Nick was gunned down in cold blood. She rushed to her husband's side, but there was nothing she could do to save his life. Nichole was pregnant with the couple's third child. Police say the trigger man was Phokham Keomenivong. He fled Midvale after the murder and has been on the run ever since. Keomenivong, who uses the aliases Noi, Dough Boy, D-Boy, and Do, has several tattoos on his upper right arm and left hand. He is a Laotian national with a large build and a chubby face. He is a smoker and wears loose baggy, gang-style clothing. Keomenivong is 24, 5'10" and 200 pounds. (See Shows #458, #475, #495 and #629, OADs 7/19/9, 11/22/97, 5/16/98 and 4/14/01)

Unknown Richard DeVecchi Killer (Vehicular Homicide) – On the morning of December 17, 1998, Richard De Vecchi was working at his family business, the Berkeley Warehouse in West Berkeley, California. Just after 7:00am, an employee of the warehouse reported that he had seen a man rummaging through Mr. DeVecchi's pick-up truck, which was located across a parking lot. When Mr. DeVecchi and the employee went to investigate they noticed that the suspect had gotten into another vehicle and was now driving slowly in their direction. When the vehicle was within a few feet of Mr. DeVecchi, the suspect accelerated the car and hit DeVecchi. 37-year-old Richard DeVecchi survived on life support for three days until he passed away. Police know little about the killer other than he was driving a mid-70's to early 80's model Cadillac that was light in color with a black top. The license plate may contain the letters C, U and S. The suspect was wearing blue mechanic's overalls at the time of the crime. The suspect is 20-35 years old, 5'11", and 185 pounds. (See Show #581, OAD 3/25/00)

Karl Joseph Muench (Rape) – On December 31, 1999 Karl Muench held a "sober party" for members of his Alcoholics Anonymous group. A 19-year-old woman was one of the guests who attended. She missed her ride home, so Muench offered the woman his bedroom for

the night while he slept on the couch. But when she went to bed, Muench made sexual advances. The woman tried to push him away but he forced himself on her and raped her. Muench told her, "You remind me of my daughters. You're like my little girls." Muench was indicted for rape in the 1st degree. He failed to appear for court in February 2000. Muench left behind a note leaving his possessions to a local woman friend of his. No one has seen him since. Muench has prior convictions including a 1996 DWI, 1988 sexual abuse, and another sexual abuse charge of young girls in 1999. He may be in Florida or North Carolina. Muench is an avid fisherman who has worked as a construction supervisor. He wears reading glasses and has a faded tattoo of a snake on his left wrist. Muench is 47, 5'8" and 155 pounds.

Michel Barrera (Attempted Murder, Armed Burglary) -- Barrera is wanted by the FBI for the 1998 armed robbery of two Miami banks, carjacking a Miami man, and the attempted murder of a Metro-Dade police officer during his getaway. Agents say on February 3, 1998, Michel Barrera and his accomplice robbed the Terra Bank in Miami, Florida, of approximately \$19,000. Then, on May 1, 1998 around 1:00pm they robbed the Republic National Bank in Miami at gunpoint. Following the robbery, the two men fled the bank and a high-speed chase ensued with Metro-Dade police officers. During the chase, cops say the two suspects fired on pursuing officers, then carjacked and severely injured a Miami civilian before ditching his car in a canal. Search teams combed the heavily foliated area near the canal and were able to find and arrest Barrera's accomplice, but Michel Barrera was nowhere to be found. Barrera, a Cuban immigrant, comes across as a sweet, nice young boy. However, he is a known gang member who may try to recruit other teenagers to commit crimes and may be hanging out with "punk" teenagers on the street. He has used the aliases Michael Barrera, Rene Caso, and Christopher Montefu. He has a burn scar on his left shoulder and "Maria" tattooed on his upper right rear shoulder, although he may have tattooed over this and grown his hair longer to change his appearance. He is always armed and has been known to impersonate a cop in home-invasion robberies. Barrera is a known drug user and loves to drink Malt liquor. He enjoys playing paintball, and frequents shooting ranges. Michel Barrera is 23, 5'8" and 145 pounds. (See Shows #519, #539 #561, #608, #611 and #639, OADs 11/21/98, 4/24/99, 10/9/99, 10/14/00, 11/18/00 and 7/7/01)

Ray Guidry Killer – The Terrebonne Parish Sheriff's office is looking for information regarding the 1987 murder of Ray Guidry, a wealthy cattle rancher and oil man in Bayou Blue, Louisiana. On October 12, 1987, the body of 78-year-old Ray Guidry was discovered in his bedroom at the Guidry Ranch. He had been beaten on the head and stabbed multiple times in the chest and the neck. The approximate time of death was estimated by the coroner between 1:00am and 7:00am. The apparent murder weapon, a steak knife, was found in the kitchen sink. There were no signs of forced entry and no other physical evidence found. Ray Guidry was the wealthiest man in Bayou Blue, but certainly not the most popular. He was ruthless when it came to business dealings and had little use for personal relationships. He was openly contemptuous of his adopted son, Vernon, who he severely beat all through Vernon's childhood. Ray's adopted daughter Tina, However, was treated like a princess, even during her adult years. Ray Guidry was known to be quite a ladies man. He was married four times, and entertained literally hundreds of women at his ranch – some of them married, a lot barely out of their teens. After Ray's murder, police discovered a secret cache of thousands of X-rated pictures of Ray's woman and a Pandora's box of sex toys. Despite a six-month investigation, a grand jury failed to indict anyone for the murder of Ray Guidry. America's Most Wanted entered the case in June 2000, enlisting the aid of two retired detectives: Ron Antoci of the NYPD and Joe Matthews of the Miami Beach PD.
