The following are the featured fugitives and others being sought by federal, state or local authorities. The <u>Update</u> (if any) gives current status, previous references, or related information.

Antonio Delacruz, Jr. (Murder) - The Harris County Sheriff's Office is searching for Antonio Delacruz. On August 31, 1998, Jose Garcia and Antonio Delacruz went to rob a house in Houston, Texas. The two men knew the owner of the house, Nicholas Acosta. Acosta was involved in drugs and had recently started dating Delacruz's ex-girlfriend. The robbery turned into violent murder. Garcia and Delacruz stabbed Acosta 17 times. Then Delacruz began beating Acosta over the head with a barbell. The scene was so frightening that Garcia fled, leaving Delacruz at the house. Garcia arrived back at his mother's house where Mrs. Garcia immediately called the police after she saw the bloody mess. Delacruz was on the way back to Garcia's when he heard that police were on the way. Delacruz decided he needed to burn all of the evidence. He fled to burn his truck, but police caught up with him. They put out the truck fire, as well as Delacruz who was also on fire. Jose Garcia was arrested and is currently in Harris County jail. Delacruz was charged with murder on August 31, 1998. A \$100,000 bond was set for his bail. On October 28, 1998, Delacruz was charged with bond forfeiture. Delacruz's father owns a bail bonding business and contacted people in his business to help his son. Delacruz's wealthy family, especially his mother's side, may be hiding him. Delacruz's mother, maiden name Flores, is an associate president of a bank in Texas. He was last seen at a strip club in February 1999. Delacruz is 27, 5'7"-5'9" and 165-175 pounds. (See Shows #622 and #670, OADs 2/24/01 and 3/30/02)

Dalton Mesarchik Killer (Murder) – On March 26, 2003 7-year-old Dalton Mesarchik was waiting for a church van to pick him up outside his home. When the van never shoed up, Dalton's mother went looking for him and discovered he had disappeared. A frantic search began and an Amber Alert was issued immediately. The next day Dalton's body was discovered in the Vermillion River just seven miles from his home by a local fisherman. Police say he was murdered and they have no suspects.

Mustapha Mohamed Atat (Murder, Drug Charges) – Atat was driving in a street race that resulted in a fatal accident. He has been charged with second degree murder. On October 8,

2001, Atat and Aaron Reynolds, 34, were street racing at speeds of more than 100 mph in a 35 mph zone. The two were both driving modified Mustangs and had bet \$12,000 on the race's outcome. Reynolds' car went out of control, crossed a sidewalk and struck three people. The accident killed Denise Jones, 35, and injured Eric Draw, 35, and Rodney Ricks, 32. Atat and Reynolds were charged with second degree murder, failure to stop at the scene of a serious personal injury accident, and two counts of felonious driving and drag racing. During a raid at Atat's residence, police were surprised to find that although Atat received welfare, he owned a large home and several luxury cars. Police attribute this discrepancy to drug dealing after finding several illegal substances on the premises. Atat has failed to appear in court and may have fled the country. Atat has a large scar on his right cheek under his eye and speaks with a Middle Eastern accent. He is 31, 5'7" and 150 pounds.

Alan William Golder (Kidnapping, Robbery, Burglary, Larceny) -- If you discovered Alan Golder in your house, you might think he had stepped out of the pages of GQ Magazine. In reality, he recently stepped out of prison, and officers hope he will be returning soon. After his feature aired on AMW, a man came forward who may be able to help - the suspect's own brother. Golder's younger brother came forward after seeing Golder's profile on AMW, a profile that filled him with concern. He says that Golder is a danger to himself and others because he simply can't stop committing crimes - he is a jewel addict, the brother claims. The only happy end to this story, the brother told AMW, would be if Golder turned himself in. Well-tanned and well-toned, Golder has made quite a name for himself, allegedly ripping off homes of the rich and famous while mixing comfortably with the rock stars and executives of the Sunset Strip crowd in Los Angeles. He even had an author interview him for a biography as he served time in prison for murder. But since he was paroled, he has, officials say, returned to what he knows best burglary. In 1978 Golder allegedly used two accomplices - Boonlert Thanarakol and Surajit Sae Sow - to rob a home in Old Brookville, New York. The robbery left the homeowner dead, and a trail of evidence led directly to Golder, who was convicted and sentenced to 15 years to life. Paroled in 1996 after 16 years behind bars, Golder told his parole officer that he wanted to be a jeweler, bartender, or a fitness trainer, but no one would hire him. Before long, police say, he was underground again, and back at work. Golder is now wanted for over 70 robberies in New England that have allegedly netted him more than a million dollars in cash and jewels. Described as slick, fearless, and cunning, Golder reportedly only strikes when residents are home and alarms are off. While the unsuspecting victims are away from the bedroom, police say he climbs their outside walls with the agility of a chimp, enters the bedroom, loads up with valuables, and escapes undetected. After a string of robberies in Greenwich, Connecticut were reported nationwide, other police agencies came forward with similar crimes. But by then, Golder had apparently slipped away to celebrate his own cunning. Police nationwide are on the lookout for Golder, but they aren't the only ones. Apparently, Golder ratted out some of his organized crime connections when he was taken down for the Old Brookville murder to get a reduced sentence, and they'd like a piece of him as well. But even with all this attention, officials believe that Golder is probably cocky enough to be hiding in broad daylight. He apparently loves the way he looks, and spends a great deal of time in Gold's Gyms and tanning salons. At night, he frequents nightclubs, strip bars, and high-profile parties. He has allegedly convinced himself that crime pays, and it will be up to the police and concerned citizens to prove him wrong. Golder has used the aliases Alan William Kulp and Thomas A. Williamson. He may have "Alan" tattooed between his knuckles. He has a large scar on his right biceps from tattoo removal. He allegedly uses girlfriends as

getaway drivers. Golder is a bodybuilder who has worked as a personal trainer and has been a member of Gold's Gym. He frequently changes identity, may have had plastic surgery and may wear a goatee. Golder is 47, 5'9"-5'11" and 175 pounds. (See Shows #487, #491, #524, #535 and #606, OADs 3/28/98, 4/25/98, 1/9/99, 3/27/99 and 9/30/00)

Brian Martin (Murder) - On November 1, 2001, Martin stabbed his father to death. Martin was raised in an exceedingly religiously strict home. Both his brother and sister had left the home at age 16 due to inability to cope with the restrictions imposed by their father and stepmother. He did not have many friends and was described as a loner. Martin had exhibited behavioral problems and his parents enrolled him in a "boot camp" to help deal with this. Martin was not allowed to participate in any extracurricular activities after school hours. He had enrolled in the ROTC program at his high school and was told earlier in the week of the murder that he would not be allowed to attend an ROTC dinner. His instructor had sent a note home to the parents telling them how important this was, but they still did not give Martin permission to attend. On November 1, 2001, Martin acted as if he was going to school, but actually hid behind the garage. He stabbed his father, David Martin, to death on the front lawn of their house and then left on foot. David Martin died on the way to the hospital. Martin's step-mother believes that he had intended to kill her as well. Martin may be heading for Buffalo, New York where his sister and uncle live. Correspondence between Martin and his sister had ceased in 2000, but she and their uncle had wanted to come get Brian from California and take him to live with them in New York. Marin is a perfectionist with obsessive compulsive tendencies. He may have teenage acne. Because he has lived in California for a year, his hair may be lighter and he may have a tan. Martin is 17, 5'6" and 130 pounds. (See Shows #665 and #669, OADs 2/16/02 and 3/23/02)

Jaime Manuel Felix Borbon (Kidnapping, Homicide)

Javier Francisco Felix Borbon (Kidnapping, Homicide) - The Borbons are wanted by the FBI for the kidnapping and hostage taking of 17-year-old Jorge Osuna Ayon. On June 30, 1993, in Paramount, California, Ayon was abducted at gunpoint by the Borbons and possibly two others. The Borbons drove Ayon to Tijuana, Mexico, holding him captive for about a month. Numerous phone calls were made to the victim's father, during which the kidnappers demanded \$800,000 ransom. The FBI believes that the kidnapping was related to a past drug debt owed by Jose Ayon, the victim's father. Jose Ayon denies any involvement with drugs. Negotiations between Jose Ayon and the kidnappers became hostile and quickly deteriorated beyond FBI control with the suspects insisted on making the drop-off site in Tijuana. On July 26, 1993, the kidnappers demanded that a woman bring the money in a yellow cab at 5:00pm sharp. The drop was to be made at the Caliente race track in Tijuana. Unfortunately, the woman was late. The men got angry and killed Ayon, shooting him 16 times in a Tijuana field. Jorge Arturo Amariallas and Rigoberto Lopez Sotelo are in custody in Mexico as co-conspirators to the crime. Jaime Borbon, who goes by the nickname "El Chivo" (the goat), dresses like a cowboy and enjoys listening to country music in Spanish. He speaks fluent English and Spanish. He may be traveling with his wife and young daughter. Jaime Borbon is 34, 5'7" and 190 pounds. Javier Bourbon, whose nickname is "El Flaco" (skinny), is a member of the Sinaloa Cowboy gang and is known to be armed and extremely dangerous. Like his brother, he dresses like a cowboy and is fluent in both English and Spanish. Javier Borbon is 37, 5'9" and 175 pounds. (See Show #679, OAD 6/8/02)

Jerry Vernon (Escape) – Jerry Vernon escaped from the Central New Mexico Correctional Facility in Los Lunas, NM on Thursday, March 29, 2001. Vernon was staying in the hospital ward of the facility's geriatric unit when he escaped through two security fences by removing the bolts. Vernon's daughter Renee smuggled in a cell phone on one of her prison visits with her father. Vernon used the cell phone to arrange a getaway driver. Lori Vernon, another daughter acquired a vehicle to be used as the getaway car. Police arrested Renee and Lori Vernon and charged them with conspiracy and aiding their fathers escape. Chris Sparks, the getaway driver, was also arrested and charged with conspiracy and aiding the escape. Jerry Vernon was serving a life sentence for the 1989 murder of Larry Steven. Vernon is a golf fanatic who was employed as a real-estate investor. He has a heart condition that requires him to take nitroglycerin. Vernon is 66, 6'4" and 280 pounds. (See Shows #636 and #668, OADs 6/9/01 and 3/16/02)

Alvin Scott (Murder) - Scott and Lillia Ivanova had been involved in divorce proceedings since May 2001. They had been married for more than ten years. Even though Scott moved out of the apartment they shared, friends say Lillia complained he was stalking her. On August 3, 2001 Lillia and her friend, Elie Abi-Saab, left Elie's apartment building around 11:30pm. Scott was waiting for them and opened fire with a handgun. The women ran back inside the building and tried to escape but Scott followed and kept shooting. Lillia and Elie were both fatally shot three times each. Scott then drove to a friend's house in Marietta, Georgia and stayed there for the night. The friend, who knew nothing of the crime, lent Scott a car. The next day Scott fled Atlanta with the friend's car. He dumped it approximately 45 minutes north of Atlanta and somehow made his way to Philadelphia. He rented a car in Philadelphia, and that car has yet to be found. Scott has also been tracked to Jamaica, New York, but he may be trying to leave the country. When authorities searched Scott's apartment in Atlanta, they discovered his gun cabinet was empty and they believe he may have taken the weapons with him. Scott, who has used the alias Ahmet Sehsuvar, was born in Turkey and speaks English, Turkish and Bulgarian. He has a military background, has studied to be a private investigator, and is rumored to have been a spy. He is described as intelligent and well-educated, a world traveler, and is a practicing Muslim. He may be driving a red Kia Sephia. He is a heavy smoker, is well-trained in martial arts and with firearms. He also carries multiple passports. Scott is 52, 6'0" and 170 pounds. (See Show #647, OAD 9/1/01)

Jose Emilio Rodriquez (Child Molestation, Wanted for Questioning for Murder) – 13-year-old Laura Newman was found murdered at 3:30am on New Years Day, 1985. Laura was babysitting for her neighbors' three children while they went to a New Years Eve celebration. When the parents returned home, they found Laura dead on the couch, covered with a blanket. The three children were not harmed. There were no signs of forced entry, leading investigators to believe Laura knew the suspect. Laura was sexually assaulted and stabbed to death. The following evening, another 13-year-old girl was molested. Jose Emilio Rodriquez was charged with the molestation of the 13-year-old girl. Rodriquez lived in the same apartment complex as Laura. He has also been arrested in Arizona for using and selling drugs. Rodriquez has tattoos on both his arms and shoulders. He has lost partial use of his left arm. Rodriquez is 47, 5'5" and 135 pounds.

CAPTURED:

Larme Price, aka "The Sunrise Killer" - For eight weeks, a mysterious gunman has struck terror throughout the merchant community in Queens and Brooklyn. Between February 8th, and March 20th, an attacker shot four shopkeepers to death and left a fifth critically wounded. The case was featured on AMERICA'S MOST WANTED: AMERICA FIGHTS BACK three times in March. New York City Police Commissioner, Raymond Kelly announced yesterday that the shadowy suspect's reign of terror is finally over. On Saturday, March 29th, detectives from the joint task force assigned to the case arrested Larme "Lokee" Price, 30, without incident at his residence in the Crown Heights section of Brooklyn. Price had walked into the 77th precinct in Brooklyn on the day before (Friday) to offer detectives information on the serial killer's alleged accomplice in one of the murder cases. His arrest was not a result of being profiled on AMERICA'S MOST WANTED. The killing spree began at 6:45 on the morning of February 8th when two men entered the Central Mini Market in Ozone Park, Oueens. One of the men shot customer John Freddy, age 43, point blank in the back of the head. Then the gunman opened fire on the store clerk. The clerk managed to dodge a hail of bullets and flee the store unharmed. The crime was captured on surveillance tape and appeared to investigators at first, to be a violent, but unsuccessful armed robbery. The shooter's accomplice wore a distinctive DKNY athletic jacket. Less than two hours later, the shooter and his accomplice surfaced in Brooklyn and gunned down another merchant, fifty-year-old Sukhjit Khajala. Sukhjit was shot three times in the head. One hundred sixty dollars was taken during the commission of that homicide. On March 10th, after a three-week lull, the shooter reappeared in Brooklyn at the Laundry King Laundromat in the Crown Heights neighborhood. It was 6:00 a.m. when the store's surveillance cameras recorded a man entering the Laundromat. The man sat down at a table, drank a cup of coffee and watched television for ten minutes. Minutes later, the suspect walked up to the attendant on duty, thirty-two-year-old Albert Kotlyar and shot him point-blank in the face. Albert was killed instantly. The killer made no effort to rob the store. Instead, the suspect calmly walked out of the Laundromat and vanished. The cold-blooded execution was graphically caught on tape. The Laundry King murder led to the formation of a task force of detectives from Brooklyn and Queens; an elite group of veteran investigators culled from the various precincts where the murders had occurred in the two sprawling boroughs. Although the task force had numerous surveillance tapes with the suspects' image and clothing visible, none provided a crystal clear look at his face. Then, on Thursday March 10th, the killer struck again. That morning, he walked into the Stop II Bodega and gunned down Abdo Nasser Ali, 54, and Yakoob Aldailam, 33. Abdo, a father of eleven, was killed instantly by a gunshot to the head. Yakoob was shot four times in the body, but survived. Police still had no solid leads on a suspect. Then, the case took a stunning and unexpected turn. On Friday March 28th, a man with a lengthy criminal history named Larme Price walked into the 77th precinct and asked to speak to a detective. Price proceeded to offer police information on the accomplice who was with the shooter (the man in the DKNY jacket) during the commission of the first murder eight weeks prior. After lengthy discussions with Price, detectives allowed him to go home, but kept him under surveillance. The following afternoon, they convinced Price to accompany them back to the precinct to delve deeper into their query with him about the murders. Detectives say Price provided a volume of details only the killer could have known about the crimes. Finally, wanting to unburden his conscience, Price told the police that he had in fact killed all four of the victims himself. Then he led them to one of the murder weapons he'd used in the bloody killing

spree. Why did he do it? Price, whose mother says he has a history of bizarre behavior, told detectives that he "heard voices" and killed merchants who had "bad vibes" in their stores. He said he was finally prompted to stop killing and turn himself in after reading the bible passage, "Thou shalt not kill." (See Shows #710, #711 and #712, OADs 3/15/03, 3/22/03 and 3/29/03)

Annette Hernandez (Murder, Robbery, Escape) - California Department of Corrections is searching for a female fugitive who escaped from the California Institute for Women in Frontera, California. She's been on the run for more than 30 years, since her escape on May 1, 1972. She was serving a sentence for murder and robbery. On December 17, 1970, Steve Smith, a husband and father of two young children, was out Christmas shopping with his friend, Dave McAlhinney, in San Bernardino, California. Afterwards, they stopped by a party that acquaintances, Annette and Art Hernandez, were throwing. When they arrived, Annette answered the door and let Steve and David inside. Once in the house, they found Art tied up with duct tape and two gunmen, Gerald Schnabel and Charles Hill. The gunmen demanded money and pointed their guns at Dave and Steve's head. Dave got on the ground while Steve struggled with the gunmen. The gun went off and Steve was fatally wounded with a gunshot to his neck. The gunmen fled, while Annette and Art helped Dave carry Steve to his VW van. They rushed him to the hospital. Before all four got to the hospital, Annette ordered Dave to stop the van and she got out because she had an outstanding parole violation. At the hospital Steve was pronounced dead. Dave told detectives he thought the robbery-murder was a set up. Later, all four involved were convicted. Annette was sentenced to five years to life for second degree murder and first degree robbery. Annette Hernandez was assigned to the California Institute for Women on March 10, 1972. A few months later, on May 1, 1972, Hernandez and inmate Susan Sutcliffe escaped by crawling through a damaged fence. Sutcliffe, also convicted of murder, was captured in 1976, but Annette escaped. Following the most recent broadcast, Annette's son-in-law phoned from Paramount, California, who informed authorities that Hernandez had died. She had committed suicide by overdosing on prescription drugs in 1985. (See Show #699, OAD 12/7/02)

The following are the featured fugitives and others being sought by federal, state or local authorities. The <u>Update</u> (if any) gives current status, previous references, or related information.

Hal Maxie Atchley (Murder) - On the afternoon of April 1, 2002, Lewin Rhodes, Jr., a 26-year-old bail bondsman from Georgia, along with two other bondsmen, went to the home of Hal Maxie Atchley in Bryant, Alabama. They were there to attempt to pick up Atchley on a bond skip from Hamilton County, Tennessee. Atchley had failed to appear in court there for possession of marijuana, disorderly conduct and assault on police, among other charges. After knocking and getting no answer at Atchley's trailer, Rhodes and one of the bondsmen entered the residence and announced they were bond enforcement officers. They found Atchley's girlfriend, Janice Rogers, hiding in a spare bedroom. Rogers claimed Atchley was not home but Rhodes continued to search the house. He approached an addition to the house containing a small kitchen and bath that was separated by a blanket and stepped behind it. Rhodes found Atchley hiding in the bathroom's shower stall and Atchley immediately fired at least four shots at Rhodes, two of which were fatal. Atchley is believed to have stolen Rhodes' 9mm handgun and a few minutes later both Atchley and Rogers were seen leaving the scene on their motorcycles at a high rate of speed. Lewis Rhodes left behind a wife and two young sons. Atchley, who has used the middle name Maxim and Maxin, has tattoos on his chest, left ankle, left arm, left hand, right ankle, right arm and right hand. He is balding, has a very rural northern Alabama accent, smokes Marlboro Lites and may also roll his own. He is a skilled auto mechanic. He may be driving a black Yamaha 750 (or larger) motorcycle, or a black 1984 Oldsmobile Cutlass. He is a known methamphetamine user. Atchley is 39, 5'11" and 190 pounds.

Larry Eugene Yarbrough, Jr. (Murder) – On August 8, 1997, John Kinghorn, Sr., a security guard at the Dob and Win bingo hall in Oklahoma City, was walking the nightly cash from the hall to a nearby bank night deposit slot. Before he could get there, he was accosted by Larry Yarbrough, who was armed. A gunfight ensued where both Yarbrough and Kinghorn were shot. Yarbrough was able to escape into a car with two accomplices inside. Kinghorn died soon

after due to the gun shot. Months later, the two accomplices, Dameyond Rollins and Gemonty Davis, were arrested, but Yarbrough escaped. In December 1997, a prostitute in Detroit filed a report saying she had been beaten up by her pimp. She said his name was Larry Yarbrough, and that he was wanted for a murder in Oklahoma City. When cops went to the address given, Yarbrough jumped out of the third story and made his escape on foot. Yarbrough, who has used the alias Micah Simms, has a large scar on his stomach from a gunshot wound. He may be working as a bouncer at a night club or strip club. He may still be armed with the gun from Kinghorn's murder. Yarbrough is 26, 61" and 228 pounds. (See Show #659, OAD 1/5/02)

Unknown Ali Kemp Killer (Murder) - On Tuesday, June 18, 2002, 19-year-old Alexandra "Ali" Kemp was working at her summer job as a neighborhood pool attendant when she was brutally murdered. The pool is located near 123rd and State Line in Leawood, Kansas. She was home on break, having just completed her freshman year at Kansas State University, and was working the 2:00pm-5:00pm shift at the pool that day. The weather was rainy so there weren't any other people using the pool. Ali was sitting at a table near the pool's pump room when she was approached by the unknown suspect. Somehow the suspect was able to get Ali into the pool pump room where he brutally beat her to death. The suspect then covered Ali's body with a tarp and other pool covers. He proceeded to leave the room and shut the doors behind him. As he started to walk out of the pool's entrance he saw a friend of Ali's. According to her, the suspect stopped and looked at her, then walked back towards the pump room, and appeared to be looking around the corner. He turned around again and walked hurriedly towards a 1980's tan Ford pickup truck and took off. Cops are looking into hundreds of leads that include pool and lawn maintenance workers, as well as a crew of construction workers from a nearby interstate road. The suspect in question was spotted twice at the pool earlier that day, and he may have been spotted watching sunbathers the day before the murder. The suspect was wearing blue clothing which might have been overalls or a blue shirt and pants. The suspect is 5'8"-6'0" and heavy set. (See Show #685, OAD 8/3/02)

Alejandro Polinar Romero (Murder) Cesar David Lucero (Murder)

Angel Salgado Sanchez—On August 18, 2002, members of the St. James gang crashed a christening party at the St. Paul's Evangelical Lutheran Church in the Parkchester section of the Bronx. The gang took over the deejay's microphone and eventually got into an argument with one of the guests, Javier Tolchimani, 28. Members of the gang and other guests decided to take the fight outside. Once they got outside the St. James gang opened fire. Tolchimani was shot three times in the neck and is paralyzed from the chest down. A stray bullet killed another guest, 10-year-old Malenny Mendez, as she waited with her aunt for a cab nearly a hundred yards down the street. Police quickly arrested members of the gang but they are still looking for three others, including two of the shooters. 18-year-old Cesar Lucero fired the gun that paralyzed Tolchimani. Alejandro Romero is believed to have fired the gun that killed little Malenny Mendez. The third suspect, Angel Salgado Sanchez, is a suspected ringleader of the gang. All three speak broken English and may be dealing in drugs and/or illegal guns. Romero, who goes by the nicknames "Buho" or "Owl", has a tattoo that reads "Alex" on the inside of his left arm and another that

depicts a Mexican eagle and a snake on his left shoulder. He has worked in construction. Romero is 23, 5'6" and 160 pounds. Lucero, whose nickname is "Bebe", has a pierced right eyebrow. He is 18, 5'0" and 150 pounds. Sanchez, who goes by the nickname "Mosca", has a scar above his right ear, a scar over his right eyebrow, and numerous tattoos on his torso, arm, neck and back. He is 20, 5'0" and 120 pounds.

William Wallace Stabler (Assault on a Police Officer, Kidnapping, Grand Theft Auto) --Stabler, a career criminal, is wanted by Twin Cities police for assault on two police officers and for kidnapping a man to make his getaway. On October 10, 1981 two Twin Cities police officers investigating a domestic dispute were involved in a shootout with Stabler at a Corte Madera, California apartment complex. Stabler escaped by kidnapping a man and forcing him to drive to San Francisco. On December 5, 1988, Stabler was arrested under an alias by Los Angeles county sheriff's deputies for carrying a concealed weapon. He was released from jail on bond before his true identity was discovered. The FBI says Stabler was last seen in New York City where he lived from November 1991 to March 1992. He had a Doberman named "Daisy" and shopped at Banana Republic clothing stores. Stabler has tattoos of an eagle and a snake on his left arm, a knife on his upper and lower right arm, a heart with a dagger on his right arm and a skull with a dagger on his left arm. He also has scars from previous tattoo removals. He speaks fluent Spanish and is an associate of the Mexican Mafia prison gang. Stabler is a rodeo fan and often wears cowboy boots. He mumbles when he speaks, has a bad temper, and frequently goes into rages. He as a limp, uses a cane, wears bifocals, and may have a mustache or a goatee. Stabler is always heavily armed with both guns and knives. He has previously impersonated a police officer. He has worked as a warehouseman, laborer, dock foreman and Teamsters truck driver. He drinks, and is addicted to heroin and methamphetamine. Stabler may be found browsing in bookstores or libraries. Stabler is 70, 6'3" and 220 pounds. (See Shows #136, #167, #198, #263 and 6/12/99, OADs 10/26/90, 6/14/91, 1/31/92, 4/9/93 and 6/12/99)

On Wednesday, March 26, 2003, Laroya Bray was last seen by her mother at 5:30pm at their home in Los Angeles. Around 9:00pm her mother's fiancé called to report that Laroya was not home. Initially a witness stated that she saw Laroya in front of her apartment building talking to an unknown black man who may be her boyfriend, but this information has been found to be incorrect. Police and family interviews with friends of Laroya's have yielded no information on her whereabouts. Laroya was in the 10th grade at Crenshaw High School but was getting ready to enroll in Dorsey High. Laroya, who has a long narrow scar on her upper left thigh, has two piercings in each ear. She is

very light-skinned and has bushy eyebrows. She is usually outspoken but could be shy around strangers. She usually wears three silver rings on her left hand, and likes to wear hats or head scarves. When last seen, she was wearing a white tank top, a red "FUBU" skirt, socks, and a gold herringbone costume chain necklace with a CZ "V"-shaped pendant.

CAPTURED:

Michael Seibert (Rape) - Police believe that they have finally put a name and face to the unknown Miami serial rapist. Michael Thomas Seibert was identified as the alleged rapist who has been targeting women in their 30's, some of whom are mothers. He comes out of nowhere, armed and dangerous. He pulls the weapon on the victim, takes them to a secluded place, then rapes them. His victims are vulnerable. They are mothers with their children being picked up from a church pre-school or just outside their pediatrician's office. Two of the victims were pregnant at the time of the assault. The last incident happened on October 16, 2002. A 31-yearold mother with her infant son had just picked up her daughter at a church pre-school. All of a sudden a man with a knife jumped out of a wooded area. He drove her to a secluded place. ordered her to get undressed in front of her kids, and then raped her. Then he wanted money. They drove to the bank and withdrew \$400. He then drove the woman and her kids back to the church where he abducted them, and then he disappeared. His MO is to take the women where he finds them, take them to a secluded place, rape them and return the victim to where he abducted her. Police estimate that Seibert is involved in at least four rapes and an attempted kidnapping between 1998 and 2002, as well as for several other unsolved assaults. The big break in the case came on February 27, 2003 when a fingerprint from an arrest made a month earlier matched a print lifted from the jeep of a woman who was raped in May 2000. The print belonged to Seibert, who was arrested this past January for trying to strangle his girlfriend. Seibert's girlfriend, who is pregnant, decided not to press charges. The couple already has a 2year-old child. Seibert was recognized in a local Burger King by a crime analyst who was working on the case, by as police cars approached, Seibert fled. He made his way to North Carolina, where he stole a car before returning to Florida. Viewer tips informed authorities that he had returned, and on March 26, 2003, authorities responded to a call about a suspicious car, where they found Siebert sleeping. He was taken into custody without incident, just one block from his father's house, and eventually confessed to police. (See Shows #699 and #710, OADs 12/07/02 and 3/15/03)

The following are the featured fugitives and others being sought by federal, state or local authorities. The <u>Update</u> (if any) gives current status, previous references, or related information.

Colonel Brooks Tavern Triple Homicide – Washington, DC police are searching for the killers of three employees at a local restaurant. On the morning of April 6, 2003, three employees were shot to death inside Colonel Brooks Tavern. Police believe robbery was the motive. The employees, 47-year-old Rodney Barnes, 48-year-old Neomi Paine and 34-year-old Joshua Greenberg were gunned down inside the walk-in freezer by two unidentified males at approximately 8:15am. An undisclosed sum of money may have been taken during the commission of the crime. The suspects were wearing masks and police have issued no specific information about their identifying characteristics.

Jimmy Miller (Child Molestation and Abuse) – Jimmy Miller and his wife, Jimi, have adopted twelve foster kids with special needs over the last two decades. Miller seemed to be a devoted father. No one, including his wife, had any idea that Miller was raping and molesting his young children. It wasn't until one of his foster daughters was in drug rehab and told a counselor that the disturbing truth came to light. Jimmy Miller had fondled, molested or raped at least nine of his twelve children, both boys and girls. His wife divorced him for reasons other than the child abuse, and Jimmy moved to live with his sister in Farmington, Illinois. Illinois police arrested him and Jimmy waived extradition. But he complained of heart pain and was put in a hospital. That's when the prosecutor released him from his warrant. Jimmy was allowed to live with his sister on home detention, but he vanished February 23, 2003 after he left for a doctor's appointment. There have been several reported sightings of Miller in Redmond, Washington, including one by a school bus driver in the same neighborhood where his foster children live. Miller has ongoing problems with bronchitis, pneumonia, hypertension and back pain, and his ex-wife says he has taken the drug oxycontin for pain, and was addicted to it two years ago. He may be using drugs and alcohol abusively. He has suicidal tendencies, and once crashed his car deliberately. He has worked as a maintenance man. Miller is 63, 6'0" and 200 pounds.

Edward Mathis (Murder, Narcotics Violations) -- Four days before Christmas in 1994, 12-year-old Chris Valdez made a discovery that will stay with him for the rest of his life. While he was away at school, someone broke into his home and murdered his mother and stepfather. He couldn't get inside, but he didn't have to. He could already see the blood. It was everywhere. Chris' mother, Millie Espinal, was found in the bedroom belonging to Chris' 4-year-old brother. Millie had been shot in the face nine times while the child cowered in his closet. In the basement was another body - Chris' stepfather, Ari Espinal. He was lying in a pool of blood from 16 gunshot wounds. Police and federal agents soon had a motive and a suspect for the horrific killings. They say that Ari Espinal had been dealing drugs, and had a large store of cash in his home. Word of his riches had fallen on the ears of a man US Marshals call one of the most ruthless outlaws they have ever put on their 15 Most Wanted List: Eddie "Lucky" Mathis. Marshals say that Mathis made a career out of violence as a drug enforcer. Even his associates in the ruthless narcotics underworld, agents claim, were shaken by his stories of pistol-whippings, robberies, and getaways. Mathis is alleged to routinely carry as many as five handguns at once, and he never leaves home without his bulletproof vest. Law enforcement thought they had Mathis when they stormed an apartment in Atlanta, Georgia, but he made his getaway through the back. Now that he has gotten used to life on the run, officials fear that his next victim may be an unsuspecting police officer who stops him for a traffic violation. "Lucky," they say, is unlikely to ever believe his luck has run out. Mathis, who has used the aliases Eddie Whitson and John Whitson, has a chain tattoo around his left biceps. He may have a mustache or goatee. Mathis is an alleged co-leader and enforcer of a crack ring in Long Island, NY. He is believed to have a Tech 9 machine gun with silencer. He is also known to be a cross-dresser. Mathis is 39, 5'9" and 190 pounds. (See Shows #488, #506 and #672, OADs 4/4/98, 8/8/98 and 4/13/02)

James "Rick" Johnson (Robbery) – Johnson was the mastermind behind at attempted robbery at Lamco Jewelers in Alameda, California in April 1997. The attempt failed but the owners, Richard and Wanda Cook, were almost beaten to death in the process. Johnson needled his way into the back rooms of a pool hall in San Francisco, making friends with pool hustler and jeweler Richard Cook. When Johnson found out that Cook kept a safe in his store which allegedly had millions of dollars in cash and jewels. Johnson plotted to rob Cook of his money. Johnson recruited a team of six men. Each man had a specific role in the job. Two men scoped out the store. Posing as customers, they visited the store several times checking out security and the Cooks' routine. Two other men were recruited to subdue the Cooks and secure the location. Another man was lookout and the sixth man was recruited to create an accident with the Cooks' only employee so he would not get to work to interrupt the robbery. Planning for the robbery took over a year. Johnson knew Cook would never give up the safe combination, so he created a scheme to take the entire safe. The team of men retrofitted a U-Haul truck with a heavy-duty winch and enough iron to handle the move. When the time was right, the team went into action, equipped with walkie talkies and a police scanner. Each member of the team meticulous did their part. Halfway through the plan something went wrong. The police scanner said there was a disturbance at the location and they were dispatching a car. The team thought they had been had and called off the heist. But they were wrong: the call was for a dispute next door. The team fled and all but Johnson was captured. Johnson's car was found at the San Francisco airport. He is known to have an active passport and connections in Europe. Johnson, who has used the

nicknames Rick and Romeo, has a small unknown tattoo on his let shoulder. He very health and body conscious, likes the beach, and is reputedly a ladies' man. He does not do drugs, but has made money importing and selling drugs. He tends to be quiet and introspective, philosophical about life, feels that he doesn't "fit", and has suicidal tendencies. He likes to take risks, and at one time was a high rise window washer. His father left when he was young, and he may be seeking a father figure or older male mentor. Johnson is 35, 6'2" and 170 pounds. (See Show #663, OAD 2/2/02)

CAPTURED:

Joseph Leroy Crouch (Murder) - Joseph Leroy Crouch, Jr., a prominent businessman and a family man in North Memphis, is wanted for the brutal murder of his wife of 40 years, Betsy Crouch. Crouch owned a seemingly successful Memphis loan and finance company that he ran along with his son. Crouch liked to show off "his money" by taking business associates on lavish trips to resort towns to golf and play at casinos. Despite his upstanding image in town, Crouch was a high roller who gambled his company's money away. He often went on long gambling binges to Las Vegas and Atlantic city, taking up with prostitutes while he was away from his wife, Betsy. By June 2001, Crouch's double life was starting to crash in on him. He had gambled all of the company's money away and was heading towards bankruptcy. Even the DA's office was on to him and was threatening to prosecute. On June 25, 2001, after an afternoon of golfing, Crouch shot his wife Betsy four times while she lay in bed. He then took the keys to her new 2000 Mercury Sable and unloaded Betsy's golf clubs so he could put his own clubs in the trunk. He drove off, possibly headed towards Atlanta. Once on the road Crouch called his son-in-law, an attorney, and said "I just shot Betsy - I'm sorry." He claimed that he didn't want her to suffer the embarrassment of the company going bankrupt. Crouch later mailed his son and daughter suicide/confession letters from somewhere in New Orleans and told them that they should contact him by placing an ad in "The Commercial Appeal" newspaper. On the run, Crouch supported his gambling habit as the "Geritol Bandit", and was responsible for more than 40 armed robberies. He still found time to pursue his hobby of karaoke singing. This proved to be his undoing, as viewers easily identified him and alerted authorities. (See Shows #706 and #707, OADs 2/15/03 and 2/22/03)

Laci (Rocha) Peterson

On December 24, 2002 at 5:48pm Scott Peterson called the Modesto, California police stating that his pregnant wife had not been seen since 9:30am that day. Peterson says that Laci Denise Peterson, eight months pregnant, stayed home to shop for dinner and to walk their

dog at East La Loma Park, also known as Dry Creek Park. Scott says he left home at 9:30am and went to his office to do a few hours of work. He kept a 14-foot aluminum boat stored at his office and after working decided to hook it up and take a short fishing trip in the San Francisco Bay. He says he tried to call Laci from his cell phone during the day but could not reach her. When he arrived home, he found his dog in the back yard with the leash still attached. There was nothing unusual found in the house to indicate anything had happened. Laci's purse was still in the house. Scott and family members began searching the park and called police. The police began a search of the park and the Dry Creek area. Over the next couple of weeks police used water rescue units, canines and equestrian teams to search in Modesto and neighboring counties. Police also conducted extensive searches near the Berkeley Marina and in the San Francisco Bay where Scott said he went fishing, but found nothing. Scott Peterson was able to provide police with a parking receipt from the Berkeley Marina; however, it does not list entry or exit times. Initially, both Laci and Scott's families insisted that Scott had no involvement in her disappearance. On January 15, 2003, Modesto police met with Laci's family and informed them that Scott was having an affair with a woman who lives in the Fresno area. They showed the family a photo of Scott posing with the women; the photo was dated mid-December on a day that he told Laci he was away on a business trip. Laci's brother Brent says that Scott later admitted to this and other affairs. Laci's family cut off communication with Scott and they say that he initially lied to them about the affair, and possibly other things. They say that Scott's demeanor in the last couple of weeks has been unusual in that he has been playing golf, disappearing for lengthy periods of time, has hired a defense attorney, has not been open with them, and has met with a realtor about selling the house. Police have not named Scott a suspect, but are asking for the public's help in placing Scott on the day of Laci's disappearance. Laci Peterson has a tattoo of a sunflower on her left ankle. She was last seen wearing a white long sleeve shirt and black pants. A headless, armless torso and the remains of a fetus washed up in the Richmond, California bay; DNA results confirmed that the remains were those of Laci Peterson and her baby. Scott Peterson was arrested in San Diego and will stand trial for the murders of his wife and unborn son. (See Shows #703, #704 and #705, OADs 1/4/03, 1/25/03 and 2/1/03)

The following are the featured fugitives and others being sought by federal, state or local authorities. The <u>Update</u> (if any) gives current status, previous references, or related information.

Rufino Castaneda (Rape) – It all began the evening of November 1, 2000 at a strip mall pub in Mishawaka, Indiana. "Tiffany" was taken by force away from the bar. Two men kidnapped her, put her into a car and began driving away from the scene. Authorities haven't yet identified the driver. Rufino Castaneda sat in the back of the car, restraining and hitting "Tiffany". They drove "Tiffany" to Castaneda's ex-girlfriend's home. The driver left, but Castaneda pulled "Tiffany" into the home. Once inside, Castaneda sexually assaulted "Tiffany" and physically attacked her repeatedly. "Tiffany" fought back and escaped, probably saving her own life. When they arrived on the scene, "Tiffany", clothed only in a cardboard box, led them to the home where she had been attacked. Further investigation linked Castaneda to the scene and he was charged with the crime. Castaneda fled immediately. He was last seen the day before the attack at his job in Bremen, Indiana. He abruptly quit his factory job. He hasn't been seen since. Castaneda, who has used the alias Rufino Castaneda Nova and goes by the nicknames Alejandro, Alex and Rufo, has noticeably acne scarring on his face and may also have an arrow-shaped scar on his face. He is a Mexican national who speaks English poorly, smokes marijuana, and may be working as a day laborer. Castaneda is 28, 5'6" and 150 pounds.

Hal Maxie Atchley (Murder) – On the afternoon of April 1, 2002, Lewin Rhodes, Jr., a 26-year-old bail bondsman from Georgia, along with two other bondsmen, went to the home of Hal Maxie Atchley in Bryant, Alabama. They were there to attempt to pick up Atchley on a bond skip from Hamilton County, Tennessee. Atchley had failed to appear in court there for possession of marijuana, disorderly conduct and assault on police, among other charges. After knocking and getting no answer at Atchley's trailer, Rhodes and one of the bondsmen entered the residence and announced they were bond enforcement officers. They found Atchley's girlfriend, Janice Rogers, hiding in a spare bedroom. Rogers claimed Atchley was not home but Rhodes continued to search the house. He approached an addition to the house containing a small kitchen and bath that was separated by a blanket and stepped behind it. Rhodes found Atchley hiding in the bathroom's shower stall and Atchley immediately fired at least four shots at Rhodes, two of which were fatal. Atchley is believed to have stolen Rhodes' 9mm handgun and

a few minutes later both Atchley and Rogers were seen leaving the scene on their motorcycles at a high rate of speed. Lewis Rhodes left behind a wife and two young sons. Atchley, who has used the middle name Maxim and Maxin, has tattoos on his chest, left ankle, left arm, left hand, right ankle, right arm and right hand. He is balding, has a very rural northern Alabama accent, smokes Marlboro Lites and may also roll his own. He is a skilled auto mechanic. He may be driving a black Yamaha 750 (or larger) motorcycle, or a black 1984 Oldsmobile Cutlass. He is a known methamphetamine user. Atchley is 39, 5'11" and 190 pounds. (See Show #714, OAD 4/12/03)

Pinkney "Chip" Carter (Murder) - On July 24, 2002, Carter entered his ex-girlfriend Elizabeth Reed's house where she lived with her four children. Reed's current boyfriend, Glenn Pafford, was also at her house. Carter, who was disgruntled about the breakup of the relationship, fired shots at Glenn, then at Elizabeth. He then turned the gun at Courtney Smith, Elizabeth's 16-year-old daughter. Elizabeth and Glenn died on the spot, but Courtney was taken to the emergency room where she died two days later. Reed's 14-year-old son Rick was in a back room and came forward after hearing screams and gunshots, then called 911. On August 5, 2002, border patrol agents in Texas located Carter's truck in Escobares, Texas. Carter abandoned the vehicle, jumped into the Rio Grande, and swam to Mexico. Mexican soldiers patrolling the border arrested Carter when he arrived on the other side. When the soldiers searched Carter, they found two handguns. Carter was charged with the illegal importation of firearms and was facing up to eight years in prison. Mexican authorities refused to release Carter to Jacksonville detectives, but told them that they would call when Carter was going to be released. Police thought it would be several years before Carter could be brought back to the US. However, just four months later Jacksonville authorities learned that Carter had been released from jail after paying a fine. Carter's brother traveled to Mexico and gave Carter a motorcycle. Carter drove off on the bike and hasn't been seen since. Carter may still be riding the motorcycle, a blue and silver 1983 Suzuki. He likes to hunt, enjoys country line dancing and shooting pool. He has worked as a grocery store clerk and may be working as a bartender. Carter is 48, 6'0" and 165 pounds.

Mitchell Arlen Meyer (Sexual Abuse) – Meyer has repeatedly had inappropriate sexual contact with several young girls. On January 27, 1999, Mitchell was charged with two counts of second degree sexual abuse. He was able to post bond on these charges and was released from jail. Almost two weeks later, on February 16, Meyer was arrested again on a violation of a court order which stated that he was not to have contact with anyone under the age of eighteen. The very next day he bonded out and apparently left town. Meyer has a glass eye in the left socket, and is missing parts of his index, middle and ring fingers on his left hand. He has worked as a mechanic and construction worker. Meyer is 40, 5'11" and 150 pounds.

CAPTURED:

Henry Paul Inocencio (Robert Ratto Killer) – The hunt is over for the suspect who shot 34-year-old Robert Ratto in San Leandro, California. Ratto was on his way to work at 4:30am on September 24, 2002 when he was shot to death. 24-year-old Henry Paul Inocencio was arrested on March 25, 2003 and charged with the murder. He is AMW's 750th capture.

Responding to a request from Alameda County sheriff's deputies, AMW commissioned forensic artist Lee Hammond to do a sketch of the murder suspect based on the description from a terrified witness who was the early morning shooting. The sketch was widely publicized by the Fox Oakland affiliate KTVU and San Francisco bay area newspapers. Immediately, the Alameda County sheriff's homicide squad started receiving calls identifying Henry Paul Inocencio, a known drug dealer. The victim, Robert Ratto, was a loving father and devoted husband who was a pillar in his community. He not only was a former Eagle Scout, he was active in his local Boy Scouts troop as well as working with the local Cerebral Palsy Foundation on projects. Robert had started with the Safeway chain at the age of 16 as a box boy, working his way up the ranks until he had just landed a coveted promotion to store manager. On the morning of his murder, he had just said goodbye to his young son and wife, and had begun his hour-long commute. The AMW sketch also led to a tip that turned up a rental car driven by the suspect. The car was examined by the FBI crime lab and the Alameda county crime lab and turned up gun residue, traces of a strong cleaning agent used to wipe down the car, and shell casings. During the investigation, Inocencio was jailed on a probation violation relating to prior drug convictions. A key piece of evidence came from an informant who claimed to have seen Inocencio dispose of a bullet and shell casing that matched the type and caliber of casing found in the rental car. The informant told detectives that Inocencio was spotted burying a small aluminum packet in a backyard. When detectives dug up the area, they found one expended shell casing and one intact bullet. Subsequent examination matched the expended casing to those recovered in the rental car. On Tuesday, March 25, 2003 Henry Paul Inocencio was formally charged with Robert Ratto's murder, but police are still seeking the public's help. They have not recovered the .40 caliber semi-automatic handgun used in the murder.

The following are the featured fugitives and others being sought by federal, state or local authorities. The <u>Update</u> (if any) gives current status, previous references, or related information.

Nathan Aguirre (Escape) Martin Sandoval (Escape) Jose Ramirez (Escape)

Alfredo Mendoza (Escape) -- The manhunt continues for five inmates who escaped on March 24, 2003 from the Madera County Jail in Madera, California. Authorities from the Madera County Corrections Department have said that the escape was planned, and a fight in a nearby module might have drawn the attention of a correctional officer providing an opportune time to execute the escape. The five escapees climbed a "daisy-chain" rope made of jail bedding, after they had cut a metal screen over an outdoor basketball court with a smuggled saw blade. They then moved along the roof to an exterior wall and slid down on another bedding rope. From there, detectives say that the men ran a short distance, scaled a wire fence and ran through a rural area and several of the men possibly sped away along Avenue 14 in a waiting car. Jesus Soto was captured two days after the escape when a call to Crime Stoppers led deputies to his girlfriend's residence on A Street in east Madera resulting in Soto's arrest. On February 10, 2003, Nathan Aguirre used a garbage dumpster to sneak up on a group of men at the Cypress Apartments in Madera and was carrying an AK-47. Aguirre then came out from behind this cover and fired at least 20 rounds into the crowd, striking four men, a dog and the surrounding buildings. All four men survived the shooting and the investigation led to Aguirre as the shooter. Aguirre, who has used the alias Daniel Torres, has several tattoos including "VKS" in large letters on his chest, a figure shooting a large pistol on his front right shoulder, "13" on his left arm, and a male figure holding a female figure on his right arm. He also has a pierced right eyebrow. He is a known member of the Sureno street gang. Aguirre is 22, 5'6" and 130 pounds. Martin Sandoval was in jail for the murder of a man whose body was found with massive blunt force head wounds in an almond orchard near the town of Chowchilla, CA on August 18, 2002. Sandoval was arrested a short distance from the crime scene after initial investigation tied him to the killing. Authorities say that a bloody carjack was found near the body with a large palm print of dried blood that was later matched by the DOJ to Sandoval. Sandoval, who has used the aliases Martin Gonsalves and Martin Gutierrez, has tattoos of a swastika on his left chest, a

dragon on his upper left arm, and three dots on his left wrist. He has a light complexion with freckles. Sandolval is 23, 5'11" and 120 pounds. Jose Ramirez was arrested in October 2002 on the charges of attempted murder, mayhem, burglary, assault with a firearm, outside warrants and false imprisonment. Police say that on July 14, 2001, a victim awoke to find Ramirez and an accomplice in his bedroom. Ramirez was armed and the two suspects started kicking the victim in the face and demanding money. Police then say that Ramirez started to try and tie the victim up while saying "you know where you're going to end up right now, you're going to end up in the canal." The victim then started to fight back and Ramirez shot him. Ramirez has used numerous aliases including Jose de Jesus Ramirez, Alfredo Carillo, Jose Carlos, Pablo Estrada, Pablo Gonzalez, Hui Ramirez, Jesus Ramirez, Carlos Delgado Ramirez and Javier Carlos Ramirez, has several tattoos including "R" and a woman's face on his right chest, "Josefina" on his left back, two clown-type faces on his left arm, a woman wearing a sombrero on his right arm, and a possibly unfinished word with "SL" on his right arm. He is a known member of the Sureno street gang. Ramirez is 25, 5'7" and 175 pounds. Mendoza was arrested in April 2002 for armed robbery, carjacking and felony evading. Detectives say that on April 4, 2002, Mendoza approached a victim that was sleeping in his truck near Avenue 8 and Road 32 in Madera and knocked on the window, pointed a gun at the window and ordered the victim out of the truck. Mendoza then demanded the victims money, wallet and car keys and then stole the victim's Ford Mustang which was nearby. As police units responded to the victim's police report, an officer spotted the vehicle and attempted to make a stop. This resulted in a car chase at over 100 mph for approximately 20 miles until Mendoza lost control of the car and crashed into a field. Mendoza was found hiding in some bushes and his gun was found in the Mustang. Mendoz has many tattoos including "Knox Street" in large letters across his chest, "Mendoz" on his upper back, "MD" in large letters on his right shin, undistinguishable letters on the back of his head under his hair, "Rosalla" on the back of his neck, multiple naken women on his left arm and right biceps, and "dfdg" around his neck like a necklace. He too is a member of the Sureno street gang. Mendoza is 22, 5'6" and 170 pounds.

James "Whitey" Bulger (Racketeering and Extortion)

Catherine Greig (Harboring a Fugitive) -- In the tough working-class neighborhood of "Southie," just south of Boston, locals say that a young man growing up there has only two career choices: the priesthood or the law. One of the Bulger brothers went on to make laws, becoming the President of the Massachusetts State Senate and holding the post for eighteen years. The other, who became known as Whitey Bulger, went on to break laws, becoming the boss of the ruthless Irish Winter Hill Gang. Police say that Whitey had his fingers in every drug deal and illegal bet in Southie, swiftly becoming respected, even legendary, in the Boston underworld. Authorities claim that he was able to consolidate power through an historic truce with the Italian Mafia in Boston, whereby they respected each other's boundaries, and even collaborated on their nefarious schemes. The Massachusetts State Police were determined to get Whitey behind bars. But every time they got an authorized wire tap, every time they set up surveillance, Whitey dodged their net. It was almost as if he knew.... On January 10, 1995, the federal grand jury handed up a RICO indictment with Whitey's name on it. True to form, Whitey was ahead of the law, and disappeared from sight. However, the indictment netted five other members of the Irish Winter Hill Gang, including Whitey's top lieutenant, Steve "The Rifleman" Flemmi. What Flemmi had to say shocked everyone, gangsters and law enforcement alike. Flemmi claimed that both he and Whitey were actually government informants, leaking

information to the FBI on their supposed partners in the Italian Mafia for nearly 30 years. He even claimed that they had been tipped by the Feds before the indictments came down, allowing Whitey to make a clean getaway. Legal hearings will determine whether Flemmi's allegations are true, and whether Flemmi and Whitey's alleged informant status makes them immune from prosecution. When the FBI indicted Bulger, Catherine Greig, his mistress, joined him on the road as they traveled as any retired couple through the historic sites and Indian reservations of the United States. So strong was her dedication to the suspected underworld mastermind that she abandoned her pet poodles and extensive collection of Hummell figures. Authorities now know that one of Whitey's stops was the quiet Louisiana enclave of Grand Isle. No one in this tight-knit community suspected that Whitey was a northeastern mob boss as he came and went Greig, paying for his rental cottage in crisp \$100 bills. Posing as "Uncle Tom and Aunt Helen," they seemed to blend right in. But now Uncle Tom and Aunt Helen have disappeared and the hunt is still on for Whitey Bulger and Catherine Greig. Police have traced the couple to Sheridan, Wyoming; San Francisco; Gulfport, Mississippi; and Selden and Holtsville, New York. The trail has been cold since July 1996. Bulger has a medium athletic build and often wears a baseball cap and sunglasses. He takes daily walks of 5-6 miles, and is take the heart medication Atenolol. Bulger drives large luxury sedans and likes making purchases with \$100 bills. He has served time for several bank robberies. Bulger has used the aliases and nicknames Jimmy, Jimmy-Boy, Jimmy Blue-Eyes, Thomas F. Baxter, Tom Harris and Mark Shapeton. Bulger is 73, 5'7"-5'9" and 150-160 pounds. Greig likes to wear high-quality jewelry. She has worked as a dental hygienist and a dog groomer. Greig has used the alias Helen Baxter. She is 51, 5'6" and 120 pounds. (See Shows #349, #378, #481, #556, #574, #579, #605, #623 and #707, OADs 1/21/95, 9/9/95, 1/24/98, 9/4/99, 1/29/00, 3/11/00, 9/23/00, 3/3/01 and 2/22/03)

Frank Lee Morris (Escape) Clarence Anglin (Escape)

John William Anglin (Escape) -- At the time of the escape, Frank Morris was 35-yearsold and serving a 14 year sentence for bank burglary. Morris was a seasoned escape artist, managing to flee from every institution he had ever been in. Morris' criminal history dates back to the 1940's. He served time at several penitentiaries, mostly for robbery. He is considered to be an intelligent man, at one time scoring 133 on his IQ test. Many believe he was the instigator of the incredible Alcatraz escape. On June 11, 1962, guards at Alcatraz found three dummies in Cell Block B. The cells belonged to robbers John and Clarence Anglin and bank burglar Morris. It is believed the trio dug their way out of their concrete cells and disappeared into the San Francisco Bay. Some say the escapees are living in Latin America. Morris, who has scars in the middle of his forehead, on his left forearm near the wrist, on his left biceps, left little finger, left elbow, both shins, right foot, and a vaccination scar on his upper left arm, has several tattoos including a devil's head on his upper right arm, a star on his left knee with a seven above and eleven blow, a star on his right knee, a star on the base or back of one of his left fingers, a circle between his left thumb and index finger, "N.T.S.B." or "N.B." on his upper left arm, a star on the center of his forehead (possibly removed), and a "C" on the back of his left index finger. He is a smoker. Today, Morris is 76, 5'7" and 135-145 pounds. Clarence Anglin is a smoker who has a pitted scar between his eyes, scars on the left side of his upper lip, back of his right ring finger, on the outside edge of his right forearm, a vaccination scar on his upper right arm, a mole on each side of his stomach, and tattoos including a scroll and "Zona" on his left wrist, outer or upper forearm, and "Nita" on his upper right arm. Today Clarence Anglin is 72, 5'11" and 167

pounds. John William Anglin has scars on the left side of his abdomen, his left cheek and a dim cut star inside his left forearm near the wrist. John Anglin is 73, 5'10" and 140 pounds.

Jessi Vega (Murder) -- On November 15, 1998, deer hunters found Tricia Beristain's body on the roadside in a canyon outside Salt Lake City. Police later determined that Beristain had been dating Vega prior to her murder. She was last seen with Vega and another man, Diego Cruz, on the night she died. Cruz was later captured in California. Detectives say Vega took Beristain up into the canyon and executed her with a 9mm handgun because he mistakenly thought she was seeing another man. Police are not sure that "Jessi Vega" is his real name; he has used numerous aliases including Jesse Vega, Jesus Vega, Jesus Alonzo, Jessi Alonzo, Jesus Mungia, Arturo Mungia, and the nickname "Chivo". He has four silver-capped upper front teeth and tattoos including a bullet bandolier across his upper torso from his left shoulder to his right waistline, a Chicago Bulls logo on his upper left shoulder, and a star between his left thumb and forefinger. He is a drifter who works sporadically as a day laborer, and may be a member of the "La Familia" or "Folks" street gangs. He drinks beer, smokes marijuana, and has a history of domestic assaults in Illinois. Vega is 28, 5'5" and 150 pounds.

Randolph Franklin Dial (Escape) -- Randolph Dial is wanted for escape from a medium security prison in Granite, Oklahoma on August 30, 1994. Dial escaped from the prison around 11:30 a.m. and took Bobbie Parker, the deputy warden's wife, with him. Agents believe Dial used Parker's van to leave the prison grounds. After the escape, police say Parker made several calls to family and friends saying that she was okay and that she would be home soon. The last phone call came on September 9, 1994. Neither Dial or Parker have been seen since. The van was recovered in Wichita Falls, TX on September 1, 1994. Dial was serving a life sentence for the 1981 murder of Kelly Hogan in Broken Arrow, Oklahoma. Dial confessed to the murder which he claimed was a contract killing for the mob. Broken Arrow police never discovered who hired Dial to kill Hogan. In 1998, author Charles Sasser wrote a book about Dial entitled, " At Large: The Life and Crimes of Randolph Franklin Dial." On November 9, 2001, Sasser claims Dial called him on the phone and the two spoke for approximately 45 minutes. Sasser also says he spoke with Parker. Agents were not able to trace the call but they believe Dial made the phone call. Dial's numerous aliases and nicknames include "Doc" Dial, Randolph Franklin Johnston, Randolph Franklin, Randy F. Johnson and "Doc" Franklin. He has a small scar under the left side of his chin, two small scars on his upper left chest, and a small round scar on the back of his left calf. His teeth are in poor condition and he may be missing one or two lower front teeth. He is a heavy drinker, speaks Spanish, and may talk about having been in the mob or claim to have been a government informant. He may be doing artwork as an occupation or means of income, and may be traveling with Bobbie Parker. Dial is 58, 5'9" and 150 pounds.

Jon Savarino Schillaci (Sexual Assault on a Minor) -- Jon Schillaci was released from prison in Sugarland, Texas in the summer of 1999 after a ten year sentence for molesting a young boy. Police say while he was in prison, Schillaci allegedly established an on-line relationship with a family in Manchester, New Hampshire. When Schillaci got released from prison, the family invited him to live with them and their five-year-old son until he got on his feet. He accepted their offer and moved in this fall. A couple of weeks after Schillaci moved in with the family, their five-year-old son approached them and told them that he and Schillaci had a "secret." The five-year-old then revealed that Schillaci had been sexually molesting him since he

moved in. The parents went to confront Schillaci in the house, but he had already fled. In October of 1999, cops say Schillaci was seen boarding a Greyhound bus, heading south. Police think he may be heading back to Texas, and a friend of Schillaci's said he was probably on his way to Mexico. Schillaci, who is extremely handy with computers, is into the occult and devil worshipping. He is known to frequent gay bars. Schillaci is 31, 5'11" and 180 pounds.

Tristen "Buddy" Myers

Age: 6 Height: 3'0"

Weight: 50 pounds

On Thursday, October 5, 2000 "Buddy" Myers wandered off from his home in Roseboro, North Carolina, with his two dogs, Sasha, a baby Doberman, and Buck, a three-legged mutt. Police conducted a massive search of the surrounding are but found to sign of Buddy or the dogs. On Tuesday night, October 10, Buck the mutt came home. Sadly, the dog was not accompanied by Buddy or Sasha. Buddy had just moved to live with his great aunt and uncle two months ago. They describe Buddy as a curious and friendly little boy who would talk to just about anyone. Buddy has scars on the right side of his neck and on the top of his head. He likes swimming and riding horses. When last seen he was wearing blue jeans, a black t-shirt, and Mickey Mouse tennis shoes. (See Shows #608, #617 and #677, OADs 10/14/00, 1/20/01 and 5/25/02)

Bobbie Louaine Parker

Age: 40 Height: 5'5"

Weight: 120 pounds

Bobbie Parker has been missing from Granite, Oklahoma since August 30, 1994. Bobbie was married to Randy Parker, a deputy warden at a medium security prison in Granite. They lived on the prison grounds with their two young daughters. Randolph Dial, an inmate serving a life sentence for murder, was assigned to do yard work at the Parker's house. Dial also ran a prison pottery program in a garage off Bobbie's house. On the morning of August 30th, Bobbie told her husband she was going shopping for the day. Agents believe Bobbie left the prison around 12:30 p.m. Later that day, guards discovered that Dial was missing. Investigators believe that Dial kidnapped Bobbie and escaped from the prison in her vehicle. Bobbie made several phone calls to friends and family, stating that she was okay and that she would be home soon. The last phone call was made ten days after the escape. Bobbie's vehicle was found abandoned in Wichita Falls, Texas. Neither Bobbie Parker or Randolph Dial have been seen since the escape.

Ashleigh Moore

Age: 12 Height: 5'4"

Weight: 120 pounds

Police in Savannah, Georgia suspect foul play in the disappearance of 12-year-old Ashleigh Moore, who was reported missing a week ago. Ashleigh hasn't been seen since Friday, April 18, 2003, when her mother's live-in boyfriend, Bobby Joe Buckner, called her at work saying the girl was missing. He told police that he put Ashleigh and her sister to bed that night and when he went to check on Ashleigh thirty minutes later, she was gone. Ashleigh's glasses, which she needs to see, were left in her bedroom. Ashleigh has no history of running away. After days were spent searching near her neighborhood on Savannah's suburban south side, police shifted their focus to Hutchinson Island - a small resort island directly across the Savannah River from the city's historic downtown. Though the island has recently been developed with a new convention center, a Westin hotel and a golf course, much of it remains a thicket of dense woods and marsh. Ashleigh's mother's boyfriend, Bobby Buckner, 26, was convicted in 1996 for the molestation and statutory rape of a 12-year-old girl. He has been jailed for violating his probation, which prohibits him from being alone with girls under 16, but although police have found traces of unidentified blood inside Buckner's car, he is not named as a suspect in this case.

The following are the featured fugitives and others being sought by federal, state or local authorities. The <u>Update</u> (if any) gives current status, previous references, or related information.

Greisy Valencia (Child Abuse) – The Hayward Police Department is searching for 49-year-old Greisy Valencia for the alleged torture of her 11-year-old daughter. Police say that Valencia began torturing the girl at the age of four. Police and witnesses say that Valencia would hold the girl's hands and face over the stove as a form of punishment. Police also say that Valencia burned and hit the girl with several different objects. Social workers and police both say it is the worse case of child abuse they have ever seen. The girl is covered with scars from head to toe. Police say on December 9, 2002, Valencia got word that someone close to the girl was going to report her to the police. Valencia abruptly left work and told her employers that she didn't know when she was going to return. The little girl and her two brothers are in foster care and doing well. Valencia works in fast food restaurants and comes across as very witty and hardworking. She has used the alias Yudera Monteel. She likes to hang out with and spend money on men. Valencia is 49, 5'3" and 130-154 pounds.

Mark William Samples (Bank Robbery) – Samples has been charged with the 2001 robbery of a Minnesota credit union, and he may be on the run with his son. On May 3, 2001, Samples entered the Red Wing Credit Union and robbed it, armed with a .45 caliber handgun. After robbing the bank, Samples attempted to make a getaway on a bicycle and then by donning scuba gear and hiding in the Mississippi River. He was eventually arrested and plead guilty to the bank robbery charges. However, when he learned his sentence would be five years, he withdrew his plea. Trial was set for September 4, 2002. On Friday, May 31, 2002 Samples picked up his son Christopher from his estranged wife's home, agreeing to return the child Sunday morning. The pair vanished. Samples has the warrior figure "Genesis" tattooed on his right arm, and has a scar on his back. He is a perfectionist; everything has to be perfectly straight and clean. He shaves with an electric razor, never a blade. When he brushes his hair, he does so very harshly to the point where his scalp will become raw. He has taken Prozac, Interferon and other medication for Hepatitis C, which makes him nauseated and tired. He doesn't cook but prefers to eat fast food or sushi, and his weight fluctuates wildly. He had an apprenticeship to become an electrician, and has worked as a life guard. He has also worked as a phlebotomist, is

very interested in veins and will talk extensively on the subject. He likes to camp, mountain climb, or anything outdoorsy and thrilling. He likes football, and the Green Bay Packers are his favorite team. He knowledgeable about computers and the internet, and probably has a laptop with him. He watches the Weather Channel often. He is a Navy veteran. He is probably carrying handguns and rifles, and has told his family that he wants to commit suicide. Samples is 39, 6'0" and 225 pounds. (See Show #692, OAD 9/28/02)

Warren Kent Smith (Escape) - Smith and four other inmates, escaped from the recreational area of the Blount County Jail in Maryville, Tennessee on July 12, 2001. Three of the five were caught within 24 hours of their escape, AMW viewer tips led authorities to Brazil where Robinson was apprehended, but Smith is still on the run. The inmates made a rope out of town bedsheets and climbed up a 24-foot wall. Then one of the inmates unwove part of a metal fence and all five slipped through. They landed on the roof and lowered themselves to the ground by climbing down a drainpipe. The men took off their prison clothes and fled, wearing only jockey shorts and t-shirts. Smith, who has scars from cigarette burns on his arm, is very paranoid and doesn't trust many people. He is fluent in English, Spanish, Portuguese and German. He is described as arrogant, smart, likeable, persuasive and easy to talk to. Though he has a lot of money with him from drug sales, he doesn't live lavishly. He likes to go to rave clubs. He is quite artistic, designs tattoos and likes to "tag" or spray paint buildings. Smith is 27, 5'5" and 150 pounds. Robinson, a practicing Hindu, has "DGAF" tattooed on his upper right arm and a cross tattooed on his upper left arm. He may have a mustache. (See Show #643, OAD 8/4/01)

Dara Marie Llorens (Interference With Child Custody) - Llorens abduced her 5-yearold daughter, Sabrina Allen, on April 20, 2002 in Austin, Texas. Llorens was unhappy with her visitation arrangement and abducted her own child. Dara was married to Greg Allen, an Austin engineer, for three years. Sabrina was their only child. During the divorce proceedings Dara was diagnosed by a court-appointed psychologist as suffering from a personality disorder and on his recommendation Greg Allen was awarded sole custody of their daughter. Dara began lodging a series of allegations with Child Protective Services that her ex-husband was abusing Sabrina. CPS investigators ruled that there was no evidence of abuse. They were suspicious that Dara was fabricating these allegations and ordered her into therapy. Shortly after this, Dara and Sabrina vanished. Llorens, whose numerous aliases include Deena Marie Guerro, Deena Lamont, Deena Patel, Deena Groves, Deena Patterson, Deena Green, Dara Marie Rose, and the nickname "Marie", has pierced ears, a long deep scar on the back of her right knee, and scars from surgery on both Achilles tendons. She walks with a slight limp from cerebral palsy as a child. She is left-handed, speaks poor Spanish, and typically works in clothing and shoe retail, as a waitress, in auto sales, jewelry sales, secretarial work, child care, cake decorator, and as a livein nanny. She has a history of melanoma. She can be charismatic and charming, but can be volatile, yelling, stomping and slamming doors. She often tells dramatic stories to elicit sympathy. Llorens is 33, 5'6" and 100 pounds. (See Show #695, OAD 11/2/02)

Desiree Dawn Lingo-Perkins (Capital Murder) – On March 12, 2000 Kyle Nathan McElroy was kidnapped in Troup, Texas. McElroy was the son of a very wealthy businessman who had recently acquired a large sum of money from a business merger. A ransom note was sent to Kyle's parents demanding \$200,000. Unbeknownst to the family, however, the kidnappers had already tortured and killed Kyle before the first ransom call was made. One day later, Kyle McElroy's body was found in rural Cherokee County, Texas. The investigation led to the arrest of three men: Daniel Rios, Ernesto Bailon and Alfredo Romero. Investigators believe that Rios had been an employee at McElroy plastics and had worked with Kyle McElroy. Still on the run is Desiree Dawn Lingo-Perkins. She is a known prostitute who was an active participant in the planning and execution of the abduction and murder of McElroy. She was responsible for making several ransom calls to the McElroy family demanding money. Lingo-Perkins is known to have family in Beaumont, Texas and Barling, Arkansas. She also a teenage daughter residing somewhere in Connecticut; two other children died in a car accident in 2002. She has supported herself for years as a prostitute in the Latin American immigrant community. Her familiarity with this community may lead her to attempt to escape to Mexico. Lingo-Perkins, who has used the alias Esperanza Perkins, has a tattoo on her right ankle and a scar on her abdomen. She is suspected to be HIV-positive. Lingo-Perkins is 34, 5'6" and 170 pounds. (See Shows #584, #595 and #705, OADs 4/15/00, 7/15/00 and 2/1/03)

Nova Esther Guthrie (Armed Bank Robbery) - Guthrie and her boyfriend, Craig Pritchert, robbed the Bank of Southwest in Durango, Colorado on October 31, 1997 and the Wells Fargo Bank in Mesa, Arizona on August 13, 1999. The FBI believes Guthrie and Pritchert have also held up banks throughout the Pacific Northwest and Texas. In March 1999, Guthrie surrendered to the FBI in Denver, Colorado and was released on bond. She moved to Cheyenne, Wyoming to live with relatives and got a job as a waitress. Pritchert remained at large. Agents believe the love-struck couple reunited on the internet. On April 4, 1999 Guthrie drove out of Cheyenne to meet Pritchert and resumed her life on the run with him. Pritchert is an active day trader on the internet. He covers his stock losses by robbing banks. The robberies have all been meticulously planned, employing scanners, handcuffs, guns, two-way radios, masks, and welltimed precision to gain access to the bank vault where the large amounts of currency are stored. Guthrie is believed to have been the getaway driver in the Durango robbery. Guthrie has used several aliases including Nova Hicks, Nova Thomas, and Alex Santini. She is from a white supremacist-religious fundamentalist family background. She studied to be a mortician, and has worked in sales and as a waitress. She loves to ski and snowboard, and may be hanging around ski resorts. Guthrie is 28, 5'4", and 130 pounds. (See Shows #565, #581, #589, #601, #639 and #688, OADs 11/13/99, 3/25/00, 5/20/00, 8/26/00, 7/7/01 and 3/16/02)

Craig Michael Pritchert (Armed Bank Robbery) – FBI agents describe Pritchert as a high-living day trader who covers his stock market losses by robbing banks. Pritchert and his long-time girlfriend Nova Esther Guthrie have traveled around the United States like a high-tech version of "Bonnie and Clyde". Pritchert was released from federal prison in Arizona on June 11, 1996 after serving time for a Las Vegas, Nevada bank robbery. After his release, Pritchert lived in Phoenix until August 13, 1997 when agents say he robbed the Norwest Bank in nearby Scottsdale. On August 13, 1999 Pritchert and Guthrie held up the Wells Fargo Bank in Mesa, Arizona. Pritchert plans his robberies meticulously, employing scanners, handcuffs, guns, two-way radios, masks, and well-timed precision to gain access to the bank vault where the large

amounts of currency are stored. Pritchert, Guthrie and an unnamed associate are also charged with the armed robbery of the Bank of Southwest in Durango, Colorado on October 31, 1997 in which they allegedly made off with \$50,000 in cash. Pritchert has numerous aliases, including Josh Riggs, Garrett W. Guthrite, John Guthrite, Wil Hicks, Brent Wilson Hicks, Matthew Ryan Pritchat, Michael Craig Pritchert, Michael Craig Pritchert, Michael Craig Pitcher, and Craig Pritchart. He is described as handsome, outgoing, charismatic and intelligent. Like Guthrie, he loves to ski and snowboard and may be hanging around ski resorts. He likes "yuppie-type" upscale cars such as BMWs, Mercedes, Saabs and Subarus. Pritchert is 39, 6'0", and 185 pounds. CAPTURED:

Cassandra Woods (Aggravated Assault) – Woods was wanted for assaulting a bartender during a bar fight which culminated in the death of Cole Bailey, Jr. On October 16, 2002, Samuel "Sammy" Compton, Christopher "Cracker" Whitley and Brandon Miller, all white supremacists, started a fight inside a Phoenix pool hall. Compton's girlfriend, Cassandra Woods, assaulted the bartender. The fight spilled out onto the sidewalk as bouncers threw them out. 20-year-old Cole Bailey, Jr. just happened to be outside the pool hall waiting for a taxi to take him to his girlfriend's house. Compton saw Cole watching the fight and yelled "What the f*** you looking at" Compton then hit Cole in the face. Cole did not respond verbally, but he started to flee after Compton continued to speak angrily. The three men chased him about 7 feet down the sidewalk and tacked the 135-pound Cole. They repeatedly kicked and stomped him into the hard concrete. While the skinheads bashed Cole Bailey, who was white, in the head, they yelled "white power". Cassandra Woods yelled "beat the n***". Cole Bailey died at the scene from the brutal and senseless murder. Compton, Whitley and Miller have been arrested. A tip from a viewer whose brother was dating Woods led authorities to Illinois where she was captured. She has been extradited to Arizona for trial. (See Show #707, OAD 2/22/03)

The following are the featured fugitives and others being sought by federal, state or local authorities. The <u>Update</u> (if any) gives current status, previous references, or related information.

Appleton Attacker (Attempted Murder) – Police in Appleton, Wisconsin are searching for the unknown stranger to nearly killed a 23-year-old woman in the early morning hours of August 7, 1999. The attacker approached a girl we will call Heather, which is not her real name, as she was entering her mother's home. He called "Come with me" in a playful manner before quickly grabbing her and dragging her across the street to a community park. Once they were in the park, the attacker produced a knife and stabbed Heather more than twenty times. At no time did the attacker attempt to sexually assault or rob Heather, nor did he say anything that would explain why he was undertaking this random attack. Emergency personnel arrived just in time to transport her to the hospital where doctors were able to save her life. After two years of attempts to create an accurate composite image of the attacker, investigators had Heather hypnotized. While in a hypnotic state she was able to help the artist create a composite picture. The suspect is 21-25 and 5'8"-5'11".

Olivera Valentino Hernandez (Homicide) – On October 17, 1992, Olivera Valentino Hernandez murdered Ernesto Lara, 17, at a construction site. Hernandez had been drinking and became angry at ex-employee Lara. Hernandez chased Ernesto from house to house in a cat-and-mouse style murder. The young boy was shot several times and then buried in a shallow grave behind Hernandez' garage. Hernandez, who has used the aliases Valentine H. Oliver and Jimmy Castro, has the face of Jesus and a cross tattooed on his chest, two women and a rose on his left biceps, a woman on his right biceps, and a rose and the Virgin Mary inside his right forearm. He wears reading glasses, is known to carry a gun, and travels by bike or box car. He claims to have a son and daughter. He may still be working in construction as a carpenter or wood carver. Hernandez is 71, 5'11" and 170 pounds. (See Show #337, OAD 10/22/94)

Unknown O.S.U. Arsonist – Fire investigators have ruled that arson was the cause of a fire at 64 East 17th Avenue in Columbus, Ohio on April 13, 2003, near Ohio State University. The house fire killed five college undergraduate students: Alan Schlessman, 21, Kyle Raulin, 20, Andrea K. Dennis, 20, Erin M. Demarco, 19, and Christine Wilson, 19. The fire injured three

others. Fire investigators say that more than fifteen students were inside the three-story brick home when the fire broke out just after 4:00am. The students were residents of the home and several guests remaining from a party the previous night. Firefighters battled the blaze and eventually pulled several students to safety, but were unable to save the fire victims. Fire investigators say the blaze was intentionally set with accelerants somewhere on the front porch area of the home. Detectives are investigating the five deaths as homicide. There maybe more than one perpetrator who may be student(s) at Ohio State University. Investigators say the perpetrator(s) may have attended the party that evening, may be obsessively talking about the fire, and may be fixated on the media coverage of the fire.

Roger Dale Holbrook (Murder, Theft) - Holbrook shot and killed fellow thoroughbred horse trainer and ex-wife Barbara Holbrook on November 5, 2002. The couple had been divorced for more than a year when Barbara Holbrook filed for a protective order against her husband. Barbara believed Roger had planted syringes with illegal performance-enhancing drugs in her horse's stall at Turfway Race Track in northern Kentucky. The discovery of the needles by the Kentucky Horse Racing Commission led to Barbara's suspension from horse racing for sixty days. Barbara also felt threatened by Roger's alleged addiction to crack and claimed to have received several threatening phone calls from him. The hearing on the protective order was scheduled for Wednesday, November 6. On Tuesday, November 5, Holbrook went to talk his ex-wife out of the court filing. When he was unable to convince her, he used a large caliber handgun and shot and killed her. He fled Indiana in a gold Ford Contour. Police in Memphis, Tennessee recovered Roger Holbrook's car on January 17, 2003. The vehicle was abandoned in a parking lot and its license plates had been removed. Roger Holbrook may be driving another car with Ohio plates AZ5 3JW. Holbrook, who has used the first name Robert, has a scar on his left wrist. He likes to drink, dips Copenhagen tobacco, and likes eating at Wendy's and staying at Red Roof Inns. He always wears blue jeans and speaks with a distinct twang. He may still be working at a track or at Off Track betting facilities. Holbrook is 57, 5'6" and 180 pounds.

Scott Alan Hornick (Escape, Burglary) – Hornick is wanted for a number of con games, burglaries and escape. In 2001 Hornick was locked up at the Warren County Correctional Center in northwest New Jersey for burglary, theft and fraud. On August 6, 2001, Hornick and another inmate, John Strubel, devised a plan to escape from the jail through a hatch in the day area of their cell block. Corrections officials say they pulled it off by picking the lock using a pair of eyeglasses as a tool. They then climbed into a crawl space and knocked out a drainpipe, which led to the second story roof of the jail. Hornick and his accomplice climbed down a ladder and over the perimeter fence where they fled on foot. On August 8, 2002 Hornick and two other men were trying to burglarize a Circuit City in Wayne, New Jersey. Cops responded to the call and the burglars fled in an SUV, leading patrol cars on a high speed chase through northern New Jersey. The SUV crashed and officers caught up with Hornick and his accomplices. Hornick cooperated and gave a statement, but used the alias Jerry Todisco and fled before police could make a fingerprint match. Police later caught up to Hornick in Mount Laurel, New Jersey, at an extended stay hotel. When cops arrived, Hornick jumped out his second story window and fled in his car. Since then, police have received confirmed sightings of Hornick at bars with gambling in the Easton, Pennsylvania area and in a mall in northern New Jersey. Hornick, whose other aliases include Scott Allen and Charles Hall, dates women to get access to their credit cards, then leaves them. Hornick is 31, 5'11" and 260 pounds.

Eduardo "Limpy" Rodriguez (Murder, Attempted Murder) – Rodriguez is wanted for four counts of murder and two counts of attempted murder. Rodriguez, along with "Toonerville" ("TVR") street gang leader Timothy McGhee (now in custody) are accused of the 2001 shooting deaths of Margie Mendoza, Mary Ann Wisotsky, Cheri Wisotsky and Bryham Robinson. Margie Mendoza, a 25-year-old mother of two with no gang affiliation, was killed when Rodriguez and McGhee opened fire on her SUV in a rival gang neighborhood in retaliation for another murder. Mary Ann Wisotsky, her daughter Cheri and family friend Robinson were executed because McGhee thought Cheri had informed on his sister to the police. Prior to the shooting, both Rodriguez and McGhee had brutally beaten Bryham in an effort to extract information from him. Shortly thereafter, all three were shot dead in Mary Ann's car. Rodriguez, who has used the alias Juan Carlos Campos Gamino, has several tattoos including "TV" on his stomach, "Toonerville" on his back, a female head on his left shoulder, "RIP" on his right arm, and additional unidentified tattoos on his right arm, upper left arm and right shoulder. He is an illegal alien from Mexico who is also wanted by the INS. He has dyed his hair red in the past. Rodriguez is 23, 5'9" and 170 pounds.

John Westley Winklepleck (Child Molestation) — Winklepleck held an impromptu sleepover for three children at his house without the parents' knowledge. The next morning he urged the kids to lie about where they had spent the night. The kids did not do as they were told, and when they arrived home they informed their parents about where they had been. One boy said that he had been sexually molested by Winklepleck. Winklepleck volunteered to come into the police station to be interviewed, but never showed up. Winklepleck, who has used the alias John Westley McGuire, has tattoos of a naked woman on his upper right arm, a castle, moon and a bird lady on his upper left arm, a wizard on his left front shoulder and a mermaid on his lower right arm. He may wear a mustache from time to time. Winklepleck is 56, 6'0" and 200 pounds.

The following are the featured fugitives and others being sought by federal, state or local authorities. The <u>Update</u> (if any) gives current status, previous references, or related information.

Duane Brown (Vehicular Homicide) – Brown is wanted for killing two people in a fiery motor vehicle accident on June 29, 2002. Palm Beach, Florida narcotics detectives saw Brown make a car-to-car drug buy. Brown's girlfriend, Porsha Davis, and another friend, Jerome Maynor, were passengers in Brown's vehicle. Uniformed officers were called in to stop Brown's car. When the officers pulled behind him and attempted to make the stop, Brown took off, traveling at speeds over 100 mph. The police did not continue the pursuit. A short time later, Brown crashed his car into a concrete utility pole. Shortly after police arrived, the car exploded. Brown survived, but both of the passengers in his car died as a result of the wreck. Brown was subsequently charged with causing the two deaths. After the accident, Brown was hospitalized and his right leg was amputated. During his stay in the hospital, he was fitted for a prosthetic leg. Brown left the hospital before he could be arrested and hasn't been seen since. He could be using crutches or a cane. Brown is 25, 5'9" and 160 pounds.

Pedro Correia DaRosa (Immigration Violations) – Da Rosa is a native of Portugal who was convicted of rape in 1991. Agents have issued a warrant of deportation for him; he was last seen in New Bedford, Massachusetts. DaRosa, who has used the alias Pedro Leonel, has a scar on his right forearm. DaRosa is 42, 5'6" and 180 pounds.

Harvey Ponce-Gomez (Immigration Violations) – Ponce-Gomez, a native of Nicaragua, was convicted of manslaughter in 1987. Agents have issued a warrant of deportation for him;he was last seen in North Hollywood, California. Ponce-Gomez, who has used the alias Ivan Narvey, is 35, 5'6" and 150 pounds.

Leonard Ray Harper (Murder) — Leonard Ray Harper is wanted for murdering his friend, Jerry Permenter, in August 1997. Harper was seeking revenge when he killed Permenter. Permented struck Harper's pregnant girlfriend, Francesca. After the incident, Francesca decided to abort her baby. About a month and a half after the incident Harper picked Permenter up in his car, drove him to a deserted field, put a gun to Permenter and shot him. Harper and Francesca

hopped on a bus and traveled across the country. Francesca continued to work as a dancer to support their life on the run. Francesca says Harper became more and more possessive. He wouldn't let her out of his sight, and she began to fear for her own life and she was pregnant again. At one point Francesca convinced Harper to let her go to the restroom of a Pizza Hut in Shamrock, Texas. While in the bathroom she used a napkin to scribble a note asking for help. She left the note behind with a manager. He called the police and they pulled over Harper's car a short time later. Harper was arrested and brought back to San Antonio. Harper was officially charged with murder, but bonded out of jail and took off. Before leaving, he threatened Francesca and promised that he would be back for his daughter someday. Harper, who goes by the nickname "Hap", has a scar on his right cheek. He is a Jekyll and Hyde personality who drinks heavily and is often high. He bites his fingernails. Harper may have a trust fund, and his grandmother may be supporting him on the run. He likes sushi and likes to cook. He is a scuba diver. Harper is 32, 5'9" and 160 pounds. (See Show #698, OAD 11/23/02)

Unknown Greer Triple Homicide – On Friday, May 16, 2003 at 1:30pm three innocent people were shot to death at Blue Ridge Savings Bank along Interstate 85, about halfway between Greenville and Spartanburg, South Carolina. The three people inside the bank were Sylvia Holtzclaw, 56, an employee of the bank, and customers James Barnes, 62, and his wife Maggie Barnes, 58. It is obvious from the crime scene that the three victims put up no struggle and they complied with the wishes and demands of the assailant(s). The assailant(s) took money and then fled the scene in a red or burgundy sedan with a Chevrolet Impala, Malibu or Cavalier body type.

Jessi Vega (Murder) -- On November 15, 1998, deer hunters found Tricia Beristain's body on the roadside in a canyon outside Salt Lake City. Police later determined that Beristain had been dating Vega prior to her murder. She was last seen with Vega and another man, Diego Cruz, on the night she died. Cruz was later captured in California. Detectives say Vega took Beristain up into the canyon and executed her with a 9mm handgun because he mistakenly thought she was seeing another man. Police are not sure that "Jessi Vega" is his real name; he has used numerous aliases including Jesse Vega, Jesus Vega, Jesus Alonzo, Jessi Alonzo, Jesus Mungia, Arturo Mungia, and the nickname "Chivo". He has four silver-capped upper front teeth and tattoos including a bullet bandolier across his upper torso from his left shoulder to his right waistline, a Chicago Bulls logo on his upper left shoulder, and a star between his left thumb and forefinger. He is a drifter who works sporadically as a day laborer, and may be a member of the "La Familia" or "Folks" street gangs. He drinks beer, smokes marijuana, and has a history of domestic assaults in Illinois. Vega is 28, 5'5" and 150 pounds. (See Show #717, OAD 5/3/03)

Jose Macias Arebalo (Rape, Child Molestation) – Mexican national Jose Macias Arebalo is suspected of molesting and raping his six-year-old and seven-year-old stepdaughters in April of 2000. Arebalo and his cousin moved from Mexico to the United States in 1993 and settled in Hamilton, Ohio. Three years later, he married and moved in with his new wife and her two daughters. On April 23, 2000, Arebalo's wife was awakened in the middle of the night by the sound of her older daughter crying. When she entered the room, she found Arebalo kneeling over the girl's bed. He told his wife he was putting a blanket on the girl. Later that day the girl confided to a family member that Arebalo had been molesting her. When Arebalo's wife confronted him, he denied the accusation and left the home. He was never seen or heard from

again. The girls were taken to the hospital where it was discovered that both of them had been sexually abused. Arebalo, who has a five-inch scar on the right side of his forehead, usually wears his hair very long. He may find work doing construction, doing dry wall. He is known to carry a 9mm pistol. Arebalo is 29, 5'9" and 180 pounds.

John Evan Mizic (Escape, Fraud, Counterfeiting, Robbery)

Karen Mizic (Accessory After The Fact to Escape) – John Mizic has a long criminal history involving scams, robberies, and cocaine and heroine abuse. He was serving time for a 1998 scam in a Harrisburg, Pennsylvania jail when he met Karen, a mother of three children. She had a boyfriend in the same jail and got to know Mizic. Karen eventually dumped the boyfriend and got involved with Mizic. She married him in jail. From his cell, he was able to control Karen and her children, forcing them to wait for his call before they went out of the house. In March 2001 Mizic was transferred from jail to a halfway house in Harrisburg to complete his sentence. Mizic was a week away from being released when he escaped from the halfway house. On May 7, 2001 he received a weekend social pass from the halfway house to visit his wife, who was undergoing shoulder surgery. When he didn't return on May 9, 2001, Mizic was placed on escape status. The United States Marshals Service learned that Mizic packed up his wife's house and three children, along with computer equipment and one or two dogs, on the morning of May 9. The family took off and has been on the run ever since. USMS have traced the Mizic family to areas of Pennsylvania, Massachusetts, Florida and Virginia. Mizic is back to his old tricks: pulling a counterfeiting check scam. He steals checks in the mail, makes phony ones on his computer and cashes them in banks around the town he happens to be in. In one month he made off with nearly \$70,000. This is how he is able to stay on the run, take his family to Disney World, buy Thomas Kinkaid prints, jewelry and an SUV. His take is well over \$500,000. Authorities are concerned about his step-children's welfare. It doesn't appear they've lived in one town long enough for the children to attend school Mizic, who has used the aliases Jon, Daryl and David Mizic, Jon Misic, Jeffrey Hoffman and Edward Buchanan, has scars on both eyes and his right arm, a rose tattoo on his forearm and an unknown tattoo on his left thigh. He is known to wear pinky rings. Mizic is 46, 6'0" and 275 pounds. Karen Mizic, who has used the aliases Karen Sheeler and Karen Barnhart, has an unidentified tattoo on her chest. She is 36, 5'3" and 130 pounds. The pair may be traveling with the children in a 1994 Ford Bronco with Florida plates F83-LSU. (See Show #692, OAD 9/28/02)

The following are the featured fugitives and others being sought by federal, state or local authorities. The <u>Update</u> (if any) gives current status, previous references, or related information.

Anibal Mustelier (Extortion, Bank Larceny) – In 1989, Mustelier was hired to kill Frank Condom, a Miami businessman. On December 22, 1989, Mustelier and another thug, Nelson Cruz, followed Frank in their car as Frank left a nightclub. As Frank drove home, Mustelier emptied a 30-round clip from his machine gun into Frank's car, then sped away. Frank somehow managed to escape the attack with only a gunshot wound to his arm. Mustelier and his crew weren't done. Mustelier and several other men planned to use a bomb to blow Frank up. On August 17, 1990, Cruz and two other men went to Frank's mother's house and put a bomb under Frank's car. When Frank and his family got into the car, the bombers detonated the device. Once again the attack failed. Frank and several members of his family suffered serious injuries but fortunately none died from the blast. Eventually, most of the group was arrested but Mustelier managed to slip away. Mustelier resurfaced in 1996 when he pulled off one of the largest bank heists in south Florida. Mustelier put together a crew of criminals and was able to get safety deposit box keys made for the Sun Trust Bank. On November 18, 1996, two men went into the bank and got away with approximately 8,000 pieces of jewelry valued at between \$5 million and \$7 million from three different safety deposit boxes. The men gave the money to Mustelier, who disappeared. Authorities believe Mustelier fled to Venezuela shortly after the robbery, but may currently be back in Florida. Mustelier has used numerous aliases including Emilio Suarez, Barrero Musteler, Anibal Musieler, Ramon Llerona, and Anivan Mutelier. He has a small scar on his neck, wears contact lenses or glasses, and is known to keep in shape and work out at gyms. He may be taking ballroom dance lessons or hanging out in dance clubs. There are rumors that he has ties to Castro as a hitman. Mustelier is 52, 5'4" and 135 pounds. (See Shows #664 and #681, OADs 2/9/02 and 6/22/02)

Unknown (Murder) -- 45-year-old Janette Piro and her 42-year-old husband, Chris Benedetto, were native New Yorkers. He was a carpenter and she was an interior decorator. In 1989, Chris was hurt on the job and six years later was awarded a \$2 million worker's compensation settlement. They decided to retire and moved to Singer Island, Florida, north of Palm Beach. With their millions, they bought a new home, a 30-foot boat, expensive fishing

rods, a BMW and kept their home stocked with fine wines and good cigars. They lived the good life on the beautiful and ritzy gold coast of Florida. They were very close to their neighbors. On November 11, 1998, when Janette and Chris failed to show up for a birthday party, neighbors became concerned. Three days later Chris' Toyota 4-Runner truck was found in the parking lot of a nearby hotel. The next day concerned neighbors phoned Chris and Janette's family in New York. Chris' two brothers, who are cops in New York, flew to Singer Island on November 18. The next day, they filed a missing persons report on Chris and Janette. They stayed in the couple's home and passed out missing posters all over town. After five days of no sign of the couple, the brothers packed up the house. While unplugging appliances they came across a three foot deep freezer in the garage that Chris used for bait. Inside, they discovered Janette's frozen body. She was killed and stuffed into the freezer. There was still no sign of Chris. Police are unsure if Chris Benedetto is a suspect or another victim. Detectives believe Chris is probably a victim. Missing are 2 to 4 fishing rods and \$100,000 worth of jewelry, including Janette's four carat diamond ring appraised at \$58,000 and her \$12,000 diamond tennis bracelet. Chris' boat was missing its anchor and 10-foot chain. (See Shows #522 and #681, OADs 12/19/98 and 6/22/02)

William Bradford Bishop, Jr. (Murder) -- Bishop is wanted on five separate counts of murder in connection with the bludgeoning deaths of five members of his family at their home in Bethesda, Maryland. On March 2, 1976, a Forestry Service employee from Tyrrell County, North Carolina responded to the scene of a fire and found the bodies of the Bishop family -- Brad Bishop's wife, mother, and three sons -- buried in a shallow grave. A shovel found at the burial site was traced to a hardware store in Potomac, Maryland and the gas can to a Bethesda, Maryland Sears store. On March 8, 1976 police in Montgomery County investigating the family disappearance found the murder scene. Bishop's fingerprints were matched to those on the gas can. The family's station wagon, used to transport the bodies, was found abandoned near the Elkmont Mountain Campground, just outside Gatlinburg, Tennessee. New information from State Department files indicates that Bishop may have fled with the help of a female accomplice, who may have been on parole from a North Carolina prison. Bishop likes to work out several times per week. He is a strong skier, plays tennis, and is fond of hiking and the outdoors. He is an amateur pilot and enjoys riding motorcycles. He reads extensively and may keep a diary or journal. He is described as intense and self-absorbed, and may be subject to violent outbursts. He may seek psychiatric care for depression or anxiety, and may suffer from insomnia. He likes a neat and orderly environment. He trained as a military intelligence officer, and is well versed in economic analysis and self-hypnosis. He speaks fluent Italian, Serbo-Croatian, Spanish and French. He drinks scotch and wine, and is known to enjoy spicy foods. Bishop is 66, 6'1" and 180 pounds. After AMW aired an age-enhanced bust of Bishop, a viewer gave authorities a prime tip, but didn't leave his or her identity. Authorities want to talk to this person again. (See Shows #180, #217, #335, #346, #537, #538, #550, #578 and #681, OADs 9/13/981, 6/12/992, 10/8/94, 12/31/94, 4/10/99, 4/17/99, 7/17/99, 3/4/00 and 6/22/02)

Mikhail Drachev (Murder, Kidnapping) – Konstantin Simberg was an informant for Phoenix, Arizona Detective Tom Britt. On December 14, 2001, Tom received a call on his cell phone from Konstantin. While on the phone, Tom heard a scream from Konstantin, then the line went dead. Two days later, Konstantin's body was found in Fossil Creek, Arizona - a rural area more than 100 miles from Phoenix. Through his own phone records, Tom learned that

Konstantin called him from a cell phone belonging to an Arizona State freshman named Chris Andrews. Detectives went to Andrews' apartment and found evidence linking him to the murder. 20-year-old Dennis Tsoukanov and 19-year-old Mikhail Drachev were also involved in the killing. All three are acquaintances of Konstantin's. The tree men attacked Konstantin while he was on the phone with Detective Britt. The gang held Konstantin overnight, then drove him to Fossil Creek the next morning. The men stabbed Konstantin in the back with a knife. The men then lit him on fire, covered him with rocks and left him for dead. Andrews and Tsoukanov are in jail awaiting trial. Drachev is currently on the run. Drachev is a Russian national who speaks English without an accent. He may be driving a 1973 Mercedes-Benz 280-SEL with Utah plate 182-XS. Drachev is 20, 5'11" and 170 pounds. (See Show #689, OAD 8/31/02)

CAPTURED:

Derek Todd Lee (Murder) -- Authorities in Zachary, LA sought a suspect in the murder of two women and the attack on two teenagers. On August 23, 1992, Connie Warner, a 41-yearold single, divorced mother, disappeared from her home in Zachary, LA. Tracey Warner, Connie's 17-year-old daughter, returned home from a weekend trip around 9pm and her mother's car was in the driveway, but Connie was nowhere to be found. After waiting for her mother for two and a half hours, Tracey became worried and called her grandfather. When he came over, they searched the house, found blood splatters and called the police. The Zachary Police detectives immediately suspected foul play. They secured the area, began searching for evidence, and started interviewing neighbors and other witnesses. Then, on September 2, 1992, a truck driver found Connie Warner's body in a drainage ditch in Baton Rouge. On April 5, 1993, two teenagers drove to the Buhler Plains Cemetery to "park" for the evening. While a teenage girl, 16, and her boyfriend, 18, were snuggling, someone opened their car door and interrupted them. The intruder attempted to stab them to death with a sling blade. During the attack, a police cruiser pulled into the cemetery to investigate the parked car. The officer scared the assailant away, before he was able to finish his killing spree. At 7:00pm on April 18, 1998, 28year-old Randi Mebruer, a divorced, single mom, went to the local video store with her son and rented some movies. The next morning, her three-year-old son, Michael, went to his neighbors' house and told them his mommy was lost. When the neighbor and her husband entered the Mebruer house to look for Randi, they found blood and called the police. This past week, working off an old tip police obtained a DNA swab from Lee; the technician processing the DNA recognized the pattern as that of a serial killer. Lee, who had fled, was sighted in Atlanta where he was taken into custody. Lee is being questioned in 37 murders. (See Shows #516 and #574. OADs 10/31/98 1/29/00)

The following are the featured fugitives and others being sought by federal, state or local authorities. The <u>Update</u> (if any) gives current status, previous references, or related information.

Chuan "Charley" Cai (Murder) — Charley Cai is wanted for allegedly killing his girlfriend Xiaoyan "Shirley" Liu in Toronto, Canada. Shirley Liu was last seen at a New Year's Eve party in the early morning hours of January 1, 2000. A few days later, after failing to reach her, Shirley's sister became concerned and contacted police. On January 6, 2000 police found Shirley's body stuffed into a suitcase in the apartment she shared with her boyfriend Charley Cai. Shirley had been suffocated and Cai was nowhere to be found. Cai is a millionaire and he and Liu lived together for six years before coming to Canada last year. Police say Liu was in the process of breaking up with Cai. Cai is originally from China, where he made his money in a computer firm. He may be driving a white 1990 four-door Toyota Camry with Ontario license plate AEDC 129. Cai is 29, 5'10" and 140 pounds. (See Shows #575 and #687, OADs 2/5/00 and 8/17/02)

Anatoliy Valenko (Murder)

Vladimir Balachov (Murder) -- Valenko and Balachov are wanted by the New York City Police Department for the 1995 dismemberment murder of their roommates in a Brooklyn apartment. Police say that on November 12, 1995 the two murdered Fakhat Askarov and Fakhat's girlfriend, Larisa Jakovleva during an argument. Then detectives say Valenko and Balachov purchased a circular saw with the victim's credit card and dismembered the bodies. Police located Fakhat Askarov's head and leg and Jakovleva's leg on Plum Beach in Brooklyn. The torsos were located in a mountain reservation in Essex County, New Jersey. Both men are from the Ukraine and speak very little English. They may be hiding out in a Russian community, possibly in California or New York. Both men place personal ads in Russian newspapers to meet women. Both men have worked as carpenters in construction jobs, as a gas station attendant and as a cashier. Valenko is 31, 5'8" and 150 pounds. Balachov is 31, 5'10" and 150 pounds. Following the initial broadcast, AMW received over 80 tips on the pair. (See Shows #529, #530 and #641, OADs 2/13/99, 2/20/99 and 7/21/01)

John Patrick Addis (Murder, Kidnapping) -- Addis is wanted for the 1995 kidnapping and murder of his girlfriend in the Nevada desert. On August 19, 1995, police say Joann Albanese disappeared from her residence in Las Vegas along with her boyfriend, John Edwards. Police later determined that Edwards was in fact, John Patrick Addis, a former Alaskan state police homicide investigator. Police say Addis was working as a personal trainer in Las Vegas, when he became involved in a romantic relationship with Joann. On the day she disappeared, Joann, a single mother of two, was scheduled to have dinner with Addis to inform him that the relationship was over. Joann's car was discovered several days later, abandoned in Little Hell's Canyon near Prescott, Arizona. Police say Addis strangled Joann in a fit of rage and hid her body. Police say Addis has a history of traveling around the country finding work in fitness clubs, so he can meet women, romance them, and live off their money. On July 31, 1998, three years after Joann disappeared, a grand jury in Clark County, Nevada charged Addis with her murder and kidnapping. On October 9, 1998, hunters discovered Joann's body. Police determined she had been murdered. Addis, who has used the aliases John H. Edwards and John Elliott, is an avid body-builder who works in gyms as a personal trainer. He is a small plane pilot, outdoorsman and marksman, and is skilled in forensics and criminal investigation. He believes in UFO's and the god RAH, and often claims he's a science fiction writer who writes screenplays on UFO's. His ex-wives say he has a history of domestic violence and fraud, and he has served time in jail for custodial interference. He is adept at manufacturing false identification and Social Security cards. Addis is 52, 6'0"-6'1" and 200 pounds. (See Shows #519, #555, #571, #641, #687 and #709, OADs 11/21/98, 8/28/99, 1/8/00, 7/21/01, 8/17/02 and 3/8/03)

Vincente Carrera (Attempted Murder, Attempted Rape) – On the afternoon of May 20, 2002, 16-year-old Savannah Cervantes had just arrived home from school when she was brutally attacked by her mother's ex-boyfriend, Vincente Carrera. When Savannah walked in the door, she first called her mother, then went to lie down for a nap. Savannah went into her bedroom, unaware that Carrera had broken into the house and was hiding in her mother's closet. He attacked her when she walked into her room. Carrera pushed her onto the bed and tried to rape her. Savannah fought back, kicking and punching, doing anything in her power to fight him off. He pulled her onto the floor and tried to rape her again. She continued to fight, but Carrera pulled out a large chef's knife and stabbed her several times. He almost cut off her left breast. As she tried to defend herself, the knife cut Savannah's hands and wrists. Carrera also cut and stabbed her legs during the attack. He then tied her hands and feed with shoelace cord and tied her neck to the leg of the bed. Carrera went into the bathroom to clean up. No one knows what he was planning to do next. With several cuts and wounds on her body, Savannah managed to untie herself from the bed. She was losing a lot of blood, but she used her strength and got off the floor. She crawled out of her window and ran. She jumped the 4-foot chain link fence around her yard and crossed the street, collapsing in the flowerbed of a neighbor's home. Neighbors called police and Savannah was rushed to the hospital. Savannah was taken into surgery upon arrival and survived. She's now on a long road to recovery. She still lives in fear, because Carrera has not been caught. Carrera, who speaks mostly Spanish, has an appendix scar on his stomach and a scar on his right cheek. He has a history of physical abuse. During the last few weeks, he has been calling Savannah's mother again. Carrera is 30, 6'0" and 180 pounds.

Shane Matthew Magan (Attempted Murder of a Peace Officer, Armed Robbery) -- Magan is wanted by Riverside and San Bernardino, California authorities for attempted murder of a peace officer and a string of supermarket and convenience store robberies in Southern California. On February 25, 1993 during a suspicious vehicle traffic stop, Magan, who was high on speed, opened fire on a Riverside sheriff's deputy. The officer returned fire, but Magan and his friend, Justin Flint, managed to escape. Minutes later, in nearby San Bernardino County, the two youths robbed a gas station convenience store at gunpoint. Flint surrendered to authorities shortly after the robbery, but Magan remains at large. Magan was spotted in a gang round-up, but authorities at that time did not know Magan was a fugitive from justice. Magan has a noticeable hare lip. He shaves his head, wears black hooded sweatshirts and black caps and fancies himself a Hispanic gangster. He may associate with Pomona's local 12th Street Sharks gang, and may run with a gang of armed graffiti Taggers. He uses amphetamines and speed, and should be considered armed and extremely dangerous. Magan is 25, 5'7" and 145 pounds. (See Shows #299, #335 and #629, OADs 1/11/94, 10/8/94 and 4/14/01)

CAPTURED:

Eric Robert Rudolph (Causing the Death of a Person, Use of an Explosive) -- It's hunting season in the Great Smokey Mountains and there's a price on the head of Eric Robert Rudolph. The FBI doesn't want anyone to shoot their most wanted man, but they are asking hunters to look for trash left behind by the accused abortion clinic bomber. Agents in Murphy, North Carolina put together a sampling of trash they say they've found abandoned by Rudolph. They're asking the thousands of hunters in the area to keep their eyes peeled for Rudolph clues. The woodsman has been burying his trash in an attempt to hide it, but it hasn't worked. Back in the summer, agents actually fingerprinted some of the trash they found and confirmed that it belonged to Rudolph. Inspired by the million-dollar reward, bounty hunters have descended on the area as well, but no one wants to see Rudolph behind bars more than Felicia Sanderson, a widow and mother of two. Her husband, Officer Robert "Sandy" Sanderson was killed by a bomb placed outside a women's clinic in Birmingham, Alabama - a bomb agents say was planted by Rudolph. It took guts, but Felicia traveled to the Smokey Mountains where her husband's killer is believed to be hiding out. She went there to lend her support to the hundreds of investigators working the case. She even used a local radio broadcast to send her plea to the community. Felicia knows that some groups sympathize with Rudolph on political grounds - that they say he was doing "God's work." In response, she doesn't mince words: "God didn't have anything to do with murdering Sandy. Eric Rudolph done that all by himself." Agents say that Eric Robert Rudolph was seen on January 29, 1998, fleeing the scene of the bombing of the New Woman All Women Clinic in Birmingham, Alabama. Immediately after the bomb went off, witnesses saw a man wearing a wig running from the site. Three witnesses saw his truck pull away, and were able to provide a description and a license plate number. The truck was traced to Rudolph, but he had already made his escape. Agents say Rudolph's bomb was loaded with nails - a bomb designed not just to damage property, but to kill and maim. It did both: Birmingham Police Officer Robert "Sandy" Sanderson lost his life. Nurse Emily Lyons was severely injured by the homemade shrapnel - she lost her left eye, lost some of the sight in her right eye, and suffered several broken bones and burns. Despite speculation that Rudolph has been close to extremist groups, friends of Officer Sanderson can't view his death as part of a political action.

Even though Sanderson was moonlighting as a security guard for a family planning clinic, they say he was outside of the abortion controversy - that he was just doing his job: enforcing the law. Rudolph is also wanted for questioning in a series of deadly Atlanta bombings: the 1996 Centennial Olympic Park bombing that killed one and injured more than one hundred others, an attack on an abortion clinic in January 1997 that injured seven, and a February 1997 attack on a gay nightclub. Authorities confirmed that they are investigating similarities in the construction of Rudolph's alleged bomb and the others. In particular, they're investigating a possible match between the nails in the Birmingham bomb and those in the Atlanta bombs. Rudolph has been described as a mysterious and reclusive man from the rugged mountains of North Carolina. Rudolph's truck was found in a pasture near Murphy, North Carolina on February 7, 1998. Though agents believe it's likely that he's taken to the wilderness to hide, they're confident that the \$1 million price on his head will make it hard for Rudolph to hide for long. Authorities also note similarities to Rudolph's known techniques in the bombing of an abortion clinic in Asheville, North Carolina on March 13, 1999. A tipster named Tammy told authorities that her relatives, Dale and Jackie, had been helping Rudolph hide out, but both of the men had died within the past year. Rudolph was forced to go out in the open to fend for himself. A police officer noticed a suspicious-looking man rooting through a dumpster behind a grocery store in Murphy, North Carolina, and took him into custody. The suspicious man turned out to be Rudolph. Further investigation found that many people in Murphy were aware of Rudolph's presence but chose not to disclose his presence. The following are the featured fugitives and others being sought by federal, state or local authorities. The <u>Update</u> (if any) gives current status, previous references, or related information.

Frederick David Russell (Vehicular Homicide) - Russell is wanted by the FBI in Washington State for the June 4, 2001 vehicular homicide of three students and the injuring of three others. At about 4:00pm Russell stopped at a liquor store in Pullman, Washington and purchased a half gallon of vodka that he said was for a friend. Apparently Russell and his friend went to Moscow, Washington, and then returned to Pullman and had a few beers at "My Office Place Tavern". They then left the tavern and headed back to Moscow. On the trip back, at approximately 10:45pm, Russell's Blazer collided with three vehicles, including 1972 Cadillac traveling in the opposite direction. The Cadillac was carrying seven Washington State University students. Three students were killed and three injured in the accident. Two and a half hours after the accident Russell's blood alcohol content was 0.12. Russell did attend a scheduled court appearance, but did not make it to his pre-trial hearing on October 26, 2001. He was last seen on October 23, 2001 in Pullman. On October 26, Russell's father received a letter from his son in which he stated "I am going to go to a state where no one will hurt me." On November 1, three area newspapers received letters believed to be from Russell. The letters to the papers were postmarked October 29, 2001 in Reno, Nevada. Russell, a likely alcohol abuser, usually drinks 151-proof rum. He was also a Washington State University student at the time of his arrest. Russell is 24, 6'1" and 215 pounds. (See Show #675, OAD 5/11/02)

Andre Neverson (Wanted for Questioning for Murder) – On Monday, July 8, 2002, NYPD cops arrived at the Brooklyn home of 39-year-old Patricia Neverson. She was found, shot to death. Three days later, on July 11, cops found the body of 34-year-old Donna Davis. Authorities have learned that Andre Neverson had an ongoing argument with his sister, Patricia, stemming from Andre's money which she used to buy her home. Neverson did not want the money repaid; instead, he wanted the house. Donna Davis had been dating Andre, but she had recently broken off the relationship. Neverson did not take the rejection well. The last time Donna was seen alive, she was in Andre's minivan outside a Queens, New York college where she studied. Days after the second murder, cops placed Neverson in Brooklyn, but after that, the trail runs cold. Neverson has used numerous aliases including Troy Michael Anderson, Troy

Michael Henderson, Trey Michael Henderson, Andre Humphrey and Andre Henderson. He has a very muscular build and a shaved head, but he may be starting to grow hair again to change his appearance. He does not drink or smoke, is very intelligent and computer literate. At times he is very calm and serene, but he has a violent temper and has served time for attempted murder. He does not drink or smoke, and may be hidden now by one of his many girlfriends. He is originally from Trinidad, but does not have an accent. He has worked as a bouncer in Caribbean clubs and as a security guard at a hospital. He has been know to buy cars, fix them up, then resell them. He may still be armed. Neverson is 39, 6'0" and 225 pounds. (See Shows #684 and #697, OADs 7/27/02 and 11/16/02)

Edward Santana (Murder) – Guiselle Rojas, 39, was returning home from a dance club shortly after 12:00am on June 13, 2002, when she was ambushed on the way into her house by Santana, who dragged her into the grass and stabbed her more than fifty times with a screwdriver. Guiselle met Santana when they were paired up at a salsa class, and often went to clubs to dance with a group of friends. Santana persistently and openly courted Guiselle at these classes and gatherings until she finally decided to go on a date at the encouragement of friends. While on trip to Las Vegas, Santana and Guiselle got into a physical altercation. Guiselle decided to end the relationship and Santana violently threatened her. Guiselle was very afraid of this new side of Santana and had a restraining order put on him. It was soon after this that Santana lay in wait and killed her. Police believe that Santana will continue to attend salsa lessons and frequent salsa clubs. He has no bank or credit cards, but is known to have lived in Las Vegas, New York, Florida and Mexico. Santana is short, has a very dark complexion, speaks English with a Puerto Rican accent, has a pronounced scar on the back of his neck, and is a heavy drinker. He drives a 2000 silver Toyota Camry with California license plate 4NNY927. He has uses the aliases and nicknames Juanito, Juan and Pierre. Santana is 51, 5'7" and 169 pounds.

Unknown Molly Bish Killer – 16-year-old Molly Ann Bish was last seen on June 27, 2000 in Warren, Massachusetts. She was employed as a lifeguard at Comins Beach, a small public beach. Her mother dropped Bish off for work at 10:00am, and that was the last time she saw her. Authorities are searching for a man who was seen in a white vehicle in the area on multiple mornings, including the day before Bish disappeared. Bish generally worked alone during the week. Around 10:20am on the day of Molly's disappearance, swimmers noticed that she was not there, but saw her belongings – a towel, water, first aid kit, sandals and her lunch – on the beach. The man who is wanted for questioning is heavy-set, with dark hair with gray highlights. In May 2003 a hunter walking through some woods five miles from where Molly disappeared found some scattered remains. Police scoured the area and found 22 bones. On June 9, 2003, the remains were confirmed as Molly's. (See Shows #595, #604 and #628, OADs 7/15/00, 9/16/00 and 4/7/01)

David Bieber (murder) -- Danielle LaBelle, Marcus Mueller and David Bieber met at a gym in Florida. The two men imported and sold steroids to other body builders. Mueller's romance with LaBelle was sidetracked by the fact that he hadn't divorced his wife back in Germany. Danielle turned to David Bieber to make Marcus jealous. After a few weeks, Danielle married Bieber. Bieber, jealous because of his rival's continued interest in his wife, threatened Mueller repeatedly. Through a fellow body-builder, Bieber found a hitman in 17-year-old David

Snipes who agreed to kill Mueller for \$1,000. The murder took place just six days after LaBelle and Bieber were married. The marriage broke up soon afterwards. Bieber began stalking his exgirlfriend and again hired Snipes to kill her. However, this time all the shots missed their intended target. Two of the men involved in the hits are awaiting trial, but Bieber is still on the loose. He frequents gyms and may still be dealing steroids. Friends spotted him in December in Ft. Myers, Florida, driving a black Toyota 4-Runner. He was last seen in a 1990 Pontiac Trans Am. Bieber is 37, 5'10" and 250 pounds. He also goes by the nickname "Beav". (See Shows #397, #435, #582 and #661, OADs 2/10/96, 1/4/97, 4/1/00 and 1/19/02)

Unknown Miami Child Rapist - Miami-Dade police are seeking a serial rapist who is targeting mainly young, school-age girls. DNA has lined the same man to the rape of at least four females in the Miami area, and he may be responsible for at least two others. The first known attack was in September of 2002. The victim was a 21-year-old woman. Then, three months later in December 2002, a 55-year-old woman was raped. On May 15, 2003, the rapist struck again. A 13-year-old was attacked when a man grabbed her throat and dragged her behind her house to sexually assault her. A couple of weeks later, on June 2, 2003, an 11-year-old, who opened the door to a stranger's knock, became the next known victim. Police speculate that another girl, a 12-year-old who was raped on June 9, 2003, is also a victim of the rapist. DNA results have not yet returned from the lab. The sixth possible victim is a 79-year-old woman who was raped in May 2003. There is no DNA evidence in this case, but police are continuing the investigation. The suspect speaks Spanish with a heavy accent, and may be Mexican, Honduran or Nicaraguan. He has extreme acne scars or pockmarks on his face, has a neatly trimmed mustache, and is described as having a small penis. He has worn the same shirt, blue with yellow spots and triangular shapes inside the spots, in at least two of the assaults, wears a gold chain with a small cross pendant and a ring with a small white stone strung on the same chain, a watch on his left wrist with a silver chain-link wristband, black face and silver hands, and a brown belt with a large oval silver belt buckle. The suspect is 30-45 and 5'2"-5'9".

Jennifer Servo Killer (Homicide) – 22-year-old Jennifer Servo was less than three months into her first full-time job as a TV reporter for the Abilene, Texas NBC station when her colleagues noticed that she was not responding to phone messages at her home. They asked her apartment manager to check on her and that's when she was found dead. Servo had been strangled and had suffered a head trauma. Jennifer was found fully clothes, but an autopsy turned up bruises on her body that indicate she had been sexually assaulted before she was killed. Missing from her apartment was a "Guess" purse with a photo of Anna Nicole Smith on it, three seasons of "Sex In The City" and "Saving Private Ryan" on DVD, and a Kyocera brand cell phone. (See Show #697, OAD 11/16/02)

Donald Lee Barto (Rape and Child Molestation) – Barto was investigated by the Pennsylvania state police and subsequently charged with sexually molesting a family member on a regular basis for a period of approximately four years. He is currently charged with 132 counts of rape and sexual molestation of a child with another possible 60 counts forthcoming. Barto failed to appear fro court on October 14, 2002 and fled in November 2002 with the help of friends and family members. Barto, who has used the alias Charles H. Barto and the nickname "Duck", frequently changes his appearance by shaving his face or head. He is an experienced carpenter specializing in home remodeling and repairs, but is unable to read or write and does not

have a driver's license. He loves hunting and fishing, is known to gamble in Atlantic City, and drinks and smokes cigarettes. Barto is 59, 5'9" and 170 pounds.

Calvin R. Sinclair (Murder) – Sinclair went to the home of his girlfriend, Shantel Armstrong, on July 4, 2001 to collect money she owed. When they began to argue Sinclair pulled out a gun and began shooting Shantel. That's when her mother, Dorothea, jumped between the two and was also shot. Both women later died at Charity Hospital in New Orleans. Detectives believe that Sinclair left New Orleans immediately after the shootings. He was born in Uganda but moved to the United States as a child. However, he may be trying to get to Uganda to hide. Sinclair has an extensive criminal record which includes arrests for battery of a woman and possession of crack cocaine. Sinclair has a scar down the inside of his left arm, several gold teeth, and "God" tattooed on his right arm. He is 30, 4'7" and 135 pounds. (See Show #675, OAD 5/11/02)

Lenard Williams (Murder) – On March 31, 2003, Williams and another man were arguing in a park when Williams stabbed and killed the victim. He is wanted for second degree murder, and may still be in New Orleans. Williams, who goes by the nickname "Boogie", has an "L" tattooed on his right arm. Williams is 42, 6'1" and 198 pounds.

CAPTURED:

Duane Brown (Vehicular Homicide) – Brown is wanted for killing two people in a fiery motor vehicle accident on June 29, 2002. Palm Beach, Florida narcotics detectives saw Brown make a car-to-car drug buy. Brown's girlfriend, Porsha Davis, and another friend, Jerome Maynor, were passengers in Brown's vehicle. Uniformed officers were called in to stop Brown's car. When the officers pulled behind him and attempted to make the stop, Brown took off, traveling at speeds over 100 mph. The police did not continue the pursuit. A short time later, Brown crashed his car into a concrete utility pole. Shortly after police arrived, the car exploded. Brown survived, but both of the passengers in his car died as a result of the wreck. Brown was subsequently charged with causing the two deaths. After the accident, Brown was hospitalized and his right leg was amputated. During his stay in the hospital, he was fitted for a prosthetic leg. Brown left the hospital before he could be arrested. Four days after the broadcast, Brown turned himself in. (See Show #720, OAD 5/24/03)

Martin Andrew Wisby (Murder) – On October 21, 2000 Shawnee, Oklahoma detectives found Sandra Brown's decomposing body in a house she was renovating. Sandra hired Martin Wisby, who is described as a transient, to help do odd jobs around her properties. Other employees complained about him and expressed distrust for him. Sandra took Wisby to one of her properties on October 16, 2000 around 1:00pm in her 1990 white Nissan pickup truck. On October 19, 2000 Sandra's mother reported her missing. Police suspect Sandra died of blunt force trauma to the head. Her pickup truck, bearing Oklahoma license plate FEW-982, has not been found. Wisby has unknown tattoos on both arms. He is a known amphetamine user. Wisby is 29, 5'11"-6'0" and 165 pounds. (See Show #635, OAD 6/2/01)

Angel Tello (Robbery, Aggravated Assault) – Angel Tello and Javier Carrasco robbed a Whataburger fast food restaurant on September 29, 2000. Deputy Sheriff Mario Quintinilla observed the stolen white four-door car speeding on Route 10 and began his pursuit. Tello and Carrasco hit the curb of a parking lot and jumped out of the car. The car continued to roll and crashed into a Goodwill store. The deputy discharged his weapon and shot Carraso because both Tello and Carrasco had guns, and Carrasco was running towards him. Tello continued to run behind a Western Auto store and jumped over a bayou, escaping the scene. Angel Tello has been missing since the incident and allegedly took Sara Cates, a 13-year-old girl, with him. She is now 15 and might be pregnant with her second child. They might be living in New Mexico or Mexico.. On June 3, 2002 Javier Carrasco pled guilty to the rime and was sentenced to 10 years for the robbery and 10 years for the assault on Quintinilla. Tello, who has used the alias Angel Baccera, is member of the East Side Chellos street gang and probably has a gang tattoo. He is 21, 5'7" and 130 pounds. (See Show #701, OAD 12/21/02)

Michael J. Coppola (Murder) – In the early morning hours of Easter Sunday, 1997, John "Johnny Cokes" Lardiere was murdered gangland style outside a hotel in Bridgewater, New Jersey. Police knew Lardiere was a member of the Genovese crime family but it would take

almost twenty years for them to get a break in the case. That break came in 1996 when another mobster who had been arrested on murder and extortion decided to cooperate with authorities. The mobster told police that Lardiere's killer was Michael Coppola, who was now a top man in the Genovese organization. However, authorities knew they had little weight with the testimony of their informant so they decided to take another look at the evidence. That's when they realized that hair samples had been preserved from a hat found at the scene of the crime. The hair was sent to the FBI lab in Quantico, Virginia where DNA was successfully extracted. A judge then gave a court order for Michael Coppola to provide saliva samples on August 8, 1996. Michael Coppola never showed for his scheduled date. He has since been charged with the murder of John Lardiere. Coppola, who has used the nicknames Mikey Cigars, Filma and Little Mike, is a workout enthusiast who runs and cycles. He is very fit and muscular for his age, and as an avid golfer may be living in a warm climate. He is known to gamble. He has a thick New Jersey Accent, is well groomed and extremely neat, and may smoke a cigar occasionally. Coppola is 57, 5'7" and 160 pounds. (See Show #697, OAD 11/16/02)

Rufino Castaneda (Rape) – It all began the evening of November 1, 2000 at a strip mall pub in Mishawaka, Indiana. "Tiffany" was taken by force away from the bar. Two men kidnapped her, put her into a car and began driving away from the scene. Authorities haven't yet identified the driver. Rufino Castaneda sat in the back of the car, restraining and hitting "Tiffany". They drove "Tiffany" to Castaneda's ex-girlfriend's home. Castaneda, who has used the alias Rufino Castaneda Nova and goes by the nicknames Alejandro, Alex and Rufo, has noticeably acne scarring on his face and may also have an arrow-shaped scar on his face. He is a Mexican national who speaks English poorly, smokes marijuana, and may be working as a day laborer. Castaneda is 28, 5'6" and 150 pounds. (See Show #716, OAD 4/26/03)

He has previously tried to fake his own death. Andrade is 39, 5'8" and 165 pounds.

The following are the featured fugitives and others being sought by federal, state or local authorities. The <u>Update</u> (if any) gives current status, previous references, or related information.

Jorge Alberto Lopez-Orozco (Murder) – On August 11, 2002, police officers found a burned out car. Inside the car, they found three bodies: 29-year-old Rebecca Ramirez and two of her young children. All three bodies had been shot to death, dumped into a car which was set on fire. Jorge Alberto Lopez-Orozco had dated Rebecca but the relationship had recently ended. Authorities believe the motive for the murders may have been the termination of the relationship. Lopez-Orozco, who has used the aliases Paul Solario and Raul Solorio, as well as the nickname "Pepe", wears his hair collar-length and likes to wear cowboy-style clothing and a white cowboy hat. He may be traveling with his wife, Juana, his infant son Jorge, Jr. and his daughters Anna Louisa and Maria. Although he is married, he has had numerous extra-marital affairs. He is a known drug user. Lopez-Orozco is 27, 5'7" and 175 pounds. (See Show #689, OAD 8/31/02)

Chaka Raysor (Murder, Racketeering, Conspiracy, Drug Charges) -- Chaka Raysor is wanted by the Bureau of Alcohol, Tobacco and Firearms and the United States Attorney's Office in the Eastern District of New York for murder, racketeering, and conspiracy to distribute crack cocaine. In 1985, investigators say Raysor and his brother Umeme formed a ruthless drug gang in their Bedford-Stuyvesant neighborhood of Brooklyn. At its peak, agents say the organization raked in over \$90,000 a week dealing crack cocaine in Brooklyn, Maryland, Delaware, and Norfolk, Virginia. The federal indictment also charges Chaka Raysor with a total of nine murders. But agents believe the Raysor organization committed more than forty homicides during their ten-year reign of terror. On the streets of Brooklyn, the gang was known as "The Killers". Agents say Raysor mesmerized his gang members with fiery, Black Panther-style rhetoric, and maintained their loyalty with an iron fist. they say during their reign of terror the ruthless Raysor gang murdered innocent local residents, rival drug dealers, landlords, and a homeless man. On April 27, 1998 Umeme Raysor was convicted of federal racketeering, narcotics conspiracy and murder charges, but his brother Chaka remains at large. Chaka Raysor has used the aliases Charles Herbert Raysor, and the nicknames "Chik", "Chak", and "C". He is usually heavily armed, and is skilled in martial arts. Raysor has a stocky, powerful build, closecropped hair and a beard, and a glass left eye with a scar underneath. He is described as ruthless, manipulative, charismatic, and extremely violent. Raysor is 33, 5'10" and 200 pounds. Viewer tips placed Raysor in Williamstown, South Carolina, but authorities were unable to locate him. (See Shows #517, #535, #559, #560, #561, #562, #571, #573, #582 and #613, OADs 11/7/98, 3/27/99, 9/25/99, 10/2/99, 10/9/99, 10/16/99, 1/8/00, 1/22/00, 4/1/00 and 12/16/00)

Shango Raysor (Wanted for Questioning) – Shango Raysor is wanted for questioning in a series of armed taxi cab robberies in New York City. Detectives believe that Shango may be traveling with his brother Chaka Raysor, the reputed head of a drug organization who was charged in a federal indictment with crack cocaine distribution in Brooklyn, Maryland, Delaware and Virginia. Agents believe the Raysor organization may have committed more than forty homicides during their ten-year reign of terror. Another Raysor brother, Umeme, was convicted of federal racketeering, narcotics conspiracy and murder charges. Chaka Raysor has been profiled on AMW 11 times since November 1998. Finding Shango may lead to the arrest of his infamous big brother Chaka. Shango Raysor sometimes wears his hair in cornrows. He is 26, 6'1" and 170-180 pounds. (See Show #613, OAD 12/16/00)

Leonardo Anselmo Cisneros (murder) -- Cisneros was persuaded by Denise Davidson, a former swimsuit model, to murder her ex-husband, pediatrician Dr. Louis Davidson for his life insurance money. Cisneros enlisted the aid of two hitmen, who bludgeoned Davidson to death in his home. Suspicion immediately fell on Denise Davidson. Police surveillance revealed that Davidson wired money to one of the hitmen, and that Cisneros had called the hitmen's beeper repeatedly. Cisneros fled back to Jamaica. Clothing left in a motel room by the hitmen was traced as being purchased by Davidson. She and the two hitmen were taken into custody. All were convicted of first degree murder. Cisneros is still at large. He is a native of the Dominican Republic who likes the nightlife throughout the Caribbean, south Florida and Central America. He holds a British passport and may be using the alias Paul Joseph Harvey. Cisneros is 41, 6'1" and 210 pounds. No suggested changes. (See Shows #405, #470 and #578, OADs 4/13/96, 10/18/97 and 3/4/00)

Dara Marie Llorens (Interference With Child Custody) – Llorens abducted her 5-yearold daughter, Sabrina Allen, on April 20, 2002 in Austin, Texas. Llorens was unhappy with her visitation arrangement and abducted her own child. Dara was married to Greg Allen, an Austin engineer, for three years. Sabrina was their only child. During the divorce proceedings Dara was diagnosed by a court-appointed psychologist as suffering from a personality disorder and on his recommendation Greg Allen was awarded sole custody of their daughter. Dara began lodging a series of allegations with Child Protective Services that her ex-husband was abusing Sabrina. CPS investigators ruled that there was no evidence of abuse. They were suspicious that Dara was fabricating these allegations and ordered her into therapy. Shortly after this, Dara and Sabrina vanished. Llorens, whose numerous aliases include Deena Marie Guerro, Deena Lamont, Deena Patel, Deena Groves, Deena Patterson, Deena Green, Dara Marie Rose, and the nickname "Marie", has pierced ears, a long deep scar on the back of her right knee, and scars from surgery on both Achilles tendons. She walks with a slight limp from cerebral palsy as a child. She is left-handed, speaks poor Spanish, and typically works in clothing and shoe retail, as a waitress, in auto sales, jewelry sales, secretarial work, child care, cake decorator, and as a livein nanny. She has a history of melanoma. She can be charismatic and charming, but can be volatile, yelling, stomping and slamming doors. She often tells dramatic stories to elicit

sympathy. Llorens is 33, 5'6" and 100 pounds. A Mexican pre-school teacher informed authorities that Sabrina was one of her students, but before authorities could move in, Llorens and her daughter had vanished again. (See Shows #695 and #718, OADs 11/2/02 and 5/10/03)

Jose Sanchez-Guillen (Murder) – Sheriff's deputy Saul Gallegos, 35, stopped a car belonging to Sanchez-Guillen, to whom Gallegos wanted to speak to for driving with a suspended license. Minutes later Gallegos was found with a gunshot wound to the head and his service pistol missing. He died moments later at the scene. Later police found the beige station wagon that Sanchez-Guillen had been driving. He may now be driving a white Ford Explorer with Washington license plates 275HIO or a white 1994 Chevy sedan. Police have arrested Sanchez-Guillen's mother for allegedly aiding her son. He may be getting other help as well. Police are searching for him from Washington State to northern Mexico. Sanchez-Guillen has shaved his head and may have a goatee. He may have the slain officer's weapon. Sanchez-Guillen is 21, 5'6" and 140 pounds.

Rufino Castaneda (Rape) – It all began the evening of November 1, 2000 at a strip mall pub in Mishawaka, Indiana. "Tiffany" was taken by force away from the bar. Two men kidnapped her, put her into a car and began driving away from the scene. Authorities haven't yet identified the driver. Rufino Castaneda sat in the back of the car, restraining and hitting "Tiffany". They drove "Tiffany" to Castaneda's ex-girlfriend's home. The driver left, but Castaneda pulled "Tiffany" into the home. Once inside, Castaneda sexually assaulted "Tiffany" and physically attacked her repeatedly. "Tiffany" fought back and escaped, probably saving her own life. When they arrived on the scene, "Tiffany", clothed only in a cardboard box, led them to the home where she had been attacked. Further investigation linked Castaneda to the scene and he was charged with the crime. Castaneda fled immediately. He was last seen the day before the attack at his job in Bremen, Indiana. He abruptly quit his factory job. He hasn't been seen since. Castaneda, who has used the alias Rufino Castaneda Nova and goes by the nicknames Alejandro, Alex and Rufo, has noticeably acne scarring on his face and may also have an arrow-shaped scar on his face. He is a Mexican national who speaks English poorly, smokes marijuana, and may be working as a day laborer. Castaneda is 28, 5'6" and 150 pounds. (See Shows #716 and #724, OADs 4/26/03 and 6/21/03)

AMW ALL-POINTS BULLETIN:

Richard Steve Goldberg (Child Molestation) – Goldberg molested six young girls under the age of ten. He reportedly gained the trust of the neighborhood parents, then became a babysitter and "friend" to kids in the area. The single man set his home up in a way that would attract children. His backyard had swings and a cage with rabbits and ducks. Inside the house, Goldberg had children's computer games that he would allow them to use, kid's music, art supplies, and even children's soap. He would also take them to Disneyland, parks, lakes, etc. Goldberg was found out after two young girls playing on his computer saw an image of two of their young friends naked, including the next door neighbor. A full investigation was launched and six neighborhood kids reported being assaulted by Goldberg. Child pornography was found on his computer, including a photo of him having sex with children. After cops came in to search his house and took his computer away, Goldberg fled the area in late June. In early July,

after finding evidence on the computer, police issued an arrest warrant for him. Authorities know he visited his parents in Rumson, New Jersey, shortly after running. There is evidence he was also in Las Vegas, and Bullhead City, Arizona. Goldberg's hair is jet black but would be gray if he didn't dye it. He has a receding hairline. He used to work at Boeing before being laid off. He likes outdoor activities and was the president of a gun and revolver club in Long Beach, California. Goldberg is 57, 6'0" and 160 pounds. (See Shows #665, #680 and #707, OADs 2/16/02, 6/15/02 and 2/22/03)

Jenny Liang (Murder) – Liang and her boyfriend Patrick Sheen were together over a year when they bought their home in Las Vegas, Nevada. Patrick owned his own insurance company, and Jenny worked as a dealer at the Mirage Casino. Jenny's 14-year-old son lived at their home and attended school in the area. Patrick's sister Ruby was close with the family. She visited her brother often and they had a very close relationship. On October 2, 2000 Jenny called Dennis Lam at the insurance company to tell him that Patrick would not be at work that day. Later that evening Jenny called Dennis again and said Patrick would be out of town for a meeting and would not return until Friday, October 6, 2000. The same day Jenny called Dennis, she also called her work and spoke to a scheduler at the Mirage. Jenny called out sick from work on October 2 and 3. Then on October 4, Jenny called the Mirage again and said she was hospitalized and would not be able to return to work. Shortly after that phone call, Jenny picked up her 14-year-old son and dropped him off at her ex-husband's house. She also gave her exhusband and her son the 1999 Mercedes-Benz she owned with Patrick. She told her son he would have to take care of himself and that she had to go. Within this week Ruby, Patrick's sister, told cops she was trying to contact him and his family, but no one could be reached. On October 11, 2000, Ruby was getting nervous and she called the police station to file a missing person report on her brother. It wasn't like him not to call or stop by her house. The police, Ruby and a locksmith went to Patrick's home. As soon as they entered they knew there was a problem because of the smell that was coming from the bedroom. The cops found Patrick's body in his bed. He had been shot multiple times in his head with a .357. Patrick's fingers were starting to mummify, the home was not ransacked, there was no forced entry, and there was \$925 in his pocket. The only thing missing was Patrick's girlfriend, her son, and their Mercedes. An investigation tracked Jenny to Los Angeles where she made a withdrawal from an ATM and purchased a plane ticket to Hong Kong. She may be in China, and may be using the names Zhen Yu Liang or Yu Zhen Liang as aliases. Jenny Liang is 40, 5'2 and 110 pounds. (See Shows #671 and #698, OADs 4/6/02 and 11/23/02)

Unknown Fran Jones Killer (Murder, Robbery) – Cleveland police are looking for the unknown killers of 62-year-old Frances Jones. Fran was gunned down in her driveway on Monday, February 4, 2002 in the early evening hours. Fran interrupted a burglary in progress at her home. After she caught the robbers red-handed, they used a semi-automatic handgun and shot Fran three times. She died in her driveway. Fran was a volunteer with Fox Channel 8 (WJW Cleveland). She was a "Call To Action" group volunteer. Fran had worked all day with the "Call To Action" phone center on Monday. The robbers broke in while she was at WJW. When Fran's husband came home around 7:45pm, he at first thought it was the chemotherapy treatment for colon cancer that caused her collapse in their driveway. It wasn't until he tried to revive her that Donald Jones, 66, realized his wife had been shot. There were two distinct and separate footprints left in the Jones family back yard in the snow. The killer stole a knife from

the home, but it was found on the driveway near Fran's body. They may have threatened Fran with it and dropped it as they fled. (See Show #680, OAD 6/16/02)

Dara was married to Greg Allen, an Austin engineer, for three years. Sabrina was their only child. During the divorce proceedings Dara was diagnosed by a court-appointed psychologist as suffering from a personality disorder and on his recommendation Greg Allen was awarded sole custody of their daughter. Dara began lodging a series of allegations with Child Protective Services that her ex-husband was abusing Sabrina. CPS investigators ruled that there was no evidence of abuse. Leanna Warner

Age: 5 Height: 3'2"

Weight: 48 pounds

Leanna was last seen at her home at 5:00pm on June 14, 2003. she told her mother she was going to visit a friend who she regularly visits and who lives a short distance from their house. Leanna usually checks in with her parents every 20 minutes. After she was gone for 45 minutes Leanna's parents began looking for her. After searching for hours, her parents realized she was missing and called 911. Police believe this is an abduction and have now set up a command center. After an exhaustive search, police did not find any clues as to where she may have gone. Due to the lack of any evidence of an accident, police are now focusing on the possibility of foul play, including an abduction. Leanna, who goes by the nickname "Beaner", was last seen wearing a sleeveless dark blue denim dress.

CAPTURED:

Andrew Luster (Rape, Kidnapping) - Cosmetics heir Andrew Luster is a serial rapist. He has a history of meeting women in bars, bringing them home, drugging them, raping them,

and then videotaping his exploits. Sheriff's investigators were called to Luster's home two years ago after a college student accused the wealthy playboy of drugging and sexually assaulting her. At the home they did not find GHB but they did find six bottles labeled "Spanish Fly Hypnotic Hypo-Knock-Out Drops". They also recovered a video camera and 17 videotapes which depicted Luster raping two unconscious women. Luster was charged with 87 counts including sexual battery, sodomy, drug possession and poisoning. Luster has been under house arrest for one year. His bail was set at one million dollars. Luster pleaded not guilty to all charges, claiming it was consensual sex. On December 16, 2002 the trial began. A former girlfriend of Luster's wept on the stand as she reviewed a tape of her being raped by her former boyfriend. There were several other women who came forward to tell their horrific tales. On January 6, Luster failed to check in with his probation officer and violated his bail. He was scheduled to appear in court that day but never showed up. An arrest warrant has been issued for the millionaire sexual predator. On January 21, 2003, Andrew Luster was convicted on 86 criminal counts. Bounty hunters tracked Luster to Puerto Vallarta, Mexico, where he was taken into custody. He has been returned to the US to begin serving his sentence. (See Show #704, OAD 1/25/03)

Jesus Mesquia (aka Unknown Mia Zapata Killer) (Murder) – Mia Zapata, vocalists for "The Gits", a progressive punk band, was brutally murdered and raped on July 7, 1993 in Seattle, Washington. She had gone out to the Comet tavern and was hanging out with her friends. Mia left and headed down Pike Street to her friend's apartment in the Capitol Hill area. She may have left the apartment and walked to the cab stand at the intersection of Pike Street and Broadway. She was known to take cabs frequently. She may have accepted a ride from an acquaintance. Robbery did not appear to be the motive since all her jewelry was on her. She was found at approximately 3:15am, two miles from where she was last seen. DNA evidence which had been kept on file since the murder was tested through CODIS, which identified Mia's killer as Jesus Mesquia. He has been charged with Mia's murder. (See Show #371 and #456, OADs 7/8/95 and 6/28/97)
