SUBJECT: **AMERICA'S MOST WANTED** – Show #738 (MW-1704) OAD 10/4/03

*The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.*

**Steven Timothy Mercer** (Murder, Armed Carjacking) – On the night of August 13, 2003, Monti Cohen and his fiancée, Tasha Taylor, were sitting in their SUV outside a friend's house when Steven Mercer approached the vehicle. After a brief conversation, Mercer walked away but quickly came back to the car. Tasha noticed a gun in his waistband and told Monti about the weapon. Monti swung his door open, knocking Mercer backwards and an altercation ensued. Tasha began screaming for help. Instead, Mercer's cousin, Leslie Bryant, rushed to the scene, with a gun drawn. Mercer then shot Monti in the head, put his body in the back of the SUV and drove off with Tasha still inside the vehicle. While driving, Bryant realized Monti was still alive and shot him eight more times. In a desperate act to save her own life, Tasha opened the door and bailed out of the moving vehicle. She safely ran to a nearby business and called 911. Mercer and Bryant dumped the vehicle several blocks away and took off. Leslie Bryant turned himself in to police less than a week later. Mercer fled on a Greyhound bus and hasn't been seen since. Mercer, who has used the aliases Rodney Walker Mercer and Eric Marshal, and goes by the nicknames Tim or Timmy, has unknown tattoos on his left arm and left chest. He has previously served time in prison for armed robbery. Mercer is 33, 6'1' and 180 pounds.

**Wanted for Questioning** – The FBI is trying to locate an individual who is wanted for questioning in the Brian Wells Killer/Pizza Bomber case. According to witnesses, this person was seen dashing across a busy street near a wooded area that Brian Wells was directed to go to in a note found after his death. Wells, a pizza deliveryman, was discovered with a bomb locked around his neck after robbing a local bank. He told police he was forced to rob the bank, and that the explosive device had been placed on him by someone else. That bomb went off, killing him, while he was begging police to free him. After Wells' death, police discovered a note on his person that instructed Wells to go to four locations after the bank hold-up. All four were within a couple of miles of the bank. Police have not released what Wells was to do at each location. Authorities are still trying to determine whether Wells was a willing participant or a victim. The person wanted for questioning had a Dutch boy style haircut, which may have been a blond wig. Another potential twist: Robert Paneti, a friend and co-worker of Wells', was found dead,

apparently of a drug overdose. However, there is no evidence to link the two deaths. (See Shows #734 and #735, OADs 9/6/03 and 9/13/03)

**John Stoneman (Rape of a Minor, Child Pornography)**

**Patricia Kelley (Rape of a Minor)** – Stoneman and Kelley are wanted for the rape of a minor. The pair videotaped their sexual assault of a profoundly handicapped four-year-old child. Kelley was a Licensed Practical nurse charged with the daily care of a four-year-old disabled girl. The victim suffers from spina bifida, hydrocephalus, diabetes and a seizure disorder that leaves her blind and unable to communicate or move. Cops first began investigating Stoneman when child pornography found during a case in Orange County, California was linked to a computer in his Cambridge, Ohio home. Police arrested Stoneman, but he quickly posted bond for those child pornography charges. Subsequent searches of the home that he and Kelley shared uncovered many more crimes, including the videotape of the assault on the disabled four-year-old. They also discovered a two-way mirror with a video camera behind it, used to videotape minors changing clothes. Authorities are still determining how many juveniles were victimized by this couple. Stoneman failed to appear for a hearing on the initial pornography and weapons charges. The pair fled together, and were last seen driving a light-gray four-door 1996 Saturn with Ohio plates DU 27 SX. Stoneman, who has used the aliases Randy D. Wackbacher and Randy D. Weckbacher, has a receding hairline. He is a smoker, has glaucoma and always wears sunglasses, even inside, and takes medicine and eye drops for his condition. He may have changed his hair color and style. He may be frequenting gun shows or firing ranges, and may be working as a handyman. He should be considered armed and dangerous. Stoneman is 38, 5'9" and 160 pounds. Kelley, who has a very visible scar across her throat from a knife wound, has used numerous aliases including Patricia A. Dowell, Trish A. Dowell, and Trish Kelley. She may have changed the color and style of her dyed-blond hair. She may still be working as a health care provider. She too should be considered armed and dangerous. Kelley is 39, 5'3" and 150 pounds.

**Anthony Craig Lee (Murder)** – On September 18, 2003 at approximately 5:30pm, Lee approached 48-year-old Jose Calvo who was in his car, backing out of his driveway. Calvo's wife Denise and one-year-old son were also in the car. Lee pointed a gun at Calvo and demanded the keys to the Mercedes. That's when Denise reached for a gun that was kept under the passenger seat. When she sat back up, Lee had shot Calvo in the head. Denise began shooting at Lee and chased him as he escaped to his car. She kept shooting at him as he sped away, blowing out the back window and possibly hitting Lee. Lee sped down Coconut Grove Street in Miami to the Kingsway Apartments where he ditched the car he was driving, a Honda Civic, and jumped into a dark blue Ford Taurus or Mercury Cougar that was waiting for him. Calvo died of the gunshot wound to his head. Besides the couple's one-year-old son, he leaves behind a seven-year-old daughter from a previous marriage. Lee has unknown tattoos on his upper body. He is 31, 5'4"-5'6" and 165 pounds.

**Pete Rudy Marron (Murder)** – On September 19, 2003, after the San Francisco Giants vs. the Los Angeles Dodgers baseball game at Dodger Stadium, Mark Antenoracruz headed back to his car in the parking lot. He was with his brother and sister. He was confronted by Pete Marron, who was mad that Mark was a Giants fan. The two men fought and the Marron pulled a gun and shot Mark twice in the chest. He fled and hasn't been seen since. Marron, whose

nickname is "Evil", has "Precious" tattooed inside his left elbow and "Misty" tattooed inside his right elbow. He may have grown his hair out to hide his identity, and is believed to have gang ties in Fresno, California. Marron is 19, 5'4" and 140 pounds.

**Unknown (Murder or Accidental Death)** -- The world-famous Vidocq Society is named in honor of Eugene Francois Vidocq, a fascinating 18th century French detective who was a confidante of writers Victor Hugo and Honore Balzac. Headquartered in Philadelphia, the Vidocq Society has 82 members -- one member permitted for each year that Vidocq lived. Members come from 17 US states and 11 countries. They take on the toughest cases - and crack them. Now AMW has joined forces with Vidocq to help solve a cruel and troubling mystery. It's a case that began on February 24, 1957 -- a bitter cold Philadelphia morning. In a desolate and rural area there was an unofficial dump - a place where anyone and everyone left the detritus of their lives. Most mornings it was household garbage or rusty car parts. On this morning, it was The Boy in the Box. One of the first detectives on the scene was Detective Sam Weinstein. All these years later, he's still haunted by the vision of the tiny, malnourished boy. His nude body had been wrapped in an Indian blanket and placed in a cardboard box. In an effort to find his identity, detectives tenderly dressed the tiny boy in a typical outfit and photographed him, hoping the simulation of life might help someone recognize him. The entire city of Philadelphia was touched by the boy's plight, but no one ever came forward to identify him. The boy's death could have been accident...or murder. Only the perpetrator can know for sure. To this day, his identity and his cause of death remain a complete mystery. Here are the primary clues: His age can only be guessed at - he had a full set of baby teeth and may have been 3 - 6 years old. His heritage was most likely north western European or Scandinavian. He had never been inoculated with any of the vaccinations most children his age received. He had been circumcised and had scars in the groin and ankle area that were indicative of some type of transfusion or other medical treatment. The boy was badly malnourished and his body was covered in bruises. He had marks around his head -- as though a strong adult may have pressed in his forehead. One of his hands looked as though it had been soaking in water. Forensic technicians call the wrinkling the 'washer woman' effect. Though he was nude, he seemed quite clean, as though he'd just been bathed. His nails were cut very close. His hair too had been recently cut quite short. Each meager clue was carefully followed. The Indian-pattern blanket in which he was wrapped had been manufactured in North Carolina. It was a fairly typical and common blanket for the time. The cardboard box in which he was found had held a bassinet from J.C. Penney. Many detectives speculate that whoever abandoned the boy at the dump, found the box there. They feel it's unlikely that the box was brought to the dump with the body. So why wasn't the boy buried, or hidden more effectively? Some Vidocq members believe that the trash dump area held some symbolism for whomever left the boy there. It's possible that the dump was a staging area - the perpetrator wanted the boy to be found, but didn't want the boy to be identified. Was it a stranger or his own parents who left him there? Some Vidocq members believe it was his own parents. They speculate that the boy was a 'problem' for the family from the start. His body indicates ongoing health problems - either through natural illness or as a result of abuse. This theory operates on the basis that the extremely short hair and nails may have been some sort of punishment. Maybe that punishment went too far and a strong hand holding the boy by the head literally squeezed the life out of the him - that theory explains the contusions on his forehead, but what about the washerwoman effect on his hand? Was the boy washed after death? A sort of burial preparation? Or did he die in water? One theory: as a cruel punishment, someone forced

the boy to sit in a bathtub far too long. On a cold February night, a skinny toddler could quickly die of exposure in cool water. Because the possibility of a connection to the parents seems so strong, Vidocq member, Frank Bender created a bust of how the boy's father may have looked. Bender is the forensic sculptor behind the bust of John List - the infamous killer from New Jersey who took the lives of his entire family. The bust is based on the facial features of the boy and drawn from Frank's decades of experience and well-honed instinct. It's a shot in the dark, but maybe after all these years someone will recognize this man. If the boy's identity is learned he will at least have a name on his headstone and maybe the mystery of his death will be solved. On November 4, 1998 the Philadelphia police exhumed the boy's body from Potter's Field to obtain a DNA sample. Police say the boy's DNA will be compared to the DNA of any suspects who are identified in the future. The boy's DNA may also be compared to possible family members of the boy. The boy was reinterred on Veterans' Day, November 11, 1998 at the Ivy Hill Cemetery. (See Shows #514 and #525, OADs 10/3/98 and 1/16/99)

**David Edgardo Fuster** (Rape, Child Abuse) – Fuster was convicted in May 2003 of child abuse, sex offenses, and rape of a 15-year-old patient in his dental office. Fuster, a licensed dentist, molested and raped at least one patient while in his dental chair. The victim testified that Fuster engaged in non-consensual sex with her while she was under the effects of nitrous oxide. Fuster was charged, tried and convicted, but allowed to remain free on bond pending his sentencing. He fled before law enforcement could get him behind bars. Fuster, a native Peruvian, may be traveling with his wife and five young children in a 2003 Chevrolet Venture mini-van with Maryland plates. Fuster is 47, 5'11" and 190 pounds.

**Hai Thanh Le (aka Teo Nguyen) (Attempted Murder)**

**Uyen Nguyen** (Attempted Murder) – On November 19, 2002 New York City police officer Hung Nguyen was visiting a friend at the Miss Saigon Bar in Jersey City, New Jersey. Yuen "Wendy" Nguyen, Mai "Mike" Nguyen (currently in custody), Teo Nguyen and Binh Nguyen (currently in custody), members of a local gang known as O.U.T. (Orientals United Together) were also at the bar that night. When the bartender tried to clear the establishment at closing time they refused to leave and became rowdy. Officer Nguyen then stepped in to remove the four. After the four left the bar they returned and severely attacked officer Nguyen. He was repeatedly beaten with bar stools and suffered two crushed vertebrae in his back. He is currently paralyzed from the chest down and is in rehabilitation. The FBI learned that since the attack the four perpetrators may be trying to flee the country for Vietnam. Le/Teo Nguyen is 22 or 23, 5'8" and 145 pounds. Uyen Nguyen, who has used the aliases Wendy U. Lee and Uyen T Le, may have blonde highlights. She is 27, 5'2" and 110-115 pounds. (See Show #701, OAD 12/21/02)

**CAPTURED:**

**Enrique "Kike" Coropuna** (Armed Robbery, Attempted Murder) -- Coropuna is one of the leaders of a South American gang believed to be responsible for several jewelry store robberies on the east coast committed in 1992. On June 6, 1992 Coropuna and another man entered the Ngoz-Long jewelry store in Arlington, Virginia where they handcuffed and pistol-whipped the store's employees. Police say the two men stole \$350,000 worth of jewelry and fled in a white American car with New Jersey plates. On July 23, 1992 Coropuna and two other men

entered another Arlington jewelry store, Phnom-Penn Jewelers, handcuffed the employees and stole \$35,000 in jewelry. The incident was taped on an overhead surveillance camera. The two other men involved in the robbery were arrested and are now serving their sentences. On November 11, 1992 Coropuna and a woman entered the Kornspan Jewelers in Linden, New Jersey. After asking to view a tray of jewelry, as many as three more men entered the store. The robbers began to handcuff the owners of the store to furniture and scoop jewelry into bags. According to police reports, when police officer Al Goncalvez arrived at the scene Coropuna fired one 9mm round at his chest. Goncalvez escaped serious injury because he was wearing a bulletproof vest. The five robbers fled and were picked up by a getaway driver in a white Oldsmobile. After a brief high-speed chase, the getaway car crashed into a parked vehicle and the suspects fled on foot. Three suspects were eventually arrested. Coropuna was finally located in jail in Lima, Peru, following a bloody shootout at a bank robbery. *The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.*

**Larry W. Woods, Jr. (Escape)** – Woods escaped from the Indiana State Prison in Michigan City on July 9, 2001 around 8:40am. Prison officials first noted Woods' absence at a mid-morning roll call on July 9. The facility was immediately locked down, but there were no signs of woods. Authorities believe he escaped inside a garbage truck that was on a routine pickup at the prison. Prison officials say that Woods was a "yard worker" whose duties included mowing the grass and shoveling snow. As a "yard worker", Larry was within both walking and visual distance of the trash pickup area. He could have watched the process daily and figured out the schedule. Police theorize the Woods put himself in the dumpster. The truck did crush trash that morning, and it is unclear how Woods may have survived. They have searched the dumpsite, but did not find his body or any evidence that he perished. It is also plausible that Woods may have ridden off the premises underneath the truck. Larry Woods was convicted of the murder and robbery of a former employer in 1994, for which he was sentenced to 111 years. Woods, whose nickname is "Elwood", has scars on his lower right arm, upper back, and stomach. He may have a very elaborate tattoo on the left side of his chest which would exactly match his girlfriend's: "9" and "Until Death Do Us Part" at the top, "Elwood" in the left heart, "Pooh Bird D" in the right heart, "Lil Larry RIP" towards the right, "6/4/99" towards the left, center heart surrounded by the words "Loves Only Always Forever"; at the bottom there is a "10" and the words "Plenty Much Love", all contained within the shape of the Libra scales. He is a known member of the Gangster Disciples street gang, and may also have Gangster Disciples tattoos (BGD). He may be wearing a gold cross necklace and a wedding ring. He had a shaved head at the time of his disappearance, and may have facial hair. Woods is 31, 5'10" and 190 pounds. (See Shows #642, #657 and #680, OADs 7/28/01, 12/8/01 and 6/15/02)

**Terrence Kasses Washington** (Armed Bank Robbery, Auto Theft, Burglary, Assault)

**Dan Robertson, Jr. (Escape)** – Washington and Robertson are wanted for a Louisiana jail escape and for assaulting a police trooper while on the lam. In March 2003 Washington was sent to the Tangipahoa Parish Jail in Amite, Louisiana to await trial for bank robbery. Washington had previously escaped from a jail in Arkansas in 1998. At the Louisiana jail, he

befriended fellow inmate Dan Robertson. On July 13, 2003 Washington and Robertson used a hacksaw blade to cut out a window in the jail. Once Washington and Robertson crawled out the window, they scaled several fences and escaped into a wooded area. The escapees then stole a truck from a nearby residence and fled the state. The stolen vehicle was recovered in New York a couple of weeks later but there were no signs of Washington or Robertson. On September 25, 2003, police spotted Washington and an unidentified suspect in a stolen SUV outside Baltimore. After a high speed chase in which Washington rammed a state trooper's car twice, Washington managed to escape through a heavily wooded area. Washington stole a van from a nearby residence and fled the area. The van was recovered less than two weeks later. Robertson may have been the unidentified suspect traveling with Washington during the high speed chase. Washington, whose numerous aliases and nicknames include Gordon Douglas Weaver, William "Dynamite" Brown, Rayford Damien, Cassidy Washington, Ryan Fociet, Travis Washington, T.T. Washington, "Cash" Washington, Damcan Walker, Brian Mays, "T Money", "TD", "T Dog", "TJ" and "Cassidy", has several tattoos including "Only God Can Judge Me" on his left chest, a person holding a gun on his right chest, the word "Cash" with a stack of money and dice on his abdomen, the words "Lil Cash" and "Don't get skull drunk" on other parts of his body, and other tattoos on both arms. He also has scars on his left finger, abdomen, right arm and left eye. Washington, who is described as a rap artist and may perform in clubs, has ties to the music industry. He is described as a big spender and may sell stolen items in pawn shops or street corners to make money. He has gold caps on some of his upper teeth. Washington is 27, 5'8" and 160 pounds. Robertson, whose aliases include Dan Robin, Dan Robbins and Damond Jones, has a teardrop tattoo under his left eye, and another tattoo on his right arm which may be his name. He is a smoker who may wear his hair in corn rows. Robertson is 45, 5'10" and 160 pounds.

**California Fire Suspect #1 (Arson and Murder)**

**California Fire Suspect #2 (Arson and Murder)**– The San Bernadino Sheriff's Office is looking for two men who are responsible for igniting a brush fire which caused extensive damage and four deaths. At approximately 9:15am on Saturday, October 25, 2003, a witness reported seeing two males in a 2000 or 2001 grey or white Chevrolet Venture mini-van on Old Waterman Canyon. The witness saw the passenger throw something from the van which ignited the brush fire. The suspects were last seen heading south on Old Waterman Canyon Road. Suspect #1, the driver, is in his early twenties and has dark hair. Suspect #2, the passenger, is in his early twenties is thin and has short blond hair.

**Ricky Alan Sleight (Murder)** – In the early morning hours of September 1, 2003, neighbors overheard an argument coming from Sleight and roommate William Baldi's apartment, followed by slamming doors and a loud thump. About four hours later someone smelled smoke and called the fire department. They arrived to find Baldi dead with cuts around his face and neck. Baldi was dead before the fire started, and authorities believe that Sleight set the fire to cover up the murder. When searching the apartment, cops found Sleight's wallet containing his driver's license and Social Security card lying near Baldi's body. Sleight drove Baldi's car to his mother's house in North Carolina and confessed to killing Baldi. Sleight had previously told his mother he wanted to move to Alaska, so authorities believe he may be there or in Canada. Sleight, who has "Tierney" tattooed on his chest, "In Memory Of Cristy" on his back, and numerous tattoos on his hands and knuckles, may have died his hair blond. Sleight is 33, 6'0" and 210 pounds.

**Jose Juan Salaz (Escape)** – Salaz escaped from the Garza East Unit of the Texas Department of Criminal Justice. He is currently the only escapee inmate in the 153-year history of the Texas prison system who has not been recaptured, killed or discovered dead. On the night of March 22, 1997, Salaz and other inmates from his dormitory were coming back into the housing area from the recreation yard. As the door closed behind them, Salaz, who was toward the back of the line, noticed that the door did not completely shut and lock. Salaz seized the opportunity, exited through the door, ran across the recreation yard and scaled a series of three fences to get out of the unit. Prison employees were unable to see Salaz clearly through the fog that night. Despite an extensive manhunt, Salaz was not recaptured. Salaz was serving a life sentence for attempted capital murder of a police officer as part of a 1995 shootout in Houston, Texas. Salaz and his accomplice, Geronimo Alverado, kidnapped a man and demanded \$5,000 for his safe return. During the money exchange on April 2, 1995, undercover cops were able to buy back the hostage. Then Salaz and Alverado got into a gun battle with police. One officer was shot by another officer in the crossfire. Cops shot Salaz four times with shotgun blasts. Salaz was apprehended when he drove his car into a police cruiser. Salaz has scars from the encounter on the left side of his forehead, the left side of his neck, and both legs. He has the letter "J" tattooed on his left hand. Salaz is 28, 5'7" and 158 pounds. (See Show #621 and #666, OADs 2/17/01 and 3/2/02)

**Glen Stewart Godwin (Murder, Escape)** -- In 1980, Glen Stewart Godwin turned on his best friend in a robbery, and the double-cross turned to murder. After stabbing the victim 26 times, he attempted to cover his tracks by dragging the lifeless body to a remote desert location, and there detonated homemade bombs next to the evidence. The attempt failed - instead of incinerating the body, the explosion catapulted it into the night, where it was later discovered. Godwin was convicted and got 26 years to life for his crime. Prison officials say that he wasn't one to play by the rules, so he was soon transferred to what convicts call "the end of the world" - California's infamous Folsom prison. Only a handful of convicts have gotten clear of Folsom's high walls - but that didn't stop Godwin. He carefully examined the security and surroundings, and realized that he could get out by turning the problem on its head - no one could get out of this prison, but what if someone broke in? Godwin enlisted an ex-con by the name of Lorenz Karlic to work his way into Folsom by way of a tunnel running underneath the prison. Folsom was built on a stream that empties into a nearby river - and while the tunnel is secure in one direction, no one was watching as Karlic cleared a path for his friend. In June 1987, the tunnel was ready, and Godwin was away. But Godwin was far from rehabilitated. Just five months after his escape, he was captured in Mexico and charged with possession of 30 grams of cocaine. Once again, he was convicted, and sentenced to seven years at the Puente Grande Federal Prison in Guadalajara. The FBI was in negotiations with Mexican authorities to bring Godwin home when they say he clouded the legal waters by killing a fellow inmate. A short time later, the FBI learned that he had escaped yet again. On December 7, 1996, Godwin was named to the FBI's Ten Most Wanted list. Agents believe he is still in Mexico, but may have slipped back into California. Godwin, who use used the aliases Dennis McWilliam and Glen S. Godwin, frequents bars and drinks champagne. He is also an alleged marijuana and cocaine user. Godwin is a tennis player, a sharp dresser, and has worked as a model, mechanic, and construction worker. He collects firearms. Godwin is 44, 6'0 and 170 pounds. (See Shows #8, #22, #101, #198, #238, #321, #368, #420, #432, #462, #508, #579 and #707; OADs 3/27/88, 7/3/88, 2/11/90, 1/31/92, 10/2/92, 6/25/94, 6/3/95, 8/3/96, 12/7/96, 8/16/97, 8/22/98, 3/11/00 and 2/22/03)

**Dennis Schley Lilly** (Aggravated Assault of a Police Officer, Escape) -- Lilly is being sought for the December 13, 1986 escape from the Missouri State Penitentiary. He was serving fifteen years to life for shooting a police officer. In 1981 Lilly, along with seven other inmates, escaped from the Kansas State Penitentiary. After the break out, Lilly was holed up in a Bonner Springs, Kansas home. When a curious police officer approached the house, Lilly shot him four times with a high-powered rifle. Lilly was ultimately captured and sent to the Missouri State Penitentiary. After a few unsuccessful attempts at breaking out of the Missouri facility, Lilly got lucky. Officials say Lilly escaped by stealing a guard's uniform and walking out of the penitentiary during a shift change. Weeks after the escape, officials found out that Lilly was in Florida and then in Canada. Lilly's wife Mary and her daughter Rebecca were missing just after the escape and are presumed to be with Lilly. Mary's passport last placed her in Ireland. Lilly has "Slick" tattooed on his upper right arm. He is slender, with a receding hairline. He is articulate, polite and soft-spoken, a loner who likes to read. He trained at a trade school as a carpenter. He and Mary are rumored to have had a new baby in New York. Lilly is 56, 5'11" and 170 pounds. (See Shows #534, #630, #634 and #727, OADs 3/20/99, 4/28/01, 5/26/01 and 7/29/03)

**Scott Alan Hornick** (Escape, Burglary) – Hornick is wanted for a number of con games, burglaries and escape. In 2001 Hornick was locked up at the Warren County Correctional Center in northwest New Jersey for burglary, theft and fraud. On August 6, 2001, Hornick and another inmate, John Strubel, devised a plan to escape from the jail through a hatch in the day area of their cell block. Corrections officials say they pulled it off by picking the lock using a pair of eyeglasses as a tool. They then climbed into a crawl space and knocked out a drainpipe, which led to the second story roof of the jail. Hornick and his accomplice climbed down a ladder and over the perimeter fence where they fled on foot. On August 8, 2002 Hornick and two other men were trying to burglarize a Circuit City in Wayne, New Jersey. Cops responded to the call and the burglars fled in an SUV, leading patrol cars on a high speed chase through northern New Jersey. The SUV crashed and officers caught up with Hornick and his accomplices. Hornick cooperated and gave a statement, but used the alias Jerry Todisco and fled before police could make a fingerprint match. Police later caught up to Hornick in Mount Laurel, New Jersey, at an extended stay hotel. When cops arrived, Hornick jumped out his second story window and fled in his car. Since then, police have received confirmed sightings of Hornick at bars with gambling in the Easton, Pennsylvania area and in a mall in northern New Jersey. Hornick, whose other aliases include Scott Allen and Charles Hall, dates women to get access to their credit cards, then leaves them. Hornick is 32, 5'11" and 260 pounds. (See Show #719, OAD 5/17/03)

**Marcellus "Mark" Levan Henderson** (Murder, Attempted Armed Robbery)

**Terron Vassel "Dread" Vernon** (Murder, Attempted Armed Robbery) – Henderson and Vernon are wanted for involvement in the attempted robbery of a bank in Roswell, Georgia and the murder of one of the bank's employees. 39-year-old Angela Towle, a teller coordinator, opened up her bank every morning. At 7:20am on Friday, October 24, 2003, Angela entered the first of two glass doors at the bank. Henderson and Vernon approached her and forced her through the second glass door. Once inside the bank, the two masked robbers demanded money from the vault. However, Angela was not able to open it, and one or both of the men shot her

four times. The pair fled the scene without any cash. About ten minutes later, other employees entered the bank. When they didn't see Angela, they called police, who found Angela. She died at a local hospital. Police retrieved two photographs of the killers from the lobby surveillance cameras. The men were wearing dark colored masks and hoods. One wore white tennis shoes, camouflage pants and a dark jacket. The other robber had dark shoes and dark clothing. Police identified the pair as Henderson and Vernon. Candace Gantt, Henderson's girlfriend, used Angela's credit card at a local store. Gantt was arrested, but Henderson and Vernon are still at large. The pair may be driving a gold 2000 Chevrolet Tahoe with fancy chrome rims and Georgia plates, a black 2000 4-door Buick Regal with Florida plates, or a black SUV with Florida plates. Both men have extensive gold dental work on their front teeth and may be wearing their hair in dreadlocks. Henderson has numerous aliases and nicknames including Oba Bruton, Jeffery A. Weis, , Anthony Butler, Anthony Williams, Alfred Romondo Williams, "Cash", "City" and "Money". Henderson is 21, 6'1" and 150 pounds. Vernon has unidentified tattoos on one of his arms. Vernon is 22, 6'1" and 200 pounds.

**David Stack Killer** – 44-year-old David Stack and his family spent weekends at a cabin in southern Virginia. David, his son Brian, and David's brother Jeff were excited about the 2003 turkey season. On the morning of April 12, 2003, all three men set out for a full day of hunting at 5:30am. The three men went their separate ways. Around 7:00am Jeff and Brian separately heard a gunshot and assumed one of them had killed a turkey. Later they each heard another gunshot. When they met back at the cabin for lunch, David didn't show. Brian and Jeff weren't concerned since David took food with him and said he might stay out all day. By late afternoon, Jeff and Brian became worried. They set out on foot looking for him, but it was difficult to check the entire 190 acres of their property. Later they contacted police, the Virginia Department of Game and Inland Fisheries, and David's family. A search through the night was conducted with a helicopter, police dogs and family members on foot. The next morning, Brian found his father's body. Police later determined that David was shot with a rifle, which is considered rare since most hunters use shotguns. Despite lengthy investigations, there are no suspects. The key clue is the slug from the murder rifle. Authorities have not ruled out that the death may have been an accident; however, since all experienced hunters check their kill, investigators believe the shooter knows he killed someone. The rifle was a .222 to .224 caliber, with 6 grooves and a right twist, and is a center fire weapon.

### **CAPTURED:**

**Michael Blane Brashar (Murder)** – On March 30, 1982, the body of 20-year-old Mary Ann Castille was found in a Houston, Texas bayou. She was raped, strangled, and left partially nude. Police had no suspects and had interviewed all of the teenager's friends, including 14-year-old Lisa Dawn Hoag. On July 1, 1982, a week after police interviewed Lisa, her body was found raped and strangled in a school yard. A tip led detectives to Michael Blane Brashar, who was 21 at the time. He lived in the same apartment complex as Lisa, and he knew both girls from hanging out at a local convenience store. Brashar was arrested and held for unpaid traffic tickets. Detectives grilled him, took a blood sample, gave him two lie detector tests which he flunked, and took a shoe cast of his sneaker. All of the evidence they had was circumstantial, so police were forced to release him. All along, Sgt. Boyde Smith of Houston homicide, believed Brashar was responsible for the two murders, but he couldn't prove it. It remained a cold case until 199

when DNA testing became available. Sgt. Smith reopened the case. He found out that the semen sample in Mary Ann Castille's case had become tainted, but the sample in Lisa Hoag's case was usable. Their crime lab conducted a DNA test comparing the semen to Brashar's 1982 blood sample. The test results indicated that Brashar was indeed their suspect. After almost 20 years, detectives know who killed Lisa Hoag, and suspect he was involved in Mary Ann Castille's case. Sgt. Smith put out a nationwide alert to all police departments. He didn't receive any solid leads. On March 16, 2001, Houston police filed capital murder charges against Michael Brashar. Brashar, who has used the aliases Mickey T. Craft, Mickey Graft, and Doyle R. Brashar, has a scar on his right forearm. He has worked in construction and is known to frequent homeless shelters and churches. Brashar is 42, 5'10" and 175-200 pounds. (See Shows #662, #703 and #737 OADs 1/26/02, 1/4/03 and 9/27/03)

### **MISSING:**

#### **Cecilia Zhang**

Age: 9

Height: 4'11"

Weight: 70 pounds

Toronto police believe 9-year-old Cecilia Zhang was abducted from her home sometime between the late evening hours of Sunday, October 19, 2003 and the morning of Monday, October 20<sup>th</sup>. Cecilia was last seen by her parents when she went to bed Sunday night around 10:00pm. Her disappearance was not noticed until Monday morning shortly before 8:30am when her parents went to wake her up for school. Police believe that more than one person entered her home through the kitchen window. The window had been damaged and the screen pried open. The abductors went to Cecilia's room and then made their escape with her through a side door. One theory is that Cecilia may have been abducted for ransom or some other type of extortion. Shortly before her parents discovered her disappearance, there were two hang-up phone calls to the Zhang house. The calls were traced to payphones on the western outskirts of Toronto. The first was located at Airport Road and Intermodal Drive in Brampton; the second was about six miles away at Maple Lodge Farms near Steeles Avenue and Winston Churchill Boulevard, also in Brompton. Cecilia, who is also known as Dong-Yue, is bilingual in English and Mandarin Chinese. She has blonde highlights in her black hair, loves to read and likes to play the piano. She loves pet cats, and may talk about her own cats, Lucky and Happy.

#### **Jessica Shores**

Age: 15

Height: 5'9"

Weight: 120 pounds

Jessica was last seen October 17, 2003 at her home in Republic, Washington. She could be with 31-year-old Stephen L. Recker, and authorities believe she is in danger. Recker is believed to have come to Jessica's home and left with her and another man, James Neace. Recker attacked Neace shortly after leaving because Neace no longer wanted to participate in the abduction. Recker cut James and then kicked him out of the vehicle somewhere in Arizona. Neace is currently back at home. Jessica did leave two notes, one to her mother and one to her father

stating that she was sorry for all the pain she had caused but it would be better if she left home. Jessica and Recker are believed to be involved in a sexual relationship. Recker is carrying knives with him, and both are amphetamine users. The pair are probably driving a 1989 black Jeep Cherokee with Washington plates 917-NBY. They may be heading to the Tri-Cities of Kennewick, Pasco and Richmond, Washington, or to New Mexico. Jessica is fastidious about her grooming. She used to have her left eyebrow pierced, but doesn't wear jewelry there any more. She likes to talk on the phone, and has a 12-year-old dog named Twenly who she left behind. She was last seen wearing a blue/gray shirt, blue jeans, white tennis shoes, and a blue/gray hooded sweatshirt.

### **UPDATES:**

**Pete Rudy Marron (Murder)** – On September 19, 2003, after the San Francisco Giants vs. the Los Angeles Dodgers baseball game at Dodger Stadium, Mark Antenoracruz headed back to his car in the parking lot. He was with his brother and sister. He was confronted by Pete Marron, who was mad that Mark was a Giants fan. The two men fought and the Marron pulled a gun and shot Mark twice in the chest. He fled and hasn't been seen since. Marron, whose nickname is "Evil", has "Precious" tattooed inside his left elbow and "Misty" tattooed inside his right elbow. He may have grown his hair out to hide his identity, and is believed to have gang ties in Fresno, California. He was last seen in a restaurant in Sacramento, California. Marron is 19, 5'4" and 140 pounds. (See show #738 OAD 10/06/03)

### **John Stoneman (Rape of a Minor, Child Pornography)**

**Patricia Kelley (Rape of a Minor)** – Stoneman and Kelley are wanted for the rape of a minor. The pair videotaped their sexual assault of a profoundly handicapped four-year-old child. Kelley was a Licensed Practical nurse charged with the daily care of a four-year-old disabled girl. The victim suffers from spina bifida, hydrocephalus, diabetes and a seizure disorder that leaves her blind and unable to communicate or move. Cops first began investigating Stoneman when child pornography found during a case in Orange County, California was linked to a computer in his Cambridge, Ohio home. Police arrested Stoneman, but he quickly posted bond for those child pornography charges. Subsequent searches of the home that he and Kelley shared uncovered many more crimes, including the videotape of the assault on the disabled four-year-old. They also discovered a two-way mirror with a video camera behind it, used to videotape minors changing clothes. Authorities are still determining how many juveniles were victimized by this couple. Stoneman failed to appear for a hearing on the initial pornography and weapons charges. The pair fled together, and were last seen driving a light-gray four-door 1996 Saturn with Ohio plates DU 27 SX. Stoneman, who has used the aliases Randy D. Wackbacher and Randy D. Weckbacher, has a receding hairline. He is a smoker, has glaucoma and always wears sunglasses, even inside, and takes medicine and eye drops for his condition. He may have changed his hair color and style. He may be frequenting gun shows or firing ranges, and may be working as a handyman. He should be considered armed and dangerous. Stoneman is 38, 5'9" and 160 pounds. Kelley, who has a very visible scar across her throat from a knife wound, has used numerous aliases including Patricia A. Dowell, Trish A. Dowell, and Trish Kelley. She may have changed the color and style of her dyed-blond hair. She may still be working as a health care provider. She too should be considered armed and dangerous. The pair was last seen at a casino in Niagara Falls, New York. Kelley is 39, 5'3" and 150 pounds. (See Show #738 OAD 10/06/03)

**Douglas Aigen** (Aggravated Assault on a Police Officer) – Doug Aigen has a long rap sheet and doesn't want to go back to prison. His crimes range from forgery and theft to assault of a police officer and kidnapping. In 1992, Aigen kidnapped a woman in a parking lot and put her in the trunk of her car as he drove around using her ATM card. He released the victim and later was convicted of kidnapping charges and robbery. He was sentenced to fifteen years in a New Jersey prison. After his release in 2002, Aigen assaulted a police officer. On October 25, 2002, Aigen was trying to steal a load of batteries from a truck. Aigen bit and punched the officer, then fled. On January 10, 2003 Aigen attempted to steal a tractor trailer from a New Jersey truck company. Employees spotted him and tried to stop him by placing a pickup truck in front of the stolen tractor. Aigen rammed the pickup and led police on a chase on the New Jersey Turnpike and Route 78 in Newark. At one point during the pursuit, Aigen came to a complete stop with a trooper car right behind him. Instead of getting out of the tractor, Aigen put his truck in reverse and rammed the police car before fleeing. No one was injured. Since then, detectives in New Jersey and New York believe Aigen has been stealing tractors and trailers. Aigen sells the merchandise inside the trailers on the streets of New York and pockets the cash. They believe he won't go down without a fight. Aigen, who has used the aliases Doug Ailen, Douglas Reed Aigen and Douglas Robert Aigen, has "Leslie" tattooed on his right hip. He has a crack habit and must steal to survive. He may suffer from depression, and his family is afraid of him. Aigen was last seen in Bradenton and Fort Meyers, Florida. Aigen is 37, 6'2" and 320 pounds. (See Show #735 OAD 9/13/03)

*The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.*

**Buddy Charles Beavers Jr. (Murder, Arson, Robbery)** – Buddy Charles Beavers, Jr. is wanted by multiple agencies for the murder of his mother, Wilma Jean Beavers, who died when her house went up in flames on December 9, 1998. Buddy, who was in the house when the blaze started, was able to escape and run to a neighbor's house to call 911. By the time firefighters arrived, two other residents of the house, Wilma Jean's boyfriend and her grandson, had also escaped the inferno. However, Wilma Jean died before she was able to get out the door. When investigators questioned Buddy, he kept changing his version of the events of that night. When they learned that Buddy had just spent two years in prison for arson and theft, he became their main suspect. They also learned that Buddy was a former cop and firefighter in the hometown of War, West Virginia. In 1995, Buddy was convicted of setting a fire at the Carrier Corporation in Farmington, Connecticut. He had been working at the company as a security guard and set the fire while employees were working. It is believed that he set the fire so that he could look like a hero. Aside from the \$600,000 in damage that he committed, he also stole \$40,000 worth of equipment. On February 11, 1999, two months after the fire that killed his mother, Buddy jumped out of the bushes near the Rostra Vernatherm factory in Bristol wearing a dark ski mask and holding a sawed-off shotgun and robbed an employee. On April 9, 1999, four months after the robbery, Buddy was arrested for shoplifting. Police found the keys to the truck in his pocket. He admitted to the robbery and told police where they could find the shotgun. It seemed that Buddy was safely behind bars while police pieced together his mother's murder investigation. However, one month later, the condominium's insurance company gave Buddy a cash settlement after he sued them for his mother's wrongful death. Buddy was able to meet his \$350,000 bond and was set free. Bristol police and the United States Marshals had been looking for Buddy ever since. In March of 2003, he was indicted for the murder of his mother. Beavers is a former firefighter and a former cop who is a huge fan of Garth Brooks. He has a Virginian accent and may be hitching rides with truckers. Beavers has an Indian head tattoo on his right bicep and a tattoo of an Indian on a horse on his back. Beavers is 43, 6'01" and 200 pounds.

**Jose Quinones Velasquez** (Murder, Kidnapping, Robbery, Escape) - In 1988, 16-year-old Jose Quinones Velasquez, along with another man, kidnapped 22 year-old Antonio Maldonado in Ponce, Puerto Rico. They later shot Maldonado in the head execution-style and threw him in a well. That same year, Quinones and his men kidnapped 75-year-old Carlos Sanchez. They tied Sanchez up in his own home and demanded money. Quinones then took a knife and sliced open Sanchez's stomach. Sanchez bled to death. Quinones was eventually captured and convicted of both murders. Quinones was serving two 99-year sentences at the Complejo Correctional de Ponce, Puerto Rico when he escaped. He was able to obtain a 24-hour day pass, but never returned. On May 8, 1999, an anonymous source told Correctional Officer Arturo Centeno, 28, that Quinones and two other men were at a pizza restaurant in Ponce, PR. When Centeno arrived, he says Quinones and two other men began to shoot at Centeno's vehicle, and a shootout ensued. Two of Quinones' men were wounded, but Quinones ran away and has not been seen since. Quinones who is also known as Joselito or Cheo, speaks Spanish and broken English and is known to use cocaine and marijuana. Quinones is 31, 5'6" and 130 pounds.

**Recepp Ahmedoff** (Deportation) - Immigration and Custom Enforcement are looking for Recepp Ahmedoff for Deportation. Ahmedoff came to the United States from Bulgaria in 1974 as a conditional entrant. In 1978, Ahmedoff was convicted of Involuntary Manslaughter. On July 4, 1978, Ahmedoff was celebrating Independence Day at a bar and was drinking heavily. He borrowed a gun from one of his friends and went outside. He then fired shots into the air. A bystander was killed by one of these shots. He pled guilty to 2<sup>nd</sup> Degree Manslaughter and spent five years in jail. Shortly after his release in 1983, Ahmedoff was involved in an argument with a co-worker. The co-worker allegedly pulled a gun and Ahmedoff claims to have drawn his own and fired into the man's car. Ahmedoff was charged with attempted murder and weapons possession, but he was only found guilty of criminal possession of a weapon. Ahmedoff's right leg is amputated below the knee. Ahmedoff is 48, 5'4" and 134 pounds.

**Calvin Anthony Inswood** (Deportation) - The Bureau of Immigrations and Customs Enforcement is looking for Calvin Anthony Inswood for deportation. Inswood entered the United States in 1976 as a lawful permanent resident. In 1981, Inswood was accused of murder. He pled guilty to the lesser charge of assault and was sent to prison. After being released, he was convicted of weapons charges twice, and resisting arrest once. The most recent conviction was in June of 1990. In 1997, the Executive Office of Immigration Review ordered Inswood to be deported to Jamaica. Inswood appealed and was allowed to remain free on bond. When the Board of Immigration Appeal dismissed Inswood's appeal in December of 1997, Inswood was gone. There is currently an active warrant of Deportation for the Inswood. Inswood has a number of arrests and convictions for criminal acts that range from robbery to weapon offenses. He owes his ex-wife \$80,000 in back child support for his three children. Inswood, who has a tattoo of the word "Callie" on his upper right arm and he may have changed his identity. Inswood is 41, 6'0" and 210 pounds.

**Jorge Pascual Campos-Espinoza** (Deportation) - Immigration and Customs Enforcement is looking for Jorge Pascual Campos-Espinoza on a deportation warrant. Campos-Espinoza arrived in the U.S. from Nicaragua in the mid-80's. Campos-Espinoza has many arrests

and convictions, including being involved in the gang rape and sexual assault of a woman. The two other men involved are known only as "Tony" and "Chivo". Campos-Espinoza was sentenced to six years in state prison for this offense. Campos-Espinoza was paroled from prison on October 7, 1988 and turned over to INS. Campos-Espinoza was placed in deportation proceedings the same day via the issuance of an Order to Show Cause. Campos-Espinoza was ordered deported on October 14, 1988. However, the INS was unable to effect deportation to Nicaragua at that time, so Espinoza-Campos was released.. In 1989, Campos-Espinoza registered as a sex offender with the Daly City Police Department. However, in 1999, his registration lapsed, and the Daly City Police Department obtained a \$25,000 bail felony warrant for his arrest. With deportation now possible to Nicaragua, Campos-Espinoza's failure to register has made him once again a candidate for deportation. Campos-Espinoza, whose numerous aliases and nicknames include Frederico, Jose Garcia, and Fredrick Jose Garcia "The Pirate," is blind in or missing his left eye. He has relatives in Miami, Florida and may be traveling with a teenager. Campos-Espinoza is 41, 5'11" and 150 pounds.

**Scott James Eizember (Murder)** - Scott James Eizember is wanted by the Creek County Sheriff's Office in Depew, Oklahoma for the murder of an elderly couple, A.J. and Patsy Cantrell, the brutal beating of 70-year-old Carla Wright and the attempted murder of a 16-year-old boy. Eizember was on a mission to kill his ex-girlfriend, Kathy Biggs, and her entire family. On Saturday, October 18, 2003, Eizember entered the home of the elderly victims which happened to be located across the street from Kathy's parents' house. Eizember killed the Cantrell's and then used their home for surveillance. Eizember then sat and waited for her to come home, but Kathy was at work. During the afternoon, Kathy's 16-year-old son, Tyler, returned home where his grandmother was cooking dinner. Eizember stealthily followed him and shot the 16-year-old in the back as he tried to enter the house. Carla Wright, his grandmother, heard the commotion and came out from the back room. When she screamed, Eizember brutally beat her. Meanwhile, Tyler managed to get up and took off in his pickup truck to get help. When Eizember realized the boy had left, he ran after him and then jumped into the back of the pickup and began shooting at Tyler again. Tyler eventually crashed the truck into a pole so that Eizember would be thrown from the back of the truck. A neighbor saw Eizember walking down the street and naively offered Eizember a ride to the hospital, but Eizember had different plans. He attempted to shoot the man and steal his car, but failed when the man grabbed the barrel of the gun and caused the shell to fire outside the car door. The man took off as Eizember reloaded the gun and started shooting at the car. Eizember has a history of violence and psychotic behavior and is considered armed and dangerous. Police are currently searching a wooded area in Depew. Eizember is very athletic and is a keen outdoorsman. Eizember is 42, 6'0" and 180 pounds.

**Aaron Anderson (Murder)** - Aaron Anderson is wanted for the fatal shooting of Pastor Benjamin Mobley. On November 4, 2003, Anderson walked into a bible study class demanding to know his estranged wife's whereabouts. After accusing the Pastor Mobley of stealing his wife, Anderson unexpectedly shoots him in the chest. Anderson fled the scene in a light blue late 80's Buick or Mustang that has a white stripe which runs from the driver's side, over the roof and down the passenger side. Anderson is 64, 6'2" and 250 pounds.

**Eduardo "Limpy" Rodriguez (Murder, Attempted Murder)** - Rodriguez is wanted for four counts of murder and two counts of attempted murder. Rodriguez, along with "Toonerville" ("TVR") street gang leader Timothy McGhee (now in custody) are accused of the 2001 shooting

deaths of Margie Mendoza, Mary Ann Wisotsky, Cheri Wisotsky and Bryham Robinson. Margie Mendoza, a 25-year-old mother of two with no gang affiliation, was killed when Rodriguez and McGhee opened fire on her SUV in a rival gang neighborhood in retaliation for another murder. Mary Ann Wisotsky, her daughter Cheri and family friend Robinson were executed because McGhee thought Cheri had informed on his sister to the police. Prior to the shooting, both Rodriguez and McGhee had brutally beaten Bryham in an effort to extract information from him. Shortly thereafter, all three were shot dead in Mary Ann's car. Rodriguez, who has used the alias Juan Carlos Campos Gamino, has several tattoos including "TV" on his stomach, "Toonerville" on his back, a female head on his left shoulder, "RIP" on his right arm, and additional unidentified tattoos on his right arm, upper left arm and right shoulder. He is an illegal alien from Mexico who is also wanted by the INS. He has dyed his hair red in the past. Rodriguez is 24, 5'9" and 170 pounds. (See Show #719, OAD 5/17/03)

**Jason Wayne McVean** (Murder, Aggravated Assault, Carjacking) -- Jason Wayne McVean is suspected of being one of the gunmen who began to terrorize police and citizens along the Utah-Colorado border on Friday, May 29. Officials still have no idea where McVean is hiding out, but they have learned some details about his past, details that are so normal they make the current events even more mysterious. McVean has had only minor altercations with the law prior to the current manhunt. After he dropped out of high school, he was arrested for underage consumption of alcohol, driving a motorcycle without eye protection, and first-degree criminal trespass, according to the Durango Herald. Relatives say that McVean lived in a camper-trailer south of Durango. He seemed quiet and reserved, working as a welder for his father's family business. Everything seemed normal to his family, leading one relative to conclude that he must have fallen in with the wrong crowd. Neighbors say that McVean had only occasional visitors, but mostly kept to himself. Unless all of McVean's friends and relatives missed something, McVean's alleged involvement in the terrifying events of May 29 can only be described as an out-of-character explosion. Police say the last positive sighting of Pilon and McVean was on June 28, 1998, when a little girl in Montezuma Creek, Colorado, reported she saw two men trying to steal a water truck belonging to her uncle. She identified Pilon and McVean from pictures she was shown. McVean may have a beard and mustache. He was last seen wearing camouflage clothing. He may be armed with automatic weapons. He has worked as a construction worker. McVean is 32 and 6'2". In early July authorities deliberately set fires in the wilderness area where Pilon and McVean are believed to be hiding out, in hopes of driving the two men out into the open, but the plan was unsuccessful. (See Shows #498, # 499, #502, #516, #542, and #565 OADs 6/6/98, 6/13/98, 7/11/98, 10/31/98, 5/15/99 and 11/13/99)

**Oscar Rene "Popeye" Cabrera** (Murder) – Cabrera is wanted by the Los Angeles police department for one count of murder, two counts of attempted murder, armed robbery, evading police, assault with a deadly weapon, and unauthorized flight to avoid prosecution. On the afternoon of January 19, 1997 Cabrera spotted several young men playing football in Vermont Square park whom he believed to be rival gang members. Two of the young men, Jose Galindo and Edgar Reteria, were paralyzed and wheelchair-bound. Witnesses say Cabrera and his accomplice Harvey "Stoner" Lariano shouted a gang slogan, then opened fire. One of the invalids was wounded. When bystander Ramon Placencia yelled at Cabrera, "Don't shoot them, they're cripples!" Cabrera shot him dead. Cabrera is also a suspect in several armed robberies, an assault with a deadly weapon on the grandfather of his own child, and a high speed chase that

ended in a shootout between members of Cabrera's gang and the L.A.P.D. Cabrera, who also uses the nickname "Solo", has facial acne scars and numerous tattoos, including a gun on his right forearm, "MS" on his stomach and the back of his neck, "WLS" behind his left ear, and fingers holding up "MS" sign on the front of his neck. He is a hardcore member of the Mara Salvatucci street gang, and has an extremely violent criminal history. He is always armed. He is known to drink alcohol and smoke marijuana. Cabrera is 31, 5'6" and 175 pounds. (See Shows #586, #626, OADs 4/29/00 & 3/24/01)

**Phillip A. Williams (Murder)** - Phillip A. Williams is wanted for stabbing his ex-girlfriend, Josephine Chacon, to death. On August 5, 2003, at approximately 3:30 a.m., Chacon was allegedly stabbed in the parking lot of the old Sandi Casino in New Mexico by her ex-boyfriend, Williams. A co-worker heard Chacon scream and later discovered her bloody body slumped next to her car. She later died en route to the hospital. When police investigated the scene, they found two latent prints on the exterior side of Chacon's driver's side door window which later were found to belong to Williams. Police also found a knife covered with blood and a cell phone in Albuquerque, which they believe confirms Williams' involvement. Williams, who also goes by the name Simmons, likes to drink and could possibly be involved in drugs. Williams is 44, 5'10" and 190 pounds.

### **MISSING:**

#### **Marquis Jobs**

Age: 13

Height: 5'0"

Weight: 110 pounds

Chesterfeild police are searching for 13-year-old Marquis Jobs who has been missing since October 22, 2003. Marquis' disappearance was not noticed until his uncle found his mother, Tasha Robinson, murdered in their Richmond VA home on October 25<sup>th</sup>. Although Marquis' 22-month-old sibling was found unharmed in the home, he was nowhere to be found. Marquis has black hair and brown eyes and was last seen by friends on Wednesday, October 22<sup>nd</sup>, the last day he reported to school.

### **CAPTURED:**

**Arthur Carl Kanev (Child Molestation)** – According to Casa Alianza, Arthur Kanev, along with another American, traveled to Costa Rica and set up an organization, supposedly dedicated to working out environmental issues in Costa Rica. Instead, the two men drugged and raped young Costa Rican girls and took photographs of them naked. The two were arrested on January 6, 1999, but at the end of 2000 Kanev was released on bond fled the country. On June 24, 2003, authorities received the tip from a woman in Pompano Beach, Florida. She claimed that she had befriended a man who seemed odd to her. She got his name, Arthur Kanev, and logged on to the Internet. Her intuition was right on because, sure enough, when she searched for his name on the internet, it showed up on [www.amw.com](http://www.amw.com), the *America's Most Wanted* website. She called the AMW tip line and relayed her information. AMW relayed this information to the Broward County Sheriff's Office in Florida and after a month of surveillance they finally

obtained an arrest warrant and systematically apprehend Kanev before he could leave the state. Kanev was held in federal custody until he was extradited back to Costa Rica.

*The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.*

**Dean Leroy Muast II (Murder)** - Dean Leroy Muast II is wanted in Indiana for the murder of 27 year-old Matthew Bair. On October 9, 2003 Maust shot Bair, the boyfriend of his ex-wife Laurie. Laurie and Dean Maust had a tragic marriage, with multiple domestic battery incidents. Maust had been arrested and was on probation at the time of Bair's murder. Bair and Laurie became romantically involved after she divorced Dean - the relationship angered him On October 9<sup>th</sup>, Dean confronted Bair and eventually shot him in the head. Laurie found Bair's body the next day after he didn't report to work. Dean later stole a truck from his employer and went on the run. The truck was found abandoned in Waco, Texas. Authorities believe Dean is heading towards Mexico and has taken on a new identity. Dean's brother, Paul, was arrested as a co-conspirator on Monday, November 10, 2003. Authorities believe that he gave Dean the gun that killed Bair and then tried to hinder the investigation. Paul has been charged with murder and conspiracy to commit murder. Maust has chronic back and shoulder problems and receives cortisones shots regularly. He has brown hair which he may have died blond. He's described as tempered, smokes a pack of cigarettes a day and may be seeking employment as a handy-man or a mechanic. Maust is 27, 5'11" and 210 pounds.

**Dino Loren Smith (Robbery, Kidnapping, Burglary)**

**Troy Devin Smith (Robbery, Kidnapping, Burglary)** – The Smith brothers are wanted fro the 2003 burglary of a San Francisco Jewelry store. The Smith brothers, along with George Turner and an unknown accomplice, broke through a wall separating two businesses and later restrained the employees of Lang's Antique Store when they arrived to open up the store for business. They made off with more than \$10 million in property. Turner was arrested in June 2003, but the two brothers remain fugitives. Dino usually shaves his head and often wears a goatee. He loves beautiful blonds and dines at upscale restaurants and bars. Troy is a former professional football player who usually follows Dino's lead. Dino is 52, 6'3" and 180 pounds. Troy is 40, 6'3" and 200 pounds.

**Unknown Sok Khak Ung Killer (Murder)** - Long Beach police are looking for the unknown gunman who shot and killed the celebrated Iraqi war soldier, Cpl. Sok Khak Ung, and his friend, Vuothy Tho. On Sunday, October 19, 2003, Cpl. Ung and his family were having a barbeque in their backyard, which is bordered by a six foot high wooden fence. A Hispanic man jumped over a neighbor's fence, came up behind the fence that divides the Ung's backyard and started firing wildly over the fence. Six to eight shots were fired. Cpl. Ung was hit in the torso and head and died at the scene. Tho was shot once in the head. He was transported to a hospital and later died. Cpl. Ung was a decorated Marine with the 15th Expeditionary Unit, which was responsible for the capture of 270 Iraqi soldiers on the first day of the war, and later participated in the rescue of Army Pfc. Jessica Lynch. Cpl. Ung's family had escaped war torn Cambodia, and he had become a US citizen only a month before his death. The suspect, Hispanic male, was wearing a black hooded sweatshirt at the time of the shooting. The he is 18 to 20 years-old, approximately 6'0" and has a large build.

**Randolph Franklin Dial (Escape)** -- Randolph Dial is wanted for escape from a medium security prison in Granite, Oklahoma on August 30, 1994. Dial escaped from the prison around 11:30 a.m. and took Bobbie Parker, the deputy warden's wife, with him. Agents believe Dial used Parker's van to leave the prison grounds. After the escape, police say Parker made several calls to family and friends saying that she was okay and that she would be home soon. The last phone call came on September 9, 1994. Neither Dial or Parker have been seen since. The van was recovered in Wichita Falls, TX on September 1, 1994. Dial was serving a life sentence for the 1981 murder of Kelly Hogan in Broken Arrow, Oklahoma. Dial confessed to the murder which he claimed was a contract killing for the mob. Broken Arrow police never discovered who hired Dial to kill Hogan. In 1998, author Charles Sasser wrote a book about Dial entitled, " At Large: The Life and Crimes of Randolph Franklin Dial." On November 9, 2001, Sasser claims Dial called him on the phone and the two spoke for approximately 45 minutes. Sasser also says he spoke with Parker. Agents were not able to trace the call but they believe Dial made the phone call. Dial's numerous aliases and nicknames include "Doc" Dial, Randolph Franklin Johnston, Randolph Franklin, Randy F. Johnson and "Doc" Franklin. He has a small scar under the left side of his chin, two small scars on his upper left chest, and a small round scar on the back of his left calf. His teeth are in poor condition and he may be missing one or two lower front teeth. He is a heavy drinker, speaks Spanish, and may talk about having been in the mob or claim to have been a government informant. He may be doing artwork as an occupation or means of income, and may be traveling with Bobbie Parker. Dial is 59, 5'9" and 150 pounds. (See Show #717, OAD 5/03/03)

**Jean Marie Jean-Francois (Murder)** - On November 7, 2003, the Broward County Sheriff's Office were called to investigate the welfare of a family living in an apartment in Pompano Beach, FL. After gaining entrance to the apartment, deputies found 37-year-old Fritz-Anna Florestral murdered. The woman's twelve-year-old daughter was found gagged and bound, but suffered no injuries. Florestral's live-in boyfriend, Jean Marie Jean-Francois, was missing as was his four-year-old daughter, Medjie Jean Francois. An Amber Alert was issued for the girl, and she was later recovered when a reverend called police to say he was caring for the child. The reverend told investigators that Jean-Francois had dropped his daughter off the afternoon of November 6, 2003. An autopsy has been performed on Florestral, however, the cause of death

has not been released. Jean-Francois, who is fluent in Creole, may have a mustache and may be traveling in a green 1999 Honda Accord. He is 33, 5'8" and 170 pounds.

**MISSING:**

**Bobbie Louaine Parker**

Age: 40

Height: 5'5"

Weight: 120 pounds

Bobbie Parker has been missing from Granite, Oklahoma since August 30, 1994. Bobbie was married to Randy Parker, a deputy warden at a medium security prison in Granite. They lived on the prison grounds with their two young daughters. Randolph Dial, an inmate serving a life sentence for murder, was assigned to do yard work at the Parker's house. Dial also ran a prison pottery program in a garage off Bobbie's house. On the morning of August 30th, Bobbie told her husband she was going shopping for the day. Agents believe Bobbie left the prison around 12:30 p.m. Later that day, guards discovered that Dial was missing. Investigators believe that Dial kidnapped Bobbie and escaped from the prison in her vehicle. Bobbie made several phone calls to friends and family, stating that she was okay and that she would be home soon. The last phone call was made ten days after the escape. Bobbie's vehicle was found abandoned in Wichita Falls, Texas. Neither Bobbie Parker or Randolph Dial have been seen since the escape. (See Show #717, OAD 5/03/03)

**Amanda Berry**

Age: 17

Height: 5'1"

Weight: 110 pounds

On April 21, 2003, Amanda Berry left her job at Burger King and has not been seen since. One week after Amanda's disappearance, her family received a mysterious phone call from an unidentified man. He claimed that he had Amanda and that she would be returned home in a couple of days. Amanda was planning on having a party to celebrate her 17<sup>th</sup> birthday on April 22<sup>nd</sup>. Amanda loves shopping, talking on the phone and listening to Eminem. She was last seen wearing a Burger King uniform.

**Mickey Wright**

Age: 49

Height: 5'8"

Weight: 185 pounds

Mickey Wright, a code enforcement inspector with the Construction Code Enforcement Office, was last seen in Memphis, Tennessee on April 17, 2001. Wright was on the job the day of his disappearance and was last seen serving a citation at a local car lot. The day Wright disappeared, a witness reported seeing an unidentified white male behind (with light-colored hair parted down the middle) the wheel of a pick up truck similar to the one Wright was driving. It is unknown if the driver is involved in the disappearance or not. Wright's county identification badge and personal items were found two days later in a canal by a jogger in southeast DeSoto County, Mississippi. Then, his government truck was found burned ten days after he was reported missing, in a field in Marshall County, Mississippi. Witnesses reported to have seen Wright engaged in a fight with three men the day he went missing. The fight moved behind a shed where they say Mickey was shot and killed but authorities have not found any evidence to confirm the account. Authorities are trying to determine if Wright was a victim of foul play or if he is alive and well living a new life. Authorities have conducted a number of searches in DeSoto and Marshall counties, but no trace of Wright has been found. Wright is a diabetic and requires insulin.

**Hai Thanh Le (aka Teo Nguyen)** (Attempted Murder) – On November 19, 2002 New York City police officer Hung Nguyen was visiting a friend at the Miss Saigon Bar in Jersey City, New Jersey. Yuen “Wendy” Nguyen (currently in custody), Mai “Mike” Nguyen (currently in custody), Teo Nguyen and Binh Nguyen (currently in custody), members of a local gang known as O.U.T. (Orientals United Together) were also at the bar that night. When the bartender tried to clear the establishment at closing time they refused to leave and became rowdy. Officer Nguyen then stepped in to remove the four. After the four left the bar they returned and severely attacked officer Nguyen. He was repeatedly beaten with bar stools and suffered two crushed vertebrae in his back. He is currently paralyzed from the chest down and is in rehabilitation. On November 12, 2003, one of the gang members, Uyen Nguyen, was captured in a local Vietnamese community in California. Le/Teo Nguyen is 22 or 23, 5'8" and 145 pounds. (See Show #701 and #738 OADs 12/21/02 and 10/04/03)

**David Garcia** (Murder, Attempted Murder) - David Garcia is wanted for murder of Burbank Police Officer Matthew Pavelka and the attempted murder of Burbank Police Officer Gregory Campbell. On the evening of Saturday, November 15, 2003, Campbell spotted two men in a Cadillac Escalade without license plates in the north parking lot of a Ramada Inn on San Fernando Road in Burbank, California. The lot was well known to Burbank Police for auto burglary, auto theft and narcotics activity. Campbell asked the driver, 25-year-old Ramon Aranda, for his license and registration and when he couldn't produce them, Campbell called for backup. Pavelka, 26, arrived almost immediately, and Campbell ordered the driver to get out of the Cadillac. Ramon and Garcia exited the vehicle and unexpectedly opened fire on the officers. Both Campbell and Pavelka returned fire but both officers were shot several times (the suspects fired 30 rounds). Aranda was killed in the shootout, but Garcia fled on foot. The officers were transported to a local hospital, but Pavelka later died in surgery. Meanwhile, a massive manhunt began for Garcia. Police set up a wide perimeter, using K-9 patrols, SWAT teams and helicopters. The intensive search--involving Burbank, Glendale and the LAPD along with L.A.

Sheriff's deputies, California Highway Patrol, FBI, DEA and the USMS, continues. Garcia, who has visible facial acne scars and a shaved head, is considered to be armed and dangerous. Authorities believe that family members in the Sun Valley area are hiding him. Garcia is 19, 6'1" and 220 pounds.

**Natia Johnson** (Murder, Attempted Robbery) - Authorities in West Palm Beach are searching for Natia Johnson for the attempted robbery and attempted murder of a woman on the way home from a bingo tournament. On Sunday, August 3, 2003, Johnson was at the popular West Palm Beach Hall (a bingo hall in Florida) when she noticed a woman, Pamela Anderson. Anderson won \$5,900 that night and Johnson wanted the money. Johnson soon had a plan and called her friends Tiffany Washington, and Calvin Morgan and her brother, B.J. to help her carry out her plan to rob Anderson. The four waited outside the bingo hall for Anderson to exit and followed her home. B.J. and Morgan jumped out of their car, ran up to Anderson's car and pointed a nine millimeter gun at Anderson and her friend and demanded the \$5,900. When the women refused to turn over the money, B.J. fired on them. The bullet went through the windshield and it hit Anderson in the stomach. The men ran back to Washington's car with Johnson still inside, and the four fled the scene. Meanwhile, fighting to remain conscious, Anderson tried to drive herself to the hospital. She eventually lost consciousness and ran off the side of the road. Fortunately, a passing motorist called for help and Anderson was rushed to the nearest hospital. Anderson is a mother of nine children, and she remains hospitalized with numerous internal injuries. Washington, Morgan and B.J. are in custody. Johnson is still at large. Authorities believe that Johnson stays on the move by renting cars and ditching them. They also discovered that she has ten different Florida licenses and her photo isn't the same on any of them. She may be pregnant and is believed to be on the run with the child's father. Johnson, who has used the aliases Natalia, and Nitia Nacole, has unknown tattoos on her left arm, left ankle and chest. She also has scars on her left arm, right leg and the right side of her neck. Johnson is 23, 5'1" and 118 pounds.

**Clown Bandit** (Bank Robbery) - Virginia Beach Police are searching for a white female who robbed a Bank of America branch on Thursday, October 30, 2003. She allegedly used an odd disguise: a clown costume complete with a multi-colored clown wig and white face makeup. A taxi driver picked up the "clown" outside a Party City store in Virginia Beach, then drove her a few miles to the Bank of America branch. The driver said the "clown" wanted to cash her paycheck. While inside the bank, the "clown" passed a note to a teller demanding money. The teller complied. A few minutes later, the "clown" left the bank, returned to the taxi and asked to be dropped off back at the Party City store. The Clown Bandit is 20-50 years old, 5'5"- 5'7" and between 140 to 170 pounds and was carrying a blue backpack at the time of the robbery.

**Unknown Las Vegas Murder Victim** – Las Vegas Police are trying to determine the identity of a man found buried in the backyard of a house owned by Anna Mitchel. In the early morning hours of July 21, 2003, Las Vegas Metropolitan Police officers were summoned to a home to investigate a report that a corpse had been found buried in the backyard. A tenant, 22-year-old Christopher Loudermilk, had discovered the body. Loudermilk told police that his landlord/roommate, Anna Mitchel, 37, had confessed to him earlier that evening that she had killed someone and buried the body in her backyard. Homicide investigators unearthed the body of a middle-aged white male whose legs had been cut off. The officers later learn that the victim's legs had been burned and stored in a garbage bag. The coroner believes the victim was murdered and buried between one and three years prior to the gruesome discovery. Mitchel was

arrested at the scene that night and charged with murder. Mitchel has refused to tell investigators anything that would help them identify the man she allegedly murdered and buried in her yard. Mitchel is currently awaiting trial for the murder of the unidentified man. The only clues to the victim's identity are the numerous tattoos that remained intact on his cadaver. A demonic skull on his lower left abdomen; a long-haired hippie looking man's head on his lower left rib cage; a skull mounted atop crossed swords on the right side of his neck; a detailed mural of naked women and other figures covering his back. The unidentified victim has long, black, and grey hair. He is 35-60 years old and 5'10"-6'0."

**Aaron Anderson (Murder)** - Aaron Anderson is wanted for the fatal shooting of Pastor Benjamin Mobley. On November 4, 2003, Anderson walked into a bible study class demanding to know his estranged wife's whereabouts. After accusing the Pastor Mobley of stealing his wife, Anderson unexpectedly shoots him in the chest. Anderson fled the scene in a light blue late 80's Buick or Mustang that has a white stripe which runs from the driver's side, over the roof and down the passenger side. Anderson is 64, 6'2" and 250 pounds. (See Show #740, OAD 11/08/03)

**John Stoneman (Rape of a Minor, Child Pornography)**

**Patricia Kelley (Rape of a Minor)** – Stoneman and Kelley are wanted for the rape of a minor. The pair videotaped their sexual assault of a profoundly handicapped four-year-old child. Kelley was a Licensed Practical nurse charged with the daily care of a four-year-old disabled girl. The victim suffers from spina bifida, hydrocephalus, diabetes and a seizure disorder that leaves her blind and unable to communicate or move. Cops first began investigating Stoneman when child pornography found during a case in Orange County, California was linked to a computer in his Cambridge, Ohio home. Police arrested Stoneman, but he quickly posted bond for those child pornography charges. Subsequent searches of the home that he and Kelley shared uncovered many more crimes, including the videotape of the assault on the disabled four-year-old. They also discovered a two-way mirror with a video camera behind it, used to videotape minors changing clothes. Authorities are still determining how many juveniles were victimized by this couple. Stoneman failed to appear for a hearing on the initial pornography and weapons charges. The pair fled together, and were last seen driving a light-gray four-door 1996 Saturn with Ohio plates DU 27 SX. Stoneman, who has used the aliases Randy D. Wackbacher and Randy D. Weckbacher, has a receding hairline. He is a smoker, has glaucoma and always wears sunglasses, even inside, and takes medicine and eye drops for his condition. He may have changed his hair color and style. He may be frequenting gun shows or firing ranges, and may be working as a handyman. He should be considered armed and dangerous. Stoneman is 38, 5'9" and 160 pounds. Kelley, who has a very visible scar across her throat from a knife wound, has used numerous aliases including Patricia A. Dowell, Trish A. Dowell, and Trish Kelley. She may have changed the color and style of her dyed-blond hair. She may still be working as a health care provider. She too should be considered armed and dangerous. Kelley is 39, 5'3" and 150 pounds. (See Show #738, OAD 10/04/03)

**Helen Schlapak (Fraud, Money Laundering)** – In June of 1997, a phony investment corporation was created under the name "Cayman Island Program" or CIP. The leaders of the corporation solicited people to join saying that when they invested a minimum of \$1,000, they would receive an 8% weekly return. They also told investors that at the end of thirteen weeks, they could retrieve their initial investment or re-invest. The investment program snowballed and grew to eventually involve victims not only in Hawaii, but throughout the United States,

American Samoa, Canada, Poland, Australia, and elsewhere. The investment program turned out to be an elaborate scam. By the time law enforcement dismantled the scheme in October of 1998, more than 5,000 people had lost an estimated \$67 million. In March of 1998, Helen Schlapak became a group leader for the premier group at CIP and successfully brought \$8 million into the program, soliciting 800 people using the Internet, the United States Postal System and church organizations. When CIP broke up in October of 1998, police recovered just \$400,000. Agents arrested and convicted twelve of the thirteen leaders of the scam. Schlapak has evaded arrest and reportedly made off with much of the \$8 million she solicited from her victims. Schlapak is 63, 5'8" and 120 pounds.

#### **ALL POINTS BULLETIN:**

**Carmen Cabrera (Murder)** - Cabrera was born in Mexico and came to the United States in the late 1980's. After being hired at a piecework factory in the South Central area of Los Angeles in 1997, Cabrera became involved with Guadalupe Alvarez, the foreman of the company. Over the next year Alvarez helped Carmen financially and provided groceries for her family. He also provided her with transportation to and from work. Because of the relationship with Alvarez, Carmen was able to remain employed at the factory despite her lack of productivity. A year into her involvement with Alvarez, Cabrera heard rumors he was going to break off the relationship with her. She refused to let him walk away and on Saturday, November 21, 1998 she shot and killed him in her apartment. She then stayed with Alvarez's body for five hours before leaving the scene. She was seen in Mexico City by relatives and friends after the murder but police believe she is now in the Los Angeles area where she has family. Cabrera, who has used the aliases Carmen Torres and Carmen Del Torres, frequently wears stiletto-type high heels and often dresses in flashy clothes and short skirts. She has long, manicured nails. She may be carrying fake resident alien card, and may still be employed as a pieceworker in a clothing factory. She is described as manipulative, egotistical and should be considered armed and dangerous. Cabrera is 43, 5'4" and 135 pounds. (See Show #706 and 733, OADs 2/15/03 and 8/30/03)

**Desiree Dawn Lingo-Perkins (Capital Murder)** – On March 12, 2000 Kyle Nathan McElroy was kidnapped in Troup, Texas. McElroy was the son of a very wealthy businessman who had recently acquired a large sum of money from a business merger. A ransom note was sent to Kyle's parents demanding \$200,000. Unbeknownst to the family, however, the kidnappers had already tortured and killed Kyle before the first ransom call was made. One day later, Kyle McElroy's body was found in rural Cherokee County, Texas. The investigation led to the arrest of three men: Daniel Rios, Ernesto Bailon and Alfredo Romero. Investigators believe that Rios had been an employee at McElroy plastics and had worked with Kyle McElroy. Still on the run is Desiree Dawn Lingo-Perkins. She is a known prostitute who was an active participant in the planning and execution of the abduction and murder of McElroy. She was responsible for making several ransom calls to the McElroy family demanding money. Lingo-Perkins is known to have family in Beaumont, Texas and Barling, Arkansas. She also a teenage daughter residing somewhere in Connecticut; two other children died in a car accident in 2002. She has supported herself for years as a prostitute in the Latin American immigrant community. Her familiarity with this community may lead her to attempt to escape to Mexico. Lingo-Perkins, who has used the alias Esperanza Perkins, has a butterfly tattoo on her right ankle and a scar on her abdomen. She is suspected to be HIV-positive. Lingo-Perkins is 34, 5'6" and 170 pounds. (See Shows #584, #595, #705 and #718, OADs 4/15/00, 7/15/00, 2/1/03 and 5/10/03)

**Greisy Valencia (Child Abuse)** – The Hayward Police Department is searching for 49-year-old Greisy Valencia for the alleged torture of her 11-year-old daughter. Police say that Valencia began torturing the girl at the age of four. Police and witnesses say that Valencia would hold the girl's hands and face over the stove as a form of punishment. Police also say that Valencia burned and hit the girl with several different objects. Social workers and police both say it is the worse case of child abuse they have ever seen. The girl is covered with scars from head to toe. Police say on December 9, 2002, Valencia got word that someone close to the girl was going to report her to the police. Valencia abruptly left work and told her employers that she didn't know when she was going to return. The little girl and her two brothers are in foster care and doing well. Valencia works in fast food restaurants and comes across as very witty and hardworking. She has used the alias Yudera Monteel. She likes to hang out with and spend money on men. Valencia is 50, 5'3" and 130-154 pounds. (See Show #718 and #727, OADs 5/10/03 and 7/19/03)

**CAPTURED:**

**Uyen Nguyen (Attempted Murder)** – On November 19, 2002 New York City police officer Hung Nguyen was visiting a friend at the Miss Saigon Bar in Jersey City, New Jersey. Yuen "Wendy" Nguyen, Mai "Mike" Nguyen (currently in custody), Teo Nguyen and Binh Nguyen (currently in custody), members of a local gang known as O.U.T. (Orientals United Together) were also at the bar that night. When the bartender tried to clear the establishment at closing time they refused to leave and became rowdy. Officer Nguyen then stepped in to remove the four. After the four left the bar they returned and severely attacked officer Nguyen. He was repeatedly beaten with bar stools and suffered two crushed vertebrae in his back. He is currently paralyzed from the chest down and is in rehabilitation. An anonymous tip from an AMW viewer led Westminster (CA) authorities to Uyen Nguyen and her boyfriend Ton Le's apartment in a local Vietnamese community. Wendy Le faces attempted murder charges and Le is charged with harboring a fugitive. Nguyen's brother, Hai Thanh Le remains a fugitive. (See Shows #701 and #738 OADs 12/21/02 and 10/04/03)

**Peters Township, Pennsylvania...**MICHAEL MARKS...Police are looking for Michael Marks and his violent band of gypsy robbers for a string of home invasions robberies, one that ended in murder.

**Webster, New York...**XEROX FEDERAL CREDIT UNION KILLER...Cops say that on the morning of August 12, 2003, a man wearing an FBI jacket and a US Marshals badge entered a Credit Union carrying a briefcase. The man told the employees that he was a federal agent who was staging a robbery and asked them about the bank's security and alarms. He then pulled out a handgun and a sawed-off long gun and demanded money from the tellers. The robber shot two of the customers, killing one of them, and then ran out of the building.

**Passaic, New Jersey...**FRANCISCO MARTINEZ UPDATE...Police in Passaic, New Jersey are looking for the man responsible for killing his boss. They say Francisco Martinez shot Michael Cerullo on September 14, 2002.

**Newport News, Virginia...**SCOTT BRINEGAR UPDATE... According to police, Scott James Brinegar is wanted for the 1996 robbery of the Signet Bank on Warwick Avenue in Newport News, Virginia.

**New York, New York...**ANDRE NEVERSON UPDATE...Cops in Brooklyn are on the hunt for Andre Neverson, suspected of murdering his sister and ex-girlfriend in 2002. Thirty-nine year-old Patricia Neverson was found shot to death in her Brooklyn home on Monday, July 8, 2002. Three days later, the body of 34-year-old Donna Davis was discovered. Cops believe the motive for the murder of Patricia Neverson was money borrowed from Andre Neverson to purchase her home. This on-going argument was fueled by Andre's desire for the house instead of the repayment of the money. Davis had been dating Neverson but had recently ended the relationship. According to friends and others close to the couple, Neverson did not take the rejection well.

**San Francisco, California...**DINO LOREN SMITH and TROY DEVIN SMITH UPDATE...Police say these brothers are charged with a 2003 burglary of a San Francisco jewelry store.

**Cincinnati, Ohio...**JOHN STONEMAN and PATRICIA KELLEY UPDATE...Police say John Stoneman and his girlfriend, Patricia Kelley, are wanted for the rape of a minor. Cops say that the pair videotaped their sexual assault of a profoundly handicapped four-year-old child.

**Davie, Florida...**RICKY ALAN SLEIGHT CAPTURE...A good police investigation led to the arrest of Ricky Sleight, a wanted killer. Police had been looking for Ricky Sleight in connection with the murder of his roommate, William Baldi. Cops say in the early morning hours of September 1, 2003 neighbors overheard an argument coming from Sleight & Baldi's apartment, then heard doors slamming and a loud thump. Thanks to viewer tips, both men were arrested on Sunday, November 2, 2003 after a wild police chase resulted in a head-on collision with Miami-Dade police.

**Lawton, Oklahoma...**DAVID LEE KEMP...On August 5, 1998, Tina Cremer Kemp divorced her husband of five years, David Kemp. **Nashville, Tennessee...**LARRY CHISM...Larry Chism is wanted by the US Marshals for escaping custody in 1978. He has been named to the US Marshals 15 Most Wanted Fugitive List. Chism was serving a 40-year sentence for Armed Robbery, Narcotics and Violation of Age of Consent. Chism has been able to overpower guards, take a hostage, steal a car, hijack a plane and elude capture.

Several hours later, her husband tried to reach her but couldn't. Mary Morris never showed up for work. Hours later, a passerby found that Mary Morris' car was torched with her body inside, burnt beyond recognition. Four days later, on October 16, 2000, the case takes a more bizarre turn. Mary McGinnis Morris is found in her car, severely beaten with a fatal gunshot wound to the head. This location is not far from where the first Mary Morris was found. Investigators are hesitant to believe that these two murders are linked, but will not rule out the possibility.

**Scottsdale, Arizona...ROBERT FISHER...**Police say Robert Fisher is wanted for killing his wife and two young children, then rigging their home to explode in order to hide the crime.

San Francisco, California...DANIEL ANDREAS SAN DIEGO...Daniel Andreas San Diego is wanted by the FBI for two bombings in the San Francisco Bay Area of California.

Jackson, Mississippi and San Diego, California...LARRY SHELTON HENTZ and ELIZABETH LACY HENTZ CAPTURE...The nearly month long search for a prison escapee, and the woman who helped him break out, is finally over. Larry Hentz and his wife Elizabeth were arrested in San Diego, California on December 11th. Detectives in Mississippi had been searching for Larry and Elizabeth Hentz since he escaped from a state penitentiary. Larry Hentz was sentenced to life in prison for murdering a man in the early 1980's. Police say Hentz cut through the bars of his cell window during the early morning hours of November 17, 2003. Cops say Hentz then cut through two perimeter fences and fled to a nearby highway. Police say Elizabeth Hentz picked her husband up and the couple took off.

Los Angeles, California...UNKNOWN HOWARD STEINDLER KILLER(S)...On Wednesday, March 9, 1977, 72-year old Howard "Howie" Steindler was robbed, kidnapped and murdered by at least two unknown suspects. Steindler was the proprietor of the famous Main Street Gym in downtown Los Angeles, California – the training place for boxing greats like Mohammad Ali, Sugar Ray Robinson and Roberto Duran . After leaving the gym on March 9, Steindler drove to his home in Encino. Just blocks from his residence, police say, Steindler's gold, 1976 Cadillac, with the vanity plate "Howie 5" might have been involved in a planned "bump and run" robbery. A witness saw Steindler standing outside of his vehicle with the suspects when they began beating him. Steindler struggled and the suspects threw him into the Cadillac's backseat and sped away. The vehicle was found a short time later on the shoulder of the Ventura Freeway near the Laurel Canyon exit. Steindler's body was found in the back seat. He had been severely beaten and smothered to death. Howie's murder is still unsolved after 26 years. LAPD's elite Robbery Homicide Division has re-opened the cold case and is looking at new DNA evidence

Pleasant Unity, Pennsylvania...UNKNOWN SANTA BANK ROBBER 2003... Pennsylvania State Police investigators are searching for the unknown white male dressed as Santa who robbed the Commercial National Bank in Pleasant Unity, Pennsylvania on December 15, 2003.

Albuquerque, New Mexico...RICHARD SANCHEZ... Police in Albuquerque, New Mexico, are looking for Richard Robert Sanchez. They say that Sanchez physically and sexually assaulted his sister-in-law as retribution against his

estranged wife. Detectives believe that when he realized he would go to jail for his actions, Sanchez abducted his three non-custodial sons and took off.

Allentown, Pennsylvania...STANLEY OBAS...Police say Stanley Obas is wanted in Pennsylvania for the 1996 torture and murder of 13-year-old Richezza Williams. Police say Richezza ran away from her home in Long Island, New York in March 1996. Five months later, her badly decomposed body was found in a cemetery in Easton, Pennsylvania. According to police, three young men tortured and murdered Richezza and then placed her body in a box, carried it to the cemetery, and hid the box in a storage vault. Two of the men involved in the murder have been arrested and convicted, but the third man, Stanley Obas, is still on the loose.

Celina, Ohio...JEROME BARGO CAPTURE...One of the longest manhunts in the history of AMERICA'S MOST WANTED is finally over – even though police had to catch him twice. Jerome Bargo is accused of trying to kill a cop back in 1989, and was sentenced to 140 years. But he escaped – and despite four airings on AMERICA'S MOST WANTED, Bargo managed to stay on the run. He hid out in Venezuela – but, ironically, decided to leave because he felt the crime rate was too high and was tired of becoming a victim! Bargo returned to America, and was arrested on drug charges. That should have ended his run – but he gave cops a fake name. And before they could figure out that he was the notorious Jerome Bargo, he managed to bail out, and vanished once again. Now, thanks to an AMW tipster, Bargo's finally back behind bars – this time for good.

Globe, Arizona...GORDON MYERS...Gordon Myers is accused of molesting his two young granddaughters. Police say one of the victims finally came forward and told her mother what was happening. Interviews were conducted and Myers was promptly arrested. He has since skipped town and has not been located.

St. Petersburg, Florida...LEO CISNEROS...Leo Cisneros is wanted for ordering a hit man to murder his girlfriend's ex-husband. Cisneros is a Columbian national who loves the nightlife, and police believe he may be hiding in South America, the Bahamas, Cuba, or Miami.

Sacramento, California...ALEJANDRO SANTANA...Cops say that on August 22, 2000, Santana, along with another accomplice, showed up at Sports Time Car Lot with the intention of stealing a Chevy Camaro. Witnesses say the two asked for Buchholz because he was a Camaro expert. The three got into the car and drove off. According to authorities, Buchholz was shot in the back of the head while in the car and his body was dumped on the shoulder of the interstate. Santana's accomplice was identified and placed in custody, however Santana is still on the run and police believe he may be in Mexico.

Miami, Florida...MICHAEL BARRERA...Police say he was a teenaged ex-con who stole his ideas from the movies and then launched a crime spree of his very own. Michael "Mitch" Barrera is accused of robbing two Miami banks, stealing a car, and attempting to murder a Metro-Dade police officer. He thought he could get rich quick, but his plan soon backfired. An alert witness foiled Barrera's latest bank robbery and sent him on the run. With help from viewers, AMW hopes to put this young criminal where he belongs – behind bars.

Cleveland, Ohio...FETHI JELASSI...Cops in Cleveland are looking for Fethi Jelassi for the 2000 double murder of David Settle and his mother Patsy. Even though he was married, Jelassi had struck up a relationship with another woman. That woman also was dating David Settle, causing Jelassi to become jealous. Cops say, on June 22, 2000, Jelassi went to a home rented by David and Patsy and shot both of them repeatedly in the head. They both were later found dead inside the home. Jelassi's SUV was found in the parking lot of a car dealership but he was gone.

Minneapolis, Minnesota...DEREK MADDOX...FBI Agents in Minneapolis, Minnesota are seeking Derek Ladonte Maddox. They say he's responsible for at least two armed robberies of banks in their city.

Los Angeles, California...MARVIN MERCADO...Since 1993, LAPD says the Asian Boyz, an Asian gang in Los Angeles, has been connected to multiple gang-related crimes including violence, vandalism, murder, burglary, robbery, and attempted murder. They were fighting for their turf in 1993 when police say, a rival gang shot and killed "Kicker" a member of the Asian Boyz. Police say since then the Asian Boyz sought revenge. Police have connected the gang to a dozen murders in an 18-month period during 1995-1996. On May 30, 1996, police rounded up 19 members of the Asian Boyz. However, they didn't have enough evidence at that time to hold Sothi Menh and Marvin Mercado, until an informant came forward on February 13, 1997 when the DA filed murder warrants on Sothi Menh and Marvin Mercado. Police say Marvin Mercado will do anything to avoid capture. He is known to carry automatic weapons, and is

considered armed and dangerous. Mercado is charged with six counts of murder, 13 counts of attempted murder and four counts of conspiracy to commit murder.

John Walsh looks back through 2003 and names his own personal "Ten Most Wanted" Fugitives from the past year. The candidates for the Most Wanted include:

--A man who killed his estranged wife's boyfriend, then tried to kill her by stabbing her 19 times and shooting her.

--A fugitive who led police on a high-speed chase on the New Jersey Turnpike in a stolen tractor-trailer.

--A man who created a ruse to get into female college students' apartments and sexually assault them.

John Walsh is starting the New Year by making a resolution to bring these fugitives to justice, and we need viewers' help to make it a reality. Tune in to see who gets pegged as the #1 Most Wanted fugitive of the year.

**Salt Lake City, Utah...**JESSIE VEGA...Police say Jessie "Chivo" Vega is wanted for the murder of 19-year-old Tricia Beristain. On November 15, 1998 deer hunters found Tricia's body in a canyon outside of Salt Lake City. Police later determined Tricia had been dating Vega prior to her murder. Tricia was last seen with Vega and another man, Diego Cruz, on the night of her murder. Detectives believe that Vega murdered Tricia because of a suspicion that she was dating another man.

**Birmingham, Alabama...**MARCUS HEAD...Police say Marcus Head plotted to kill his estranged wife Sabrina after she left their abusive marriage to start a new life in Alabama. Head frequently called Sabrina threatening her life if she didn't come back to their home in Indiana. In mid-September Head called her enraged – threatening that he was going to find her and kill her on her birthday, October 1<sup>st</sup>, if she didn't come back to him. Sabrina did not return and in fact was involved with another man at this time. Police say Head followed through on his threat and broke into Sabrina's home and while Sabrina and her new boyfriend were sleeping, Head burst from the guest room closet and within seconds shot

the boyfriend multiple times – killing him. According to authorities, Head turned the gun on Sabrina shooting her twice and realized he had run out of bullets so he pulled out a knife and brutally stabbed her 19 times. Sabrina miraculously survived and Head is on the loose.

**Cincinnati, Ohio...**JOHN STONEMAN and PATRICIA KELLEY UPDATE...Police say John Stoneman and his girlfriend, Patricia Kelley, are wanted for the rape of a minor. Cops say that the pair videotaped their sexual assault of a profoundly handicapped four-year-old child.

**Hayward, California...**GREISY VALENCIA...The Hayward Police Department is searching for 49-year-old Greisy Valencia for the alleged torture of her 11-year-old daughter. Police say that Valencia began torturing the girl at the age of four. Police and witnesses say that Valencia would hold the girl's hands and face over the stove as a form of punishment. Social workers and police both say it is the worse case of child abuse they have ever seen. The girl is covered with scars from head to toe. Police say on December 9, 2002, Greisy Valencia got word that someone close to the girl was going to report her to the police so she abruptly left work and told her employers that she didn't know when she was going to return. Police say the little girl and her two brothers are in foster care and doing well.

**Tampa, Florida...**CHRISTIAN CLEMENTE RODRIGUEZ...Police are looking for Christian Rodriguez, who is wanted for a series of sexual assaults against Florida State University students in 1999. Authorities say Rodriguez has been charged for the crimes, but fled to Miami and has since possibly moved to Puerto Rico.

**Fairview, New Jersey...**DOUG AIGEN UPDATE...Police are hot on the trail of fugitive Doug Aigen, a man who has no fear. Cops say after a string of abductions, Aigen stole a tractor-trailer and drove it onto the New Jersey Turnpike, deliberately smashing into any state trooper, passenger car or commercial truck that got in his way. Amazingly, Aigen was able to escape and remains on the loose.

**Los Angeles, California...**EDUARDO "LIMPY" RODRIGUEZ...According to police, Eduardo Campos Rodriguez is wanted for four counts of murder and two counts of attempted murder.

**Clovis, California...**LOVEKESH "BOBBY" KUMAR...Authorities say that Lovekesh Kumar is the prime suspect in the double murder of his estranged wife and her mother. Police say that there was evidence at the scene linking Kumar to the murders for which the victims were repeatedly slashed and stabbed with a knife. On the same day as the murders, a man called police saying he almost hit a man who was running in and out of traffic in San Jose. The man fit Kumar's description, and had a car that fit the license plate number of Kumar's vehicle. Police responded, but when they arrived at the scene the suspect was gone.

**Jacksonville, Florida...PINKNEY CARTER...**Cops say that on July 24, 2002, Pinkney "Chip" Carter went to his ex-girlfriend, Elizabeth Reed's house where she lived with her four children. Elizabeth's current boyfriend, Glenn Pafford, was also at her house. Police say Carter was upset about the breakup with Elizabeth and fired shots at her and Glenn. Cops say he then turned the gun at Elizabeth's 16 year-old daughter. All three died from the gun shot wounds.
