The following are the featured fugitives and others being sought by federal, state or local authorities. The <u>Update</u> (if any) gives current status, previous references, or related information.

Jessi Vega (Murder) -- On November 15, 1998, deer hunters found Tricia Beristain's body on the roadside in a canyon outside Salt Lake City. Police later determined that Beristain had been dating Vega prior to her murder. She was last seen with Vega and another man, Diego Cruz, on the night she died. Cruz was later captured in California. Detectives say Vega took Beristain up into the canyon and executed her with a 9mm handgun because he mistakenly thought she was seeing another man. Police are not sure that "Jessi Vega" is his real name; he has used numerous aliases including Jesse Vega, Jesus Vega, Jesus Alonzo, Jesus Mungia, Arturo Mungia, and the nickname "Chivo". He has four silver-capped upper front teeth and tattoos including a bullet bandolier across his upper torso from his left shoulder to his right waistline, a Chicago Bulls logo on his upper left shoulder, and a star between his left thumb and forefinger. He is a drifter who works sporadically as a day laborer, and may be a member of the "La Familia" or "Folks" street gangs. He drinks beer, smokes marijuana, and has a history of domestic assaults in Illinois. Vega is 28, 5'5" and 150 pounds. (See Shows #717 and #720, OADs 5/3/03 and 5/24/03)

Marcus Head (Murder) – Head plotted to kill his estranged wife Sabrina after she left their home in Indiana to start a new life in Alabama. Friends and relatives of the couple say Head had a history of physically abusing Sabrina. In 2001, Sabrina finally got up the courage to leave him and moved closer to her family. Head refused to let things end there. He frequently called Sabrina, threatening her that he would kill her if she didn't come back to their home in Indiana. In mid-September 2001, Marcus called her in Birmingham enraged, threatening her that he was coming down to kill her on her birthday, October 1, unless she came back to him. Sabrina did not return. In fact, she began dating another man, 17-year-old Derrick Charles. Late on the night of September 30, 2001, Sabrina, Derrick and another couple celebrated Sabrina's birthday with a night out on the town. While they were gone, Head removed an air conditioning unit and broke into Sabrina's house through a window. He hid himself in a guest bedroom

closet. Sabrina, Derrick and the other couple arrived home late and went to bed. Sabrina and Derrick slept in her bedroom, while the other couple stayed in the guest room where Head was hiding. Head laid in wait until 4:00am and then burst out of the guest room closet. He stormed past the couple and into Sabrina's room where she and Derrick were sleeping. Within seconds, Head pulled a gun and shot Derrick multiple times, killing him. He then turned the gun on Sabrina and shot her twice. He would have kept going but the gun jammed. So head pulled out a knife and brutally stabbed her, then fled. Sabrina survived the attack. Head has a scar on his head from a childhood accident. He sometimes wears a ponytail or braids, has a soft, mellow tone of voice, and smokes Newport cigarettes. He is scared of bugs. His family may be protecting him. He has tried to contact Sabrina since the murder. Head is 26, 6'1" and 230-280 pounds. (See Show #706, OAD 2/15/03)

John Stoneman (Rape of a Minor, Child Pornography)

Patricia Kelley (Rape of a Minor) – Stoneman and Kelley are wanted for the rape of a minor. The pair videotaped their sexual assault of a profoundly handicapped four-year-old child. Kelley was a Licensed Practical nurse charged with the daily care of a four-year-old disabled girl. The victim suffers from spina bifida, hydrocephalus, diabetes and a seizure disorder that leaves her blind and unable to communicate or move. Cops first began investigating Stoneman when child pornography found during a case in Orange County, California was linked to a computer in his Cambridge, Ohio home. Police arrested Stoneman, but he quickly posted bond for those child pornography charges. Subsequent searches of the home that he and Kelley shared uncovered many more crimes, including the videotape of the assault on the disabled four-yearold. They also discovered a two-way mirror with a video camera behind it, used to videotape minors changing clothes. Authorities are still determining how many juveniles were victimized by this couple. Stoneman failed to appear for a hearing on the initial pornography and weapons charges. The pair fled together, and were last seen driving a light-gray four-door 1996 Saturn with Ohio plates DU 27 SX. Stoneman, who has used the aliases Randy D. Wackbacher and Randy D. Weckbacher, has a receding hairline. He is a smoker, has glaucoma and always wears sunglasses, even inside, and takes medicine and eye drops for his condition. He may have changed his hair color and style. He may be frequenting gun shows or firing ranges, and may be working as a handyman. He should be considered armed and dangerous. Stoneman is 39, 5'9" and 160 pounds. Kelley, who has a very visible scar across her throat from a knife wound, has used numerous aliases including Patricia A. Dowell, Trish A. Dowell, and Trish Kelley. She may have changed the color and style of her dyed-blonde hair. She may still be working as a health care provider. She too should be considered armed and dangerous. Kelley is 39, 5'3" and 150 pounds. (See Shows #738 and #742, OADs 10/04/03 and 11/22/03)

Greisy Valencia (Child Abuse) – The Hayward Police Department is searching for 49-year-old Greisy Valencia for the alleged torture of her 11-year-old daughter. Police say that Valencia began torturing the girl at the age of four. Police and witnesses say that Valencia would hold the girl's hands and face over the stove as a form of punishment. Police also say that Valencia burned and hit the girl with several different objects. Social workers and police both say it is the worse case of child abuse they have ever seen. The girl is covered with scars from head to toe. Police say on December 9, 2002, Valencia got word that someone close to the girl was going to report her to the police. Valencia abruptly left work and told her employers that she

didn't know when she was going to return. The little girl and her two brothers are in foster care and doing well. Valencia works in fast food restaurants and comes across as very witty and hardworking. She has used the alias Yudera Monteel. She likes to hang out with and spend money on men. Valencia is 50, 5'3" and 130-154 pounds. (See Shows #718, #727 and #742, OADs 5/10/03, 7/19/03 and 11/22/03)

Christian Clemente Rodriguez (Armed Burglary, Sexual Battery) — On March 12, 1999 Rodriguez and an accomplice broke into an apartment just off the University of South Florida campus. Rodriguez tied up two college students and then both men sexually assaulted one of them. On March 26, 1999, Rodriguez sexually assaulted another USF student in her apartment. This time, Rodriguez created a ruse, saying he was collecting signatures from tenants to have a party. When he confirmed the victim was home alone, he pushed his way in and sexually assaulted her. After being charged with the crimes, Rodriguez fled to Miami and authorities missed apprehending him by just minutes. Cops fear that he's since fled to Puerto Rico. Rodriguez, who has used the aliases Chris Rivera, Juan Antonio Rivera-Soto and Chris Rivers, has a scar on his right wrist and an unknown tattoo on his upper right arm. He speaks both English and Spanish, is known to frequent strip clubs and pick up the dancers, and has fathered a child by a stripper. Both his ears are pierced. He has sold drugs and burglarized cars for money in the past but has no solid work history. Rodriguez is 31, 5'9" and 170 pounds. (See Show #736, OAD 9/20/03)

Douglas Aigen (Aggravated Assault on a Police Officer) – Doug Aigen has a long rap sheet and doesn't want to go back to prison. His crimes range from forgery and theft to assault of a police officer and kidnapping. In 1992, Aigen kidnapped a woman in a parking lot and put her in the trunk of her car as he drove around using her ATM card. He released the victim and later was convicted of kidnapping charges and robbery. He was sentenced to fifteen years in a New Jersey prison. After his release in 2002, Aigen assaulted a police officer. On October 25, 2002, Aigen was trying to steal a load of batteries from a truck. Aigen bit and punched the officer, then fled. On January 10, 2003 Aigen attempted to steal a tractor trailer from a New Jersey truck company. Employees spotted him and tried to stop him by placing a pickup truck in front of the stolen tractor. Aigen rammed the pickup and led police on a chase on the New Jersey Turnpike and Route 78 in Newark. At one point during the pursuit, Aigen came to a complete stop with a trooper car right behind him. Instead of getting out of the tractor, Aigen put his truck in reverse and rammed the police car before fleeing. No one was injured. Since then, detectives in New Jersey and New York believe Aigen has been stealing tractors and trailers. Aigen sells the merchandise inside the trailers on the streets of New York and pockets the cash. They believe he won't go down without a fight. Aigen, who has used the aliases Doug Ailen, Dougas Reed Aigen and Douglas Robert Aigen, has "Leslie" tattooed on his right hip. He has a crack habit and must steal to survive. He may suffer from depression, and his family is afraid of him. Aigen is 37, 6'2" and 320 pounds. (See Show #735, OAD 9/13/03)

Eduardo "Limpy" Rodriguez (Murder, Attempted Murder) – Rodriguez is wanted for four counts of murder and two counts of attempted murder. Rodriguez, along with "Toonerville" ("TVR") street gang leader Timothy McGhee (now in custody) are accused of the 2001 shooting

deaths of Margie Mendoza, Mary Ann Wisotsky, Cheri Wisotsky and Bryham Robinson. Margie Mendoza, a 25-year-old mother of two with no gang affiliation, was killed when Rodriguez and McGhee opened fire on her SUV in a rival gang neighborhood in retaliation for another murder. Mary Ann Wisotsky, her daughter Cheri and family friend Robinson were executed because McGhee thought Cheri had informed on his sister to the police. Prior to the shooting, both Rodriguez and McGhee had brutally beaten Bryham in an effort to extract information from him. Shortly thereafter, all three were shot dead in Mary Ann's car. Rodriguez, who has used the alias Juan Carlos Campos Gamino, has several tattoos including "TV" on his stomach, "Toonerville" on his back, a female head on his left shoulder, "RIP" on his right arm, and additional unidentified tattoos on his right arm, upper left arm and right shoulder. He is an illegal alien from Mexico who is also wanted by the INS. He has dyed his hair red in the past. Rodriguez is 24, 5'9" and 170 pounds. (See Show #719, OAD 5/17/03)

Lovekesh "Bobby" Kumar (Murder) – Kumar is the prime suspect in the double murder of his estranged wife Pooja Vasudeva, 23, and her mother, Neeraj Narula, 43. A relative called police on January 10, 2003 when her repeated phone calls to Pooja were unanswered. Police officers discovered two bodies. There was evidence at the scene linking Kumar to the murders. The victims were repeatedly stabbed and slashed with a knife. On the same day, San Jose police received an anonymous call saying that a man was frantically running in and out of traffic in south San Jose and was almost hit by a car. Half an hour later the driver of a car called saying that he almost hit a man fitting Kumar's description, and also gave the license plate number of a car matching Kumar's. Hollywood police subsequently found Kumar's vehicle parked in a commercial parking garage. An attendant reported the car after it was left over the weekend without payment. Police had tips of Kumar being seen in the area. He may be using the surname Vasudeva. Kumar is 31, 5'6" and 128 pounds. (See Show #736, OAD 9/20/03)

Octiveio Gomez (Vehicular Manslaughter)- Octiveio Gomez is wanted for a hit and run incident that occurred on March 14, 2000. Gomez was driving a van when he struck and killed Kevin Dejear, who was riding his bicycle. Gomez fled the scene and abandoned the van at his girlfriend's house. Gomez has not been seen since. Gomez who is also known as "Blu ha" has worked as a laborer and as a roofer and is known to frequent drug houses. Gomez is 34, 5'8" 134 pounds.

Pinkney "Chip" Carter (Murder) – On July 24, 2002, Carter entered his ex-girlfriend Elizabeth Reed's house where she lived with her four children. Reed's current boyfriend, Glenn Pafford, was also at her house. Carter, who was disgruntled about the breakup of the relationship, fired shots at Glenn, then at Elizabeth. He then turned the gun at Courtney Smith, Elizabeth's 16-year-old daughter. Elizabeth and Glenn died on the spot, but Courtney was taken to the emergency room where she died two days later. Reed's 14-year-old son Rick was in a back room and came forward after hearing screams and gunshots, then called 911. On August 5, 2002, border patrol agents in Texas located Carter's truck in Escobares, Texas. Carter abandoned the vehicle, jumped into the Rio Grande, and swam to Mexico. Mexican soldiers patrolling the border arrested Carter when he arrived on the other side. When the soldiers searched Carter, they found two handguns. Carter was charged with the illegal importation of firearms and was facing up to eight years in prison. Mexican authorities refused to release Carter

to Jacksonville detectives, but told them that they would call when Carter was going to be released. Police thought it would be several years before Carter could be brought back to the US. However, just four months later Jacksonville authorities learned that Carter had been released from jail after paying a fine. Carter's brother traveled to Mexico and gave Carter a motorcycle. Carter drove off on the bike and hasn't been seen since. Carter may still be riding the motorcycle, a blue and silver 1983 Suzuki. He likes to hunt, enjoys country line dancing and shooting pool. He has worked as a grocery store clerk and may be working as a bartender. Carter is 49, 6'0" and 165 pounds. (See Show #716, OAD 4/26/03)

San Antonio, Texas...LEONARD RAY HARPER...Police say Leonard Ray Harper is wanted for murdering his friend Jerry Permenter in March 1998. Police say the killing came as a result of an argument between Jerry, Jerry's girlfriend, and Harper's girlfriend. According to authorities, Harper fled town with his girlfriend before charges could be made. After his girlfriend began to fear for her life, she left a note with a manager in a restaurant who notified the police. The police pulled their car over shortly afterward, arresting Harper. Harper was officially charged with murder, but bonded out of jail and took off.

Las Vegas, Nevada...HEATHER TALLCHIEF...The FBI in Nevada and Las Vegas police are looking for Heather Tallchief, a 28-year-old armored car driver, and her male roommate who disappeared on October 1, 1993, along with a Loomis Armored Inc. van filled with \$3.15 million dollars.

Boynton Beach, Florida...NATIA JOHNSON CAPTURE...The final fugitive wanted in connection with the shooting of a Florida woman who won a Bingo jackpot -- only to be the target of a gang of thieves -- has been caught thanks to a tip from a viewer of AMERICA'S MOST WANTED: AMERICA FIGHTS BACK. According to police, Natia Johnson went to Prime Time Bingo Hall in West Palm Beach, Florida on August 4, 2003 with a plan to rob someone of their winnings. That night, Pamela Anderson hit the jackpot of \$5,900 and was paid in cash. Unbeknownst to her, Johnson was a few tables away – watching. Police say Johnson, along with three accomplices, followed Pamela home and shot her in the abdomen when she refused to give over the cash. Pamela was able to drive away and was soon after rescued by paramedics. Johnson escaped, but is now in custody.

New York, New York...DEAN DESIMONE KILLERS... New York City detectives are searching for the men they say burst into an auto body shop and shot and killed local Bronx businessman, Dean DeSimone on March 21, 2003.

Las Vegas, Nevada...JENNY LIANG...Police say that Jenny Liang, a Las Vegas blackjack dealer murdered her live-in boyfriend, Patrick Sheen. Laing vanished from Las Vegas after purchasing a plane ticket to Hong Kong.

Palmyra, Virginia...GREGORY ALLEN MOYER... In 1994, Gregory Allen Moyer was working as a teacher at a private boys' school in Fluvanna County, Virginia. Boys at the school began to come forward with allegations of sexual abuse involving him. Moyer was arrested and subsequentially convicted on fourteen felony charges of Taking Indecent Liberties with a child. Moyer was sentenced to twenty-eight years in prison with twenty-four years and six months suspended.

He appealed, but was unsuccessful. A court ordered Moyer to appear for sentencing on May 10, 2001, but he never showed.

Abilene, Texas...JENNIFER SERVO...According to Abilene police, Jennifer Servo, a 22-year-old TV reporter for the Abilene NBC station was found dead in her apartment building. Servo had been strangled and had suffered a head trauma. Jennifer was found fully clothed, but an autopsy turned up bruises on her body that indicate she had been sexually assaulted before she was killed.

The following are the featured fugitives and others being sought by federal, state or local authorities. The <u>Update</u> (if any) gives current status; previous references, or related information.

Antonio George James (Murder) - Authorities believe Antonio James is responsible for stabbing his ex-girlfriend to death as her three little boys lay sleeping next to her in bed. On February 15, 1996, police were called to Terri Thomas' home on a domestic disturbance call. Police arrived and escorted James off Terri's property. He was told by police to leave the area and not return. However, cops say, James didn't stay away for long. They claim, later that night, James crept into a window and stabbed Terri once in the chest, fatally killing her. Terri's three young sons were in the bed with her and slept all night with their deceased mother all night. James is a native of Jamaica who has relatives in the Bronx, NY and Springfield MA. James, who has used the aliases Paul Bogle, Anitio James and James Antoniohas been employed as a marble finisher, welder, and as a mail sorter for the USPS. James is 38, 5'9" and 175 pounds.

Unknown Kriewald Killer – On March 7, 2002 at approximately 3:30am a masked man hiding inside the Sidelines Sports Grille in the outskirts of Atlanta, Georgia pulled a gun on the 34-year-old owner of the bar, Barbara Kriewald, and Terry Kirby Jr., a manager-in-training. The gunman forced Terry into the office. Barbara, who was seven months pregnant at the time, was zapped with a stun gun then forced into the office to open the safe. Then the attacker ordered Barbara to tie Terry's legs and hands behind his back. Barbara opened the safe and gave the gunman the money. The attacker told Barbara to tie her own legs and lie face down on the floor next to Terry. He zapped Barbara again with the stun gun and then shot both Barbara and Terry in the back. The gunman left twelve minutes later. Barbara and Terry called 911. Police arrived moments later. Barbara and her unborn child died on the way to the hospital. Terry survived but is paralyzed from the waist down. The suspect is in his 20's to early 30's, 6'0"-6'2" and 145-165 pounds. (See Shows #669, #672 and 712, OADs 3/23/02, 4/13/02 and 3/29/03)

Phillip Lloyd Ferguson (Securities Fraud) - FBI agents say Phil Ferguson is wanted for securities fraud. Agents say Ferguson stole \$20-25 million dollars from about 500 clients who invested with his firms. He had operated four businesses in Marion, Indiana for about 20 years.

Agents say during the late 1990's, Ferguson began to steal money from his clients who had invested in one of his commodity pools. Authorities say he stole mostly from teachers, factory workers, and farmers. In June of 2000, the Commodities Futures Trading Commission began to investigate Ferguson and he took off. Agents say Ferguson relocated to Golden, Colorado, where he used the aliases William Allen Russell, Al Russell, Richard Gadius and Roy Vernon Cox. Before authorities caught up with him, they say he fled in November of 2000, leaving his car, furniture and personal belongings behind. Authorities say that only \$1 million of the money Ferguson stole has been recovered. Ferguson likes to gamble, especially in riverboat casinos. He is a heavy drinker who smokes Marlboro Lights and likes to hang out in strip clubs. Ferguson has a four inch scar on his neck and a scar on his upper left arm and may be wearing a full beard. Ferguson is 53, 5'11" and 185 pounds.

Mustapha Mohamed Atat (Murder, Drug Charges) – Atat was driving in a street race that resulted in a fatal accident. He has been charged with second degree murder. On October 8, 2001, Atat and Aaron Reynolds, 34, were street racing at speeds of more than 100 mph in a 35 mph zone. The two were both driving modified Mustangs and had bet \$12,000 on the race's outcome. Reynolds' car went out of control, crossed a sidewalk and struck three people. The accident killed Denise Jones, 35, and injured Eric Draw, 35, and Rodney Ricks, 32. Atat and Reynolds were charged with second degree murder, failure to stop at the scene of a serious personal injury accident, and two counts of felonious driving and drag racing. During a raid at Atat's residence, police were surprised to find that although Atat received welfare, he owned a large home and several luxury cars. Police attribute this discrepancy to drug dealing after finding several illegal substances on the premises. Atat has failed to appear in court and may have fled the country. Atat has a large scar on his right cheek under his eye and speaks with a Middle Eastern accent. He is 31, 5'7" and 150 pounds. (See Show #713, OAD 4/05/03)

Herman Arthur Carroll, Sr. (Criminal Assault on a Child, Criminal Sexual Assault) - Illinois law enforcement agencies are seeking Herman Arthur Carroll, Sr. They say he sexually abused his daughter. Carroll is a twice-convicted child sexual offender. The most recent charges stem from abuse allegations in the summer of 2000. Carroll was arrested on July 3, 2000. He posted bond shortly after his arrest and failed to appear for his jury trial. Carroll told people that he believes he will spend the rest of his life in jail if he is convicted. He is looking at an extended sentence (possible 90-year sentence) if convicted because it would be his third conviction. Carroll has a scar on his right finger and left wrist and has tattoos on both of his shoulders. He is a skilled trim finisher and specializes in new construction. Carroll is 52, 5'7" and 200 pounds.

Police in Leesburg, Virginia are looking for 17-year-old Christa Rogaliner who was last seen on December 12, 2003 when she skipped school and drove her parent's car to Dulles Town Center mall. Cops say Christa apparently damaged the family's 1993 green Ford Escort station wagon and asked workers at the mall for directions to an auto parts store. The car was found was found abandoned the next morning in a Reston, Virginia neighborhood with the keys in the ignition and a present for Christa's older sister. The family originally believed that Christa was afraid to come home because she damaged the car. She was last seen talking on a cell phone standing near the car in Reston. She was wearing a yellow and navy Tommy Hilfiger jacket and jeans. The Carol Sund/Carrington Memorial Reward Foundation is offering a \$5,000 reward for any information on Christa Rogaliner.

CAPTURED:

Scott James Eizember (Murder) - Scott James Eizember is wanted by the Creek County Sheriff's Office in Depew, Oklahoma for the murder of an elderly couple, A.J. and Patsy Cantrell, the brutal beating of 70-year-old Carla Wright and the attempted murder of a 16-yearold boy. Eizember was on a mission to kill his ex-girlfriend, Kathy Biggs, and her entire family. On Saturday, October 18, 2003, Eizember entered the home of the elderly victims which happened to be located across the street from Kathy's parents' house. Eizember killed the Cantrell's and then used their home for surveillance. Eizember then sat and waited for her to come home, but Kathy was at work. During the afternoon, Kathy's 16-year-old son, Tyler, returned home where his grandmother was cooking dinner. Eizember stealthily followed him and shot the 16-year-old in the back as he tried to enter the house. Carla Wright, his grandmother, heard the commotion and came out from the back room. When she screamed, Eizember brutally beat her. Meanwhile, Tyler managed to get up and took off in his pickup truck to get help. When Eizember realized the boy had left, he ran after him and then jumped into the back of the pickup and began shooting at Tyler again. Tyler eventually crashed the truck into a pole so that Eizember would be thrown from the back of the truck. A neighbor saw Eizember walking down the street and naively offered Eizember a ride to the hospital, but Eizember had different plans. He attempted to shoot the man and steal his car, but failed when the man grabbed the barrel of the gun and caused the shell to fire outside the car door. The man took off as Eizember reloaded the gun and started shooting at the car. Police believe Eizember hid in the woods of Depew, Okalahoma, and when he finally emerged he fled to Waldron, Arkansas where he carjacked a couple in who bravely fought back and wounded the fugitive before police apprehended him. Currently, Eizember is being treated for his gunshot wounds and is under armed guard at a Lufkin, Texas hospital. After he is healthy, Eizember will be transported out of the hospital to a local jail and will eventually face extradition back to Oklahoma. (See Show #740, OAD 11/08/03)

Independence Shootout Suspects (Attempted Robbery, Attempted Murder) -William Blair and three others were wanted in connection with nearly twenty robberies in and around Kansas City, Missouri since December 3, 2003. Those robberies included the wild shootout at Kern's liquors in Independence, Missouri, where the store clerk fought back with his own weapon. The gunman in that robbery and the clerk exchanged gunfire, and the clerk was seriously wounded. William Blair and his robbery crew were arrested after a brief car and foot

chase with Kansas City Police officers. William Blair along with three other suspects is awaiting charges to be filed against them for nearly twenty robberies. (See Show #749, OAD 1/17/04)

The following are the featured fugitives and others being sought by federal, state or local authorities. The <u>Update</u> (if any) gives current status, previous references, or related information.

Saul Aguilar, Jr. (Murder) - On December 12, 1997, Saul Aguilar walked up to Ivette Ruiz's home with a sawed off shotgun and tried to get in the front door. He pounded on the door and yelled, but 19-year-old Ivette and others in the house wouldn't let him in. Aguilar went to an unscreened window and saw his estranged girlfriend Ivette with her three-year-old daughter near the Christmas tree. Aguilar reportedly stuck his upper torso through the window, and shot Ruiz in the back as she tried to run away from him. Ruiz died from her injuries, the child was unharmed. Aguilar uses the aliases Sal Fernando Avila, Marcello Aguilar Garcia and has several tattoos including "Sureno" on his back, "Saul" on his chest, "Aguilar" on his stomach, an "Aztec warrior" and a man and a woman on his back. Aguilar is associated with the Huntington Park Locos gang and the Part Boyz gand and has family in Southern California area. Aguilar is 33, 5'8" and 175 pounds.

Shawn Windsor (Murder) - On December 28, 2003, Shawn Windsor beat and stabbed his estranged wife, Betty Jean Windsor, and their eight-year-old son, Corey, to death in his home. The Louisville Metropolitan Police Department discovered Corey and Betty's bodies after family members requested a wellness check at Shawn's location. Inside, they found both bodies and an alleged detailed written confession, signed by Windsor. Police believe that Windsor was upset about Betty filing for divorce. In the summer of 2003, Windsor was found guilty of domestic-violence assault. Windsor hit Betty in the face while they were in a car and their son was in the back seat. The July incident led a judge to order Windsor to stay at least 500 feet from his family. Less than four months later, Betty Jean Windsor filed for divorce. Shawn Windsor had refused to accept a December 15th summons mailed to his apartment, leaving the divorce in limbo. Windsor was last seen driving Betty's 1992 maroon Chevy Corisca which have Kentucky plates. Windsor, who is considered armed and dangerous, is described as short-tempered and arrogant. He has bad teeth, a scar or his lower left leg and an "S&A" tattoo on his right arm. He loves NASCAR and University of Kentucky sports and often wears U of K hats, jerseys, and jackets.

Windsor likes to doodle and may be supporting himself with odd jobs including building internet websites. Windsor is 40, 6'2" and 220 pounds.

Unknown Daniel Price Killer (Murder)- San Francisco Police are seeking an unknown suspect for the murder of Daniel Price, 28, an artist who lived in the upscale Cow Hollow neighborhood of San Francisco. On December 18, 2003, a man confronted Daniel's wife, Sarah, in front of their apartment building. He threatened her with a gun. Daniel, who was just pulling away in a cab, made the cab stop, got out and confronted the gunman. The man turned and shot Daniel in the head, killing him. The suspect escaped on foot. Police believe that robbery was not a motive because the suspect had not tried to steal Sarah's purse or attempt to rob Price. Police believe that the suspect may have tried to carjack a limousine on a nearby street a few moments later. The suspect is described as a 5'6" to 5'8" black male in his twenties or thirties, with a thin build. Witnesses describe his hair as a brushed afro about four inches long on top and sticking out about two inches on the sides a la "Don King." He was wearing a blue waist length jacket and dark pants.

Carlie Brucia Killer (Seeking information) - Police are looking for information about the man charged with the kidnapping and murder of 11-year-old Carlie Brucia in Sarasota, Florida on February 2, 2004. Carlie went missing on Superbowl Sunday as she was walking home from a friend's house at approximately 6:20 pm. Police discovered a videotape the next day that showed Carlie being abducted by a man behind a car wash. Police also found video tape showing a Buick station wagon driving up to the car wash. A tip led police to arrest Joseph Smith, who had access to that car. On Friday, February 6, 2004, police discovered Carlie's body near a church just a few miles from the car wash. Police have now charged Smith with Carlie's murder. Police are hoping to develop information about Smith, his background, and his whereabouts between Sunday, February 2 and Tuesday, February 4, 2004. They are also asking for information from anyone who has seen the Buick Century during that time. On the day of the kidnapping, Carlie was wearing a red shirt with blue jeans and may have been carrying a pink backpack.

Dino Loren Smith (Robbery, Kidnapping, Burglary)

Troy Devin Smith (Robbery, Kidnapping, Burglary) – The Smith brothers are wanted fro the 2003 burglary of a San Francisco Jewelry store. The Smith brothers, along with George Turner and an unknown accomplice, broke through a wall separating two businesses and later restrained the employees of Lang's Antique Store when they arrived to open up the store for business. They made off with more than \$10 million in property. Turner was arrested in June 2003, but the two brothers remain fugitives. Dino usually shaves his head and often wears a goatee. He loves beautiful blonds and dines at upscale restaurants and bars. Troy is a former professional football player who usually follows Dino's lead. Dino is 45, 6'3" and 180 pounds. Troy is 40 6'3" and 200 pounds. (See Show #741, OAD 11/15/03)

Unknown Lauderdale Lakes Jewelry Thieves (Burglary, Grand Theft)- Police in Lauderdale Lakes, Florida are looking for jewelry thieves who stole more than \$300,000 of distinctive middle-eastern jewelry. Police say at least three individuals used a ladder to climb onto the roof of the Middle Eastern Fashion Center strip mall on the evening of January 6, 2004. The thieves used a chisel and hammer to cut a hole in the concrete roof of Ali Baba Kabobs &

Grill and then slid through a ceiling tile into the restaurant. Their real target was the Babylon Jewelry Store right next door. The thieves knocked a hole through the restaurant wall into Babylon Jewelry. The point of entry was exactly at the side of a huge steel and concrete safe. The thieves cut a hole into the safe and stole hundreds of thousands of dollars of middle-eastern jewelry. Authorities believe that Dino and Troy Smith may have been involved in the jewelry heist.

William Ray Plemons (Murder, Kidnapping, Parole Violation) - William Plemons is wanted by Phoenix, AZ authorities for the murder of his second wife, Ermalinda Macatangay. While Plemons was in prison for robbery, assault and escape, he developed pen pal relationships with at least two women. He married one while still in prison and was granted parole in April 2003. After his release, he left his first wife and took up with Ermalinda. He allegedly stole from her bank accounts and ran up her credit cards. On June 24th, Plemons is accused of killing Ermalinda in a fit of rage. Police fear that he may have another female pen pal whose money he is using to survive and run from the law. If not, police believe he may be committing armed robberies. The family is offering a \$5000 reward for Plemons' capture. Plemons has used the aliases John Coleman, David Howell, Ray Plemon, William Keller, William Taylor and "Bubba." He reportedly uses low dosages of methamphetamine to stay awake due to his fear of being alone. He is also known to pay people to drive him around. Plemons has been known to wear Kmart type blue jeans and a pressed collar button down type shirt and to frequently solicit prostitutes. Plemons is 57, 5'8" and approximately 190 pounds.

Miguel Gonzalez (Sexual Crimes Against Minors) - Miguel Gonzalez is wanted for sexually assaulting three underage girls. In 1992, Gonzales plead guilty to indecent assault on two 12-year-old girls. He spent seven years on probation. He was accused of more assaults in 2002. In August 2002, Gonzalez fled with his wife and two step children, but his wife has since surrendered to authorities. Gonzalez was convicted in absentia of rape, aggravated indecent assault, sexual assault and corruption of minors and sentenced in October 2002 to between 21 and 42 years in prison. Authorities believe that Gonzalez spent time in the Dominican Republic but may be hiding in North Carolina or Texas. Gonzalez uses the aliases Antonio Ortiz and Michael Gonzalez. Gonzales is 40, 5'8" and 148 pounds.

The following are the featured fugitives and others being sought by federal, state or local authorities. The <u>Update</u> (if any) gives current status, previous references, or related information.

Argelio "Angel" Aguayo, Jr. (Possession with Intent to Distribute)
Gianni Gugliatto (Possession with Intent to Distribute)

Unknown Accomplice (Possession with intent to Distribute) - Miami's Immigration and Customs Enforcement (ICE) agents are looking for Argelio "Angel" Aguayo and his girlfriend, Gianni Gugliatto, and an unknown accomplice on cocaine distribution charges. They have been on the run since August 2003. ICE agents started investigating Aguayo and Gugliatto after a high-speed boat chase in February 2003 led to the seizure of more than 900 pounds of cocaine, roughly an \$8.2 million street value. The alleged smugglers fingered Aguayo and Gugliatto as "middlemen" in the Miami drug trade In August of 2003, ICE agents, Miami Dade Police and Hialeah Police attempted to set up Aguayo on an undercover drug deal. But when Aguayo got suspicious, the bust was blown and Aguayo fled. A chase ensued, but Aguayo got away. Aguayo and Gugliatto have not been seen since and are believed to be traveling together. Agents would like to identify an unknown accomplice who was in the back seat of the Cadillac during the car chase. Aguayo and Gugliatto speak fluid Spanish and spend most of their free time working out, eating sushi and drinking Corona beer with lime at night clubs and bars. The Cuban born Aguayo has family in the Miami area and may be working in the boating industry. He likes to flash his money and usually wears name-brand clothing and may be wearing a men's GMT Master Rolex watch. Although he may have shaved, he likes to wear a goatee. Aguayo is 31, 5'7" and 180-190 pounds. Gugliatto, a former University of Miami student, is known to use homeopathic medicine. She has a tattoo of a triangular design on her lower back and a deep dimple on her lower left cheek. She also has several ear piercings, a mole on her upper right cheek and may be wearing colored contacts. Gugliatto is 23, 5'6" and 105 pounds. Aguayo and Gugliatto's unknown accomplice is described as a thin male in his 20's who has short black hair and a mustache.

Unknown Monica Rivera Valdizan Killer (Murder) - On January 5, 2004, the body of 26-year-old Monica Rivera Valdizan was found abandoned in some bushes in a private community of Boca Raton, Florida. Police say Valdizan was abducted three days earlier, on January 2, 2004, and apparently taken somewhere where she was badly beaten and ultimately murdered Police fear that Valdizan may have been murdered by a serial killer. They believe she was probably snatched by someone who had been watching her and knew about her routine nightly walk. The last person to have had contact with Valdizan was her boyfriend back in Peru. She placed a call to him on her cell phone at approximately 8:30 p.m. while outside of a Publix supermarket. Cops suspect that she was abducted shortly before 9:00 p.m. on her way home.

Gerald Lyle Hemp (Escape) - Gerald Hemp is one of the U.S. Marshals 15 Most Wanted. He escaped in 1984 from a West Palm Beach prison where he was serving 40 years for masterminding an operation to smuggle drugs from Columbia to the U.S. On July 10, 1984, Hemp was released from the Lantana Correctional Institute on a two-hour furlough to visit the dentist. He never returned. Hemp had mistakenly been assigned to the minimum security prison on a transfer from Tennessee. In 1981, authorities raided Hemp's Tennessee mountain chalet and seized \$200 million worth of cocaine in what was the largest drug haul in U.S. history. Later that year in Florida, agents recovered an additional 369 pounds of cocaine. Hemp was arrested in 1982 and later convicted of possession with intent to deliver and sell cocaine. Investigators want to question Hemp about the deaths of his alleged pilot and smuggling partner, Charles Leslie Kaeglar, and the death of Dr. Robert Rixse. Hemp uses the aliases Jerry Whittier, James Comstock and George Baker. He may or may not be wearing a beard and may have died his hair. He like to dine in expensive restaurants and talks about his CIA connections. Hemp is 65, 5'8" and 220 pounds. (See Shows #106, #144 and #307, OADs 3/18/90, 12/21/90 and 3/12/94)

Herbert Rodriquez (Murder) - Herbert Rodriquez is wanted for the August 26, 1999 murder of 40-year-old Alvin Locke in Los Angeles, California. In the summer of 1999, Rodriquez moved into a house owned by a female acquaintance who was involved in a relationship with the victim, Alvin Locke (from Belize). Rodriquez, who was known to have a short and mean temper, grew jealous of Locke's relationship with the woman. Cops say the 200-pound Rodriquez was probably high on August 26, 1999 when he went after the small-framed Locke. After torturing Locke with a knife, Rodriguez stabbed Locke seven times and then shot him in the head. Rodriquez originally fled to El Salvador but cops say he's now back in the United States, probably in Texas or Southern California. Rodriquez is an experienced professional soccer referee who is known to have sold and used cocaine. He is known to carry a sawed-off shot gun and is considered to be dangerous. Rodriquez is 45, 5'8" – 5'10" and 200 pounds.

John Doe #1 (Sexually Exploiting a Minor for the Purpose of Producing Child Pornography)

John Doe #2 (Sexually Exploiting a Minor for the Purpose of Producing Child Pornography) –

Agents from the FBI Innocent Images Unit, a group of undercover agents who arrest pedophiles who commit crimes on the Internet, say images of John Doe #1 having sex with a child have been repeatedly shown and traded on the Internet. Sometimes it is "traded" as a movie clip, sometimes as a still photo. Agents have determined that John Doe #1 is an American, and that the movie of him having sex with a child was made recently, sometime in the last five years. For the first time, law enforcement has been able to charge an unnamed person for crimes against

children. There is a warrant for the arrest of John Doe #1, despite the fact that agents don't know his true identity. Federal agents are hoping that someone who sees his picture on America's Most Wanted will be able to identify him and put a name to the face. And in doing so, protect children from further harm. Authorities are also looking for a second suspect, John Doe #2. John Doe #1 is described as a white male with brown eyes and light brown hair. John Doe #2 is described as a white male with brown hair.

Williams Earl Phillips (Murder) – Authorities in Oklahoma have charged William Earl Phillips with the 2003 murder of his girlfriend, Dashia Alexander. On June 1, 2003, Alexander told her family she was planning on leaving Phillips because he was very jealous and possessive. The next day, Phillips paid Alexander a visit. Neighbors reported hearing an argument followed by gunshots and witnessed Phillips leave Alexander's townhouse. Neighbors called police, but when cops arrived they found Alexander shot to death. Soon after the murder, Phillips and a friend (who was unaware of the murder) drove from Oklahoma City to Akron, Ohio. That is where the trail for Phillips has gone cold. Phillips has used the aliases Jamon Justin White, C-Nut, and William Dean Phillips. He has unknown tattoos on his right arm, right shoulder, right forearm, left shoulder, chest, abdomen, right leg, left arm and back. Police say that he is a large-scale drug dealer with contacts nationwide and is known to associate himself with those in the hip-hop industry. Phillips is 26, 6'0" and 200 pounds.

Yazoo County (MS) Sheriff's deputies are looking for the Hargon family. Michael, 27, his wife, 29-year-old Rebecca and their four-year-old son, James were last seen on Friday, February 13, 2004. On Saturday, February 14, 2004, police checked out a report that something was wrong at

the Hargon home. There was no sign of the family but the officers found several ominous clues including bullet holes and a trial of blood. Nothing seemed to be missing from the home including their cars and James' asthma medication. Michael works in construction. He has a scar over his left eye and on his right hand. Rebecca works as a physical therapist's assistant. She has a mole on her left neck and breast and has a scar on her forehead and burns scars on top of both feet. James has a scar above his left eye and a mole on his head. He has an asthma condition and needs to have breathing treatments twice a day.

CAPTURED:

Anthony Craig Lee (Murder) – On September 18, 2003 at approximately 5:30pm, Lee approached 48-year-old Jose Calvo who was in his car, backing out of his driveway. Calvo's wife Denise and one-year-old son were also in the car. Lee pointed a gun at Calvo and demanded the keys to the Mercedes. That's when Denise reached for a gun that was kept under the passenger seat. When she sat back up, Lee had shot Calvo in the head. Denise began shooting at Lee and chased him as he escaped to his car. She kept shooting at him as he sped away, blowing out the back window and possibly hitting Lee. Lee sped down Coconut Grove Street in Miami to the Kingsway Apartments where he ditched the car he was driving, a Honda Civic, and jumped into a dark blue Ford Taurus or Mercury Cougar that was waiting for him. Calvo died of the gunshot wound to his head. Besides the couple's one-year-old son, he leaves behind a seven-year-old daughter from a previous marriage. Anthony Craig Lee ultimately captured without incident in Eutawville, South Carolina as a result of the diligence of a Lieutenant with the Orangeburg County Sheriff's Office. Unknown Indiana Shootout Bank Robber (Wanted for Questioning) - Police in Anderson, IN and Muncie, IN are looking for the person or persons responsible for the robbery of two banks: the Madison County Federal Credit Union on August 1, 2003 and the Mutual Federal Bank on January 12, 2004. Police say at around 2:30 p.m., on August 1, 2003, a light skinned black male in dark pants, a black baggy shirt, baseball gloves and a black ski mask entered the Madison County Federal Credit Union. The robber was carrying a semi-automatic revolver. There were two tellers and one patron in the bank at the time. The patron was the Assistant Chief of Police, Ray Novak, who was dressed in plain clothing. The robber yelled. "You know what this is!" When the tellers and Novak did not respond, he yelled "you know what this is" again, and then instructed everyone to get down on the ground. When everyone finally got down on the ground, the robber jumped over the second teller station. Novak grabbed his own gun and a shootout ensued between officer and bank robber. Novak went out to his car to call for help, and the robber jumped over the teller station to follow him. The robber fired one more shot at Novak and then ran across the street to an abandon shopping center, then into the woods. The robber has not been seen since. Police had no leads on the Anderson bank robbery until January 12, 2004. Police in Muncie, IN say at around 2:15 pm that day, a light skinned black man dressed in a similar outfit, entered the bank and, just like the Anderson robbery. yelled, "You know what this is!" He then fired one round from his semi automatic chrome handgun. He then ordered everyone to get down on the ground. He then proceeded to empty the bank tellers' drawers and flee. Police believe he may have a getaway car in the neighborhood. The robber has not been seen since. Police believe the man who robbed the Anderson, IN bank is the same man who robbed the Muncie, IN bank. They are, however, investigating the two incidents separately, and are not willing to jump to any conclusions. Unknown Indiana Shootout Bank Robber is 24-29, 6'0"-6'3" and 220-275 pounds.

Indiana Shootout Bank Robber Accomplice (Wanted for Questioning) - Police in Anderson, IN are looking for the unknown bank robber who robbed the Madison Community Bank on August 1, 2003. At 1:20 p.m., a white male in his late 20's to early 30's, wearing dark colored sunglasses, a black shirt, dark jeans, a baseball hat, and rubber tip over his fingers that looked like hospital gloves on his left hand, entered the Madison Community Bank. He came and left twice, asking to see a loan officer but never doing so. The third time the man entered the bank, he did so with a dark colored semi-automatic handgun and a small black bag. He proceeded to walked up to a teller, pointed his handgun at her, and said, "Give me all your money! Give me all your money or I will kill you!" The teller put all of the money into the black bag and handed the bag back to the robber. Police say the robber grabbed the bag and left the bank. As he left the robber told her, "If you tell anyone, I'll come back later and I'll kill you. Police say the robber fled from the bank. He ran toward the back of the bank where police believe a woman was sitting in a turquoise Ford Aerostar mini van, in the Kia dealership parking lot. An employee at the Kia dealership saw the woman sitting there for quite some time. Police say the white male jumped into the van with the woman and fled. The robber has not been seen since. Police believe that this bank robber may be connected to the Indiana Shootout Robber. The Indiana Shootout Bank Robber Accomplice is 25-35, 6'0" and 140-170 pounds.

John Doe #1 (Sexually Exploiting a Minor for the Purpose of Producing Child Pornography)-Agents from the FBI Innocent Images Unit, a group of undercover agents who arrest pedophiles who commit crimes on the Internet, say images of John Doe #1 having sex with a child have been repeatedly shown and traded on the Internet. Sometimes it is "traded" as a movie clip, sometimes as a still photo. Agents have determined that John Doe #1 is an American, and that the movie of him having sex with a child was made recently, sometime in the last five years. For the first time, law enforcement has been able to charge an unnamed person for crimes against children. There is a warrant for the arrest of John Doe #1, despite the fact that agents don't know his true identity. Federal agents are hoping that someone who sees his picture on America's Most Wanted will be able to identify him and put a name to the face. And in doing so, protect children from further harm. Authorities have already arrested another suspect that was profiled with John Doe #1. A tipster identified him as Scott Hayden. It turns out, Hayden is already convicted for molestation and producing those disgusting images. He is currently serving a 50-year sentence in an Indiana prison. John Doe #1 is described as a white male with brown eyes and light brown hair. (See Shows #753 and #754, OADs 2/21/04 and 2/28/04)

Elizabeth Anna Duke (Conspiracy, Unlawful Possession of Firearms and Destructive Devices) - Agents with the FBI and deputies with the U.S. Marshal Service are looking for Elizabeth Duke, charging her with the above-mentioned crimes, stemming from her countergovernment activism of the 70's and 80's. In 1985, agents searched a shed in the backyard of the house where Duke had been living. In the shed, agents found firearms, ammunition, explosives, detonating cords, fake identification and numerous communications involving bombings and other criminal activity. Duke was arrested and released. Soon after, she fled and has not been seen since. Agents have since tied her to the 1983 bombings of the U.S. Capitol, the National War College and the DC Naval Yard. No one was injured in these explosions. Duke uses the aliases Linda Gail Bourgea, Louise Marcella Cox, Betty Duke, Mary Alice Hamilton, Lorraine Jackson, Mary Ann Joanson, Bess J. Lunderman, Elizabeth Anna Weir, Judith Chomsky and

"Danielle." Duke is described as a very intelligent woman who has pin-sized hole son the front of each ear resulting from a genetic condition. She is known to wear glasses and wigs as disguises. She speaks fluent Spanish and may be working as a real estate agent. She may be in the company of Donna Joan Bump. Duke is 63, 5'6" and 140 pounds.

Thomas Earl Johnson (Murder) -Carlsbad Police are on the hunt for Thomas Johnson for the alleged murder of his father and the stabbings of his mother and five-year-old nephew. On Monday, February 16, 2004, at 1:48 p.m., the Carlsbad Police Department received a call from a medical office. They were worried about the welfare of one of their patients. The caller said that the office staff had called the home of Robert Johnson with test result information. The phone was answered by a small child who asked for help and said that he had been hurt. Officers were dispatched to the home. When they arrived, they discovered a five-year-old boy with head and neck wounds. Officers also found 80-year-old Rita Johnson unconscious and Robert Johnson dead, all from stab wounds. The injured little boy and his wounded great-grandmother were taken to the hospital. Information from the victims and area residents helped officers identify Thomas Earl Johnson as the suspect in the attacks. Johnson is the son of Robert and Rita, and the grand uncle of the five-year-old boy. Carlsbad Police believe Johnson may be headed to Modesto, California or the Boulder, Colorado area. Johnson enjoys local coffee shops, libraries, and the outdoors. He known to camp and hike in remote areas by himself. He has been known to frequent parks and inexpensive motels along the California coast including Monterey and Pismo Beach. Johnson is believed to be driving a 1997 silver Honda Civic CA, CA license 3TPV37. Johnson is 55, 6'1" and 168 pounds.

Ismael Zambada-Garcia (Drug Trafficking & Organized Crime) - The Drug Enforcement Agency and FBI are hunting for the man they call their "#1 Most Wanted drug lord," Ismael Zambada-Garcia. He is wanted for the importation of tens of thousands of pounds of cocaine, meth and marijuana. He is also accused of having links to other drug dealers who have been involved in several acts of violence, including the torture and killing of a DEA agent. Zambada, 55, is allegedly the leader of a drug organization based in the Pacific Coast town of Mazatlan. Zambada is also suspected of increasing his power by facilitating the murder of his chief rival, Ramon Arellano-Felix. Police believe Zambada lured him to his home turf and paid the local police to kill him. When Benjamin Arellano-Felix was arrested, police say Zambada took over the remnants of the brothers' operation, becoming the largest and most dangerous drug lord in Mexico. According to authorities, Zambada's organization receives tons of cocaine from Columbia through maritime shipping to the Mexican states of Sinaloa and Nayarit. The drugs are then smuggled with a variety of methods into the United States, and members of the organization then transport the drugs around the country to locations such as Los Angeles, Chicago and New York. The DEA and FBI worked together in a 19-month-long sting called Operation Trifecta, which focused on Zambada's drug organizations and the trafficking. The operation spanned several states and resulted in the arrest of over 240 suspected smugglers related to Zambada's organization. The operation seized nearly six tons of cocaine, 100 pounds of methamphetamine, 25 thousand pounds of marijuana and \$8.4 million in cash from alleged smugglers. Zambada's organization is also suspected in a variety of other crimes, including the death of Tijuana's police chief, Alfredo de la Torre Maraquez, in 2000. According to authorities, Zambada's organization receives tons of cocaine from Columbia through maritime shipping to the Mexican states of Sinaloa and Nayarit. The drugs are then smuggled with a variety of methods into the United States and the members of the organization then transport the drugs to

Los Angeles, Chicago and New York. Zambada uses the aliases "El Mayo", El Ingeniero Quinto, Jesus Loaiza Avendano, Javier Garcia Hernandez, and Ishmael Higuera-Renteria. Zambada is 55, 5'9" and 160 pounds.

Todd Coleman (Wanted for Questioning, Parole Violation) - Police in New York City are searching for Todd Coleman for the murder of an off-duty prison guard. Gregory Goff, a corrections officer at the Riker's Island Detention Center, was attending an early Valentine's party at a Masonic lodge in Jamaica Queens on Saturday, February 7, 2004. Police estimate that there may have been as many as two hundred partygoers in attendance that night. Police say that around 2:00 a.m., two groups of men, not known to Coleman, began shooting at each other following an argument over a woman. One of the shooters, Derrick Coleman, dropped his weapon when he was struck in the leg. Police say his brother, Todd, then picked up the weapon and continued firing. Goff was struck once in the chest and died a few hours later. Police say Goff did have his service weapon on him but he did not reveal his weapon during the gunfight. Derrick was arrested after his release from the hospital. Todd has not been seen since the night of the shooting. Police say both brothers have extensive arrest records. Coleman uses the alias "Boog" and has a scar on his right cheek, right ear and under his left eye. Coleman is 24, 5'11" and 175 pounds.

Unknown Monica Rivera Valdizan Witness (Person of Interest) - Police are searching for a person seen on videotape exiting a Florida supermarket moments after Monica Rivera Valdizan on January 2, 2004. The night of January 2, 2004, Valdizan went to the Publix grocery store. She bought a few items, then sat on a bench near the supermarket for an hour talking to her boyfriend in Peru. She reentered the store and left again a few moments later, shortly before 9 p.m. Surveillance cameras photographed Valdizan leaving the store. They also photographed a second figure leaving just behind her. Cops would like to talk with this person, hoping that he/she (police cannot determine the gender of the individual) might have information relevant to the case. Police stress that they have no reason to believe that this person had anything to do with Valdizen's death. In the above photos, authorities believe the person of interest was wearing blue jeans and a denim or light blue long sleeve shirt. The following are the featured fugitives and others being sought by federal, state or local authorities. The <u>Update</u> (if any) gives current status, previous references, or related information.

Argelio "Angel" Aguayo, Jr. (Possession with Intent to Distribute)

Unknown Aguayo & Gugliatto Accomplice (Possession with the Intent to Distribute) -Miami's Immigration and Customs Enforcement (ICE) agents are looking for Argelio "Angel" Aguayo and his girlfriend, Gianni Gugliatto, and an unknown accomplice on cocaine distribution charges. They have been on the run since August 2003. ICE agents started investigating Aguayo and Gugliatto after a high-speed boat chase in February 2003 led to the seizure of more than 900 pounds of cocaine, roughly an \$8.2 million street value. The alleged smugglers fingered Aguayo and Gugliatto as "middlemen" in the Miami drug trade In August of 2003, ICE agents, Miami Dade Police and Hialeah Police attempted to set up Aguayo on an undercover drug deal. But when Aguayo got suspicious, the bust was blown and Aguayo fled. A chase ensued, but Aguayo got away. Days after her profile, Gugliatto turned herself in. Aguayo and their accomplice have not been seen since. Aguayo speaks fluid Spanish and spends his free time working out, eating sushi and drinking Corona beer with lime at night clubs and bars. The Cuban born Aguayo has family in the Miami area and may be working in the boating industry. He likes to flash his money and usually wears name-brand clothing and may be wearing a men's GMT Master Rolex watch. Although he may have shaved, he likes to wear a goatee. Aguayo is 31, 5'7" and 180-190 pounds. Aguayo and Gugliatto's unknown accomplice is described as a thin Hispanic male in his 20's who has short black hair and a mustache. (See Show #753, OAD 2/21/04)

John Doe #3 (Child Molestation) - Federal agents are searching for an unknown man who they accuse of sexually exploiting a minor, and then distributing images of this abuse via the Internet. Agents from the FBI Innocent Images Unit, a group of undercover agents who arrest pedophiles who commit crimes on the Internet, say images of John Doe #3 having sex with two young boys have been repeatedly shown and traded on the Internet. Sometimes it is "traded" as a movie clip, sometimes as a still photo. Agents have determined that John Doe #3 is a Caucasian American, and that the movie of him having sex with a child was made recently, sometime in the last five years. For the first time, law enforcement has been able to charge an unnamed person

for crimes against children. There is a warrant for the arrest of John Doe #3, despite the fact that agents don't know his true identity. Agents are hoping to determine an identity for John Doe #3, and subsequently arrest him.

Midtown Jane Doe (Unknown Victim) -Police in New York City need the public's help to determine the identity of a Jane Doe. Police say that on February 10, 2003, construction workers removing debris from the basement of a building in Times Square cracked through a cement slab and found a human skull. Police investigated and determined this was a 'bone case' so they called in the medical examiner's office. Once the full remains of a skeleton were recovered, the medical examiner determined that the deceased was a white female, 18-20 years old and 5'1." It was also determined that the woman was killed in the mid-to-late 1980's. Police believe that the young woman may have been a prostitute because her remains were found in a building that was known as a favorite haunt for drug dealers and prostitutes. In fact, the building is just a few blocks from the Port Authority Bus Terminal, which had a reputation for attracting runaways and vagabonds from all over the United States. Police found a gold-plated signet ring near the woman's remains with the initials "PG Mc," which could possibly be the initials "P McG." They also found a woman's gold colored Bulova watch and a green plastic toy soldier.

Terrence Kasses Washington (Armed Bank Robbery, Auto Theft, Burglary, Assault) Dan Robertson, Jr. (Escape) – Washington and Robertson are wanted for a Louisiana jail escape and for assaulting a police trooper while on the lam. In March 2003 Washington was sent to the Tangiopahoa Parish Jail in Amite, Louisiana to await trial for bank robbery. Washington had previously escaped from a jail in Arkansas in 1998. At the Louisiana jail, he befriended fellow inmate Dan Robertson. On July 13, 2003 Washington and Robertson used a hacksaw blade to cut out a window in the jail. Once Washington and Robertson crawled out the window, they scaled several fences and escaped into a wooded area. The escapees then stole a truck from a nearby residence and fled the state. The stolen vehicle was recovered in New York a couple of weeks later but there were no signs of Washington or Robertson. On September 25, 2003, police spotted Washington and an unidentified suspect in a stolen SUV outside Baltimore. After a high speed chase in which Washington rammed a state trooper's car twice, Washington managed to escape through a heavily wooded area. Washington stole a van from a nearby residence and fled the area. The van was recovered less than two weeks later. Robertson may have been the unidentified suspect traveling with Washington during the high speed chase. Washington, whose numerous aliases and nicknames include Gordon Douglas Weaver, William "Dynamite" Brown, Rayford Damien, Cassidy Washington, Ryan Fociet, Travis Washington, T.T. Washington, "Cash" Washington, Damcan Walker, Brian Mays, "T Money", "TD", "T Dog", "TJ" and "Cassidy", has several tattoos including "Only God Can Judge Me" on his left chest, a person holding a gun on his right chest, the word "Cash" with a stack of money and dice on his abdomen, the words "Lil Cash" and "Don't get skull drunk" on other parts of his body, and other tattoos on both arms. He also has scars on his left finger, abdomen, right arm and left eye. Washington, who is described as a rap artist and may perform in clubs, has ties to the music industry. He is described as a big spender and may sell stolen items in pawn shops or street corners to make money. He has gold caps on some of his upper teeth. Washington is 27, 5'8" and 160 pounds. Robertson, whose aliases include Dan Robin, Dan Robbins and Damond Jones, has a teardrop tattoo under his left eye, and another tattoo on his right arm which may be his name. He is a smoker who may wear his hair in corn rows. Robertson is 45, 5'10" and 160 pounds. (See Sow #739, OAD 11/01/03)

Andre Neverson (Wanted for Questioning for Murder) - On Monday, July 8, 2002, NYPD cops arrived at the Brooklyn home of 39-year-old Patricia Neverson. She was found, shot to death. Three days later, on July 11, cops found the body of 34-year-old Donna Davis. Authorities have learned that Andre Neverson had an ongoing argument with his sister, Patricia, stemming from Andre's money which she used to buy her home. Neverson did not want the money repaid; instead, he wanted the house. Donna Davis had been dating Andre, but she had recently broken off the relationship. Neverson did not take the rejection well. The last time Donna was seen alive, she was in Andre's minivan outside a Queens, New York college where she studied. Days after the second murder, cops placed Neverson in Brooklyn, but after that, the trail runs cold. Neverson has used numerous aliases including Troy Michael Anderson, Troy Michael Henderson, Trey Michael Henderson, Andre Humphrey and Andre Henderson. He has a very muscular build and a shaved head, but he may be starting to grow hair again to change his appearance. He does not drink or smoke, is very intelligent and computer literate. At times he is very calm and serene, but he has a violent temper and has served time for attempted murder. He does not drink or smoke, and may be hidden now by one of his many girlfriends. He is originally from Trinidad, but does not have an accent. He has worked as a bouncer in Caribbean clubs and as a security guard at a hospital. He has been know to buy cars, fix them up, then resell them. He may still be armed. Neverson is 39, 6'0" and 225 pounds. (See Shows #684, #697, #723, and #743, OADs 7/27/02, 11/16/02, 6/14/03 and 12/06/03)

Ronnie Dontell Drane (Murder, Attempted Murder) - Ronnie Drane, wanted by the U.S. Marshals and the Lake County Indiana Sheriff's Office for the murder of two family members and the attempted murder of a third. On October 12, 2002, Drane went to visit his two cousins, Larry Peaches and Herman Buchanan, at their home in Gary, Indiana. The three men were watching television, when Drane got up to use the bathroom. Witness say when he came out, he was holding a gun and began shooting. Drane shot and killed Larry instantly. He then chased Herman to the back door and shot him once in the face. Despite being shot, Herman managed to escape and ran to a neighbor's house to call for help. Help arrived, but it was to late for Delores Buchanan, Drane's aunt, who was also in the house. Delores hid in her bedroom closet hoping Drane wouldn't shoot her. Drane found her and shot her approximately seven times through the closet door. Police found her scrunched in the corner of the closet with her hands over her face. When Herman was released from the hospital, he went to live with his brother in Kentucky. But on March 7, 2003, Herman was found shot to death on his porch. Police have not charged Drane with Herman's murder, but want to talk to him about it. Drane has used the alias Ronnie Patterson and has a tattoo of his daughter's name, Ronnika, on his left arm. He frequents strip clubs and likes to drink beer. He is a violent man who may be armed. Drane is 30, 6'1" and 175 pounds.

Vernon Coleman (Child Molestation) - Authorities in Wichita, Kansas are searching for Vernon "Spike" Coleman. They say that in 1995, over a two month period, he molested an eight-year-old girl in a strip club that he owned. Police say when Coleman heard that the girl had told of what had been going on, he took off. Coleman uses the aliases Spike, Elvis and Steve. He has a surgical scar on his abdomen and often wears a toupee. He has owned and/or been around strip clubs for much of his life and has worked as a cab driver or trucker. Coleman is 60, 6'0" and 180 pounds.

Daniel Andreas San Diego (Maliciously Damaging and Destroying By Means of Explosives) - Daniel Andreas San Diego is wanted by the FBI for two bombings in the San Francisco Bay Area of California. On August 28, 2003, San Diego placed two pipe bombs outside the Chiron Corporation in Emeryville, California. Both bombs exploded, causing damage to the lab, but no one was injured. Then, on September 26, 2003, San Diego placed another bomb outside the Shaklee Corporation in Pleasanton. The bomb went off around 3:22 a.m. Once again, the bomb caused some damage to the building, but no one was injured in the explosion. Through an investigation, they were able to link San Diego to both bombings. They began tracking San Diego hoping that he would lead them to where the bombs were made, or to other people involved. Agents believe that San Diego must have been on to them because on October 6, 2003, he parked his car in downtown San Francisco and walked away and had not been seen since. The FBI says that San Diego planted the bombs because the two corporations have had ties with labs that use animals for the testing of medications and other products. After both bombings, an animal rights group called the "Revolutionary Cells-Liberation Brigade" posted an e-mail taking responsibility for the bombing. The group also threatened that if Chiron and Shaklee didn't sever their ties with animal testing labs, the bombs would increase in size and the employees' homes and families would be targets. Agents cannot directly connect San Diego to the emails, but they do know that he has ties to the group who sent them. San Diego goes by the name Andreas as is believed to be armed. He is smart, clean cut, strict vegan who is known to wear glasses. San Diego is 26, 6'0" and 160 pounds. (See Show #745, OAD 12/20/03)

CAPTURED:

Gianni Gugliatto (Possession with Intent to Distribute) - Miami's Immigration and Customs Enforcement (ICE) agents are looking for Argelio "Angel" Aguayo and his girlfriend, Gianni Gugliatto, and an unknown accomplice on cocaine distribution charges. They have been on the run since August 2003. ICE agents started investigating Aguayo and Gugliatto after a high-speed boat chase in February 2003 led to the seizure of more than 900 pounds of cocaine. roughly an \$8.2 million street value. The alleged smugglers fingered Aguayo and Gugliatto as "middlemen" in the Miami drug trade In August of 2003, ICE agents, Miami Dade Police and Hialeah Police attempted to set up Aguayo on an undercover drug deal. But when Aguayo got suspicious, the bust was blown and Aguayo fled. A chase ensued, but Aguayo got away. Days after her profile, Gugliatto turned herself in. Aguayo and their accomplice have not been seen since. Aguayo speaks fluid Spanish and spends his free time working out, eating sushi and drinking Corona beer with lime at night clubs and bars. The Cuban born Aguayo has family in the Miami area and may be working in the boating industry. He likes to flash his money and usually wears name-brand clothing and may be wearing a men's GMT Master Rolex watch. Although he may have shaved, he likes to wear a goatee. Aguayo is 31, 5'7" and 180-190 pounds. Aguayo and Gugliatto's unknown accomplice is described as a thin male in his 20's who has short black hair and a mustache. (See Show #753, OAD 2/21/04)

Thomas Earl Johnson (Murder) -Carlsbad Police are on the hunt for Thomas Johnson for the alleged murder of his father and the stabbings of his mother and five-year-old nephew. On Monday, February 16, 2004, at 1:48 p.m., the Carlsbad Police Department received a call from a medical office. They were worried about the welfare of one of their patients. The caller said that the office staff had called the home of Robert Johnson with test result information. The phone

was answered by a small child who asked for help and said that he had been hurt. Officers were dispatched to the home. When they arrived, they discovered a five-year-old boy with head and neck wounds. Officers also found 80-year-old Rita Johnson unconscious and Robert Johnson dead, all from stab wounds. The injured little boy and his wounded great-grandmother were taken to the hospital. Information from the victims and area residents helped officers identify Thomas Earl Johnson as the suspect in the attacks. Johnson is the son of Robert and Rita, and the grand uncle of the five-year-old boy. Just before his profile aired, Johnson was captured in Monterey, California on February 28, 2004. (See Show #754, OAD 2/28/04)

John Doe #1 (Sexually Exploiting a Minor for the Purpose of Producing Child Pornography)-Agents from the FBI Innocent Images Unit, a group of undercover agents who arrest pedophiles who commit crimes on the Internet, say images of John Doe #1 having sex with a child have been repeatedly shown and traded on the Internet. Sometimes it is "traded" as a movie clip, sometimes as a still photo. Agents have determined that John Doe #1 is an American, and that the movie of him having sex with a child was made recently, sometime in the last five years. For the first time, law enforcement has been able to charge an unnamed person for crimes against children. There is a warrant for the arrest of John Doe #1, despite the fact that agents don't know his true identity. Federal agents are hoping that someone who sees his picture on America's Most Wanted will be able to identify him and put a name to the face. And in doing so, protect children from further harm. Authorities have already arrested another suspect that was profiled with John Doe #1. A tipster identified him as Scott Hayden. It turns out, Hayden is already convicted for molestation and producing those disgusting images. He is currently serving a 50-year sentence in an Indiana prison. John Doe #1 has been identified Thomas Richard Evert. His mother insisted that he turn himself in after his sister recognized his photo on AMW. (See Shows #753 and #754, OADs 2/21/04 and 2/28/04)

The following are the featured fugitives and others being sought by federal, state or local authorities. The <u>Update</u> (if any) gives current status, previous references, or related information.

Neil Newmister (Rape) - Neil Newmister allegedly raped the wife of one of his friends and is now on the run. In August 2002, he entered her home through a sliding glass door, he snuck up on her while she slept, duct taped her eyes and hands together, forced her onto the ground and raped her. He then let himself out of the house. The victim was able to call the police, who found her partially bound with tape. Police found DNA evidence that connected Newmister to the crime. Newmister agreed to come to the police station for questioning but police say he never showed up. When police called his workplace, they were told he called in sick and never returned. Newmister is described as nosy and bossy. He drives fancy cars and enjoys beer, skydiving and playing pool. Newmister has hazel eyes, usually wears a goatee, and may be seeking work as a day laborer. Newmister is 30, 5'10" and 178 pounds.

Oscar Torres-Chavez (Murder) - Oscar Torres-Chavez is wanted for the murder of an innocent eight year-old boy. On July 21, 1998, Torres-Chavez (who just goes by Oscar Torres) and a group of seven other individuals jumped in a car and headed out to exact revenge on a group of rival gang members. One of the gang members told the group that members of the opposing gang had damaged one of their cars. However, in reality, he was involved in an accident earlier that day and made up the story to avoid blame. The group drove up to a house where they believed their rivals were staying and saw several people standing outside. They opened fire with a shotgun and ended up striking an eight-year-old boy several times in the head. The boy died shortly thereafter. The vehicle was pulled over by law enforcement and all of the occupants were arrested. Seven individuals pled guilty and were sentenced to prison time, everyone except for Torres-Chavez. He was able to bond out and police believe he took off to Mexico. Law enforcement claims to have tracked him going in and out of Mexico several times over the years. Unfortunately, they only find out after the fact. Torres-Chavez uses the aliases Demon, Roberto Albares Bravo, Oscar David Montano and Erik Torres. He has a scar on his right index finger and a birthmark on his left hand. He has a tattoo of a scorpion and a "D" on his right hand. Torres-Cahvez is 23, 5'7" and 150 pounds.

Anibal Mustelier (Extortion, Bank Larceny) – In 1989, Mustelier was hired to kill Frank Condom, a Miami businessman. On December 22, 1989, Mustelier and another thug, Nelson Cruz, followed Frank in their car as Frank left a nightclub. As Frank drove home, Mustelier emptied a 30-round clip from his machine gun into Frank's car, then sped away. Frank somehow managed to escape the attack with only a gunshot wound to his arm. Mustelier and his crew weren't done. Mustelier and several other men planned to use a bomb to blow Frank up. On August 17, 1990, Cruz and two other men went to Frank's mother's house and put a bomb under Frank's car. When Frank and his family got into the car, the bombers detonated the device. Once again the attack failed. Frank and several members of his family suffered serious injuries but fortunately none died from the blast. Eventually, most of the group was arrested but Mustelier managed to slip away. Mustelier resurfaced in 1996 when he pulled off one of the largest bank heists in south Florida. Mustelier put together a crew of criminals and was able to get safety deposit box keys made for the Sun Trust Bank. On November 18, 1996, two men went into the bank and got away with approximately 8,000 pieces of jewelry valued at between \$5 million and \$7 million from three different safety deposit boxes. The men gave the money to Mustelier, who disappeared. Authorities believe Mustelier fled to Venezuela shortly after the robbery, but may currently be back in Florida. Mustelier has used numerous aliases including Emilio Suarez, Barrero Musteler, Anibal Musieler, Ramon Llercna, and Anivan Mutelier. He has a small scar on his neck, wears contact lenses or glasses, and is known to keep in shape and work out at gyms. He may be taking ballroom dance lessons or hanging out in dance clubs. There are rumors that he has ties to Castro as a hitman. Mustelier is 53, 5'4" and 135 pounds. (See Shows #664, #681 and #721, OADs 2/9/02, 6/22/02 and 5/31/03)

On September 30, 2000, 18-year-old Colleen Perris got a cell phone call at home. She answered the call, told her mother she would be back around 5:00 when the family planned to go to a Florida Marlins game together. The teenager never returned. Six days later, her white Mazda MX6 was found at a nearby strip mall. Police suspect foul play because of a number factors: her cell phone, though not found, was never used again. She left over a thousand dollars in her bank account. She left her car with a carton of cigarettes in it. For the last three years, her parents have been keeping the case alive with flyers, a website, and by taking an active role in the missing children issues in Florida. Colleen has tattoos of a large butterfly across the small of her back, a half-finished ankle bracelet of Chinese characters on her right ankle, and has pierced ears and navel, and several piercings in her tongue. John Stoneman (Rape of a Minor, Child Pornography)

Patricia Kelley (Rape of a Minor) - Stoneman and Kelley are wanted for the rape of a minor. The pair videotaped their sexual assault of a profoundly handicapped four-year-old child. Kelley was a Licensed Practical nurse charged with the daily care of a four-year-old disabled girl. The victim suffers from spina bifida, hydrocephalus, diabetes and a seizure disorder that leaves her blind and unable to communicate or move. Cops first began investigating Stoneman when child pornography found during a case in Orange County, California was linked to a computer in his Cambridge, Ohio home. Police arrested Stoneman, but he quickly posted bond for those child pornography charges. Subsequent searches of the home that he and Kelley shared uncovered many more crimes, including the videotape of the assault on the disabled four-yearold. They also discovered a two-way mirror with a video camera behind it, used to videotape minors changing clothes. Authorities are still determining how many juveniles were victimized by this couple. Stoneman failed to appear for a hearing on the initial pornography and weapons charges. The pair fled together, and were last seen driving a light-gray four-door 1996 Saturn with Ohio plates DU 27 SX. On March 4, 2004, Patricia Kelley was taken into custody at a restaurant at the Toronto airport where she was working. John Stoneman was arrested soon after. The following are the featured fugitives and others being sought by federal, state or local authorities. The <u>Update</u> (if any) gives current status, previous references, or related information.

Oliver Berry (Murder) -- U.S. Marshals are looking for Oliver Berry for the murder of Josiah Salley. On July 16, 2002, Berry was involved in a fight with Sally over a parking dispute. Berry left the scene and when he returned a few minutes later, he pulled out a gun and fired several rounds into Salley's car. Two of the bullets hit Salley and killed him. Berry has not been seen since. Berry has served time for aggravated assault and criminal possession of weapons. Marshals believe that he could be armed and dangerous. Berry is 24, 5'9" and 200 pounds.

Chaka Raysor (Murder, Racketeering, Conspiracy, Drug Charges) -- Chaka Raysor is wanted by the Bureau of Alcohol, Tobacco and Firearms and the United States Attorney's Office in the Eastern District of New York for murder, racketeering, and conspiracy to distribute crack cocaine. In 1985, investigators say Raysor and his brother Umeme formed a ruthless drug gang in their Bedford-Stuyvesant neighborhood of Brooklyn. At its peak, agents say the organization raked in over \$90,000 a week dealing crack cocaine in Brooklyn, Maryland, Delaware, and Norfolk, Virginia. The federal indictment also charges Chaka Raysor with a total of nine murders. But agents believe the Raysor organization committed more than forty homicides during their ten-year reign of terror. On the streets of Brooklyn, the gang was known as "The Killers". Agents say Raysor mesmerized his gang members with fiery, Black Panther-style rhetoric, and maintained their loyalty with an iron fist. they say during their reign of terror the ruthless Raysor gang murdered innocent local residents, rival drug dealers, landlords, and a homeless man. On April 27, 1998 Umeme Raysor was convicted of federal racketeering, narcotics conspiracy and murder charges, but his brother Chaka remains at large. Chaka Raysor has used the aliases Charles Herbert Raysor, and the nicknames "Chik", "Chak", and "C". He is usually heavily armed, and is skilled in martial arts. Raysor has a stocky, powerful build, closecropped hair and a beard, and a glass left eye with a scar underneath. He is described as ruthless, manipulative, charismatic, and extremely violent. Raysor is 34, 5'10" and 200 pounds. Viewer

tips placed Raysor in Williamstown, South Carolina, but authorities were unable to locate him. (See Shows #517, #535, #559, #560, #561, #562, #571, #573, #582, #613 and #725, OADs 11/7/98, 3/27/99, 9/25/99, 10/2/99, 10/9/99, 10/16/99, 1/8/00, 1/22/00, 4/1/00,12/16/00 and 6/28/03)

Dimitrios A. Androutsopoulos (Murder) -- Androutsopoulos and three accomplices, brothers John Boyd, Brian Boyd and Steven Howerton, went to the trailer home of Dwight Vice on the night of May 4, 2001. Dwight, a commercial fisherman, lived with his 12-year-old son Darryl. John Boyd was a friend of Dwight's. The four men intended to rob Dwight Vice of money and marijuana. During the course of the robbery, the four tortured Dwight and his son Darryl by repeatedly strangling and beating them while demanding to know where Dwight's money and drugs were stashed. Young Darryl's spinal cord was severed by a stab wound to the back and he was strangled until the men thought he was dead. His father was stabbed and strangled to death. Androutsopoulos and his crew fled the scene believing they had killed Dwight and his son. The next morning Dwight's co-worker stopped by the trailer to pick Dwight up for work and found the horrific scene. Incredibly, little Darryl was still alive. The 12-yearold was able to identify his father's "friend" John Boyd as one of the attackers. Police arrested the Boyd brothers and Howerton, but Androutsopoulos slipped out of the area and remains at large. Darryl was left permanently paralyzed by the stab wound to his spinal cord. Androutsopoulos, who may associate with members of the Latin Kings street gang, has worked at a meat processing plant. He may have a mustache and goatee. Androutsopoulos is 28, 5'7" and 160 pounds. (See Shows #665 and #703, OADs 2/16/02 and 1/04/03)

Unknown Wheaton Bank Robber (Bank Robbery) -- An unidentified man robbed nine banks in the Wheaton area in the past two years. He wears a heavy coat, black ski mask and carries a semi-automatic handgun. Police believe he may have a background in law enforcement or the military. His last robbery took place on January 14, 2004 at a health care credit union. Witnesses have said he may be blonde. Police say that he appears to know the area very well so he may live in the neighborhood. The Unknown Wheaton Bank Robber is white, 20-30, approximately 5'9," has blue eyes and a medium build.

Wilfred Cotaya (Aggravated Rape, Aggravated Kidnapping) -- Nearly seventeen years ago, a twenty-year-old woman made her way into a New Orleans Police precinct, just after having been savagely beaten and raped. Although her statement lead police right to an arrest, the suspect made bail with the help of his wealthy father, and has never been heard of again. The story began on the evening of April 15, 1981, when the victim was enjoying an evening drinking with friends in the trendy Lakeside district of New Orleans. She was approached by a well-dressed young man who introduced himself as "Will," and said he was the vice-president of a large corporation. He then bought a round of champagne for the table, and by the time the victim and her friends were ready to move on to the next bar, he had gained her confidence. She agreed to join him for the short drive. Almost as soon as they were alone, the seemingly all-American young man turned vicious. He beat the woman as she sat in her car, beat her on the street, and finally locked her in the trunk of his car. He drove to a more isolated area, stopped, beat her again, and then gagged and blindfolded her. Before long, they were at a residence,

where he removed her from the trunk, dragged her across the lawn, and tied her to a bed. He then proceeded to rape and beat her for six hours, resting for short periods of time and tightening her bonds every time she struggled. Finally, he let her go, but not before threatening her with more torture to come should she ever go to the police. The brave victim went to the police directly, and gave a statement that helped detectives crack the case right away. They started at the bar where the victim had met "Will." The bartender knew that he had only served champagne to one table, and that the man had paid with a credit card. The name on the receipt: Wilfred Cotaya. Police found the shocked twenty-four year old Cotaya at his quarter-million dollar estate. They then found the victim's gold chains in the bedroom, and sheets, ropes, and duct tape with the victim's blood and hair. Investigators were soon reminded of an unsolved rape that had occurred four months earlier. Another young woman had been abducted in a bar, locked in a trunk, tied with duct tape, and fastened to a bed. Police say that Cotaya confessed to the rape of the most recent victim, and the case seemed to be neatly wrapped up. But then Cotaya's father put up three-quarters of a million dollars to bail his son out of jail, and Wilfred hasn't been seen since. Even after all this time, the victim still desperately wants to see her attacker in front of a jury, and the detective, who remains in contact with the victim, still has him on top of his most wanted list. Cotaya is described as meticulous and neat, and as a braggart. He is an avid skier and a film buff who collects movies. Cotaya is 46, 5'9" and 145 pounds. (See Shows #398 and #482, OADs 2/17/96 and 1/24/98)

John Evan Mizic (Escape, Fraud, Counterfeiting, Robbery)

Karen Mizic (Accessory After The Fact to Escape) -- John Mizic has a long criminal history involving scams, robberies, and cocaine and heroine abuse. He was serving time for a 1998 scam in a Harrisburg, Pennsylvania jail when he met Karen, a mother of three children. She had a boyfriend in the same jail and got to know Mizic. Karen eventually dumped the boyfriend and got involved with Mizic. She married him in jail. From his cell, he was able to control Karen and her children, forcing them to wait for his call before they went out of the house. In March 2001 Mizic was transferred from jail to a halfway house in Harrisburg to complete his sentence. Mizic was a week away from being released when he escaped from the halfway house. On May 7, 2001 he received a weekend social pass from the halfway house to visit his wife, who was undergoing shoulder surgery. When he didn't return on May 9, 2001, Mizic was placed on escape status. The United States Marshals Service learned that Mizic packed up his wife's house and three children, along with computer equipment and one or two dogs, on the morning of May 9. The family took off and has been on the run ever since. USMS have traced the Mizic family to areas of Pennsylvania, Massachusetts, Florida and Virginia. Mizic is back to his old tricks: pulling a counterfeiting check scam. He steals checks in the mail, makes phony ones on his computer and cashes them in banks around the town he happens to be in. In one month he made off with nearly \$70,000. This is how he is able to stay on the run, take his family to Disney World, buy Thomas Kinkaid prints, jewelry and an SUV. His take is well over \$500,000. Authorities are concerned about his step-children's welfare. It doesn't appear they've lived in one town long enough for the children to attend school. Mizic, who has used the aliases Jon, Daryl and David Mizic, Jon Misic, Jeffrey Hoffman, Otis Jackson, Victor Gallo, Anthony Eugene Jones and Edward Buchanan, has scars on both eyes and his right arm, a rose tattoo or an eagle on his forearm and an unknown tattoo on his left thigh. He is known to wear pinky rings. He appears to have gained a considerable amount of weight. Mizic is 47, 6'0" and

275-310 pounds. Karen Mizic, who has used the aliases Karen Sheeler and Karen Barnhart, has an unidentified tattoo on her chest. She is 37, 5'3" and 130 pounds. The pair may be traveling

with the children in a 1994 Ford Bronco with Florida plates F83-LSU or a 1999 Burgundy Dodge conversion van. (See Shows #692, #720 and #750, OADs 9/28/02, 5/24/03 and 1/24/04)

Jose Luis Vizcaino-Ramos (Murder) -- Jose Luis Vizcaino-Ramos is wanted in Bolivar, Tennessee for the murder of his girlfriend Mary Graves. Graves dated Vizcaino-Ramos for approximately three years but the couple had recently separated. Graves had a five-year-old boy, from a previous relationship, who had grown close to Vizcaino-Ramos. On the evening of March 6, 2004, Graves and Ramos were arguing inside of Graves' car outside his house. Graves' son was in the back seat. At some point, detectives say Vizcaino-Ramos pulled out a handgun and shot Graves six times, killing her. Vizcaino-Ramos dumped Graves' body in the yard, pulled Graves' son from the vehicle, and then drove off. A short time later, Graves' son saw a local sheriff's car passing through the neighborhood. The boy flagged down the deputy and told him what happened. Graves' car was found early the next morning in Webster, Texas, but there was no sign of Vizcaino-Ramos. Vizcaino-Ramos has a tattoo of the initials "JLVR" on his left shoulder and the initials "JOS" on his left hand. He's a Mexican national who has worked as a day laborer at a saw mill and as kitchen help at area restaurants. Vizcaino-Ramos is 29, 5'6" and 150 pounds.

Errol Domangue (Rape, Murder) --Police say Errol Domangue, a handyman, lured a resident of the complex he lived in to a vacant apartment. He tied the woman to the bed, raped her, and then strangled her to death. Police say he left her body in the vacant apartment. It was two weeks before the decomposing body was found. Domangue never showed up for work again and has been on the run ever since. Domangue has a tattoo of a blue bird and the letters "N" and "M" on his upper left arm. Domangue is 51, 5'7" and 158 pounds.

Michael Alfonso (Murder, Aggravated Stalking) -- Alfonso is wanted in Wheaton, Illinois for the murder of Genoveva Franco Velasquez on the morning of June 6, 2001. Velasquez was killed as she approached the entrance to the McDonald's where she worked as assistant manager. Alfonso walked past cars at the drive-thru window, then pulled a gun from his duffle bag, shooting Velasquez in the chest. He then stood over the victim and fired more shots into her. Witnesses say he fled the scene on foot, dropped his gun and jumped into a parked car in a lot behind the McDonald's. The victim worked with Alfonso at her second job with the Pampered Chef. Velasquez had been having an affair with Alfonso, but decided to break it off and remain with her husband and 9-year-old daughter. On June 5th, Velasquez reported for work at the Pampered Chef and was confronted by an angry Alfonso. He refused to leave her alone unless she agreed to talk to him. When Velasquez tried to leave, Alfonso grabbed her arm and pulled her backwards. He threatened Velasquez and her family, saying he might show up at her house. Velasquez called the police, but requested that Alfonso not be contacted, because she was afraid that he would retaliate. Alfonso's birth name is Michael Johnson. He speaks fluent Spanish and English, has a muscular build, and likes to work out. He likes fast cars and is ironically a fan of America's Most Wanted. He has a tattoo of the word "Blanca" on his back that he may have had removed and a stab wound scar on the left side of his

chest. Alfonso is 34, 5'6" and 150 pounds. (See Shows #642, #659, #696, #707 and #711, OADs 7/28/01, 1/5/02, 11/9/02, 2/22/03 and 3/22/03)

CAPTURED:

Boris George Graham (Murder) -- On the night of February 8, 1999, Graham and Kirell Francis Taylor committed a home invasion robbery that ended in the death of thirty-year-old Christopher Rawlings. Rawlings, a self-made millionaire, husband, and father of two young daughters, was returning to his Woodland Hills, California home after an errand when he was attacked in his garage by two masked men, tied up and thrown into the trunk of his \$200,000 Bentley. When police responded to a desperate 911 call from Christopher's wife Barbi, Graham and Taylor jumped into Christopher's Bentley and sped off with him still tied up in the trunk. The high-speed chase that ensued ended in a violent car crash that resulted in Christopher being ejected from the trunk and fatally injured. The case was highly publicized and profiled on America's Most Wanted. In July 1999, Taylor was arrested and charged with the murder of Christopher Rawlings. Detectives have since learned that Graham was Taylor's accomplice, and the driver of the Bentley during the chase. Graham and Taylor are members of the Piru Bloods street gang and suspect they may be responsible for a string of unsolved home invasion robberies. Graham was last spotted in Chicago, Illinois. Graham has used the aliases Juba Pattis and Kato. He has a tattoo on his right shoulder and a scar on his upper lip. Graham was captured in Broward County, Florida on January 28, 2004. He will be transferred back to Los Angeles where he will be tried for Christopher's murder, and face a life sentence with no possibility of parole.
