The following are the featured fugitives and others being sought by federal, state or local authorities. The <u>Update</u> (if any) gives current status, previous references, or related information.

Angel Manuel Rivera (Murder) – Rivera murdered three of his tenants on June 26, 1991. Witnesses saw Rivera pull up to the Santa Cruz house he rented out to several tenants. Rivera had an argument with tenant Geronimo Aragun Modesto about working on cars in the driveway of the house. Rivera pulled out a gun and shot him, killing Modesto immediately. Hearing the shots, Juan Rodriguez, a father of two, ran outside to see what the commotion was about; Rivera shot him as well. Rodriguez died at the hospital shortly after. Rodriguez's common-law wife ran out of the house next, leaving their two small children inside. Rivera shot her as she exited the front door, killing her immediately. Rivera then fled the scene. In 1999 Rivera surfaced at the home of a distant cousin, Felix Gusman. The Gusman family offered him a room, telling him he could stay for a few nights or until he found a place to live. River, however, ended up staying for several months. Gusman had heard that Rivera had killed someone and confronted Rivera. Rivera said the shooting was in self-defense and that he was the victim of a stabbing, showing Gusman old surgery scars as evidence. It was during this time that Rivera became involved with the Gusman daughter, Myra. Rivera moved to East Chicago and asked Myra and her 11-year-old son, Orlando Sotomayor, to join him. Gusman warned his daughter of the murders, but she went anyway. Gusman never saw his daughter again. On December 12, 1999, Myra's son said goodnight to his mother and Rivera, then went to sleep. The next morning he woke up to find his mother strangled to death. Since 1999 Rivera has been getting food and shelter from the unsuspecting Puerto Rican Catholic Church. Claiming to be a religious man, he seeks the help of the community and priest for food and shelter in exchange for light yard work and home repairs. Rivera, who has used the aliases Jose Robles, Sylvester Vasquez, Miguel Rivera and Manuel Rivera, has a surgical scar on the right side of his abdomen, a lump on his left shoulder, and may have surgical scars on his left shin and knee. He takes handyman-type jobs and may make money as a day laborer. He is a compulsive liar with a history of battering his women and

children. He may walk with a limp, and reputedly collects guns. Rivera is 57, 5'9" and 160-170 pounds. (See Show #665, OAD 2/16/02)

Zeke Cooper (Attempted Murder of a Police Officer, Home Invasion) – On November 17, 2001, LAPD officers Rodney Carter and Andre Nainey spotted two males illegally riding a bicycle – one was perched on the handlebars. They called for the men to pull to the curb and put their hands up. The man riding on the bars, Cooper, jumped off and was approaching the squad car with his hands up when the officers noticed a handgun in his waistband. Before the squad car was completely stopped Cooper drew his gun and fired five rounds at the car, hitting officer Carter in the arm. Both suspects fled the scene. Cooper's residence was staked out, but Cooper was gone. His girlfriend who shared the apartment told them that Cooper came home, packed in a hurry, and left without telling her where he was going. On February 26, 2002 NYPD responded to a home invasion call in Brooklyn. A couple was robbed of jewelry, cash and cell phones, and the male victim was pistol whipped by the assailants. Police tracked calls placed on one of the stolen cell phones and were able to identify the suspect as Zeke Cooper. The female victim later confirmed the identification in a photo lineup. On April 6, 2002 NYPD arrested a man for smoking a marijuana cigarette on the sidewalk. He identified himself and was booked under the name Donovan Carlisle. He was then released on a minor charge before fingerprint analysis came back identifying the man as Cooper, who has multiple outstanding warrants in New York and Los Angeles. Cooper is a "third striker" who has no regard for human life. Cooper, whose other known alias is Carlisle Donovan, has a distinctive tattoo of a tophat with sunglasses on his shoulder. Cooper is 33, 5'11" and 190 pounds.

Unknown New Orleans Armed Robbers - On April 19, 2002 at 3:00am, three masked men robbed the Diamond Jubilee Casino on the eastern side of New Orleans. Their crime was caught on surveillance tape. They were carrying high powered weapons including an AK-47 and a 9 .mm. The backpack one of the men was carrying probably contained extra weapons and ammunition. The three were also wearing body armor. Once inside, they ordered the customers to get on the floor and then they went back to the money room. The suspect toting the AK-47 seems to be the ringleader and was wearing a rubber Bill Clinton mask and camouflage. The suspects saw an armed security guard near the money room and said "Unarm her". When neither of the suspects moved to take her gun, the security guard went to give it to them, but instead of waiting, the suspect with the AK-47 immediately shot her in the stomach. She fell to the ground and they took her gun. They moved her aside to get into the money room and then shot her again in the thigh. Amazingly she survived. Once inside, they demanded the cashier open the safe. They got away with thousands of dollars and took off. On their way out the front door, the suspect with the AK-47 fired several rounds at the floor, just missing a customer. On April 29, 2002 they struck again. They walked into an Auto Zone located several miles from the casino. It was around 8:00am when the three masked men entered, toting a bag of guns and wearing body armor. Again, their crime was caught on surveillance tape. One customer inside was wearing a two-way radio on his belt. One of the suspects thought he was a cop. The suspect dragged the customer down the aisle to the back of the counter and held a gun to his head until he was convinced the man was not a cop. The suspect with the AK-47 forced the manager at gunpoint into the back office and tried shooting open the safe. They could not open it so they grabbed the store's petty cash and took off again. This time no one was seriously injured. The first suspect used a 9 .mm rifle, wore a white hooded sweatshirt, light pants, a black mask partially covering

his face, and white gloves. He is 20-30, 5'8"-6'0" with a heavy build. The second suspect, the probable ringleader, was wearing camouflage pants and shirt. He is 20-30, 5'8"-6'0" with a medium build. The third suspect was wearing a long-sleeved light colored shirt and dark pants, a fishing-type hat, a dark mask covering his face and white gloves. He is 20-30, 5'8"-6'0" with a medium build.

Anthony Stephen Kuchta (Drug Charges) -- Kuchta is accused of being a Class I narcotics trafficker. He wanted by the Michigan State Police for conspiring to deliver over 650 grams of cocaine - an offence punishable by life without parole in the state of Michigan. Kuchta and four associates were arrested April 23, 1990 in a reverse drug transaction in which they purchased two kilos of cocaine in an undercover sting operation. This was to be the first parcel of a two-hundred kilo deal in which Kuchta was the money man. Arrested along with Kuchta were Pedro Molla and Giovanni Mereu. Molla and Mereu were deported after their cases were dismissed. The two Molla sisters failed to appear for trial March 16, 1991 and are also fugitives. Kuchta failed to appear the previous December. Kuchta, who has used the aliases Dave Taylor and Dade Taylor, has a scar on his left wrist. He grew up wealthy, dresses well, wears a Rolex watch, likes manicures and facials, and likes expensive American cars. He is divorced but very close to his young son. He is very intelligent. He fishes and boats, and prefers warm climates. Kuchta is 50, 5'10" and 170 pounds. (See Shows #268 and #347, OADS 5/14/93 and 1/7/95)

Unknown (Murder) -- It looked like a closed case. The parents of Sofia Silva would never get their daughter back, but at least, they thought, her killer was behind bars. Nine months later, however, the discovery of two more bodies led directly to the horrifying prospect that a serial killer was at work, and still at large. Now, the parents of the quiet town of Spotsylvania, Virginia, are keeping their children close. Now the town knows that no one is safe. On September 9, 1996, shortly after her 16th birthday, Sofia went out to enjoy the afternoon sun on the front porch of her tranquil suburban home. From there, she simply disappeared. No one could believe that Sofia had been snatched right from her own yard, but five days later, the community's worst fears were realized - Sofia's body was discovered wrapped in a blanket, tied with rope, and left in a pool of water. She had been dumped about 20 miles from where she lived. Months later, in January 1997, the Spotsylvania Sheriff's department believed they had cracked the case. Armed with loads of forensic evidence, investigators moved in on a 44-year-old neighbor and charged him with murder. They proudly announced that their prime suspect was in custody, Spotsylvania parents breathed a sigh of relief, and the Silvas' grief was finally mediated by the knowledge that someone would pay. But then, on Tuesday, May 6, 1997, the nightmare returned. The bodies of 12-year-old Kati Lisk and 15-year-old Kristin Lisk were discovered under a bridge in the South Anna River, 40 miles from the girls' Spotsylvania County home. Before long, deputies knew that someone had made a terrible mistake, and that

Sofia's killer was still at large, still looking for victims. A re-examination of the forensic evidence cleared the jailed suspect, and sent the county into paroxysms of terror. These days, no concerned Spotsylvania parent can let a child out of sight. The FBI continues to work with the Spotsylvania Sheriff's Department, following as far as they are able every one of the leads that continue to pour in. So far, two leads look promising. Seventy-five miles from the Lisk home, reports came in of a man in a white Ford pickup truck with a rear camper, chrome wheels, and a blue reflective stripe on the tailgate who attempted to abduct a 22-year-old college student. Could this be the same serial killer at work? Then, on May 17, 1998, a man tried to abduct a 12-year-old girl from her own apartment in Manassas, Virginia, about 15 minutes from Spotsylvania. The girl escaped and the suspect was arrested. But police say that it is not yet time for celebration - there are still about a dozen leads they need to follow. The Silvas don't have to be told that they may be disappointed. They've seen a suspect cleared before. Instead, they are focusing their energies on preserving Sofia's memory through the Sofia Silva Scholarship Fund. Patti Lisk, mother of Kati and Kristin, attempts to teach others about the grieving process - she recently gave a speech to a group of ministers. And as the parents of the victims reach out to others, they have also found each other, and say they have become and will always remain friends in grief. Carlos Daniel Medina (Murder, Attempted Murder) – On Saturday, February 9, 2002 Margie Perez was with her mother, Zoraida Lizardi, at a bar in Cleveland, Ohio when they were approached by Margie's estranged husband, Medina. Eyewitnesses say he was hostile towards both of them and confronted them before he left. Margie and Zoraida were uncomfortable exiting the bar on their own and asked the bartender to escort them outside shortly after midnight. After the bartender got them outside and did not see Medina, he returned to his post inside. At this point Medina revealed himself. He came from out of the shadows by the women's car and stabbed Zoraida. He ran after Margie, stabbing her in the driveway by the front door of the bar. Bar patrons called 911 and both victims were taken to a local hospital. Margie Perez was pronounced dead shortly after her arrival. Her mother survived the incident. Medina, who has used the alias Carlos Daniel Hernandez, may be working in auto body repair and maintenance. He speaks fluent Spanish. Medina is 22, 5'6'-5'8", and 140-155 pounds.

Eddie J. Burgos (Aggravated Sexual Assault, Battery, Robbery) – Chicago police are seeking Eddie Burgos for the June 16, 2001 aggravated sexual assault, battery and kidnapping of a 16-year-old girl. Recently, he also became a suspect in the murder of a 15-year-old girl in Chicago. In the nearby suburb of Cicero, Illinois, police are seeking Burgos for questioning in the July 1, 2002 murder of two people. In the 2001 incident Burgos raped and beat a 16-year-old

girl inside his car. He kidnapped the girl, repeatedly slammed the girl's head into the ground and then stabbed her in the neck with a sharp-tipped Puerto Rican flag. After Burgos had subdued her, he dragged her back to his Toyota Camry and raped her. Burgos was arrested in July 2001 after the victim identified him as her attacker in a photo lineup. He remained in jail until March 25, 2002 when Burgos' mother bailed him out. On Saturday, June 29, 2002, 15-year-old Ashley Beverly went to meet her stepsister's boyfriend, Eddie Burgos. Family members became alarmed when Ashley did not show up to be the flower girl in her stepbrother's wedding on Sunday. They notified police and filed a missing persons report. Meanwhile, Burgos had contacted members of the Beverly family and they knew he was staying at a motel in Cicero. On Monday, July 1, 2002, Ashley's family went to the motel to confront Burgos and try to find Ashley. A very heated argument led to a violent shooting. Ashley's father, Ashby Beverly, and Ashley's stepbrother, George Cuervas, were both shot dead in the parking lot of the motel. That same day, a delivery truck driver discovered Ashley's decomposed body under a bridge in Chicago. Police have not yet been able to determine how or when Ashley died, but are calling it a homicide. Cicero police are anxious to speak with Eddie Burgos and call him their prime suspect in the murders of Ashby Beverly and George Cuervas. On July 10, 2002, Burgos did not show up for a bond hearing scheduled in the June 2001 sexual assault case. Burgos, who has used the aliases Eddie Rios, Eduardo Otero Pagan and Eddie Martinez, has several tattoos including a large grim reaper on his left inner forearm, a grim reaper with a sickle on his upper right arm, and the word "criminal" in oriental script on his left shoulder. He is a known gang member and may be armed and dangerous. He speaks Spanish fluently and is proud of his Puerto Rican heritage. Burgos is 29, 5'9" and 140 pounds.

CAPTURED:

James Vincent Sullivan (Murder) -- James Sullivan was wanted for murder by the Atlanta Police Department and the Georgia Bureau of Investigation in the contract killing of his wife, Lita McClinton Sullivan. Police believe on Friday, January 16, 1987 at approximately 8:15am, Phillip Harwood, a hitman hired by Sullivan, rang the doorbell of Lita's condominium in the Buckhead community of Atlanta. When she opened her front door Harwood, posing as a flower delivery man, shot her in the head with a 9mm semi-automatic pistol, killing her instantly. Lita and Sullivan were involved in a turbulent divorce which entailed a large settlement of money on Lita's behalf. At the time of the murder Sullivan resided in Albermarle, North Carolina and was not considered a suspect. However, Phillip Harwood was arrested a short time later and confessed that Sullivan had indeed hired him to murder Lita. When Sullivan found out Harwood had been arrested he fled to Costa Rica before police could obtain an arrest warrant. In April 1998 police finally obtained an arrest warrant but Sullivan was nowhere to be found.

Viewer tips led authorities to Thailand, where Sullivan had entered the country using an Irish passport. He was arrested by the Royal Thai Police. (See Show #528, OAD 2/6/99)

Screening Report

This will confirm that I have screened the air copy of the above-captioned episode and have the following comments:

Andre Neverson (Wanted for Questioning for Murder) - On Monday, July 8, 2002, NYPD cops arrived at the Brooklyn home of 39-year-old Patricia Neverson. She was found, shot to death. Three days later, on July 11, cops found the body of 34-year-old Donna Davis. Authorities have learned that Andre Neverson had an ongoing argument with his sister, Patricia, stemming from Andre's money which she used to buy her home. Neverson did not want the money repaid; instead, he wanted the house. Donna Davis had been dating Andre, but she had recently broken off the relationship. Neverson did not take the rejection well. The last time Donna was seen alive, she was in Andre's minivan outside a Queens, New York college where she studied. Days after the second murder, cops placed Neverson in Brooklyn, but after that, the trail runs cold. Neverson has used numerous aliases including Troy Michael Anderson, Troy Michael Henderson, Trey Michael Henderson, Andre Humphrey and Andre Henderson. He has a very muscular build and a shaved head, but he may be starting to grow hair again to change his appearance. He does not drink or smoke, is very intelligent and computer literate. At times he is very calm and serene, but he has a violent temper and has served time for attempted murder. He does not drink or smoke, and may be hidden now by one of his many girlfriends. He is originally from Trinidad, but does not have an accent. He has worked as a bouncer in Caribbean clubs and as a security guard at a hospital. He has been know to buy cars, fix them up, then resell them. He may still be armed. Neverson is 38, 6'0" and 225 pounds.

Ray Guidry Killer – The Terrebonne Parish Sheriff's office is looking for information regarding the 1987 murder of Ray Guidry, a wealthy cattle rancher and oil man in Bayou Blue,

Louisiana. On October 12, 1987, the body of 78-year-old Ray Guidry was discovered in his bedroom at the Guidry Ranch. He had been beaten on the head and stabbed multiple times in the chest and the neck. The approximate time of death was estimated by the coroner between 1:00am and 7:00am. The apparent murder weapon, a steak knife, was found in the kitchen sink. There were no signs of forced entry and no other physical evidence found. Ray Guidry was the wealthiest man in Bayou Blue, but certainly not the most popular. He was ruthless when it came to business dealings and had little use for personal relationships. He was openly contemptuous of his adopted son, Vernon, who he severely beat all through Vernon's childhood. Ray's adopted daughter Tina, However, was treated like a princess, even during her adult years. Ray Guidry was known to be quite a ladies man. He was married four times, and entertained literally hundreds of women at his ranch – some of them married, a lot barely out of their teens. After Ray's murder, police discovered a secret cache of thousands of X-rated pictures of Ray's woman and a Pandora's box of sex toys. Despite a six-month investigation, a grand jury failed to indict anyone for the murder of Ray Guidry. America's Most Wanted entered the case in June 2000, enlisting the aid of two retired detectives: Ron Antoci of the NYPD and Joe Matthews of the Miami Beach PD. (See Show #645, OAD 8/18/01)

Unidentified "Precious Doe" – Police found the headless body of a young girl on April 28, 2001 when they were searching for a missing man in the woods of Eastern Kansas City, Missouri. He threatened to harm the 9-year-old sister if she told the police what happened. Two hours after the abduction, Elizabeth's sister told her parents what had happened. Hugo Jimenez (Murder)

Brian Aquino (Murder) – 18-year-old Adriana Pinon was an aspiring actress who appeared 19 times on the TV soap opera "The Young And The Restless". She had been home alone all afternoon on January 31, 2002 when an unknown person shot and killed her. Adriana's mother discovered her body in the living room at 5:30pm. The investigation is focusing on unknown vehicles and strangers which neighbors saw near Adriana's house the afternoon of the murder. One neighbor reported seeing a black sedan backed into the driveway of the Pinon home. Based on interviews with this witness and others, police believe this car might be an older black Ford sedan – possibly five to ten years old – possibly a Thunderbird or Lincoln Continental. Another neighbor reported seeing a suspicious man hurrying from the direction of Adriana's house toward what might have been a getaway car. Following the broadcast, viewers led authorities to Jimenez, whose prints matched those lifted from a television set carried outside the Pinon house by Adriana's killer, and to his accomplice, Brian Aquino. The following are the featured fugitives and others being sought by federal, state or local authorities. The <u>Update</u> (if any) gives current status, previous references, or related information.

Alfredo G. "Chino" Hernandez (Murder) - Hernandez and Juan Cardoso were drinking beer on the afternoon of April 14, 2002 in the parking lot of Juan's neighborhood. Juan went to the Crawdaddy Bayou restaurant, where Juan's brother Jorge was working, and borrowed \$20 for more beer. Jorge was upset with Juan that he would come to his workplace intoxicated, and he chastised his brother in front of his friends. That's when Hernandez started to give Juan a hard time. As the group moved to the parking lot of the restaurant, Hernandez and Juan got into a heated argument about how he let his brother treat him. The argument turned into a physical altercation and the two had to be separated by their friend. The friend convinced them that they should part ways and the evening of revelry came to an end. Around 7:25pm, Hernandez and Juan confronted each other once again in the parking lot outside their apartments. Juan brought a few friends along. Hernandez, along with his brother Juan Carlos, brought several friends along as well, and a ten-inch butcher knife from his kitchen. After a heated exchange, Hernandez stabbed Juan in the abdomen, piercing his lung and heart. Juan died a week later from his wounds. Hernandez has not been seen since. Police believe he is traveling with his brother. Hernandez, who has used the alias Carlos Torres, speaks fluent Spanish but very little English. He may be working as a day laborer, and may be working at a warehouse setting. Hernandez is 26, 5'10" and 175 pounds.

Unknown Ali Kemp Killer (Murder) - On Tuesday, June 18, 2002, 19-year-old Alexandra "Ali" Kemp was working at her summer job as a neighborhood pool attendant when she was brutally murdered. The pool is located near 123rd and State Line in Leawood, Kansas. She was home on break, having just completed her freshman year at Kansas State University, and was working the 2:00pm-5:00pm shift at the pool that day. The weather was rainy so there weren't any other people using the pool. Ali was sitting at a table near the pool's pump room

when she was approached by the unknown suspect. Somehow the suspect was able to get Ali into the pool pump room where he brutally beat her to death. The suspect then covered Ali's body with a tarp and other pool covers. He proceeded to leave the room and shut the doors behind him. As he started to walk out of the pool's entrance he saw a friend of Ali's. According to her, the suspect stopped and looked at her, then walked back towards the pump room, and appeared to be looking around the corner. He turned around again and walked hurriedly towards a 1980's tan Ford pickup truck and took off. Cops are looking into hundreds of leads that include pool and lawn maintenance workers, as well as a crew of construction workers from a nearby interstate road. The suspect in question was spotted twice at the pool earlier hat day, and he may have been spotted watching sunbathers the day before the murder. The suspect was wearing blue clothing which might have been overalls or a blue shirt and pants. The suspect is 5'8"6'0" and heavy set.

Donnie Allen Hulett (Murder) – On the morning of July 22, 2002, after a car he had stolen broke down on the side of the road, Hulett went into the nearby Chattahoochee National Forest. He slept in the woods near the Mountaintop Boys Home for troubled teens. When 69-year-old Arvin Phelps and his brother, 62-year-old Larry, started to clear land near the home, Hulett heard the chain saws. Like a sniper, Hulett fired three shots from 70 yards away, hitting Arvin. When Larry tried to save his brother, he was hit with a fatal shot in the neck. Arvin later died. Hulett then took off the \$400 from the men's wallets, weapons, and a 2000 burgundy F-150 Ford pickup truck. Hulett fled south and several days later switched the plates on the pickup to Georgia tag 1105 ABN. Hulett, who has used the alias/nicknames "D.A." and "D.J.", has a dragon tattooed on his right arm, and unknown tattoos on his left arm and chest. He was just released from prison for auto theft. He has a wildlife license and is a survivalist. He has very thick eyebrows, a short beard and goatee with a thin mustache. He likes the grunge look, smokes Marlboro Lights, and likes being the center of attention. He has worked in construction and laying carpet. Hulett is 21, 5'11" and 160 pounds.

Late Update: Hulett was captured in Arizona.

Unidentified "Precious Doe" – Police found the headless body of a young girl on April 28, 2001 when they were searching for a missing man in the woods of Eastern Kansas City, Missouri. Three days later, a volunteer searching the same area found her head in a garbage bag just 100 yards away from where her body was discovered. There have been on reports of a missing child matching her description and police now believe she may not be from the Kansas City area. "Precious Doe" is described as being three or four years old, weighting 35-40 pounds, and is 42 to 44 inches tall. She has a chipped upper left front tooth and also has a crescent-

shaped birthmark on her left shoulder. (See Shows #632, #660, #675 and #684, OADs 5/12/01, 1/12/02, 5/11/02 and 7/27/02)

William Severs (Murder) – On January 10, 2002 at 7:10pm Severs followed his exgirlfriend Tina Labriola and her fiancé Ralph Kearney to a friend's house in Vineland, New Jersey. When Tina and Ralph came out of the house, Ralph wanted to put some oil in their car before they left. He asked Tina to get a funnel from the trunk. When she went around to the back of the car, Severs shot her with a high-powered rifle, and Tina collapsed into the street. Meanwhile, Bonnie and Francisco Martin, a nurse and a corrections officer, drove by and saw Tina in the street. They thought she had been hit by a car so they stopped to help. Bonnie began doing CPR on Tina and prayed with her. Francisco went back to his car, got his service weapon and cleared the area of onlookers. Francisco also realized that the shooter was still out there somewhere. When police arrived they searched the area but didn't find the shooter. Instead they found the high-powered rifle with a scope in a nearby baseball field. They also found a guitar case and a zebra striped strap with Severs' name on it near the rifle. Severs shot Tina from 60 yards away, then fled on foot. He then placed the gun against a fence surrounding the baseball field and either forgot to pick up his guitar case or couldn't find it in the dark where he left it. Tina Labriola died in the hospital several hours later. Severs, who has also used the surname Seavers, has a bird tattooed on his upper right arm. He is a truck driver, and used to own a candle manufacturing company called Innerscent Candles. He is known to play the guitar and piano and enjoys riding moto-cross motorcycles. Severs is 40, 6'2" and 180 pounds. (See Show #676, OAD 5/18/02)

Unknown Missouri River Killer (murder) -- On October 10, 1996, the body of 21-year-old Christy Fugate was pulled from the rushing waters of the Missouri river near Dover in Lafayette County, Missouri. Police say this shocking discovery was only the beginning. Since then, a series of bodies has continued to appear along the banks of this raging river. The murdered women all have something in common - they were all alleged prostitutes working in the Independence Avenue area of Kansas City, Missouri. They were all roughly of the same weight and height, and many had been warned of the possible threat to their lives posed by what police are ready to call a serial killer. So far, ten women from Kansas City have been discovered downstream, and three women who were suspected to work in the Independence Avenue area have disappeared: Cheresa Lordi, Jamie Pankey and Connie Williams (see below). Five months after Christy's body was discovered, the body of Sherri Livingston was found in the river nearby. Three weeks passed, and another body - Connie Wallace-Byas - was found. The next day, Linda Custer's body was recovered near Dover. Two weeks later, Chandra Helsel's body was found near Boonsville. In April 1998, the mutilated body of Tammy Smith was found in the river near

Sibly. The bodies of four other Kansas City women have been discovered along the water's edge. Police believe they too may be the victims of the mysterious Missouri River Killer. The rushing river has done the killer's work by destroying potential forensic evidence on the bodies. With no evidence, no crime scene, and no witnesses, the police are desperate for information. The Kansas City Police Department has pulled together a crack team to investigate this case - Detective Shelly Volker, raised in law enforcement; Detective Ron Russell, a 20 year veteran of the homicide unit; and Sgt. David Bernard, who has worked the Missouri River for years. Leaving no stone unturned, these top cops are following leads, checking every inch of bridges, and waiting anxiously for the river to reveal its secrets. Meanwhile warnings have gone out to prostitutes in the Independence Avenue area, and the search for the missing women goes on. Police are anxious for information. (See Show #494, OAD 5/9/98)

Mark Anthony Wilson (Murder, Theft, Forgery) – Mark Wilson and Joni Manning lived together for about six months, and they had dated for about eight months. Wilson beat his girlfriend to death on or about Friday, July 6, 2001. Joni died from head injuries caused by a blunt object. Her family became concerned when they were unable to reach Joni by phone. On Sunday, July 8, the victim's sons, ages 15 and 20, when to her home and discovered the body. Mark Wilson had fled and authorities believe he stole Joni's 2000 gold-colored Mustang. On Monday, July 9, the Mustang was found in Kansas City, Missouri. Two men were in the car and police believe Wilson sold it to them on the street. Wilson is a smooth talker who likes to sing and whistle, likes to cook, wears Dockers, and chews on his cigarette butts. He may have a short beard with a lot of gray in it. He prefers Caucasian women and often dates nurses. He was convicted of the attempted murder of his ex-wife in the 1980's. Wilson is 43, 5'9" and 175 pounds.

Armando Garcia (Murder) – Armando Garcia is an extremely violent Mexican national who was wanted in Los Angeles in connection with two attempted murders. On April 29, 2002, Los Angeles County Sheriff's Deputy David March pulled Garcia over on a routine traffic stop. Garcia got out on the drivers side of his 1989 black four door Nissan Maxima and approached Deputy March. When the deputy attempted to frisk Garcia, he was immediately shot multiple times in the face, neck and chest area. Garcia got back in his car and fled the scene. Deputy March died. Garcia, who has used the alias Daniel Garcia and the nickname "Chato", has "Garcia" tattooed on his shoulder blade. A professed cop hater, he doesn't go anywhere without his 9mm gun. Garcia is 25, 5'10"-6'0", and 230 pounds. (See Shows #674, #675 and 684, OADs 5/4/02, 5/11/02 and 7/27/02)

Adolfo Frias Soto (Murder) - On November 20, 1993 in Clayton, Texas, Soto shot Pedro

Cano in the chest and right wrist with a .380 caliber automatic pistol. Soto drove to his home in Henderson, Texas, where he told his family what he had done. He took the clothes hanging on the line and the family dog and fled to Jacksonville, Texas where his brother Delfino lives. He may have also gone to Mexico temporarily, but is now believed to have returned to the U.S. Soto is 38, 5'6" and 180 pounds.

MISSING:

Officials discovered that Wilson was unaccounted for on April 25, 2002. At first police believed that Wilson might be the little girl (Precious Doe) who was found beheaded in Kansas City, Missouri, but when authorities compared the girls' handprints, they weren't a match. Tabitha Brewer

Age: 20 Height: 5'7"

Weight: 115 pounds

Tabitha Brewer was last seen on April 27, 1998. She and her boyfriend, Nicholas Travis, were picked up outside of a house where they lived with Tabitha's father and stepmother in Shawnee, Kansas. The day they were last seen, Tabitha and Nick were hanging out with friends at their house. Nick told Tabitha and their friends that he was going somewhere with a male friend who was coming from a local Circle K store. This male friend was a classmate of the couple. Nick would not say what his plans were with this friend, and Nick told Tabitha he didn't want her coming with him. Tabitha persuaded Nick to let her come. The male friend picked the two up just before midnight. Tabitha and Nick never returned. Police later found Tabitha's charred purse, along with her and Nick's ID's in a dumpster near 55th Street and Paseo Boulevard in Kansas City, Kansas. When police questioned the male friend, he told police he dropped Nick

and Tabitha off at the same Circle K from which he came. The convenience store is located near 75th street and Interstate 35. Four months later, a construction worker made a gruesome discovery. While renovating a house, he came upon the body of Nick, who was buried in the duplex's back yard. This was just a few houses down from the dumpster where Tabitha's purse was located. After Nick's body was located, police found no new evidence to charge anyone with the murder, and there has been no sign of Tabitha. At the time of her disappearance, Tabitha had three earrings in one ear, two in the other, and a tattoo with the initials "TD" on her ankle. She had an old skull fracture and had previously broken her wrist in an auto accident, and had a wire in her jaw. She had scars on her left hand, under her right eye and on her left knee.

The following are the featured fugitives and others being sought by federal, state or local authorities. The <u>Update</u> (if any) gives current status, previous references, or related information.

Manuel Tarango, Jr. (Attempted Murder, Armed Robbery) – It was 1:22am on the morning of December 5, 1999 when Manuel Tarango, Jr., Emilio Rodriguez and a third suspect burst into Mr. D's Sports Bar & Grill. Brandishing pistols, the gunmen began firing as soon as they entered the bar, but the gunmen had picked a bar that was full of off-duty police officers that night who'd come to see a band of cop-musicians, "Pigs In A Blanket", perform. All three gunmen were wearing masks. When Tarango tried to jump over the bar to get to the ash register, several patrons grabbed him and slammed him to the floor. The third suspect began firing wildly into the crowd. At that same moment, on the other side of the bar Rodriguez engaged in a toe-totoe shootout with off-duty cop Dennis Devitte. Devitte was shot seven times, but managed to fatally wound Rodriguez with eight bullets. Rodriguez died at the scene. Five other patrons were wounded during the attempted robbery. The entire event was over in less than twenty seconds. Police believe Tarango fled to Mexico after the robbery. The third suspect, who was wearing a white t-shirt over his head, has not been identified by authorities. Officer Devitte recovered from his wounds and returned to normal patrol duty five months after the shooting. He has been honored as one of America's "Top Cops" for the year 2000 for his heroic actions that night at Mr. D's. Tarango, who has gang affiliations, uses the street name "Demon". He may have a thin mustache and a shaved head or very close-cropped hair. He is known to smoke both marijuana and PCP. Tarango is 21, 5'10" and 185 pounds. (See Shows #600, #618 and #670, OADs 8/19/00, 1/27/01 and 3/30/02)

Antonio Delacruz, Jr. (Murder) – The Harris County Sheriff's Office is searching for Antonio Delacruz. On August 31, 1998, Jose Garcia and Antonio Delacruz went to rob a house in Houston, Texas. The two men knew the owner of the house, Nicholas Acosta. Acosta was involved in drugs and had recently started dating Delacruz's ex-girlfriend. The robbery turned

into violent murder. Garcia and Delacruz stabbed Acosta 17 times. Then Delacruz began beating Acosta over the head with a barbell. The scene was so frightening that Garcia fled, leaving Delacruz at the house. Garcia arrived back at his mother's house where Mrs. Garcia immediately called the police after she saw the bloody mess. Delacruz was on the way back to Garcia's when he heard that police were on the way. Delacruz decided he needed to burn all of the evidence. He fled to burn his truck, but police caught up with him. They put out the truck fire, as well as Delacruz who was also on fire. Jose Garcia was arrested and is currently in Harris County jail. Delacruz was charged with murder on August 31, 1998. A \$100,000 bond was set for his bail. On October 28, 1998, Delacruz was charged with bond forfeiture. Delacruz's father owns a bail bonding business and contacted people in his business to help his son. Delacruz's wealthy family, especially his mother's side, may be hiding him. Delacruz's mother, maiden name Flores, is an associate president of a bank in Texas. He was last seen at a strip club in February 1999. Delacruz is 26, 5'7"-5'9" and 165-175 pounds. (See Shows #622 and #670, OADs 2/24/01 and 3/30/02)

David Mark Veal (Murder/Escape) — Veal escaped from the Hood County Prison on February 13, 2001. Veal loosed a shower head in his cell and managed to punch a hole in the cinder block. He crawled through the hole and made his way to an air vent. Once in the air vent, he made his way to the roof and jumped over the barbed wire fence. He was last spotted in Colorado Springs. Veal was being held for the murder of Charles Henderson at the time of his escape. He was hired by Henderson's wife, Twila Henderson, to kill her husband. On April 26, 2000, David Veal was waiting for the Charles to return from work. When Charles walked through the door, Veal shot him twice in the chest, killing him. Veal and Twila Henderson were both charged with murder. Veal uses methamphetamine and he may be living in a homeless community. He works odd jobs - handy man, painting and cutting lawns. Veal has a tattoo of a bird on his upper left shoulder and the words "White to the Heart" on his left biceps. He also has a tattoo of a lion on his right shoulder, a flower and a bird with a lightning bolt on his left arm above the wrist, a ring tattoo on his left finger and State of Texas on his left knee and a wizard on his right calf going up to his knee. Veal has large skin grafts on both of his thighs. Veal is 36, 5'10" and 115-135 pounds. (See Shows #637 and #670, OADs 6/16/01 and 3/30/02)

Dudley Vincent Forbes (murder) - Forbes beat his girlfriend, Lorna, beginning when she was four months pregnant. After the birth of her son, she and her two boys left but Forbes continued to stalk her, threatening to kill her and her whole family. Forbes broke into her apartment, and stabbed her 13 times before fleeing. After being tipped off by a friend, Forbes followed Lorna to a nightclub. After a brief altercation in the club he left, but returned to shoot the place up, killing two and wounding seven. Though usually soft-spoken, Forbes has an explosive temper. He has a welder's certificate and has worked as a forklift driver and compound

mixer. Forbes enjoys playing soccer and dominoes. He is 40, 5'10" and 175 pounds, and speaks with a Jamaican accent. Viewer tips have placed Forbes in the Flatbush area of Brooklyn, New York, where he may be living under an assumed name. He is believed to be driving a grey 1988 or 1989 Honda with New York plates. (See Shows #404, #414, #443, #538, #555, #593 and #670, OADs 4/13/96, 5/22/96, 3/15/97, 4/17/99. 8/28/99, 7/1/00 and 3/30/02)

Lloyd Andre Lindsey (Aggravated Sexual Assault, Kidnapping, Robbery) – On February 14, 2000 a 31-year-old black female was walking home when a black male in a car stopped and asked her if she wanted a ride. A few minutes later, the same man was walking behind her. He put a knife to her neck and forced her into his car. He drove her to a secluded location where he ordered her into the back seat and forced her to take her pants off. He raped her and forced her to perform sex acts. Then the man pushed her out of the car. The woman ran to a nearby business and called police. Later she identified him as Lloyd Lindsey. A year later, on the night of May 23, 2001 a similar incident occurred. A woman was walking to her boyfriend's house when a black male in a car asked her if she wanted a ride. He then got out of his car and at knifepoint ordered her into his car. The man drove her to an alley where he raped her and stole her money. The victim fought with the man and freed herself. She ran towards her boyfriend's house and she used his phone took all police. She later identified the suspect as Lloyd Lindsey. Lindsey has a mole on his left cheek, and sometimes wears a beard and goatee. He works as a laborer, and has previously served 20 years for sexual assault. Lindsey is 30, 6'0" and 160 pounds.

Unknown (Murder) -- Authorities in Zachary, LA are seeking a suspect in the murder of two women and the attack on two teenagers. On August 23, 1992, Connie Warner, a 41-year-old single, divorced mother, disappeared from her home in Zachary, LA. Tracey Warner, Connie's 17-year-old daughter, returned home from a weekend trip around 9pm and her mother's car was in the driveway, but Connie was nowhere to be found. After waiting for her mother for two and a half hours, Tracey became worried and called her grandfather. When he came over, they searched the house, found blood splatters and called the police. The Zachary Police detectives immediately suspected foul play. They secured the area, began searching for evidence, and started interviewing neighbors and other witnesses. Then, on September 2, 1992, a truck driver found Connie Warner's body in a drainage ditch in Baton Rouge. On April 5, 1993, two teenagers drove to the Buhler Plains Cemetery to "park" for the evening. While a teenage girl, 16, and her boyfriend, 18, were snuggling, someone opened their car door and interrupted them. The intruder attempted to stab them to death with a sling blade. During the attack, a police cruiser pulled into the cemetery to investigate the parked car. The officer scared the assailant away, before he was able to finish his killing spree. At 7:00pm on April 18, 1998, 28-year-old Randi Mebruer, a divorced, single mom, went to the local video store with her son and rented

some movies. The next morning, her three-year-old son, Michael, went to his neighbors' house and told them his mommy was lost. When the neighbor and her husband entered the Mebruer house to look for Randi, they found blood and called the police. The suspect in all three cases is 25-30 years old, 5'8"-6'0" and of medium build. (See Shows #516, #574 and #670, OADs 10/31/98, 1/29/00 and 3/30/02)

AMW ALL-POINTS BULLETIN:

Stanley Obas (Criminal Homicide, Aggravated Assault, Kidnapping) – In March 1996, 13-year-old Richezza Williams ran away from her home in Long Island, New York. Five months later, her badly decomposed body was found in a cemetery in Easton, Pennsylvania. On July 28, 1996, about two weeks prior to the discovery of the body, three young men tortured and murdered Richezza in the basement of a house three blocks from the cemetery. After the murder, the men placed Richezza's body in a box, carried it to the cemetery and hid the body in a storage vault. Two of the men involved in the murder have been arrested and convicted, but the third man, Stanley Obas, is still on the loose. Obas, who has used the aliases Neil Stevenson and Troy Smith and the nickname "Wildman", has scars on his left arm, left leg and face. He is a member of the Cash Money Boys gang, a known drug user, and considered armed and dangerous. He often wears three rings on his hand. Obas is originally from Haiti. He is 24, 5'10" and 130-180 pounds. (See Shows #631 and #670, OADs 5/5/01 and 3/30/02)

Clifford Carrol Graham (Mail Fraud, Wire Fraud, Income Tax Evasion) -- It's the oldest confidence game in the book: the goose that lays golden eggs, the promise of money out of thin air. But no one ever suspected it would come from self-made millionaire Clifford Graham. In the 1970s, Graham got rich establishing the Fotomat chain - a network of little yellow shacks that suddenly sprung up in parking lots across the country. His critics called him a dreamer when he got started. He proved them wrong millions of times over. So when Graham started looking for investors for a new scheme, he didn't come up short. He had developed a number of wealthy and influential friends, and was able to impress them with his contacts at the upper levels of government - including Gerald Ford. Coming from anyone else, his promises would have looked insane at best, criminal at worst. But when he put out word that his latest company, Au Magnetics, would soon be using new technology to extract gold from ordinary sand, the world beat a path to his door. The feds say that behind his impressive sales pitch, however, Graham was in deep trouble. His millions from the Fotomat empire had dwindled away into nothing, they claim, and he wasn't about to give up his extravagant Southern California lifestyle. Whether the technology was viable or not was a moot point, they say: he wasn't in it for the gold - he was in it for his investors' cash. Graham allegedly oversold shares in his

company, and instead of using the investments for development of his miracle gold machine, FBI agents claim that he lined his own pockets with \$10 million of his investor's money. Among the hardest hit was Graham's own secretary, Kristine Griffin, and her husband, a veteran firefighter. They thought they were getting an inside track on a sure-fire scheme. Instead, they lost their life savings. Following an attempted investor takeover, the FBI and IRS became very interested in Graham. That when, they say, he decided to take an extended vacation. Graham was allegedly last seen living large on a Caribbean island. Meanwhile, the Griffins, their equity wiped out, were wondering how they were going to feed their second child. Graham has used the aliases "C.C." and Cliff. He has a scar from the right corner of his mouth to his right cheek and a scar on his right leg, but he may have had plastic surgery. He is a physical fitness enthusiast who wears lifts in his shoes to add up to three inches to his height. He may be armed with a revolver. Graham is 77, 5'4" and 155 pounds. (See Shows #298, #376, #498 and #670, OADs 1/4/94, 8/19/97, 6/6/98 and 3/30/02)

Martha Ann Gomez (Sexual Assault of a Child) --- Gomez is wanted for sexually assaulting three girls between the ages of 13 and 15 from 1996 to 1998. Gomez posed as a teenage boy and usually met her victims through phone chat/sex lines. She preyed upon girls with low self-esteem, touting herself as someone who would listen to their problems. The conversations eventually escalated to actual meetings where Gomez sexually assaulted the girls. When the girls, who still believed Gomez was a man, tried to break out of the relationship, Gomez threatened their lives and their families' lives. In at least one case, police say Gomez used a gun. Police figured Gomez out and arrested her in the fall of 1998 on one count of aggravated sexual assault of a child. She bonded out. On November 24, when she was supposed to appear in court, and as police were filing three additional charges against her, Gomez disappeared. Gomez may have cut her hair and dyed it blonde. She has acne scars on both cheeks, "Gomez" tattooed on her lower left arm near her wrist and "ACE" on her upper left arm near the biceps. She has a very masculine walk, and hunches down as she walks. She claims she injured her back years ago when working in a candle factory, and used to receive disability checks for a dislocated disc in her back. She usually does factory work. Gomez has used several aliases, including Emilio Garrison, Eric Garrison, and Eric Barragan. Gomez is 38, 4'9" and 115-125 pounds. (See Shows #544, #563, #586 and #670, OADs 5/29/99, 10/23/99, 4/29/00 and 3/30/02)

The following are the featured fugitives and others being sought by federal, state or local authorities. The <u>Update</u> (if any) gives current status, previous references, or related information.

Chuan "Charley" Cai (Murder) – Charley Cai is wanted for allegedly killing his girlfriend Xiaoyan "Shirley" Liu in Toronto, Canada. Shirley Liu was last seen at a New Year's Eve party in the early morning hours of January 1, 2000. A few days later, after failing to reach her, Shirley's sister became concerned and contacted police. On January 6, 2000 police found Shirley's body stuffed into a suitcase in the apartment she shared with her boyfriend Charley Cai. Shirley had been suffocated and Cai was nowhere to be found. Cai is a millionaire and he and Liu lived together for six years before coming to Canada last year. Police say Liu was in the process of breaking up with Cai. Cai is originally from China, where he made his money in a computer firm. He may be driving a white 1990 four-door Toyota Camry with Ontario license plate AEDC 129. Cai is 29, 5'10" and 140 pounds. (See Show #575, OAD 2/5/00)

Unknown (2) (Murder) -- Agents and detectives in Atlanta are looking for at least two suspects in the 1998 murder of ATM courier William Hill. The shooting took place in broad daylight at the Roswell-Wieuca Shopping Center, a heavily populated strip-mall in the Buckhead area of Atlanta. On May 6, 998 witnesses remember seeing a Ford pickup truck with a camper shell at the scene of the crime over an hour before the shooting. Witnesses noticed the inside of the camper shell was lined with pine straw, creating a tunnel. At 1:45pm, William Hill shows up at the South Trust ATM at the shopping center to refill the ATM. Without warning, Suspect #2 fired a single shot from either an AR-14 or a hunting rifle and hit Hill in the head, killing him instantly. Suspect #1 appeared, ordered witnesses to call 911, and then calmly picked up the money, climbed into the pickup truck and drove away. Minutes later, police found the pickup truck engulfed in flames. Police discovered the truck had been stolen back in January. Suspect #1 is described as clean-cut with a mustache and bushy hair, with muscular facial features and a slender build. He is approximately 40-50 years old. Suspect #2 is proficient with firearms, and

may have some military background and tactical training. Detectives say he has a disciplined personality. There is no description available. (See Shows #535, #583 and #641, OADs 3/27/99, 4/8/00 and 7/21/01)

Anatoliy Valenko (Murder)

Vladimir Balachov (Murder) — Valenko and Balachov are wanted by the New York City Police Department for the 1995 dismemberment murder of their roommates in a Brooklyn apartment. Police say that on November 12, 1995 the two murdered Fakhat Askarov and Fakhat's girlfriend, Larisa Jakovleva during an argument. Then detectives say Valenko and Balachov purchased a circular saw with the victim's credit card and dismembered the bodies. Police located Fakhat Askarov's head and leg and Jakovleva's leg on Plum Beach in Brooklyn. The torsos were located in a mountain reservation in Essex County, New Jersey. Both men are from the Ukraine and speak very little English. They may be hiding out in a Russian community, possibly in California or New York. Both men place personal ads in Russian newspapers to meet women. Both men have worked as carpenters in construction jobs, as a gas station attendant and as a cashier. Valenko is 30, 5'8" and 150 pounds. Balachov is 31, 5'10" and 150 pounds. Following the initial broadcast, AMW received over 80 tips on the pair. (See Shows #529, #530 and #641, OADs 2/13/99, 2/20/99 and 7/21/01)

John Patrick Addis (Murder, Kidnapping) -- Addis is wanted for the 1995 kidnapping and murder of his girlfriend in the Nevada desert. On August 19, 1995, police say Joann Albanese disappeared from her residence in Las Vegas along with her boyfriend, John Edwards. Police later determined that Edwards was in fact, John Patrick Addis, a former Alaskan state police homicide investigator. Police say Addis was working as a personal trainer in Las Vegas, when he became involved in a romantic relationship with Joann. On the day she disappeared, Joann, a single mother of two, was scheduled to have dinner with Addis to inform him that the relationship was over. Joann's car was discovered several days later, abandoned in Little Hell's Canyon near Prescott, Arizona. Police say Addis strangled Joann in a fit of rage and hid her body. Police say Addis has a history of traveling around the country finding work in fitness clubs, so he can meet women, romance them, and live off their money. On July 31, 1998, three years after Joann disappeared, a grand jury in Clark County, Nevada charged Addis with her murder and kidnapping. On October 9, 1998, hunters discovered Joann's body. Police determined she had been murdered. Addis, who has used the aliases John H. Edwards and John Elliott, is an avid body-builder who works in gyms as a personal trainer. He is a small plane pilot, outdoorsman and marksman, and is skilled in forensics and criminal investigation. He believes in UFO's and the god RAH, and often claims he's a science fiction writer who writes screenplays on UFO's. His ex-wives say he has a history of domestic violence and fraud, and he has served time in jail for custodial interference. He is adept at manufacturing false identification and Social Security cards. Addis is 51, 6'0"-6'1" and 200 pounds. (See Shows #519, #555, #571 and #641, OADs 11/21/98, 8/28/99, 1/8/00 and 7/21/01)

Guisseppe Lino Loporto (Rape) – Loporto sexually abused his own daughter from the time she was seven years old until she was 17. The abuse took place from 1987-1997. His daughter finally came forward and told her mother about the abuse in 1996. The mother later notified authorities. Loporto was arrested, but fled before his trial. Loporto is of Libian descent and holds dual citizenship with the U.S. and Italy. He speaks French Spanish and Italian. He has worked as a financial broker, but may be an architect or computer expert now. He likes to live

extravagantly, with expensive cars, clothes, and fine dining. He likes to drink but doesn't smoke. He likes to hang out with the wealthy in his spare time. Loporto is 69, 5'7" and 155 pounds.

Shane Matthew Magan (Attempted Murder of a Peace Officer, Armed Robbery) -Magan is wanted by Riverside and San Bernardino, California authorities for attempted murder
of a peace officer and a string of supermarket and convenience store robberies in Southern
California. On February 25, 1993 during a suspicious vehicle traffic stop, Magan, who was high
on speed, opened fire on a Riverside sheriff's deputy. The officer returned fire, but Magan and
his friend, Justin Flint, managed to escape. Minutes later, in nearby San Bernardino County, the
two youths robbed a gas station convenience store at gunpoint. Flint surrendered to authorities
shortly after the robbery, but Magan remains at large. Magan was spotted in a gang round-up,
but authorities at that time did not know Magan was a fugitive from justice. Magan has a
noticeable hare lip. He shaves his head, wears black hooded sweatshirts and black caps and
fancies himself a Hispanic gangster. He may associate with Pomona's local 12th Street Sharks
gang, and may run with a gang of armed graffiti Taggers. He uses amphetamines and speed, and
should be considered armed and extremely dangerous. Magan is 24, 5'7" and 145 pounds. (See
Shows #299, #335 and #629, OADs 1/11/94, 10/8/94 and 4/14/01)

Jennifer Renee Short

Age: 9 Height: 4'3"

Jennifer Short and her family lived in Bassett, Virginia, along a manor interstate, Route 220, just 35 miles south of Roanoke. Jennifer has been missing since Wednesday, August 14, 2002. It wasn't until Thursday morning that a co-worker of Jennifer's parents stopped by the Shorts' house early Thursday morning and discovered Mary and Michael Shorts' dead bodies. When cops arrived at the scene they determined that there had been a struggle in Jennifer's bedroom and that her parents had been killed with a single gunshot to the head each. Julian J. Lockhart (Murder, Robbery) – Lockhart beat Robert Glidden to death with a tree branch on Thursday, May 9, 2002. Glidden, a young Navy vet with no criminal record, posted an ad in the local newspaper advertising his 1989 Ford Mustang for sale. Glidden went with Lockhart for a test drive, but Glidden never returned home. On Sunday afternoon, May 12, police found Glidden's Mustang without its license plates and partially burned in a commuter parking lot in Cheshire, Connecticut. On Monday evening, a police line search found Glidden's body in the woods near the Chapman Manufacturing Plant. Investigators determined that Glidden had been beaten to death, and that he died from a blunt force trauma to the head. Near the body, cops discovered a tree branch which the believe was the murder weapon. A few days after the murder, Lockhart took a bus to New York City. Lockhart was previously convicted of assault in the mid-90's and served six years in prison. Lockhard, who has used the last name Lockheart and the nickname "J.J.", may be wearing his hair in dreadlocks. Lockhart is 27, 6'1" and 220 pounds.

Francisco Martinez (Murder) – Martinez shot his both, Michael Cerullo, in the back of the head on September 14, 2001. Cerullo was an owner of Yofi Textiles in Passaic, New Jersey. Martinez, the warehouse manager, was also the lead suspect in an arson that occurred a few weeks prior to the murder. Friends and family of the two men were puzzled by the murder because the two were also very good friends. They had known each other for thirty years and would often spend time together outside of work. Martinez was stealing textiles from the company, selling material for cash and not reporting the money. Francisco tried to burn down the factory to cover up the crimes. Cerullo became suspicious of Francisco and may have had a confrontation about the theft and arson. Cerullo was found in the basement of Yofi Textines with a bullet wound to the head. A few days later police divers found the murder weapon in the

Passaic river. By this time Francisco had disappeared. Martinez, who has used the alias Francisco Martinez Seminari, has a scar on his abdomen, psoriasis on his head and neck leaving bumps and a rash that looks like a birthmark, a discolored front tooth. He always wears baseball caps to cover his discolored balding head, and has an extensive collection of caps. Martinez is 40, 5'8" and 350 pounds.

Robert Foster (Murder) – On August 17 and 18, 2000, body parts began to float up in Manhattan's East River. The body was so badly decomposed that police were only able to determine that the parts were female because of long painted fingernails on a hand. Detectives were able to pull a fingerprint from one hand, and when they ran the print through INS, the INS database confirmed that the prints belonged to Leisa Lennon of The Bronx. When police went to her apartment they discovered a gruesome crime scene. They also discovered that her commonlaw husband, Robert Foster, had packed and left town. Foster is considered the key suspect in the crime and he is also wanted on parole violations by the NYPD. Foster was born in Jamaica and may be headed back there by way of Mexico. He was last known to be in Southern California looking for work in construction. Foster, who has used the alias George Escalante, and the nicknames "Bobby", "Scar Face", and "Scar Neck", may indeed have scars on his neck and face which cannot be seen in photos and which cannot be confirmed by the NYPD. Foster is 5'7" and 160 pounds. (See Show #672, OAD 4/13/02)

Unknown Irving Sicherer Killer – On July 23, 2001, a grocery store surveillance tape shows 76-year-old Irving Sicherer entering the store with an unknown man. After leaving the store, Sicherer and this mysterious man were again caught on surveillance tape, this time at Sicherer's condo. When Sicherer's daughter hadn't heard from him. She went to check on him and found that he had been beaten to death, and that his Lincoln Navigator was gone. It was later recovered in Hollywood, Florida. Police originally thought Adama Ezerski was responsible for Sichere's death. Now they believe the man in the video is someone else. (See Show #644, OAD 8/11/01)

Brian Michael Jones (Rape, Sexual Assault, Kidnapping) – Jones is wanted for the rape and kidnapping of a Las Vegas woman, "Mary". On August 28, 1999 "Mary's" car got stuck in the desert sand. She began walking for help when Jones stopped and offered to help her pull her car out. He told her that he had a truck at his house and it would be able to pull her car out of the sand. "Mary" got into Jones' car and went to his house. Instead of just getting his truck, Jones held "Mary" hostage for 18 hours while he raped and performed sexual acts on her. After 18 hours of abuse, "Mary" was able to escape and run to safety. Jones was arrested on September 2,

1999. He was released on bail in November 1999. Jones checked in weekly with a parole officer while he was awaiting trial. In September 2000, Jones failed to report to his parole officer and hasn't been seen since. Jones worked in the real estate business. He likes to work in landscaping, is a handyman, collects guns and makes his own bullets. He is known to have driven a 1979 orange/red Stingray Corvette and a 1980's white Chevy pickup truck. Jones is 45, 5'11" and 180 pounds. (See Show #633, OAD 5/19/01)

Fernando Leon Blanco (Felony Hit and Run) – On September 1, 2000 at 5:25pm Blanco was driving his pickup truck when he collided with Larry Collumn, Jr. who was riding an ATV. After the accident Blanco left Collumn, who had been injured and landed in a nearby canal, and fled the scene. Collumn later died and the cause of death was drowning. Shortly after the accident, Blanco moved to Salome, Arizona, and lived there under the alias Javier Cota. Blanco fled the area before police could arrest him. Blanco, who also goes by the nickname "Pedro", may be working in construction or as a farm laborer. Blanco is 34, 5'9" and 180 pounds.

Jennifer Renee Short

Jennifer Short and her family lived in Bassett, Virginia, along a manor interstate, Route 220, just 35 miles south of Roanoke. Jennifer has been missing since Wednesday, August 14, 2002. It wasn't until Thursday morning that a co-worker of Jennifer's parents stopped by the Shorts' house early Thursday morning and discovered Mary and Michael Shorts' dead bodies. When cops arrived at the scene they determined that there had been a struggle in Jennifer's bedroom and that her parents had been killed with a single gunshot to the head each. There was no sign of Jennifer in the house, and investigators are convinced that she was abducted by her parents' killer(s). There are no suspects yet, but authorities believe that the Shorts probably knew their attacker. The family recently put their house on the market and investigators are looking closely at their realtor's records of who came through the house during the last few weeks. Michael Short worked as a mobile home mover. Business hadn't been good, and he was planning to move the family out of their home in western Virginia and into a mobile home. Jennifer is described as friendly and talkative. There were signs of a struggle in Jennifer's bedroom. (See

The following are the featured fugitives and others being sought by federal, state or local authorities. The <u>Update</u> (if any) gives current status, previous references, or related information.

Jorge Alberto Lopez-Orozco (Murder) – On August 11, 2002, police officers found a burned out car. Inside the car, they found three bodies: 29-year-old Rebecca Ramirez and two of her young children. All three bodies had been shot to death, dumped into a car which was set on fire. Jorge Alberto Lopez-Orozco had dated Rebecca but the relationship had recently ended. Authorities believe the motive for the murders may have been the termination of the relationship. Lopez-Orozco, who has used the aliases Paul Solario and Raul Solorio, as well as the nickname "Pepe", wears his hair collar-length and likes to wear cowboy-style clothing and a white cowboy hat. He may be traveling with his wife, Juana, his infant son Jorge, Jr. and his daughters Anna Louisa and Maria. Although he is married, he has had numerous extra-marital affairs. He is a known drug user. Lopez-Orozco is 26, 5'7" and 175 pounds.

Unknown Richard Evonitz Victims – Police are searching for information on possible additional victims of a known child killer. A mask was found in the car of serial killer Richard Evonitz. Evonitz as been deemed responsible for murdering Sophie Silva in 1996 and Kati and Kristen Lisk in 1997. Evonitz committed suicide after a high-speed police chase in June 2002. Police were able to find Evonitz because a brave 15-year-old victim got away from his apartment in South Carolina, after enduring a 17-hour long episode of repeated rapes and assaults. Police would like to know if any victims of unsolved rimes may have described the mask found to police. They are using the mask as a tool to find other Evonitz victims. Photographs were found spliced into Evonitz's homemade pornography videos. The first depicts a child wearing clothes and a hairstyle that appear to be from the late 1960's or early 1970's. The photo appears to be a school picture. A second photo depicts a child wearing makeup like an adult. She is posed in a seductive position.

Russell John Smith (Rape and Sodomy of a Child) – Smith persuaded a 12-year-old girl to become involved in satanic rituals, and a part of those rituals was having sex. Smith is on the run and his daughter, Tara Jenine Swiger-Smith, is with him. Smith worked as a correctional officer. Smith also claimed to be a satanist and to have founded a satanic church. When authorities searched Smith's basement, he had created a satanic ritual room which included ritualistic material such as black candles, robes, satanic symbols and a goat's head. On August 17, 2002, three days after Smith quit his job as a corrections officer, his girlfriend reported Smith and his daughter missing. When the allegations of rape surfaced he went on the run and took his 12-year-old daughter with him. Police are concerned that he has involved his daughter in satanic rituals. Smith, who has used the alias Reverend Sorath, has a tattoo of a pentagram on his right forearm and a military tattoo on his left upper arm. He has Crohn's disease, claims to have stomach cancer, and takes prescription medications Ketoprosen and Prednisone. He is a non-smoker who drinks occasionally. He is traveling with a 38mm gun, and the license plate of his Red 1997 Nissan reads "100P666", which police believe means "100% Evil". Smith is 37, 5'7" and 160-180 pounds. His daughter Tara Jenine is 12, 5'0" and 110 pounds.

Mikhail Drachev (Murder, Kidnapping) – Konstantin Simberg was an informant for Phoenix, Arizona Detective Tom Britt. On December 14, 2001, Tom received a call on his cell phone from Konstantin. While on the phone, Tom heard a scream from Konstantin, then the line went dead. Two days later, Konstantin's body was found in Fossil Creek, Arizona - a rural area more than 100 miles from Phoenix. Through his own phone records, Tom learned that Konstantin called him from a cell phone belonging to an Arizona State freshman named Chris Andrews. Detectives went to Andrews' apartment and found evidence linking him to the murder. 20-year-old Dennis Tsoukanov and 19-year-old Mikhail Drachev were also involved in the killing. All three are acquaintances of Konstantin's. The tree men attacked Konstantin while he was on the phone with Detective Britt. The gang held Konstantin overnight, then drove him to Fossil Creek the next morning. The men stabbed Konstantin in the back with a knife. The men then lit him on fire, covered him with rocks and left him for dead. Andrews and Tsoukanov are in jail awaiting trial. Drachev is currently on the run. Drachev is a Russian national who speaks English without an accent. He may be driving a 1973 Mercedes-Benz 280-SEL with Utah plate 182-XS. Drachev is 19, 5'11" and 170 pounds.

James Ramiah Logan (Murder) – Logan shot and killed two Prince George's County Maryland sheriff's deputies on the evening of August 29, 2002. Cpl. James Arnaud and Deputy Sheriff Elizabeth Magruder went to Logan's home in Adelphi, Maryland to take Logan into custody on an emergency psychiatric warrant. When the deputies entered the home, Logan shot both of them with a handgun. Arnaud was pronounced dead at thescene, while Magruder died a short time later at a nearby hospital. Logan has paranoid delusions involving religion. He is 23,

5'11" and 160 pounds.

AMW ALL-POINTS BULLETIN:

Unknown Riverside Robber (Armed Robbery, Attempted Murder) -- On June 5, 2001, an unidentified man attempted to rob and murder the clerk of the Palm Liquor Store in Riverside, California. The suspect entered the store at 9;10am, and concealed his identity with a ski mask and motorcycle helmet. The clerk watched suspiciously as the man approached him at the counter. Suddenly the suspect whipped out a gun and pointed it at the clerk, who grabbed his own gun from a hiding place under the counter. They exchanged several rounds before the subject fled the store. The suspect is approximately 6'0". (See Show #648, OAD 9/8/01)

Unknown Indiana Bank Murderers (Murder, Attempted Murder, Bank Robbery) – On August 27, 2002, two men burst into the First State Bank of Porter in the town of Pines, Indiana. A security guard, Kieth Hill, tried to stop them from entering, but the robbers shot him in the chest. While one robber guarded the door, the other approached the bank counter and shot two tellers, Kay Peckat and Chandler Simpson. Kay Peckat died at the scene. The robber then tried to open the vault. When he was unsuccessful, the robbers fled without any money. They fled in a dark Chevy Caprice or Ford Taurus. Shortly thereafter, police discovered a car ablaze on an access road near the bank. The car was a tan Dodge Aries, which may have been the getaway vehicle. A woman was seen near this burning car. The woman is wanted for questioning. The woman is 35-40, and 170-180 pounds. The first robber is approximately 5'11" and approximately 200 pounds. The second robber is approximately 240 pounds.

Richard Yang (Murder) B On July 4, 2001, Louise Yang left the restaurant that she co-owned with her estranged husband for home. She unlocked the back door to find her husband, Richard Yang, just inside the door with a chef=s knife. They struggled and he chased her through the house, stabbing her repeatedly, leaving a bloody trail all over the floors and walls. Louise managed to make it to the dining room and into the living room where she was stabbed to death. Yang waited about 45 minutes before he picked up the phone and called police saying, Al killed my wife. Yang pleaded to 2nd degree murder. He was then released from custody by a judge so he could appear in court in another county on charges of tax evasion. Yang fled and has evaded authorities ever since. But before he skipped town, Yang placed a personal ad in the local paper in search of a new girlfriend. Authorities say he is very wealthy and that he has the resources to start another business or restaurant. He has connections in China, Memphis, San Francisco, St. Louis, New York, Texas and Jamaica, but he could be anywhere. Yang is 62, 5'4" and 148 pounds. (See Show #638, OAD 6/23/01)

Frederick Verian Wells (Drug Charges) - Wells was fired from Idaho State University

because of his poor performance as a chemistry professor. When school officials cleaned out his lab, they found "Schedule II" chemicals and officers determined that Wells was manufacturing ephedrine. Ephedrine is used to make methamphetamine. Wells is a recluse and is difficult to get along with. He has a prior record for lewd telephone calls and child molestation. Wells is 53, 5'11" and 195 pounds.

Unknown Roger Boisvert Killer – On September 30, 2001 at 4:15am, the suspect approached a car in which Roger Boisvert was a passenger and Jim Swanner was the driver. The car was pulled to the side of the road while the men consulted an onboard computer in an effort to find a hotel. They were in the 4600 block of Imperial Highway in Los Angeles headed east, and were actually talking on a cell phone with the receptionist of the Marriot Courtyard in Torrance, California. The suspect approached the open window on Boisvert's side of the car and demanded money. Boisvert complied. When he saw the telephone in Swanner's hands he demanded the phone, which was handed over. Then, reaching through the window, he shot Boisvert at point blank range, killing him almost instantly. Swanner stepped on the gas and sped away, stopping at an Arco station three blocks east to call for assistance. Boisvert was a prominent Canadian businessman who had made a significant success in the internet business in Japan. His death made national news in Canada and Japan. The Japanese Guardian Angels who he supported have contacted the U.S. Guardians for help in finding the killers. The suspect is light skinned and may be of mixed race, was well-spoken and apparently well-educated, wore his hair combed back and was last seen wearing a white or gray t-shirt. The suspect is 20-30, 5'7"-5'10" with a stocky build.

MISSING:

Jill Behrman

Age: 21 Height: 5'7"

Weight: 120 pounds

19-year-old Indiana University freshman Jill Behrman went out on a bike ride on May 31, 2000 at a little after 9:30am. The bike ride was a part of her normal workout routine. She never returned. Jill's classmate saw her about 10 minutes after she left her parents' home. Jill never showed up for work at her campus job that day. When she failed to show up for lunch with her family, the search began. At approximately 12:30pm a farmer in rural Monroe County found Jill's bike. It was about 12 miles away from her typical path. Police surmise that Jill was next to her bike, possibly drinking water, when an on-coming vehicle clipped her and injured or killed

her. Police think the assailant or assailants grabbed Jill and her bike, dumping her bike a distance away from the scene. A radio matching the description of Jill's was recovered at the parking lot of a Catholic church in Bloomington. Jill's body has not been found. Authorities are interested in finding the occupants of several vehicles. The first person being sought has been described as a 6' white male in his late teens or early 20's. The driver has been described as an "escort service driver". On that evening, authorities believe that the male drove at least one female escort to and from a call in Bloomington, Indiana. The vehicle is a late-model white or light-colored 2-door convertible. The driver of the second car is a 6', stocky-built (190-20) pounds) white male in his late 20's with professionally-done tattoos. His friend was a passenger in the front seat. He is described as approximately 5'10"-5'11", 170 pound white male, also in his late 20's. The passenger probably also had at least one tattoo. Authorities believe that on the evening in question, the male drove his friend and two females from a rural location to a Bloomington apartment complex. The car is a late-model light-colored 4-door sedan with front bucket seats, a gear shift on the floor, a radio with CD player, and a troll doll with green hair and an air freshener hanging from the rearview mirror. Authorities believe that one or more individuals who were passengers in these cars may have been involved in Jill's disappearance. The owners and drivers of the vehicle may not realize that they possess critical information in the case, or that the cars even played a role in Jill's alleged abduction. Police are also searching for the driver of a dirty older-model (1980's) full-size standard-cab pickup truck with a bench seat. badly-working radio, automatic shift on the column, and possibly a missing right side-view mirror. The truck, which may be used in construction, had a large toolbox, a heavy-duty, dirty plastic tarp, concrete or cinder blocks and assorted trash and fast food bags in the truck bed. This truck may have been borrowed from the owner or even stolen on or about May 30, 2000. When the truck was returned to its rightful owner, there may have been damage on it. The borrower may have claimed that he or she hit a deer. (See Show #651, OAD 9/29/01)

CAPTURED:

Uriah Jay Clouse (aka) Unknown Ellettsville, Indiana Attempted Abductor – On Tuesday, June 13, 2000 a man attempted to abduct an 18-year-old female in Ellettsville, Indiana. There may be a connection to the Jill Behrman abduction. Sometime between 10:30pm and 11:00pm, in an alley behind the Bigfoot Convenience Store, a white male in a large black vehicle, possibly a pick-up truck with a black camper shell, reached from within the cab of his vehicle and grabbed a would-be victim by her right arm. With her left arm, the woman was able to free herself from the attacker's grip. She didn't suffer major injuries, but did have scrapes and bruises from the altercation. She ran away from the truck and attacker to her boyfriend's home, where she called police. She noticed the smell of alcohol on the attacker's breath and a profound

smell of dog emanating from the interior of the vehicle. The attacker didn't speak to her at all. She was also able to give the police an accurate description to create a composite. She described the would-be abductor as a muscular, white male in his 30's with short blond hair. Nearly a year later, on May 13, 2001, a young woman riding on her bike in Bowling Green, Kentucky was assaulted and nearly killed. The victim of the first assault identified Clouse from a composite picture developed from both cases. (See Show #651, OAD 9/29/01)

The following are the featured fugitives and others being sought by federal, state or local authorities. The <u>Update</u> (if any) gives current status, previous references, or related information.

Jamal Sapp (Assault) – Sapp sprayed his ex-girlfriend with a caustic mixture that included a powerful drain cleaner. Sapp approached the woman after a head half-hour argument and threw caustic material in her face. The victim was then taken to New York Hospital. She has serious burns on her face and eyes. A 28-year-old man who was standing near the victim was splashed as well, but he was not seriously burned. The mixture consisted of Drano, which contains lye, mayonnaise and soda. Neighbors reported they heard the couple fighting outside. When Sapp assaulted the victim he grabbed her, held her with his arm around her and squirted the mixture from a squeeze bottle. Sapp, who has used the alias Jamal Deron Davis, has a violent history of robbery and drug sales, and is known to resist arrest. Sapp is 39, 6'1" and 220 pounds.

Assaad Hamdan (Controlled Substance Charges) – DEA agents broke up a drug ring on January 10, 2002, during Operation Mountain Express. The operation was set up several years ago in order to catch methamphetamine producers. The suspects were smuggling pseudoephrine, a chemical used to make meth, from Canada to different locations in the United States. As a result of the operation, 140 people were arrested, some of whom had ties to the Middle East. Some of the Middle Easterners may have funneled profits from their drug-dealing to terrorist organizations such as Hizballah. Hamdan may know something about the connection to Hizballah or other terrorist organizations. Hamdan is 38, 5'8" and 170 pounds.

Ramzi Mohammed Abdullah Binalshibh (Terrorism, Conspiracy) – On September 21, 2001, German authorities issued an international warrant for Binalshibh, naming him as an accomplice in the September 11th attacks. They suspect Binalshibh was meant to be the 20th hijacker in the September 11th attacks. Investigators believe that he had attempted to enter the

U.S. to assist the hijackers, but was denied a visa for reasons unknown. He may have left German just prior to September 11, possibly heading for Pakistan. Binalshibh is 29, 5'8" and 145-160 pounds. (See Shows #654 and #655, OADs 11/10/01 and 11/17/01)

Yolanda Ricaforte (Plunder, Fraud) - Ricaforte is wanted by NBI officials in the Philippines on plunder charges. Ricaforte was the personal bookkeeper/auditor for former president Joseph Estrada. Estrada was recently impeached on plunder charges stemming from accusations that he was running a racket and stealing money from the country through a longrunning illegal lottery game in the Philippines. Estrada formed an illegal gambling ring called the "Midnight Cabinet" made up of high-powered government figures and personal friends of Estrada, such as Charlie Atong Ang and Governor Singson. The official Cabinet met during the day, while the Midnight Cabinet met nearly every night to discuss backroom deals and bribes. The group would play mahiong while drinking expensive bottles of wine, often gambling several million pesos at a time. Yolanda Ricaforte kept tabs on all the money coming in from the lottery and she kept books on how that money was distributed between the president and his associates. She opened accounts totaling 270 million pesos for the former president at six different bank branches, sometimes passing herself off as someone in real estate, travel business or in the export of prawns. Those officials involved in the Midnight Cabinet often competed for their piece of Estrada's operation. In early 2001, relations between some of the officials fell apart and the illegal activity was revealed to Philippine authorities. Ricaforte was called to testify at Estrada's impeachment trial, but she fled the country shortly after her appearance in court. Ricaforte hopped a plane to the United States, along with another one of Estrada's cronies, Charlie Atong Ang. The two got working visas through a fish company in Los Angeles owned by one of Ang's friends in L.A.'s Philippine community. Ricaforte joined her husband and other family members in Los Angeles. Ang was arrested by the FBI in Las Vegas at Thanksgiving 2001. He went there to gamble and apparently to meet up with Ricaforte, but authorities are not sure why. Ricaforte has gone underground since, but agents say she is still in the U.S. and may be hiding in another Philippine community. Ricaforte, who goes by the nicknames "Yolly", "Yolli", and "The Auditor", has diabetes and must seek medical care. She occasionally wears glasses. She may have obtained legal residency status in the U.S. at some point. Ricaforte is 51, 5'1" and 130 pounds.

James Ross Fischer (Sex Charges, Escape) – Fisher had sexual intercourse three times between mid-January 1999 and early February 1999 with a 15-year-old girl. He was arrested on rape charges on February 12, 1999 and housed in the Linn County Jail in Albany, Oregon. He was later released on his own recognizance. He was indicted on several rape and sexual abuse charges with his trial scheduled for November 1999. He did not appear for trial. He was located on April 2000 in North Carolina. Fischer fled to Georgia and on April 26, 20000 he was apprehended at a remote mountain cabin. He was in the Fanin County Jail, waiting for extradition proceedings to be signed by the governor. By the time the documents were signed and delivered on June 9, 2000, Fischer had already escaped. Fisher, who goes by the nickname "Fish", has an unidentified tattoo on his chest. He is an actor who was last known to be seeking acting work in Oregon, but may now be in California. He has worked at a mortgage company. Fischer is 45, 6'0" and 205 pounds.

CAPTURED:

Russell John Smith (Rape and Sodomy of a Child) – Smith persuaded a 12-year-old girl to become involved in satanic rituals, and a part of those rituals was having sex. Smith is on the run and his daughter, Tara Jenine Swiger-Smith, is with him. Smith worked as a correctional officer. Smith also claimed to be a satanist and to have founded a satanic church. When authorities searched Smith's basement, he had created a satanic ritual room which included ritualistic material such as black candles, robes, satanic symbols and a goat's head. On August 17, 2002, three days after Smith quit his job as a corrections officer, his girlfriend reported Smith and his daughter missing. When the allegations of rape surfaced he went on the run and took his 12-year-old daughter with him. Police are concerned that he has involved his daughter in satanic rituals. On the Wednesday following the initial broadcast, a police officer found an abandoned SUV, and a viewer listening to the police band report realized that this was Smith's vehicle. The day after the discovery, when police returned to the scene Smith and his daughter were by the side of the road. Smith was taken into custody without incident, and his daughter was unharmed. (See Show #689, OAD 8/31/02)

Zeke Cooper (Attempted Murder of a Police Officer, Home Invasion) – On November 17, 2001, LAPD officers Rodney Carter and Andre Nainey spotted two males illegally riding a bicycle - one was perched on the handlebars. They called for the men to pull to the curb and put their hands up. The man riding on the bars, Cooper, jumped off and was approaching the squad car with his hands up when the officers noticed a handgun in his waistband. Before the squad car was completely stopped Cooper drew his gun and fired five rounds at the car, hitting officer Carter in the arm. Both suspects fled the scene. Cooper's residence was staked out, but Cooper was gone. His girlfriend who shared the apartment told them that Cooper came home, packed in a hurry, and left without telling her where he was going. On February 26, 2002 NYPD responded to a home invasion call in Brooklyn. A couple was robbed of jewelry, cash and cell phones, and the male victim was pistol whipped by the assailants. Police tracked calls placed on one of the stolen cell phones and were able to identify the suspect as Zeke Cooper. The female victim later confirmed the identification in a photo lineup. On April 6, 2002 NYPD arrested a man for smoking a marijuana cigarette on the sidewalk. He identified himself and was booked under the name Donovan Carlisle. He was then released on a minor charge before fingerprint analysis came back identifying the man as Cooper, who has multiple outstanding warrants in New York and Los Angeles. Cooper is a "third striker" who has no regard for human life. Following the broadcast, viewer tips led authorities to an Air Force base near Boise, Idaho, where Cooper had moved in with a female military officer. Cooper was arrested and returned to LA for trial. (See Show #683, OAD 7/13/02)

Joseph A. Safrany (Vehicular Homicide) – On April 7, 2000 Safrany was alone, driving drunk and speeding when his car collided with another vehicle that was making a turn. As a result of the collision, three people in the other vehicle died and the fourth is still recovering. All of the victims were young Air Force officers stationed at MacDill Air Force Base in Tampa, Florida. After the accident, Safrany was released on bond. He was scheduled to appear in court on June 14, 2001, but he never showed up for the hearing. Safrany, who goes by the nickname "Bones", has a grim reaper with "Joe" above it tattooed on his right arm. He comes from a wealthy family, is a party animal who likes to drink and do drugs, and generally lives in the "fast lane". He is bi-sexual and has a lot of girlfriends. He has worked as a salesman for a lighting company, and likes to play golf and work out. Safrany is 37, 6'0" and 220 pounds.

Unknown Harry Bolling Killer (Vehicular Manslaughter) — Authorities are looking for the driver of a black Corvette who is charged with vehicular manslaughter for a hit-and-run during an illegal street race. On May 4, 2002, Harry Bolling, 62, was on his way home after closing his club in downtown Detroit at approximately 2:45am when a black Corvette slammed into his Jaguar, causing Bolling to lose control of his car and slam into a utility pole, killing him. Witnesses say that two Corvettes were drag racing in the area. The driver of the damaged Corvette fled the scene with the vehicle missing its hood, side panels and other body parts. Police believe that the suspect is probably a male and are questioning bodyshop owners to see if any has done repairs on a black Corvette and also asked them to notify police if anyone brings in a car matching the description. The accident is on the latest in a series of problems with illegal street racing in Detroit. Bowling owned the Atlantic Barber Shop fo 40 years, and opened up the club in 1987. Relatives say that Bolling worked as a barber during the day and ran the club at

Flavio Salazar (Murder and Felony Theft) - Salazar and his girlfriend, Maria Santillan, had been dating since at least 1996. Maria had given birth to two girls by Salazar, Tanya and Yasmin. Salazar and Maria had been fighting and on November 17, 2001, Maria took her two children and moved in with her mother. Two days later, Maria received a call from Salazar and decided to go back home. Later that day, Maria's brother went by her apartment to check on her. Maria's brother saw Salazar with the kids in a car but didn't see Maria. At approximately 9:00pm Maria's brother went to her apartment again and go no answer at the door. Maria's brother asked the apartment manager to let him in the apartment so he could see if everything was all right. Maria's brother found her in the back bedroom. She had been strangled. Salazar and the children haven't been seen since. Salazar, who has used the alias Juan Perez, may be driving a stolen white 1996 two-door Ford Escort with Tennessee tag JBQ993. He is known to do carpentry work. Salazar is 30, 5'5" and 180 pounds.

Unknown Trev Broudy Attackers – Three suspects are wanted for the hate crime assault of Trev Broudy, 33, and Edward Lett, 22. On September 1, 2002 at 11:45PM, Broudy and Lett were standing in the street next to their car. As they embraced to say goodbye, the suspects' vehicle came driving down the street. The suspects yelled something, and then suspect #1 exited the car with a baseball bat and began assaulting the two victims. Suspect #2 then joined the assault by striking one of the victims in the head with a metal pipe. The suspects then reentered the vehicle and fled the scene. Trev Broudy sustained serious head trauma and is currently hospitalized in serious condition. Edward Lett was treated for less serious injuries. This appears to be a hate-related crime because the victims are gay. The first suspect was wearing a dark, baggy t-shirt and baggy pants, and a dark beanie or skull cap. He is in his 20's, either 5'5"-5'6" or 6'0"-6'2", with a slim build. The second suspect wore his hair in tight corn rows. He is 18-28, 6'0", with an average build. There is no description of the third suspect. The vehicle is described as a light brown or "stop sign" red 1987-1998 4-door Nissan Sentra, with a partial California license plate of either 3SDO or 3SDU.

Andre Neverson (Wanted for Questioning for Murder) – On Monday, July 8, 2002, NYPD cops arrived at the Brooklyn home of 39-year-old Patricia Neverson. She was found, shot to death. Three days later, on July 11, cops found the body of 34-year-old Donna Davis. Authorities have learned that Andre Neverson had an ongoing argument with his sister, Patricia, stemming from Andre's money which she used to buy her home. Neverson did not want the money repaid; instead, he wanted the house. Donna Davis had been dating Andre, but she had recently broken off the relationship. Neverson did not take the rejection well. The last time Donna was seen alive, she was in Andre's minivan outside a Queens, New York college where she studied. Days after the second murder, cops placed Neverson in Brooklyn, but after that, the trail runs cold. Neverson has used numerous aliases including Troy Michael Anderson, Troy Michael Henderson, Trey Michael Henderson, Andre Humphrey and Andre Henderson. He has a very muscular build and a shaved head, but he may be starting to grow hair again to change his appearance. He does not drink or smoke, is very intelligent and computer literate. At times he is very calm and serene, but he has a violent temper and has served time for attempted murder. He does not drink or smoke, and may be hidden now by one of his many girlfriends. He is originally from Trinidad, but does not have an accent. He has worked as a bouncer in Caribbean clubs and

as a security guard at a hospital. He has been know to buy cars, fix them up, then resell them. He may still be armed. Neverson is 38, 6'0" and 225 pounds. (See Show #684, OAD 7/27/02)

Loren Preston Key (Attempted Murder, Kidnapping, Carjacking) -- Loren Key shot two police officers and a civilian victim in an early morning rampage on Saturday, May 18, 2002. Shortly after midnight on May 18, Key kidnapped his girlfriend and her male friend at gunpoint. As Key was in the passenger seat, he threatened them at gunpoint. The male friend drove around town, following Key's directions, throughout the night. Around 2:00am, Key let his girlfriend out of the car at her home. Key and the male driver continued to drive around. Once free, Key's girlfriend called 911 to report the kidnapping. Police in the area searched for the automobile the two men were known to be driving. At around 8:15am, two police officers, one male and one female, found and pulled over the vehicle. Key came out of the car shooting. They say he first shot the male officer in his arm and hand and then turned and shot the female officer in her side. With both officers down, Key then fled on foot. Cops say that Key then cariacked a vehicle at gunpoint. As he attempted to drive the car away, the car stalled. Authorities say he abandoned the stalled vehicle and carjacked another male driver. Key shot the man in his neck, pulled him from the car and attempted to drive away in his vehicle. Key stalled that vehicle as well. This time he fled on foot. Key has not been seen since. Key has both ears pierced once. He is 32, 5'11" and 230 pounds. (See Show #677, OAD 5/25/02)

Lyndon Hale (Aggravated Sexual Assault)

Kerrie Evelyn Layman (Missing) — Hale was arrested on August 4, 1998 for the aggravated sexual assault of his two young daughters, who are now safe with their mother. A grand jury indicted him, but he was released on \$100,000 bond. Hale left the area before his court date, July 26, 1999. Police believe he left with his girlfriend, Kerrie Evelyn Layman. Hale had thinning hair at the time of his disappearance. His last known car was a 1997 green over gray over green Dodge pickup truck with a long, wide bed and Texas plates WF1308. Hale is 44, 6'1" and 185 pounds. Layman is 42, 4'11" and 240 pounds.

AMW ALL-POINTS BULLETIN:

Michele Denise Comstock (Manslaughter) -- Comstock was convicted in absentia on November 29, 1992 of manslaughter and DUI charges for ramming her car into a house and killing a 5-year-old boy. The night of the accident, Dawn and Steve Gunning went to bed around midnight, allowing their son Colin to sleep in a living room chair. That same night Comstock drank at least five cocktails and took methamphetamines. Comstock had several prior DUI convictions and several bars refused to serve her. Comstock left a bar around 1:00am and began

cruising south on North Fairview Avenue in Tucson. Moments later she lost control of the car and smashed into the living room of the Gunnings' home. Comstock left the car and ran home to call an attorney. Meanwhile, the Gunnings, awakened by the car's impact, found their son Collin pinned upside down beneath the car. The boy died later that night. Comstock, who has used the aliases Michele Ellis, Michele Sims, and Vicki Comstock, wears heavy black eye makeup and big earrings, and may be wearing a shoulder-length curly red wig. She dresses in jeans and t-shirts with bar logos, drinks Budweiser, gin and tonic, smokes Marlboro 100's, and uses marijuana and methamphetamines. She has worked as a bartender and as a waitress in bars, and has worked in fast food restaurants, but may also be working as a stripper. She knits or reads books when depressed, and may be driving a Cadillac Seville. Comstock is 39, 5'9" and 150 pounds. (See Shows #252, #299 and #349, OADs 1/22/93, 1/11/94 and 1/21/95)

Sarkis Peltekian (vehicular manslaughter, DUI) – On July 2, 1993 police say Peltekian, driving drunk, lost control of his car and smashed into a pickup truck carrying nine teenagers on their way home from the beach. The truck careened off a concrete overpass, fell 50 feet, and landed in a railroad yard. Seven teenagers died. Two survived with serious injuries. Peltekian was arrested, but released on bail within 48 hours. He immediately moved out of his apartment and disappeared. Sarkis has a scar on his back. He was born in Lebanon and speaks fluent Arabic. He wears fancy clothes, and has worked as an auto mechanic and tire and paint salesman. Investigators initially thought Peltekian might have returned to Lebanon, but they now suspect he is still in the U.S. because his daughter is now living with Peltekian's parents in Corona, California. Peltekian is 40, 5'8" and 200 pounds. (See Shows #455 and #603, OADs 6/21/97 and 9/9/00)

Martin C. Altamirano (Manslaughter) – On July 1, 2000 Altamirano was intoxicated and unlicenced when he crashed into a vehicle driven by 38-year-old Goretta Doyle, killing her and injuring her 8-year-old daughter. Altamirano was fleeing the scene of a minor car accident when he ran a red light a crashed into Doyle's car. Altamirano was taken to a nearby hospital where he was arrested and charged with him with driving while intoxicated. He was also issued a summons for driving without a license and driving an uninsured car. After Altamirano posted bail he fled and has not been seen since. Altamirano, who has used the name "Colorado", has a scar on his left cheek. He speaks Spanish and English, and works as a day laborer for construction companies. Altamirano is 23, 5'6" and 160 pounds.

Screening Report

The following are the featured fugitives and others being sought by federal, state or local authorities. The <u>Update</u> (if any) gives current status, previous references, or related information.

Jason Davis (Murder) – Davis killed David Ramirez after an argument over his friend's driving. On November 14, 2001, Ramirez and a friend were leaving a gala event held in honor of Chicago's Mayor Daley. Ramirez was included in the event because his father, a former Chicago police officer, had been one of Mayor Daley's bodyguards. Ramirez's friend was driving and as they tried to park outside of a bar, a pedestrian accused the driver of nearly hitting him. The man yelled and a brief fist-fight broke out. People on the street started throwing rocks and bricks at Ramirez and his friend. That's when Hector Flores asked for a gun from Davis and Mario Garcia. Davis got the gun. Ramirez tried to walk away from the situation. Once he was about 60 feet away, Garcia fired at Ramirez's back, striking him in the neck and killing him. Flores and Garcia are now in custody. Police suspect that Davis, Flores and Garcia have gang associations. The gun used in the murder was a Tech-9. Davis, who is Caucasian but may claim to be Hispanic, may be linked to an Hispanic gang. Davis is 20, 5'9" and 140 pounds.

Anthony Fu Yin Chang (Murder) – The United States Postal Service has issued a warrant for Anthony Chang for conspiring to mail a bomb disguised as a toy dog to Patrick Hsu, the younger brother of Chang's ex-wife, Wendy Hsu. The bomb exploded, killing Patrick Hsu almost instantly. The investigation led to Anthony Chang's friend David Lien who mailed the package from Milpitas, California while Anthony Chang was under house arrest with an electronic ankle control in Las Vegas. Lien is in custody and is awaiting trial for the same charges as Chang. The bombing ended the turbulent relationship between Anthony and Wendy, which had included domestic violence. They were briefly married, and when she filed for and got a divorce, the bomb was mailed within a month. Chang has several tattoos, including the Chinese symbol for Kamikaze inside his left forearm (a Chinese gang affiliation sign), a ying-

yang symbol topped by an eagle with "Anthony" above it on his right shoulder, the Chinese symbol for "Wendy" on his upper left chest and "Wendy" in English characters on his upper right chest. He likes motorcycles, has worked in a mechanic's shop, and had a maroon and cream Suzuki Marauder. He has very thick facial hair, very prominent eyebrows, and sometimes wears a goatee. He has a violent temper and has been known to hit people in public. He may be involved with cocaine and marijuana dealers. Chang is 32, 5'8" and 160 pounds.

Unknown Baton Rouge Serial Killer (Murder) – On September 24, 2001, Gina Wilson Green, 41, was strangled in her home. Then, on May 31, 2002 Charlotte Murray Pace, 22, was stabbed to death in her townhouse. On July 12, 2002, Pam Kinamore, 44, was taken from her home. Her body was found July 16 off Interstate 10. Her throat had been cut. On July 29, 2002 a press release announced that all three cases have been linked by DNA. There are no obvious threads to bind the three women together, but police say that their murders were committed by the same man. All three families are working together to find a link between the three victims, a clue that could lead to the serial killer. As of now, the only information released was that the man, aged 25-35, was wearing size 10 or 11 Rawlings tennis shoes during one of the murders. The suspect may be driving a white 1996 or 1997 Chevrolet pickup, may have had scratches or bruises on his face or body from the May 31st murder, and is probably able to lift about 175 pounds.

William Welch Attackers (Assault With A Deadly Weapon) – William Welch, also known as "The Messiah", was a 24-year-old rising star on the independent wrestling circuit. One day William was at home relaxing when two men walked in. Welch assumed they were his roommate's friends. But the two men jumped Welch. They cut his thumb off with gardening shears, hit him with dining room chairs, and slammed a fish bowl over his head. Welch fought off his attackers and they eventually fled, taking Welch's thumb with them. No one knows why these two men attacked Welch, but police believe that finding the attackers may provide all the answers they need. The first attacker was heavy set, had a beard, a chipped tooth, and squinty eyes. This suspect was wearing a hat. He is in his mid-20's and 200-230 pounds. The second attacker had a goatee at the time of the attack. He is in his mid-20's and 200-210 pounds.

Deandre Laprest Wilson (Murder) – On July 5, 2000, 71-year-old Edward Burton stopped at a house in Detroit, Michigan to pick up a co-worker. He honked his horn, prompting Deandre Wilson to tell him to stop. An argument ensued and Wilson reached into the car and hit Edward in the face. Then Wilson used a brick to shatter Edward's windshield. When Edward fled, Wilson followed, eventually catching and shooting him, while the only witness got away. Edward Burton died a short time later. On September 17, 2000, Wilson and a female accomplice went after the lone witness, opening fire in his home. While he didn't hit the intended target,

Wilson shot four people, killing one – the witness's daughter. On October 26, 2001 he was arrested in Indianapolis on drug and weapons charges, and for DUI. At the time of his arrest, Wilson stated that his name was James Thomas. He was released on bond before the fingerprint identification came back identifying him as Wilson. On May 2, 2002, Wilson was arrested in Des Moines, Iowa. (See Shows #611 and #674, OADs 11/18/00 and 5/4/02)

"Charlotte" (Unknown Deandre Wilson Accomplice) (Murder) — Agents in Detroit believe "Charlotte" is the unknown accomplice of Deandre Wilson. "Charlotte" was with Wilson as he forced his way into the home of an eyewitness to a murder and that "Charlotte" was an accessory in the shooting death of a 16-year-old girl and the wounding of several others. On July 5, 2000, 71-year-old Edward Burton stopped at a house in Detroit, Michigan to pick up a coworker. He honked his horn, prompting Deandre Wilson to tell him to stop. An argument ensued and Wilson reached into the car and hit Edward in the face. Then Wilson used a brick to shatter Edward's windshield. When Edward fled, Wilson followed, eventually catching and shooting him, while the only witness got away. Edward Burton died a short time later. On September 17, 2000, Wilson and a female accomplice went after the lone witness, opening fire in his home. While he didn't hit the intended target, Wilson shot four people, killing one — the witness's daughter. "Charlotte may wear glasses. She is in her 20's, of average height, and at least 175 pounds.

Claude Gayron Hayes (Child Molestation) – Hayes molested a young girl for two years from October 1, 1999-February 16, 2001. Hayes, who has used the alias Gary Hayes, is religious and affiliated with the Baptist Church, and has spent most of his life in small towns or rural areas. He has worked as a quality manager technician and a product analyst. Hayes is 51, 5'9" and 156 pounds.

Jose Jesus Jaimes Espinoza (Robbery, Carjacking, Attempted Robbery) – Espinoza was identified in a series of home invasion robberies committed between August 1995 and July 1996 in the northeast area of Los Angeles. He preyed on women with small children, or lone women. He would approach the victims outside their residences, force the victims into their homes, then lock the women in bathrooms or tie them with duct tape. He carried a variety of weapons such as handguns, shotguns and knives. He stole computers, electronic equipment, currency and jewelry, as well as frequently stealing his victims' cars. Occasionally he forced the women to load their own property into the vehicle. The invasions grew progressively more violent and cruel during his crime spree. None of the stolen property has been recovered. Espinoza has numerous aliases, including Luis Morales, Alfonso Lopez, Pancho Lopez, Jesse Prieto, Roberto Salas, Alfonzo Rivera Lopez, Jesus Salas, Jermon Jason Jones, and Jose Jesus Jaimes. He has an eye-shaped scar on his sternum and a large scar on his right arm. He has a very youthful appearance and has

passed as a juvenile while his girlfriend, Maria Menjivar, 20 years his senior, posed as his mother and presented false birth certificates to obtain Espinoza's release from custody. Espinoza is 27, 5'5" and 140 pounds.

Andrew Harold Eugene Smith, Jr. (Kidnapping) – Smith kidnapped 6-year-old Jonathan "Alex" Kiral. Smith, Kiral's mother's boyfriend, took the child at 8:30pm on August 25, 2002. Smith may or may not be Alex's biological father. Smith's three children from a previous marriage are believed to be traveling with the pair. Smith has threatened to harm all four of the children rather than give them up. Smith, who goes by the nicknames "Andy" and "Poppy", has bad acne scars on his face, a tattoo of a swastika on the inside of his left forearm and a tattoo of a part of an "A" on his upper arm. He is a supporter of the Aryan Nations groups, is probably carrying a gun, may have a mustache, and likes to wear black clothes and combat boots. He and the children may be staying in a homeless shelter, and he may be making the children panhandle on the streets. He may be working as a carpenter, construction worker, cable installer, or on a chicken farm in exchange for free rent. He frequents libraries to use e-mail, reads gun magazines, and frequents Western Union offices to receive money. He has prior convictions for robbery, battery and kidnapping. He may be traveling in a gray 1983 Chrysler New Yorker 5th Avenue with Indiana license plates 96Z 8325. Smith is 39, 6'1" and 190 pounds.

Mark William Samples (Bank Robbery) – Samples has been charged with the 2001 robbery of a Minnesota credit union, and he may be on the run with his son. On May 3, 2001, Samples entered the Red Wing Credit Union and robbed it, armed with a .45 caliber handgun. After robbing the bank, Samples attempted to make a getaway on a bicycle and then by donning scuba gear and hiding in the Mississippi River. He was eventually arrested and plead guilty to the bank robbery charges. However, when he learned his sentence would be five years, he withdrew his plea. Trial was set for September 4, 2002. On Friday, May 31, 2002 Samples picked up his son Christopher from his estranged wife's home, agreeing to return the child

Sunday morning. The pair vanished. Samples has the warrior figure "Genesis" tattooed on his right arm, and has a scar on his back. He is a perfectionist; everything has to be perfectly straight and clean. He shaves with an electric razor, never a blade. When he brushes his hair, he does so very harshly to the point where his scalp will become raw. He has taken Prozac, Interferon and other medication for Hepatitis C, which makes him nauseated and tired. He doesn't cook but prefers to eat fast food or sushi, and his weight fluctuates wildly. He had an apprenticeship to become an electrician, and has worked as a life guard. He has also worked as a phlebotomist, is very interested in veins and will talk extensively on the subject. He likes to camp, mountain climb, or anything outdoorsy and thrilling. He likes football, and the Green Bay Packers are his favorite team. He knowledgeable about computers and the internet, and probably has a laptop with him. He watches the Weather Channel often. He is a Navy veteran. He is probably carrying handguns and rifles, and has told his family that he wants to commit suicide. Samples is 39, 6'0" and 225 pounds.

Unknown Bison Dele, Serene Karlan and Bertrand Saldo Killer(s) (Murder) – Foul play is suspected in the disappearance of retired NBA player Bison Dele (formerly known as Brian Williams), 33, and his girlfriend Serena Karlan, 30, along with Bertrand Saldo, the captain of Dele's 55-foot catamaran, the Hakuna Matata. In early July the group planned to sail from Tahiti to Honolulu, Hawaii via the Tua Motu and Marquesas Islands. Dele's older brother, Miles Dabord, was also on the boat. The last known contact with Dele, Karlan and Saldo was in early July when Karlan left a telephone message at her parents' home saying "all is well". Prior to that call, Dele had been contacting his bank and Kevin "KP" Porter, his executive assistant in Michigan, once a month. After the others on the boat went missing, Miles Dabord was seen in Taravao, Tahiti, around July 19th, where he docked a boat and signed registrator papers using an alias. Two Tahitian residents told police that they drove Dabord 60 miles from Taravao to Papeete, Tahiti on July 20 to board a plane for Los Angeles. Miles Dabord was detained in Phoenix on September 5 after he allegedly signed receipts using his brother's former name, Brian Williams. Dabord tried to buy \$152,000 in gold bullion from a coin dealer in Phoenix using his missing brother's passport as identification. Dabord was taken into custody, but authorities released him, believing his story that he was trying to get the gold for his brother. On September 12, 1 boat in Taravao was identified by Saldo's girlfriend as the Hakuna Matata. It has been repainted, renamed the Aria Belle and had the old registration numbers scratched off. After the arrival of FBI agents, they assisted Tahitian detectives in an examination of Dele's boat, where they found a gun and bullet holes. Dele, Karlan and Saldo are now presumed dead - apparently the victims of a triple homicide. On September 14 the FBI tracked Miles Dabord to the Mexican border, where he apparently tried to commit suicide. Dabord was brought to a hospital in San Diego, barely clinging to life, ending the manhunt - but leaving the mystery of what happened on the boat unsolved. Bison Dele played NBA basketball with the Denver Nuggets, LA Clippers,

2997 NBA champion Chicago Bulls, and most recently with the Detroit Pistons from 1997-1999. Dele retired early, forfeiting \$36 million remaining in his contract and moved to Beruit, then Australia and New Zealand where he learned to sail.

John Evan Mizic (Escape, Fraud, Counterfeiting, Robbery)

Karen Mizic (Accessory After The Fact to Escape) – John Mizic has a long criminal history involving scams, robberies, and cocaine and heroine abuse. He was serving time for a 1998 scam in a Harrisburg, Pennsylvania jail when he met Karen, a mother of three children. She had a boyfriend in the same jail and got to know Mizic. Karen eventually dumped the boyfriend and got involved with Mizic. She married him in jail. From his cell, he was able to control Karen and her children, forcing them to wait for his call before they went out of the house. In March 2001 Mizic was transferred from jail to a halfway house in Harrisburg to complete his sentence. Mizic was a week away from being released when he escaped from the halfway house. On May 7, 2001 he received a weekend social pass from the halfway house to visit his wife, who was undergoing shoulder surgery. When he didn't return on May 9, 2001, Mizic was placed on escape status. The United States Marshals Service learned that Mizic packed up his wife's house and three children, along with computer equipment and one or two dogs, on the morning of May 9. The family took off and has been on the run ever since. USMS have traced the Mizic family to areas of Pennsylvania, Massachusetts, Florida and Virginia. Mizic is back to his old tricks: pulling a counterfeiting check scam. He steals checks in the mail, makes phony ones on his computer and cashes them in banks around the town he happens to be in. In one month he made off with nearly \$70,000. This is how he is able to stay on the run, take his family to Disney World, buy Thomas Kinkaid prints, jewelry and an SUV. His take is well over \$500,000. Authorities are concerned about his step-children's welfare. It doesn't appear they've lived in one town long enough for the children to attend school Mizic, who has used the aliases Jon, Daryl and David Mizic, Jon Misic, Jeffrey Hoffman and Edward Buchanan, has scars on both eyes and his right arm, a rose tattoo on his forearm and an unknown tattoo on his left thigh. He is known to wear pinky rings. Mizic is 46, 6'0" and 275 pounds. Karen Mizic, who has used the aliases Karen Sheeler and Karen Barnhart, has an unidentified tattoo on her chest. She is 35, 5'3" and 130 pounds. The pair may be traveling with the children in a 1994 Ford Bronco with Florida plates F83-LSU.

David Anthony Pike (Murder During Robbery) – On June 21, 1985 23-year-old Calvin Lee Irvin had gone over to Pike's home and spent several hours there with a group of friends. Around midnight, Irvin, Pike and a third man drove off in Pike's car. They bought some beer and started driving around town. Then Pike and his accomplice decided to rob Irvin. After they robbed him, they beat him and Pike shot him in the back. Irvin's body was found the next morning in a shallow ditch by the side of the road. The accomplice was arrested and jailed, but Pike fled after he was released on bond and hasn't been seen since. Pike, who has used the

aliases Phillip Pike and David Ogden, has scars on his right forearm, right biceps and both knees, a tattoo of a cross on his upper left arm, and an SS with skull and dagger tattooed on his right forearm. Pike is 41, 5'7" and 130 pounds.

Richard Steve Goldberg (Child Molestation) - Goldberg molested six young girls under the age of ten. He reportedly gained the trust of the neighborhood parents, then became a babysitter and "friend" to kids in the area. The single man set his home up in a way that would attract children. His backyard had swings and a cage with rabbits and ducks. Inside the house, Goldberg had children's computer games that he would allow them to use, kid's music, art supplies, and even children's soap. He would also take them to Disneyland, parks, lakes, etc. Goldberg was found out after two young girls playing on his computer saw an image of two of their young friends naked, including the next door neighbor. A full investigation was launched and six neighborhood kids reported being assaulted by Goldberg. Child pornography was found on his computer, including a photo of him having sex with children. After cops came in to search his house and took his computer away, Goldberg fled the area in late June. In early July, after finding evidence on the computer, police issued an arrest warrant for him. Authorities know he visited his parents in Rumson, New Jersey, shortly after running. There is evidence he was also in Las Vegas, and Bullhead City, Arizona. Goldberg's hair is jet black but would be gray if he didn't dye it. He has a receding hairline. He used to work at Boeing before being laid off. He likes outdoor activities and was the president of a gun and revolver club in Long Beach, California. Goldberg is 56, 6'0" and 160 pounds. (See Shows #665 and #680, OADs 2/16/02 and 6/15/02)

Loren John Trites (Illegal Wiretapping, Tampering With Evidence) – Trites is wanted for the 1997-1998 unauthorized videotaping of teenage females in a swimming locker room. Trites was the swim coach at Franklin and Marshall College in Lancaster, Pennsylvania. He was also the coach of a large competitive swimming club in the area. Trites filmed the girls on his swim team, ages 13-21, in various stages of undress in their locker room at F&M. Trites would climb up onto the ceiling ducts and hide cameras under towels to film the girls. On January 23, 1998 the female swimmers turned over a tape from a camera they found under a pile of dirty towels. Trites was interviewed by police, but invoked his Fifth Amendment rights. Before he could be questioned further, he withdrew money from a Philadelphia bank and fled. He was traced to Trinidad and then to New London, Connecticut, but both times Trites escaped. Police suspect that Trites is running from more than just these charges because he deserted his home, job, wife, and new car before he was even charged with the crimes. Trites, who was going through a divorce at the time he fled, is an unassuming and otherwise law-abiding person who likes the finer things in life, including nice SUV's and drove a new Lincoln Navigator prior to the incident. He sometimes changes his appearance with a beard and/or mustache. Trites is 40, 6'7-6'8" and 290-300 pounds. (See Shows #630 and #659, OADs 4/28/01 and 1/5/02)

Andrew Harold Eugene Smith, Jr., Kiral's mother's boyfriend, took Alex at 8:30pm on August 25, 2002. Smith may or may not be Alex's biological father. Smith's three children from a previous marriage are believed to be traveling with the pair. Smith has threatened to harm all four of the children rather than give them up. Alex has a small freckle on his forehead, a small birthmark on his back, and a dimple on his left cheek. His hair has a "rattail". He has never been in school. He has asthma and needs medication.

Christopher William Samples

Age: 3 Height: 3'6"

Weight: 34 pounds

On May 3, 2001, Mark William Samples entered the Red Wing Credit Union and robbed it, armed with a .45 caliber handgun. After robbing the bank, Samples attempted to make a getaway on a bicycle and then by donning scuba gear and hiding in the Mississippi River. He was eventually arrested and plead guilty to the bank robbery charges. However, when he learned his sentence would be five years, he withdrew his plea. Trial was set for September 4, 2002. On Friday, May 31, 2002 Samples picked up his son Christopher from his estranged wife's home, agreeing to return the child Sunday morning. The pair vanished. Christopher has a scar on his left cheek, discolorations on his neck, and a gap between his two top front teeth. He is sometimes referred to as Thomas Samples, because he loves Thomas the Train, or Chrissy Samples. He is outgoing, likes hugs, and is a very hands-on child who likes to color or draw rather than sit and watch TV.

Ashani Creighton

Age: 10

Ashani Creighton was discovered missing when police arrested her grandparents Ernest and Kaia Jackson in Tulsa, Oklahoma on Monday, October 2, 2000. Ashani Creighton was last seen in Orlando, Florida with her grandparents in 1998. Ashani's mother knows nothing of her whereabouts. Ashani's grandparents are currently in police custody and are facing charges of child abuse. Elizabeth Smart

Age: 14 Height: 5'6"

Weight: 105 pounds

On Wednesday, June 5, 2002, Elizabeth Smart was abducted at gunpoint from her Federal Heights home. At about 1:00am a man cut the screen and crawled through the kitchen window. He then went to the bedroom shared by Elizabeth and her 9-year-old sister. He took Elizabeth out of the house at gunpoint after he allowed her to grab her shoes. He threatened to harm the 9-year-old sister if she told the police what happened. Two hours after the abduction, Elizabeth's sister told her parents what had happened. There is no evidence of a vehicle, and it appears they left on foot. Police are looking for a male believed to be in his 30's or 40's. He is about 5'8" with a medium build. The suspect has dark hair and was seen wearing a tan or white jacket with a white cap. The police have extended their search beyond Utah to Idaho and Wyoming. Jennifer Renee Short

Age: 9 Height: 4'3"

Weight: 58 pounds

Jennifer Short and her family lived in Bassett, Virginia, along a manor interstate, Route 220, just 35 miles south of Roanoke. Jennifer has been missing since Wednesday, August 14, 2002. It wasn't until Thursday morning that a co-worker of Jennifer's parents stopped by the Shorts' house early Thursday morning and discovered Mary and Michael Shorts' dead bodies. When cops arrived at the scene they determined that there had been a struggle in Jennifer's bedroom and that her parents had been killed with a single gunshot to the head each. There was no sign of Jennifer in the house, and investigators are convinced that she was abducted by her parents' killer(s). There are no suspects yet, but authorities believe that the Shorts probably knew their attacker. The family recently put their house on the market and investigators are looking closely

at their realtor's records of who came through the house during the last few weeks. Michael Short worked as a mobile home mover. Business hadn't been good, and he was planning to move the family out of their home in western Virginia and into a mobile home. Jennifer is described as friendly and talkative. There were signs of a struggle in Jennifer's bedroom. (See Shows #687 and #688, OADs 8/17/02 and 8/24/02)
