*The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.*

**David Lee Kemp** (Murder) – On August 5, 1998 Tina Cremer Kemp divorced her husband of five years, David Kemp. Six days later she was dead, along with her new boyfriend, Robert Miller. The couple was shot in Rob Miller's apartment. Rob was in the kitchen; Tina was in the shower. All evidence pointed towards David Kemp, but before cops could question him he skipped town. Thirteen days later cops found him in Bishop, California. Kemp engaged them in a two-hour stand-off and demanded to talk to his mother. After cops lowered a cell phone behind a fence, Kemp talked to his mother for a bit before he was taken down with non-lethal beanbag shots. He was taken into custody and flown back to Lawton, Oklahoma to face the music in the Comanche County Jail. On March 11, 1999 a jail trustee stole a barbecue fork from the kitchen and pulled it on the one guard on duty that night. He locked the guard in a cell and unlocked several other inmates. Nine inmates escaped. Eight were recovered. The only one still missing is David Kemp. The last official sighting of David Kemp was in June of 1999. He was checked into the Vista Motel and, by all accounts, he was an ideal tenant. He kept to himself and always paid his rent on time. But one day he didn't pay his rent and the night manager came calling. He found Kemp had barricaded himself into the bathroom. The manager knocked down the door and Kemp was lying in the bathtub with a knife on his stomach and covered with blood. It looked like Kemp had tried to kill himself, but when the doctors examined his wounds, they found they were only superficial cuts. He did get out of paying his rent, however. He was last seen getting into his brother's black Firebird at a gas station on the outskirts of Las Vegas. Kemp should be considered armed, dangerous, and extremely unstable. Kemp has used the aliases Ian Melancon and David Glover. He has scars on his wrists from a failed suicide attempt. He always wears a baseball cap, and likes hot rod and matchbox cars. He has been known to work as a janitor, carpenter, and oil rigger. Kemp is 34, 6'3" and 200 pounds. (See Shows #557,

**Rufino Castaneda (Rape)** – It all began the evening of November 1, 2000 at a strip mall pub in Mishawaka, Indiana. “Tiffany” was taken by force away from the bar. Two men kidnapped her, put her into a car and began driving away from the scene. Authorities haven’t yet identified the driver. Rufino Castaneda sat in the back of the car, restraining and hitting “Tiffany”. They drove “Tiffany” to Castaneda’s ex-girlfriend’s home. The driver left, but Castaneda pulled “Tiffany” into the home. Once inside, Castaneda sexually assaulted “Tiffany” and physically attacked her repeatedly. “Tiffany” fought back and escaped, probably saving her own life. When they arrived on the scene, “Tiffany”, clothed only in a cardboard box, led them to the home where she had been attacked. Further investigation linked Castaneda to the scene and he was charged with the crime. Castaneda fled immediately. He was last seen the day before the attack at his job in Bremen, Indiana. He abruptly quit his factory job. He hasn’t been seen since. Castaneda, who has used the alias Rufino Castaneda Nova and goes by the nicknames Alejandro, Alex and Rufo, has noticeably acne scarring on his face and may also have an arrow-shaped scar on his face. He is a Mexican national who speaks English poorly, smokes marijuana, and may be working as a day laborer. Castaneda is 29, 5’6” and 150 pounds. **Malaika Tamu Griffin (Murder)** – Malaika Tamu Griffin is wanted for the murder of 25-year-old Jason Horsely. In the winter/spring of 1999, Griffin was renting a room in a house next door to Jason and his girlfriend, Deborah Loiselle. On April 20, 1999, Deborah had her first encounter with Griffin as the two women were standing in their front yards separated by a fence. Deborah says Griffin, whom she’d never seen nor met before that day, immediately threatened to kill her dogs and began cursing and hurling racial slurs. Jason and Deborah are Caucasian; Griffin is African-American. Over the next 28 days, Griffin had several other run-ins with Jason and Deborah that they say she initiated over parking on the public street and Jason unloading his tools on the public sidewalk in front of her house. None of the arguments made any sense to Jason and Deborah because they insist they never trespassed on her property and the parking spaces should have never been a matter of dispute because Griffin didn’t even own a car. Hers had been repossessed. On the evening of May 18, 1999, Jason was organizing his carpentry tools on the sidewalk in front of Griffin’s house when she came outside and began screaming at him. Deborah heard the commotion and came out of her house to stick up for Jason. After a brief but intense argument, both women stormed back into their respective homes and Jason continued organizing his tools. Griffin came back outside minutes later armed with a laser-sighted 9mm pistol and shot Jason in the back at point-blank range. He never saw her coming. The bullet pierced Jason’s heart and killed him almost instantly. Then, Griffin ran to the home of an acquaintance, Monique Thomas, and carjacked her at gunpoint. Griffin abandoned the car in Iowa and hopped a bus to Chicago where her trail went cold. When police searched Griffin’s room in Denver, they were shocked to find a stockpile of ammunition, diffused hand grenades, a 9mm assault rifle and books commonly associated with terrorists, *The Anarchists’ Cookbook* and *The Poor Man’s James Bond*. They also found spiral notebooks full of Griffin’s secret writings about a coming race war and the killing of white people. None of her colleagues or close friends

ever heard her express the types of racist rhetoric she wrote about in her notebooks. Griffin is a world-traveled lady with a Magna Cum Laude degree in chemistry. She has worked in laboratories and a pharmacy in the past. Griffin is an avid outdoorswoman and survivalist who buys top of the line camping gear and firearms. She has bad credit and declared bankruptcy in 1999. She doesn't smoke, but may drink occasionally. She prefers going to museums to clubs or other nightlife. She usually carries a backpack wherever she goes. Griffin is 32, 5'4" and 145 pounds. (See Shows #575, #599, #646 and, #726, OADs 2/5/00, 8/12/00, 8/25/01 and 7/12/03)

**William Peter Fischer (Murder)** -- Billy Fischer met Nancy Hyer on a Manhattan-bound train and opened up his life to her. Nancy soon found that the polite young man sitting next to her suffered from cystic fibrosis - he had been sick most of his life. During this time, he was abandoned by uncaring parents and left to drift from one foster home and group home to the next. The only caring family Billy had was his brother Jayson, who lived in separate foster homes while they grew up. The brothers saw each other as often as they could, and Jayson would fill Billy in on their absent and unpredictable father, William Peter Fischer. Ten years after he abandoned his two sons to foster homes, Fischer remarried and suddenly took a renewed interest in the boys. Jayson maintains that this surge of fatherly love was hollow and motivated by a desire to look better in the eyes of his new wife's family. But the Fischer family reunion was short-lived. Jayson says that his father was deep in the throes of a crack habit and that made his behavior erratic and hot-tempered. The boys decided they would be better off on their own. For four years, Billy refused to talk to his father, but on a trip to New York to see Jayson, he learned that Fischer was willing to see him. Billy's health had taken a turn for the worse, and when he arrived at his father's home in Southampton he found a suddenly supportive father. Billy now found a father ready to pay for his medical bills - which had already piled up on Fischer's doorstep - and even ready to buy him a car. But, police say, this was all just a ruse to put Billy off his guard. Nancy, the woman Billy met on the train, was moved by Billy's story and wanted to see him again. She called him at Fischer's Southampton home and arranged to meet him at 8:00 p.m. on December 11, 1986. It turned out to be her date with destiny. Nine days later, police found her body and Billy's in her abandoned car at the Southampton Elks Club. Billy had been shot 18 times, and Nancy had been stripped of her clothing and stabbed in the chest and abdomen. Serving a search warrant on Fischer's home, police say they discovered three bullets lodged in the wall that matched those that had killed Billy. And with the blood-detecting chemical Luminol, they discovered blood traces throughout the house - even in the vacuum cleaner. Fischer, meanwhile, was in the process of getting a second mortgage on his house. When a grand jury indicted him for murder, he had already left with \$60,000 in his pocket. His car was discovered at New York's Kennedy Airport on February 27, 1987. Fischer has a tracheotomy scar on his throat and a receding hairline. He is a fancy dresser and very flirtatious - he reportedly engages in "kinky" sex with multiple partners. He is a heavy drinker, a suspected crack cocaine user, and a smoker. He is a heavy antacid user and may have stomach problems. He has worked as an auto dealer. Fischer is 59, 5'11" and 180-200 pounds. **Vuthy Woodward Sok (Grand Theft)** -- On June 7, 2000, Javier Saucedo was working his usual schedule with Vuthy Woodward Sok for an armored truck company. After making

twelve stops, Sok told Saucedo he had left a key at an earlier location. The suspect insisted on going back right away and offered to drive the armored truck back to the location. Sok asked Saucedo to go inside and get the key while he caught up on his paperwork. Inside, an employee told Saucedo they had not left the key there. When Saucedo got back into view of the truck, he noticed the messenger door was open and that Sok was outside, which is against company policy. Saucedo then saw that moneybags were thrown on the ground outside the truck, and asked what Sok was doing. Sok said that he needed money and asked if Saucedo wanted to be a part of it. Fearing for his safety, Saucedo said yes. Then Sok suggested that they shoot up the truck. Saucedo made the excuse that he wanted to go back inside and get the key before they took the money. Sok exited the truck, closing the door behind him, and was dragging off a large plastic bag of money containing \$744,628. Saucedo pulled his weapon and ordered Sok to halt and put his hands up. Sok looked over his shoulder and kept going. Saucedo yelled for someone to call 911, and report that he was being robbed. Sok then got away in a car with two unidentified individuals. Sok is a former LAPD officer who is described as a compulsive gambler. He is very flirtatious with women. Sok is 31, 5'8" and 160 pounds. (See Shows #599, #646 and #726, OADs 8/12/00, 8/25/01 and 7/12/03)

**Jose Luis Quiroz (Sexual Assault)** -- On August 3, 2003, Jose Luis Quiroz and three other individuals raped a mentally challenged 16-year-old girl. The men allegedly picked up the girl from outside of an apartment complex where she had been roller blading and asked her to come for a ride in the car. The men brought her to a local motel, where they raped her. The assailants released the girl and gave her \$20.00 bribe to ensure her silence. Quiroz is the only individual that has not been apprehended. Quiroz has worked as a landscaper and uses the aliases Jose Luis Quiroz-Pernillo and Jose Luis Quiros. Quiroz is 31, 5'6" and 165 pounds.

#### **Georgina "Gina" DeJesus**

Age: 14

Height: 5'1"

Weight: 135 pounds

On Friday, April 2, 2004, 14-year-old Georgina "Gina" DeJesus disappeared as she was walking home from school. Gina left Wilbur Wright Middle School around 2:30 p.m. and headed home, but she never arrived. When her mother got home and realized her daughter never returned from school, she called police. Police say witness last saw Gina at the corner of 105th Street and Lorain Avenue. She was wearing black pants, a white shirt and a powder blue, hooded jacket. Police have no leads or suspects. Police are treating Gina's disappearance as a missing persons case. Friends and family say she was a happy girl and would never have run away. Police want to talk with a man seen driving along Lorain Avenue in the area where Gina disappeared. The man is described as Hispanic, driving a light-colored, older-model compact car with a license plate that includes the letters SMS. Police are not calling this man a suspect, but he and his car have been described by multiple witnesses. On April 21, 2003, 17-year-old Amanda Berry went

missing just six blocks from where Gina was last seen. Police have no reason to believe that the two cases are connected, but they're not ruling anything out at this time. Gina is Hispanic. She has a light brown birthmark on her right leg and her right ear is pierced at the top and the bottom.

### **Amanda Berry**

Age: 17

Height: 5'1"

Weight: 110 pounds

On April 21, 2003, Amanda Berry left her job at Burger King and has not been seen since. One week after Amanda's disappearance, her family received a mysterious phone call from an unidentified man. He claimed that he had Amanda and that she would be returned home in a couple of days. Amanda was planning on having a party to celebrate her 17<sup>th</sup> birthday on April 22<sup>nd</sup>. Amanda loves shopping, talking on the phone and listening to Eminem. She was last seen wearing a Burger King uniform. Amanda has a scar on her lower abdomen, a double piercing in her ear and a pierced left eyebrow. (See Show #741, OAD 11/15/03)

**Douglas Aigen** (Aggravated Assault on a Police Officer) -- Doug Aigen has a long rap sheet and doesn't want to go back to prison. His crimes range from forgery and theft to assault of a police officer and kidnapping. In 1992, Aigen kidnapped a woman in a parking lot and put her in the trunk of her car as he drove around using her ATM card. He released the victim and later was convicted of kidnapping charges and robbery. He was sentenced to fifteen years in a New Jersey prison. After his release in 2002, Aigen assaulted a police officer. On October 25, 2002, Aigen was trying to steal a load of batteries from a truck. Aigen bit and punched the officer, then fled. On January 10, 2003 Aigen attempted to steal a tractor trailer from a New Jersey truck company. Employees spotted him and tried to stop him by placing a pickup truck in front of the stolen tractor. Aigen rammed the pickup and led police on a chase on the New Jersey Turnpike and Route 78 in Newark. At one point during the pursuit, Aigen came to a complete stop with a trooper car right behind him. Instead of getting out of the tractor, Aigen put his truck in reverse and rammed the police car before fleeing. No one was injured. Since then, detectives in New Jersey and New York believe Aigen has been stealing tractors and trailers. Aigen sells the merchandise inside the trailers on the streets of New York and pockets the cash. They believe he won't go down without a fight. Aigen, who has used the aliases Doug Ailen, Douglas Reed Aigen and Douglas Robert Aigen, has "Leslie" tattooed on his right hip. He has a crack habit and must steal to survive. He may suffer from depression, and his family is afraid of him. Aigen is 38, 6'2" and 350 pounds. (See Shows #735, #747 and #758, OADs 9/13/03, 1/03/04 and 3/27/04) An AMW tipster informed authorities that Aigen, who used the alias Sam Kingsfinger, did some handy work for her in Franklin New Jersey before he stole \$1000 and her white 1998 Ford F-150 (with ladder racks, black bed liner and a third door. Aigen is completely bald and reportedly wears a University of Michigan baseball cap- he likes to wear it backwards. He has gained a considerable amount of weight. Aigen can't fit into a regular pants any longer so

he wears sweatpants. He might still be driving the 1998 Ford F-150 with New Jersey plates X9758K.

**Michael J. Coppola (Murder)**-- In the early morning hours of Easter Sunday, 1997, John "Johnny Cokes" Lardiere was murdered gangland style outside a hotel in Bridgewater, New Jersey. Police knew Lardiere was a member of the Genovese crime family but it would take almost twenty years for them to get a break in the case. That break came in 1996 when another mobster who had been arrested on murder and extortion decided to cooperate with authorities. The mobster told police that Lardiere's killer was Michael Coppola, who was now a top man in the Genovese organization. However, authorities knew they had little weight with the testimony of their informant so they decided to take another look at the evidence. That's when they realized that hair samples had been preserved from a hat found at the scene of the crime. The hair was sent to the FBI lab in Quantico, Virginia where DNA was successfully extracted. A judge then gave a court order for Michael Coppola to provide saliva samples on August 8, 1996. Michael Coppola never showed for his scheduled date. He has since been charged with the murder of John Lardiere. Coppola, who has used the nicknames Mikey Cigars, Filma and Little Mike, is a workout enthusiast who runs and cycles. He is very fit and muscular for his age, and as an avid golfer may be living in a warm climate. He is known to gamble. He has a thick New Jersey Accent, is well groomed and extremely neat, and may smoke a cigar occasionally. Coppola is 57, 5'7" and 160 pounds. (See Shows #697 and #724, OADs 11/16/02 and 6/21/03)

**Unknown O.C. Smith Attacker (Attempted Murder)** -- On June 1, 2002, Dr. O.C. Smith, the Shelby County Medical Examiner, was attacked. Smith left his office shortly after 10:00pm. As Smith exited the building, a man ambushed him, throwing some kind of chemical in his face, which burned Smith's skin and temporarily blinded him. Dr. Smith was beaten and thrown down a nearby stairwell. The attacker then wrapped Dr. Smith in barbed wire and chained him to a window gate. Before the attacker fled the scene, he placed a bomb on Dr. Smith's chest. Dr. Smith stood motionless for more than two hours before a patrol officer found him. Three letters threatening Dr. Smith were sent to three different people in Memphis in April 2001. The reason for the threats stems from Dr. Smith's testimony in a clemency hearing for a convicted cop killer, Philip Workman. In March 2002 police discovered a bomb outside Dr. Smith's office. The man who attacked Dr. Smith is the same person who wrote the letters and planted the bomb in March. The suspect has fair skin, is not fat, but has "chunky cheeks", and may have cuts on his arms or body from the barbed wire. He knows how to make homemade explosives. He may be staying in homeless shelters and may change jobs frequently. He may write or use the phrase "JMJ". He may be extremely religious, possibly Catholic, frequently talk about religion and may talk about hearing messages from God. He may refer to the bible passage John 15:13, and may use the phrase "steel in the hand of the king of kings". He may be vocal about abortion. Dr. Smith's attacker is 30-40, 5'10"-6'2" and 180 pounds. (See Show #681, OAD 6/22/02) Authorities believe that evidence related to the incident suggests that Dr. Smith may have been involved.

**James Joseph "Whitey" Bulger** (Racketeering and Extortion) -- In the tough working-class neighborhood of "Southie," just south of Boston, locals say that a young man growing up there has only two career choices: the priesthood or the law. One of the Bulger brothers went on to make laws, becoming the President of the Massachusetts State Senate and holding the post for eighteen years. The other, who became known as Whitey Bulger, went on to break laws, becoming the boss of the ruthless Irish Winter Hill Gang. Police say that Whitey had his fingers in every drug deal and illegal bet in Southie, swiftly becoming respected, even legendary, in the Boston underworld. Authorities claim that he was able to consolidate power through an historic truce with the Italian Mafia in Boston, whereby they respected each other's boundaries, and even collaborated on their nefarious schemes. The Massachusetts State Police were determined to get Whitey behind bars. But every time they got an authorized wire tap, every time they set up surveillance, Whitey dodged their net. It was almost as if he knew.... On January 10, 1995, the federal grand jury handed up a RICO indictment with Whitey's name on it. True to form, Whitey was ahead of the law, and disappeared from sight. However, the indictment netted five other members of the Irish Winter Hill Gang, including Whitey's top lieutenant, Steve "The Rifleman" Flemmi. What Flemmi had to say shocked everyone, gangsters and law enforcement alike. Flemmi claimed that both he and Whitey were actually government informants, leaking information to the FBI on their supposed partners in the Italian Mafia for nearly 30 years. He even claimed that they had been tipped by the Feds before the indictments came down, allowing Whitey to make a clean getaway. Legal hearings will determine whether Flemmi's allegations are true, and whether Flemmi and Whitey's alleged informant status makes them immune from prosecution. When the FBI indicted Bulger, Catherine Greig, his mistress, joined him on the road as they traveled as any retired couple through the historic sites and Indian reservations of the United States. So strong was her dedication to the suspected underworld mastermind that she abandoned her pet poodles and extensive collection of Hummell figures. Authorities now know that one of Whitey's stops was the quiet Louisiana enclave of Grand Isle. No one in this tight-knit community suspected that Whitey was a northeastern mob boss as he came and went Greig, paying for his rental cottage in crisp \$100 bills. Posing as "Uncle Tom and Aunt Helen," they seemed to blend right in. But now Uncle Tom and Aunt Helen have disappeared and the hunt is still on for Whitey Bulger and Catherine Greig. Police have traced the couple to Sheridan, Wyoming; San Francisco; Gulfport, Mississippi; and Selden and Holtsville, New York. The trail has been cold since July 1996. Bulger has a medium athletic build and often wears a baseball cap and sunglasses. He takes daily walks of 5-6 miles, and is take the heart medication Atenolol. Bulger drives large luxury sedans and likes making purchases with \$100 bills. He has served time for several bank robberies. Bulger has used the aliases and nicknames Jimmy, Jimmy-Boy, Jimmy Blue-Eyes, Thomas F. Baxter, Tom Harris and Mark Shapeton. He may still be traveling with his girlfriend Katherine Greig and he may be taking medicine for a heart condition. Bulger is 74, 5'8" and 150-160 pounds. **Dion Koglin** (Criminal Sexual Conduct) --Dion Koglin is wanted by the Clinton police for Criminal Sexual Conduct of the 1st degree. Koglin has a criminal record dating back to

1995, when he served as a Police Cadet at the City of Livonia Department of Public Safety. According to police, a female accused him of sexual harassment while he was on the job, and shortly after, Koglin resigned. They say he was also a suspect in an Assault and Battery case involving a woman at a local bar. On April 26, 1997, Koglin allegedly held a prostitute at gunpoint in his car, claiming he was a law enforcement officer, and drove her to his girlfriend's parents' house where he raped her. Afterwards, he took the woman to a neighboring town and pushed her out of the car, forcing her to fend for herself. The prostitute called police, who responded quickly and found Koglin's vehicle. As they closed in on Koglin, he began to flee. Police followed him until he pulled over and began to run. A dramatic foot chase ensued, but in the end, cops caught up to him and recovered the gun. Police say Koglin's parents posted bond, and he has been on the run ever since. Authorities believe he may be in close contact with his brother in the Chicago area. Koglin lifts weights on a regular basis and is described by authorities as a cocaine user who has a violent temper. Koglin is 36, 6'0" and 195 pounds.

**Unknown Carol Miller Killer(s) (Murder) – Las Vegas, NV** - Authorities are looking for the killer(s) who strangled and robbed Carol Miller. Carol Miller, 58, was last seen about 5 p.m. on Saturday, February 1, 2003, leaving her home in the gated community near Fort Apache Road and Sahara Avenue in the Canyon Gate subdivision of Summerlin. When Carol hadn't come home later in the evening, her husband, Doug Miller, started to get concerned, drove around the area, and called neighbors, hospitals and the coroner's office. But no one had seen or heard from her. On February 3, 2003, construction workers found Carol's body by the roadside, in an area partially littered with illegal dumping, near Interstate 215 and Far Hills Drive. Detectives said that the body was found wrapped up. Authorities said that Carol had been strangled and was robbed of her necklace and other jewelry. She was wearing glasses, a black nylon jogging suit, sneakers and several gold rings, a white gold necklace with black lapis stones and a small gold women's Rolex watch. Carol is described as 5'2", 170 pounds, brown eyes and frosted blond hair. Detectives would like to speak to anyone having seen Carol on her walk on February 1, 2003 to help them establish a timeline leading up to her murder.

It turned out that Robert Saylor was the man they were looking for but he was subsequently cleared as a suspect. After seeing AMW, another person who was at the supermarket the night Valdizan disappeared claims that he saw a man watching and waiting for her. He helped investigators make a sketch of the man. **Donald Crosby** (Assault, Criminal Deviate Conduct) -- Police in Indianapolis, IN are looking for Donald Crosby, who is wanted for sexually assaulting a nurse in training. Crosby used his brother's name, Preston Crosby, to get a job at Wishard Hospital in Indianapolis, IN. Crosby was working there as a supply clerk. Police say that on September 20, 2003, after three months on the job, Crosby finally convinced a nurse in training to go to lunch with him. Crosby told the woman he had to pick up something from a supply room before he could go. Once they

were inside the room, Crosby began to attack the nurse. She tried to get out of the supply room, but Crosby pushed her against some boxes and violently attacked her. Crosby was arrested and released from jail on bond. He is now on the run and may be traveling with his girlfriend. Police say Crosby has a long criminal history and could be dangerous. Crosby is 36, 5'10" and 220 pounds.

**Cuitlahuac Tahua "Tao" Rivera (Murder)** -- The Merced County Sheriff's Office and Merced Police Department are conducting an aggressive multi-agency manhunt for murder suspect Cuitlahuac Tahua "Tao" Rivera, who is wanted for the killing of Merced Police Officer Stephan Gray. Authorities say that on the evening of Thursday, April 15, 2004, Officer Stephan Gray, 34, was performing a routine traffic stop at about 7:30 p.m. near the intersection of East 19th Street and Glen Avenue in Merced. Witnesses say that the officer had pulled over a Geo Metro and was talking to the driver for a while. According to the witnesses, Gray made contact with a male passenger and began to search the vehicle. The passenger, Rivera, 21, then started to run and Officer Gray pursued Rivera on foot. Rivera spun around and fired an unknown caliber gun during the chase and struck Gray twice. Gray was hit in the chest, just above his body armor and later died at Mercy Medical Center in Merced. Rivera was reportedly seen the day after the murder with his mother, Erika Rivera, 43, at an apartment complex in Merced on Friday, April 16, 2004. Erika Rivera was arrested on Saturday, April 17, 2004 and booked on felony charges of aiding and abetting a criminal and being an accessory to a crime for helping her son. Tahua, who uses the nicknames "Tao" and "Bullet," has a large tattoo of the letter "M" on his stomach, a "MGC" tattoo on his right forearm and "2DAS" on his left forearm, the number "3" on his right fingers and large undetermined tattoos on both shoulders. Rivera has a criminal past dating back to October of 2000 and is considered armed and dangerous. Rivera is 21, 5'8" and 190 pounds.

**John Evan Mizic (Escape, Fraud, Counterfeiting, Robbery)**

The family took off and has been on the run ever since. USMS have traced the Mizic family to areas of Pennsylvania, Massachusetts, Florida and Virginia.

Mizic is back to his old tricks: pulling a counterfeiting check scam. He steals checks in the mail, makes phony ones on his computer and cashes them in banks around the town he happens to be in. In one month he made off with nearly \$70,000. This is how he is able to stay on the run, take his family to Disney World, buy Thomas Kinkaid prints, jewelry and an SUV. His take is well

over \$500,000. Authorities are concerned about his step-children's welfare. It doesn't appear they've lived in one town long enough for the children to attend school. Mizic, who has used the aliases Jon, Daryl and David Mizic, Jon Misic, Jeffrey Hoffman, Otis Jackson, Victor Gallo, Anthony Eugene Jones and Edward Buchanan, has scars on both eyes and his right arm, a rose tattoo or an eagle on his forearm and an unknown tattoo on his left thigh. He is known to wear pinky rings. He appears to have gained a considerable amount of weight. Mizic is 47, 6'0" and 280-310 pounds. Karen Mizic, who has used the aliases Karen Sheeler and Karen Barnhart, has an unidentified tattoo on her chest. She is 37, 5'3" and 130 pounds. The pair may be traveling with the children in a 1994 Ford Bronco with Florida plates F83-LSU or a 1999 Burgundy Dodge conversion van. **Riverside Armored Car Killer/Robber** (Murder, Armed Robbery) -- The FBI and police departments in Riverside, CA and Dallas, TX are looking for the suspects in three armed robberies, one of which resulted in the murder of an armored car driver. On January 8, 2004, Corey Medlock, a Brink's armored car driver, was shot and killed while delivering cash to a Food-4-Less supermarket in Riverside, CA. The suspect escaped through an emergency exit in the rear of the Riverside store. The suspect fled the crime scene in a red 2002 Ford Taurus. The FBI believes the Riverside killer may be the same man as the robber of another armored car in Dallas, TX. Exactly one month before the Riverside hold-up, on the morning of December 8, 2003, a suspect armed with a semi-automatic pistol is clearly seen on video surveillance tape entering the Fiesta grocery store in Dallas, Texas. Wearing gloves and what appeared to be a dark wig, the suspect laid in wait for the Loomis Fargo driver to arrive with his cash delivery. As soon as the suspect spotted the driver, he approached him and brandished a gun. The suspect ordered the driver to remove his glasses, then sprayed him in the face with pepper spray, grabbed the driver's satchel containing an undisclosed amount of cash and exited the rear of the store. Police say the Riverside murder suspect bears a striking resemblance to the Dallas robber and that similar disguises were used in both cases (a dark wig, hat, light beard and goatee). In both instances, the suspect escaped through an emergency exit in the rear of the store. On the afternoon of April 19, 2004, police believe the same suspect from Dallas and Riverside struck again in San Antonio, TX. The suspect entered a H-E-B grocery store armed with a handgun, approached the armored car driver wearing a *white* wig and baseball cap, demanded the bag of money, pepper sprayed the driver and fled the scene in a white Ford Econoline van. This suspect is a white male. He is 30-40, 5'10"-6'10" and appears to be bow legged. He has a medium to heavy build, dark long hair, a full mustache and sometimes a beard. He usually wears a woman's wig and a cap.

**Othmaro Orellana** (Person of Interest in a Quadruple Murder) – Detectives in Missouri would like to speak to Othmaro Orellana to find out what, if any, involvement he has in a 2004 quadruple murder. On Monday, April 26, 2004, KCMO police were called to a house with the report of four dead bodies. The victims were identified as a 22-year-old man, a 21-year-old woman, a two-year-old boy and a one-year-old girl. Detectives learned that the dead were a woman, her brother and the woman's two children. Othmaro Orellana is the children's father and the deceased woman's estranged husband. He disappeared right after the murders. Cops do not know if he's involved in the murders and they have not charged him in connection with the crime. Orellana may be driving a green 1995 Mazda 626, bearing Missouri plates 839-WGN. Orellana, who goes by the name Omar, has connections to Arkansas and El Salvador. He likes to play soccer and has worked in the fire and water damage restoration business as well as construction. Orellana is 25, 5'5" and 135 pounds.

**Tracey Boyce** (Murder) -- Detectives in New York City are looking for Tracey Boyce, a failed rapper who allegedly shot and killed his producer in a Bedford-Stuyvesant recording studio. Tracey Boyce, 30, who rapped under the moniker "Sha Danger," shot and killed James "County" Green, 45, at his Hilltop Studios on Quincy Street over a dispute about rent money. Boyce had been renting a room in the basement of the studio for \$125.00 a month. In April 2003, friends say Green asked Boyce to leave because he had not paid rent for some time. Boyce left for a few weeks only to return on May 14, 2003. Detectives say Boyce shot Green two days later. The NYPD has been looking for Boyce ever since. Boyce, who uses the nicknames "Flipster" and "Snuff," is known to deal and smoke marijuana. Police believe he may steal identities, and money, by lifting wallets. Acquaintances say he is a very good basketball player and has been known to hustle for money on the courts. Boyce is 31, 5'9" and 170 pounds.

**Anibal Mustelier** (Extortion, Bank Larceny) – In 1989, Mustelier was hired to kill Frank Condom, a Miami businessman. On December 22, 1989, Mustelier and another thug, Nelson Cruz, followed Frank in their car as Frank left a nightclub. As Frank drove home, Mustelier emptied a 30-round clip from his machine gun into Frank's car, then sped away. Frank somehow managed to escape the attack with only a gunshot wound to his arm. Mustelier and his crew weren't done. Mustelier and several other men planned to use a bomb to blow Frank up. On August 17, 1990, Cruz and two other men went to Frank's mother's house and put a bomb under Frank's car. When Frank and his family got into the car, the bombers detonated the device. Once again the attack failed. Frank and several members of his family suffered serious injuries but fortunately none died from the blast. Eventually, most of the group was arrested but Mustelier managed to slip away. Mustelier resurfaced in 1996 when he pulled off one of the largest bank heists in south Florida. Mustelier put together a crew of criminals and was able to get safety deposit box keys made for the Sun Trust Bank. On November 18, 1996, two men went into the bank and got away with approximately 8,000 pieces of jewelry valued at between \$5 million and \$7 million from three different safety deposit boxes. The men gave the money to Mustelier, who disappeared. Authorities believe Mustelier fled to Venezuela shortly after the robbery, but may currently be back in Florida. Mustelier has used numerous aliases including

Emilio Suarez, Barrero Musteler, Anibal Musieler, Ramon Llercna, and Anivan Mutelier. He has a small scar on his neck, wears contact lenses or glasses, and is known to keep in shape and work out at gyms. He may be taking ballroom dance lessons or hanging out in dance clubs. There are rumors that he has ties to Castro as a hitman. Mustelier is 53, 5'4" and 135 pounds. (See Shows #664, #681, #721 and #756, OADs 2/9/02, 6/22/02, 5/31/03 and 3/13/04)

**Shawn Dale Bovee** (Felony Conspiracy to Illegally Manufacture a Controlled Substance & Illegal Distribution of a Controlled Substance) -- DEA agents are searching for Shawn Dale Bovee, who, they allege, is a major distributor of the so called "date-rape drug," GHB. Bovee is known on the streets as "Head" because of his "large, alien-shaped cranium." For the past two years, Bovee has built up what they describe as a significant business of manufacturing and distributing GHB throughout southern California, primarily in and around Orange County, CA. Investigators have learned that Bovee buys his main source of chemicals for the manufacture of GHB from a supplier in Scotland, and then purchases the additional chemicals needed from local sources in southern CA. He has mixed (manufactured) GHB in various locations throughout southern CA, including his own home. The DEA considers Bovee to be one of the largest dealers of GHB in southern CA, and that he and his friends use a great deal of the drug themselves. Cops consider Bovee and his friends serious addicts of GHB and, in their words, "they are fried". While Bovee is not wanted for rape or drug-induced sexual assault, cops feel certain that the GHB made and sold by Bovee could probably be linked to a number of recent drug-induced sexual assaults in southern CA. Bovee has green eyes, he is 24, 6"0" and 185 pounds.

**Eric Glynn Johnson** (Murder) -- Authorities say Eric Glynn Johnson is wanted by the Baton Rouge Police Department for the brutal murder of 23-month-old Dalyen Chapman. On April 15, 2004 Johnson beat, slapped, and kicked 23-month-old Dalyen. Johnson was living with his girlfriend and her son Dalyen. Johnson had beaten his girlfriend along with her son on several different occasions. Johnson stated that he was tired of the child acting scared around him and slapped Dalyen with an open hand knocking him to the floor. After this incident, Johnson repeatedly hit, punched and kicked the young boy. Dalyen's mother tried to intervene but she too had been beaten. After the alleged beating, Daylen's mother noticed he was having trouble breathing, tried to help him and called paramedics. Daylen died a few hours later from internal injuries. Johnson fled the residence in his older model blue and white Chevrolet van and his whereabouts are unknown. Johnson uses the aliases Johnathan Seaverson and has the word "MURDER" tattooed on his right arm and a picture of a skull with cross bones on his right arm. Johnson is 26, 5'9" and 170 pounds.

### **CAPTURED:**

**Douglas Aigen** (Aggravated Assault on a Police Officer) -- Doug Aigen has a long rap sheet and doesn't want to go back to prison. His crimes range from forgery and theft to assault on a police officer and kidnapping. In 1992, Aigen kidnapped a woman in a parking lot and put her in the trunk of her car as he drove around using her ATM card. He released the victim and later was convicted of kidnapping charges and robbery. He was sentenced to fifteen years in a New Jersey prison. After his release in 2002, Aigen assaulted a police officer. On October 25,

2002, Aigen was trying to steal a load of batteries from a truck. Aigen bit and punched the officer, then fled. On January 10, 2003 Aigen attempted to steal a tractor trailer from a New Jersey truck company. Employees spotted him and tried to stop him by placing a pickup truck in front of the stolen tractor. Aigen rammed the pickup and led police on a chase on the New Jersey Turnpike and Route 78 in Newark. At one point during the pursuit, Aigen came to a complete stop with a trooper car right behind him. Instead of getting out of the tractor, Aigen put his truck in reverse

and rammed the police car before fleeing. No one was injured. Since then, detectives in New Jersey and New York believe Aigen has been stealing tractors and trailers. Aigen sells the merchandise inside the trailers on the streets of New York and pockets the cash. They believe he won't go down without a fight. Aigen, who has used the aliases Doug Ailen, Douglas Reed Aigen and Douglas Robert Aigen, has "Leslie" tattooed on his right hip. He has a crack habit and must steal to survive. He may suffer from depression, and his family is afraid of him. Aigen is 38, 6'2" and 370 pounds. (See Shows #735, #747, #758 and #760, OADs 9/13/03, 1/03/04, 3/27/04 and 4/17/04) On Friday, April 23, 2004, Officer Al Panopoulus spotted Aigen while on foot patrol. Panopoulus recognized Aigen from his AMW profile the week before and the wanted posters hanging in his NYPD precinct. Aigen was arrested without incident is being held in a New York City jail while he awaits an extradition hearing.

**Ioannis "John" Koutoumanos (Attempted Murder)** -- Police in Schaumburg, IL say Ioannis "John" Koutoumanos is wanted for the drive-by shooting of a rival gang member. On the evening of April 2, 2003, Schaumburg police officers responded to the intersection of Schaumburg Road and Carver Lane, where witnesses heard shots fired. Koutoumanos, an alleged member of the street gang Latin Count, shot a handgun four times, aiming at two alleged members of the Spanish Cobra gang. The victim survived the shooting and Koutoumanos was arrested for the crime. Marshals say Koutoumanos bonded out on the charges and then failed to appear for a court hearing. Police say he has been a fugitive since May of 2003. Koutoumanos has a tattoo of a "C" on his left hand; "Shorty" on his left leg; and happy and sad faces on his upper left arm. He is considered armed and dangerous. Koutoumanos is 20, 5'8" and 158 pounds.

**Juan Jose Hernandez-Mendoza (Murder)** -- Napa County authorities have identified and obtained an arrest warrant for Juan Jose Hernandez-Mendoza, 22, in the fatal stabbing of Yountville Veterans' Home security officer Manuel Reyes, 58, on August 4, 2003. Reyes was found stabbed to death near his marked security vehicle that had crashed into a tree at Dry Creek and Mount Veeder roads around 12:30 a.m. This was an hour after he had agreed to give a ride to a young Hispanic man who was having trouble communicating with a cab driver. Police are not sure of the exact order of events leading to the truck crashing into the tree and when the stabbing occurred. They are also unsure of the motive. The knife used as the murder weapon and also a baseball cap with the "Titleist" logo were recovered at the scene. The identity of the suspect was obtained from witnesses who came forward after a composite sketch was circulated in the local

media. Through investigation, the detectives were able to track Mendoza's activities before hailing the taxi cab. Detectives tracked him to a sporting goods store for which they have obtained video surveillance of Mendoza entering and exiting the store several times. Detectives also discovered that Mendoza made a purchase in the store, which was a knife. Mendoza, who uses the alias Jose Mendoza, has a large mole on his left cheek and warts on his right forearm. Mendoza is 25, 5'6" and 140 pounds.

**Michael Alfonso** (Murder, Aggravated Stalking) -- Alfonso is wanted in Wheaton, Illinois for the murder of Genoveva Franco Velasquez on the morning of June 6, 2001. Velasquez was killed as she approached the entrance to the McDonald's where she worked as assistant manager. Alfonso walked past cars at the drive-thru window, then pulled a gun from his duffle bag, shooting Velasquez in the chest. He then stood over the victim and fired more shots into her. Witnesses say he fled the scene on foot, dropped his gun and jumped into a parked car in a lot behind the McDonald's. The victim worked with Alfonso at her second job with the Pampered Chef. Velasquez had been having an affair with Alfonso, but decided to break it off and remain with her husband and 9-year-old daughter. On June 5<sup>th</sup>, Velasquez reported for work at the Pampered Chef and was confronted by an angry Alfonso. He refused to leave her alone unless she agreed to talk to him. When Velasquez tried to leave, Alfonso grabbed her arm and pulled her backwards. He threatened Velasquez and her family, saying he might show up at her house. Velasquez called the police, but requested that Alfonso not be contacted, because she was afraid that he would retaliate. Alfonso's birth name is Michael Johnson. He speaks fluent Spanish and English, has a muscular build, and likes to work out. He likes fast cars and is ironically a fan of America's Most Wanted. He has a tattoo of the word "Blanca" on his back that he may have had removed and a stab wound scar on the left side of his chest. Alfonso is 34, 5'6" and 150 pounds. **Peter Jerome Cunningham** (Homicide) -- Peter Jerome Cunningham is wanted by the Broward County Florida Sheriff's Office for the murder of twenty-three-year-old Jason Tavares. Jason Tavares is the son of seventies R&B/Disco legend, Antone "Chubby" Tavares. Investigators say Peter Cunningham gunned down Jason in front of the Villas Apartment Complex in Lauderhill, Florida on the night of September 20, 2002. The shooting stemmed from a dispute over money. Cunningham allegedly ripped off Jason during what was supposed to have been an uneventful marijuana transaction. Police say Cunningham shot Jason once in the back and leg, then opened fire on Jason's friends, Tommy and John, as well as firing on other bystanders that were on the corner at the time of the incident. Police tracked Cunningham to Sarasota, Florida shortly after the murder, but his trail went cold after that. Police say Cunningham is a marijuana dealer, and should be considered armed and dangerous. Cunningham is 21, 5'9" and 150 pounds.

**Skerdi Zena** (Attempted Murder) -- Police in London, Ontario, Canada are searching for Skerdi Zena. They say that he randomly attacked a woman in her home. On Saturday, January 31<sup>st</sup>, 2004, at about 3:45 am, Zena broke into a town house via the back window. Inside, a single mother and her four children (ages 3 to 17) slept. After Zena came in through the back window, he took off his shoes and his coat. He then went to the mother's bedroom where he found her

sleeping on the bed. London Police say Zena stabbed the mother multiple times and beat her. Cops surmise that Zena thought he had killed her. Police say that he ran out of the house, leaving behind his coat, shoes and cell phone. The victim survived and is currently recovering from her wounds. Cops say there are no previous links between her and Zena. They say he is likely a habitual offender that will continue to commit these kinds of violent acts until he is apprehended. Zena is an Albanian National who speaks English with a heavy Albanian accent. He works as a day laborer and has recently worked as a roofer. He likes to frequent bars, strip clubs and casinos. Zena has a history of violence towards women and is considered armed and dangerous. Zena, who uses the alias Steve Zana, has a scar on the left side of his upper lip and a tattoo of a lobster on his upper right arm. Zena is 30, 5'8" and 181 pounds.

**Armando Garcia** (Murder) – Armando Garcia is an extremely violent Mexican national who was wanted in Los Angeles in connection with two attempted murders. On April 29, 2002, Los Angeles County Sheriff's Deputy David March pulled Garcia over on a routine traffic stop. Garcia got out on the drivers side of his 1989 black four door Nissan Maxima and approached Deputy March. When the deputy attempted to frisk Garcia, he was immediately shot multiple times in the face, neck, and chest area. Garcia got back in his car and fled the scene. Deputy March died. Garcia, who has used the alias Daniel Garcia and the nickname "Chato," has "Garcia" tattooed on his shoulder blade. A professed cop hater, he doesn't go anywhere without his 9mm gun. Garcia is 27, 5'10"-6'0", and 230 pounds. (See Shows #674, #675 and #703, OADs 5/4/02, 5/11/02 and 1/04/03)

**Carl Djuseberg** (Attempted Murder) – Djuseberg kidnaped an acquaintance at gunpoint while they were fishing at a local reservoir. He forced the victim to drive him to her home where he terrorized her by threatening to kill her. He disrobed the victim and bound her wrists together. The victim escaped early the next morning after Djuseberg fell asleep. The naked victim went to a neighbor's home for help. He escaped before the SWAT team entered the victim's home. Djuseberg eluded the police for days and during that time he threatened another acquaintance and stole his car. Djuseberg is also wanted for the attempted murder of an off duty police officer and another person in 1997. He is also wanted for parole violations and unlawful flight to avoid prosecution involving sexual assaults in San Francisco. Djuseberg is known to frequent coffee shops and body building facilities. He has a tattoo of a double-headed dragon and a surgical scar on his chest. Djuseberg is 39, 5'10" and 180 pounds. (See Show #637, OAD 6/16/01)

**Robert Glenn Brown (Murder)** -- The U.S. Marshals say that on November 1, 2003, Robert Glenn Brown shot and killed Larry Hawkins, a bartender at D.J.'s, a bar near Waco, Texas. On November 10<sup>th</sup>, police discovered Hawkins shot dead in his home. Several items were missing from the house including Hawkins' 1980 Honda motorcycle, some cordless phones and his wallet that contained around \$3,000. Witnesses say Brown was seen riding Hawkins's motorcycle in the days following the murder. Friends say that Hawkins told them that he was feeling threatened in the days before the murder, Hawkins had recently broken up with a girlfriend. Patrons at the bar reported seeing Hawkins threatened by another local gang member on behalf of the girl's father. Investigators are sketchy on the details of how the two men knew each other. Brown was known to come into D.J.'s as a customer and friends say that Hawkins bought a blue Mustang from Brown that is also missing. Robert Glenn Brown, who goes by the nicknames Junior, Robby and Justin, has green eyes and has a tribal tattoo on his upper left arm. Robert Glenn Brown is 30, 5'10" and 180-200 pounds.

**Brittany Fish Abductor (Abduction, kidnapping)** -- On Saturday, April 24, 2004, Brittany Fish was abducted as she rode her scooter to a friend's house. Police and neighbors quickly scoured the neighborhood looking for the missing five-year-old but all they found was her discarded Barbie scooter. Then, nearly twenty-four hours later, Fish was found alive. A businessman had been checking out an abandoned warehouse that he was interested in purchasing when he heard whimpering under a tarp. When he pulled the tarp back, he found Fish alive but bound in duct tape. Fish was able to give police a description of her abductor and the vehicle he was driving. He's described as a white, tanned or possibly Hispanic male who is in his 40's, thin and balding with a mustache and lines on his forehead and neck. She said his car has four doors and is white. It also has a gray interior and is described as filthy.

**Winston Whittingham (Sexual Battery)** -- In January of 2002, Winston Whittingham was charged with molesting and raping his girlfriend's 14-year-old daughter multiple times during a period of a year and a half. Whittingham was arrested and subsequently released pending a trial date, but was ordered to have no contact with the victim whatsoever. However, sadly enough, the State Attorney's Office was forced to discontinue prosecution when the victim's mother refused to let the young girl attend the trial. Then, again in April of 2003, police were called to the victim's high school to investigate further allegations of abuse. Once more, charges were drawn up on Whittingham. Before an arrest could be made, cops believe Whittingham was tipped off and presumably left town. Detectives have been unable to locate him. Winston Whittingham is 40, 5'7" and 170 pounds.

**Cuitlahuac Tahua "Tao" Rivera (Murder)** -- The Merced County Sheriff's Office and Merced Police Department are conducting an aggressive multi-agency manhunt for murder

suspect Cuitlahuac Tahua "Tao" Rivera, who is wanted for the killing of Merced Police Officer Stephan Gray. Authorities say that on the evening of Thursday, April 15, 2004, Officer Stephan Gray, 34, was performing a routine traffic stop at about 7:30 p.m. near the intersection of East 19th Street and Glen Avenue in Merced. Witnesses say that the officer had pulled over a Geo Metro and was talking to the driver for a while. According to the witnesses, Gray made contact with a male passenger and began to search the vehicle. The passenger, Rivera, 21, then started to run and Officer Gray pursued Rivera on foot. Rivera spun around and fired an unknown caliber gun during the chase and struck Gray twice. Gray was hit in the chest, just above his body armor and later died at Mercy Medical Center in Merced. Rivera was reportedly seen the day after the murder with his mother, Erika Rivera, 43, at an apartment complex in Merced on Friday, April 16, 2004. Erika Rivera was arrested on Saturday, April 17, 2004 and booked on felony charges of aiding and abetting a criminal and being an accessory to a crime for helping her son. Tahua, who uses the nicknames "Tao" and "Bullet," has a large tattoo of the letter "M" on his stomach, a "MGC" tattoo on his right forearm and "2DAS" on his left forearm, the number "3" on his right fingers and large undetermined tattoos on both shoulders. Rivera has a criminal past dating back to October of 2000 and is considered armed and dangerous. Rivera is 21, 5'8" and 190 pounds. Cuitlahuac Tahua "Tao" Rivera was taken into custody on Sunday, May 2, 2004 in Merced, California. (See Show #761, OAD 4/24/04)

*The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.*

**William Ray Plemons** (Murder, Kidnapping, Parole Violation) - William Plemons is wanted by Phoenix, AZ authorities for the murder of his second wife, Ermalinda Macatangay. While Plemons was in prison for robbery, assault and escape, he developed pen pal relationships with at least two women. He married one while still in prison and was granted parole in April 2003. After his release, he left his first wife and took up with Ermalinda. He allegedly stole from her bank accounts and ran up her credit cards. On June 24th, Plemons is accused of killing Ermalinda in a fit of rage. Police fear that he may have another female pen pal whose money he is using to survive and run from the law. If not, police believe he may be committing armed robberies. The family is offering a \$5000 reward for Plemons' capture. Plemons has used the aliases John Coleman, David Howell, Ray Plemon, William Keller, William Taylor and "Bubba." He reportedly uses low dosages of methamphetamine to stay awake due to his fear of being alone. He is also known to pay people to drive him around. Plemons has been known to wear Kmart type blue jeans and a pressed collar button down type shirt and to frequently solicit prostitutes. Plemons is 58, 5'8" and approximately 190 pounds. (See Show #752, OAD 2/07/04) Plemons' was last seen frequenting bars in Florida.

**Malaika Tamu Griffin** (Murder) – Malaika Tamu Griffin is wanted for the murder of 25-year-old Jason Horsely. In the winter/spring of 1999, Griffin was renting a room in a house next door to Jason and his girlfriend, Deborah Loiselle. On April 20, 1999, Deborah had her first encounter with Griffin as the two women were standing in their front yards separated by a fence. Deborah says Griffin, whom she'd never seen nor met before that day, immediately threatened to kill her dogs and began cursing and hurling racial slurs. Jason and Deborah are Caucasian; Griffin is African-American. Over the next 28 days, Griffin had several other run-ins with Jason and Deborah that they say she initiated over parking on the public street and Jason unloading his

tools on the public sidewalk in front of her house. None of the arguments made any sense to Jason and Deborah because they insist they never trespassed on her property and the parking spaces should have never been a matter of dispute because Griffin didn't even own a car. Hers had been repossessed. On the evening of May 18, 1999, Jason was organizing his carpentry tools on the sidewalk in front of Griffin's house when she came outside and began screaming at him. Deborah heard the commotion and came out of her house to stick up for Jason. After a brief but intense argument, both women stormed back into their respective homes and Jason continued organizing his tools. Griffin came back outside minutes later armed with a laser-sighted 9mm pistol and shot Jason in the back at point-blank range. He never saw her coming. The bullet pierced Jason's heart and killed him almost instantly. Then, Griffin ran to the home of an acquaintance, Monique Thomas, and carjacked her at gunpoint. Griffin abandoned the car in Iowa and hopped a bus to Chicago where her trail went cold. When police searched Griffin's room in Denver, they were shocked to find a stockpile of ammunition, diffused hand grenades, a 9mm assault rifle and books commonly associated with terrorists, *The Anarchists' Cookbook* and *The Poor Man's James Bond*. They also found spiral notebooks full of Griffin's secret writings about a coming race war and the killing of white people. None of her colleagues or close friends ever heard her express the types of racist rhetoric she wrote about in her notebooks. Griffin is a world-traveled lady with a Magna Cum Laude degree in chemistry. She has worked in laboratories and a pharmacy in the past. Griffin is an avid outdoorswoman and survivalist who buys top of the line camping gear and firearms. She has bad credit and declared bankruptcy in 1999. She doesn't smoke, but may drink occasionally. She prefers going to museums to clubs or other nightlife. She usually carries a backpack wherever she goes. Griffin is 33, 5'4" and 145 pounds. (See Shows #575, #599, #646, #726, and #759, OADs 2/5/00, 8/12/00, 8/25/01, 7/12/03 and 4/10/04)

**Svetlana Vitman (Murder)** -- American businessman Preston Brooks fell in love with Vitman in Russia and smuggled her into the United States illegally. Once in the U.S., Vitman fell in love with another woman. Vitman became tired of Brooks and shot him on the night of June 6, 1994, while he slept in a motel room after they had sex. Two months after her profile first aired on America's Most Wanted, Vitman surfaced in Amsterdam. On July 30, 1995, she surrendered herself to Dutch authorities. After authorities arranged to have her escorted back to the U.S., Vitman changed her mind and simply walked out of the Amsterdam hotel the police had put her up in. She has not been seen since. Vitman, who has used numerous aliases including Svetlana Kojurne, Svetlana, Kojourina, and Svetlana Kozurian, speaks English with a heavy accent. She is a heavy smoker, a bisexual who frequents lesbian bars, and enjoys the beach, coastal areas and snow skiing. Vitman is 40, 5'8" and 110 pounds. (See Shows #364, #401, #424, #454 and #705, OADs 5/6/95, 3/16/96, 8/31/96, 6/16/97 and 2/01/03)

**Unknown Indy Female Bank Robber (Robbery)**

**Unknown Indy Male Bank Robber Accomplice (Robbery)** -- Police in Indianapolis, Indiana are looking for a female who robbed an Eastside bank. On October 9, 2003, shortly after 10 a.m., a black male and female entered the Fifth Third Bank on the Eastside of Indianapolis, IN. The woman approached the teller counter and got in line. The male stood in the back and pretended to fill out a deposit slip. When the woman approached the teller, the man left the bank and returned to the vehicle. The female handed the teller a note saying, "I have a gun, give me

the money, no dye pack." Police say when she got the money, she ran to a car parked on the far side of the parking lot. She and the male fled from the bank in a mid 80's, dark colored, 4-door Cadillac and have not been seen since. The female bank robber is 25-30, 5'7" and was wearing a black t-shirt with "New York 34" written on the front and her hair in a ponytail. The male was wearing blue jeans and a light colored shirt and hat.

**Linda Sue Andrews (Burglary)**

**Allen Wayne Andrews (Felony Theft)** -- The Phoenix Police Department Cold Case Squad is looking for Linda Sue Andrews for the 1987 burglary of a school teacher's house. They believe she may have information regarding the school teacher's murder. In 1998, the Cold Case Squad reopened the 1987 murder and, after contacting Linda Sue, she and her husband, Allen Wayne Andrews, fled Arizona. They dropped their kids off at his relatives in Texas and disappeared. A federal UFAP warrant was issued, but Linda Sue or Allen Wayne have not been seen since 1998. Linda Andrews uses the aliases Linda Freeman, Linda Rehart and Linda Spring. She wears prescription eyeglasses and may be working an administrative job in an office. Linda Andrews is 48, 5'7" and 200 pounds. Allen Wayne is wanted in Bozeman, Montana for two counts of felony bad checks and felony theft by deception. These warrants were issued by the Gallatin County Sheriff's Office in 1990. Andrews also has a 1998 misdemeanor warrant by Mesa Police Department for passing bad checks. Allen uses the aliases Wayne Freeman, John Wayne Freeman, Andy Simpson, Thomas Daily, Ed Bassett and Bobby Bassett. He has scars on his right arm, upper left arm, left forearm, left elbow, right thigh and right leg. Allen Andrews is 57, 5'10" and 210 pounds.

**UPDATE:**

**Unknown Las Vegas Murder Victim** – Las Vegas Police are trying to determine the identity of a man found buried in the backyard of a house owned by Anna Mitchel. In the early morning hours of July 21, 2003, Las Vegas Metropolitan Police officers were summoned to a home to investigate a report that a corpse had been found buried in the backyard. A tenant, 22-year-old Christopher Loudermilk, had discovered the body. Loudermilk told police that his landlord/roommate, Anna Mitchel, 37, had confessed to him earlier that evening that she had killed someone and buried the body in her backyard. Homicide investigators unearthed the body of a middle-aged white male whose legs had been cut off. The officers later learn that the victim's legs had been burned and stored in a garbage bag. The coroner believes the victim was murdered and buried between one and three years prior to the gruesome discovery. Mitchel was arrested at the scene that night and charged with murder. Mitchel has refused to tell investigators anything that would help them identify the man she allegedly murdered and buried in her yard. Mitchel is currently awaiting trial for the murder of the unidentified man. The only clues to the victim's identity are the numerous tattoos that remained intact on his cadaver. A demonic skull on his lower left abdomen; a long-haired hippie looking man's head on his lower left rib cage; a skull mounted atop crossed swords on the right side of his neck; a detailed mural of naked women and other figures covering his back. The unidentified victim has long, black, and grey hair. He is 35-60 years old and 5'10"-6'0." (See Show #742, OAD 11/22/03) The victim was identified as 44 year-old Cecil Wilson. His niece recognized the tattoos she had seen on AMW.

**MISSING:**

**Georgina "Gina" DeJesus**

Age: 14

Height: 5'1"

Weight: 135 pounds

On Friday, April 2, 2004, 14-year-old Georgina "Gina" DeJesus disappeared as she was walking home from school. Gina left Wilbur Wright Middle School around 2:30 p.m. and headed home, but she never arrived. When her mother got home and realized her daughter never returned from school, she called police. Police say witness last saw Gina at the corner of 105th Street and Lorain Avenue. She was last seen wearing black pants, a white/tan shirt, and a powder blue, hooded jacket. Police have no leads or suspects. Police are treating Gina's disappearance as a missing persons case. Friends and family say she was a happy girl and would never have run away. Police want to talk with a man seen driving along Lorain Avenue in the area where Gina disappeared. The man is described as Hispanic, driving a light-colored, older-model compact car with a license plate that includes the letters SMS. Police are not calling this man a suspect, but he and his car have been described by multiple witnesses. On April 21, 2003, 17-year-old Amanda Berry went missing just six blocks from where Gina was last seen. Police have no reason to believe that the two cases are connected, but they're not ruling anything out at this time. Gina is Hispanic. She has a light brown birthmark on her right leg and her right ear is pierced at the top and the bottom. (See Show #760, OAD 4/17/04)

**Leanna Warner**

Age: 5

Leanna was last seen at her home at 5:00pm on June 14, 2003. she told her mother she was going to visit a friend who she regularly visits and who lives a short distance from their house. Leanna usually checks in with her parents every 20 minutes. After she was gone for 45 minutes Leanna's parents began looking for her. After searching for hours, her parents realized she was missing and called 911. Police believe this is an abduction and have now set up a command center. After an exhaustive search, police did not find any clues as to where she may have gone. Due to the lack of any evidence of an accident, police are now focusing on the possibility of foul play, including an abduction. Leanna, who goes by the nickname "Beaner", was last seen wearing a sleeveless dark blue denim dress. (See Show #725, OAD 6/28/03)

**Alexis S. Patterson**

Age: 9

Height: 3'8" (at the time of her disappearance)

Weight: 42 pounds (at the time of her disappearance)

Alexis Patterson vanished on May 3, 2002. She was last seen at 8:00am when her stepfather walked her to an intersection near the Hi-Mount Community School in Milwaukee, Wisconsin. Alexis never made it to class and hasn't been seen since. Alexis, who goes by the nickname "Lexi", has a scar under her right eye and a bump on her left pinky finger. She was last seen wearing a red hooded jacket with gray stripes, a purple shirt, blue jeans and white Nike tennis shoes, and she was carrying a pink Barbie book bag. She was wearing her hair in two braids and a ponytail. (See Show #675 and #684, OADs 5/11/02 and 7/27/02)

### **Rayon Gray**

Age: 10

Height: 4'7"

Weight: 82 pounds

Maryland State Police officials are searching for Rayon Gray, who, they say, was taken by his non-custodial mother on October 18, 2003. Rayon Gray had been living with his father in Baltimore, MD. On October 18, 2003, he was dropped off by his father to his non-custodial mother's house for what was supposed to be a two hour visit. However, the mom fled and has not been seen or heard from since. According to police, Rayon's non-custodial mother, Margarita Peterson, abducted him once before in 1996 and was missing for approximately two years before being arrested. After this incident, full custody was given to Rayon's father. A circuit court judge, however, did allow Rayon to go to the home of Brenda Peterson to visit with his mother for two hours every other week. Again, police say, Margarita fled with Rayon. During the first abduction, Margarita was in the states of Florida and Texas. She apparently lived in various shelters and failed to enroll Rayon in school. Police say Rayon is likely a victim of severe neglect. According to cops, Margarita has a past of severe violence. They say she has an extensive criminal history which includes: use of a weapon with intent to injure, numerous felony assaults, the use of a handgun in commission of a crime, resisting arrest and several counts of distributing and using narcotics. After the show aired on Saturday, May 22, 2004, the AMW Hotline received a call from a woman who says her daughter recognized Rayon as a student at her school--Barranca Elementary School. Police confirmed Margarita was there but have been unable to track her down. They found out that she is disguising herself as an Islamic woman by wearing a burkha. Rayon has a scar on the right side of his forehead.

### **CAPTURED:**

**Carl Djuseberg (Attempted Murder)** – Djuseberg kidnaped an acquaintance at gunpoint while they were fishing at a local reservoir. He forced the victim to drive him to her home where he terrorized her by threatening to kill her. He disrobed the victim and bound her wrists together. The victim escaped early the next morning after Djuseberg fell asleep. The naked victim went to

a neighbor's home for help. He escaped before the SWAT team entered the victim's home. Djuseberg eluded the police for days and during that time he threatened another acquaintance and stole his car. Djuseberg is also wanted for the attempted murder of an off duty police officer and another person in 1997. He is also wanted for parole violations and unlawful flight to avoid prosecution involving sexual assaults in San Francisco. Djuseberg is known to frequent coffee shops and body building facilities. He has a tattoo of a double-headed dragon and a surgical scar on his chest. Djuseberg is 39, 5'10" and 180 pounds. (See Show #637, OAD 6/16/01) Carl Djuseberg was taken into custody on Tuesday, May 18, 2004 in Charleston, West Virginia. Police say his capture is a direct result of appearance on the program. He is now in a Charleston jail waiting for the many various departments to decide where to prosecute him first.

**Marco Antonio Camacho** (Murder) -- Police in Napa, CA are looking for Marco Camacho in connection with the fatal shooting of Roberto Torres. September 16, 2000 was an exciting day for Janet Mendez. The 15-year-old Napa, CA girl was surrounded by family and friends as she celebrated her Quinceanera, or "coming out" party. After attending a church mass, the teen and over 300 guests attended her Quinceanera at the Napa, CA fairgrounds. She had asked Camacho to be her escort to the special event, and the two were dressed in formal wear, appearing like a bride and groom would, both at the church and at the elaborate party afterwards. However, police say Mendez didn't know that her date had a violent past and an even worse temper. Robert Torres showed up with his pregnant girlfriend and some other friends to the party. They were denied entry by security because they did not have their invitations. Torres approached Camacho who happened to be outside, and asked if he knew "Juan," who had invited him. Camacho became angry with Torres and the two got into a heated verbal argument. Camacho then turned violent quickly, pulling a gun from his waistband and shot Torres in the torso and wrist. Torres stumbled into the party and fell. His pregnant fiancé held him in her arms. A nearby witness began to run away and cops say that Camacho then turned the gun on him and began shooting. This second guest was able to escape without injury. Camacho then fled was last scaling a fence at the fairgrounds. Two weeks later, Torres died as a result of his gunshot wounds. Friends say that Torres had no prior affiliation with Camacho. The Police investigation revealed that at the rehearsal for the Quinceanera (two days prior), Camacho got into an altercation with a group of men, pulled out a gun and fired several shots at them. By the time police arrived, everyone had fled. Camacho, who uses the alias Jose Antonio Gutierrez, has a distinctive tattoo of a "X" on his right earlobe and a "3" on his left earlobe. Camacho is 23, 6'0" and 160 pounds.

**Jason Arthur Mori (Murder)** --The Shasta County Sheriff's Office says that Jason Arthur Mori, 25, is wanted for the murder of Rodney Bates on Friday, April 9, 2004. Detectives say that Mori shot and killed Bates, 33, with a .12-gauge shotgun during a struggle at the home of Jeanette Gibson and John Dell'Amico on Elk Trail East in Jones Valley, CA. Just prior to the murder, Bates was having dinner at the couple's home with his girlfriend, Michelle Toutant. According to detectives, Mori left at least seven messages on Gibson's answering machine as the friends were at dinner, and later showed up in front of the house in a car driven by his friend John David Pires, 27. Detectives say that a "low key" conversation in the front yard escalated and Mori got out of the car with a shotgun. Authorities say that Mori pointed the weapon at Toutant, and Bates quickly grabbed it. Mori and Bates then struggled and police say when Mori gained control of the gun, he pulled the trigger. Bates died of a shotgun blast to the abdomen. Dell'Amico told deputies he then grabbed the shotgun to prevent Mori from chambering another shell. They struggled and Mori freed himself and jumped back into the car. Deputies then say that Toutant chased Mori into the car and started beating him and then grabbed "something" from inside the car and stabbed Mori "numerous times." Detectives have not been able to verify what object was used in the stabbing but have confirmed that Mori was bleeding and injured. Mori then yelled at Pires to drive away and then, after driving away some distance, Mori told him to slow down so that Mori could throw the shotgun out of the car window. Investigators recovered the shotgun. In the days after the murder, deputies were in contact with Mori by telephone when they found his girlfriend Brook Leganza, 24, had used her bank debit card to rent a motel room at the Orland Inn south of Redding. Detectives placed a call to the motel room and spoke with Leganza and Mori. Investigators did not get to the room quickly enough to make an arrest, but found evidence of Mori's stab wounds when they recovered bloodstained sheets in the room. Leganza surrendered to deputies after several days of telephone negotiations. She told detectives that her last contact with Mori was when she dropped him off in Bakersfield, CA. Leganza is charged as an accessory after the fact to murder. John David Pires was arrested and charged with murder in the killing of Rodney Bates. Detectives are particularly interested in the areas of Huntington Beach, Bakersfield and Coalinga, CA, where Mori has either friends or family. Mori used a debit card in Coalinga, CA to make a \$60 cash withdrawal, but has not made any further transactions. Authorities say the dispute started the week before the murder when Gibson allegedly called Mori the "N" word. Detectives say that Mori and Pires are not affiliated with a white supremacist group, but that this comment did not set well with Mori. On April 7<sup>th</sup>, Mori showed up at the same residence and fired several warning shots with the shotgun. Gibson and Dell'Amico called police. Mori was arrested, so cops think the incident on April 9<sup>th</sup> was retaliation for his April 7<sup>th</sup> arrest. Jason Arthur Mori uses the aliases Jason Arthur Cupp and Jason Hagelbarger. He has scars on the left side of his head, a star on his right upper cheek and a star below his eye. He has a shaved head with a bushy beard and is skilled at living in the wilderness. Mori is 25, 5'6" and 145 pounds.

**BTK Killer (Murder)** -- Wichita Police are searching for a killer (possibly a white male) who calls himself "BTK" which stands for bind, torture and kill. Police say he is wanted for the murder of seven people. Police have linked him to murders as far back as 1974. "BTK's" first victims were members of the Otero family in Wichita. The Otero's oldest son, Charlie, arrived home from school on January 15, 1974, and found his father lying on the bedroom floor. He ran to get help and when police arrived, they found Joseph Otero dead on the floor and Charlie's

mother, Julie, dead on the bed. Police searched the house for clues, but what they found was even more devastating. Charlie's younger brother was found murdered in his bed and his younger sister was hanging from a pipe in the basement. Police searched for clues and followed several leads, but came up empty handed. Then a local newspaper received a call directing police to the Wichita Public Library. There, police found a letter addressed from "BTK" taking credit for the murders. Over the next ten years, "BTK" is believed to have killed three more people. On March 17, 1977, Shirley Vian, 24, was found strangled in her house. Police say "BTK" locked her three children in the bathroom before he killed her. Then on December 8, 1977, police received a call from an anonymous person stating that there was a murder at a home in Wichita. When police arrived on the scene, they found the body of twenty-five-year-old Nancy Fox. Police believe the call was from "BTK." Police say after the murder of Nancy Fox, it appeared that "BTK" had stopped killing. But then on March 19, 2004, KAKE TV received a letter from "BTK." Police say the letter contained crime scene photos and the driver's license of twenty-eight year-old Vicki Wegerle. Police say Vicki was found murdered in her home on September 16, 1986. At the time, police could not connect "BTK" to her murder. Now, police say, DNA has linked him to her death, making Vicki "BTK's" seventh victim. Police say the letter is authentic. They do not know why after thirty years this killer known as "BTK" has resurfaced. Police are hoping that new technology and new leads will help them identify "BTK."

**Alan William Golder** (Kidnapping, Robbery, Burglary, Larceny) -- If you discovered Alan Golder in your house, you might think he had stepped out of the pages of GQ Magazine. In reality, he recently stepped out of prison, and officers hope he will be returning soon. After his feature aired on AMW, a man came forward who may be able to help - the suspect's own brother. Golder's younger brother came forward after seeing Golder's profile on AMW, a profile that filled him with concern. He says that Golder is a danger to himself and others because he simply can't stop committing crimes - he is a jewel addict, the brother claims. The only happy end to this story, the brother told AMW, would be if Golder turned himself in. Well-tanned and well-toned, Golder has made quite a name for himself, allegedly ripping off homes of the rich and famous while mixing comfortably with the rock stars and executives of the Sunset Strip crowd in Los Angeles. He even had an author interview him for a biography as he served time in prison for murder. But since he was paroled, he has, officials say, returned to what he knows best - burglary. In 1978 Golder allegedly used two accomplices - Boonlert Thanarakol and Surajit Sae Sow - to rob a home in Old Brookville, New York. The robbery left the homeowner dead, and a trail of evidence led directly to Golder, who was convicted and sentenced to 15 years to life. Paroled in 1996 after 16 years behind bars, Golder told his parole officer that he wanted to be a jeweler, bartender, or a fitness trainer, but no one would hire him. Before long, police say, he was underground again, and back at work. Golder is now wanted for over 70 robberies in New England that have allegedly netted him more than a million dollars in cash and jewels. Described as slick, fearless, and cunning, Golder reportedly only strikes when residents are home and alarms are off. While the unsuspecting victims are away from the bedroom, police say he climbs their outside walls with the agility of a chimp, enters the bedroom, loads up with valuables, and escapes undetected. After a string of robberies in Greenwich, Connecticut were reported nationwide, other police agencies came forward with similar crimes. But by then, Golder had apparently slipped away to celebrate his own cunning. Police nationwide are on the lookout for Golder, but they aren't the only ones. Apparently, Golder ratted out some of his organized crime connections

when he was taken down for the Old Brookville murder to get a reduced sentence, and they'd like a piece of him as well. But even with all this attention, officials believe that Golder is probably cocky enough to be hiding in broad daylight. He apparently loves the way he looks, and spends a great deal of time in Gold's Gyms and tanning salons. At night, he frequents nightclubs, strip bars, and high-profile parties. He has allegedly convinced himself that crime pays, and it will be up to the police and concerned citizens to prove him wrong. Golder has used the aliases Alan William Kulp and Thomas A. Williamson. He may have "Alan" tattooed between his knuckles. He has a large scar on his right biceps from tattoo removal. He allegedly uses girlfriends as getaway drivers. Golder is a bodybuilder who has worked as a personal trainer and has been a member of Gold's Gym. He frequently changes identity, may have had plastic surgery and may wear a goatee. Golder is 48, 5'9"-5'11" and 150-180 pounds. (See Shows #487, #491, #524, #535, #606 and #713, OADs 3/28/98, 4/25/98, 1/9/99, 3/27/99, 9/30/00 and 4/05/03)

**Angelo Grenci, Jr.** (Assault, Robbery) -- On August 11, 2002, Angelo Grenci, Jr. and a group of his friends were at a party. One of Grenci's friends picked a fight with Roy Piazza. After the altercation, Piazza went home to his apartment. Later that evening, Grenci and the four other individuals drove to the victim's residence. Grenci and his crew entered the residence through an unlocked door and began to terrorize Piazza his guests. Piazza told the guys to leave and they conceded. When they left, he was able to lock the door behind them. However, they didn't stay out. According to police, the men kicked in the door and began to physically assault Piazza and his friends. Detectives claim Grenci hit Piazza in the head with a beer bottle while the others punched and kicked him. After the attack, Grenci and his crew attempted to run the injured Piazza over with their vehicle. Cops later arrested each of the participants. Grenci attended all of his pretrial dates, but did not show up for the actual trial. Nonetheless, he was convicted on one count of burglary and six counts of aggravated assault. Grenci has a scar on his shoulder blade, a pierced left ear and has various tattoos including a "handgun" and "barbed wire" on his left arm, "RAGE" on his torso, the letter "A" on his left hand and a spider web on his left elbow. Grenci is known to carry a knife and has a very violent temper. He drinks heavily and is known to use steroids, cocaine and ecstasy. Grenci is 27, 5'11" and 200 pounds.

**Richard Lynn Bare** (Murder) -- Bare is wanted for the January 15, 1984 murder of Sherry Hart, 24, of West Jefferson, North Carolina. Bare and a friend, Jeffery Burgess, drove Hart to an area known as the Jumping Off Place, a 1,200-foot rock cliff outside of town. There, Bare became enraged when Hart refused his sexual advances. According to Burgess, who is cooperating with investigators, Bare followed Hart into the woods, and when she ran from him, Bare hit her over the head with a gun he was carrying. Bare then threw Hart over the Jumping Off Place to her death. Bare and Burgess were arrested in March 1985 and charged with Hart's murder. But in July 1985, Bare escaped from the Wilkes County, North Carolina jail where he was awaiting trial. Burgess remains free on bond pending his trial. Bare probably has dyed his hair blond and shaved his beard. He is a heavy drinker who prefers Jim Beam whisky. He is a non-skilled, general laborer who hates working, but has had a job as a chicken factory packer. He does not smoke or like being around people who do. He is a hard-rock music fan and considers himself a ladies' man. Bare is 39, 5'7" and 145 pounds. (See Shows #113, #139, #167, #212, #355, #599 and #726, OADs 5/6/90, 11/16/90, 6/14/91, 5/1/92, 3/4/95, 8/12/00 and 7/12/03) The FBI has received reports that Bare may now be disguised as a woman.

**Abderraouf Jdey (Terrorism)** -- On May 26, 2004, Attorney General John Ashcroft announced that the Justice Department was issuing a new terror alert. General Ashcroft named seven individuals who are wanted for questioning for having possible terrorist ties or are current fugitives on the FBI Most Wanted Terrorists List. Abderraouf Jdey is one of the people named in the current terror alert. Authorities believe Jdey may have been selected for flight training to be used in a possible second attack on U.S. soil. 1. Jdey was born in Tunisia, but emigrated to Canada in 1991 and became a Canadian citizen in 1995. He may be using a passport issued in Montreal, Canada. Jdey left behind a suicide letter, wherein he proclaimed to die fighting anti-Muslim infidels and a videotaped suicide message by Jdey was found in the Afghanistan home of Mohammed Atef (Osama Bin Laden's military chief who was killed in air strikes by the U.S.). Jdey uses the aliases Abd Al-Rauf Bin Al-Habib Bin Yosef Al-Jiddi, Abderraouf Dey, A. Raouf Jdey, Abdal Ra' Of Bin Muhammed Bin Yousef Al-Jadi, Farouq Al-Tunisi, Abderraouf Ben Habib Jeday. Jdey is 39, 6'0" and 209 pounds.

**Amer El-Maati (Wanted for Questioning)** - El-Maati is a Kuwaiti national who the FBI believes to have a connection to Al-Qaeda. He is thought to have information about terrorist threats in the USA and abroad. He has trained as an airline pilot, and the FBI says he has participated in terrorist training camps. Documents found in Afghanistan link El-Maati to Canada, where he is a naturalized citizen. However, authorities have not been able to locate him. He may have slipped across the border, and should be considered armed and dangerous. El-Maati has used several aliases, including Amro Badr El-Adin Abou El-Maati, Abu Omar, and Abu Umar. He usually wears a full beard and mustache, but may have shaved them off. He requires corrective lenses and may be wearing glasses. El-Maati is 40, 6'0" and 209 pounds. (See Show #699, OAD 12/07/02)

**Ahmed Khalfan Ghailani (Wanted For Murder of U.S. Nationals Outside the U.S.; Conspiracy to Murder U.S. Nationals Outside the U.S.; Attack on a Federal Facility Resulting in Death)** -- Attorney General John Ashcroft announced that the Justice Department was issuing a new terror alert. Ashcroft named seven individuals who are wanted for questioning for having possible terrorist ties or are current fugitives on the FBI Most Wanted Terrorists List. Authorities say Ghailani was indicted in the southern district of New York, on December 16, 1998, for his alleged involvement in the August 7, 1998 bombings of the U.S. embassies in Dar Es Salaam, Tanzania, and Nairobi, Kenya. Ghailani was one of two men who purchased a Nissan Atlas refrigeration truck that carried a bomb that exploded at the U.S. embassy in Dar Es Salaam on August 7, 1998 and killed 11 people, two of them embassy employees. The Rewards For Justice Program and the United States State Department is offering a reward of up to \$5 million for information leading directly to the apprehension or conviction of Ghailani. He should be considered armed and dangerous. Ghailani's numerous aliases and nicknames include Ahmad Khalafan Ghilani, Ahmen Khalfan Ahmed, Abubakar K. Ahmed, Abubakary K. Ahmed, Abubakar Ahmed, Abu Bakr Ahmad, A. Ahmed, Ahmed Khalfan, Ahmed Khalfan Ali, Abubakar Khalfan Ahmed, Ahmed Ghailani, Ahmad Al Tanzani, Abu Khabar, Abu Bakr, Abubakary Khalfan Ahmed Ghailani, Mahfudh Abubakar Ahmed Abdallah Hussein, Shariff Ohmar Mohammed, "Foopie", "Fupi", and "Ahmed the Tanzanian". He was born in Zanzibar,

Tanzania. Ghailani is 5'3"-5'4" and 150 pounds. (See Shows #653, #655 and #659, OADs 10/12/01, 11/17/01 and 1/05/02)

**Fazul Abdullah Mohammad** (Wanted For Murder of U.S. Nationals Outside the U.S.; Conspiracy to Murder U.S. Nationals Outside the U.S.; Attack on a Federal Facility Resulting in Death) -- On May 26, 2004, Attorney General John Ashcroft announced that the Justice Department was issuing a new terror alert. Ashcroft named seven individuals who are wanted for questioning for having possible terrorist ties or are current fugitives on the FBI Most Wanted Terrorists List. Authorities say Fazul Abdullah Mohammed was indicted on September 17, 1998, in the southern district of New York, for his alleged involvement in the bombings of the U.S. embassies in Dar Es Salaam, Tanzania, and Nairobi, Kenya, on August 7, 1998. These terrorist attacks killed 224 innocent civilians and wounded over 5,000 others. The FBI says Mohammad was declared the mastermind of the Nairobi bombing. On the day of the actual bombing, he drove the lead truck that led the bomb to the U.S. Embassy. The Rewards For Justice Program and the United States Department of State, is offering a reward of up to \$5 million for information leading directly to the apprehension or conviction of Mohammed. He was born in Moroni, Comoros Islands, and speaks French, Swahili, Arabic, English and Comoran. He likes to wear baseball caps and tends to dress casually. He is very good with computers. He has Kenyan citizenship. Fazul is 5'3"-5'6" and 120-140 pounds. (See Shows #653, #655 and #659, OADs 10/12/01, 11/17/01 and 1/05/02)

**Adnan G. El Shukrijumah** (Terrorism) – The FBI has issued a “Be on the Lookout” (BOLO) alert for El Shukrijumah stating that the United States has information indicating he may be involved in al-Qaida and may pose an imminent threat to US interests at home or overseas. El Shukrijumah was known to have been in the United States since the terrorist attacks of September 11, 2001, living for a time in Miami. Authorities believe his pilot training raises the possibility that he is planning an airborne attack. El Shukrijumah has used numerous aliases, including Abu Arif, Ja’far Al-Tayar, Jaffar Al-Tayyar, Jafar Tayar, and Jaafar Al-Tayyar, occasionally wears a beard. He is 28, 5'3"-5'5" and 132 pounds. Adam Gadahn is one of the names on this current terror alert. The FBI says they have been looking for Gadahn to question him for over a year. Although they are not indicating that there is any specific information linking him to specific terrorist activities, the FBI does believe Gadahn attended Al-Qaida training camps and may have served as a translator. Gadahn was born in USA, has family in California and may have a wife and child in Pakistan. Gadahn uses the aliases Adam Pearlman, Abu Suhayb Al-Amriki, Abu Suhayb, Yihya Majadin Adams and Yayah. Gadahn is 25, and 5'11.”

**Aafia Siddiqui** (Wanted for questioning) -- On May 26, 2004, Attorney General John Ashcroft announced that the Justice Department was issuing a new terror alert. Ashcroft named seven individuals who are wanted for questioning for having possible terrorist ties or are current fugitives on the FBI Most Wanted Terrorists List. Aafia Siddiqui was the only female named on the most recent terror alert. The FBI issued a global warrant for her arrest in March of 2003. Authorities have not yet indicated they have information that she is connected to any specific terrorist activities, but they would like to question her. Siddiqui is a 32 year-old from Pakistan who studied biology at the Massachusetts Institute of Technology. Siddiqui has no known aliases.

**Peter Jerome Cunningham** (Homicide) -- Peter Jerome Cunningham is wanted by the Broward County Florida Sheriff's Office for the murder of twenty-three-year-old Jason Tavares. Jason Tavares is the son of seventies R&B/Disco legend, Antone "Chubby" Tavares. Investigators say Peter Cunningham gunned down Jason in front of the Villas Apartment Complex in Lauderhill, Florida on the night of September 20, 2002. The shooting stemmed from a dispute over money. Cunningham allegedly ripped off Jason during what was supposed to have been an uneventful marijuana transaction. Police say Cunningham shot Jason once in the back and leg, then opened fire on Jason's friends, Tommy and John, as well as firing on other bystanders that were on the corner at the time of the incident. Police tracked Cunningham to Sarasota, Florida shortly after the murder, but his trail went cold after that. Police say Cunningham is a marijuana dealer, and should be considered armed and dangerous. Cunningham is 21, 5'9" and 150 pounds. *The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.*

He has Kenyan citizenship. Fazul is 5'3"-5'6" and 120-140 pounds. (See Shows #653, #655, #659 and #766, OADs 10/12/01, 11/17/01, 1/05/02 and 5/29/04)

**Adam Yahiye Gadahn** (Wanted for questioning) -- On May 26, 2004, Attorney General John Ashcroft announced that the Justice Department was issuing a new terror alert. Ashcroft named seven individuals who are wanted for questioning for having possible terrorist ties or are current fugitives on the FBI Most Wanted Terrorists List. Adam Gadahn is one of the names on this current terror alert. The FBI says they have been looking for Gadahn to question him for over a year. Although they are not indicating that there is any specific information linking him to specific terrorist activities, the FBI does believe Gadahn attended Al-Qaida training camps and may have served as a translator. Gadahn was born in USA, has family in California and may have a wife and child in Pakistan. Gadahn uses the aliases Adam Pearlman, Abu Suhayb Al-Amriki, Abu Suhayb, Yihya Majadin Adams and Yayah. Gadahn is 25, and 5'11." (See Show #766, OAD 5/29/04)

**Aafia Siddiqui** (Wanted for questioning) -- On May 26, 2004, Attorney General John Ashcroft announced that the Justice Department was issuing a new terror alert. Ashcroft named seven individuals who are wanted for questioning for having possible terrorist ties or are current fugitives on the FBI Most Wanted Terrorists List. Aafia Siddiqui was the only female named on the most recent terror alert. The FBI issued a global warrant for her arrest in March of 2003. Authorities have not yet indicated they have information that she is connected to any specific terrorist activities, but they would like to question her. Siddiqui is a 32 year-old from Pakistan who studied biology at the Massachusetts Institute of Technology. Siddiqui has no known aliases. (See Show #766, OAD 5/29/04)

**Brittany Fish Abductor** (Abduction, kidnapping) -- On Saturday, April 24, 2004, Brittany Fish was abducted as she rode her scooter to a friend's house. Police and neighbors quickly scoured the neighborhood looking for the missing five-year-old but all they found was her discarded Barbie scooter. Then, nearly twenty-four hours later, Fish was found alive. A businessman had been checking out an abandoned warehouse that he was interested in purchasing when he heard whimpering under a tarp. When he pulled the tarp back, he found Fish alive but bound in duct tape. Fish was able to give police a description of her abductor and the vehicle he was driving. He's described as a white, tanned or possibly Hispanic male who is in his 40's, thin and balding with a mustache and lines on his forehead and neck. She said his car has four doors and is white. It also has a gray interior and is described as messy. (See Show #765, OAD 5/22/04)

**Christian Clemente Rodriguez** (Armed Burglary, Sexual Battery) -- On March 12, 1999 Rodriguez and an accomplice broke into an apartment just off the University of South Florida campus. Rodriguez tied up two college students and then both men sexually assaulted one of them. On March 26, 1999, Rodriguez sexually assaulted another USF student in her apartment. This time, Rodriguez created a ruse, saying he was collecting signatures from tenants to have a party. When he confirmed the victim was home alone, he pushed his way in and sexually assaulted her. After being charged with the crimes, Rodriguez fled to Miami and authorities missed apprehending him by just minutes. Cops fear that he's since fled to Puerto Rico. Rodriguez, who has used the aliases Chris Rivera, Juan Antonio Rivera-Soto and Chris Rivers, has a scar on his right wrist and an unknown tattoo on his upper right arm. He speaks both English and Spanish, is known to frequent strip clubs and pick up the dancers, and has fathered a child by a stripper. Both his ears are pierced. He has sold drugs and burglarized cars for money in the past but has no solid work history. Rodriguez is 31, 5'9" and 170 pounds. (See Show #736, OAD 9/20/03)

**Ena McNeish** (Homicide) -- U.S. Marshals are looking for Ena McNeish, who is wanted for killing a man in a head on collision. Marshals say that on July 13, 1992, McNeish borrowed a car from a woman who lived in Albany, NY. She then taped cocaine to her body, and got in the car and drove away. Marshals say that McNeish was speeding along Route 144 in Bethlehem in the early morning and passed a truck in a no pass zone. McNeish slammed into a car head on, and instantly killed a 46-year-old man. Marshals say McNeish was critically injured and taken to the hospital, but was able to flee from the hospital shortly after her admission. McNeish went on the run and hasn't been seen since. McNeish uses the aliases "Foxy," "Pebbles," Nicole LNU,

Ena Jones, Ena Walcott, Ena Edwards, Ena Highgate and Ena Taylor. McNeish is 51, 5'6" and 140 pounds.

**MISSING:**

**Rosa Sandoval**

Age: 12

Height: 5'2"

Weight: 110 pounds

Rosa Sandoval, 12, left her home on Friday, May 25, 2004. According to police, she headed towards Sky Harbor Elementary School, only blocks away from her house and vanished. A crossing guard told police she never made it to the crosswalk less than one-tenth of a mile from her house. Sandoval's parents did not notice she was missing until late in the day. They thought she was at a friend's house but when they discovered she was not, they began to search for her. After they couldn't find her, they reported her missing to the police. Police have spoken to her friends and family who describe her as shy and reserved. She is an honor roll student and has perfect attendance at school. She was last seen wearing a white T-shirt, decorated with a surfboard and light blue lettering, blue jeans and black tennis shoes. She was also carrying a purple backpack. Rosa is Hispanic and has brown eyes and black hair. She has a scar above her left eye and usually wears her hair in a ponytail.

**Mark Anthony Holsombach** (Attempted Murder, Possession of Firearms)

**William James Frazier** (Attempted Murder, Theft) -- Mark Holsombach and William Frazier are wanted by Van Buren County police for the shooting of a state trooper outside their small, makeshift mountain hut in Alread, Arkansas. On the morning of March 22, 2004, several state troopers visited the hut to serve several warrants, including a possession of firearms charge on Holsombach, and to question the pair about the disappearance of Theodore R. Throneberry, 46, and his wife, Ann Ryberg Throneberry, 45, who lived about a half-mile away from the two men. Police say that Frazier and Holsombach were the last people seen with Ann Throneberry. As troopers approached the hut, one of the men fired a rifle shot from inside and hit State Trooper Charlie Edmonson in the arm. Edmonson was hospitalized and released. After the gunshot, the troopers tried to flush the men out with tear gas. Over three hours went by, before the troopers decided to ram the small hut with an armored car, only to discover that no one was inside. Authorities found two bunkers on their property filled with weapons and military gear. They began to search the heavily wooded Ozark National Forest with search dogs, night-vision equipment and a heat-sensing device in a helicopter. The men have managed to evade authorities and are still on the run. Police believe that they are heavily armed and hiding out in caves or bunkers in the forest. Authorities say they are taking many precautions and believe the men may have set booby traps to tie up the search efforts. Holsombach is 49, 6'0" and 176 pounds.

Frazier is 28, 6'0" 200 pounds. On the morning of March 22, 2004, several state troopers visited Holsombach and Frazier's home to serve several warrants, including a possession of firearms charge on Holsombach, and to question the pair about the disappearance of Theodore R. Throneberry, 46, and his wife, Ann Ryberg Throneberry, 45, who lived about a half-mile away from the two men. Police say that Frazier and Holsombach were the last people seen with Ann Throneberry. Authorities found two bunkers on the fugitive's property filled with weapons and military gear. Police say they then began to search the heavily wooded Ozark National Forest with search dogs, night-vision equipment and a heat-sensing device in a helicopter. On Friday, April 2, 2004, Mark Anthony Holsombach and Ann Throneberry were picked up as they walked along a dirt road off Arkansas 7 near Pelsor in southern Newton County. They were taken to the county jail in Jasper, and then moved to the Van Buren County jail. Then, on Saturday, April 3, 2004, a resident of Johnson County heard a description of Frazier over the police scanner. He spotted Frazier on Highway 64 and called the Johnson County Sheriff's Office. A Johnson County sheriff's deputy drove to Highway 64 and found Frazier on U.S. Highway 64 at Coal Hill and took him into custody without incident, according to the state police. (See Show #758, OAD 3/27/04)

*The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.*

## **Wayne Cassidey (Escape)**

**Stafford Lake (Escape)** -- Authorities at the Mountain Institution in Agassiz, British Columbia, Canada are searching for 48-year-old Wayne Cassidey and 55-year-old Stafford Lake. Cassidey was serving a life sentence for the murder of his girlfriend and Lake was serving a 23 year sentence for the brutal rape of a woman from Riviere-du-loup. The director of Kenneth Creek Camp says that on May 8, 2004, Cassidey and Lake were missing from their beds. Staff members at Kenneth Creek believe that sometime before 4:00 a.m., Cassidey and Lake stole another resident's car and fled the camp. The car was later discovered on the side of the road. Searches were conducted, but there were no sightings of either of them. On May 19, 1992, police say, Cassidy strangled his girlfriend, Wanda Marlene Fedorowycz, 44, of St. Catharines, Ontario. Reports say that family friends found her body in her home and phoned police. Police say at the same time they were investigating the crime scene, Cassidey called police from a payphone and turned himself in. He pled guilty and was sentenced to life in prison. Cassidey has a 6" scar on his left wrist, a scar on his face and a tattoo of a heart and "Mom" on his upper right arm. He wears glasses, has a beard and mustache and is balding. Cassidey is 48, 5'9" and 170 pounds. Lake was convicted in 1993 for raping a woman in a bar in Quebec. Records say that he waited in the bar for customers to leave and then approached the woman bartender. He grabbed her by the scalp and demanded money. He then dragged her to the kitchen and raped her. According to police, Stafford then bound and gagged the woman and threw her in the back of his car. He drove a few miles and then dumped her on the side of the road in the snow. Lake has a scar on his left wrist, tattoos of a heart and "Mom" on his upper right arm, "AIGLE" on his back, a skull and a cowboy on his left arm and a skull with wings on his right arm. Lake has a goatee that is closely shaven and a mustache. Lake is 55, 6'1" and 234 pounds.

**Timothy William Berner** (Murder, Bank Robbery) -- Police in Sterling Heights, Michigan are on the hunt for the man who they say killed one of their own. On Friday, June 4, 2004 Sterling Heights police officer Mark Anthony Sawyers was filling out a report in his patrol car when a red Chevy Camaro pulled along the passenger side. The driver of the Camaro, Timothy Berner, fired one shot from a shotgun into the back of officer Sawyer's head. Berner then stole Sawyer's handgun and fled the scene. A surveillance camera from a nearby bank recorded Berner's vehicle fleeing the scene. They believe he may still be driving his 1994 red Chevy Camaro with license plate number YSR497. There have been no confirmed sightings since immediately after Mark's murder. Police believe that Berner's motivation for acquiring Sawyer's handgun would be that it would be a more practical weapon for committing bank robberies. Officer Sawyers joined the Sterling Heights Police Department seven months ago. Prior to joining the force, he was a police officer in Detroit for three years. Officer Sawyers leaves behind a wife and an eleven-month-old daughter. Timothy Berner uses the aliases Tim Smith, Don Jones and Vic (Vengeance). He has several tattoos including USMC on his upper arm, a dragon on his left shoulder, a tribal image on his left forearm and daggers on his inner forearms on both sides. Berner is a large man who is a former semi-pro wrestler and a Desert Storm veteran. He likes to frequent strip clubs and is a heavy drinker who prefers Jack and Coke. He has piercing blue eyes and may have either died his hair or shaved it off. Berner is considered armed and dangerous. Berner is 33, 6'4" and 250 pounds.

**Unknown Cecilia Zhang Killer(s)** (Murder) -- On March 28th, 2004, the Peel Regional Police discovered the body of Cecilia Zhang in Mississauga, Ontario, Canada. Cecilia was a nine-year-old girl who had been abducted from her home in Toronto more than five months earlier. Police say Cecilia was abducted from her home sometime between the late evening hours of Sunday, October 19th, 2003 and the morning of Monday, October 20. Authorities say Cecilia was last seen by her parents when she went to bed Sunday night around 10 pm. Her disappearance was not noticed until Monday morning shortly before 8:30 a.m. when her parents went to wake her up for school. Police believe one or more persons entered her home through the kitchen window. The window had been damaged and the screen pried open. Police say the abductors went to Cecilia's bedroom, and then made their escape with her through a side door. Police say one of their theories is that Cecilia may have been abducted for ransom or some other type of extortion. Police are investigating this theory, but have not ruled anything out in her disappearance. Shortly before her parents discovered her disappearance, there were two hang-up phone calls to the Zhang house. Police have traced the calls to payphones on the western outskirts of Toronto. The first was located at Airport Road and Intermodal Drive in Brampton. The second was about six miles away at Maple Lodge Farms near Steeles Avenue and Winston Churchill Boulevard, also in Brampton. (See Show #739, OAD 11/01/03)

**Richard Emile Newman** (Murder) -- Police in Toronto, Canada are looking for Richard Newman in connection with the murder of Rhoan Gooden. Rhoan Gooden was a security guard at the Tropical Nights Club in Toronto, Canada. On August 4, 2002, Richard Newman entered the club with several of his friends. Gooden approached Newman and told him to remove his headband and stop smoking his cigarette. Although Newman argued with the bouncer, he did take the headband off, but a few minutes later, he was seen putting it back on. About a half an hour later, Newman approached Gooden and fired a single fatal gunshot into the man's stomach.

Gooden died two days later. Gooden was a 32-year-old married man with two young children. Police say that he could still be in Canada or may have crossed into the United States. Newman is from Jamaica and speaks with an accent. He wears his hair in a ponytail or cornrows and may have nerve damage in one of his hands. Newman may seek work in construction or as a short order cook. Newman is 32, 5'10" and 170-200 pounds.

**Ismael "El Mayo" Zambada-Garcia** (Drug Trafficking & Organized Crime) - The Drug Enforcement Agency and FBI are hunting for the man they call their "#1 Most Wanted drug lord," Ismael Zambada-Garcia. He is wanted for the importation of tens of thousands of pounds of cocaine, meth and marijuana. He is also accused of having links to other drug dealers who have been involved in several acts of violence, including the torture and killing of a DEA agent. Zambada, 55, is allegedly the leader of a drug organization based in the Pacific Coast town of Mazatlan. Zambada is also suspected of increasing his power by facilitating the murder of his chief rival, Ramon Arellano-Felix. Police believe Zambada lured him to his home turf and paid the local police to kill him. When Benjamin Arellano-Felix was arrested, police say Zambada took over the remnants of the brothers' operation, becoming the largest and most dangerous drug lord in Mexico. According to authorities, Zambada's organization receives tons of cocaine from Columbia through maritime shipping to the Mexican states of Sinaloa and Nayarit. The drugs are then smuggled with a variety of methods into the United States, and members of the organization then transport the drugs around the country to locations such as Los Angeles, Chicago and New York. The DEA and FBI worked together in a 19-month-long sting called Operation Trifecta, which focused on Zambada's drug organizations and the trafficking. The operation spanned several states and resulted in the arrest of over 240 suspected smugglers related to Zambada's organization. The operation seized nearly six tons of cocaine, 100 pounds of methamphetamine, 25 thousand pounds of marijuana and \$8.4 million in cash from alleged smugglers. Zambada's organization is also suspected in a variety of other crimes, including the death of Tijuana's police chief, Alfredo de la Torre Maraquez, in 2000. According to authorities, Zambada's organization receives tons of cocaine from Columbia through maritime shipping to the Mexican states of Sinaloa and Nayarit. The drugs are then smuggled with a variety of methods into the United States and the members of the organization then transport the drugs to Los Angeles, Chicago and New York. Zambada uses the aliases "El Mayo", El Ingeniero Quinto, Jesus Loaiza Avendano, Javier Garcia Hernandez, and Ishmael Higuera-Renteria. Zambada is 56, 5'9" and 160 pounds. (See Show #754, OAD 2/28/04) Mexican authorities believe that he has recently had plastic surgery to alter his appearance.

**Skerdi Zena** (Attempted Murder) -- Police in London, Ontario, Canada are searching for Skerdi Zena. They say that he randomly attacked a woman in her home. On Saturday, January 31<sup>st</sup>, 2004, at about 3:45 am, Zena broke into a town house via the back window. Inside, a single mother and her four children (ages 3 to 17) slept. After Zena came in through the back window, he took off his shoes and his coat. He then went to the mother's bedroom where he found her sleeping on the bed. London Police say Zena stabbed the mother multiple times and beat her. Cops surmise that Zena thought he had killed her. Police say that he ran out of the house, leaving behind his coat, shoes and cell phone. The victim survived and is currently recovering from her wounds. Cops say there are no previous links between her and Zena. They say he is likely a habitual offender that will continue to commit these kinds of violent acts until he is

apprehended. Zena is an Albanian National who speaks English with a heavy Albanian accent. He works as a day laborer and has recently worked as a roofer. He likes to frequent bars, strip clubs and casinos. Zena has a history of violence towards women and is considered armed and dangerous. Zena, who uses the alias Steve Zana, has a scar on the left side of his upper lip and a tattoo of a lobster on his upper right arm. Zena is 30, 5'8" and 181 pounds. (See Show #763, OAD 5/08/04)

**Hector Armando Dominguez (Murder)** -- On September 20, 1997, the Chaves County Sheriff's Office in Roswell, NM received a tip about the body of a missing person being located off of a local highway. When the police responded, they did indeed find the victim, Edward Sanchez, lying face up with two gunshot wounds to the head. An autopsy later determined that Sanchez had died from those injuries. Investigators questioned friends and family of Sanchez. What they learned from witnesses was that Sanchez had been hanging out with a couple of guys on the night of September, 18, 1997. Police say one of these men was Hector Dominguez. Police believe Dominguez purposely took Sanchez out to that area with the intent to murder him. Police are not exactly 100% sure of a motive. However, they believe it may have to do with something Sanchez had witnessed or possibly due to a debt Sanchez owed Dominguez. Hector Dominguez uses the aliases Armando Dominguez, Dillon White and Dillon Green. He has a tattoo of a dragon on his upper left arm and a scorpion on his upper left arm. Dominguez has relatives in Parral, Chihuahua (Mexico) and may be employed as a day laborer. Dominguez is 28, 5'9" and 154 pounds.

**Jesse James Hollywood (Murder, Kidnapping)** – On August 6, 2000 at approximately 2:30pm 15-year-old Nicholas Sam Markowitz was kidnapped from West Hills, California. He was taken because his brother owed Hollywood and his companions money from a drug deal. Markowitz was taken to the Santa Barbara area where he was held until late in the evening on August 8, 2000. Hollywood and his companions, Ryan Hoyt and Jesse Ruge, walked Markowitz up a trail while a third suspect, Graham Pressley, remained behind at the vehicle. Pressley and Hoyt had been there earlier in the day to dig a grave. Ruge and Hoyt duct-taped Markowitz's hands behind his back and taped his mouth, then put the boy into the grave and shot him in the torso and head. The grave was filled and covered with branches. Hikers found the body on August 12, 2000 and notified officials. Hollywood remains at large. Hollywood, who is known to like guns and expensive cars, may have very short hair. He is 24, 5'4 and 140 pounds. (See Shows #602, #614, #626, #637, #660, #700 and #736, OADs 9/2/00, 12/30/00, 3/24/01, 6/16/01, 1/12/02, 12/14/02 and 9/20/03) Jesse James Hollywood was last spotted in British Columbia, BC Canada.

### **CAPTURED:**

**Dudley Vincent Forbes (Murder)** -- Forbes beat his girlfriend, Lorna, beginning when she was four months pregnant. After the birth of her son, she and her two boys left but Forbes continued to stalk her, threatening to kill her and her whole family. Forbes broke into her apartment, and stabbed her 13 times before fleeing. After being tipped off by a friend, Forbes followed Lorna to a nightclub. After a brief altercation in the club he left, but returned to shoot the place up, killing two and wounding seven. Though usually soft-spoken, Forbes has an explosive temper. He has a welder's certificate and has worked as a forklift driver and compound

mixer. Forbes enjoys playing soccer and dominoes. He is 42, 5'11"-6'0" and 170-180 pounds, and speaks with a Jamaican accent. Viewer tips have placed Forbes in the Flatbush area of Brooklyn, New York, where he may be living under an assumed name. He is believed to be driving a grey 1988 or 1989 Honda with New York plates. (See Shows #404, #414, #443, #538, #555, #593, #670, #686 and #758, OADs 4/13/96, 5/22/96, 3/15/97, 4/17/99, 8/28/99, 7/1/00, 3/30/02, 8/10/02 and 3/27/04) As the years passed, tip after tip told authorities something that they'd suspected all along: Dudley Forbes was back in his native Jamaica. Unfortunately, cops couldn't narrow down his exact location. Members of the Royal Canadian Mounted Police Liaison office in Kingston, Jamaica worked in conjunction with the Jamaica Constabulary Force (JCF) fugitive squad. After more than a year of following leads and developing intelligence on Forbes' possible whereabouts, the JCF officers developed specific information that finally led them to his doorstep on May 6, 2004. JCF officers arrested Forbes at a house in the Lieba Gardens section of Spanish Town, near Kingston. Forbes was unarmed and arrested without incident. His neighbors, who knew him as "Dewey," say Forbes had lived in the house since 1996. Forbes is being held in a Jamaican jail pending a hearing in Jamaica's judicial system to determine if he will, in fact, be extradited back to Canada to finally face justice.

**William "Billy" Gene Myears (Murder)** -- William Myears is wanted by the Brainerd, MN Police Department. According to authorities, Myears is charged with killing Erika Dalquist, 21, whose skeletal remains were found on May 15, 2004. Searchers found Erika's skeletal remains east of Brainerd on a heavily wooded property owned by Myears' grandparents, Norman and Arleen Myears. Erika was last seen leaving a bar in downtown Brainerd on October 30, 2002. According to authorities, Myears was charged with manslaughter in January 2003 after he told investigators he had been at the bar and given Erika a ride that night. According to police, Myears said he couldn't remember if he did anything bad to Erika, but he might have dumped her body in a water-filled abandoned mine pit. However, after searching the pit, authorities did not find anything, and they dropped the charge and released him two weeks later because of a lack of evidence. Authorities then lost track of Myears whereabouts. They believe he may have joined a carnival and left the state. When Erika's remains were found, police recharged Myears with murder and issued a warrant for his arrest. Myears uses the aliases "Billy" or "Cowboy." He has numerous tattoos on his body including a star on his right and left shoulders; a skull on his right thigh; a heart on his chest; a skull with a knife going through it on his upper leg; a knife, not finished, and a blue tattoo on his back; and squiggly lines on his ankle. Myears has many different looks and has been known to dye his hair brown or to even shave it off. Myears has worked on oil rigs, installed garage doors and was last seen working for a traveling carnival in the Midwest. He likes karaoke and his favorite song is "Bad to the Bone." Myears is 25, 5'9" and 155 pounds. (See Show #767, OAD 6/05/04) William Myears was arrested on June 5, 2004 while working the Ferris wheel at a fair in Birmingham, Michigan. Myears was captured shortly after being profiled AMW. His apprehension was a direct result of the broadcast and the 798th capture for the show.

*The following are the featured fugitives and others being sought by federal, state or local authorities. The Update (if any) gives current status, previous references, or related information.*

**Shawn Windsor** (Murder) - On December 28, 2003, Shawn Windsor beat and stabbed his estranged wife, Betty Jean Windsor, and their eight-year-old son, Corey, to death in his home. The Louisville Metropolitan Police Department discovered Corey and Betty's bodies after family members requested a wellness check at Shawn's location. Inside, they found both bodies and an alleged detailed written confession, signed by Windsor. Police believe that Windsor was upset about Betty filing for divorce. In the summer of 2003, Windsor was found guilty of domestic-violence assault. Windsor hit Betty in the face while they were in a car and their son was in the back seat. The July incident led a judge to order Windsor to stay at least 500 feet from his family. Less than four months later, Betty Jean Windsor filed for divorce. Shawn Windsor had refused to accept a December 15th summons mailed to his apartment, leaving the divorce in limbo. Windsor was last seen driving Betty's 1992 maroon Chevy Corisca which has Kentucky plates. Windsor, who is considered armed and dangerous, is described as short-tempered and arrogant. He has bad teeth, a scar on his lower left leg and an "S&A" tattoo on his right arm. He loves NASCAR and University of Kentucky sports and often wears U of K hats, jerseys, and jackets. Windsor likes to doodle and may be supporting himself with odd jobs including building internet websites. Windsor is 40, 6'2" and 220 pounds. (See Show #752, OAD 2/07/04)

**Maria and Carmen Hernandez Killer(s)** (Murder) -- Police in Fremont, CA are looking for the killer of Maria and Carmen Hernandez, a mother and daughter beaten to death as they walked down the street. In the early morning hours of February 1, 2004, Maria's usual ride to work fell through, so she decided to walk there from her Newark, CA home. She wanted to be on time for her 5 a.m. shift as a worker in the laundry room of the Fremont Care Center, a nursing home. Police say that Maria set out alone and left the house at 2:30 a.m. to start the four mile walk to the center. Her daughter, Carmen, quickly decided that she would accompany her mother

for safety purposes, so she left a few minutes behind Maria and quickly caught up with her. Detectives say that as the women walked down Thornton Avenue, a well-traveled, well-lit street, Carmen called her cousin, Hildee Cuellar, to ask for a ride. According to Cuellar, Carmen sounded very calm and didn't sound anxious or concerned. Detectives say that Cuellar drove down Thornton Avenue and when she didn't see the two women, she called Carmen's cell phone. Detectives say that when the cell phone connected, someone was yelling "Hildee" and there was the sound of screaming and foot steps running. Then the phone went dead. At about 2:45 a.m., two witnesses heard screaming outside of their home at the intersection of Alameda and Contra Costa Avenues in a usually quiet neighborhood of Fremont. One witness said he looked out of his front window to see a shadowy figure standing over and beating two figures curled up on the pavement. His son, who had also heard the noises, quickly ran outside to the front lawn to witness a man hovering over the bodies and a late model Honda Accord idling nearby with its lights off. Detectives say that the suspect dropped an object and started running down the street. The witness also told police that as the Honda drove off in the opposite direction, it turned on its headlights. The witness saw as many as three other people inside. Maria and Carmen Hernandez lay dead, brutally beaten on the pavement of the street corner. Detectives say that the suspect is described as a white male, in his 20's or early 30's. He's about 6'-6'2", 180-200 pounds and was wearing a jean jacket with tan sleeves. The car is described as a light-colored, two-door Honda Accord, circa 1988-92. Police recovered the murder weapon, which the suspect had dropped at the scene. It is described as a thick tree branch, approximately 20 inches long and a few inches thick. Police say that this would be an odd weapon to carry as a murder weapon, so they are looking into whether there was any tree trimming in the area where the suspect might have picked it up upon opportunity. Police hope other witnesses might have seen the man and/or his accomplices pick up the piece of wood from that yet-to-be-determined location.

**Timothy William Berner** (Murder, Bank Robbery) -- Police in Sterling Heights, Michigan are on the hunt for the man who they say killed one of their own. On Friday, June 4, 2004 Sterling Heights police officer Mark Anthony Sawyers was filling out a report in his patrol car when a red Chevy Camaro pulled along the passenger side. The driver of the Camaro, Timothy Berner, fired one shot from a shotgun into the back of officer Sawyer's head. Berner then stole Sawyer's handgun and fled the scene. A surveillance camera from a nearby bank recorded Berner's vehicle fleeing the scene. They believe he may still be driving his 1994 red Chevy Camaro with license plate number YSR497. There have been no confirmed sightings since immediately after Mark's murder. Police believe that Berner's motivation for acquiring Sawyer's handgun would be that it would be a more practical weapon for committing bank robberies. Officer Sawyers joined the Sterling Heights Police Department seven months ago. Prior to joining the force, he was a police officer in Detroit for three years. Officer Sawyers leaves behind a wife and an eleven-month-old daughter. Timothy Berner uses the aliases Tim Smith, Don Jones and Vic (Vengeance). He has several tattoos including USMC on his upper arm, a dragon on his left shoulder, a tribal image on his left forearm and daggers on his inner forearms on both sides. Berner is a large man who is a former semi-pro wrestler and a Desert Storm veteran. He likes to frequent strip clubs and is a heavy drinker who prefers Jack and Coke. He has piercing blue eyes and may have either died his hair or shaved it off. Berner is considered armed and dangerous. Berner is 33, 6'4" and 210-220 pounds. (See Show 6/12/04, OAD 6/12/04) Police believe that he may have lost weight dropping from 250 to 220 pounds.

**Andre Neverson** (Wanted for Questioning for Murder) – On Monday, July 8, 2002, NYPD cops arrived at the Brooklyn home of 39-year-old Patricia Neverson. She was found, shot to death. Three days later, on July 11, cops found the body of 34-year-old Donna Davis. Authorities have learned that Andre Neverson had an ongoing argument with his sister, Patricia, stemming from Andre's money which she used to buy her home. Neverson did not want the money repaid; instead, he wanted the house. Donna Davis had been dating Andre, but she had recently broken off the relationship. Neverson did not take the rejection well. The last time Donna was seen alive, she was in Andre's minivan outside a Queens, New York college where she studied. Days after the second murder, cops placed Neverson in Brooklyn, but after that, the trail runs cold. Neverson has used numerous aliases including Troy Michael Anderson, Troy Michael Henderson, Trey Michael Henderson, Andre Humphrey and Andre Henderson. He has a very muscular build and a shaved head, but he may be starting to grow hair again to change his appearance. He does not drink or smoke, is very intelligent and computer literate. At times he is very calm and serene, but he has a violent temper and has served time for attempted murder. He does not drink or smoke, and may be hidden now by one of his many girlfriends. He is originally from Trinidad, but does not have an accent. He has worked as a bouncer in Caribbean clubs and as a security guard at a hospital. He has been know to buy cars, fix them up, then resell them. He may still be armed. Neverson is 40, 6'2" and 225 pounds. (See Shows #684, #697, #723, #743 and #755, OADs 7/27/02, 11/16/02, 6/14/03, 12/06/03 and 3/06/04)

**Randolph Franklin Dial** (Escape) -- Randolph Dial is wanted for escape from a medium security prison in Granite, Oklahoma on August 30, 1994. Dial escaped from the prison around 11:30 a.m. and took Bobbie Parker, the deputy warden's wife, with him. Agents believe Dial used Parker's van to leave the prison grounds. After the escape, police say Parker made several calls to family and friends saying that she was okay and that she would be home soon. The last phone call came on September 9, 1994. Neither Dial or Parker have been seen since. The van was recovered in Wichita Falls, TX on September 1, 1994. Dial was serving a life sentence for the 1981 murder of Kelly Hogan in Broken Arrow, Oklahoma. Dial confessed to the murder which he claimed was a contract killing for the mob. Broken Arrow police never discovered who hired Dial to kill Hogan. In 1998, author Charles Sasser wrote a book about Dial entitled, " At Large: The Life and Crimes of Randolph Franklin Dial." On November 9, 2001, Sasser claims Dial called him on the phone and the two spoke for approximately 45 minutes. Sasser also says he spoke with Parker. Agents were not able to trace the call but they believe Dial made the phone call. Dial's numerous aliases and nicknames include "Doc" Dial, Randolph Franklin Johnston, Randolph Franklin, Randy F. Johnson and "Doc" Franklin. He has a small scar under the left side of his chin, two small scars on his upper left chest, and a small round scar on the back of his left calf. His teeth are in poor condition and he may be missing one or two lower front teeth. He is a heavy drinker, speaks Spanish, and may talk about having been in the mob or claim to have been a government informant. He may be doing artwork as an occupation or means of income, and may be traveling with Bobbie Parker. Dial is 59, 5'9" and 150 pounds. (See Show #717 and #741, OAD 5/03/03 and 11/15/03)

**Bobbie Louaine Parker**

Age: 42

Height: 5'5"

Weight: 120 pounds

Bobbie Parker has been missing from Granite, Oklahoma since August 30, 1994. Bobbie was married to Randy Parker, a deputy warden at a medium security prison in Granite. They lived on the prison grounds with their two young daughters. Randolph Dial, an inmate serving a life sentence for murder, was assigned to do yard work at the Parker's house. Dial also ran a prison pottery program in a garage off Bobbie's house. On the morning of August 30th, Bobbie told her husband she was going shopping for the day. Agents believe Bobbie left the prison around 12:30 p.m. Later that day, guards discovered that Dial was missing. Investigators believe that Dial kidnapped Bobbie and escaped from the prison in her vehicle. Bobbie made several phone calls to friends and family, stating that she was okay and that she would be home soon. The last phone call was made ten days after the escape. Bobbie's vehicle was found abandoned in Wichita Falls, Texas. Neither Bobbie Parker or Randolph Dial have been seen since the escape. (See Shows #717 and #741, OADs 5/03/03 and 11/15/03)

Officials in Independence, Missouri are desperately searching for a missing brother and sister, eight-year-old Lindsey and seven-year-old Samuel Porter. They were last seen when their father picked them up for a visit on June 4, 2004. On that day, Samuel and Lindsey were picked up for the weekend by their father for a court-ordered visit. But when it was time to return the kids to their mother, 41-year-old Daniel Porter never showed. Cops say he began making calls to the mom threatening to kill himself and their children. Cops quickly arrested him. However, he is refusing to reveal the whereabouts of the children. According to police, the only thing he will say is that he left the children with a stranger. Police say Daniel also has a long history of domestic violence. Investigators say they found the clothing of Sam and Lindsey along Highway 6 outside Trenton, MO, not far from Daniel's neighborhood. The clothing found includes a girl's shirt and a boy's pair of pants. The clothing articles were apparently what the children had

packed for their visit with their father. When Samuel was last seen, he was wearing a tan and orange shirt and blue sweatpants. When Lindsey was last seen, she was wearing a blue shirt and red sweatpants. Lindsey has brown hair and blue eyes. Samuel goes by the nickname Sam. He has brown hair and blue eyes.

**CAPTURED:**

**Unknown Indy Female Bank Robber (Robbery)** -- Police in Indianapolis, Indiana are looking for a female who robbed an Eastside bank. On October 9, 2003, shortly after 10 a.m., a black male and female entered the Fifth Third Bank on the Eastside of Indianapolis, IN. The woman approached the teller counter and got in line. The male stood in the back and pretended to fill out a deposit slip. When the woman approached the teller, the man left the bank and returned to the vehicle. The female handed the teller a note saying, "I have a gun, give me the money, no dye pack." Police say when she got the money, she ran to a car parked on the far side of the parking lot. She and the male fled from the bank in a mid 80's, dark colored, 4-door Cadillac and have not been seen since. The female bank robber is 25-30, 5'7" and was wearing a black t-shirt with "New York 34" written on the front and her hair in a ponytail. The male was wearing blue jeans and a light colored shirt and hat. (See Show #765, OAD 5/22/04) Thanks to alert AMW viewers, the Unknown Indy Female Bank Robber was identified as Naomi Betts. Betts was arrested on May 27, 2004 at her mother's home in Sikeston, Missouri. Betts' arrest is a direct result of tips to the AMW Hotline.
