Screening Report

The following are the featured fugitives and others being sought by federal, state or local authorities. The <u>Update</u> (if any) gives current status, previous references, or related information.

Andre Neverson (Wanted for Questioning for Murder) - On Monday, July 8, 2002, NYPD cops arrived at the Brooklyn home of 39-year-old Patricia Neverson. She was found, shot to death. Three days later, on July 11, cops found the body of 34-year-old Donna Davis. Authorities have learned that Andre Neverson had an ongoing argument with his sister, Patricia, stemming from Andre's money which she used to buy her home. Neverson did not want the money repaid; instead, he wanted the house. Donna Davis had been dating Andre, but she had recently broken off the relationship. Neverson did not take the rejection well. The last time Donna was seen alive, she was in Andre's minivan outside a Queens, New York college where she studied. Days after the second murder, cops placed Neverson in Brooklyn, but after that, the trail runs cold. Neverson has used numerous aliases including Troy Michael Anderson, Troy Michael Henderson, Trey Michael Henderson, Andre Humphrey and Andre Henderson. He has a very muscular build and a shaved head, but he may be starting to grow hair again to change his appearance. He does not drink or smoke, is very intelligent and computer literate. At times he is very calm and serene, but he has a violent temper and has served time for attempted murder. He does not drink or smoke, and may be hidden now by one of his many girlfriends. He is originally from Trinidad, but does not have an accent. He has worked as a bouncer in Caribbean clubs and as a security guard at a hospital. He has been know to buy cars, fix them up, then resell them. He may still be armed. Neverson is 38, 6'0" and 225 pounds. (See Shows #684 and #697, OADs 7/27/02 and 11/16/02)

Guillermo Del Prado (Drug Charges) – On the night of January 20, 2002, U.S. Customs agents were on routine patrol in the air looking for suspicious vessels out at sea. Around 11:30pm they spotted a go-fast boat driving fast without its lights on. Customs agents say that

this is a classic drug smuggling method. U.S. Customs called in their go-fast boat to follow the suspicious vehicle. They followed the boat in the water and in the air. From video shot from the helicopter, there is evidence of the smugglers throwing out bales of marijuana and then landing on Miami Beach just near the Fountainbleu Hotel. All three occupants jumped from the boat and ran onto the busy streets of Miami Beach. Customs agents chased them on foot. With the help of citizens who pointed out the direction of the suspects, agents arrested two of the three drug smugglers. One of the arrested men was picked up in the Bahamas and paid \$3,000 for a ride. He was not involved in the drug smuggling and is cooperating with authorities. The second man in custody is believed to be the middle man between the drug pick up point in the Bahamas and the drop off point in Miami. The third man, who is at large, Guillermo Del Prado, is the transporter of the drugs. Del Prado is probably traveling with his wife, Ginny Del Prado, who was nine months pregnant at the time of her husband's last arrest. They most likely have a baby with them. Del Prado is 27, 5'9" and 240 pounds. (See Show #676, OAD 5/18/02)

Dimitrios A. Androutsopoulos (Murder) - Androutsopoulos and three accomplices, brothers John Boyd, Brian Boyd and Steven Howerton, went to the trailer home of Dwight Vice on the night of May 4, 2001. Dwight, a commercial fisherman, lived with his 12-year-old son Darryl. John Boyd was a friend of Dwight's. The four men intended to rob Dwight Vice of money and marijuana. During the course of the robbery, the four tortured Dwight and his son Darryl by repeatedly strangling and beating them while demanding to know where Dwight's money and drugs were stashed. Young Darryl's spinal cord was severed by a stab wound to the back and he was strangled until the men thought he was dead. His father was stabbed and strangled to death. Androutsopoulos and his crew fled the scene believing they had killed Dwight and his son. The next morning Dwight's co-worker stopped by the trailer to pick Dwight up for work and found the horrific scene. Incredibly, little Darryl was still alive. The 12-yearold was able to identify his father's "friend" John Boyd as one of the attackers. Police arrested the Boyd brothers and Howerton, but Androutsopoulos slipped out of the area and remains at large. Darryl was left permanently paralyzed by the stab wound to his spinal cord. Androutsopoulos, who may associate with members of the Latin Kings street gang, has worked at a meat processing plant. He may have a mustache and goatee. Androutsopoulos is 27, 5'7" and 160 pounds. (See Show #665, OAD 2/16/02)

Edward Paul Morris (Murder) – Morris murdered his pregnant wife and three children on a logging road in the Tillamook State Forest in Oregon. Renee Morris, 31, was found 20 yards off the road by an elk hunter and his son in the early morning hours of Saturday, December 21, 2002. The bodies of 10-year-old Bryant, 8-year-old Alexis and 4-year-old Jonathan were discovered by police nearby when they arrived on the scene. The Morrises lived in Portland, Oregon, about 70 miles east of the forest, and had been struggling financially. The killings

occurred sometime between Thursday, December 19 and their discovery on the 21st. Morris is on the run in the family van. The vehicle is a 1993 gray Dodge Caravan with Oregon license plates WSH 171. The car has two stickers on the back windows: "Luis Palau" (a Beaverton, Oregon-based Christian evangelist) and "Promise Keepers". Morris, who is known to be religious, wears prescription glasses and has worked in roofing, landscaping and commercial cleaning. Morris is 37, 6'0" and 200 pounds. (See Show #702, OAD 12/28/02)

Armando Garcia (Murder) – Armando Garcia is an extremely violent Mexican national who was wanted in Los Angeles in connection with two attempted murders. On April 29, 2002, Los Angeles County Sheriff's Deputy David March pulled Garcia over on a routine traffic stop. Garcia got out on the drivers side of his 1989 black four door Nissan Maxima and approached Deputy March. When the deputy attempted to frisk Garcia, he was immediately shot multiple times in the face, neck and chest area. Garcia got back in his car and fled the scene. Deputy March died. Garcia, who has used the alias Daniel Garcia and the nickname "Chato", has "Garcia" tattooed on his shoulder blade. A professed cop hater, he doesn't go anywhere without his 9mm gun. Garcia is 25, 5'10"-6'0", and 230 pounds. (See Shows #674 and #675, OADs 5/4/02 and 5/11/02)

Anthony Fu Yin Chang (Murder) - The United States Postal Service has issued a warrant for Anthony Chang for conspiring to mail a bomb disguised as a toy dog to Patrick Hsu, the younger brother of Chang's ex-wife, Wendy Hsu. The bomb exploded, killing Patrick Hsu almost instantly. The investigation led to Anthony Chang's friend David Lien who mailed the package from Milpitas, California while Anthony Chang was under house arrest with an electronic ankle control in Las Vegas. Lien is in custody and is awaiting trial for the same charges as Chang. The bombing ended the turbulent relationship between Anthony and Wendy, which had included domestic violence. They were briefly married, and when she filed for and got a divorce, the bomb was mailed within a month. Chang has several tattoos, including the Chinese symbol for Kamikaze inside his left forearm (a Chinese gang affiliation sign), a yingyang symbol topped by an eagle with "Anthony" above it on his right shoulder, the Chinese symbol for "Wendy" on his upper left chest and "Wendy" in English characters on his upper right chest. He likes motorcycles, has worked in a mechanic's shop, and had a maroon and cream Suzuki Marauder. He has very thick facial hair, very prominent eyebrows, and sometimes wears a goatee. He has a violent temper and has been known to hit people in public. He may be involved with cocaine and marijuana dealers. Chang is 32, 5'8" and 160 pounds. (See Shows #692 and #696, OADs 9/21/02 and 11/9/02)

Francisco Martinez (Murder) – Martinez shot his both, Michael Cerullo, in the back of the head on September 14, 2001. Cerullo was an owner of Yofi Textiles in Passaic, New Jersey.

Martinez, the warehouse manager, was also the lead suspect in an arson that occurred a few weeks prior to the murder. Friends and family of the two men were puzzled by the murder because the two were also very good friends. They had known each other for thirty years and would often spend time together outside of work. Martinez was stealing textiles from the company, selling material for cash and not reporting the money. Francisco tried to burn down the factory to cover up the crimes. Cerullo became suspicious of Francisco and may have had a confrontation about the theft and arson. Cerullo was found in the basement of Yofi Textiles with a bullet wound to the head. A few days later police divers found the murder weapon in the Passaic river. By this time Francisco had disappeared. Martinez, who has used the alias Francisco Martinez Seminari, has a scar on his abdomen, psoriasis on his head and neck leaving bumps and a rash that looks like a birthmark, a discolored front tooth. He always wears baseball caps to cover his discolored balding head, and has an extensive collection of caps. Martinez is 41, 5'8" and 350 pounds. (See Show #688, OAD 8/24/02)

Unknown Baton Rouge Serial Killer (Murder) – On September 24, 2001, Gina Wilson Green, 41, was strangled in her home. Then, on May 31, 2002 Charlotte Murray Pace, 22, was stabbed to death in her townhouse. On July 12, 2002, Pam Kinamore, 44, was taken from her home. Her body was found July 16 off Interstate 10. Her throat had been cut. On July 29, 2002 a press release announced that all three cases have been linked by DNA. There are no obvious threads to bind the three women together, but police say that their murders were committed by the same man. All three families are working together to find a link between the three victims, a clue that could lead to the serial killer. As of now, the only information released was that the man, aged 25-35, was wearing size 10 or 11 Rawlings tennis shoes during one of the murders. The suspect may be driving a white 1996 or 1997 Chevrolet pickup, may have had scratches or bruises on his face or body from the May 31st murder, and is probably able to lift about 175 pounds. (See Show #692, OAD 9/21/02)

Loren Preston Key (Attempted Murder, Kidnapping, Carjacking) -- Loren Key shot two police officers and a civilian victim in an early morning rampage on Saturday, May 18, 2002. Shortly after midnight on May 18, Key kidnapped his girlfriend and her male friend at gunpoint. As Key was in the passenger seat, he threatened them at gunpoint. The male friend drove around town, following Key's directions, throughout the night. Around 2:00am, Key let his girlfriend out of the car at her home. Key and the male driver continued to drive around. Once free, Key's girlfriend called 911 to report the kidnapping. Police in the area searched for the automobile the two men were known to be driving. At around 8:15am, two police officers, one male and one female, found and pulled over the vehicle. Key came out of the car shooting. They say he first shot the male officer in his arm and hand and then turned and shot the female officer in her side. With both officers down, Key then fled on foot. Cops say that Key then carjacked a

vehicle at gunpoint. As he attempted to drive the car away, the car stalled. Authorities say he abandoned the stalled vehicle and carjacked another male driver. Key shot the man in his neck, pulled him from the car and attempted to drive away in his vehicle. Key stalled that vehicle as well. This time he fled on foot. Key has not been seen since. Key has both ears pierced once. He is 32, 5'11" and 230 pounds. (See Shows #677 and #691, OADs 5/25/02 and 9/14/02)

Michael Blane Brashar (Murder) – On March 30, 1982, the body of 20-year-old Mary Ann Castille was found in a Houston, Texas bayou. She was raped, strangled, and left partially nude. Police had no suspects and had interviewed all of the teenager's friends, including 14year-old Lisa Dawn Hoag. On July 1, 1982, a week after police interviewed Lisa, her body was found raped and strangled in a school yard. A tip led detectives to Michael Blane Brashar, who was 21 at the time. He lived in the same apartment complex as Lisa, and he knew both girls from hanging out at a local convenience store. Brashar was arrested and held for unpaid traffic tickets. Detectives grilled him, took a blood sample, gave him two lie detector tests which he flunked, and took a shoe cast of his sneaker. All of the evidence they had was circumstantial, so police were forced to release him. All along, Sgt. Boyde Smith of Houston homicide, believed Brashar was responsible for the two murders, but he couldn't prove it. It remained a cold case until 199 when DNA testing became available. Sgt. Smith reopened the case. He found out that the semen sample in Mary Ann Castille's case had become tainted, but the sample in Lisa Hoag's case was usable. Their crime lab conducted a DNA test comparing the semen to Brashar's 1982 blood sample. The test results indicated that Brashar was indeed their suspect. After almost 20 years, detectives know who killed Lisa Hoag, and suspect he was involved in Mary Ann Castille's case. Sgt. Smith put out a nationwide alert to all police departments. He didn't receive any solid leads. On March 16, 2001, Houston police filed capital murder charges against Michael Brashar. Brashar, who has used the aliases Mickey T. Craft, Mickey Graft, and Doyle R. Brashar, has a scar on his right forearm. He has worked in construction and is known to frequent homeless shelters and churches. Brashar is 41, 5'10" and 175-200 pounds. (See Show #662, OAD 1/26/02)

On December 24, 2002 at 5:48pm Scott Peterson called the Modesto, California police stating

that his pregnant wife had not been seen since 9:30am that day. Laci Denise Peterson, eight months pregnant, stayed home to shop for dinner and to walk their dog at East La Loma Park, also known as Dry Creek Park. Scott, her husband, went fishing. He tried to call Laci from his cell phone during the day but could not reach her. When he arrived home, he found his dog in the back yard with the leash still attached. There was nothing unusual found in the house to indicate anything had happened. Laci's purse was still in the house. Scott and family members began searching the park and called police. The police began a search of the park and the Dry Creek area. The Stanislaus County sheriff's department helicopter was called in to assist with the search as well. On Christmas morning, the Water Rescue Units from Modesto City Fire Department and Stanislaus Consolidated Fire assisted too. Canines and equestrian teams were used to further the search. The search continues for Laci, looking for any clue that could lead police to her. Laci Peterson has a tattoo of a sunflower on her left ankle. She was last seen wearing a white long sleeve shirt and black pants.

As of now, the only information released was that the man, aged 25-35, was wearing size 10 or 11 Rawlings tennis shoes during one of the murders. The suspect may be driving a white 1996 or 1997 Chevrolet pickup, may have had scratches or bruises on his face or body from the May 31st murder, and is probably able to lift about 175 pounds. (See Shows #692 and #703, OADs 9/21/02 and 1/4/03)

Andrew Luster (Rape, Kidnapping) - Cosmetics heir Andrew Luster is a serial rapist. He has a history of meeting women in bars, bringing them home, drugging them, raping them, and then videotaping his exploits. Sheriff's investigators were called to Luster's home two years ago after a college student accused the wealthy playboy of drugging and sexually assaulting her. At the home they did not find GHB but they did find six bottles labeled "Spanish Fly Hypnotic Hypo-Knock-Out Drops". They also recovered a video camera and 17 videotapes which depicted Luster raping two unconscious women. Luster was charged with 87 counts including sexual battery, sodomy, drug possession and poisoning. Luster has been under house arrest for one year. His bail was set at one million dollars. Luster pleaded not guilty to all charges, claiming it was consensual sex. On December 16, 2002 the trial began. A former girlfriend of

Luster's wept on the stand as she reviewed a tape of her being raped by her former boyfriend. There were several other women who came forward to tell their horrific tales. On January 6, Luster failed to check in with his probation officer and violated his bail. He was scheduled to appear in court that day but never showed up. An arrest warrant has been issued for the millionaire sexual predator. On January 21, 2003, Andrew Luster was convicted on 86 criminal counts. Luster, who sometimes uses the nickname Drew, is an avid surfer who likes to be close to the water and likes to hang out at local bars. He has traveled extensively, has an interest in Indian artifacts, and has contacts throughout the world. He may be traveling with a woman companion, and may be traveling under an alias with false identification. Luster is 39, 6'0" and 210 pounds.

Joseph Michael Grate (Murder) - Gates is wanted for a string of charges including the homicide of Derick D. Williams on the night of February 14, 2001. The men knew each other and the altercation was possibly a result of a dispute they had earlier that same day. Around 11:00pm Grate shot Williams in the head and fled the scene. Authorities believe Grate has left the Hampton, Virginia area, but still comes back into town, perhaps as often as once a month. Grate, who has used the alias Mike Gardner, has numerous tattoos including one on the right side of his neck. He is known to wear his hair in an Afro or cornrows and usually wears a goatee. He frequents nightclubs and the Riverdale Apartments and Shopping Center. Grate is 23, 5'9" and 145 pounds.

AMW ALL-POINTS BULLETIN:

Victor Manuel Rodas (Murder) – Rodas attacked his housemate, 60-year-old Juan Ramirez. Rodas had been drinking most of the day and when he ran out of alcohol went to Mr. Ramirez's room looking to borrow money. When Ramirez refused to give Rodas the money, Rodas viciously attacked him with a machete. Ramirez died before an ambulance arrived. After the attack Rodas persuaded two acquaintances to drive him to a Greyhound bus terminal in Delaware. There are no records to show that Rodas ever got on a bus. Police have also learned that the suspect's name may actually be Jose Manuel Medrano. Rodas, who has also used the aliases Hector Ascencio and Victor Manuel Rodriguez, is known to always carry a knife or other blade. He has worked as a day laborer on construction sites and in factories. Rodas is 42, 5'8" and 185 pounds.

Scott James Brinegar (Robbery, Threats to Bomb) -- "He had these wild-looking eyes. I knew I had a fruitcake in front of me... he looked crazy...I felt sick to my stomach." This is the reaction of a teller at the Signet Bank on Warwick Avenue in Newport News, Virginia, when a

strange man walked through the bank's front door on August 6, 1996. Moments later, the teller was looking at a nylon lunch bag with a strange assortment of wires sticking out the top. The man in front of her told her it was a bomb, and he was ready to detonate it, killing himself and her, unless she loaded him up with \$20,000. She believed him. She gave the man all she could -\$6,371 to be exact, and thankfully watched the "fruitcake" leave the building. But the bag he left behind. Soon the bomb squad was on the scene, and x-rays revealed that there was no bomb just a haphazard arrangement of wires and duct tape. One of the customers told officers he had watched the robber duck around behind a bar across the street. When police investigated, they found what they now call the trailer of drifter and ex-con Scott James Brinegar. Brinegar's toilet was lined with his own hair - police say after the robbery he gave himself a quick trim to help hide his identity. America's Most Wanted's forensic artists have rendered a photo, shown above, to show what he might look like in his new coiffeur. The evidence police say they uncovered in Brinegar's lair included more wires and duct tape and a letter to a former cellmate in which he bragged about becoming the next "Unabomer." Police went out on the town to look for more leads. Later that day, they got a tip that Brinegar was headed for Illinois on a Greyhound bus. The last departure had a stop in Pittsburgh, so police there were informed and ready when the bus arrived. They found a man who matched his description on the bus, and allegedly found two weapons and \$3,400 in his possession. But when he was fingerprinted, no match. It turned out that this was not the fugitive Brinegar, but the fugitive David Lee Patterson, wanted by the Chesapeake, Virginia, police for murder. Brinegar, meanwhile, apparently has vanished without a trace. Brinegar has several tattoos including a Pink Panther on his right leg and a Viking on his left leg. He is a smoker and beer drinker, and has worked as a carnival ride operator. He has prior arrests for shoplifting, burglary, and possession of cocaine. Brinegar is 35, 6'0" and 165 pounds. (See Shows #464, #500, #529, #578 and #604, OADs 9/6/97, 6/20/98, 2/13/99, 3/4/00 and 9/23/00)

Phillip Lloyd Ferguson (Securities Fraud) - Ferguson stole between \$22 and \$50 million dollars from about 500 clients who invested with his firms. He had operated his four businesses in Marion, Indiana for about 20 years. During the late 1990's Ferguson began to steal money from his clients who had invested in one of his commodity pools. He stole mostly from teachers, factory workers and farmers. In June 2000 the Commodities Futures Trading Commission began to investigate Ferguson, and he took off. Ferguson relocated to Golden, Colorado where he used the aliases William Allen Russell, Al Russell, Richard Gladius and Roy Vernon Cox. Before authorities caught up with him, he fled aga in November 2000, leaving his car, furniture and personal belongings behind. The money Ferguson stole has not been recovered. Ferguson has a four-inch surgical scar on his neck and a scar on his upper left arm. He is left-handed, and may wear a full beard. He uses the Internet and singles club to meet women, and likes to date women with children. He is an avid gambler who likes to play craps, and likes to frequent strip clubs

and local bars. He likes to make lists. He has interests in farming, ranching, cattle and horses, and wants to learn to fly a plane. He drinks Bud Lites and White Russians, makes his own Kahlua, and smokes Mariboro Lights 100's. In addition to the investment companies, he has also owned a bridge construction company. Ferguson is 52, 5'11" and 185 pounds.

They showed the family a photo of Scott posing with the women; the photo was dated mid-December on a day that he told Laci he was away on a business trip. Laci's brother Brent says that Scott later admitted to this and other affairs. Laci's family cut off communication with Scott and they say that he initially lied to them about the affair, and possibly other things. They say that Scott's demeanor in the last couple of weeks has been unusual in that he has been playing golf, disappearing for lengthy periods of time, has hired a defense attorney, has not been open with them, and has met with a realtor about selling the house. Police have not named Scott a suspect, but are asking for

the public's help in placing Scott on the day of Laci's disappearance. Laci Peterson has a tattoo of a sunflower on her left ankle. She was last seen wearing a white long sleeve shirt and black pants. (See Show #703, OAD 1/4/03)

One day later, Kyle McElroy's body was found in rural Cherokee County, Texas. The investigation led to the arrest of three men: Daniel Rios, Ernesto Bailon and Alfredo Romero. Investigators believe that Rios had been an employee at McElroy plastics and had worked with Kyle McElroy. Still on the run is Desiree Dawn Lingo-Perkins. She is a known prostitute who was an active participant in the planning and execution of the abduction and murder of McElroy. She was responsible for making several ransom calls to the McElroy family demanding money. Lingo-Perkins is known to have family in Beaumont, Texas and Barling, Arkansas. She also a teenage daughter residing somewhere in Connecticut; two other children died in a car accident in 2002. She has supported herself for years as a prostitute in the Latin American immigrant community. Her familiarity with this community may lead her to attempt to escape to Mexico. Lingo-Perkins, who has used the alias Esperanza Perkins, has a tattoo on her right ankle and a scar on her abdomen. She is suspected to be HIV-positive. Lingo-Perkins is 34, 5'6" and 170 pounds. Steven Harrison (Attempted Murder, Arson, Kidnapping)

Tamika A. Hamilton (Wanted for Questioning) - On April 27, 2002 21-year-old Don Bryant allowed his friends to bring an exotic dancer to his home. The dancer was a woman named Tamika Hamilton. Don's friends met her at a strip club in Myrtle Beach, North Carolina.

The gunmen demanded money from Jason and Don. Jason's girlfriend hid in a back bedroom closet. When Don told the armed invaders that he did not have any money, don was Shot in the leg. Don the tried to run out the front door but he was shot down. The attackers poured gas inside the house and set it on fire. Jason was told that if he tried to escape the burning house, he would be shot as well. Harrison and his partner then took off. After several minutes, the house was engulfed in flames. Jason grabbed his girlfriend and began to navigate his way out of the house. Jason through Don died form the gunshot wounds and told his girlfriend they would leave Don behind. Don heard Jason and told them he was not dead yet. Jason dragged Don to his truck and rushed him to the hospital. Don miraculously survived his injuries but is currently paralyzed from the chest down. Police identified and charged Harrison with attempted murder. Detectives have yet to identify Harrison's partner, and also want to question Tamika Hamilton in this case. Harrison, who has used the alias Steven Malone, may wear his hair in cornrows and may have facial hair. He may be traveling in a late 1970's to early 1980's red Chevy van, perhaps with his partner, a lightskinned clean-shaven black male with a short fade haircut; he may also be traveling with Tamika Hamilton. Harrison is 25, 5'8" and 175 pounds. Hamilton has used the alias Takeisha Jones and the stage name "China". She is 20, 5'4" and 105 pounds.

Hazel Leota Head (Murder, Arson) -- Hazel Leota Head is wanted for the murder of Charles Barker on September 2, 1998 in Benton, Louisiana. Barker was shot in the back of the head as he sat at his trailer counter. Police found a murder weapon and say physical evidence points to Hazel Head. Hazel had met Barker at a local casino under the name Deianna Ray. She subsequently moved in with him. When Barker's body was found, his cash and his car were gone. Upon further investigation, police found that there was an outstanding warrant for Hazel's arrest in Nebraska, where she is accused of burning down a boyfriend's trailer. Police also learned that Hazel has a history of moving around. She has been married multiple times, to as many as ten different men. She has lived all across the country. Head has many aliases, including Hazel Morgan, Willow Shields, Hazel Foley, Kelly Morgan, Hazel Spurbeck, Hazel Haynes, Hazel Vincent, Deianna Ray, Hazel Woodman, Hazel Fautch, Treasa "Tess" Jean Coyle, and Treasa "Tess" Venable. She has a noticeable gap between her front teeth. She is a smoker and drinker, favoring vodka. She often works as a waitress, and hangs out a truck stops, often traveling with truckers. She frequents casinos and places personal ads looking for men. A truck driver believes the woman he picked up in Madisonville, Kentucky and drove to a truck stop in

Woodhaven, Michigan was Head. The woman told the trucker she was trying to get to Las Vegas. Head is 53, 5'2" and 120 pounds. (See Shows #527, #528, #533, #545, #560, #562, #574 and #671, OADs 1/30/99, 2/6/99, 3/13/99, 6/5/99, 10/2/99, 10/16/99, 1/29/00 and 4/6/02)

Svetlana Vitman (Murder) -- American businessman Preston Brooks fell in love with Vitman in Russia and smuggled her into the United States illegally. Once in the U.S., Vitman fell in love with another woman. Vitman became tired of Brooks and shot him on the night of June 6, 1994, while he slept in a motel room after they had sex. Two months after her profile first aired on America's Most Wanted, Vitman surfaced in Amsterdam. On July 30, 1995, she surrendered herself to Dutch authorities. After authorities arranged to have her escorted back to the U.S., Vitman changed her mind and simply walked out of the Amsterdam hotel the police had puther up in. She has not been seen since. Vitman, who has used numerous aliases including Svetlana Kojurne, Svetlana, Kojourina, and Svetlana Kozurian, speaks English with a heavy accent. She is a heavy smoker, a bisexual who frequents lesbian bars, and enjoys the beach, coastal areas and snow skiing. Vitman is 38, 5'8" and 110 pounds. William Dewey Kittrell (Murder) – Kittrell ambushed his estranged wife, Glenda, on June 1, 1999 as she was returning home from work. She was shot and killed with a high-powered rifle. In march 1999, before the murder, Kittrell allegedly abducted Glenda and took her into the woods surrounding her home. There he showed her a grave and told her she would soon be in it. Screening Report

The following are the featured fugitives and others being sought by federal, state or local authorities. The <u>Update</u> (if any) gives current status, previous references, or related information.

Timothy Joseph McGhee (Murder) – McGhee has been described by cops as a "walking, stalking killing machine". The undisputed and murderous leader of the powerful "Toonerville" gang (TVR) in the northeast section of Los Angeles, McGhee is wanted in connection with at least fourteen murders, including the killing of Margie Mendoza, a 26-yearold mother of two young children, and Marty Roybol, a 17-year-old aspiring artist. Between 1997, after he was released on parole from a 1994 conviction of assault with a deadly weapon on a police officer, and the fall of 2001, McGhee and his gang attempted at least thirteen additional murders and numerous assaults, including an ambush of the LAPD. Under McGhee's leadership huge profits were made with the sale and distribution of crystal methamphetamine, rock cocaine and heroin. Police believe he is also running AK-47's between Las Vegas and Los Angeles. McGhee runs his gang with almost military precision. They utilize police scanners, walkietalkies and Nextel phones. McGhee has taken police science courses and studies police tactics to avoid arrest. He has connections is Arizona, Texas and Alaska. McGhee, who has used the aliases "Hucro", "Whitey" and "Eskimo", has numerous tattoos including "Atwater Village" across his chest, "TVR" across his stomach, the Mexican flag symbol (an eagle holding snake) on the back of his head, a female face wearing a sombrero with "Toonerville" inscribed on the hat band on his right biceps, and "Toonerville Rifa" on his back. He usually shaves his head or wears his hair very closely cut, but sometimes wears a hat with a wig sewn into it to hide the tattoo on his head. He is large and muscular, always armed, highly intelligent and organized. He speaks "street" Spanish. McGhee is 29, 5'8"-5'9" and 190-210 pounds.

NOTE: McGhee was captured in Arizona a few days prior to the broadcast.

Brian David Mitchell (aka) "Emmanuel" (Wanted for Questioning) – Police are searching for "Emmanuel" for questioning regarding the abduction of Elizabeth Smart. In the middle of October the Smart's 9-year-old daughter Mary Katherine came to her parents indicating this may be the man who took Elizabeth. The Smarts had met "Emmanuel", a homeless man to whom they offered work, in downtown Salt Lake City. He told Ed Smart that he and his sister were staying with someone in the valley and that there were traveling to different cities preaching to the homeless. He took a bus to a stop close to the Smarts' home and then walked to the house. He worked for five hours, helping on the roof and raking leaves. Law enforcement has tried to locate him for questioning, but has been unsuccessful. A composite drawing was made from Ed Smart's recollection from the previous year. Mitchell is in his 30's or 40's, and 5'8"-5'10".

Joe Crouch (Murder) - Joseph Leroy Crouch, Jr., a prominent businessman and a family man in North Memphis, is wanted for the brutal murder of his wife of 40 years, Betsy Crouch. Crouch owned a seemingly successful Memphis loan and finance company that he ran along with his son. Crouch liked to show off "his money" by taking business associates on lavish trips to resort towns to golf and play at casinos. Despite his upstanding image in town, Crouch was a high roller who gambled his company's money away. He often went on long gambling binges to Las Vegas and Atlantic city, taking up with prostitutes while he was away from his wife, Betsy. By June 2001, Crouch's double life was starting to crash in on him. He had gambled all of the company's money away and was heading towards bankruptcy. Even the DA's office was on to him and was threatening to prosecute. On June 25, 2001, after an afternoon of golfing, Crouch shot his wife Betsy four times while she lay in bed. He then took the keys to her new 2000 Mercury Sable and unloaded Betsy's golf clubs so he could put his own clubs in the trunk. He drove off, possibly headed towards Atlanta. Once on the road Crouch called his son-in-law, an attorney, and said "I just shot Betsy - I'm sorry." He claimed that he didn't want her to suffer the embarrassment of the company going bankrupt. Crouch later mailed his son and daughter suicide/confession letters from somewhere in New Orleans and told them that they should contact him by placing an ad in "The Commercial Appeal" newspaper. Authorities believe Crouch is still in the U.S. He has been spotted by acquaintances at different casinos and still sends packages to his son and daughter from New Orleans. He may have picked up a favorite prostitute in Atlanta when he fled. She is known as Dee Dee, and had red hair when last seen. Crouch likes to play golf at private courses as a guest and hangs out in VIP rooms when gambling. He enjoys singing karaoke. Crouch is 60, 5'9" and 180 pounds.

Marcus Head (Murder) – Head plotted to kill his estranged wife Sabrina after she left their home in Indiana to start a new life in Alabama. Friends and relatives of the couple say Head had a history of physically abusing Sabrina. In 2001, Sabrina finally got up the courage to

leave him and moved closer to her family. Head refused to let things end there. He frequently called Sabrina, threatening her that he would kill her if she didn't come back to their home in Indiana. In mid-September 2001, Marcus called her in Birmingham enraged, threatening her that he was coming down to kill her on her birthday, October 1, unless she came back to him. Sabrina did not return. In fact, she began dating another man, 17-year-old Derrick Charles. Late on the night of September 30, 2001, Sabrina, Derrick and another couple celebrated Sabrina's birthday with a night out on the town. While they were gone, Head removed an air conditioning unit and broke into Sabrina's house through a window. He hid himself in a guest bedroom closet. Sabrina, Derrick and the other couple arrived home late and went to bed. Sabrina and Derrick slept in her bedroom, while the other couple stayed in the guest room where Head was hiding. Head laid in wait until 4:00am and then burst out of the guest room closet. He stormed past the couple and into Sabrina's room where she and Derrick were sleeping. Within seconds, Head pulled a gun and shot Derrick multiple times, killing him. He then turned the gun on Sabrina and shot her twice. He would have kept going but the gun jammed. So head pulled out a knife and brutally stabbed her, then fled. Sabrina survived the attack. Head has a scar on his head from a childhood accident. He sometimes wears a ponytail or braids, has a soft, mellow tone of voice, and smokes Newport cigarettes. He is scared of bugs. His family may be protecting him. He has tried to contact Sabrina since the murder. Head is 25, 6'1" and 230-280 pounds.

Mohammed Sher Mohammad Khan (Wanted for Questioning) – On Friday, February 7, 2002, the FBI issued an alert for Mohammed Sher Mohammad Khan - the same day the Terror Alert status was raised from yellow to orange. Khan is wanted for questioning as part of the FBI's ongoing terrorism investigation. Agents believe Khan entered the U.S. illegally after September 1, 2001. The FBI does not have any specific information to link Khan to potential terrorist activities, but believe he has ties to Al Qaeda. Khan has numerous aliases, including Muhammad Shir Muhammad Khan, Mohammed Essagh, Ja'Far Al-Tayar, Jaffar Al-Tarray, Jafar Tayar, Jaafar Al-Tayyar, Ali Abdul Qadir, and Abdul Qadir; in fact authorities are not sure of his real name or birthdate. He is asthmatic. He sometimes has a beard. He was born in Swat, Pakistan. Khan is 36, 5'3"-5'7" and 132 pounds.

AMW ALL-POINTS BULLETIN:

Carmen Cabrera (Murder) - Cabrera was born in Mexico and came to the United States in the late 1980's. After being hired at a piecework factory in the South Central area of Los Angeles in 1997, Cabrera became involved with Guadalupe Alvarez, the foreman of the company. Over the next year Alvarez helped Carmen financially and provided groceries for her

family. He also provided her with transportation to and from work. Because of the relationship with Alvarez, Carmen was able to remain employed at the factory despite her lack of productivity. A year into her involvement with Alvarez, Cabrera heard rumors he was going to break off the relationship with her. She refused to let him walk away and on Saturday, November 21, 1998 she shot and killed him in her apartment. She then stayed with Alvarez's body for five hours before leaving the scene. She was seen in Mexico City by relatives and friends after the murder but police believe she is now in the Los Angeles area where she has family. Cabrera, who has used the aliases Carmen Torres and Carmen Del Torres, frequently wears stiletto-type high heels and often dresses in flashy clothes and short skirts. She has long, manicured nails. She may be carrying fake resident alien card, and may still be employed as a pieceworker in a clothing factory. She is described as manipulative, egotistical and should be considered armed and dangerous. Cabrera is 42, 5'4" and 135 pounds.

Joseph Michael Maloney (Murder) -- On May 27, 1967, 32-year-old Joe Maloney entertained his wife and children on the occasion of his five-year-old's birthday. Maloney offered a drink containing wood alcohol to his wife, then another. June Maloney lapsed into a coma and died in a hospital eight days later. Maloney had made inquiries of a friend who was an amateur chemist, and eventually gained access to the friend's downstairs lab. Charged with his wife's murder, Maloney requested a mental evaluation and was taken to a Rochester, New York mental facility from which he later escaped. In 1973 the FBI found Maloney living under the alias Michael O'Shea in Ireland. Interpol fingerprints confirmed O'Shea was Joe Maloney, but authorities were powerless without an existing extradition treaty. Arrested again in 1985, Maloney fought extradition and made two efforts to escape before being transferred to a maximum security prison used to house suspected IRA members. Released on a technicality in 1986, Maloney disappeared with his current wife, Sheila O'Shea. Maloney, who has a slash scar over his right eye and a surgical scar on the left side of his abdomen, had a gray beard with red highlights the last time he was seen. He is a storyteller and liar, adept at assuming new identities. He is prone to violent outbursts. He has handled armor on film sets, is knowledgeable about guns and explosives, and claims to have served in the Special Forces. He has worked in construction, car sales and repair, and as a tree surgeon. Maloney is 67, 6'2" and 230 pounds. (See Shows #258 and #320, OADs 3/5/93 and 6/18/94)

Daniel Perez (Murder) – Perez is wanted by the Fontana, California police department for the murder of Carlos Vara. He is also a fugitive from the Southgate, California police department for the attempted murder of his wife, Annabella Perez. In April 1999 Daniel Perez abducted his estranged wife at gunpoint in a parking lot where they had agreed to meet. Perez held his wife hostage in a car for three hours until she agreed to end their two-month-long separation. After Annabella plead for her life, Perez allowed her to get into her own car and

follow him home. Annabella immediately called 911 and tried to drive to the nearest police station. Daniel spotted Annabella talking on her cell phone and made a u-turn to confront her. Annabella also made a u-turn and led Daniel on a ten-minute chase through the streets of Southgate. When Annabella finally got stuck in traffic, she got out of her car and started running for her life. Daniel Perez caught Annabella and shot her in the head in broad daylight. As his wife lay bleeding on the sidewalk, Daniel Perez calmly walked away. Perez was apprehended just a few hours later, but after posting a million dollars bail two weeks later, he was set free. Annabella miraculously survived her injury and in mid-August Perez went on trial for attempted murder. On the day of August 26, 1999 Annabella's father, Carlos Vara, testified in the attempted murder trial of his son-in-law. Annabella noticed that Daniel was acting strangely in court that day. Hours later, at approximately 3:00am, a masked February 10, 2000 Daniel Perez broke into the home where Carlos Vara and his five children, as well as Daniel and Annabella's own 5-year-old son, were sleeping. After confronting Vara in a hallway, Perez shot Vara several times and then fled. Daniel Perez never showed up to his trial again and was convicted of attempted murder in absentia. Perez is very social, a good talker and well educated with a good business sense, but he is extremely controlling. He needs contact lenses or glasses. Perez is 31. 5'9" and 165 pounds. The fight spilled out onto the sidewalk as bouncers threw them out. 20-year-old Cole Bailey, Jr. just happened to be outside the pool hall waiting for a taxi to take him to his girlfriend's house. Compton saw Cole watching the fight and yelled "What the f*** you looking at" Compton then hit Cole in the face. Cole did not respond verbally, but he started to flee after Compton continued to speak angrily. The three men chased him about 7 feet down the sidewalk and tacked the 135-pound Cole. They repeatedly kicked and stomped him into the hard concrete. While the skinheads bashed Cole Bailey, who was white, in the head, they yelled "white power". Cassandra Woods yelled "beat the n***". Cole Bailey died at the scene from the brutal and senseless murder. Compton, Whitley and Miller have been arrested. Woods, whose nickname is "Aryan Angel", is from Indiana and may still have ties there. Her ex-husband is a member of the Nazi Lowrider gang, a hardcore, violent skinhead group. Julian J. Lockhart (Murder, Robbery) – Lockhart beat Robert Glidden to death with a tree branch on Thursday, May 9, 2002. Glidden went with Lockhart for a test drive, but Glidden never returned home. Investigators determined that Glidden had been beaten to death, and that he died from a blunt force trauma to the head. Near

the body, cops discovered a tree branch which the believe was the murder weapon. A few days after the murder, Lockhart took a bus to New York City. Lockhart was previously convicted of assault in the mid-90's and served six years in prison. Lockhart, who has used the last name Lockheart and the nickname "J.J.", may be wearing his hair in dreadlocks. Lockhart is 27, 6'1" and 220 pounds. (See Show #688, OAD 8/24/02)

FBI'S TEN MOST WANTED:

Michael Alfonso (Murder, Aggravated Stalking) - Alfonso is wanted in Wheaton, Illinois for the murder of Genoveva Franco Velasquez on the morning of June 6, 2001. Velasquez was killed as she approached the entrance to the McDonald's where she worked as assistant manager. Alfonso walked past cars at the drive-thru window, then pulled a gun from his duffle bag, shooting Velasquez in the chest. He then stood over the victim and fired more shots into her. Witnesses say he fled the scene on foot, dropped his gun and jumped into a parked car in a lot behind the McDonald's. The victim worked with Alfonso at her second job with the Pampered Chef. Velasquez had been having an affair with Alfonso, but decided to break it off and remain with her husband and 9-year-old daughter. On June 5th, Velasquez reported for work at the Pampered Chef and was confronted by an angry Alfonso. He refused to leave her alone unless she agreed to talk to him. When Velasquez tried to leave, Alfonso grabbed her arm and pulled her backwards. He threatened Velasquez and her family, saying he might show up at her house. Velasquez called the police, but requested that Alfonso not be contacted, because she was afraid that he would retaliate. Alfonso, whose birth name is Michael Johnson, is 33, 5'6" and 150 pounds. James Joseph "Whitey" Bulger (Racketeering and Extortion)

Catherine Greig (Harboring a Fugitive) -- In the tough working-class neighborhood of "Southie," just south of Boston, locals say that a young man growing up there has only two career choices: the priesthood or the law. One of the Bulger brothers went on to make laws, becoming the President of the Massachusetts State Senate and holding the post for eighteen years. The other, who became known as Whitey Bulger, went on to break laws, becoming the boss of the ruthless Irish Winter Hill Gang. Police say that Whitey had his fingers in every drug deal and illegal bet in Southie, swiftly becoming respected, even legendary, in the Boston underworld. federal grand jury handed up a RICO indictment with Whitey's name on it. True to form, Whitey was ahead of the law, and disappeared from sight. However, the indictment netted five other members of the Irish Winter Hill Gang, including Whitey's top lieutenant, Steve "The Rifleman" Flemmi. What Flemmi had to say shocked everyone, gangsters and law enforcement alike. Flemmi claimed that both he and Whitey were actually government informants, leaking information to the FBI on their supposed partners in the Italian Mafia for nearly 30 years. He even claimed that they had been tipped by the Feds before the indictments came down, allowing Whitey to make a clean getaway. Legal hearings will determine whether Flemmi's allegations are true, and whether Flemmi and Whitey's alleged informant status makes them immune from prosecution. When the FBI indicted Bulger, Catherine Greig, his mistress, joined him on the road as they traveled as any retired couple through the historic sites and Indian reservations of the United States. So strong was her dedication to the suspected underworld mastermind that she abandoned her pet poodles and extensive collection of Hummell figures. Authorities now know that one of Whitey's stops was the quiet Louisiana enclave of Grand Isle. No one in this tight-knit community suspected that Whitey was a northeastern mob boss as he came and went Greig, paying for his rental cottage in crisp \$100 bills. Posing as "Uncle Tom and Aunt Helen," they seemed to blend right in. But now Uncle Tom and Aunt Helen have disappeared and the hunt is still on for Whitey Bulger and Catherine Greig. Police have traced the couple to Sheridan, Wyoming; San Francisco; Gulfport, Mississippi; and Selden and Holtsville, New York. The trail has been cold since July 1996. Bulger has a medium athletic build and often wears a baseball cap and sunglasses. He takes daily walks of 5-6 miles, and is take the heart medication Atenolol. Bulger drives large luxury sedans and likes making purchases with \$100 bills. He has served time for several bank robberies. Bulger has used the aliases and nicknames Jimmy, Jimmy-Boy, Jimmy Blue-Eyes, Thomas F. Baxter, Tom Harris and Mark Shapeton. Bulger is 73, 5'7"-5'9" and 150-160 pounds. Greig likes to wear high-quality jewelry. She has worked as a dental hygienist and a dog groomer. Greig has used the alias Helen Baxter. She is 51, 5'6" and 120 pounds. (See Shows #349, #378, #481, #556, #574, #579, #605 and #623, OADs 1/21/95, 9/9/95, 1/24/98, 9/4/99, 1/29/00, 3/11/00, 9/23/00 and 3/3/01)

Joseph Leroy Crouch (Murder) – Joseph Leroy Crouch, Jr., a prominent businessman and a family man in North Memphis, is wanted for the brutal murder of his wife of 40 years, Betsy Crouch. Crouch owned a seemingly successful Memphis loan and finance company that he ran along with his son. Crouch liked to show off "his money" by taking business associates on lavish trips to resort towns to golf and play at casinos. Despite his upstanding image in town, Crouch was a high roller who gambled his company's money away. He often went on long gambling binges to Las Vegas and Atlantic city, taking up with prostitutes while he was away from his wife, Betsy. By June 2001, Crouch's double life was starting to crash in on him. He had gambled all of the company's money away and was heading towards bankruptcy. Even the DA's office was on to him and was threatening to prosecute. On June 25, 2001, after an

afternoon of golfing, Crouch shot his wife Betsy four times while she lay in bed. He then took the keys to her new 2000 Mercury Sable and unloaded Betsy's golf clubs so he could put his own clubs in the trunk. He drove off, possibly headed towards Atlanta. Once on the road Crouch called his son-in-law, an attorney, and said "I just shot Betsy - I'm sorry." He claimed that he didn't want her to suffer the embarrassment of the company going bankrupt. Crouch later mailed his son and daughter suicide/confession letters from somewhere in New Orleans and told them that they should contact him by placing an ad in "The Commercial Appeal" newspaper. Authorities believe Crouch is still in the U.S. He has been spotted by acquaintances at different casinos and still sends packages to his son and daughter from New Orleans. He may have picked up a favorite prostitute in Atlanta when he fled. She is known as Dee Dee, and had red hair when last seen. Crouch likes to play golf at private courses as a guest and hangs out in VIP rooms when gambling. He enjoys singing karaoke. Crouch is 60, 5'9" and 180 pounds. (See Show #706, OAD 2/15/03)

Robert William Fisher (Murder, Arson) – On April 10, 2001 at 8;42am, Scottsdale, Arizona police and fire units responded to reports of an explosion and house fire. The bodies found in the rubble were 38-year-old Mary Fisher, her 12-year-old daughter Brittney, and her 10-year-old son Bobby. The family members had been murdered before the fire destroyed their home. Wife Mary had been shot in the back of the head and her throat slashed. The children's necks were also cut. The father of the house, Robert Fisher, was nowhere to be found. Ten days later, police found his vehicle and dog in the Tonto National Forest. An extensive search of the are turned up no signs of Robert Fisher. Police believe he hid out for the first few days after the murders, then left the area to start over in another community. Fisher may have a light scar on his back where he had surgery years ago, and walks with his back very straight and his chest pushed out because of his lower back injury. He is an avid hunter, fisherman and outdoorsman, and enjoys talking about these sports. He chews Copenhagen tobacco, and may be in the company of an unidentified female. Authorities believe he is armed with several weapons including shotguns, handguns, and possible a .357 Magnum revolver. Fisher is 41, 6'3" and 190 pounds. (See Shows #644, #659 and #682, OADs 8/11/01, 1/5/02 and 6/29/02)

Hopeton Eric Brown (Drug charges, Murder, Attempted murder of a witness) – Brown is charged with the 1997 murder of a drug associate. He also had international murder charges on him for a double murder in Jamaica in 2001. On March 21, 1997, Hopeton Brown and some of his associates entered the St. Paul apartment of James Rodgers, a man who had been receiving drugs for Brown. When Rodgers could not produce the latest shipment, Brown and his cohorts opened fire, killing Rodgers. They also shot Rodgers' friend five times, but she managed to survive. The other co-conspirators are all in custody. On January 14, 2001 Brown, along with a friend of his known only as "Pambo", shot and killed a man in Montego Bay, Jamaica solely because the victim was leaning on Brown's car. A stray bullet also killed a man sleeping in his

home nearby. Brown has used numerous aliases, including Devon Foster, Shawn Foster, Shawn Smith, Gregerie Excell, Simon Pleseted, Anthony Brisco, and the nicknames "Sando" or "Sandokam", and he changes identities quickly and often. He has a mole under his left eye and may have a large scar on his chest. He is known to wear heavy gold jewelry, and he likes to ride motorcycles. Brown is 28, 5'8" and 175 pounds. (See Shows #625 and #643, OADs 3/17/01 and 8/4/01)

Victor Manuel Gerena (Bank Robbery, Armed Robbery) - Gerena, one of the FBI's Ten Most Wanted, is wanted for the 1983 robbery of a Wells Fargo armored truck depot in West Hartford, Connecticut. On September 12, 1983 Gerena took two of his fellow Wells Fargo employees hostage and escaped with \$7 million. Gerena pulled a gun, tied up his hostages, and injected them with a substance to make them sleep. Gerena loaded the money into a rented Buick and fled to Massachusetts. The FBI says Gerena was recruited and trained for the robbery by Los Macheteros, a violent Puerto Rican independence movement. The Macheteros moved Gerena through Texas to Mexico in a trailer, then sent him to Cuba. An FBI investigation into the robbery led to the indictment of nineteen alleged Macheteros. One was acquitted, four pled guilty, and in April 1989 four more were found guilty. Gerena has used the alias Victor Ortiz. He speaks English with a marked accent. He has a one-inch scar and a mole on his right shoulder blade. He has strikingly green eyes and wears wire-rimmed prescription glasses. He wears his hair combed straight back with no part, and can grow only a sparse mustache. He drinks lots of strong coffee. Gerena has precise, meticulous handwriting and dresses very neatly. He was a paralegal assistant at the Puerto Rican Center for Justice in Hartford, and enjoys watching TV news and discussing politics. He has also worked as a machinist, truck driver, security guard, concessionaire, playground worker, and as an aide at the state capitol. He lifts weights, jogs, and plays racquetball. Gerena is 44, 5'6" and 170 pounds. (See Shows #553, #579 and #605, OADs 8/14/99, 3/11/00 and 9/23/00)

Richard Steve Goldberg (Child Molestation) – Goldberg molested six young girls under the age of ten. He reportedly gained the trust of the neighborhood parents, then became a babysitter and "friend" to kids in the area. The single man set his home up in a way that would attract children. His backyard had swings and a cage with rabbits and ducks. Inside the house, Goldberg had children's computer games that he would allow them to use, kid's music, art supplies, and even children's soap. He would also take them to Disneyland, parks, lakes, etc. Goldberg was found out after two young girls playing on his computer saw an image of two of their young friends naked, including the next door neighbor. A full investigation was launched and six neighborhood kids reported being assaulted by Goldberg. Child pornography was found on his computer, including a photo of him having sex with children. After cops came in to search his house and took his computer away, Goldberg fled the area in late June. In early July, after finding evidence on the computer, police issued an arrest warrant for him. Authorities

know he visited his parents in Rumson, New Jersey, shortly after running. There is evidence he was also in Las Vegas, and Bullhead City, Arizona. Goldberg's hair is jet black but would be gray if he didn't dye it. He has a receding hairline. He used to work at Boeing before being laid off. He likes outdoor activities and was the president of a gun and revolver club in Long Beach, California. Goldberg is 56, 6'0" and 160 pounds. (See Shows #665 and #680, OADs 2/16/02 and 6/15/02)

Eric Robert Rudolph (Causing the Death of a Person, Use of an Explosive) -- It's hunting season in the Great Smokey Mountains and there's a price on the head of Eric Robert Rudolph. The FBI doesn't want anyone to shoot their most wanted man, but they are asking hunters to look for trash left behind by the accused abortion clinic bomber. Agents in Murphy, North Carolina put together a sampling of trash they say they've found abandoned by Rudolph. They're asking the thousands of hunters in the area to keep their eyes peeled for Rudolph clues. The woodsman has been burying his trash in an attempt to hide it, but it hasn't worked. Back in the summer, agents actually fingerprinted some of the trash they found and confirmed that it belonged to Rudolph. Inspired by the million-dollar reward, bounty hunters have descended on the area as well, but no one wants to see Rudolph behind bars more than Felicia Sanderson, a widow and mother of two. Her husband, Officer Robert "Sandy" Sanderson was killed by a bomb placed outside a women's clinic in Birmingham, Alabama - a bomb agents say was planted by Rudolph. It took guts, but Felicia traveled to the Smokey Mountains where her husband's killer is believed to be hiding out. She went there to lend her support to the hundreds of investigators working the case. She even used a local radio broadcast to send her plea to the community. Felicia knows that some groups sympathize with Rudolph on political grounds - that they say he was doing "God's work." In response, she doesn't mince words: "God didn't have anything to do with murdering Sandy. Eric Rudolph done that all by himself." Agents say that Eric Robert Rudolph was seen on January 29, 1998, fleeing the scene of the bombing of the New Woman All Women Clinic in Birmingham, Alabama. Immediately after the bomb went off, witnesses saw a man wearing a wig running from the site. Three witnesses saw his truck pull away, and were able to provide a description and a license plate number. The truck was traced to Rudolph, but he had already made his escape. Agents say Rudolph's bomb was loaded with nails - a bomb designed not just to damage property, but to kill and maim. It did both: Birmingham Police Officer Robert "Sandy" Sanderson lost his life. Nurse Emily Lyons was severely injured by the homemade shrapnel - she lost her left eye, lost some of the sight in her right eye, and suffered several broken bones and burns. Despite speculation that Rudolph has been close to extremist groups, friends of Officer Sanderson can't view his death as part of a political action. Even though Sanderson was moonlighting as a security guard for a family planning clinic, they say he was outside of the abortion controversy - that he was just doing his job: enforcing the law. Rudolph is also wanted for questioning in a series of deadly Atlanta bombings: the 1996 Centennial Olympic Park bombing that killed one and injured more than one hundred others, an

attack on an abortion clinic in January 1997 that injured seven, and a February 1997 attack on a gay nightclub. Authorities confirmed that they are investigating similarities in the construction of Rudolph's alleged bomb and the others. In particular, they're investigating a possible match between the nails in the Birmingham bomb and those in the Atlanta bombs. Rudolph has been described as a mysterious and reclusive man from the rugged mountains of North Carolina. Rudolph's truck was found in a pasture near Murphy, North Carolina on February 7, 1998. Though agents believe it's likely that he's taken to the wilderness to hide, they're confident that the \$1 million price on his head will make it hard for Rudolph to hide for long. Authorities also note similarities to Rudolph's known techniques in the bombing of an abortion clinic in Asheville, North Carolina on March 13, 1999. Rudolph, who has used the alias Bob Randolph. has worked as a carpenter and spent 18 months in the U. S. Army. He has a reputation for antigovernment views. He is estranged from family. He is an experienced woodsman and completed army survival training. Rudolph is 36, 5'11" and 150 pounds. Glen Stewart Godwin (Murder, Escape) -- In 1980, Glen Stewart Godwin turned on his best friend in a robbery, and the double-cross turned to murder. After stabbing the victim 26 times, he attempted to cover his tracks by dragging the lifeless body to a remote desert location, and there detonated homemade bombs next to the evidence. The attempt failed - instead of incinerating the body, the explosion catapulted it into the night, where it was later discovered. Godwin was convicted and got 26 years to life for his crime. Prison officials say that he wasn't one to play by the rules, so he was soon transferred to what convicts call "the end of the world" -California's infamous Folsom prison. Only a handful of convicts have gotten clear of Folsom's high walls - but that didn't stop Godwin. He carefully examined the security and surroundings, and realized that he could get out by turning the problem on its head - no one could get out of this prison, but what if someone broke in? Godwin enlisted an ex-con by the name of Lorenz Karlic to work his way into Folsom by way of a tunnel running underneath the prison. Folsom was built on a stream that empties into a nearby river - and while the tunnel is secure in one direction, no one was watching as Karlic cleared a path for his friend. In June 1987, the tunnel was ready, and Godwin was away. But Godwin was far from rehabilitated. Just five months after his escape, he was captured in Mexico and charged with possession of 30 grams of cocaine. Once again, he was convicted, and sentenced to seven years at the Puente Grande Federal Prison in Guadalajara. The FBI was in negotiations with Mexican authorities to bring Godwin home when they say he clouded the legal waters by killing a fellow inmate. A short time later, the FBI learned that he had escaped yet again. On December 7, 1996, Godwin was named to the FBI's Ten Most Wanted list. Agents believe he is still in Mexico, but may have slipped back into California. Godwin, who use used the aliases Dennis McWilliam and Glen S. Godwin,

frequents bars and drinks champagne. He is also an alleged marijuana and cocaine user. Godwin is a tennis player, a sharp dresser, and has worked as a model, mechanic, and construction worker. He collects firearms. Godwin is 44, 6'0 and 170 pounds. Donald Eugene Webb (Murder) - Webb, one of the FBI's Ten Most Wanted, is wanted for first degree murder in the 1980 slaying of a Pennsylvania police chief, and for third degree burglary in upstate New York in 1979. On December 4, 1980, Webb and possibly one accomplice were pulled over on a routine traffic violation in Saxonburg, Pennsylvania. After a brief, violent scuffle in the parking lot of an Agway supermarket, Chief Gregory Adams was found bleeding from two bullet wounds. Adams died on the way to the hospital. Webb has used many aliases, including Donald Eugene Perkins, Stanley Portas, Stanley Perkins, A.D. Baker, Donald Eugene Pierce, John S. Portas, Stanley Webb and Wilfred E. Reams. He has scars on his right cheek and right forearm, and on the right side of his torso from a hernia operation. He has "Ann" tattooed on his chest and "Don" in the web of his right hand. He has graying hair which he may dye to disguise himself. Webb, who is described as a generous tipper, is a flashy dresser who likes to dine in expensive restaurants. He always drives rental cars and pays cash, and frequents pawn shops and auctions. He may own an antique shop. He frequents both dog and horse racing tracks. He has a working knowledge of real estate, and has worked as a butcher, car salesman, vending machine repairman and jewelry salesman. He is allergic to penicillin. Webb is 72, 5'9" and 165 pounds. Osama Bin Laden (Conspiracy to Murder, Murder, Destruction of a Federal Facility) -- According to the Federal Bureau of Investigations, Osama Bin Laden, "with others known and unknown", has been charged with the August 7, 1998 bombings of the U.S. Embassies in Kenya and Tanzania. These attacks killed more than 220 people and seriously injured 5,000 men, women and children. Authorities say Osama Bin Laden is the leader of "Al Qaeda", a worldwide terrorist organization, with many members. In an indictment by the U.S. Attorney's Office handed down in November of 1998, it is alleged that Bin Laden, through al Qaeda, issues "fatwahs", urging members and associates to target U.S. facilities and personnel around the world. The U.S. Government is offering a reward of up to \$5 million dollars for information leading to the arrest or conviction of Bin Laden. Bin Laden sometimes spells his first name "Usama". He wears a beard and mustache, and speaks Arabic and poor English. Bin Laden is 44 and 6'5". Screening Report

The following are the featured fugitives and others being sought by federal, state or local authorities. The <u>Update</u> (if any) gives current status, previous references, or related information.

James Joseph Singleton (Murder) – On August 18, 2002, Eric Singleton returned home from a weekend away and found his adoptive parents, Ralph and Sherida Singleton, brutally murdered. Cops determined that Eric's brother James had murdered his parents with a Chinese militia sword he had hanging on his bedroom wall. After murdering his parents, James drove his mother's car to the Deep Ellum section of Dallas, where he abandoned it. Eric Singleton has a scar on his head and multiple tattoos, including a long-stemmed rose that extends from his left wrist to the bed in his elbow, a skull with the phrase "Still Smokin" on his left shoulder, an Old English-style "J" on the back of his left shoulder, an Old English-style "S" on the back of his right shoulder, and a black and red tribal design (heavy metal design) on the top of the middle finger of either his left or right hand. Authorities believe he fits a psychopathic profile. When he travels, he usually takes the bus. James Singleton is 21, 6'0" and 165 pounds.

Brian David Mitchell (aka) "Emmanuel" (Wanted for Questioning) – Police are searching for "Emmanuel" for questioning regarding the abduction of Elizabeth Smart. In the middle of October the Smart's 9-year-old daughter Mary Katherine came to her parents indicating this may be the man who took Elizabeth. The Smarts had met "Emmanuel", a homeless man to whom they offered work, in downtown Salt Lake City. He told Ed Smart that he and his sister were staying with someone in the valley and that there were traveling to different cities preaching to the homeless. He took a bus to a stop close to the Smarts' home and then walked to the house. He worked for five hours, helping on the roof and raking leaves. Law enforcement has tried to locate him for questioning, but has been unsuccessful. A composite drawing was made from Ed Smart's recollection from the previous year. Mitchell is in his 30's or 40's, and 5'8"-5'10". (See Show #706, OAD 2/15/03)

Unknown Ronald Bridges Killer (Murder)

Unknown Ronald Bridges Killer Accomplice (Murder) - On September 16, 2002 at approximately 12:20pm, an unknown black man attempted to rob the Game Proz video game store in Houston, Texas. The robbery had a getaway driver waiting outside the store. The robber entered the store and disabled the surveillance cameras by spray painting them. The robber then had the clerk fill a bag with money and video games. When police arrived at the scene, the getaway driver fled leaving the robber inside the store. The robber quickly took off on foot, leaving the money and games behind. Police chased the suspect into a nearby residential area but could not find him. The suspect gained access to a home in that community through an open porch door then climbed into the attic to hide. The house belonged to 53-year-old Ronald Bridges, who was home at the time. Ronald was relaxing on his couch when he heard a loud crash coming from a back bedroom sometime between 3:30 and 4:00pm. The man who had been hiding in Ronald's attic fell through the ceiling. When Ronald entered the room to investigate the noise, the intruder attacked and killed him during the subsequent struggle. The killer then took Ronald's truck and fled the area. The truck was found several hours later. The vehicle had been set on fire and destroyed. A composite sketch was created of the killer from witnesses at the robbery. A sketch was also done of the getaway driver from the failed robbery. The suspect has a slim, muscular build, and is described as very athletic. The suspect is in his mid 20's to mid 30's and 6'3"-6'5". The accomplice is described as having a dark complexion and a medium or heavy build. The pair may be traveling in a white 1995 Chevy Caprice with chrome rims and a chrome grille.

Unknown Taxi Cab Robber Suspect (Armed Robbery) – On the night of August 17, 2001, two young Hispanic males called for a taxi cab from a pay phone at a Crown gas station in the Hybla Valley section of Alexandria, Virginia. A cab was dispatched to pick them up from the Springfield Taxi Cab Company at approximately 2:00am. The suspects directed the cab driver to an apartment complex located at Fairfield and Lockheed Boulevards in Alexandria. Once there, the suspects produced a gun and a knife and robbed the driver of approximately \$29 in cash and relieved him of his wallet. They fled the taxi on foot. The suspect who brandished the handgun was later apprehended in Texas. In Texas, that suspect is listed as an adult, but in Fairfax County he is listed as a juvenile, so his name has not been released to the public. The other suspect, the one with the knife, remains at large. This case was the first in the Washington, DC metropolitan area where a taxi cab robbery was captured on film in the form of still photographs. Springfield Taxi Cab Company had installed the new digital security system in their cabs just two weeks prior to the robbery. (See Show #667, OAD 3/9/02)

Gregory Marc Riviera (murder) -- Riviera is wanted for the 1992 murder of his exgirlfriend, Juliette Rivera. On July 6, 1992, deputies say, Riviera convinced Juliette to meet him and go to a Pescadero, California bar for a drink. Juliette's body was discovered two weeks later in an irrigation pond several miles from the bar. Deputies say Riviera is a chronic liar who always tells tales to women to try and impress them. Juliette told friends that Riviera made her nervous and that was the reason she stopped seeing him. Deputies believe that a jealous Riviera murdered Juliette because she was dating other men. Riviera claims to be of royal Hawaiian descent but is actually Puerto Rican. He is a good cook, specializing in French sauces and likes to eat at fine restaurants. He always pays with cash, from a wad of bills, and does not have

charge cards or a checking account. Through exercise, frequent facials and keeping his hair dyed black, he looks much younger than his age. He is 60, 5'10" and 170 pounds. (Shows #270, #303, #372 and #536, OADs 6/4/93, 2/12/94, 7/15/95 and 4/3/99).

Martha Letecia Cano Patlan (Murder)

Genaro E. Espinosa Dorantes (Murder) - On February 23, 2003, the body of four-year-old Luis Cisneros was discovered by a park in Nashville, TN. Doctors and detectives determined that the boy died of blunt force trauma to the head, and had infected burn marks on his body that detailed signs of abuse. Police believe Luis was killed Thursday or Friday, and was dumped in the park Saturday night or early Sunday. Police are searching for the boy's mother, Martha Patlan, and her boyfriend, Genaro Espinosa Dorantes. The two of them have not been seen since last Thursday. They may be traveling with Martha's eight-year-old daughter, Mariana Patlan, and the couple's 15-month-old son, Edgardo Espinosa. Authorities were first alerted to signs of trouble on Thursday, February 20, 2003. A relative of Patlan's called authorities to notify them that when she had seen the two suspects and the children that afternoon, Luis appeared to be ill. The relative called police hours after Patlan and Dorantes left. On Friday, February 21, 2003, Youth Services detectives learned of a possible address. After going to the location, they realized it had been abandoned. Family members were instructed to notify police if any contact was made. The vehicle they are presumed to be driving is a white 1995 Chevy Astro minivan. The VIN number is NDM19W7SB221953. An Amber Alert has been issued for both children. Patlan is 28, 5'6" and 170 pounds. Dorantes, who has used the aliases Edgar Durantes, Edgar Espinosa-Dorentes, Edgar Dorantes, and Javier Edgardo Espinosa, has a scar on his face. He is 32, 5'7" and 200 pounds.

On Wednesday, June 5, 2002, Elizabeth Smart was abducted at gunpoint from her Federal Heights home. At about 1:00am a man cut the screen and crawled through the kitchen window. He then went to the bedroom shared by Elizabeth and her 9-year-old sister. He took Elizabeth out of the house at gunpoint after he allowed her to grab her shoes. He threatened to harm the 9-year-old sister if she told the police what happened. Two hours after the abduction, Elizabeth's sister told her parents what had happened. There is no evidence of a vehicle, and it appears they

left on foot. Police are looking for a male believed to be in his 30's. He is about 5'8" with a medium build. The suspect has dark hair and was seen wearing a tan or white jacket with a white cap. CAPTURED:

Timothy Joseph McGhee (Murder) – McGhee has been described by cops as a "walking, stalking killing machine". The undisputed and murderous leader of the powerful "Toonerville" gang (TVR) in the northeast section of Los Angeles, McGhee is wanted in connection with at least fourteen murders, including the killing of Margie Mendoza, a 26-year-old mother of two young children, and Marty Roybol, a 17-year-old aspiring artist. Between 1997, after he was released on parole from a 1994 conviction of assault with a deadly weapon on a police officer, and the fall of 2001, McGhee and his gang attempted at least thirteen additional murders and numerous assaults, including an ambush of the LAPD. Under McGhee's leadership huge profits were made with the sale and distribution of crystal methamphetamine, rock cocaine and heroin. Police believe he is also running AK-47's between Las Vegas and Los Angeles. McGhee runs his gang with almost military precision. They utilize police scanners, walkietalkies and Nextel phones. McGhee has taken police science courses and studies police tactics to avoid arrest. Authorities followed leads to Bullhead City, Arizona where McGhee and a female companion were arrested. Screening Report

The following are the featured fugitives and others being sought by federal, state or local authorities. The <u>Update</u> (if any) gives current status, previous references, or related information.

Dudley Vincent Forbes (murder) - Forbes beat his girlfriend, Lorna, beginning when she was four months pregnant. After the birth of her son, she and her two boys left but Forbes continued to stalk her, threatening to kill her and her whole family. Forbes broke into her apartment, and stabbed her 13 times before fleeing. After being tipped off by a friend, Forbes followed Lorna to a nightclub. After a brief altercation in the club he left, but returned to shoot the place up, killing two and wounding seven. Though usually soft-spoken, Forbes has an explosive temper. He has a welder's certificate and has worked as a forklift driver and compound mixer. Forbes enjoys playing soccer and dominoes. He is 41, 5'10" and 175 pounds, and speaks with a Jamaican accent. Viewer tips have placed Forbes in the Flatbush area of Brooklyn, New York, where he may be living under an assumed name. He is believed to be driving a grey 1988 or 1989 Honda with New York plates. (See Shows #404, #414, #443, #538, #555, #593, #670 and #686, OADs 4/13/96, 5/22/96, 3/15/97, 4/17/99. 8/28/99, 7/1/00, 3/30/02 and 8/10/02)

John Patrick Addis (Murder, Kidnapping) -- Addis is wanted for the 1995 kidnapping and murder of his girlfriend in the Nevada desert. On August 19, 1995, police say Joann Albanese disappeared from her residence in Las Vegas along with her boyfriend, John Edwards. Police later determined that Edwards was in fact, John Patrick Addis, a former Alaskan state police homicide investigator. Police say Addis was working as a personal trainer in Las Vegas, when he became involved in a romantic relationship with Joann. On the day she disappeared, Joann, a single mother of two, was scheduled to have dinner with Addis to inform him that the relationship was over. Joann's car was discovered several days later, abandoned in Little Hell's Canyon near Prescott, Arizona. Police say Addis strangled Joann in a fit of rage and hid her body. Police say Addis has a history of traveling around the country finding work in fitness

clubs, so he can meet women, romance them, and live off their money. On July 31, 1998, three years after Joann disappeared, a grand jury in Clark County, Nevada charged Addis with her murder and kidnapping. On October 9, 1998, hunters discovered Joann's body. Police determined she had been murdered. Addis, who has used the aliases John H. Edwards and John Elliott, is an avid body-builder who works in gyms as a personal trainer. He is a small plane pilot, outdoorsman and marksman, and is skilled in forensics and criminal investigation. He believes in UFO's and the god RAH, and often claims he's a science fiction writer who writes screenplays on UFO's. His ex-wives say he has a history of domestic violence and fraud, and he has served time in jail for custodial interference. He is adept at manufacturing false identification and Social Security cards. Addis is 51, 6'0"-6'1" and 200 pounds. (See Shows #519, #555, #571, #641 and #687, OADs 11/21/98, 8/28/99, 1/8/00, 7/21/01 and 8/17/02)

Terry Drake (Child Endangerment) --Sometime between 12:30am and 8:00am on March 1, 2003, Lindsey Ryan went missing from her Jones, Indiana residence. She is believed to be traveling with 56-year-old Terry Drake. Police are unsure at this time whether Drake has kidnapped the girl or if she has gone with him freely. Drake has spent time in prison and was convicted for kidnapping and murder. Due to Lindsey's age, the police are considering her disappearance an abduction. Lindsey's parents called authorities after having to break in her bedroom door. It was clear that she had climbed out the window. Several items were missing from the house, including \$4,000 and a number of firearms. Drake is believed to be driving a white Dodge Dakota pickup truck with Indiana registration 406211A. Drake and Ryan met through their church and are believed to have been carrying on an internet relationship. The hard drive of the computer she used has been erased, but friends of Lindsey's have come forward telling the family that there had indeed been a relationship. Since the disappearance, there have been sightings in several locations in the southwest, including California. Reports have indicated that the girl may have dyed her hair black. Drake, who has used the alias Terry Blaine, has numerous tattoos including a large dragon on the side of his neck and others on his forearm. He wears glasses and is a welder by profession. Drake is 56, 6'2" and 190 pounds.

"The Zodiac" (Murder, Attempted Murder, Kidnapping) -- San Francisco police are searching for the man known as "The Zodiac" who they say murdered five people in Northern California in the late 1960's. To this date the case remains an open investigation and possible suspects are being looked at. In each instance police have tied the murders to one man. what follows is a synopsis of the cases:

On December 20, 1968 at 11:15pm, police say the unidentified killer murdered David Faraday, 17, and Betty Lou Jensen, 16, on Lake Herman Road in Vallejo, California in a popular lover's lane area. According to police, Faraday was shot at close range behind his

left ear, and Jensen was shot five times in the back as she ran away from her attacker.

On July 5, 1969 at around 12:00am, police say Darlene Ferrin, 22, and Michael Mageau, 19, were attacked at another well-known lover's lane in Vallejo by a man driving a tan colored car which resembled a '58 or '59 Falcon with old California plates. Police say the man emerged from the tan car shining a bright light in the couple's eyes and fired into the car, killing Ferrin and wounding Mageau.

On September 27, 1969, sometime after 4:00pm, police say college sophomores Cecilia Shepherd and Bryan Hartnell were attacked by the same man at Lake Berryessa in Napa County. According to police, the suspect was dressed in a midnight black hood that hung down almost to his waist with slits for the eyes, nose and mouth. On the portion of the hood which covered the suspect's chest was a hand-painted white circle with a cross on top of it. After the victims were hogtied, the suspect pulled out a one foot knife and stabbed Cecilia to death and wounded Bryan.

On October 11, 1969 police say the suspect killed Yellow Cab driver Paul Stine, 29, between 9:30 and 9:55pm on Washington Street in San Francisco. Police say the killer pressed a gun against Stine's right cheek and fired. The suspect took Stine's wallet and tore off a portion of his shirt, police say.

On August 1, 1969, police say the San Francisco Chronicle newspaper received the first of 21 letters bearing the same crossed symbol that was seen on the hooded suspect in the Lake Berryessa attack. In the letters, several of which included swatches of Stine's bloody shirt, the killer refers to himself as "the Zodiac", admits to the murders and threatens to kill again. Some of the letters also included a coded message made up of symbols which resemble symbols used in astrology. Portions of the letters were printed in the newspaper, and a couple in North Salinas cracked the killer's code. All leads and clues were investigated, but police were unable to identify the killer. On the night of March 17, 1970, police say Kathleen Johns was abducted by the suspect on Maze Road near Interstate 5 in Vallejo. She managed to escape by jumping out of his moving car. Between 1969 and 1981 there were 42 other murders which police say may have been committed by the Zodiac; however, there is not enough evidence to link the 42 murders to the same man responsible for the six attacks listed above. The suspect had a stocky build, wore a crew cut and glasses over "dead-pan" eyes. His speech was described by victims as precise, pronounced and monotone. Police speculate he may have a military background, possibly Navy, as he wore military clothes and used military terms in his threat letters. He writes with a distinctive print and used British phrasing in the threat letters. Based on the content of his letters, he is a fan of Gilbert and Sullivan's "The Mikado", and movies including "Badlands", "The

Exorcist", and "The Most Dangerous Game". The suspect would be 60-70 years old today, 6'0" and 180-200 pounds. (See Shows #518, #555 and #593, OADs 11/14/98, 8/28/99 and 7/1/00)

Marlon James Winters (Sexual Assault on a Child) – In July 1999 Winters was indicted on five sex charges involving children under the age of nine. Marc Zanichelli, a manager of an autoparts store. The two thugs walked into the store at 9:36am, led Zanichelli and three co-workers to a back room, and then ordered Zanichelli to open the safe. When he told them the key was in his car, they shot him and fled. The first suspect was wearing a black knit cap with yellow and red stripes and a dark jacket. He is 22-23, 5'7"-5'9" and 170 pounds. Peter Hommerson (arson, murder) --On January 23rd firefighters battled an arson blaze at the home of Marvin and Kitty Lichtman. Their bodies were found in the rubble, but they had died of gunshot wounds before the fire started. Hommerson, a local handyman and glass installer, had known and worked for the couple for years. Police speculate that Hommerson killed Kitty Lichtman, looted the multi-million dollar house, killed Marvin when he arrived home, then set the fire to cover his crimes. Hommerson has been charged with murder. He is believed to have fled into Mexico, but may have returned to the states. Hommerson is a native of Hungary who used to go by the name Lajohs Farengi. He speaks English with a thick accent. He also speaks Italian, German and Hungarian. Hommerson may have died his brown hair black. He has a distinctive line tattoo on his left wrist which he tries to hide under his watch. Hommerson is an outdoorsman and should be considered armed and dangerous. He is 57, 6'0" and 220 pounds. (See Shows #407, #424, #454, #654 and #669, OADs 4/27/96, 8/31/96, 6/16/97, 11/10/01 and 3/23/02)

Unknown Littleton Bowling Alley Triple Murder Persons of Interest (Wanted for Questioning) – On January 27, 2002, just before midnight, a woman entered the AMF Broadway Lanes in Littleton, Colorado, to pick up her friend from work. The woman found three people, James Springer, Jr., Robert Zajac and Erin Golla, all of whom had been shot to death. James and Erin had worked at the alley that night and Robert was a customer. A composite drawing was made based on the woman's recollections. The person she saw may be connected to a robbery of the same bowling alley on January 21. He may wear a dark-colored trench coat, may still be armed with a handgun, and may be driving a dark-colored, late-model full-sized pickup truck. He is 25-35 and 6'0"-6'2". A second composite drawing is based on recollections of those at the bowling alley that night. This person has a mustache, wears black-rimmed glasses, and may also be connected with the prior robbery. He is 45-55 and 5'10"-6'0".

Adnan G. El Shukrijumah (Terrorism) – The FBI has issued a "Be on the Lookout" (BOLO) alert for El Shukrijumah stating that the United States has information indicating he may be involved in al-Qaida and may pose an imminent threat to US interests at home or overseas. El Shukrijumah was known to have been in the United States since the terrorist attacks of September 11, 2001, living for a time in Miami. Authorities believe his pilot training raises

the possibility that he is planning an airborne attack. El Shukrijumah has used numerous aliases, including Abu Arif, Ja'far Al-Tayar, Jaffar Al-Tayyar, Jafar Tayar, and Jaafar Al-Tayyar, occasionally wears a beard. He is 27, 5'3"-5'5" and 132 pounds.

Errol Domangue (Rape and Murder) – Domangue lured a resident of the complex he lived in to a vacant apartment, raped her and then strangled her to death. He left her body in the vacant apartment, where it remained for two weeks until it was discovered. Domangue, who has a tattoo on his upper left arm of a blue bird and the letters "N" and "M", is probably homeless. He usually hitchhikes and may be working at a hotel or resort, or doing some sort of odds-and-ends type job. Domangue is 52, 5'7" and 158 pounds.

Unknown Kristin Laurite Killer (Murder) --- Arkansas Sheriff's Deputies are looking for information in the August 26, 2000 murder of Kristin Laurite. A truck driver discovered the naked body of twenty-five-year old Kristin on the banks of a pond in Arkansas. Laurite had been stabbed to death and according to autopsy reports, suffered multiple stab wounds to the neck. The pond where the discovery of her body was made is located at an Interstate 40 rest stop near Morrilton, Arkansas. Laurite had stopped there a day earlier during her cross-country trip from New Jersey to Northern California. Laurite — described as 5'2" tall, weighing less than 100 pounds, with brown dread locked hair had been traveling in a 1971 gold and white Volkswagen bus with a pop-up top and New Jersey license plates. She was last seen wearing a lavender and white sundress. Laurite's two dogs, a Border Collie and a tan German Shepard mix, accompanied her on her journey and helped lead the trucker to Kristin's body. Kristin last spoke with her family on the afternoon of Friday, August 25 when she called her mother from the rest stop. In the summer of 2002, Arkansas state crime lab technicians received a hit on the national DNA database, CODIS. Forensic evidence linked Kristin's unknown killer to the scene of another murder, just a few months after Kristin's death. Police believe one man is responsible for the murders of both Kristin and of Jacque Travis in California, and that he may be a serial killer. 49-year-old Jacque Travis was living alone in her apartment in Merced, California in December 2000. A friend found Jacque's body on the morning of December 8, 2000. There was no sign of forced entry and authorities believe Jacque likely knew her killer. (See Show #622, OAD 2/24/01)

Mariana Cisneros

Police are searching for Mariana Cisneros, whom they believe to be in the custody of her mother, Martha Patlan and her mother's boyfriend, Genaro Dorantes, both of whom are wanted for the murder of 4-year-old Luis Cisneros. On February 23, 2003, the body of four-year-old Luis Cisneros was discovered by a park in Nashville, TN. Doctors and detectives determined that the boy died of blunt force trauma to the head, and had infected burn marks on his body that detailed signs of abuse. Police believe Luis was killed Thursday or Friday, and was dumped in the park Saturday night or early Sunday. Police are searching for the boy's mother, Martha Patlan, and her boyfriend, Genaro Espinosa Dorantes. The two of them have not been seen since last Thursday. They may be traveling with Martha's eight-year-old daughter, Mariana Patlan, and the couple's 15-month-old son, Edgardo Espinosa. Authorities were first alerted to signs of trouble on Thursday, February 20, 2003. A relative of Patlan's called authorities to notify them that when she had seen the two suspects and the children that afternoon, Luis appeared to be ill. The relative called police hours after Patlan and Dorantes left. On Friday, February 21, 2003, Youth Services detectives learned of a possible address. After going to the location, they realized it had been abandoned. Family members were instructed to notify police if any contact was made. The vehicle they are presumed to be driving is a white 1995 Chevy Astro minivan. The VIN number is NDM19W7SB221953. An Amber Alert has been issued for both children. (See Show #710, OAD 3/15/03)

CAPTURED:

Guillermo Del Prado (Drug Charges) – On the night of January 20, 2002, U.S. Customs agents were on routine patrol in the air looking for suspicious vessels out at sea. Around 11:30pm they spotted a go-fast boat driving fast without its lights on. Customs agents say that this is a classic drug smuggling method. U.S. Customs called in their go-fast boat to follow the suspicious vehicle. They followed the boat in the water and in the air. From video shot from the helicopter, there is evidence of the smugglers throwing out bales of marijuana and then landing on Miami Beach just near the Fountainbleu Hotel. All three occupants jumped from the boat and ran onto the busy streets of Miami Beach. Customs agents chased them on foot. With the help of citizens who pointed out the direction of the suspects, agents arrested two of the three drug smugglers. One of the arrested men was picked up in the Bahamas and paid \$3,000 for a ride. He was not involved in the drug smuggling and is cooperating with authorities. The second man

Screening Report

The following are the featured fugitives and others being sought by federal, state or local authorities. The <u>Update</u> (if any) gives current status, previous references, or related information.

Unknown Kriewald Killer – On March 7, 2002 at approximately 3:30am a masked man hiding inside the Sidelines Sports Grille in the outskirts of Atlanta, Georgia pulled a gun on the 34-year-old owner of the bar, Barbara Kriewald, and Terry Kirby Jr., a manager-in-training. The gunman forced Terry into the office. Barbara, who was seven months pregnant at the time, was zapped with a stun gun then forced into the office to open the safe. Then the attacker ordered Barbara to tie Terry's legs and hands behind his back. Barbara opened the safe and gave the gunman the money. The attacker told Barbara to tie her own legs and lie face down on the floor next to Terry. He zapped Barbara again with the stun gun and then shot both Barbara and Terry in the back. The gunman left twelve minutes later. Barbara and Terry called 911. Police arrived moments later. Barbara and her unborn child died on the way to the hospital. Terry survived but is paralyzed from the waist down. The suspect is in his 20's to early 30's, 6'0"-6'2" and 145-165 pounds. (See Shows #669 and #672, OADs 3/23/02 and 4/13/02)

Sunrise Killers (Murder) – There are two maniacs in New York who seem to kill for kicks. The first killing was February 8, 2003, at 6:45am in Ozone Park. The second killing was later the same day in Brooklyn. The next, also in Brooklyn, was at 9:36am on March 1. The last known shooting was March 10th at 6:00am in Crown Heights. The last victim, Albert Kotlyar, had no warning, nor did his executioner try to take any money. A male in his 20's wearing a hooded sweatshirt entered the laundromat, which at that hour had only a few customers. Witnesses told police that the killer sat down for ten minutes and drank his coffee. Without warning, he stood up, went over to Kotlyar, pulled a handgun and shot him once in the face. Kotlyar was killed instantly. Witnesses said the gunman made no attempt to raid the cash register or crack open an ATM. Police are now poring over chilling footage from a store security

camera that captured the horrifying thrill-kill. Authorities have already examined footage from the first murder. The video shows two men entering the store just before 7:00am wearing hooded sweatshirts pulled over their heads. One suspect is wearing a distinct DKNY jacket with the number "55" sewn onto the left sleeve. Without warning the other suspect pulls out a gun and shoots customer John Freddy once in the head. Just two yours later, one of the bandits walked into a deli in Brooklyn and found owner Sukhjit Khajala, who died of two gunshot wounds to the head. Ballistics show that all three men were murdered with the same gun, a .40 caliber. Detectives are certain that the same two men are responsible for the March 1 murder of Marc Zanichelli, a manager of an autoparts store. The two thugs walked into the store at 9:36am, led Zanichelli and three co-workers to a back room, and then ordered Zanichelli to open the safe. When he told them the key was in his car, they shot him and fled. On March 20, a .9 millimeter gun was the weapon when a gunman entered a market in Crown Heights and shot Ali Mohomed Abdo Nasser and his cousin, Yakoob Aldaylam. Nasser died instantly, and Aldaylam is in critical condition. In the surveillance video from the Zanichelli murder, the first suspect was wearing a black knit cap with yellow and red stripes and a dark jacket. He is 22-23, 5'7"-5'9" and 170 pounds. The second suspect was wearing the DKNY varsity jacket that was sold only at Jimmy Jazz clothing stores. He is 22-23, 5'8"-5'10" and 180 pounds. (See Shows #710 and #711, OADs 3/15/03 and 3/22/03)

Adnan G. Habis Abdulla Al Saoub (Conspiracy, Terrorism) – The FBI has launched a worldwide manhunt for Habis Abdulla Al Saoub, indicted in Portland, Oregon on several terrorist-related charges. The indictment charges him with conspiracy to levy war against the US, conspiracy to provide material support and resources to foreign terrorist organizations, and conspiracy to contribute service to Al Qaeda and the Taliban. Al Saoub chose to travel overseas after the September 11, 2001 attacks with the intent to kill American soldiers in Afghanistan. However, the FBI says he never made it to Afghanistan and they are unsure where he is. He left the US on October 17, 2001, and the last record of his whereabouts places Al Saoub departing China on May 23, 2002. The FBI believes Al Saoub is the leader of the Al Qaeda terrorist cell in Oregon known as the "Portland 6". Agents arrested five of the six in October 2002, including Jeffrey

Battle, Patrice Ford, Muhammad Bilal, Hamed Bilal and October Lewis. All are in federal custody and are awaiting trial. Al Saoub is considered armed and dangerous. He is a former Mujahadenn who fought previously against the Soviets in Afghanistan. He lived in Peshawar, Pakistan until 1993, when he emigrated to the US and later became a permanent US resident alien. Al Saoub, who has used numerous aliases including Abu Tarek, Abu Tariq, Habisadbdulla Al-Saub, and Habis Abdulla Al-Saoub, has a 3- to 5-inch vertical scar on his lower back, and a malformed left ear - a piece of flesh in a half-moon shape is missing from the lobe. He has worked as a parking lot attendant, computer/electronic component assembler, and an auto repairman. Al Saoub is 37, 6'3" and 210 pounds.

Emil Fuentes (Murder, Kidnapping) – Fuentes is wanted for a robbery and murder that occurred on April 2, 2000 in North Carolina. Emil and his cousin Wilmer Fuentes robbed a convenience store in Fuquay-Varina, North Carolina. After the robbery, the two cousins went back to Emil's house in Olivia, North Carolina, and murdered Angela Fuentes, Emil's wife. Angela's mother found her the next day when Angela did not report to work. After the shooting, Fuentes stayed in the Fayetteville, North Carolina area for approximately one day, then fled. Fuentes, whose numerous aliases include Carlos Abraham Montero Paiz, Suarez Fuentez, Carlos Montero, Abraham Montero, Abraham Paiz, Juan Solano Flores, Carlos Paiz, and Emil Suarez, is a Honduran national who does not smoke or drink and likes to dress well. Fuentes is 27, 5'6" and 150 pounds.

Adrian Martindale (Sexual Assault) - On May 23, 1995 Veronica Clark and her two children went into the West Haven, Connecticut police department headquarters. The children were 11 and 12 years old. Along with her was a 7-year-old companion of the children and his sister, who was also the child's guardian. At this time, sworn statements were taken that describe several instances of sexual abuse on each of the boys by Veronica Clark's live-in boyfriend, Adrian Martindale. Ms. Clark stated that sometime during the months of March and April 1995, her eldest son became tensed up when he knew that she would be going out. However, he would not disclose the reason. Sometime during the month of April, Ms. Clark picked the lock on the bathroom door and found Martindale in the shower with the older boy. Once more, the child would not talk about what had been happening, but did appear to have a look of fear. On May 23, 1995, Ms. Clark was finally able to interview her son. She was told that Adrian Martindale had fondled his penis and forced him to perform oral sex. In addition, Ms. Clark was informed that Adrian had been touching the younger son on his penis and that these acts had been occurring for approximately two years. The guardian of the 7-year-old also signed a sworn statement alleging that her brother was sexually assaulted by Martindale on or about May 9, 1995, when Martindale squeezed the boy's penis and punched him in the stomach. Each of the boys were sent to Yale New Haven Sexual Abuse clinic for interview and examination. It was

confirmed that the sexual abuse had occurred. On June 6, a case worker assigned to the case conducted more interviews and test. Information learned from these interviews indicated that the two older brothers had been forced to perform oral sex on Martindale and that he had performed anal intercourse on each of the boys. The boys both had complained of the pain, but had been afraid to tell their mother. As soon as Martindale figured out that charges were going to be filed against him, he fled from the Clark house. No one has reported seeing him since. Martindale is 37, 5'11" and 145-155 pounds.

The Wideman Murders – In Rebecca, Georgia, a crime took the lives of three family members and an unborn baby. On March 22, 2003, a truck driver on Georgia State Highway 112 reported seeing a house on fire. The house belonged to Tommy Joe Wideman, his wife Deborah, and their daughter Melissa, who was eight months pregnant. The roof of the house collapsed within the first few minutes of the fire fighters' arrival. The fire fighters also said that the family vehicles were present. When the fire was extinguished, the bodies of the three Widemans, including Melissa's eight-month fetus, were found. Tommy Joe was the chief tax assessor for Turner County. His wife Deborah owned a bridal shop. Their daughter Melissa was a student. The bodies were identified through dental records. Autopsies proved that the Wideman family had been shot, then their home was set on fire. The weapon used in the crime was a .38 caliber pistol. Lab results showed that an accelerant was used to start the blaze. The fire completely destroyed the single-story brick home, leaving few forensic clues behind. The nature of the crime led investigators to believe this was not a random act of violence. The Widemans were a well-liked family. Though Tommy's job as tax assessor led to some heated debate with residents, he was an affable guy who could reason with just about everybody. Melissa had broken up with her boyfriend months earlier, and they no longer had contact.

AMW ALL-POINTS BULLETIN:

Lottie Mae Stanley (Bank Fraud) – Stanley has utilized various names and identities to fraudulently obtain up to \$800,000, and her crimes are considered theft by deception. Stanley is one of the greatest bank fraud artists authorities have ever seen. She has a police record going back to the 1980's, but started her current streak in late 1997. In addition to a federal warrant for her arrests, she is wanted for fraud and forgery in 16 different states. She typically goes into a local bank with a fake ID and tells the bank teller that she's forgotten her account number, then asks them to write it down for her. After depositing a stolen check made out to the account holder, she asks for the account balance, and then informs the teller that she would like to make a split deposit, where part of the check is deposited and the rest paid to the account holder in cash. She hits banks around the country and often drastically changes her appearance involving her hair color, hair length, and clothing. She is often seen with a younger woman and is thought to

be traveling with her husband. Among Stanley's aliases thus far are Linda Allen, Linda Brown, Linda Jones, Brenda Carter, Patricia Thomas, Patty Davis, and Mary Wilson. She wears her sunglasses on the top of her head, and is a compulsive gambler. Reports say she has ten or eleven children. Stanley is 51, 5'3" and 120 pounds.

Denise Mansfield Killers (Murder) – In June 2002, police found 45-year-old Denise Mansfield dead in the living room of her home in the upscale neighborhood of Lake Arbor in Prince George's County, Maryland. She had been strangled to death. Mansfield was a former accountant for Arthur Anderson who ran a business from her home refurbishing and selling desktop computers to a select list of customers. She had recently placed classified ads to sell some furniture. Someone posing as a buyer for the computers or for the furniture for sale may have killed Mansfield. In August, one of Mansfield's credit card bills showed that her card was used at an ATM in a shopping center not far from her home. The transaction occurred on June 22, 2002, the same day police believe Mansfield was killed. Surveillance photos show that three women in a row used Mansfield's card and PIN to withdraw cash from the ATM. There was an attempt to use the card at a Safeway supermarket in the same shopping center. In addition to the three women who used the ATM, surveillance cameras show a man who waited in line behind them. Police are hoping to locate this witness and determine if he has any information that could be helpful. The first suspect, who wears glasses, is 25-40 5'5"-5'7" and 150-200 pounds. The second suspect is 25-40, 5'5"-5'7" and 115-130 pounds. The third suspect is 30-45, 5'3"-5'5" and 150-200 pounds. The potential witness, who was wearing a baseball cap with the letter "P" on it, is 20-29, 5'11"-6'1" and 140-160 pounds.

Billy Brossman Killer (Murder) – On November 30, 2001, an unidentified white male entered the Bower's 7th and 70 Liquor Store in Terre Haute, Indiana. He picked up beer from the freezer, then approached the counter, pointed a gun at the store clerk, Billy Brossman, and demanded all the cash from the register. After Brossman handed over the cash, the gunman instructed him to walk to the back of the store. As Billy was walking, the gunman shot him once in the back of the head and then left the store. The entire robbery was caught on the store surveillance video, and the suspect can be clearly seen to be a white male between 25-30, 5'10"-6'0" and 160-165 pounds.

Steven Harrison (Attempted Murder, Arson, Kidnapping)
Tamika A. Hamilton (Wanted for Questioning) - On April 27, 2002 21-year-old Don
Bryant allowed his friends to bring an exotic dancer to his home. The dancer was a woman

named Tamika Hamilton. Don's friends met her at a strip club in Myrtle Beach, North Carolina. Hamilton danced for a couple of hours, then Don's friends took her back to Myrtle Beach. The next morning at approximately 7:30am, two men knocked on the door of Don's house. One of the men was Steven Harrison, but police do not know the identity of the second individual. Hamilton sent Harrison and his partner to Don's house to rob the residence. At the time, Don, his roommate Jason Lewis, and Jason's girlfriend were asleep. Harrison and his partner, armed with handguns, forced their way into the house. The gunmen demanded money from Jason and Don. Jason's girlfriend hid in a back bedroom closet. When Don told the armed invaders that he did not have any money, don was Shot in the leg. Don the tried to run out the front door but he was shot down. The attackers poured gas inside the house and set it on fire. Jason was told that if he tried to escape the burning house, he would be shot as well. Harrison and his partner then took off. After several minutes, the house was engulfed in flames. Jason grabbed his girlfriend and began to navigate his way out of the house. Jason through Don died form the gunshot wounds and told his girlfriend they would leave Don behind. Don heard Jason and told them he was not dead yet. Jason dragged Don to his truck and rushed him to the hospital. Don miraculously survived his injuries but is currently paralyzed from the chest down. Police identified and charged Harrison with attempted murder. A tipster in Memphis alerted authorities that a man named Toby Beck who was incarcerated there for robbery was actually Harrison. Ironically, Toby Beck is Harrison's real name. Erol Turnage, the unknown partner, was identified by viewers as Hamilton's boyfriend. Turnage was serving time in the same jail as Hamilton, but he had not yet been identified as the second man in this case and was released the day after Hamilton's capture. Another tipster located Turnage and Hamilton in Las Vegas, where local police picked up the pair. (See Show #705, OAD 2/1/03)
