A) **EDUCATION:** Issues relating to public school and university education in our community.

Title: BYUI Diversity Petition

Broadcast Date: 6-18

Duration: 2:24

Description: A group of BYU-Idaho College of Performing and Visual Arts students have initiated a petition drive calling for creation of a diversity and inclusion office. They claimed some college policies "weaponized the violence against the early members of the Church of Jesus Christ of Latter Day Saints against black Americans. Students of the "Black Student Union" said that cultural group was discontinued by the university. They contend the university's diversity rate has suffered, because minorities can't find a place in the academic, cultural, and social environment.

Title: JUNETEENTH

Broadcast Date: 6-19

Duration: 2:30

Description: A group of Rexburg people joined together to stage a Juneteenth commemoration in the city. One of the organizers explained the history of the occasion. The day marked the delivery of the emancipation proclamation to slaves in Texas. Group organizers said the nation's slavery history impacts the genealogy of many citizens and is a topic that must always be taught.

B) **HEALTH / ENVIRONMENT**: Issues related to our environment and health of our community.

Title: CHILDHOOD IMMUNIZATION

Broadcast Date: 5-26

Duration: 2:15

Description: Amid the COVID-19 pandemic, district health officials are concerned about a major drop-off in childhood immunizations. Because school was out, when the district normally holds its free clinics, they are worried that many young kids may be missing important vaccines. Measles vaccines in key age groups are down by over 15%. In 2019, two-thirds of children 5 months and older were up to date on vaccinations. In 2020, that number dropped to less than half.

Title: IDAHO REBOUNDS ENTERS STAGE 3

Description: Governor Brad Little said he was working to move Idaho towards a more normal lifestyle. Stage 3 of Idaho Rebounds will begin as planned on May 30. Under established guidelines, night clubs and larger venues, including sports events, should remain closed, but develop plans for Stage 4.



Team coverage included interviews with shocked neighbors after two sets of human remains were found buried on the property.
