The group says there is an established online curriculum available that offers tuition free and accredited by the state and based on Idaho standards. The association is also working to provide resources for families that may not have them.

Broadcast Date: 7-7

Duration: 1:45

Description: State health officials report Idaho's testing process is beginning

to backlog as testing supplies run low. Some people are waiting up to a week to get results. More than 100,000 people have now been tested to a rate of 12,000 per week by the end of June. Commercial labs are running low on the substance used to sample. Short of testing, people are encouraged to wear face masks and maintain social distancing as a safeguard.

Title: COVID-19 PROGRESS

Broadcast Date: 8-25

Description: To appearances, the number of COVID-19 cases in the Southeast Idaho Public Health District is dropping. But, SIPH officials said our current rates of infection are about double where they should be. As of now, the region appears to have peaked in mid-July when 15% of Idahoan's tests came back positive. Thanks to mask mandates and health precautions, that fell to 9% by mid-August. Bonneville and Bingham counties continue to be among the national "hot spots".

Title: BINGHAM COUNTY JAIL

Broadcast Date: 8-28

Duration: 1:00

Description: More than half the inmates of the Bingham County Jail have tested positive for the COVID-19 virus. Sheriff Craig Rowland said 53 inmates and 5 staff members were infected. The sheriff decided to test the entire facility after four inmates tested positive. Prisoners who tested negative were moved to separate pods. Those who need medical care are receiving it.

Title: COVID-19: Hospital Impact

Broadcast Date: 9-22

Description: Regional hospitals were beginning to feel the pinch of a large uptick in COVID-19 cases in the area. Portneuf Regional Medical Center and Bingham Memorial reported they are not yet full, but are getting close. Active Covid-19 cases increased by 200% in three weeks time. Health officials believe the spike was due to Labor Day gatherings and a return to public and university classes. Hospitals are concerned because the winter months normally put additional pressure on health services.

So far, Pocatello crews have pumped almost 1.2 million gallons this year, which is about double that of a typical year.
