2) Council decides on dual track for city legal services

City Attorney Kelly Martinez recently resigned to take a different position. The city council voted this past Monday night to take a dual track for securing legal services. We are taking applications for a full-time position. However, many cities and counties are finding it difficult to fill attorney positions. And the job requires knowledge and experience in all sorts of issues, from housing to development contracts to prosecuting misdemeanors. So we are also seeking proposals to retain a firm to provide legal services

The council will look over the applications and proposals and then make a decision on whether to fill the position or contract out services by the end of the year. In the meantime, we have retained a firm to provide services. Prosecution and other city work will continue.

3) Fire prevention week

What to know about Albert Lea this week:

1) Small bug, big impact

The emerald ash borer is smaller than a penny, but will have a big impact on Albert Lea. This invasive species will cost the City of Albert Lea almost \$800,000 over the next 20 years in treating and replacing 1,100 ash trees in parks and boulevards. We do have a DNR grant of \$100,000 to help with the management plan, which is essentially "treat the best and replace the rest."

Albert Lea has about 12,000 ash trees total. If not treated, the borer will kill all of them, changing the look of our community. The tree loss could also impact property values, quality of life, and human and environmental health.

What can our listeners do? If you have ash trees, have a licensed tree professional assess them for treatment or replacement. You can find a list of licensed tree professionals on the city's website. If you're not sure what kind of trees you have, go to the city's website at cityofalbertlea.org or the Minnesota DNR website and search for "emerald ash borer." Pages should pop up with photos of ash trees to help you determine if you have this type of tree.

2) Council meets Monday night, will vote on applying for a grant to help with cleanup of Blazing Star Landing

The Albert Lea City Council will meet Monday at 7 p.m. The meeting is open to the public, held at City Hall, available online at cityofalbertlea.org and on Charter channel 180.

One agenda item is applying for a state grant to continue with cleanup of soil contamination at the Blazing Star Landing. In preparation for additional housing at the site, the City is planning to remediate four-and-a-half acres directly east of the existing apartment building. A private developer plans two additional housing buildings on the site.


3) Why the change for East Main intersections?

87 crashes in 10 years occurred on East Main Street between Garfield and Prospect avenues. 63 of them were right-angle or T-bone crashes, more likely to cause injuries. Another 10 were rear-end crashes. Replacing cross-street intersections with "J turns" can reduce injury crashes by 42%, according to traffic studies.

What to know about Albert Lea this week:

1) Reminder: Burning leaves and brush is illegal in Albert Lea
Earlier this week, Freeborn County issued a burning restriction because of
unusually warm temps and high winds.

A friendly reminder that open burning is always prohibited in the City of Albert Lea without a permit. That includes burning leaves and brush. Let's protect the lungs of all our students participating in sports and activities outside. Also, we have many senior citizens with health issues in our community, along with others who suffer from allergies and other conditions. Be a good neighbor and dispose of your leaves at the transfer station. You can dispose of a pickup load of brush for \$5 at the transfer station, or buy an annual permit for yard waste for \$13.

Even better, leave them on the grass overwinter. The leaves actually benefit your lawn and insects.

Recreational fires are allowed. They need to be 3 feet in diameter or less, surrounded by non-combustible materials, and at least 25 feet from any structure or combustible material.

2) Election day is Tuesday

Tuesday, Nov. 8, is election day. We encourage everyone eligible to get out and vote! Albert Lea voters will elect a new mayor and decide on four city council seats: First, second, fourth and sixth wards.

Two polling places changed earlier this year in the city:

- First ward voters now cast their ballots at the Fairlane Building at the Freeborn County Fairgrounds. Use the Bridge Avenue entrance. If you used to vote at Edgewater Park, now you vote at the fairgrounds.
 - Fifth ward voters now cast their ballots at the National Guard Armory on Prospect Avenue. This precinct was previously at City Hall.

3) Drainage project continues at Snyder Fields

Hershey Street has a small detour while crews continue to install a stormwater retention pond at Snyder Fields. The pond is part of a much larger project to improve drainage at the fields, meaning safer play for baseball and softball. These fields have hosted 4 big tournaments each season the last few years, including a state tournament. That means hundreds of players and their families visit Albert Lea and spend thousands of dollars.

And the drainage is just the beginning of several improvements. We are working with the Albert Lea Youth Baseball Association on new fencing, dugouts, lighting and parking.

1) Let's salute our veterans

On this Veterans Day, it's important to say thank you to our veterans who have defended our freedoms. In their honor, City Hall and Fire Station are shining green lights this week to let veterans know they are seen, appreciated and supported.

2) Speaking of freedoms ...

Albert Lea voters on Nov. 8th elected a new mayor and three new city councilors:

- Mayor: Rich Murray (current councilor for Ward 1)
- Ward 1: Rachel A.B. Christensen
- Ward 2: Larry J. Baker (incumbent)
- Ward 4: Sherri Rasmussen
- Ward 6: Brian "BJ" Anderson

Earlier this year, Mayor Vern Rasmussen Jr. announced that he would step down after serving on the council since 2004, first as the Ward 1 councilor and then as mayor since 2010.

Al "Minnow" Brooks, Ward 6 city councilor, also chose to step down from his seat. He was first elected as Ward 6 councilor in 1998.

Reid Olson, current councilor for Ward 4, was first elected in 2006.

The council will conduct a Canvass Board meeting to certify the city election results at 5:15 p.m. Monday, Nov. 14, which is open to the public.

The new mayor and councilors will take their seats in January 2023. Thank you to all the candidates who stepped forward!

3) City council meets Monday night

At its meeting Monday night, the council will vote on several matters, including disposing of several city-owned properties. The city acquired many of these through unpaid taxes or to preserve historic buildings. The council will vote on issuing requests for proposals to purchase and develop nine vacant lots and four buildings.

Two of the buildings are in our historic downtown, the top two floors of the Freeborn Bank Building and the Jacobson Building next door. With the owner of the lower floors of the bank building marketing them for sale, and the City repairing the façade of the Jacobson Building, staff is recommending taking proposals to develop these vacant buildings.

If you ever wanted to own a piece of local history, here's your chance.

The overall purpose for the City to dispose of all these properties is to encourage development to increase the tax base, jobs and housing options while reducing blight.

What to know about Albert Lea this week:

1) Welcome hockey players!

After hosting the "B Bantams" last weekend, the City Arena is home to the "A Bantam" tournament November 18th-20th. We have 8 teams total coming from Minnesota, Iowa and Nebraska. Please give them a warm Albert Lea welcome. And good luck to our Albert Lea team!

2) City moving ahead with some wastewater treatment work

While still lobbying for state funding toward upgrades to our wastewater treatment plant, the city is moving ahead with some parts of the project. The council approved a \$434,000 agreement Monday night with an engineering firm to move ahead with a new grit removal building. Wastewater actually contains sand, silt, egg shells, coffee grounds and other grit that wears on the equipment. This grit is removed as part of the treatment process. Our current grit removal equipment is 10 years past its maximum useful life span of 30 years, and greatly corroded. In addition, the area needs more ventilation to be safe for our staff. The engineering firm will also look at using solar arrays to help offset some of the energy use and cost. The total project is expected to cost \$73 million.

3) Who should get an exception to zoning rules?

The Board of Appeals is a group of volunteers appointed by our council to decide whether to recommend approval of exceptions or variances to zoning rules. The intent of these rules is to protect public health and safety. But sometimes the only way to build a deck is with a smaller setback from a property line. Or expanding a garage means violating the density standard. That's where the Board of Appeals comes in. This board needs more volunteer members to keep construction projects moving along. It meets only when needed. Consider applying today. Learn more on our website at cityofalbertlea.org.



I have bad news, better news and good news.

1) Water and sewer fees may increase ~

The City Council is scheduled to vote December 12th on increasing water and sewer fees by 5 and 7%, respectively, to cover increasing costs. For the average household – using 6,000 gallons of water per month - that would be \$4.15 more, from \$69.32 to \$73.47. Local fees would still be less than several southern Minnesota cities, including Austin and Fairmont. For sound financial management, water and sewer services must be completely funded by fees, not subsidized by property taxes. Utility fees cover the costs of providing water and sewer, not fixing streets, plowing snow, buying books or fire trucks, making ice at the arena, running elections or other city expenses.

2) Council directs staff to trim city tax levy

Also at Monday's meeting, the Albert Lea City Council will vote on a tax levy increase of 5.75%, down from 6.5% first proposed. The city was able to trim the levy because it's in line for receiving state aid for firefighting in 2023. The proposed levy totals \$7.39 million, up \$399,000 from 2022, to cover increases in health care and inflation.

The impact to individual property owners will depend on their valuations as assessed by Freeborn County. For a \$100,000 home with no increase in valuation, city taxes would actually decrease by about \$83. For a \$100,000 home seeing a 22% increase in value – the average this past year – city taxes would increase by almost \$35 per year. The local property tax levy makes up 30% of the total city budget of \$18.1 million with the rest coming from state aid, fees, and other sources.

Compared to the rest of the state, Albert Lea's tax increase is on the lower side. Statewide, cities report an average increase of 9.1% in their local levies.

The Dec. 12th council meeting starts at 7 p.m., is open to the public, and held at City Hall, 221 E. Clark St. For the full agenda, visit the City website at cityoflabertlea.org. 3) Proposals received for all 13 properties up for sale

The city recently issued an RFP for 13 properties it acquired through unpaid taxes. The good news is that all 13 properties have interested buyers and developers, including the historic Freeborn Bank and Jacobson buildings downtown. The city manager will be looking for direction from the city council on accepting the proposals during the work session before the regular council meeting on Monday. The work session starts at 5:30 p.m. and is open to the public. Stay tuned for the next steps.

1) How and when does the city plow snow?

Tis the season for snow plowing ... our Streets Department is always monitoring the forecast and then getting ready. Their goal is safety followed by efficiency, not to plow all streets by the time most people leave for work or school.

We spend almost \$500,000 every season on snow removal.

Our council adopted a snow removal policy some years ago to maximize efficiency. Under this policy, the crews start snow removal or ice treatments when:

- Snow reaches 3 inches or more of accumulation;
- Drifting of snow causes problems for travel;
- Icy conditions seriously affect travel;
- Snowfall is heavy during peak traffic times.

In total, 16 workers will hit the streets, usually at 2 a.m. to plow about 120 miles of streets.

Priorities for plowing are 1) trunk highways, arterial and collector streets; 2) emergency vehicle locations; 3) school streets; 4) bus routes; 5) residential streets and alleys; 6) city parking lots.

We have quite a few new workers in the Streets Department who are still learning how to operate the equipment and the best way to plow their routes. They're also responsible for removing snow from many miles of sidewalks and trails.

Snow removal is expensive so we try to keep costs like overtime and fuel use down. Albert Lea's snow budget is \$485,261 per year. During an average winter, we use 800 tons of salt and 1,500 tons of sand.

2) Sold – almost! Local buyers interested in downtown buildings

At this week's council work session, the city councilors directed the city manager to negotiate contracts with interested parties to purchase and develop 13 properties that the city owns. Because we acquired them through unpaid taxes, their development needs to serve a public purpose, such as alleviating the housing shortage. That means we cannot make a profit on the sales.

A local group of investors submitted a proposal for the Freeborn Bank Building and Jacobson Building, with retail on the lower levels and apartments upstairs. They are proposing a \$5 million investment into the properties with renovations over 3 years. Stay tuned for more details!
