

KTXH LICENCE RENEWAL POST-FILING NOTICES AND CERTIFICATION

INSTRUCTIONS FOR POST-FILING NOTICE

During the period beginning within five (5) business days after the license application was accepted for filing – we will let you know that date - you must broadcast a notice the filing of the license renewal application and place a link on your station's website. You must broadcast the on-air announcements at least once per week (Monday through Friday) between the hours of 7:00 a.m. and 11:00 p.m. local time for four consecutive weeks, for a total of six (6) broadcasts, with no more than two broadcasts in a week. Broadcasts made in the same week shall not air on the same day.

The text of the *on-air post-filing* announcement is as follows:

Broadcast Post-filing Announcement Text

On April 1 2022, Fox Television Stations LLC, licensee of KTXH Channel 20 (RF Channel 19), Houston, Texas, filed an application for renewal with the Federal Communications Commission. Members of the public wishing to view this application or obtain information about how to file comments and petitions on the application can visit publicfiles.fcc.gov, and search KTXH's public file.

You also must post notice on the station's website. Again, the posting must be placed on the website within five days of the release of the FCC public notice that the renewal application has been accepted for filing. We will notify you that date. The announcement must remain posted for 30 consecutive days. You must post the online notice to the "FCC Applications" tab on your website. That tab was created in late 2020 to comply with the FCC requirements (and the landing page for the tab currently states there are no pending applications).

On April 1, 2022, Fox Television Stations LLC, licensee of KTXH Channel 20 (RF Channel 19), Houston, Texas, filed an application for renewal with the Federal Communications Commission.
