
RETAINER CONTRACT



1. Client agrees to retain the services of producer for the purpose of the following services:
2 1/4 pages (double spaced) voice only each month.
2. This agreement is for a term of 2 years beginning May 1, 2013 and ending May 1, 2015.
3. The client agrees to pay the producer a monthly fee of \$300.00 per month for the 24/7 licencing and usage of the voice of producer. It is responsibility of client to use the monthly allotment of voice only pages as updates each month or lose them.
4. The producer grants to client the sole and exclusive right to the services for promotional purposes within the city/metro served. Upon termination of this agreement, all material with the voice of the producer, MITCH CRAIG, shall be taken off the air and not used for any purpose without the written consent of the said producer. Further none of the monthly allotment is to be accrued beyond the monthly terms outlined in this agreement.
5. The services in this agreement are for the voice of MITCH CRAIG and no others and is not to imply total exclusivity to other services offered by MITCH CRAIG PRODUCTIONS. Exclusive does not prohibit commercial voice overs that might air occasionally in market if not associated with another broadcast facility. This does not prohibit voicing for satellite or internet. In the event of ownership change or change of format, contract remains responsibility of client unless assumed by new owner.

7. Each party agrees that this writing constitutes the entire agreement between the parties and there are no other representations or warranties set forth herein.




